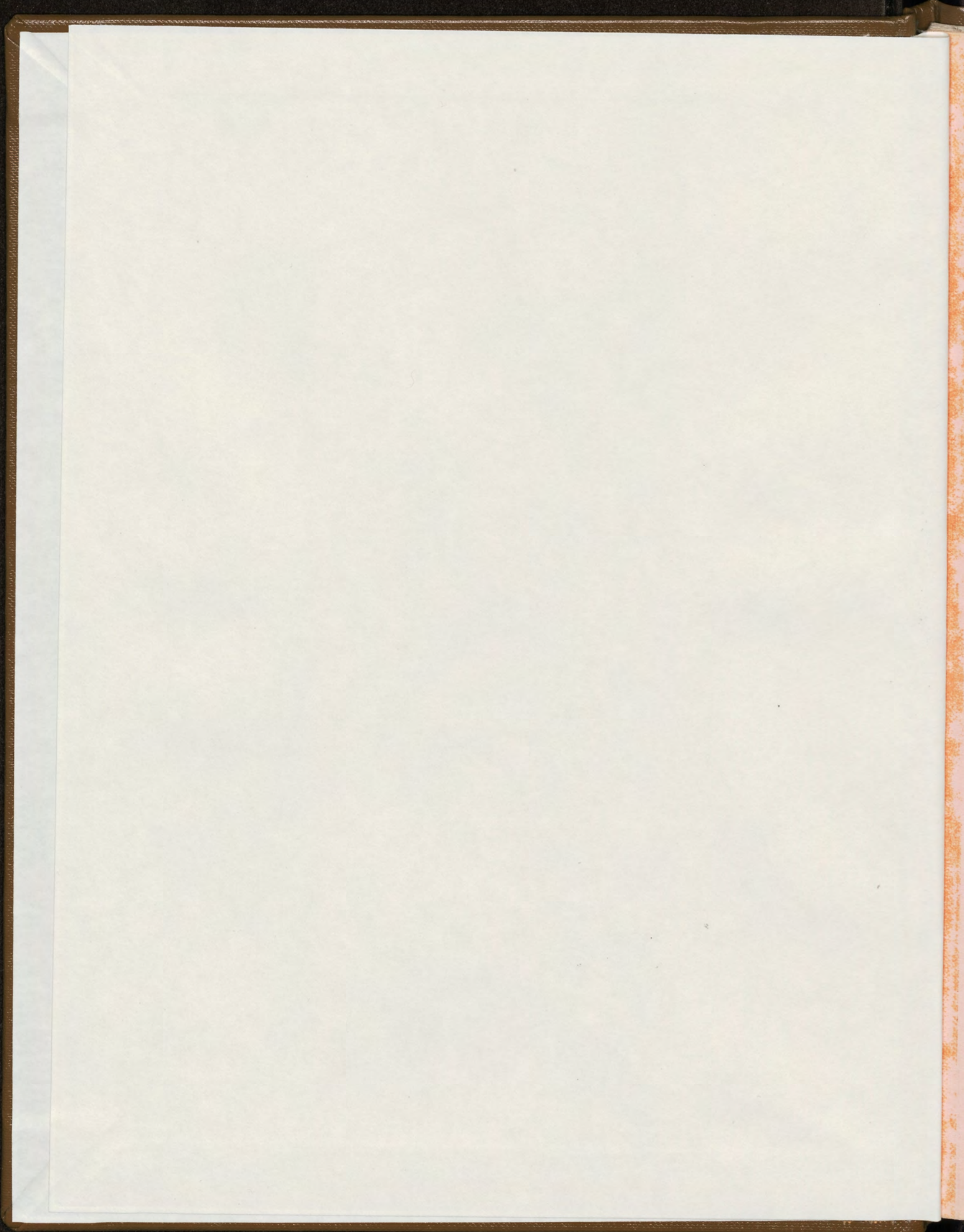



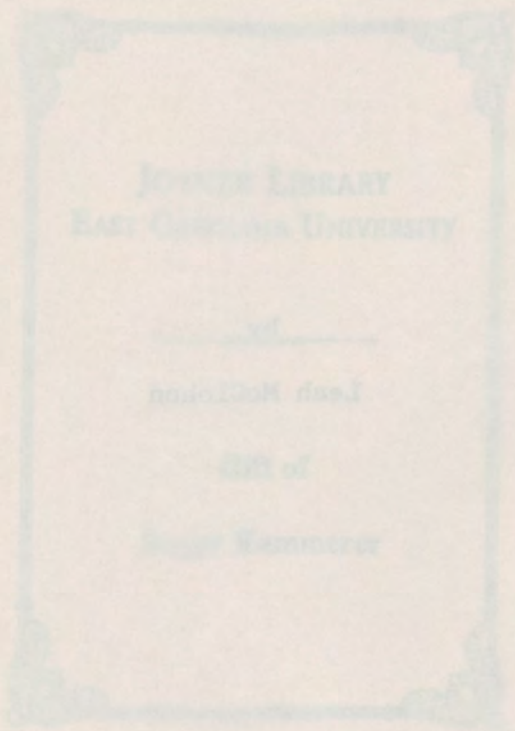

JEREMIAH MCGLOHON FAMILY

JEREMIAH MCGLOHON, the son of George McGlohon and Mary _____, was born October 29, 1818. On January 28, 1844, he married SUSAN ELIZABETH ELLIS (b. Jan. 28, 1824; d. May 1, 1899, bur. Sumrell-McLawnhorn Cem., as named by St. Amand), the daughter of Eleazar Ellis and Nancy Bonner Blount. Jeremiah was active in the Hancock Baptist Church. Sometime between 1830 and 1840, the church split over the missions question; but the two groups used the same building until about 1867. In October 1852 "Jeremiah McLohon" was ordained as a deacon of the church, most probably the missionary faction. When the missionary faction was reconstituted in 1881, he was a member of the church, known as Antioch Baptist Church and located about one mile south of Winterville. The church was later moved into Winterville and renamed Winterville Missionary Baptist Church.

Since there were a number of Jeremiahs, it is somewhat difficult to distinguish who is who in the deed records; therefore, no attempt has been made to trace his deed transactions. However, he was a farmer and owned some land. He also served as a commissioner in Pitt County. He died on August 11, 1894, and was buried in the Sumrell-McLawnhorn Cemetery on rural road No. 1112 west of Ayden. His name is spelled "McGlohon" on his tombstone. 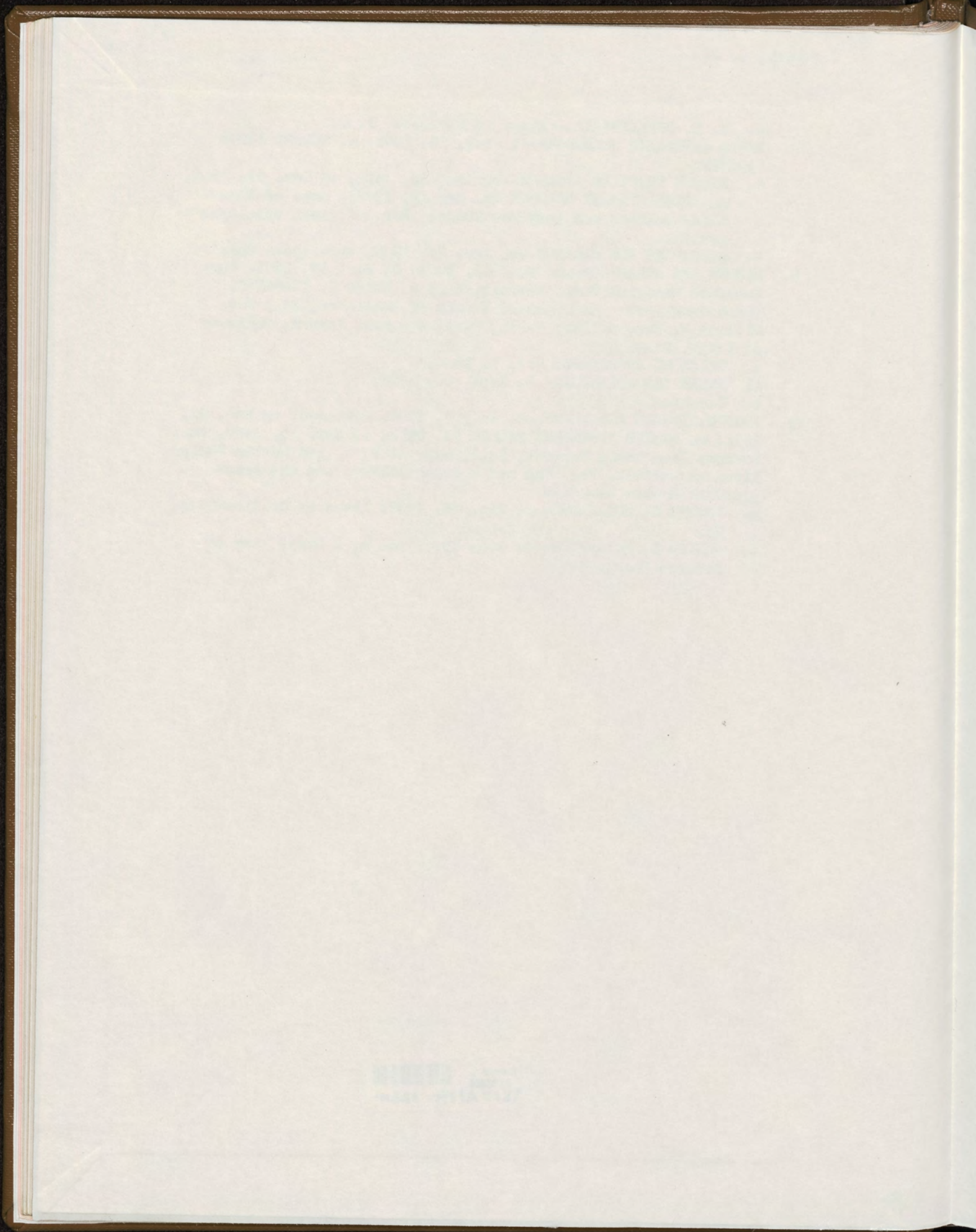
