DURHAM, NC - Recently Durham, North Carolina became the 11th city on a 15 city tour for Nation of Islam Leader, Minister Louis Farrakhan's Millions More Movement, scheduled to take place in Washington, D.C. October 14th through 16th, Washington D.C.

New Orleans Flood Survivor Claims Levee Was Blown-up... "I heard something go BOOM!"

M-Voice Newspaper As Katrina's Category 4 storm winds began to subside, and residents, thinking the worst of the storm had passed, Ray Nagin, the Mayor of New Orleans greeted the nation with more disturbing news... news that only hours before Joe Edwards, Jr., his friends, his neighbors and family were already coping with; a section of the levee holding back the swollen waters of Lake Ponchartrain in Edward's neighborhood had been breached and water was rapidly pouring in... rushing in, and New Orleans was flooding. Edwards, an over the road (OTR) truck driver lived in a part of New Orlean's 9th Ward not far from where the breach

occurred According to Dave Muir, a reporter for ABC Television News in an interview which followed the de-



Edwards stated he rushed to get himself and as many people he could loaded onto and into the cab of his truck and drove to the top of the bridge (pictured above) where they remained until they were evacuated.

## Overkill: Feared Blackwater Mercenaries Deployed in New Orleans

By Jeremy Scahill and Daniela Crespo NEW ORLEANS — Heavily armed paramilitary mercenaries from the Blackwater private security firm, infamous for their work in Iraq, are openly patrolling the streets of New Orleans. Some of the mercenaries say they have been "deputized" by the Louisiana governor; indeed some are wearing gold Louisiana state law enforcement badges on their chests and Blackwater photo identification cards on their arms. They say they are on contract with the Department of Homeland Security and have been given the authority to use lethal force. Several mercenaries we spoke with said they had served in Iraq on the personal security details of the former head of the US occupation, L. Paul Bremer and the former US ambassador to Iraq. John Negroponte.

This is a totally new thing to have guys like us working CO-NUS (Continental United States)," a heavily armed Blackwater mercenary told us as we stood on Bourbon Street in the French Quarter. We're much better equipped to deal with the situation in Iraq.

Blackwater mercenaries are some of the most feared professional killers in the world and they are accustomed to operating without worry of legal consequences. Their presence on the streets of New Orleans should be a cause for serious concern for the remaining residents of the city and raises alarming questions about why the government would allow men trained to kill with impunity in places like Iraq and Afghanistan to operate here. Some of the men now patrolling the streets of New Orleans returned from Iraq as recently

What is most disturbing is the claim of several Blackwater mercenaries we spoke with that they are here under contract from the federal and Louisiana state governments, Continues on Page 8

# Hurricane Katrina confirms huge racial divide in U.S.

by George E. Curry WASHINGTON (NNPA) - Hurricane Katrina has exposed a deep racial divide in the United States,

thirds of African-Americans feeling that the government would have reacted faster had most of the storm

Victims been white and 77 percent of whites saying the race of the victims would have made no difference if the residents had been white, according to a new report.

The polling was done Sept. 6-7 among 1,000 Americans and released late last week by the Washington-based Pew Research Center

For the People & The Press. "Half of those polled (50 percent) say they felt anger because of what happened in areas hard hit by the hurricane," the report states. "But overall opinion on this measure obscures a substantial racial divided in reactions to the disaster - as many as 70 percent of African Americans say they have felt angry, compared with 46% of whites. Blacks are twice as likely as whites to know people directly affected by

response to the crisis."

Blacks and whites also draw different conclusions about the lessons of Hurricane Katrina.

Seven-in-ten Blacks (71 percent) say the disaster shows that racial inequality remains a major problem in the country; a majority of whites (56 percent) say this was not a particularly important lesson of the

Four years after the terrorist attacks on the United States, both Blacks and whites agree that the Bush administration should place more emphasis on domestic issues. "For the first time since the 9/11 terror attacks, a majority of Americans (56 percent) say it is more important for the president to focus on domestic policy than the war on terrorism.

That shift comes at a time when Bush's popularity has plummeted. The president's approval rating is 40 percent, down from 50 percent in January. According to the report, 79 percent of African-Americans disapprove of the job Bush is doing.

Most Americans - 67 percent also agree that Bush could have done more to speed up relief efforts, while only 28 percent think he did all he could to quickly provide assistance and 5 percent remain undecided. Even then, attitudes among the races were significantly differ-

"More than eight-in-ten Blacks (85%) say Bush could have done more to get relief efforts going

though Democrats tend to be more critical of Bush and Republicans were more supportive, "these racial differences remain even when party affiliation is taken into account.

Because Blacks were twice as likely as whites - 43 percent to 22 percent - to have had a close friend or relative directly affected by Hurricane Katrina, 73 percent of African-Americans say they have felt depressed over the loss of lives and property, compared to 55 percent of whites.

"Blacks also hold more sympathetic attitudes toward the people who became stranded by the flooding in New Orleans," the report found. "An overwhelming majority (77%) say most of those who stayed behind did so because they didn't have a way to leave the city, not because they wanted to stay (16%). Most whites agree, but by a slimmer 58% to 32% margin.

"Most Blacks (57%) also think people who took things from homes and businesses in New Orleans were mostly ordinary people trying to survive during an emergency. Just 38% of whites see it that way, while as many (37%) say most who took things were criminals taking advantage of the situation."

The public was equally critical of local and state officials in their handling of the natural disaster.

While 58 % think the federal government has done only a fair or poor job in reacting to the devasta-

siana and Mississippi," the study found.

Many African-Americans complained about a double-standard in expanded its audience share more the news coverage. Some Blacks were labeled "looters" yet when whites were discovered doing the same thing, they were described as "finding" food in abandoned grocery stores. Critics also objected to calling U.S. citizens "refugees."

Still, the news media earned high marks from the public for its coverage. Two-thirds of the public gives news organizations excellent (28 %) or good (37%) ratings for their coverage of the impact of Katrina, compared to only a third who say the coverage has been fair or poor. The majority of the public gets its news about national or international issues from cable TV.

NEW ORLEAÑS — New Orleans Mayor Ray Nagin calls Lt. Gen. Russel Honore a "John Wayne dude who can "get some stuff done."

"He came off the doggone chopper, and he started cussing and people started moving," Nagin said in an interview Thursday night with a local radio station. The three-star general directed the deployment of

Orleans street corner Friday, making it clear that it was a humanitarian relief operation.

Getting food and water to the people at the city's convention center was a difficult process, Honore said. "If you ever have 20,000 people come to supper,

you know what I'm talking about. If it's easy, it would have been done already.

Honore recognizes that storm victims have waited days for relief, and his troops are trying to get them out of the city and into a more comfortable environ-

"Our number one task is to deal with the concentration of people in New Orleans, as well as those that are isolated. And we're going to get after it," he said. The general acknowledged that frustration, and in

some cases lawlessness, is building.

By-and-large, these are families that are just waiting to get out of here. They are frustrated; I would be, too. I get frustrated at the cash register counter when er runs out.

Hundreds of National Guard and active duty troops are carrying weapons in the city. But the way they carried those guns was a concern to the general.

He ordered all he encountered to point their weapons down, said CNN Pentagon Correspondent Barbara Starr, who was with the general. Honore repeatedly went up to military vehicles, National Guardsmen standing sentry and even to New Orleans police officers, telling them to please point their weapons down and reminding them that they were not in Iraq.

The general came to rescue of one young mother trying to carry her twin babies down the street in the terrible heat and humidity of New Orleans, Starr reported. The mother was so exhausted the children were almost falling out of her arms.

The general went up to the woman and took both of her babies, handing them off to soldiers to carry, as he promised the mother that they were going to get her some help. The troops helped the three hurricane victims to a Goast Guard ship, where they vere treated for exhaustion and dehydration.

Honore said he wants his troops' profile in New Orleans to be that of humanitarian relief operations, leaving the law enforcement role to the local police.

# need Black advice

Prisons are built to warehouse the enemies of the state and not to simply imprison the violators of the penal laws. If the latter were the case, the prisons would be filled with whites. Instead, it is filled with a class of persons whose movements in this country have been curtailed for four hundred years in the interest of national security. Arabs, on the other hand, still enjoy freedom from whole-

Freedom of movement and the right to privacy separate a free people from an enslaved people. To maintain control, enslaved Africans were confined to plantations. To leave the plantation, they had to be in possession of passes. This meant that Blacks had to remain unable to write in English. Thus, the "War on Terrorism" is, of necessity, a badge of slavery.

Blacks and whites read the Thirteenth Amendment differently. Blacks read it as literally ending slavery. Whites read it as continuing slavery. Blacks emphasize the main text. Whites look for the legal loopholes. History shows a connection between emancipation and the establishment

of penitentiaries. Because Blacks are not allowed to enjoy their own legal representation, we must wait for white liberals and their Black sidekicks to define legal issues for us. The interests of white liberals are antithetical to the interests of Blacks. Only a Black person who believes that he or she

is passing would seek to equate these competing interests. White liberals define our current plight in constitutional terms. To them, there is a current erosion of the Fourth Amendment. For Blacks, there has always been a breach of the Fourth Amendment. It took until 1961 for the Supreme Court to require the states to honor it in principle. The Supreme Court retreated in 1968 by holding that urban Blacks could not find complete sanctuary in the Fourth Amendment.

Before the Civil War, Blacks were subject to the slave codes. The Black codes supplanted them. The codes still harbor legal customs even though most Blacks have never read them. Of course, ignorance of the law is no excuse. From the Black codes, it is very easy to dragnet Blacks into martial law.

Random searches, clearly permitted under military justice, are violations in a free society. These searches retard freedom of movement and deprive persons of the right to privacy. Any consent to search should be free and voluntary and not subject to the denial of a privilege. Intelligence and not surveillance stops terrorism.

Random searches, per se, give rise to racial profiling. Police departments are inherently racists. Racism was the seed that gave rise to vigilantism and state-sponsored, law enforcement agencies. We must wait for civil liberties groups to sue on our behalf. It should have happened yesterday. Don't hold your breath, however. These groups are in cahoots with law enforcement agencies.

Blacks are waiting for white liberals to tell us that we are living under shades of martial law. Unlike the Japanese, it will take some time to intern all of us. A panic would ensue if they told us our true legal status right now. No other race relies on other people for legal advice. We suffer from xenophilia.

You can feel the nooses being tightened around our Adam's apples. After propaganda, the next stage of war-

are is deception. The recent, failed bombings in London are marketing strategies to promote surveillance cameras and to paint the face of terrorism Black. Those four photographs, appearing on the front page of virtually every newspaper, are suspect.

In the meantime, Black leaders appeared on radio talk shows this past Sunday to fight like cats and dogs over white men's crumbs; namely, the Atlantic Yards project in Brooklyn. None of them remember the Indians saying "the white man speaks with forked tongue." To them, it is just a question of which white men offer the best deal.

It was embarrassing to listen to these radio interviews. Black leadership is bankrupt and incompetent. None of them are aware that the founding fathers are working against them. To make matters worse, I represented most of them pro bono. Now, it is clear that most of them would stab us in the back on minute's notice. We are being primed for concentration camps.

We need legal directions. If it is not the Atlantic Yards, it is the proposed, peaceful assembly in Washington in October. This proposed march refuses to challenge the First Amendment and, therefore, it is a half-stepping proposal. Blacks can ill-afford to half-step in 2005.

The right of peaceful assembly is only a condition precedent to petitioning the government for a redress of grievances. When you assemble peaceably on federal land, the First Amendment is automatically invoked. We may as well go for all the marbles since our ancestors built the White House and Capitol Hill.

To satisfy the First Amendment, Blacks would have to tour Pennsylvania Avenue and Capitol Hill and "nail" our petition to the White House, the Supreme Court and Congress. The citation of authorities for petitioning the government for a redress of grievances include Dred Scott, Frederick Douglass, the Colfax Massacre, A. Phillip Randolph, Adderly v. Florida, Malcolm X and Dr. John

Racial unity can only be ensured provided that we respect and consult our ancestors before we initiate any collective action. "Let the chips fall where they may." It must not be a personal agenda. Our ancestors have nothing to gain from the physical realm other than the liberation of their offspring.

Whites are guided by a hidden hand - the founding fathers. This is why Republicans control the three branches of the federal government. The party that bears the closest resemblance to the ideology of the founding fathers will rule the roost. This warning comes from Howard Dean, head of the Democratic Party.

Like Bush 43, I am also a strict constructionist and believe in original intent. I strictly adhere to the teachings of my divine ancestors and consult with them on every issue, including this article. They despised the founding fathers. I am in favor of petitions including the petition of Dred Scott, which demanded reparations.

WASHINGTON - President Bush's the world. decision to put thousands of activeduty soldiers and Marines on Hurricane Katrina relief duty adds a new dimension to the enormous strain on the military from wars in Iraq and Afghanistan.

Senior military officers said Saturday they have plenty of troops to handle their wide range of missions at home and abroad, and they discounted suggestions that the urgent deployment of soldiers and Marines to the Gulf Coast would interfere with the rotation of combat troops in and out of Iraq and Afghanistan.

We can handle the overseas war-fight commitment and still defend our homeland and support the Department of Homeland Security simultaneously," Lt. Gen. Steven Blum, chief of the National Guard Bureau, told a Pentagon news con-

"People say, 'Aren't you stretched too far, aren't you about ready to run out?' There are 200,000 citizen soldier National Guardsmen left with the right kind of skills around this nation" to help with hurricane relief, Blum said.

The active-duty military has about 1.2 million people in the Army, Navy, Air Force and Marine Corps, of which about 140,000 are in Iraq and nearly 20,000 in Afghanistan. That leaves hundreds of thousands not committed directly to fighting wars, but many of them perform a range of staff functions in the Pentagon and other government agencies and at military headquarters across the nation and around

Lt. Gen. Joseph Inge, deputy commander of Northern Command, told reporters at the Pentagon on Saturday that the Katrina mission would have no negative effect on executing the missions in Iraq or Afghanistan.

"Absolutely not," Inge said.

The ranking Democrat on the House Armed Services Committee, Rep. Ike Skelton of Missouri, said that while he has been personally assured by Pentagon officials that the Gulf Coast rescue and recovery effort can be accomplished without disrupting plans for Iraq rotations, he remains worried about the future.

This effort will clearly increase the overall burden on our military," Skelton said Friday. "The Defense Department's civilian leaders must look at the impact of this and future crises and the ongoing war on the military's future readiness and overall state.

Inge said the Army's 82nd Airborne Division, which already has several infantry battalions in Afghanistan and Iraq or preparing to go there, began dispatching about ,500 soldiers, including infantry, and support troops, to Louisiana on Saturday. They included most of the

The 1st Cavalry Division, from

Fort Hood, Texas, is sending about 2,700 soldiers to the Gulf Coast, and the Marines are sending about 2,000 from bases in California and North Carolina. The 4th Infantry Division, which is getting ready to begin a new deployment to Iraq, already has sent some helicopters to Louisiana.

The Air Force is flying missions to the Gulf daily, and the Navy has numerous ships off the Gulf Coast.

Blum said the National Guard was going to send 10,000 more troops than previously planned, bringing the total number of Guardsman involved in the relief effort to 40,000 within the next several days. He said there would be 33,000 in Louisiana and Mississippi by the end of Saturday.

In addition to deployments in Kosovo and Afghanistan, the National Guard is heavily committed to the conflict in Iraq. The Army National Guard has 39,800 soldiers in Iraq and the Air National Guard has about 900. That represents about 30 percent of all U.S. forces in Iraq. Thousands also are operating in

Blum said the only Guard unit he knows of that has been pulled off the list to rotate into Iraq is a small unit whose members live in Gulfport, Miss., which was heavily battered by Hurricane Katrina.

"Many of them, we can't find them," Blum said.

A Guard infantry unit that was training at Camp Shelby, Miss., when Katrina struck has been kept off disaster relief duty so that it can deploy to Iraq as scheduled, Blum said.

Many Gulf Coast residents are still suffering from the devastation caused by Hurricane Katrina, who marched through New Orleans and parts of Alabama and Mississippi with a fury unmatched by Hurricane Betsy in 1965. She showed no mercy in her rampage, killing and injuring hundreds of people.

Preliminary damage estimates, according to Joseph Treaster and Kate Zernike of The New York Times, ranged from \$9 billion to \$16 billion. Eighty percent of New Orleans was covered by water.

Katrina's turbulent winds stripped fifteen-foot sections from the Superdome's roof, where over 25,000 evacuees took shelter.

New Orleans' mayor was right to criticize President Bush for "dragging his feet." Because the city is almost 70 percent black, I am not surprised by Bush's delay

## RITA ONCE AGAIN TAUNTS THE BIG EASY New Orleans Relives Flooding Nightmare

By Allen G. Breed NEW ORLEANS - Hurricane Rita's wind and rain breached one of New Orleans' battered levees Friday and sent water gushing into the already-devastated Ninth Ward just days after the impoverished neighborhood was pumped dry.

The water streamed through gaps at least 100 feet wide and was soon waist-deep on a nearby street. It began covering buckled homes, piles of rubble and mud-caked cars that Katrina had swamped with up to 20 feet of water nearly a month ago.

There was no immediate indication that the rest of New Orleans was in danger from the new flooding in the Ninth Ward, a particularly low-lying part of the city that has been largely abandoned. Officials with the Army Corps of Engineers said other levees appeared secure, including those breached during

The flooding was the first blow to fall on the ravaged city from Rita. "Our worst fears came true," said Maj. Barry Guidry, a National Guards-

As Muir's interview continued, Edwards told Muir that his house broke in half and his mothers house, which was made of brick "just disintegrated." Edward's said that houses there floated down the street "like somebody's guiding 'em." Ar ground zero, according to a reporter for the Wall Street Journal, it took only ten minutes for flood waters to almost cover the one-story structures that dotted that area.

When Muir once again asked Edwards was it solely the force of the water that broke the levee, or motioning then to a large barge now resting in a place where his home use to be; was it the force of the barge that broke through the levee. Edwards emphatically said it was neither. Viewing Muir's report, Edwards along with the group of people he rescued collectively expressed long held resentment of being disenfranchised by city govern-ment as well, and actually felt that "the city," which Mayor Nagin scoffed during Muir's questioning, "blew up the levee to save richer neighborhoods like the French Quarter.

However, as the city began to flood, the French Quarter, which was said to sit on higher ground, actually sustained more wind damage than water damage. But as Muir's interview continued, he once again asked Edwards if he was "convinced" that the city "broke the levee on purpose." Edwards emphatically replied I know this happen and gesturing with his arms upwardly he said, "they blew it" with the other people in the background nodding their heads in affir-

Edwards was absolutely certain he heard an explosion just before the waters rushed in and his story wasn't the only one. Other stories emerged about other people reporting they heard multiple explosions. The Ninth Ward district located east of the city sat between the levee wall holding back the waters of Lake Ponchartrain and the French Quarter. Counter-clockwise winds spinnig westward we have battered that section. The Levee wall, which snaked along the edge of Lake Ponchartrain sustained a total of six breaks which lead to a massive flooding 9th Ward.





Blackwater is one of the leading private "security" firms servicing the occupations of Iraq and Afghanistan. It has several US government contracts and has provided security for many senior US diplomats, foreign dignitaries and corporations. The company rose to international prominence after 4 of its men were killed in Fallujah and two of their charred bodies were hung from a bridge in March 2004. Those killings sparked the massive US retaliation against the civilian population of Fallujah that resulted in scores of deaths and tens of thousands of refugees.

As the threat of forced evictions now looms in New Orleans and the city confiscates even legally registered weapons from civilians, the private mercenaries of Blackwater patrol the streets openly wielding M-16s and other assault weapons. This despite Police Company of the streets of t lice Commissioner Eddie Compass' claim that "Only law enforcement are allowed to have weapons.

Officially, Blackwater says it forces are in New Orleans to join the Hurricane Relief Effort." A statement on the company's website, dated September 1, advertises airlift services, security services and crowd control. The company, according to news reports, has since begun taking private contracts to guard hotels, businesses and other properties. But what has not been publicly acknowledged is the claim, made to us by 2 Blackwater mercenaries,

That raises a key question: under what authority are Blackwater's men operating? A spokesperson for the Homeland Security Depart-ment, Russ Knocke, told the Wash-ington Post he knows of no federal plans to hire Blackwater or other private security. "We believe we've got the right mix of person-nel in law enforcement for the federal government to meet the demands of public safety." he said.

But in an hour-long conversation with several Blackwater mercenaries, we heard a different story. The men we spoke with said they are indeed on contract with

Security and the Louisiana governor's office and that some of them are sleeping in camps organized by Homeland Security in New Orleans and Baton Rouge. One of them wore a gold Louisiana state law enforcement badge and said he had been "deputized" by the governor. They told us they not only had authority to make arrests but also to use lethal force. We encountered the Blackwater forces. as we walked through the streets of the largely deserted French Quarter. We were talking with 2. New York Police officers when an unmarked car without license plates sped up next to us and stopped. Inside were 3 men, dressed in khaki uniforms, flak

jackets and wielding automatic weapons. "Y'all know where the Blackwater guys are?" they asked. One of the police offic-ers responded, "There are a bunch of them around here," and pointed down the road. 'Blackwater?" we asked. "The guys who are in Iraq?' Yeah," said the officer.

"They're all over the place." A short while later, as we

continued down Bourbon Street, we ran into the men from the car. They wore Blackwater ID badges on their arms.

"When they told me New Orleans, I said, 'What country is that in?,'" said one of the Blackwater men. He was wear-

neck in a carrying case with the phrase "Operation Iraqi Freedom" printed on it. After bragging about how he drives around Iraq in a "State Department is-sued level 5, explosion proof BMW," he said he was "just trying to get back to Kirkuk (in the north of Iraq) where the real ac-tion is." Later we overheard him on his cell phone complaining that Blackwater was only paying \$350 a day plus per diem. That is much less than the men make serving in more dangerous conditions in Iraq. Two men we spoke with said they plan on returning to Iraq in October. But,

remembered for all the right reasons." and that task was very well accomplished. As they're indicating that next year in Phoenix, AZ for their 36th Annual Convention they're requesting 'The Golden Plat-ter" & "Bubblin' Brown Sugar" for the featured entertainment slot.

Still, as time would have it, for the past some 65 + years it was a time to pay homage and reflect back on the contributions and the 'almost forgotten' un-documented piece of American WWII History. To Bullock, it was all about these aging WWII heroes and the youngsters of today that have been charged with the responsibilities to carry on this proud legacy. "I recall reflecting back in my teenage years of the type of roll models these types of men and women demonstrated for my gen-eration and me. I had two direct sources of such teachings—Uncles that were WWII heroes-Uncle Lafayette Brown. Tuskegee Airman, who actually drove for General Ben. O. Davis; Jr., and an Uncle Ellsworth Bullock who served in the Philippine/Midway Island Theater. They had by a natural 'caring sense'

— the right to reprimand, discipline and even demand that I/we as youngsters attain a certain level of self-expectations and stay the course. Something that is apparently missing in the lives of our youth for the past three generations" Bullock said.

He told me that it was through the Tuskegee Airmen's Young Eagles Scholarship Flight Program influenced him to choose a career with the Air Force. Next year during Black History Month 2006 Bullock said that two of these surviving members of the Wilson V. Eagleson Tuskegee Airman Chapter of Goldsboro, NC would be keynote speakers here in Edgecombe
