REPARATIONS----- DO YOU HEAR THE CALL

The U.S. government's first reparations plan to compensate African-Americans for the legacy of slavery was 40 acres and a mule apiece ----that was Gen. William Sherman's promise to former slaves shortly after the Civil War ended in 1865. His order set aside land on the Georgia and South Carolina coasts for the settlement of thousands of newly freed families. But the promise was quickly recanted and the land was taken back, with no other plans for reparations.

Since then, the issue has been revisited time and again by leading civil rights activists. In 1963, for example, Martin Luther King Jr., called Sherman's promise "a check which has come back marked 'insufficient funds." King called instead for "a check that will give (African-Americans) upon demand the riches of freedom and the security of justice."

Support from the White House and Congress still remains weak: President Bush is said to oppose paying slave compensation, and U.S. Rep. John Conyers' proposal to set up a commission to study the impact of slavery has languished for over a decade **Reparations include** compensations such as return of sovereignty or political authority, group entitlements, and money or property transfers, or some combination of these, due to the wrongdoing of the grantor. It is obvious, then, that the form reparations will take depends on, among other things, the particular demands of the victimized group and the nature of the wrong committed. In arguing for Black reparations, this article

supports the idea of compensation through money transfers and group entitlements because I believe that reparations present an opportunity for institutionbuilding that is badly needed, and should not be squandered in the consumer market. Nevertheless, I also believe that the poorest among us should be compensated first and through meaningful (not symbolic) monetary transfers.

Even though recent statements have been made to apologize for the wrongs done to our people (slavery) that is not enough.

We have to continue to sound the gong for reparations until our voices are heard from the White House to the Crack House.




