

Unarmed – another Black teen gunned down by cops

There is uproar in the hood..again.Hitting him ten times, five cops, including two sergeants and a detective, shot and killed unarmed 18-yearold Kyle Coppin in Bedford-Stuyvesant on Monday night."The first shot was fatal because that hit him in the chest. They hit him with at least nine more. The police picked him up and acted like they were arresting him because they couldn't have him die on the scene," activist Abubaka Miller told the Amsterdam News.Gates Avenue in Bedford-Stuyvesant is busy on a quiet day, on Monday night it was tense and overflowing as news

spread like wildfire that housing and 79th Precinct cops had struck yet again. The hastily strung up yellow tape could not contain hordes of angry teens, parents, activists and area residents, as they all gathered outside the housing project at 590 Gates Avenue. Accounts varied - but one fact remained- the teen did not have a weapon. Some witnesses claimed that a hairbrush fell out of his pocket, others said that he had it in his hand. Some news reports have quoted a "police source" claiming that it might have been a suicide-by-cop wish fulfilled."He'd dropped the brush. He had his hands in the air and then they started shooting," said eyewitness Andres Sanchez.Many distraught witnesses agreed cops did not have to fire and some were simply shocked by the number of bullets at the young man. "It's just shoot to

kill," said one thirtysomething man. On Monday night Coppin's mother. Denise Owens, called police after arguing with her son. Some published reports stated that she said he had a gun. On Tuesday she told AmNews that she told the 911 dispatcher that her son did not have a gun At a press conference on Tuesday, Police **Commissioner Ray Kelly** released the 911 transcript of the original phone call, where somebody makes mention of a gun, but not Owens. When cops got to the scene, witnesses said that Coppin, who reportedly had a history of mental issues, was standing on a first floor ledge of an apartment at 590 Gates Avenue. Cops claim he had something under his shirt.Some witnesses said that

Tar babies and high yellows, "good" hair vs. "bad" hair. Some thought color discrimination among **African Americans had** pretty much blown away with the Black cultural revolution of the 1960s and 1970s. But according to sociologists, academicians and other measures of the nation's social barometer. the issue is still rooted in day-to-day life.

"There is evidence, no let me rephrase that, it's a reality that people receive preferential treatment based on color," said sociologist Cedric O. Herring, a professor at the University of Illinois and editor of Skin Deep: How Race and Complexion Matter in the "Color-Bling" Era.

"It is something that for a long time was an impolite subject to talk about but it's real."

The subject reared its head most visibly recently when Detroit DJ Ulysses Barnes was flooded with so many emails, telephone calls and negative publicity that he was forced to cancel the event. In his defense, Barnes said he had plans for "Sexy Chocolate" and "Sexy Carmel" parties too, and that "it was just a party thing."

It wasn't just a "party thing" for people like Ayana Teal, an administrator for the Jewish

you be so pale that the "blue veins" on the underside of the arm were visible; to more , modern times when Black fraternities and sororities administered the "brown paper bag test" to prevent people who were "too dark" from entering their ranks.

Such attitudes about color reflect "internalized racism." said Melvin Thomas, president of the Association of Black Sociologists and professor of sociology at North Carolina State University.

"For some Blacks, the more white you are, the better," he said. "It's based on White racism but it gets internalized so that Blacks have the same negative attitudes towards Black skin and see European features as more desirable."

Herring said color

discrimination doesn't only go one way. "Lightcomplected African American women may be the desirable group of women," he said. "They aren't seen as Blacks and the treatment they receive from African-American women, especially, is hateful."

Thomas and others argue that the preference towards lighter-skinned Blacks is reflected in various aspects of life, particularly the

entertainment world, where lighter-skinned female celebrities - Lena Horne, Halle Berry, Alicia Keys and Mariah Carey - appear to be the preference.

Changa Bell, an area film director and former BET employee, used to direct hip hop music videos. Bell, 35, said that the emphasis on light-skinned Africans Americans was one of the reasons why he drew away from the genre. "Back when I was heavy into making hip hop videos it was the 'Blasian,' Black-Asian, mix that was popular," he said. "But more often than not, it is the light, brown to light skinned models who appear in these videos."

The artist will usually ask for a certain type of look and the director will find models to fit that look, Bell said.

David Hayrock, director of operations for Supergroup International, which produces hip hop videos, denied that there is a bias. "From the point of view of casting, there has never been any talk about choosing models based on their complexion," Hayrock said. "It's more about booties and how their faces look in close-ups."

Teal, who also works as a fashion stylists, said she also

Baltimore. Teal, 25, was made "painfully aware" early on that her dark skin was not seen as desirable.

"People would say, 'You're really pretty for a dark-skinned girl,' qualifying it like darkskinned people aren't supposed to be pretty," she said.

Have we forgotten our past?

For over 300 years, black. people were treated worse than the lowest animals on earth. Our throats were slashed; we were lynched and burned beyond recognition; our black women were raped so often, that our color has changed. We were the food that sharks ate; we died not by the hundreds or thousands, but by the millions as we were among the worst holocausts this planet has ever known. Have we forgotten?

Emmitt Till was accused of whistling at a white woman and there was hardly anything left of him after they lynched and burned him. There has been enough black blood spilled to create a large lake. Many slaves did survive and lived to have children and kept our race alive, but no one can really understand the suffering and the humiliation it required to survive as a human being. Have we forgotten?

Black men, do you remember Willie Lynch, who in 1712 spoke to his fellow Virginia slave owners saying: "While Rome used cords of wood as crosses for standing human bodies along its old highways in great numbers, you are here using the tree and rope on occasion.

"I caught the whiff of a dead slave hanging from a tree a couple of miles back. You are not only losing valuable stock by hangings, you are having uprisings, slaves are having uprisings, slaves are running away, your crops are sometimes left in the field too

long for maximum profit, you suffer occasional fires, your animals are being killed. Gentlemen, you know what your problems are, I do not need to elaborate." He went on to say; "I have a fool-proof method for controlling your black slaves. I guarantee everyone of you that if installed correctly it will control the slaves for at least 300 years." He continued to elaborate: "I use fear, distrust and envy for control purposes"; he continued, "the black slave after receiving this indoctrination shall carry on and will become selfrefueling and self-generating for hundreds of years, maybe thousands.

"Don't forget you must pit the old black male against the young black male, and the young black male against the old black male. You must use the dark skin slaves against the light skin slaves and the light skin slaves against the dark skin slaves. You must also have white servants and overseers distrust ALL blacks, but it is necessary they trust and depend on us. They must love, respect and trust ONLY us'".

He concluded by saying, "This plan if used intensely for one year, the slaves themselves will remain perpetually distrustful".

African Americans, have we overcome or are we still living his plan?

Did Dr. Martin Luther King Jr., Malcolm X and so many others who fought so long and so hard for our freedom die in vain? In every aspect of life, we had to fight and die to move up a step on the ladder of equality. Each year, as in 2007, we find ourselves with the power to correct many of the injustices confronting us by using the power of the ballot, yet 8 million of us remain unregistered voters and millions of us are rotting away in prisons while laws are currently being passed to put another million away in prison. All of this because we have forgotten our history? If we forget our past, we will have no future!

Dr. King was confronted with the thought of calling off a particular movement, because he was not certain if the people would back him, he turned to prayer as he headed to Beulah Baptist Church in Atlanta, Georgia. As he drew closer to the church, he was unable to park his car, as thousands of brothers and sisters were outside unable to get inside the crowded church. They were content to listen to him over the loudspeaker. Even when the police turned off the speakers, the crowd remained, content just to be there. Dr, King wrote; "My doubts concerning the continued success of our venture were dispelled."

Today, many young people (mostly black) without high school diplomas have been suffering for over three decades. Will we allow them to attend and graduate from "Trade Schools" and confront society with an ability to earn a living wage, or will we "wait" for additional decades to fully realize that our black prison populations, etc. will continue to grow? Our future will depend on our remembering our past!

the lessons of history are condemned to repeat them. Among other things, in the past, Blacks secured the Civil Rights Act of 1964, the Voting Rights Act of 1965 and the Open Housing Act of 1968. In addition, the U.S. Supreme Court decided Loving v. Virginia and Jones v. Alfred H. Mayer Co.

While we were pumping our fists and beating our chests, the forces of evil were at work. Because we failed to respect or support watchdogs, we never knew what hit us in 1968. In the meantime, white lawyers were reviewing the Thirteenth Amendment. To them, there is a loophole. This is our future. must consider its population. The United States also takes the gold for incarceration rates and Russia replaces China for the silver. This country is still a penal colony.

Among the domestic states, Louisiana has the highest incarceration rate. Texas and Mississippi follow. The states with the lowest incarceration rates are Maine, Minnesota, Rhode Island and New Hampshire. There is obviously a correlation between race and incarceration rates.

History is repeating itself.

today to re-enslave descendants of enslaved Africans is like having put newly-emancipated Blacks back under the constructive jurisdiction of the Confederates States of America after the Tilden-Hayes Compromise.

Slavery was a private institution similar to the Federal Reserve System. The original meaning of the Thirteenth Amendment is that Africans could only be enslaved by the state after a criminal conviction especially since it is only state action coupled with due process that can deprive a person of liberty. England gave the Royal African Company a monopoly over slave trading in 1662. This charter supplanted the Dutch's monopoly over the slave trade. Congress ended the slave trade in 1808. The institution of slavery would continue in the United States until 1865. Badges of slavery still thrive.

in prison stocks. It listed GEO Group, Corrections Corp. of America and Cornell Co. as potential investments. Stocks and bonds are the staples of slavery. Investors should be required to disinvest.

Barron's noted the risks attendant with investing in prison stocks although "the rewards to investors can be considerable – not only in stocks but also in bonds." Blacks need to keep an eye on former Attorney General Edwin Meese, an advocate for reenslaving Blacks through a loophole. 1840's. Dean Charles Hamilton Houston rekindled this struggle in the 1920's at Howard University.

Today, there should be several Robert Morrises and Charles Houstons. Instead, we are moving backwards and we are clueless as to the reason. Private prisons operate on the principle that two wrongs make a right. This is not right.

Before Hurricane Katrina, it appeared that Blacks would be at least fifty percent of Louisiana's population by 2025. During the 1990's, the state's white population increased by less than 1% while the Black population increased 12%. Judge J.P. Mauffray and LaSalle Parish District Attorney J. Reed Walters are obviously on assignment.

For every action, there is an opposite and greater reaction. This law applies to white supremacy's response to the liberation struggle.

This was seen in Jena, LA., as sixty thousand persons marched in Jena on September 20 to protest the railroading of six Black youths in adult court for an alleged attack on a white youth, Justin Barkin, in December 2006.

In June 2006, an all-white jury in adult court convicted Mychal Bell of aggravated assault and battery and conspiracy to commit a battery. Before the march, an appeals court threw out the remaining conviction for lack of jurisdiction. Jena officials have chosen to try Bell again in juvenile court.

After the march, Bell's probation was wrongfully violated on another charge. He was given 18 months in prison and is awaiting trial on the December 2006 charge despite double jeopardy. His parents were ordered to pay for his current confinement.

Those who fail to learn from

Congress has the authority to prohibit private racial discrimination as a badge of slavery. This is the rule in the Thirteenth Amendment and it was made clear in Jones v. Alfred H. Mayer Co. Thus, Congress has the authority to ban private prisons. Penology is also a public function.

Between 1970 and today, there has been more than a 700% increase in the prison population. This occurred not because of an increase in crime but because of the enactment of harsher sentencing laws. Without watchdogs, voting has allowed Blacks to endorse their own oppression.

In 1970, the state and federal prison population was under 190,000. Today, the same population is more than two million without counting persons on parole and probation. The total count is more than seven million persons in the criminal justice system alone.

The United States takes the gold for incarcerating people. China takes the silver, but you

After the Civil War, states established convict leasing systems to exploit Black labor and to put "free" Blacks in check. The Ku Klux Klan was formed within a week after the ratification of the Thirteenth Amendment. The Chinese Exclusion Acts were enacted after the ratification of the Fourteenth Amendment. Connect the dots.

Prison populations in southern states increased dramatically after the Civil War due to private prisons. The prison population in these states became disproportionately Black. Private companies were formed to lease convicts from the state for a fee. There was a lucrative market for "idle" Blacks.

The convict leasing system marched in lockstep with lynching. Private prisons are back in vogue. Nooses have followed. Although the convict leasing system may have never been challenged during Reconstruction, the convict leasing system yesterday as well as private prisons today violate the Thirteenth Amendment.

Operating private prisons

Persons in opposition to a fugitive slave law in 1793 noted the public expense of enforcing slavery. The Fugitive Slave Law of 1793 was ruled constitutional in Priggs v. Pennsylvania. It deputized all whites to seize "fugitive slaves."

The institution of slavery was not only protected by the U.S. Constitution but also by subsequent federal legislation. At least, nine clauses in the U.S. Constitution protect slavery although slavery is not mentioned in the Supreme Law.

Prison stocks are traded on the New York Stock Exchange. Investors demand that states enact harsher sentencing laws like in the conviction of Genarlow Wilson in Georgia. Last week, the Georgia Supreme Court outlawed his sentence as being cruel and unusual. Five inmates still exist in the Wilson et al. prosecution.

Black legislators led the fight to enact the unconstitutional law in Georgia which undergirded Wilson's conviction. Eleven of the twenty-one members of the Congressional Black Caucus voted for the Anti-Drug Abuse Act of 1986 which imposed a much harsher sentence for persons dealing or possessing crack cocaine.

The New York Stock Exchange is regulated by federal law under the auspices of the Securities and Exchange Commission. The fugitive slave laws were used to facilitate slavery in interstate commerce and, today, the Securities Act of 1933 and the Securities Act of 1934 serve the same function. Presidential candidates will not touch this issue.

in daycare. A closer look at the data shows that the more disruptive children had gone to lower-quality daycare centers probably reflecting what their parents could afford. Most of the disruptive kids also started daycare in infancy; babies need a lot more one-on-one attention than a 1 or 2 year old. Those factors could explain the differences in later behavior. And when it came to a child's ultimate behavior and performance in school, the research team said, " parenting quality" was far more important than time spent in daycare. But when there's an opportunity to make working moms feel guilty, who cares about the details? "The downside of daycare is what everyone wants to talk about."

On the occasions that Jones has wanted to travel through a particular state, his dispatcher tries to get him there, as well. Jones resides in Greenville, North Carolina and likes to spend his free time relaxing. His advice to people considering truck driving as a career is to always do the very best you can and to always be considerate. According to Jones, "If you do those two things, good things can happen."

study that blames them for ruining their kids lives. The National Institute of Child Health and Development released a multi-year study on daycare's impact on children, and it sent the "parental guilt meter" soaring into the red zone. Keeping preschoolers in daycare for a year or more, the study found, increased the likelihood that they would later become disruptive in class. The findings clearly struck a nerve. Social conservatives were quick to say, "We told you so," while liberals said the results showed the need for more federal dollars for daycare. Working mothers, though, could merely sigh. "What are we supposed to do with this information?" asked Jane Doe, a single mother of two from San Jose. "Are we all supposed to take our kids out of daycare?"

And a second second

million children under 5 are in daycare for one simple reason; Their families "cannot pay for food, clothing and shelter with one paycheck." Sure, in an ideal world, all little children would spend their earliest years at home in the loving care of two parents. In the real world, only a shrinking minority of families has one-stay-athome parent.

It's good that we are keeping a watchful eye on what is happening to these kids, but it won't help to demonize daycare. Instead, "let's figure out how ti improve it," said one writer.

In fact, the new study is hardly an indictment of daycare. Despite the blaring headlines about "bad behavior", the study found only slightly more unruly behavior among schoolchildren who had spent three or four years

finds color discrimination in the fashion industry. "It's become really hot to look exotic, long flowing hair, fair skin, light-colored eyes," she said. "At a fashion shoot in New York that I worked on, I noticed during the models call that they were picking only the tall, fair models and when I called the (shoot director) on it she said she hadn't realized."

The bias against darker skin tone is also evident in the workplace. Just ask Dwight Burch, a former Applebee's employee. The darkerskinned African American won a \$40,000 lawsuit against the restaurant, claiming his lighter-skinned African American manager discriminated against him because of his complexion and fired him when he complained of his treatment. The author of a recent study on the effects of complexion on economic status said his research found that lightskinned Blacks are considered for jobs over equally qualified dark-skinned Blacks.

"The most shocking finding of this study was that darkskinned Blacks makes with an MBA and managerial experience were deemed to be less qualified than a light skinned male with a bachelor's degree," said Matthew Harrison, the study's author and a University of Georgia doctoral student.

"The study showed that the economic gap between light

skinned and darker skinned blacks is similar to the gap between whites and Blacks."

Herring said he is doubtful that the social phenomenon would ever cease to exist.

Cheriss May, a Washington graphic artist and Howard University professor, agreed. "Since we ourselves perpetuate self-hate it continues to exist," she said.


and not just in my spiritual walk with Christ!!!



he had dropped the brush before cops unleashed their barrage, while cops claim they shouted "halt," Coppin kept walking towards them, and they said that's when they fired 20 bullets, hitting him with at least half of them. He was pronounced dead at Woodhull Hospital.Witnesses added that after Coppin was shot, the cops put a knee in his back and handcuffed him.While Police Commissioner Kelly said that with the belief that the object - the hairbrush, under the teen's shirt-was a deadly weapon "this shooting appears to be within department guidelines."But even he acknowledged that no gun was ever seen, and no gun was recovered at the scene. "Before we examine whether or not the shooting was justified we have to examine whether police followed proper protocol and procedure," retired detective Marquez Claxton told the AmNews.Added Mayor Michael Bloomberg: "A young man is dead, and that it is a tragedy." The family of the deceased is being represented by attorney Paul Wooten, who has decried Kelly's "rush to judgment." In response to Kelly's swift statement and nationally televised press conference on Tuesday, the family held a briefing of its own just after identifying Kyle's body. There, Noel Leader of 100 Blacks in Law Enforcement, demanded a "special prosecutor because of the incestuous relationship between the police department and the D.A.'s office."Meanwhile, emotions on Gates Avenue were still running high Tuesday afternoon."It's like you know the story before somebody open's their mouth, all you do is just change the name," a young bystander muttered."The young folk are furious," said Abubaka Miller of The Brotherhood, standing at the scene of the incident. "They are tired of the police harassment and being bombarded on the street and even in their own buildings.

one of you?"""Calling the cops for help is like dialing M for murder," charged **Brooklyn Councilman** Charles Barron. "How dare they say this was suicide by cops, like this young man wanted them to kill him. This was not suicide by cops - this was murder by cop. This was similar to what happened to Louis Baez in 1979. His wife called the police for help because she was having problems and they came and shot him 24 times. Rev. Daughtry and I told them then that in these domestic situations they need to send a psychologist, a social worker and someone to diffuse the conflict with the police so that they can talk the people down. You don't just go send in John Wayne and turn a situation into the O.K. Coral."On Tuesday morning Barron visited the 79th Precinct. As he, Coppin's family and the community at large awaited developments in a case born in an all-too familiar territory, Barron stated, "A wallet, a brush, a candy bar, that young man in Harlem pointed his finger...I hold the mayor and police commissioner responsible because they refuse to send a signal and hold police officers who kill Black people accountable. This latest killing is just a couple of blocks from where Timothy Stansbury was killed. Police Commissioner Kelly gave that killer cop, Richard Neri, a 30 day suspension."Just one block over from where Coppin was gunned down, an unarmed Stansbury was shot and killed by housing cop Neri in January 2004. Neri was never prosecuted, and this summer the city settled with Timothy's mother, Phyllis Claybourne, for \$2 million."Nobody is buying that 'we thought he had a gun crap,' that the cops say every time they kill an unarmed Black man. They should just be honest and say 'we shot because we could - now what?" said Divine Allah. Youth Minister of the New

going to use every time they kill a Black person?"As news filtered down late Tuesday morning that some gangs were planning a response, the NBPP activist concluded, These kids out here don't hear foolishness and act like they don't. They aren't rolling with the patience of their grandparent's generation. This leadership out here has to stop telling them that all they've got to do is fall back and pray and trust in the system. They don't. Guide them correctly. Speak their language so they can hear you. The youth are going to respond.
