## Jackson Death Set Stage For Legal Battles Semi Naked Woman

(June 27, 2009) - The shocking death of the King of Pop, Michael Jackson, has left legal minds to ponder the fate of his three young children, his estate and the careerrevitalizing tour he planned to launch this summer. Jackson, who evolved from being a shy teenage heartthrob to mega superstar to legend, died at age 50 on Thursday. His death has been attributed to cardiac arrest. In the hours immediately after his death, it had been assumed his mother, Katherine, would take custody of the children, Prince Michael Jr., 12; Paris, 11 and Prince Michael Jackson II, 7, also known as "Blanket." During his 2003 interview with Martin Bashir, Jackson claimed that his sperm cells were used in the conception of each of the three children. "I used a surrogate mother [for Blanket] and my own sperm cells," he said at the time. "I had my own sperm cells in my other two children. They are all my children." However Debbie Rowe, the dermatology nurse Jackson married in 1996, is the mother of the two oldest children and has expressed interest in raising them. Although she attempted in 2005 to give up custody of the children, having described Jackson as a wonderful father, a judge ruled later that Rowe hadn't completely terminated her parental rights. The third child was conceived with a surrogate mother, whose name has yet to be released. Another possibility is that all three children might continue in the care of the moonwalking star's longtime employee and confidante, Grace Rwaramba, 42. According to Stacey Brown, a family friend and co-author of "Michael Jackson Behind

Rwaramba to take over. "Michael always said he wants Grace, the nanny, to have them if something happened to him," Brown said in a statement Friday. In the event Rowe gains custody, she would be eligible for a huge chunk of child support from Jackson's estate. But determination of that estate's value could take months or even years and it remains unclear if, despite a career that spanned 40 years, Jackson had any money to leave to any of his beneficiaries. According to reports, Jackson spent money lavishly, but never quite recouped that spending. Some reports estimate he was spending about \$20 million a year more than he was bringing in. Other estimates hold that his estate could be worth a billion dollars, but that his debts could easily reach \$500 million. One of his shrewdest deals came at the height of his fame in 1985 with the \$47.5 million acquisition of ATV Music, which owned the copyright to songs written by the Beatles' John Lennon and Paul McCartney. The catalog was estimated to be worth between \$500 million to \$1 billion and provided Jackson a steady stream of income and the ability to afford his over-the-top lifestyle. But during the last few years of his life Jackson had relied on benefactors to assist him financially. Last year, Jackson lost his 2,500-acre Neverland ranch in Santa Barbara, Calif., to foreclosure. A financier pal purchased the property and is making extensive repairs after the property was allowed to fall into disarray. Jackson purchased the ranch in 1988 for \$14.6 million and at the time of his death, was living at a rented multimillion dollar home in Bel Air, Calif. Citing sources familiar with his finances, The

that the value of Jackson's biggest assets probably still exceed his debt. Furthermore, the estate's division has been complicated by his family, including his parents, brothers and sisters. In addition, the highly sought-after contents of Neverland, which include stage costumes, paintings, sculptures and. 18 Grammy awards removed for an auction this past spring, could go back on the block in the wake of Jackson's sudden demise. To the chagrin of investors, Jackson had abruptly changed his mind about the auction and the items were carted off to storage where they remain. But Jackson, after surviving a decade of scandal, had also been on the cusp of a major comeback tour. The 50-concert tour was slated to kick off in just a matter of weeks and ticket sales had been brisk. Jackson, listed among the most influential and infamous celebrities of modern times, reportedly had the potential to generate between \$750,000 and \$1 million in gross receipts each night of the tour. Reports state he could have easily walked away with half of that amount.Jackson, who hadn't toured since 1997, was also working on getting his body back into shape for the grueling performances. On the day he died, he had prepared to drive to Burbank, where he was rehearsing the new show. But the tour could face other problems. It had reportedly struggled to find an insurance broker willing to take a risk on the final leg of the performances and, as of this weekend, fans were waiting to see if they could get a refund on their tickets. ## **Tasered**

Were it not for a frantic phone call to the AmNews on Thursday afternoon, the paper may never have known that a semi-naked woman was lying handcuffed in the pouring rain on cold concrete being tasered by a female sergeant from the 32nd Precinct-at the very same time NYPD recruits were participating in multicultural training at the Apollo Theater, with Police Commissioner Ray Kelly, Reverend Al Sharpton and Reverend Herbert Daughtry. Officers just 25 blocks away were acting as if they had forgotten what they learned during their own training.

Last Thursday, officers on 150th Street and Frederick Douglass Boulevard were observed tasering an unarmed Black woman, who neighbors say seemed to be mentally unstable. The unidentified woman was seen lying outside in her underwear on the street in the rain.

"What happened to this young woman is outrageous and unacceptable," stormed State Senator Bill Perkins. "Mayor Michael Bloomberg is allowing technology that was designed to be used to subdue animals to be used on women, men and even the mentally disturbed.

Residents in the neighborhood rushed out of their buildings to see close to 20 officers surrounding the woman as she lay in the rain, according to witnesses. EMS took up to 45 minutes to respond to the scene, they told the paper.

Officers on the scene would not give a clear reason as to why the woman was being detained. Hiram, a resident, told the AmNews that he saw officers handcuff the woman and put her in a police car by pushing her in by her face. That's when the tasering began by a Sgt. Torres from the 32nd Precinct.

"She started kicking the door and they opened the door, pulled her out, tasered her and she fell to the ground. The whole time she was handcuffed," he said. "Then, she fell to the ground and she was moving all around, screaming and hollering and they tasered her again."



a white woman in the same predicament in the same way," charged Councilman Charles Barron. "This lady was already cuffed, why did they keep tasering her? They learn in academy how to restrain a person. They don't know her condition. They could have worsened any medical situation she had. They could have given her a heart attack."

Recalling the incident last September year where Iman Morales, 35, an emotionally disturbed man was Tasered with 50,000 volts by cops in Bedford-Stuyvesant, and fell to his death off a ledge, Barron continued, "Once again, they think they can treat us like animals-cuffed and tasered in front of us." In February this year, Morales' mother, Olga Negron, filed a \$10 million lawsuit against the city; Officer Nicholas Marchesona, who fired the taser; and the estate of Lt. Michael Pigott, the officer who ordered Marchesona to do so and later committed suicide. "Are you telling me that in 2009, with a woman in cuffs, they don't know a better way to restrain her? Like with Iman Morales, they could have caused her death," said Barron. "Even the NYPD regulations indicate that Tasers are not a mere tool for compliance of detainees or arrestees," explained retired Detective Marquez Claxton. "You never know when a person has a pre-existing medical condition that may result in death because of Tasering. Like discharging a firearm, the Taser should be used as a tool of last resort and it should also be regulated the same way as a 9 mm. To repeatedly Taser a semi-nude woman on the streets of Harlem shows that the NYPD has not learned anything after the death of Iman Morales in Bed-Stuy." Lt. Mike Wysokowski told the AmNews, "We responded to an emotionally disturbed person at the location. When officers got there, she was partly nude and violent. She was a 32-year-old female. They were able to put her in the patrol car, but she tried to kick out the windows. When they took her out of the car, she was still violent and lunging at the officers." Asked about the constant tasering, Wysokowski said that the woman was only tasered once after she "spat at the sergeant in the face. They shot the taser once." He insisted that "only one dart was in there," so she was not being tasered as often as people thought. When told that she screamed out in pain several times and that eye witnesses, including the two AmNews reporters, saw the sergeant seem to repeatedly taser the woman, the lieutenant replied, "No, she may not have been in pain-she was acting up."



## **Reports Confirms Black Male** Employment is lacking by James Wright

June 20, 2009) - African-Américan men are finding it harder to get a job during this recession and their prospects may not get better anytime soon. That's the conclusion of a report, "Weathering the Storm: Black Male Employment in the Recession," released by the Center for American Progress, a Washington, D.C.-based thinktank, on Friday. "The recession is taking its toll on most Americans and has resulted in job losses not seen in almost 25 years, but Black men have felt its effects particularly hard," the report's author, Alexandra Cawthorne, said. "Black men have long faced limited employment prospects and disproportionately high rates of unemployment. The current degree of job loss among Black men is particularly alarming." Among the report's findings: \*Black men lead the unemployment surge, with an unemployment rate of 15.4 percent \*Over a third of young Black men aged 16 to 19 in the labor market are unemployed \*Eight percent of Black men have lost their jobs since November 2007 \*Black men without criminal records tend to have a tougher time finding employment than White men who have been convicted by the criminal justice system. Those figures stand out further when compared to job prospects for White men. While the unemployment rate for Black males is 15,4 percent, it is only 5.5 percent for White males.
