### OUT THEY GO.

#### In We Come—Democrats Take Charge.

At 11:30 o'clock this morning the fusion Board of County Commissioners, who have had charge of the county for the last two years, announced their readiness to turn over affairs to their successors. The Democratic Board recently elected—Messrs. R. L. Davis, O. W. Harrington and Calvin J. Tucker at once qualified and the new Board organized by the election of R. L. Davis as chairman. A recess was then taken until 1 o'clock for dinner.

Upon reassembling in the afternoon the Board examined and accepted the bonds of the county officers in the following order:

G. M. Mooring, Sheriff, official bond \$5,000 with A. G. Cox and J. L. Little sureties; State tax bond \$10,000, with Jesse Cannon and J. B. Cherry as sureties; county and school tax bond \$30,000, with J. R. Davenport, J. A. K. Tucker, J. L. Wooten, Oscar Hooker, W. H. Bagwell, W. G. Mizell, J. A. Andrews, R. R. Fleming, J. O. Proctor, W. E. Proctor and J. L. Perkins as sureties.

J. B. Cherry, Treasurer, official bond, \$15,000, with J. J. Nobles, J. G. Moye and J. R. Moye as sureties; school tax bond, \$18,000 with M. G. Ernul, J. R. Moye, J. G. Moye and G. M. Mooring as sureties.

The oath of office was administered to each of these and the board then took up the bonds of the Constables of the several townships.

#### To Indict Wilmington Citizens.

Washington, Dec. 2.—The Attorney General of the United States has written a letter, directing United States District Attorney Bernard, of North Carolina, to at once proceed to indict the men who drove United States Commissioner Bunting from Wilmington. Bunting, together with

ex-Chief of Police Melton and a man named Gill, from Wilmington, are now in Washington. The plan is that if bills of indictment can be secured, Judge Purnell shall issue bench warrants and have the men taken to Raleigh immediately for trial at the term of United States District Court, which begins next Monday. It is the purpose to make the proceedings the same as in the Tolbert case in South Carolina and to have Bunting, Melton and Gill at Raleigh as witnesses.—Special to Charlotte Observer.

### RUNNING A RISK.

#### Somebody Liable to Get Hurt.

We never could see where the fascination for jumping on and off moving trains comes in, and just why people will engage in such a dangerous amusement, if amusement it can be called, is past understanding. Go to the depot here almost any morning and you can see numbers of boys, some grown men, too, clamoring to get on the platforms as the train starts, and there seems to be something of a rivalry between them as to which can let the train get the highest speed before he jumps off. It would not surprise us much to have to write up an account of somebody getting killed or losing a limb in this risky practice. Only a morning or two ago a man fell and the car wheels did not miss his foot more than a hand-breadth. If their reason can be appealed to, THE REFLECTOR urges those given to this habit of jumping off the trains to stop it.

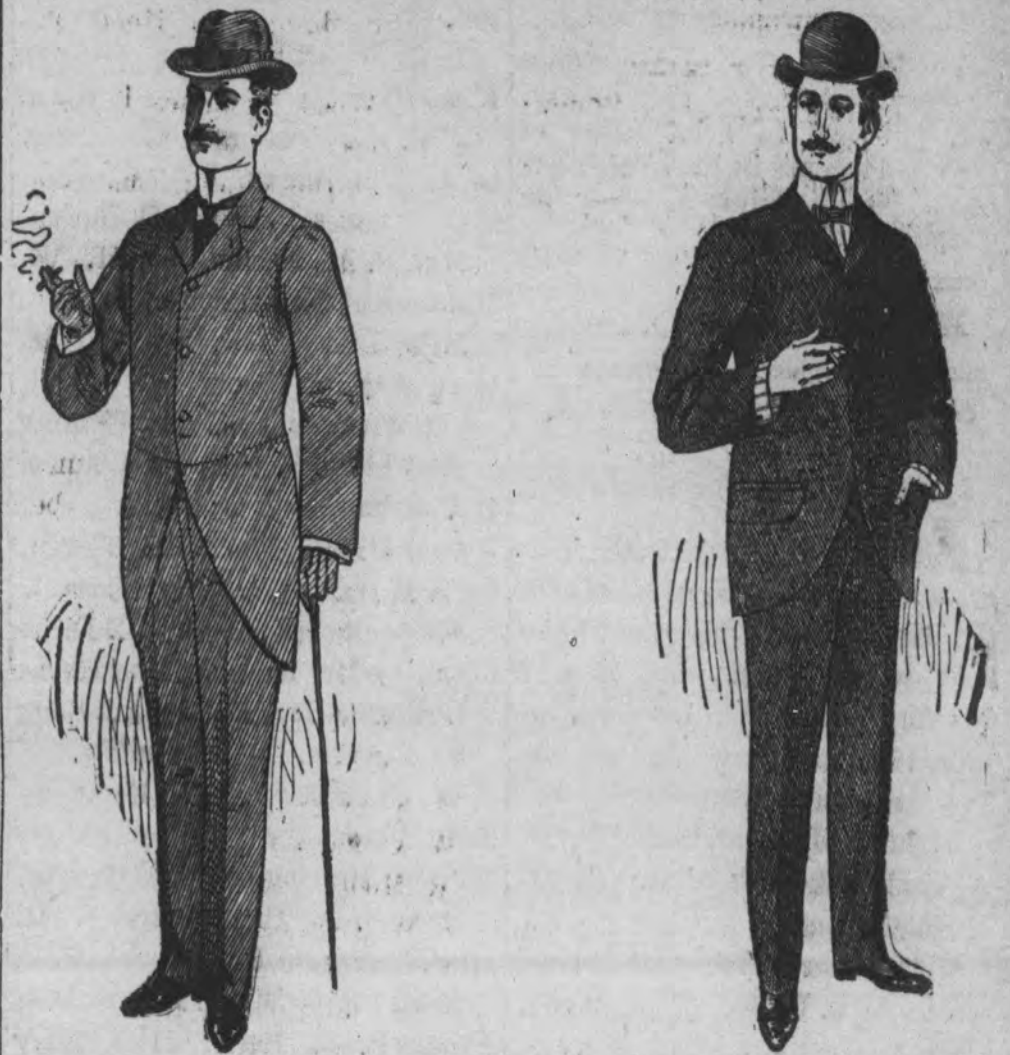

**METHODIST CONFERENCE**

Elizabeth City, N. C., Dec. 2.—The third day's session of the North Carolina Conference was called to order at the regular hour. Will X. Coley of the Oxford Orphan Asylum was introduced and spoke of the good work that institution is doing, and asked the conference for its continued support.  
 Rev. Charles Brothers of the Western North Carolina Conference was announced as a transfer.  
 The committee on the paper question were elected as follows: J. N. Cole, J. E. Underwood, L. W. McMullan and L. L. Smith.  
 The call of question twenty was resumed and when John C. Kilgo was called he spoke at some length of the trials of the year, and said he came out of the storm without malice in his heart against any one. He announced that he was ready to serve the church he loved in any capacity, and if further conflicts were ahead he was ready to lay all his strength upon the altar, and die if need be, for the interests of the Master's kingdom. There were not many dry eyes in the conference when he took his seat, and there was a spontaneous outburst of applause.  
 Under call of question twenty, which was resumed, Presiding Elder Hall, of the Washington District, announced that there were charges against Rev. R. J. Moorman, of Rocky Mount; and a committee of investigation was appointed by the bishop, consisting of Revs. R. B. John, George F. Smith and W. J. Twilley.  
 The hour of 11 o'clock arrived, and the publishing house claim committee reported through L. L. Smith, Esq. It condemned the deception of Stahlman and the lack of candor on the part of agents Barbee and Smith, and proposed refunding the claim to the government if the Senate would say the bill would not have passed that body but for the deception practiced.  
 Rev. John N. Cole offered a substitute, asking the college of bishops to take steps for the unconditional and prompt return of the government.  
 The substitute was supported by Dr. Yates in a fine speech, but was lost. Revs. John and Norman spoke in favor of committee's report. So did L. L. Smith, and the same was adopted.  
 A class of five young preachers were elected to elder's orders, and eight local preachers were elected deacons.  
 The following were received into full membership in the conference: Bryan Thompson, Albeth Barnes, Robert Willis and Andrew Graves.  
 The conference took up the question of place for the next conference just before adjournment, and four nominations were made, viz: Washington, Wilmington, Newbern and Rocky Mount. The contest was somewhat spirited and Washington was chosen.

This is a pretty wide range.
