## "JIM CROW CARS."

### Separate Cars for Whites and Blacks.

Representative McLean, of Harnett county, has introduced a bill in the Legislature to provide separate cars for white and black passengers in this State. The bill reads as follows:

Section 1. That all railroads and railroad companies engaged in this State as common carriers of passengers for hire shall furnish separate compartments in all first-class coaches for the accommodation of white and colored passengers: provided, that equal accommodations shall be supplied to all persons, without distinction of race, color or previous condition, in such coaches.

Sec. 2. That any first-class coach of such carrier for passengers may be divided into compartments separated by a substantial partition, in lieu of separate coaches.

Sec. 3. That should any railroad or railroad company, its agents or employes, violate the provisions of this act, such railroad or railroad company shall be liable to a penalty of not more than \$500 nor less than \$200 for each violation, to be collected by suit, to be instituted by the State, and the penalty recovered shall be paid into the general fund of the State Treasury.

Sec. 4. That the provisions of this act shall not apply to nurses on trains or to passengers holding inter-State tickets: nor to relief trains in case of accident or emergency, nor to through sleeping-cars, nor to the officers and guards transporting prisoners, nor to the prisoners being so transported. That the provisions of this act shall not go into effect until—1899.

Sec. 5. That all conductors or other employes in charge of such cars shall be required to assign all passengers to their respective cars or compartments of cars, so as to separate the white and colored races; and all conductors or other employes of railroads shall have, and are hereby vested in, police powers to carry out the provisions of this act.

Sec. 6. That any person remaining in any car or compartment other than that to which he may have been assigned shall be guilty of a misdemeanor and on conviction shall be punished by a fine of \$—.

Sec. 7. Jurisdiction for this offense shall be in the county in which the same occurred.

The conductor and any or all employes on such car or cars are hereby clothed with power to eject from the train or car any passenger who refuses to remain in such car or compartment as may be assigned him; and for such refusal to carry such ejection neither the conductor nor the employes nor the railroad company shall be liable for damages in any court.

## WHITE SCHOOLS.

### To Get the Money of White Tax Payers.

Representative D. R. Julian has introduced a bill in the Legislature to amend the Constitution of the State so that school taxes paid by the white race shall go to the white schools, and the taxes of the colored race to the colored schools. His bill reads as follows:

Section 1. That Section 2 of Article IX of the Constitution of North Carolina be amended by striking out all after the word "schools" in the eighth line thereof and inserting: "and all the moneys arising from the taxation of the polls and property of the white race for public schools shall be appropriated to the support of the public schools of the white race; and all the moneys from the taxation of the polls and property of the colored race for public schools of the colored race."

Sec. 2. This amendment, when agreed to by three-fifths of each house of the General Assembly, shall be submitted, at the next general election, to the qualified voters of the whole State; and in the event of its adoption by a majority of the whole vote cast, it shall become a part of the Constitution of this State, from and after the official declaration of such result. At said election, those favoring this amend shall vote a printed or written, or partly printed and partly written, ballot: "For School Tax Amendment;" and those opposed thereto shall vote a similar ballot, "Against School Tax Amendment."

Section 3 of Article IX of the Constitution now reads as follows: "The General Assembly, at his first session under this Constitution shall provide by taxation and otherwise for a general and uniform system of public schools, wherein tuition shall be free to all children of the State between the ages of six and twenty-one years. And the children of the white race and the children of the colored race shall be taught in separate public schools; but there shall be no discrimination in favor of or to the prejudice of either race."

Mr. Julian's amendment is designed to eliminate the last sixteen words and substitute those employed by him in the above bill.

## JOE RAWLS CAUGHT.

### After A Search of Nine Years.

On the 28th day of April, 1890, Messrs. John King and Joe Rawls had a difficulty here over a mule. Both used their postols and both received wounds, King being shot in the hip and Rawls through the leg. King's wound was most serious and he was never able to get up, but died after a confinement of several weeks. Rawls fled, and though many attempts were made to capture him he eluded arrest. In these nine years he has been in all parts of the country and whenever his whereabouts was discovered the effort to arrest him was renewed.

For a year or two past he has been living in Bertie county near Ahoskie and on Thursday last he was arrested and was brought to Greenville Friday evening and delivered to the Sheriff. Rawls has changed but little since he left Greenville about the only noticeable difference in his appearance being that he is some stouter.
