## THE WAR TAX.

### Some Things That Require Stamps.

The Treasury Department has issued a pamphlet containing the revised rulings in reference to tax stamps made by Commission Scott. We publish below some of these rulings that may be of interest to REFLECTOR readers:

A policy of insurance is not valid unless it bears the proper cancelled revenue stamp.

Deeds and mortgages executed by a sheriff, in compliance with an order of the court, are subject to a tax.

Orders for the payment of money, drawn by the secretary of an order or beneficiary society on its treasurer, in favor of a third party, requires a 2-cent stamp.

Certificates of deposit drawing interest, if left a certain time, are taxable, first, at the rate of 2 cents, but left until interest accrues, stamps at the rate of 2 cents per \$100 must be added.

Certificates of "proof of loss" for use of an insurance company, being a statement made as to the facts and circumstances attending a fire, is not a certificate requiring a stamp.

Certificate of protest of every note, bill of exchange, etc, whether protested by a notary public or by any other officer duly authorized by law, must be stamped.

When a sale is made of live stock at a live stock exchange or any similar place, or an agreement to sell entered into, the seller must give to the buyer a bill or memorandum, or other evidence of such sale, agreement of sale, or agreement to sell, to which must be affixed the stamp required—viz, 1 cent for each \$100 in value of such sale, agreement of sale, or agreement to sell, and 1 cent for each additional \$100 or fractional part thereof.

Money orders issued by express companies must be stamped at the rate of 2 cents for each order.

Foreign express money orders cashed in the United States, are subject to taxation at the rate of 2 cents.

A 2-cent stamp is required on an order for cash drawn on a merchant by one of his customers.

If papers in the nature of receipts are given in lieu of checks and are used as commercial instruments, they are checks and not receipts, and are subject to tax.

Mere agreements to build houses are not taxable, but if bonds are included for the faithful performance of work or contracts, they are held to be subject to tax as bonds. Marriage bonds require a stamp of 50 cents.

Where a bond is given with a guaranty company as surety, the bond should have, in addition to a 50-cent stamp, a stamp denoting one-half of 1 cent on each dollar or fractional part thereof, paid by the principal obligor on the bond as a premium.

"Broker's note, or memorandum of sale of any goods or merchandise, stocks, bonds, exchange, notes of hand, real estate or property of any kind or description issued by brokers or persons acting as such, for each note or memorandum of sale, not otherwise provided for in this act, 10 cents."

## UNCLE JESSE DEAD.

Greensboro, Jan. 7.—Rev. J. A. Cuninggim died at his home in this city at 9 o'clock tonight. He had been ill for some time, but the immediate cause of his death was heart failure. The funeral will take place Monday.

Uncle Jesse, as he was called for many years, was one of the oldest members of the North Carolina Conference, M. E. Church South. After long and successful service in the pastoral relation he was called to the responsible work of presiding elder. In that capacity he served the Raleigh district four years, and with the close of the last conference year completed his time limit on the Durham district. Admonished by failing health and the infirmities of age, he realized that his work in the ministry was finished. He was too feeble to attend the conference at Elizabeth City, but he wrote a very pathetic letter to his fellow laborers in the ministry, asking to be placed in the superannuated relation. His request was granted with the hope that his life would be spared yet a long time. But that was not to be: his earthly career closed within a few weeks after he laid down his work.

## WINSTON ELECTION LAW AMENDMENT.

[CONCLUDED FROM YESTERDAY]

Sec. 7. No male person who was on January 1, 1867, or at any date prior thereto, entitled to vote under the Constitution or statutes of any State in the United States wherein he then resided, or who prior to that time was a regularly enlisted soldier in the army of the United States; and no person, son or grandson of any such person not less than 21 years of age at the date of the adoption of this Constitution; and no male person who was naturalized prior to the first day of January, 1900, shall be denied the right to register and vote in this State by reason of his failure to possess the educational or property qualification prescribed by this Constitution; provided he shall have resided in this State for five (5) years next preceding the date at which he shall apply for registration, and shall have registered in accordance with the terms of this Article prior to September 1, 1900; and no person shall be entitled to register under this section after said date.

This section also provides for the method which such persons shall pursue to secure the benefits of the above, and provides also the oath he shall take; also for a separate registration of this class of voters, and all whose names appear thereon shall be permitted to vote at all elections in the State, etc.

Sec. 8. Provides for the payment of poll tax of all persons under the age of 60 years; and provides that no such person shall be permitted to vote unless such payment is made on or before the 31st day of December of each year for the two (2) years preceding the year in which he offers to vote. All between the ages of 21 and 60 not herein exempted come within this provision.

It is also required by this section that the poll tax receipt for said time shall be exhibited to the election officer in official form, or duplicate in event of loss, or proof of payment of such poll tax shall be produced by the affidavit of the party to whom it was paid.

Heavy penalty is imposed for changing or altering in any way one of these receipts; and any tax collector, sheriff or other person who shall ante-date such shall be guilty of forgery?

have paid all poll taxes assessed against them.

Sec. 9. This section provides the oath to be taken by office holders.

Sec. 10. Defines who shall be eligible to office. Also provides for the submission of this Amendment to the Constitution to the voters of the State, after ratification—"on the Tuesday after the first Monday in May, 1900." The election is to be conducted and held under the same rules and regulations as are provided in the law regulating elections in this State and in force May 1, 1899—that is to say, under the new election law to be passed by the present General Assembly.

## WASHINGTON LETTER.

From Our Regular Correspondent.

Washington, D. C., Jan. 9, '99. Senator Mason fired an unexpected bomb-shell into the ranks of the Philippine annexationists when he offered his resolution, starting with a quotation from the Declaration of Independence—"Whereas, all just powers of government are derived from the consent of the government"—and declaring that the U. S. will not attempt to govern the people of any other country without the consent of the people themselves or subject them by force to our dominion against their will. Unless the attitude of Aguinaldo and his followers changes widely from what the latest official advices state it to be, we have got to govern them by force or not at all.

Representative Bailey won his constitutional fight without a report from the House Judiciary Committee, although the members of the Committee are understood to be unanimous in the belief that the acceptance of a commission in the volunteer army, by a Representative, vacates his seat in the House. Czar Reed won Mr. Bailey's fight for him, by refusing to certify the vouchers for the pay of the three members of the House who hold commissions.

The mail of Southern Senators and Representatives is full of protests from ex-Confederate soldiers against the proposal of Senator Butler, of North Carolina, to give them United States pensions. Senator Pascal presented a formal memorial to the Senate against the Butler idea, from the Confederate veterans of Ocala, Florida.

The House has administered its annual scare to the Civil Service Commission, and it was more real than usual. This time, the House sitting as a Committee of the whole actually voted to strike out the appropriation for the Civil Service Commission, in the Executive, Legislative and Judicial bill. When the yea and nay vote was taken, however, the appropriation got a small majority, and this year's scare was over.

## BLIND MAN'S BLUFF.

The Origin of This Favorite Sport of Childhood and Youth.

This favorite sport of childhood and youth is of French origin and very high antiquity, having been introduced into England in the train of the Norman conquerors. Its French name, "Colin Maillard," was that of a brave warrior, the memory of whose exploits still lives in the chronicles of the middle ages.

In the year 999 Liege reckoned among its valiant chiefs one Jean Colin. He acquired the name Maillard from his chosen weapon being a mallet, where-with in fight he used literally to crush his opponents. In one of the feuds which were of perpetual recurrence in those times he encountered the Count de Lorraine in a pitched battle, and, so runs the story, in the first onset Colin Maillard lost both his eyes. He ordered his esquire to take him into the thickest of the fight, and, furiously brandishing his mallet, did such fearful execution that victory soon declared itself for him.

When Robert of France heard of these feats at arms, he lavished favor and honors upon Colin, and so great was the fame of the exploit that it was commemorated in the pantomimo representations that formed part of the rude dramatic performances of the age. By degrees the children learned to act it for themselves, and it took the form of a familiar sport.

The blindfolded pursuer, as, with bandaged eyes and extended hands, he gropes for a victim to pounce upon, seems in some degree to repeat the action of Colin Maillard, the tradition of which is also traceable in the name, blind man's bluff.—Philadelphia Press.

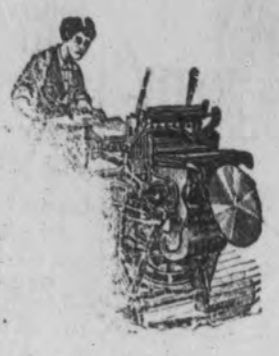
