

THE FOREIGN CORPORATION BILL.

"An Act to Provide a Manner in Which Foreign Corporations May Become Domestic Corporations.

The General Assembly of North Carolina do enact:

Section 1. That every telegraph, telephone, express, insurance, steamboat and railroad company incorporated, created and organized under and by virtue of the laws of any State or government other than that of North Carolina, desiring to own property or to carry on business or to exercise any corporate franchise whatsoever in this State, shall become a domestic corporation of the State of North Carolina by filing in the office of the Secretary of State a copy of its charter, duly authenticated in the manner directed by law for the authentication of statutes of the State or country under the laws of which such company or corporation is chartered or organized, and a copy of its bylaws, duly authenticated by the oath of its secretary. Such corporation shall pay therefor to the Secretary of State, to be turned over by him into the State Treasury, such fees as are or may be required by law.

Sec. 2. That if any such charter or by-laws, or any part thereof, filed in the office of the Secretary of State, shall be in contravention or violation of the laws of this State, such charter or by-laws, or such part thereof as are in conflict with the laws of this State, shall be null and void in this State.

Sec. 3. That when any such corporation shall have complied with the provisions of this act above set out, it shall thereupon immediately become a corporation of this State, and shall enjoy the rights and privileges and be subject to the liability of corporations of this State the same as if such corporation had been originally created by the laws of this State. It may sue and be sued in all courts of this State, and shall be subject to the jurisdiction of the courts of this State as fully as if such corporation were originally created under the laws of the State of North Carolina.

Sec. 4. That on and after the first day of June, 1899 it shall be unlawful for any such corporation to do business or to attempt to do business in this State without having fully complied with the requirements of this act.

Sec. 5. Any such corporation violating any provision of this act shall forfeit to the State of North Carolina a penalty of two hundred dollars for each and every day after the first day of June, 1899, on which such corporation shall have continued to operate or do business without having complied with the requirements of this act. Such penalty shall be recoverable by the Treasurer of the State for the benefit of the State of North Carolina, and it shall be his duty to sue for such forfeiture in the Superior Court of Wake county as the same accrue.

Sec. 6. No telegraph, telephone, express, insurance, steamboat or railroad company which is a foreign corporation of another State doing business in North Carolina shall be allowed to sue in the courts of North Carolina on or after June 1st, 1899 until such foreign cor-

poration has become a domestic corporation either by a special act of the Legislature or under the provisions of this act.

Sec. 7. No such foreign corporation mentioned in the preceding section of this act shall be allowed to enter into a contract in the State of North Carolina on or after the first day of June, 1899, nor shall any such contract heretofore or hereafter made or attempted to be made and entered into by such corporation in the State of North Carolina, be valid or enforceable by such corporation unless such corporation shall on or before the first day of June, 1899, become a domestic corporation under and by virtue of the laws of North Carolina.

Sec. 8. Any such corporation violating any of the provisions of this act by doing any business in this State without first becoming a domestic corporation in the manner prescribed by law, shall, in addition to the penalty prescribed in section 5 of this act, forfeit a penalty of five hundred dollars (\$500) for each day any such business shall be done by it in the State of North Carolina, on and after the first day of June, 1899. The amount so forfeited under the provisions of this section shall be recovered by the Treasurer of North Carolina, and it shall be the duty of said State Treasurer to institute suit for same in the Superior Court of Wake county: Provided the business contemplated in this section of this act does not embrace such business as is strictly the business of interstate commerce.

Sec. 9. That all laws and clauses of laws in conflict with the provisions of this act are hereby repealed.

Sec. 10. That this act shall be in force from and after its ratification.

LETTER FROM DR. NICHOLSON.

LOUISBURG, N. C., Jan 17 '99.

DEAR SIR:

In Louisburg the dispensary has proven such a success that a great majority of our people favor it. Instead of losing friends it has gained many. It has proven a success in that it has reduced liquor drinking to the minimum, while no one feels that his liberties have been abridged, since he can get the liquor when he wants it, provided always that he has the money to pay for it. For this reason this law is more easily enforced than a prohibitory one. For the following reasons then I regard the dispensary the solution of the liquor problem:

1st. Those, who will have liquor get it pure, at reasonable prices, in sealed packages, for cash only.

2nd. The dispensary is closed at sunset and not opened until sunrise.

3rd. The social feature of drinking is eliminated by there being no mixed or fancy drinks and no drinking on the premises.

4th. The sale of this poisonous drug is taken from the hands of unscrupulous men and put under the direct management of bonded officers of the law.

I sincerely believe that it is to the best social, moral and business interest of every town and county to replace the barrooms with dispensaries. Yours sincerely,

THE FIGHT IS ON.

The dodger is likely to have a hard time of it. Better make up your mind to be openly for the bar-room or openly against it. The issue is on. The friends of the open bar-room are already circulating a petition against the Dispensary.

Let no man be deceived as to the issue. On the side of the open bar-room is to be counted all the saloon keepers and their special allies and friends, all who are financially benefitted by the many saloons. On the other side ought to be enlisted all who favor morality, good government, larger revenues for public schools and other purposes and greater prosperity in all other lines of business. It is a plain proposition. Every dollar spent in the bar-room means one dollar less to be spent for dry goods and groceries.

The cry that to close the bar-rooms and open a Dispensary would injure the business of the town is a flimsy falsehood that ought to deceive no one. It destroys no business except that of the bar-keeper.

Fayetteville, Louisburg, Monroe and Waynesville have all had greater prosperity under the Dispensary law than ever before in their history. The tax book proves it.

We are not surprised that all the bar-keepers are opposed to the Dispensary, but how any other citizen having the welfare of the town before him, can put his name and influence on that side is hard to understand.

When asked if the Dispensary had decreased crime in Fayetteville Mr. Robinson, though opposed to the measure, was compelled to reply: "If the reports of the Mayor be true it has reduced crime."

Politicians are proverbially afraid of their own shadows. But why not lay politics aside and act simply as independent citizens. In a private letter Judge Timberlake says the "Good people of Louisburg without regard to politics or religion united in an effort to secure the Dispensary." A similar movement in Greenville would insure success.

The Election Laws of Various States.

In connection with the discussion now going on in North Carolina with reference to the framing of laws for restricting the franchise, the following synopsis of the constitutional requirements for a voter in various States of the Union may prove interesting:

The Louisiana franchise act, which has received much favorable comment among the legislators at Raleigh, provides that a qualified voter must be a citizen of the United States, a resident of the State for two years, the county one year and the precinct six months. "If unable to read and write, as provided by the constitution, then he shall be entitled to register and vote if he shall, at the time he offers to register, be the bona-fide owner of property assessed to him in the State at a valuation of not less than \$300 on the assessment roll of the current year in which he offers to register, or on the roll of the preceding year, if the roll of the current year shall not then have been completed and filed, and on which, if such property be personal only, all taxes shall have been paid."

The South Carolina election law provides that a voter must be a citizen of the United States, a resident of the State for two years, the county one year, the town four months and the precinct four months. He must also have paid for six months before the election any poll tax then due, and must read and write any section of the State constitution, or can show that he owns and has paid all taxes due the previous year on property in the State assessed at \$300 or more.

A voter in Mississippi must be a citizen of the United States, who can read or understand the constitution, and who has paid all taxes. He must also have lived in the State two years and in the county and precinct one year.

The laws of Georgia require that to become a voter a citizen must have resided in the State one year and the county six months, and must have paid all his taxes due since 1877.

Connecticut and Massachusetts require voters to be able to read and write the English language, after a residence in the State of one year.

The States of Rhode Island, Delaware, Maine, Massachusetts, New Jersey and West Virginia exclude all paupers from the right to vote.

In New York State a voter is disqualified if he has been convicted of any crime, or who has paid or promised to pay compensation for giving or withholding votes, or who has laid any wager on the election.

The Vermont law is the most water-tight of all. In that State no person can vote except those "who have obtained the approbation of the board of civil authority of the town in which they reside." These boards have absolute power to say who shall and who shall not vote. It is disfranchisement on a scale never dreamed of in the South.

Persons convicted of felony or other infamous crime, idiots, lunatics and those who deny the being of an Almighty God are not allowed to vote, in North Carolina.

In Delaware a citizen must pay a registration fee of \$1 before he is allowed to cast his ballot.

The new Western States are the most liberal in their franchise re-

quirements. Colorado, Idaho, Wyoming and Utah allow any citizen of the United States, male or female, to vote, after residing in the State six months.

Oregon allows white male citizens of the United States to vote after residing in the State six months.

Tennessee and Pennsylvania require voters to have paid their taxes for the two years preceding the election.

A citizen of California who is unable to read the constitution in English, and write his own name, is not allowed to cast a ballot.

The Australian ballot law, or a plan based on it, is in force in all the States except North and South Carolina.

The requirements for electors in South Carolina, Louisiana and Mississippi serve to almost completely disfranchise the negro voter, and he is, therefore, not a factor in the politics of those States.

The registration of voters is not required in the States of Indiana and Oregon, and it is prohibited by constitutional provision in Arkansas and West Virginia.

Women are allowed to vote on local questions in Arizona, Connecticut, Illinois, Delaware, Indiana, Iowa, Kentucky, Massachusetts, Michigan, Minnesota, Montana, Nebraska, New Hampshire, New Jersey, North Dakota, Ohio, Oklahoma, Oregon, South Dakota, Texas, Vermont, Washington and Wisconsin.

The Louisiana law, with the proper modification, appears to be the favorite among the North Carolina law-makers now in session, and a bill based on its provisions has already been introduced in the Legislature. Any action of the General Assembly looking to the adoption of the Louisiana law, however, must be ratified by the voters at the polls at the next election, as it will include an amendment to the constitution of the State.—Charlotte Observer.

In the days of the Crusades men of the bravest hearts and noblest blood in Europe bound themselves together in a semi-religious, semi-military order under the strongest vows, one of which, curiously enough, was that they would drink only water, in order to defend the Holy Sepulchre against the infidel. Today tens of thousands of men, women, and children are bound together by a solemn obligation of total abstinence from all intoxicants, that they may wage a modern crusade against this curse of nations.

The Power of Pardon.

This Legislature should provide for a Board of Pardons or some committee which shall finally decide whether a person convicted of crime shall have his sentence carried out or be set free. The disadvantage of having this matter of pardons left with one man, the Governor, has been demonstrated quite often in North Carolina and especially during the past few years under the regime of Russell. A few days ago a young forger who had robbed people of Union county by a scheme of swindle and forgery was pardoned out of the penitentiary before he had well begun a just and righteous sentence. The criminal in this case was a dudsily dressed young man who posed as a "sport" and had some friends in this element. The only excuse the Governor gave for the pardon

was the fact that the solicitor had recommended his pardon. If we mistake not, this same solicitor was himself arrested and fined in court for gambling.

It is such pardons as these that create a desire to see the pardoning power taken out of the hands of one man.

When the governor is a good man, but has too tender a heart, he may out of his tenderness extend mercy to scores of criminals who do not deserve it. We have such an instance in the retiring governor of Tennessee, Gov. Boh Taylor, who "never refused a pardon to any man who could give a good reason for it." When an unprincipled man is in the Governor's chair the power becomes dangerous. We have not forgotten that in the election of 1896 a large number of negroes were arrested for flagrant violations of the election law, and it was affirmed that, if convicted, the newly-elected governor would "pardon every one of them out of the penitentiary."

The power of pardon is too great to be left in the hands of one man.—Charlotte News.

WHAT A WORK IS MAN!

The Human Body the Most Wonderful Thing in the World.

Human beings are of all sizes, but the tall man is less common than the short. Only one in every 208 exceeds the height of six feet. For every foot of stature a man should weigh from 36 to 28 pounds, a proportion that is not the lot of all in these hurrying, scurrying days. An average sized man weighs 140 pounds; a woman 125 pounds. Curiously enough, the mean weight and height of lunatics are below those of sane people. Another unexpected thing in this respect is that a negro's skeleton weighs more than that of an Englishman.

The vitalizing power is the blood, a drop of which takes but 22 seconds to go the round of the body. There passes through the heart once every three minutes an amount of this precious fluid equal to all that is contained in the body. The mileage of the blood circulation reveals some astonishing and undreamed of truths. It is estimated that, assuming the average speed of the heart to be 69 beats a minute, the blood travels 207 yards in 60 seconds. In other words, 7 miles an hour, 168 a day or 6,320 per year.

If a man of 84 could have one single blood corpuscle floating in his blood all his life, it would have traversed in that period no less than 5,150,808 miles. The average weight of the brain of an adult male is 3 pounds 8 ounces, of a female 2 pounds 8 ounces. The woman's brain begins to decline in weight after the age of 30, the man's not till ten years later. According to high authorities the nerves, with their branches and minute ramifications connecting with the brain, exceed 10,000,000 in number.

The palms of the hands and soles of the feet are composed of cushions of fat, in order that sudden jolts and violent blows may be successfully resisted and no injury done to the muscles and bones underneath. The muscles—of which the tongue monopolizes 11—and bones of the human structure in combination are capable of more than 1,200 different motions.

The teaching of experience indicates that accidents are far more likely to occur to the right leg and arm than to the left. Further evidence of this fact is supplied by the makers of artificial limbs. They dispose of many more appendages to the right side of the body than to the other. Statistics show that in 54 cases out of 100 the left leg is stronger than the right.

If a man could move his legs proportionally as fast as an ant, he would travel not far from 800 miles an hour. —London Mail.
