Train Sped 100 Miles an Hour.

Omaha, Neb., Feb. 18.—The westbound Burlington fast mail train left Chicago last evening at 10.47. Between Chicago and Burlington it exceeded 100 miles per hour for several spurts. The actual elapsed time between Chicago and Omaha was 9 hours and 14 minutes, actual running time, taking out stops, 8 hours and 44 minutes, for the 502 miles. The best previous record was 9 hours and 23 minutes.

Size of the Tobacco Crop.

Are you in possession of any data bearing upon the size of the tobacco crop in the United States and in Europe. R. E. McH. Charlotte, N. C.

The world's product of tobacco is estimated at 1,900,000,000 pounds, valued at about \$220,000,000. Of this the Western Hemisphere raises about 650,000,000 pounds, the United States contributing 480,000,000 and Cuba, whose tobacco is the widest known and highly esteemed, only producing 62,000,000 pounds. Europe raises about 5,000,000 pounds, the East Indies 400,000,000, Australia 10,000,000 pounds and Africa not enough to be counted. By the addition of our new territories the United States will increase her product by Cuba 62,000,000, Porto Rico 8,800,000 and the Philippines 45,000,000, which will give us a total of 603,800,000 pounds. Of the States in the Union, Kentucky leads with about 185,000,000 pounds, which is far in excess of any other State. North Carolina comes next with only 40,000,000 and Virginia next with 35,000,000.—Atlanta Constitution.

The New Jim-Crow Car Bill.

Section 1. That all railroad companies engaged as common carriers in the transportation, within the limits of the State of North Carolina, of passengers for hire, other than street railways, shall provide separate but equal accommodations on their passenger trains for the white and colored races. Such accommodations may be either separate passenger coaches appropriated exclusively to the use of the white and colored races, respectively, or else by partition of a passenger coach or coaches so arranged as to effect the purpose of this act. Provided, however, that nothing in this act shall be interpreted as applying to freight trains, to relief trains operated in case of accident or emergency, or to through express trains that do not stop at all stations, nor so as to require the separation from their employers of negro servants traveling in attendance upon their employers, nor to officers or guards transporting prisoners, nor to prisoners being so transported. Provided, the provisions of this act shall not be construed to permit officers to carry colored prisoners into cars for the white race.

Sec. 2. The Railroad Commission of this State shall have power, and is hereby authorized to exempt from the provisions of this act any branch lines under fifty miles in length or narrow-gauge roads, if in their judgment the enforcement of this act is unnecessary to secure the purposes hereof and the comfort of passengers by reason of the light volume of the passenger traffic thereon, or the character of accommodations now or hereafter to be furnished.

Sec. 3. On all trains where separate accommodations are furnished as herein provided, the railroad company or companies so providing the same, shall not be required to sell what is known as second-class tickets; provided, however, the first-class rates are reduced to not exceeding three cents per mile; and provided further, that where the Railroad Commission exempts any branch road or narrow-gauge road from the provisions of this act, such branch or narrow-gauge roads shall be required to sell first and second-class tickets at not exceeding the legal rate allowed to be charged by the Railroad Commission.

Sec. 4. That conductors in charge of passenger trains to which the provisions of this act apply, shall have the power and are hereby required to assign to the cars or compartments of cars, when the same are divided by partitions, passengers of the different races to the cars or compartments provided for them, and in the event that any passenger refuses to accept the as-

signment of accommodations made by such conductors, the said conductors and the railroad company for which they are acting, shall have the power and are hereby authorized to refuse to transport such passenger or passengers on such trains, and for such refusal neither the conductors nor the railroad company they represent shall be liable in any court for any damages.

Sec. 5. That any railroad company failing to comply with the provisions of this act shall be deemed guilty of a misdemeanor, and upon conviction in a court of competent jurisdiction, shall be fined not less than one hundred dollars nor more than five hundred dollars; each day the railroad company fails to comply with the provisions of this act shall constitute a separate offence.

Tell It.

The Raleigh Post lays justice down in heavy chunks in the following:

"We cannot refrain from mentioning some incidents of the present cold snap.

"When the whole community was stirred on Monday to provide ways and means to relieve the destitute of this city, one of the first acts was to appoint a committee to ask the aid of the railroads; and when thus approached, both the Southern and Seaboard quickly responded by offering to haul free of charge, fuel to the city.

"When it was reported to Col. Andrews Monday evening that the insane asylum was out of coal he immediately ordered a car-load belonging to the Southern to be delivered to the asylum authorities, which was done, three engines and forty men being required to carry over and unload it.

"And yet these are the great and necessary agencies of enterprise and development, and this is the man whom a certain class of politicians who have yet to render the State 'some service'—some of whom have been large beneficiaries of the State's patronage, as well as patience—seek to oppress and plunder, and prefer to continuously slander and traduce.

"No tale of disaster can be told to any manager of a railroad in North Carolina without meeting with prompt and liberal response; no opportunity can be presented by which they can contribute to the development of the State or any section 'within the sphere of influence' which fails of prompt action. Yet these are special objects of the personal and partisan malice of the few demagogues whom the last election left on the surface. Time vindicates all things."

The Duel Between Mr. Shott and Mr. Nott.

A duel was lately fought in Texas by Hiram Shott and John S. Nott. Nott was shot and Shott was not. In this case it was better to be Shott than Nott. There was a rumor that Nott was not shot and Shott avows that he shot Nott, which proves either that the shot Shott shot at Nott, was not shot, or that Nott was shot notwithstanding. Circumstantial evidence is not always good. It may be made to appear when the trial comes off that the shot Shott shot shot Nott, or as accidents with firearms are frequent, it may be possible that the shot Shott shot shot Shott himself, when the whole affair would resolve itself into its original elements and Shott would be shot and Nott would be not. We think, however, that the shot Shott shot, shot not Shott but Nott. Anyway, it's hard to tell who was shot and who was not.

Under the Act of Congress of March 30 last permitting the filing of claims for indemnity on account of the Maine disaster there have already been presented 325 claims, aggregating \$123,342. The list will be largely increased when the claim agents shall have exhausted the possibilities of the permissive statute. These claims are entirely apart from the pension account which must be kept with the ninety-four survivors and the relatives of the 261 victims of the catastrophe. When all shall have been settled the sinking of the Maine may well be reckoned among the most costly disasters in the world's naval history.—Philadelphia Record.

Mechanical gambling devices will probably be driven out of business in Oklahoma through a recent decision of the United States District Court, which has ruled that when a man makes round metal disks, not stamped in imitation of money, and beats slot machines with them, he does not violate the law. The disks are not counterfeit, and it is not swindling to rob an illegal game.

At Caldwell, Kan., the other day a man chastised his neighbor for referring to his child as a "kid." When the case was brought before a justice of the peace Webster's Dictionary was consulted, and it was found that "kid" was there defined as "a young child or infant." The indignant parent was thereupon adjudged to have been in the wrong, and was fined \$5 and costs.
