Let Congress Take Warning

It is reported that Great Britain has waived all privileges under the Clayton-Bulwer treaty, and has consented to the construction of the Nicaragua Canal by the United States. If this is true, Congress had better take warning. Great Britain is not in the habit of conceding any thing that is of value. The fact is, England has never attached slightest value to a canal across Nicaragua. Some years ago when the defunct canal company sent agents to London to arouse interest in this enterprise, the British declined to enthuse, and British engineers denounced it as a chimera, as they did a number of years ago when it was first surveyed. Not a single European engineer of note has ever endorsed it and the same may be said of the engineers in this country.

England would be more than willing for the United States to waste untold millions of dollars upon this impracticable scheme. If it were built she would be able with her immense navy to command it, just as she has done at Suez, and she is always willing to have her chestnuts pulled out of the fire. But British, Belgium, Germany and French engineers know very well that no canal suitable to commerce can be constructed over the Nicaragua route by any system of engineering known to the profession. Entrance and exit are insuperable obstacles, for the removal of which not a single suggestion has yet been made which will command the attention of a first class engineer. The winds and waves and flats can be controlled for a certain distance, but not when they extend miles out to sea. A rampart costing \$10,000,000 would disappear in a month, and sandbanks would pop up in the channel dug out for commerce. No navigation company after one such experience, would again risk its vessels. It would as soon think of sending them to the stars.

To vote millions for such an enterprise looks as if there was more money in the Treasury than Congress knew what to do with, and that congress was anxious to get rid of it. The route itself, if carefully examined ought to convince prudent men of its unfitness. Why try to go one hundred and ninety miles over land in expensive ships when the trip can be made forty-five miles? Where is the route to supply the depth for 15,000

ton ships? The San Juan, which is to furnish of the supply, is about two feet deep at some points, and much less at others. Lake Nicaragua is a shallow concern, which holds out no promise whatever of permanent supply, and the sea on either side is too shallow to provide water a mile from the entrance. If Congress passes the Nicaragua bill it will involve the United States in the most colossal scandal of all the ages, and it will do it in defiance of the fact that a commission, created by itself, is now engaged in seeking accurate information—Baltimore American.

A Stove to Italy.

Higgs & Taft a few days ago sold a Buck's stove that goes to Italy. The purchaser had the stove shipped from Greenville to New York and from the latter place re-shipped to Italy. We doubt if any other retail stove house in North Carolina ever made such a sale as this.

THE COTTONSEED OIL INDUSTRY.

The cottonseed oil industry is becoming an important factor in the development of the cotton States of the South. The growing prosperity of the cotton planters of that section is in no small measure due to their ability to sell at a substantial price a large part of their product which a few years ago had no market value. It is estimated that to every 500 pounds of cotton there is about 100 pounds of seed, which is worth, at the present market price, \$12 to \$17 per ton—the price depending on its nearness to a market. The value of the seed is, therefore, equivalent to nearly two cents per pound added to the price of the cotton, and at best market quotations it practically brings that staple up to nearly 10 cents per pound. There appears to be an unlimited demand for cottonseed oil. Being a vegetable product, it has the preference over lard for domestic purposes in many households, and its uses are multiplying in other directions. Cottonseed meal, from which the oil has been extracted, is a rich food for farm stock, and is extensively taking the place of Western grain, which in former years was the Southern planter's almost sole dependence for stock feeding. The manufacture of cottonseed oil has generally yielded large profits, and the building of mills is going forward actively in all parts of the cotton growing sections. The manufacture of the oil is becoming one of the leading industries in that part of the country, and it will not be long till every planter in the South will have as good market for the seed as for the cotton itself.

Meanwhile there is a boom in the building of cotton mills in many of the cotton States, and sanguine & enterprising Southerners confidently believe that it will continue so long as there shall be a bale of raw cotton to ship out of the South. With large quantities of cotton on the ground, and a ready remunerative market for their waste product, it looks as though the long period of hardship for Southern planters had ended, and that their turn for profit and prosperity had come round.

We rejoice in the good fortune apparently in store for our Southern neighbors; for, sentiment aside, we of the North have good reason to wish them the largest measure of prosperity. Their increasing demands for all kinds of products will stimulate Northern industry, and will insure steady employment for Northern working people. If cotton production shall again become safely profitable it will tend wonderfully to round out and make permanent the prosperity of the whole country.—Philadelphia Record.

THE AMENDMENT.

The following is the amendment to article 6 of the State constitution, adopted by the General Assembly of 1899, and to be submitted to the voters for ratification next August:

Section 1. That article VI of the constitution of North Carolina be and the same is hereby abrogated and in lieu thereof shall be substituted the following article of said constitution:

ARTICLE VI.

SUFFRAGE AND ELIGIBILITY TO OFFICE—QUALIFICATIONS OF AN ELECTOR.

Section 1. Every male person born in the United States, and every male person who has been naturalized, twenty-one years of age, and possessing the qualifications set out in this article, shall be entitled to vote at any election by the people in the State, except as herein otherwise provided.

Sec. 2. He shall have resided in the State of North Carolina for two years, in the county six months, and in the precinct, ward or other election district in which he offers to vote, four months next preceeding the election; Provided, That removal from one precinct, ward or other election district to another in the same county, shall not operate to deprive any person of the right to vote in the precinct, ward or other election district from which he has removed, until four months after such removal. No person who has been convicted, or who has confessed his guilt in open court upon indictment of any crime the punishment of which is, or may hereafter be, imprisonment in the State prison, shall be permitted to vote, unless the said person shall be first restored to citizenship in the manner prescribed by law.

Sec. 3. Every person offering to vote shall be at the time a legally registered voter as herein prescribed and in the manner hereinafter provided by law, and the General Assembly of North Carolina shall enact general registration laws to carry into effect the provisions of this article.

Sec. 4. Every person presenting himself for registration shall be able to read and write any section of the constitution in the English language; and, before he shall be entitled to vote, have paid on or before the first day of March of the year in which he proposes to vote, his poll tax as prescribed by law, for the previous year. Poll taxes shall be a lien only on assessed property, and no process shall issue to enforce the collection of the same except against assessed property.

Sec. 5. No male person who was, on January 1, 1867, or at any time prior thereto, entitled to vote under the laws of any State in the United States wherein he then resided, and no lineal descendant of any such person, shall be denied the right to register and vote at any election in this State by person of his failure to possess the educational qualifications prescribed in section 4 of this article: Provided, he shall have registered in accordance with the terms of this section prior to December 1, 1908. The General Assembly shall provide for a permanent record of all persons who register under this section on or before November 1, 1908, and all such persons shall be entitled to register and vote at all elections by the people in this State, unless disqualified under section 2 of this article: Provided, such persons shall have paid their poll tax as required by law.

Sec. 6. All elections by the people shall be by ballot, and all

elections by the General Assembly shall be viva voce.

Sec. 7. Every voter in North Carolina, except as in this article disqualified, shall be eligible to office, but before entering upon the duties of the office he shall take and subscribe the following oath: "I, _____, do solemnly swear (or affirm) that I will support and maintain the constitution and laws of the United States, and the constitution and laws of North Carolina not inconsistent therewith, and that I will faithfully discharge the duties of my office as _____ So help me, God."

Sec. 8. The following classes of persons shall be disqualified for office: First, all persons who shall deny the being of Almighty God. Second, all persons who shall have been convicted or confessed their guilt on indictment pending, and whether sentenced or not, under judgments suspended, of any treason or felony, or any other crime for which the punishment may be imprisonment in the penitentiary, since becoming citizens of the United States, or corruption and malpractice in office, unless such person shall be restored to the rights of citizenship in a manner prescribed by law.

Sec. 9. This act shall be in force from and after its ratification.

Doubtless it will be a surprise to many to read the statement that there is a country in the world in which it is a crime to smoke. Rut such is the case in Abyssinia. The Penny Magazine tells in a paragraph that the law forbidding the use of tobacco their dates from 1642. It was first merely intended to prevent smoking in the churches, but it was taken too literally; and now even foreigners who smoke there at all have to do so subrosa, as if they were still school-boys.—Scotland Neck Commonwealth.

What 50 Cents and a Dozen Goose Eggs Bought 70 Years Ago.

Mr. H. A. Cathey, of Steele Creek township was in the city yesterday brandishing (in a friendly way) a razor that his father bought 70 years ago. The razor has been scraping beards ever since and is yet in good condition. Mr. Cathey's father paid 50 cents for it. Mr. Cathey also showed a buckskin pocketbook which his father bought at the same time he got the razor. He traded a dozen goose eggs for the pocketbook. The old buckskin like the razor still does good service.—Charlotte Observer.

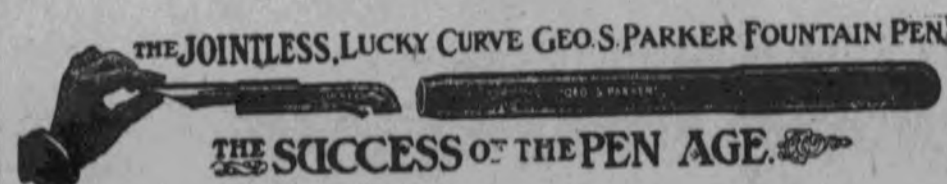
