WOMAN IN JAIL.

Tried to Commit Suicide.

Annie Dixon, the colored woman who poisoned her husband by putting rough-on rats in his coffee, at Calico, was arrested Monday and brought to Greenville and placed in jail.

Before being arrested she attempted suicide by cutting her throat in two places. Neither of the gashes were deep enough to prove fatal and both were sewed up by the doctor.

The Coroner found that it was not necessary to perform a post mortem examination upon the dead man as there was sufficient evidence that he was poisoned by his wife.

She has been in a stupid condition since the attempt at suicide and has nothing to say about her reason for killing her husband.

OUR RALEIGH LETTER.

Personal Work Needed—Political Outlook after Six Weeks of Campaigning—Danger in Overconfidence!

Special Correspondent of Reflector.

RALEIGH, N. C., May 28, 1900.

Several of the Democratic State candidates were here last week, and I talked with them. It has been six weeks now since they began their splendid campaign. Within that period they have done much for the cause they present. So far as argument and oratory along general lines would accomplish it, they have made converts of many who listened to the great political truths they proclaimed—for the man who will not be impressed through the medium of such a skillful debater and peerless orator as the matchless Aycock cannot be reached by such methods.

PERSONAL WORK REQUIRED.

And here is the first point I desire to raise: All voters cannot be reached by such means; as a matter of fact, there is a large percentage of them who are laboring under error in this campaign that will never be brought within the fold of Democracy by this method alone I fear—and in making this assertion I am supported by no less authority than Mr. Aycock himself. Personal work is needed! Democrats want to talk and urge with their neighbors about the great issue of this campaign especially in the west where many well-meaning white men have been lied to by the opposition with regard to the effects upon them of the adoption of the amendment. A world of good can be accomplished this way.

DANGER OF OVERCONFIDENCE.

Another matter of importance is to guard against that often fatal error, over confidence. I have seen and talked with several of the candidates on the State ticket the past week. While all of them are exceedingly hopeful and sanguine and almost assured of success—certainly if the election should occur to-morrow—yet each of them spoke of the danger of overconfidence. Let our people "keep up the lick" until after the closing of the polls. Be not weary in well doing. Relax not your efforts or your vigilance for a single day, a single hour. The enemy's campaign will be carried on largely on bush-whacking principles—and you've got to watch 'em.

ACTION OF THE EXTRA SESSION

We are beginning to make arrangements here to receive the legislators who soon will assemble in adjourned session, and it is to be hoped that every democratic member will be present. While, of

course, no general legislation will be taken up, it is probable that a few matters which urgently demand attention just now will receive it. Three of these are the passage of the Textile School bill; the legalizing of the State Primary for Senator, and the modification of the law which unexpectedly compelled some of the leading insurance companies to cease business in North Carolina—a result never intended.

I hear that when the session adjourns it will not be a sine die adjournment, but that another recess will be taken, so that if necessary the body can again assemble in adjourned session.

NORTH CAROLINA'S "SUMMER CAPITAL."

The gayest place in North Carolina for the the next four months, and the most comfortable and enjoyable, will be Morehead City—and when we say Morehead City we mean of course the Atlantic Hotel there, which is the biggest part of the "city" and the mecca of pleasure-seekers and tired and worn-out business men and their families on the hunt for a suitable place to recuperate. For several years the "Atlantic" has been one of the most popular seaside resorts in the South, but this season (and the season there begins there next Friday) it will eclipse all former records and vie and compete in the splendor of its entertainment with any similar resort North or South.

I had a talk today with Mr. Beauregard Poland, the traveling representative of the "Atlantic," and in reply to my inquiries as to the character of the guests and the territory to be drawn on this season, he surprised me by showing me a partial list of the "bookings" he has made lately in reserving accommodations for some of the best known public men and representative business and professional men (and their families always) in seven States, viz., Kentucky, Tennessee, Alabama, South Carolina, Virginia, Georgia, Mississippi and also Washington, especially from Richmond, Atlanta, as well as many other Southern cities and towns. Many of these names any one would recognize by reputation.

As to North Carolina, the management state that there has never been such a large nor so desirable a crowd as is promised this season, and preparations for their comfort and entertainment were never so elaborate and well looked at before.

This season the Messrs. Barbee, of Raleigh, proprietors, have secured two of the best hotel and summer resort men in the country to manage the Atlantic—Messrs. G. W. and L. W. Scoville, of Atlanta, proprietors of the Aragon hotel of Atlanta. It is said their superior is not to be found.

Next Friday night, June 1, the opening ball will take place in the magnificent ball room of the Atlantic, and from then on there will be a constant round of important and pleasurable events taking place. Raleigh will send several hundred guests, including most of her beautiful women.

LLEWXAM.

The Associated Press Declared a Common Carrier.

The Illinois Supreme Court has denied the application of the Associated Press for a rehearing in the suit of the Chicago Inter-Ocean Publishing Company against that organization. The court some weeks ago rendered a decision to the effect that the Associated Press was a common carrier and must supply its news service to the Inter-Ocean.

The Associated Press at once entered a motion for a rehearing of the case, on the ground that it was

not a common carrier, but a private enterprise conducted by a committee representing its membership. The decision given finally disposes of the issue between the two parties.

As has already been noted, the Inter-Ocean as soon as the original decision was made at once entered notice of suit against the Associated Press for \$500,000 damages.

The papers in the case have been duly registered with the clerk of the Circuit Court. The claim of damage set forth is that in consequence of the action of the Associated Press in debarring the Inter-Ocean Publishing Company from receiving its news reports the plaintiff has been compelled to spend for the correspondence service \$50,000 for telegraph tolls \$50,000, and for court costs and attorney's fees \$25,000.

The Inter-Ocean further alleges that its loss of receipts in circulation aggregate \$50,000, and its loss of advertising patronage to \$50,000. In addition to these claims the plea is advanced that it has otherwise been greatly injured in its good name, the total injury being placed at \$500,000.

The officers of the Associated Press have not yet decided what steps will be taken to meet the decision of the court. Under its present charter it must obey the law, and will undoubtedly do so.

The decision of the Supreme Court of Illinois, of course, carries no weight outside of that State. It is possible that similar suits may be brought against the Associated Press elsewhere on the same grounds as those taken in the case of the Chicago Inter-Ocean.—The Fourth Estate.

WASHINGTON LETTER

From Our Regular Correspondent.

WASHINGTON, D. C., May 28, 1900.

Republican Senators consented to a Congressional investigation of all Cuban accounts, as proposed by Senator Bacon's resolution, not because they wanted an investigation, but because they feared to defy a practically universal public demand for one. They are now trying to devise schemes that will enable them to keep the investigation in their own hands, but democratic Senators are wide-awake and intend to participate in that investigation, and if possible, they are going to have another for Porto Rico, where there has been great extravagance in the payment of double and in some cases triple salaries to postal employes, if no actual stealing. It is also generally believed that affairs are quite as bad, if not worse, in the civil branch of our government in the Philippines, and there are scandals even in the Washington City Post Office.

The anxiety of the republican leaders to hurry adjournment is amusing. Although they have a good big majority in both branches, they act as if they were afraid that Congress would do something they didn't want it to do, if adjournment wasn't rushed. It is hardly likely that adjournment will take place June 6, the date set by the House resolution, but it will as soon thereafter as the republican leaders in the Senate can get the appropriation bills out of the way.

Representative Talbert, of South Carolina has been making another warm speech on the Pension question, his text being the case of the Michigan man who draws \$1800 a year as a clerk in the Interior Department, and \$1200 a year as private Secretary to Representative S. W. Smith, of Michigan, and who has been voted by Congress a pension of \$72 a month for total disability. Representative H. C. Smith, cited the case of Justice

Long, of the Supreme Court of Michigan, who draws a pension of \$140 a month as an excuse for this case, and Mr. Talbert said in reply: "Two wrongs do not make one right. The gentleman asks now because one man is robbing and plundering the government unjustly and unmeritoriously, that another man may be placed on the pension roll and receive a high pension. That is the trouble about this indiscriminate grabbing of pensions. One man gets in and another man wants to get in. Members have their friends and they will not vote against each other. They will not have the reports read because they sit here like dummies saying, 'Oh, they will reach my case next.' That is what is the matter. You want to do a dozen wrongs to make one right and you want to continue to do wrong in order that your own cases may be favorably acted upon. I want to see justice done by the old soldiers and I will help do it everytime if I can, but I do not want to give any soldier what he does not deserve."
