COUNTY COMMISSIONERS.

Proceedings of December meeting.

The Board of County Commissioners began the new fiscal year on the first Monday in this month.

The usual pauper orders were issued and claims for general county purposes were allowed.

At 12 o'clock the new Board with the exception of C. J. Tucker who was absent, qualified and R. L. Davis was elected chairman.

T. R. Moore, Register of Deeds elect, presented his official bond with S. T. White, W. F. Hart, W. E. Proctor, R. A. Tyson and Chas. Cobb as sureties, which was accepted and the oath of office administered.

The former bonds of D. C. Moore Clerk Superior Court, were examined and deemed amply sufficient.

O. W. Harrington, Sheriff elect, tendered his official bonds with J. O. Proctor, W. E. Proctor, B. F. Patrick, J. A. K. Tucker, J. B. Galloway, W. G. Mizelle, G. T. Tyson, G. M. Tucker, G. M. Mooring, Oscar Hooker, R. W. King, J. G. Moye, C. D. Rountree, R. Greene, L. I. Moore, J. L. Perkins, J. R. Davenport, R. R. Fleming, John M. Cox and T. O. Cannon as sureties, which were approved and the oath of office administered.

J. D. Cox, Surveyor elect, tendered his official bond with A. G. Cox as surety which was accepted and the oath of office administered.

J. B. Cherry, Treasurer elect, tendered his official bonds with Jesse Cannon, J. R. Moye, J. G. Moye, McG. Ernul, G. M. Mooring, as sureties which were accepted and the oath of office administered.

J. A. Harrington, Standard keeper elect, presented his official bond with J. R. Smith and J. A. Davis as sureties, which was accepted and the oath of office administered.

Abram Baker, Constable elect of Pactolus, township, tendered his official bond with G. H. Little, and R. R. Fleming as sureties, which was accepted and the oath of office administered.

Joseph McLawhorn, Constable elect of Contentnea township presented his official bond with J. R. Smith and W. B. Quinerly as sureties, which was accepted and the oath of office administered.

W. G. Little and H. A. Blow were appointed as committee to examine reports of the various county officers.

The Sheriff was ordered to place two stoves in the jail and have windows repaired; also to confine prisoners in cells at night, and not to allow at any time more than two in the passageway.

J. B. Cherry, Treasurer, and C. O'H Laughinghouse, Superintendent of Health, filed their monthly reports.

Lands of Woodie McLawhorn in Contentnea township were reduced in value from \$71.0 to \$500.

Ordered that B. F. Tyson's claim for taxes paid on land at Sheriff's sale in 1898 be allowed.

M. M. Ewell was released from taxes on \$892 solvent credits erroneously charged.

G. E. Jackson was released from taxes on \$200 erroneously charged.

C. O'H. Laughinghouse, Coroner elect, tendered his official bond with T. M. Hooker and J. L. Wooten as sureties, which was accepted and the oath of office administered.

A petition for a new road from Winterville to the Tar road across the lands of J. B. Carroll and others was filed.

Now good people, let your interest in the welfare of Greenville assert itself. The Board of Aldermen have called a special meeting in the Court House next Thursday night, 13th, to consider the matter of preparing a bill to present the coming Legislature asking that Greenville be allowed to hold an election on the question of issuing bonds for the construction of electric lights, water works, better streets and sewerage. The Board requests that all citizens interested in this matter be present at the meeting Thursday night. This request ought to bring every man in town to the meeting, for there is not one but should be interested in securing the improvements suggested. Greenville has plodded in the old ruts long enough, and it is time we were getting out of them. These matters under consideration are urgent needs of the town, and the sooner they are secured the better it will be for our progress.

As was mentioned some days ago the Legislature to meet next month will be confronted with the great question of how to get more taxes, as during the fiscal year, which ended November 30 last, the excess of disbursements over direct receipts was \$178,000. There will certainly be a pressing call for more money for the public schools, which now get \$963,000, and which it is urged ought to have at least \$1,500,000. There are three ways of raising more taxes; one by an increase of assessments of all property, another by taxing railroads more either in general valuation along with other property or else by a tax on receipts; a third by an inheritance and legacy tax and a tax on oysters which will really amount to something. If any one will take the trouble to ask the State Auditor about the general taxes he will no doubt be told that property is not taxed at more than two thirds of its actual value. The investigation of the tax assessment case now in progress appears to have quite well confirmed this statement. A preacher testified that his farm, worth \$15,000, was assessed at only \$5,000. A great deal of property escapes taxation—Raleigh correspondent Charlotte Observer.

TOWN MATTERS.

Meeting of Board of Aldermen.

The Board of Aldermen met in regular monthly session Thursday night, six of the members being present.

The several standing committees made their monthly report.

The Market House Committee was authorized to make some needed repairs to the guard house.

The Street Committee was authorized to lay out a street between Fourth street and Fifth street near the property of G. B. King and E. B. Ficklen in West Greenville.

A special committee consisting of Aldermen J. B. White, J. N. Hart and B. F. Patrick was appointed to have settlement with Alderman O. E. Warren, Cemetery Committeeman, for funds received by him from sale of lots in cemetery.

A motion to reduce the license tax on tobacco pinhookers from \$5 to \$2.50 per year was lost.

Dr. C. J. O'Hagan appeared before the Board with a letter from Dr. Richard H. Lewis, Secretary of the State Board of Health, requesting that vital statistics of the town be furnished him. The Clerk was instructed to write the Secretary for such blanks as are necessary to make the reports and distribute them among the physicians of the town and request them to hand in statistics monthly.

The Tax Collector and Policemen made their reports for the past month showing amount of collections.

A special meeting of the Board was called for Thursday night, 13th at the Court House, to consider the matter of preparing a bill to go before the next Legislature to authorize Greenville to hold an election on the question of issuing bonds for the construction of electric lights, water works, sewerage, etc. All citizens of the town are requested to attend this meeting and confer with the Board on the matter.

The town attorneys were instructed to prepare an answer to the complaint filed in the suit brought against the town by the Board of County School Directors for fines collected by the town.

S. M. Daniel was allowed to list taxes for 1900.

A restaurant license was granted to Austin Hanrahan, in tobacco town.

Accounts were allowed and orders issued amounting to \$695.80.

Dr. Kilgo Endorsed.

The following resolution was adopted by the North Carolina Conference now in session at New Bern:

Whereas, Certain events having recently transpired touching the moral integrity of Dr. J. G. Kilgo, President of Trinity College, W. R. Odell, member of the M. E. church, South in Concord, N. C., and B. N. Duke, of Main street, Methodist church, Durham, there fore, be it,

Resolved That this Conference has unabated confidence in the said J. C. Kilgo, W. R. Odell and B. N. Duke, and assure these brethren that it shall be the pleasure and faith of this Conference to aid them in overcoming, in the name of our Lord, the efforts being made to destroy our college and to damage the influence of the Methodist church in North Carolina.

Resolved that in our judgment the church will be more united than ever in her prayer and held and purpose to sustain the college, with its able President and faculty, and we hereby offer to the Messrs. Duke the most generous benefactors of the college our sincere thanks for their support of the institution
