TOWN MATTERS.

Transacted by Board of Aldermen—Bond Election Called.

The Board of Aldermen met in regular session Thursday night, every member being present.

Alderman-elect D. E. House, from Third ward to succeed J. C. Albritton, resigned, was sworn in.

The Board first took up the matter of providing for the bond election to be held on the second Tuesday in April in accordance with the bill passed by the General Assembly of North Carolina. The following Registrars and Poll holders were appointed for the several wards, the election in each to be held at the places designated:

FIRST WARD.

Registrar, J. B. Jarvis. Poll holders, W. J. Cowell and S. P. Humphrey. Voting place, colored Odd Fellows hall.

SECOND WARD

Registrar, Charles John O'Hagan. Poll holders, J. L. Sugg and L. C. Arthur. Voting place, office on corner of Clark property.

THIRD WARD.

Registrar, L. W. Lawrence. Poll holders, H. C. Hooker and H. A. White. Voting place, Court House.

FOURTH WARD.

Registrar, W. L. Brown. Poll holders, J. G. Bowling and T. E. Hooker. Voting place, Marcellus Moore store.

FIFTH WARD.

Registrar, A. A. Forbes. Poll holders, J. C. Lanier and H. C. Ormond. Voting place, Farmers Warehouse.

A new registration of voters was ordered for this election.

All resident physicians of the town were authorized to vaccinate any and all citizens of the town presenting themselves for that purpose, and to charge the town 25 cents for each person vaccinated, the town also to pay for the virus so used.

The finance committee reported about \$2,700 in the treasury.

The street committee reported that in addition to general work done during the past month, lumber had been purchased and the bill approaching the river bridge

put in good condition.

The other committees had no special reports to offer, except that everything in their respective departments was in good condition.

The Tax Collector, Assistant Police and Chief of Police made their monthly reports.

The Board decided that to restore the recently partially burned building belonging to McGowan and Weathington, on Fifth street, should be constituted repairing said building.

M. L. Starkey & Bro. were granted a duplicate retail liquor license, their original license having been destroyed in the late fire.

A petition from S. P. Humphrey to be released from taxes on a town lot charged against him, which he did not own, was referred to the Tax Collector to investigate and make such correction as the case required.

The street committee was instructed to purchase new harness for the town team.

A. J. Griffin tendered his resignation as Chief of the Fire Department, and stating that he could not serve longer the resignation was accepted. A committee was appointed to draught resolutions expressing the regret of the Board at the resignation of the Chief and thanking him for his faithful services to the town.

Accounts amounting to \$459.15 were allowed and ordered paid.

Henry Duff was ordered to continue to care for Frank Hines, the colored man who was so badly beaten and left for dead in the railroad cut some weeks ago, until other arrangements are made.

It Is Repairing.

As long as no one else would solve the problem, the Board of Aldermen settled it for themselves by saying it was repairing and not erecting a building. So the Fifth street owners get back their house that the fire came so near taking away from them. The Board is ready for the next puzzle that may be sprung on them.

ELECTION NOTICE.

To the Voters of the Town of Greenville.

Whereas, the General Assembly of North Carolina, at its present session, has passed an act entitled "An Act to Authorize the Town of Greenville to Issue Bonds for Works of Improvement" to the amount of Seventy Five Thousand Dollars, if the qualified voters of the town shall so vote at an election to be held on the second Tuesday of April, 1901.

And whereas, the Board of Aldermen of said town at a meeting held on the 7th day of March, 1901, in accordance with said act did designate the following places in the several wards in which said election should be held on the said second Tuesday in April, 1901 from 8 o'clock a. m. to 6 o'clock p. m., to wit:

First Ward—at the Colored Odd Fellows Hall on Front street.

Second Ward—at the Clark office on corner of Third and Greene streets.

Third Ward—at the Court House on Evans street.

Fourth Ward—at the Marcellus Moore store on Five Points.

Fifth Ward—at the Farmers Warehouse on Dickinson avenue.

At said meeting the said Board also appointed the following named persons as Registrars and Judges of Election to hold and conduct such election, to wit:

First Ward—R. B. Jarvis Registrar. W. J. Cowell and S. P. Humphrey Judges.

Second Ward—Chas. Jno. O'Hagan Registrar. J. L. Sugg and L. C. Arthur Judges.

Third Ward—L. W. Lawrence Registrar. H. C. Hooker and H. A. White Judges.

Fourth Ward—W. L. Brown registrar. J. G. Bowling and T. E. Hooker Judges.

Fifth Ward—A. A. Forbes Registrar. J. C. Lanier and H. C. Ormond Judges.

And whereas by said act a new registration of the qualified voters is required to be had, notice is here by given that the registration books of the several wards will be opened for the registration of the qualified voters at the voting places herein before prescribed, from 2 o'clock P. M. to sunset on Tuesday, Wednesday and Thursday preceding said day of election, but such registration may be made on other days previous at any other place in said town.

At said election all persons whose names are found upon the registration books shall be entitled to vote for or against issuing the bonds. Those desiring to vote for it shall vote a written or printed ticket with the words "For Bonds" and those desiring to vote against it shall vote a written or printed ticket with the words "Against Bonds."

Now, therefore, I, Joseph G. Moye, Mayor of the town of Greenville, in accordance with said act, do hereby issue this notice or proclamation calling said election to be held and conducted on the second Tuesday in April, 1901 for the purpose and in the manner prescribed in the aforesaid Act of the General Assembly.

It is the duty of every citizen interested in the future of Greenville to work for the bond issue. The measure should be carried at the election to be held on the second Tuesday in April.

The fact stands out prominently that Greenville needs improvements, and needs them badly. Without these improvements the town will make no progress for years to come. We must either go forward or retrograde, and without the contemplated improvements the latter is inevitable. Every one should work to adopt the bond issue.

Papers of incorporation have been taken out for the Neuse milling Co., of Kinston, to manufacture meal and flour and the buying of hay, grain, wood and coal, the capital stock being \$3,300, with privilege of increasing to \$10,000. The incorporators are Mess. J. A. Harvey, Chas. F. Harvey, L. Harvey, C. Felix Harvey and E. L. Harvey Harvey.—Kinston Free Press.

Horrible Death.

We learned this afternoon of the most horrible death by fire of Mr. Charles Wilson, at his home at Institute, in this county.

Mr. Wilson went home last night in a state of intoxication. His conduct was such as to frighten his wife, who took her four children and left the house, going over to a neighbor's to spend the night.

About 9 o'clock a negro heard Mr. Wilson yelling and went in the house and found his clothing on fire. The negro became scared, and instead of trying to put the fire out, ran over to tell Mr. Thomas Wilson, a brother of Mr. Charles Wilson. The burning man ran out of the house and fell in a ditch, and only breathed a few times after being found.

It is not known how Mr. Wilson caught on fire, but it is supposed that he laid down in front of the fire and rolled in it or a spark popped on his clothing.

The remains were buried this afternoon in the family burying ground.

Mr. Wilson was a splendid farmer and a good neighbor but was devoid of reason when under the influence of liquor. His horrible ending is deplored, and much sympathy is expressed toward his wife and orphan children.—Kinston Free Press.

N. C. POSTOFFICES.

Queer Names that Would Puzzle a South American.

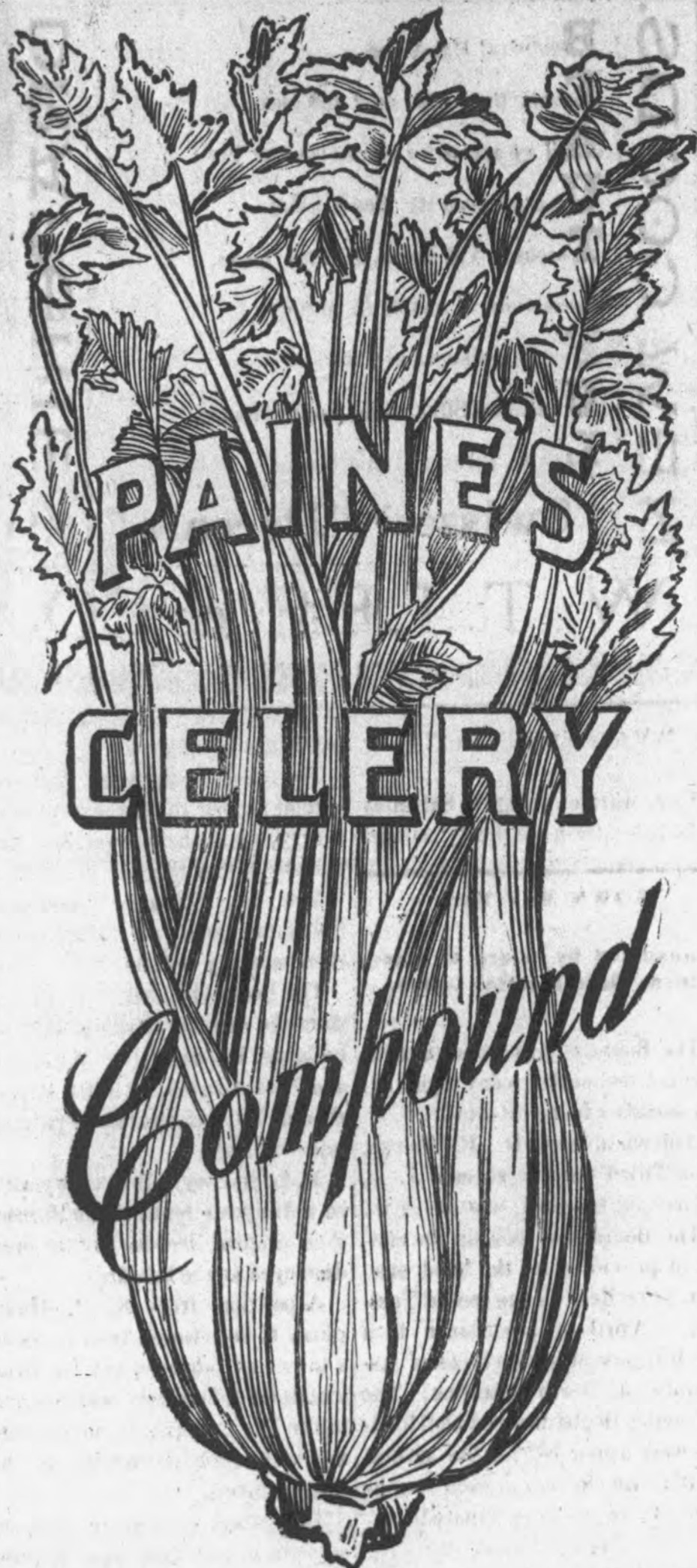

VACCINATION NOTICE.

At a special meeting of the Board of Aldermen of the town of Greenville, held on Monday night, March 4th, the following ordinance was unanimously adopted:

Whereas, it has been made to appear to the Board from representations by the members of the medical profession, and from other good and satisfactory sources that smallpox, a contagious or infectious disease is now prevailing in the neighboring county of Greene, and that it has made its appearance in several well developed cases in this county near the town of Farmville, and this Board being desirous to prevent its appearance in Greenville, and in order to protect the health and lives of its citizens and to protect the commercial interests of the town and believing that vaccination is one of the great means to prevent the spread of the disease,

It is therefore ordered by the Board that all residents of the town of Greenville who have not been vaccinated or who should be revaccinated shall appear before the Superintendent of Health for Pitt County on or before the 12th day of the present month and when deemed by him necessary shall have themselves and their families vaccinated or revaccinated as the case may be.

Any person failing to submit themselves and families to be vaccinated shall upon conviction before the Mayor be fined five dollars.

And to the end that this order may be fully complied with it shall be the duty of the Chief of Police in connection with the Superintendent of Health of Pitt County to visit each and every family in the town and see that this order is carried into effect.

I shall see that this ordinance is strictly enforced and carried out to the letter, and to this end all citizens of the town are asked to comply with its requirements.

A Serious Loss to the Fire Department.

He has been a most efficient officer in that position, giving his closest personal attention to all the apparatus of the department and keeping it in order, as well as getting in the thickest of the battle whenever a fire occurred. No man has tried harder than he to get up a good fire department and what the town has is due in a great measure to his efforts. At the same time it has been very mortifying to the Chief to see that the citizens of the town showed so little appreciation and took such little interest in the fire department. It was enough to discourage him that the property owners of the town, who ought to be interested, would not join the department and help to make it better, and would not even extend a helping hand to the volunteer boys who would go struggling on through the sand with the hose reel to save somebody's property, yet those same people were quick enough to criticize and even speak abusively about the department when things were not done just in accordance with their notions. This spirit, or disposition, is responsible for the present state of affairs.

THE REFLECTOR wants to see the fireman encouraged so that the department may be efficient, and time and again in the past urged its claims upon our citizens. The fire department is composed entirely of volunteer membership, and it can hardly be expected that men with any sensibility about them will want to undergo the duties and hardships required when those whose property they protect take no part with them and help to bear none of the burden.
