TO THE VOTERS OF NORTH CAROLINA.

A game is being played on the East by a certain railroad attorney that is ruinous to the people's interest. This attorney is writing to railroad attorneys and their friends all over the East to be on the alert and see that their delegates are instructed to vote for Mr. McNeil for corporation commission. Why are the railroads through their attorney at work for Mr. McNeil? The question needs no answer. When my two and one half cent railroad fare bill was before the senate committee composed of railroad lawyers: did not the railroad attorneys argue to that committee that it was the duty of the corporation commission to lesson rates and not the Legislature? That the corporation commission was created by the Legislature for this purpose. Did the vote in the House of Representatives of 74 for and 31 against show to the corporation commission whether the people wanted it or not? What did the corporation commission do? They disregarded the voice of the people spoken through the House of Representatives and did what the railroad attorneys in the senate wanted them to do. They did nothing. The people want some one who will do something. The people think that an infusion of some new blood in that commission will do good. Those who want 3 1/2 cent rates vote for the same old commission. Those that want lower fares and freight rates vote for Jacob A. Long.

The present commission by their action say the dividends declared by the owners of railroads are not too great; therefore, passenger and freight rates must be kept up, and accommodations kept down, and labor squeezed and worked 18 to 20 hours out of 24. That owners who water their stock may get enormous dividends from stock created out of ink and paper: While all this is going on safety appliances are neglected and bridges allowed to stand, till they fall beneath a load of screaming, dying, bleeding passengers.

The system of robbing the tax payer for the benefit of the non tax payer has indeed, been reduced to a science.

How long since has it been that members of our corporation commission rode in a private car of the Southern to investigate a wreck on the Asheboro road, a branch of the Southern, dining with officers of the road whose wreck they were going to investigate?

If a juror was on duty, trying a case for you, was to be invited by you to dine and ride with you and he should do it, upon report of the fact to an upright judge, he would put both you and the juror in jail, and ought to. But it seems all right for our corporation commission to do that same thing, and the press and the public say but little about.

Years ago Chief Justice Pearson made some remarks that were pertinent to this state of affair—"Prisoner feeds the watch dog"—"The watch dog fondles upon the prisoner." "There is no use in keeping the dog on watch longer." 76, N. C. Page 358.

COL. SUGG SPEAKS.

Two Thousand Present At The Commencement Of The James School At Atlantic, N. C.

The above was the lowest estimation made by several prominent citizens and visitors from the speakers stand and it was considered by all present who expressed an opinion to be the best school entertainment ever rendered in Eastern North Carolina.

The exercises commenced Thursday evening at 8 p. m. with a short address by Rev. Chas. S. Davis, a graduate of Grant University, Tenn., who said he got his start to the said institute under Prof. James. Then came the beautiful tableaux drills, and other performances by the school, all of which was unsurpassed in completeness and beauty, which showed that they had been trained by a master mind.

Friday at 1 p. m. there was spread several long tables well laden with good things to eat. Notwithstanding the crowd was much larger than anticipated there was plenty for all and to spare, for those Atlantic people have an old time way of doing things.

At 2 p. m. came the annual address by Col. I. A. Sugg, a prominent citizen and lawyer of Greenville, Col. Sugg held that large audience spellbound by his eloquence an hour and a half. He expressed great surprise both at the large number and intelligent citizenship. He paid the highest tribute and congratulations to Prof. James as a teacher. He stated that he had known Prof. James from a child, and that he was the best teacher he ever saw. This was not the first time he had ever had the pleasure of delivering the annual address at Prof. James commencement.

At 8 p. m. the concert exercises were resumed to the delight of as many as could crowd into the house and windows.

We dare not to give in detail a description of this feature of the exercise. We could not do justice to its perfectness if we were to make the attempt.

At the conclusion of those exercises Col. Sugg paid Prof. James and the school the highest compliment by declaring that after traveling over the United States and attending a great many commencement exercises, this was the best and most perfect he had ever seen.

On Sunday morning at eleven o'clock came the commencement sermon by Rev. G. W. Stancill. His subject was building character. This was delivered in a very earnest and impressive way, forcing upon the young the great necessity of building upon the rock, Christ Jesus. The school was beautifully uniformed, both girls and boys in white.

On Thursday there were ten marshals who met the many boats coming in with colors flying for miles and miles up and down the sound. As the marshals met those boats crowded with visitors they fired salutes of welcome and conducted them to the campus where many old friends met to have a hand shake and spend a pleasant day together.

FIGHTING THE SCOURGE.

Eminent Physicians at Jamestown Exposition will Exhibit Methods of Stamping Out Tuberculosis.

(By Chas. Frederick Stanbury.)

Norfolk, Va.—D. Charles R. Grandy, of Norfolk, who is the secretary and treasurer of the Virginia State branch of the National Association for the Study and Prevention of Tuberculosis, while attending the recent convention of the association in Washington suggested to that body the advisability of holding their next annual convention at the Jamestown Exposition. He also pointed out to his fellow members the value of giving at the Jamestown Exposition next year an exhibit of methods of prevention and cure of the great scourge. The association did not, however, see its way clear to changing its hard and fast rule of holding its conventions at Washington not wishing to set a precedent which might cause embarrassment in the future.

Dr. Grady was, however, successful in getting the association to agree to install a comprehensive exhibit at the Jamestown Exposition which would be an object lesson to the world concerning the prevention and cure of the world's greatest scourge, tubercular consumption. Unfortunately, the funds at the disposal of the association are not sufficient to maintain such an exhibit for more than six weeks or two months, unless some fortuitous circumstances should increase the resources in the meantime. A tuberculosis even for that period at the Exposition will, however, Dr. Grandy thinks be of great value to the medical profession and the world at large.

The exhibit will consist of specimens showing different stages of the disease, pictures of rooms used, models and specimens of houses, tents and buildings, etc., used in sanitariums for the cure of tuberculosis. There will be statistical tables, instruments and apparatus used in the cure of the dread disease. Some of these exhibits have already been shown in large cities and their effect in education in the matter of stamping out the disease has been incalculable. The exhibit has been seen by at least 80,000 people and is at present attracting the attention of

citizen and well to do farmer of Pitt county.

Many compliments were paid Prof. James on his grand success and the great good he has accomplished in these two years that he has taught here. Prof. James rules entirely by love. Not only does he win the affections of his pupils for himself, but he creates so much of this spirit that they love one another. This was greatly manifested by the many tears that were shed at this little separation that is only to last till the first of September, when Prof. James and his school in the good providence of God will again be united for another eight months session. FOR THE LITTLE ONES.

The Order in Which the Five Senses
Go to Sleep.

Those wonderful men, the scientists, are always telling us about some queer discovery that they have made. Now it is about the order in which the senses fall asleep—you would never have thought of that, would you? Perhaps you may have thought that all five of them go to sleep at the same time, but it is not so. It seems that sight is the first, being obscured by the eyelids. Then follows the sense of taste, smell, hearing and touch coming next in order. The sense of touch is the lightest sleeper and is the most easily awakened. Smell, though one of the first to fall asleep, is the last to wake. After touch, hearing is the first to regain consciousness. The different parts of the body fall asleep at different times too. The influence begins with the feet and goes gradually upward to the center of nervous action. Warm feet are therefore essential to sound sleep.

A Guessing Game.

The game of shul-a-rul is great fun. You must have the boys and girls stand in a circle and each hold in his hand a sackful of beans or hazelnuts.

Each in turn must take some of the beans or nuts in his hands, turn to his left hand neighbor and repeat the following rhyme:

"Shul-a-rul,
Two hands full,
Pick a penny;
Guess how many."

The neighbor makes a guess. If he guesses too little the other one must supply enough beans or nuts to make the correct number. Suppose the number is ten and he only guesses eight. He must be given two to make it ten.

But if he guesses too many he must supply enough to make the number come up to his guess. Suppose the number is ten, but he guesses thirteen. He must give three to make it thirteen.

Why Black Men Are Black.

It is not an accident of nature that the skin of the African is black, but a wise provision. The skin of a white man soon scorches and blisters when exposed to the rays of a hot sun, but the black skin of the African absorbs the rays and carries them beneath it. His skin, therefore, does not scorch and blister. If you put a white glove on one hand and a black glove on the other and expose them both to a hot sun the hand with the white glove on will scorch, but the other will not, and yet the hand with the black glove on will feel hotter than the hand with the white glove.

The Game of Trades.

In this game there are two leaders, one for the masters and another for the workmen. The leaders choose sides and select a trade, telling the first and last letters to the masters. For instance, "H—r" (horseshoer) is taken.

The workmen stand in line, and each does something in pantomime appropriate to the trade chosen. One blows bellows, one hammers the anvil. The masters are allowed one guess. If this is correct the workmen become masters and the masters take their places.

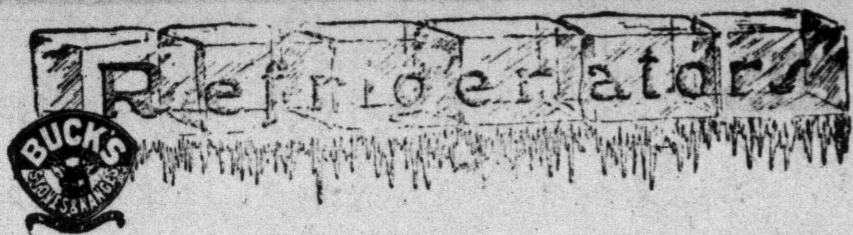

The strawberry season has closed and it is almost time for potatoes to be moving.

The long drouth in this section is at last broken and there is corresponding joy in the hearts of the farmers.

We cannot see that it concerns the balance of us much who the Republicans have for their State chairman. It is their own fight and they are welcome to all they can get out of it.

Jones county has endorsed Hon. L. I. Moore for solicitor of this district. It looks like he will get the nomination with but little opposition.

We were looking for it and it came. The failure of Dr. Kilgo to get elected as one of the bishops by the recent General Conference gave Webster's Weekly a text for a two column article.

Enterprises that give people employment, make more wage earners and turn loose more money to be spent among the merchants, are the things that Greenville should encourage.

Other towns that have electric plants are putting on day current to give small manufacturing plants an opportunity to get power with which to operate. Greenville should hurry up and get the day current in operation here. It will mean much for the town.

The United States Circuit Court at Nashville, Tenn., made a big haul in the fertilizer trust and found indictments against eighty manufacturers. The Virginia-Carolina Chemical Company heads the list of those indicted. It is amazing to what extent the people of the country are defrauded and oppressed by various trust combinations, and still more surprising that the government has been so slow to put forth its hand and check them.

"Just suppose Greenville had had such a building and loan association ten years ago," remarked an observing man in speaking of the association recently started here "what a difference it would have made in the growth of the town." Quite true, but those ten years are gone, and Greenville was the loser in proportion to the needed things she did not have. But now we have a good building and loan association and now the thing to do is make the next ten years count for all they are worth.

The article written by Mr. J. J. Laughinghouse in another column is to the point. It is time the people were getting their eyes open to these things and electing men as corporation commissioners who are not under the control of the corporations.

PUBLIC BUT NOT POLITICAL QUESTIONS.

Two of the most important measures that are now before the people of North Carolina are good schools and good roads. That both are beneficial to any community everyone admits. The only difference of opinion appears to be as to the question of issuing bonds or increasing taxation for their construction and support. That is a matter, however, that should be fought out on its own merits and not be dragged into the political arena.

One of the most unfortunate tendencies in the public life of the State is the inclination evinced by many to make all public questions party questions, even though the lines of demarcation between the parties have absolutely no bearing on the question at issue. "Render unto Caesar the things that are Caesar's and unto God the things that are God's" is advice given us from the highest source and until we heed it and divorce from politics matters of a purely local or economic nature we, as a people, can never give to these matters the calm, thoughtful consideration they deserve.

As it is with roads and schools, so it is with regard to other matters. A Democrat and a Republican are apart on certain theories of government, but that disagreement should in no way make either less solicitous for the moral, mental and material advancement of the State to which both owe allegiance.

The man—no matter what his politics may be—who seeks to becloud nonpolitical questions by dragging them into politics deserves the condemnation of his neighbors. We should be big enough to differ with another man on certain questions and yet fight shoulder to shoulder with him for certain other things of which we both heartily approve. —Greensboro Industrial News.

SHOCKED THE PROFESSORS.

Professor Barber, who is at the head of the Latin department of the University of Nebraska, became indignant when he saw the students had been eating their luncheon in his class room, strewing bits of paper and particles of food on the floor. He complained to the authorities, and the superintendent of buildings and grounds told one of his assistants to write a sign of warning, to be placed in Professor Barber's room. The assistant worked for awhile, and the sign displayed when he got through read this way: "Do not luncheon in this room."

Many of the purists of the university were shocked, and the placard caused almost a sensation. There were loud complaints, and finally the chancellor took a hand in the matter. The young assistant was asked why he had used "luncheon" as a verb.

"Because it is a verb as well as a noun," he calmly replied. And he produced an authoritative book to prove it. Some of the brightest men in the university had learned something.—Kansas City Star.

The Weight of the World.

The world is to be weighed once more, doubts being entertained by scientists as to the accuracy of previous estimates. But whether the error be a case of short weight or overweight has yet to be settled. So an expedition is to set out to Egypt, where, strange as it sounds, the great pyramid will be utilized by the investigators. First the weight of the pyramid will be ascertained and then the weight of the earth estimated from its proportionate size. The swinging of pendulums will be the gauge, for the pendulum is affected by the power of attraction exerted by a large or small body—a mere question of arithmetic to the man of science. From the force exerted by the pyramid in pulling the swinging pendulum from its natural course the weight of the pyramid can be estimated, and that of the earth—the exact size of which is known—can then be easily calculated.

Bombarding a Farmyard.

An Algerian farmer defied the police and barricaded his farmyard. Several rifle volleys were fired at his place in the hope of terrifying him. As this apparently had no effect, a three inch quick firing field gun and melinite shell were brought into use. In all eighteen bombs were fired. The first two flew wide, but the other sixteen reduced all the farm buildings to heaps of rubbish, under which, when search was made, the farmer's body was found. He had evidently been killed by a rifle bullet on the preceding day, so that all the terrors of artillery and melinite had been wasted on a corpse. It is perhaps the first time that the police have tried heavy artillery on one lone man.

JUDGE PAGE'S LOST COAT.

Judge Calvin Page of Portsmouth, a leading member of the New Hampshire bar, has been prominent in New Hampshire politics for a number of years. A few years ago he was sitting in the rotunda of the Eagle hotel in Concord earnestly discussing the political situation with some friends. He had a very nice new overcoat, which he carefully placed upon the chair underneath him. Becoming interested in the conversation, he paid no further attention to the coat. A stranger standing near noticed that the judge was very much absorbed and, walking up to him, placed his hand on his shoulder and said, "Excuse me, sir, but you are sitting on my coat." The judge promptly arose and apologized, allowing the man to walk off with his coat. When the conversation was finished and the judge looked for his coat his remarks were rather emphatic.—Boston Herald.

Points on Oysters.

When oysters are removed from more saline water to that which is less salt, says Dr. William K. Brooks, professor of zoology in the Johns Hopkins university, who has made the oyster a life study, they absorb water quickly and become plump, or "fat," but the fatness is nothing but water. The "fattening" is usually carried on in the mouths of rivers, which are always near towns and polluted by sewage. Every "fattened" oyster is too suspicious to be eaten raw, and the outbreaks of typhoid fever which have been traced to oysters most clearly have been traced to "fattened" oysters. All the fresh water that a "fattened" oyster has absorbed is at once extracted by cooking, so that the "fattening" of oysters that are to be cooked is not only an unnecessary expense, but a fraud on the consumer, who is sold filthy water from the harbors of cities at the price of oysters.—New York Times.

Chances in Modern Battles.

In Homeric days a battle was a conflict of armed mobs. The nearer you got to your assailant the better was your chance of killing or being killed. The bigger the man the better were his chances in the strife. In these piping times of mechanical warfare the situation is reversed. Battles are fought at ranges of a mile or so. The smaller the man the less are his chances of being hit. An ingenious mathematician has figured out that perhaps the casualties on the Japanese side must have been considerably less than those of the Russians in the recent war, if it be assumed that the marksmanship of each was equally good. The advantage of the Japanese was inversely as the cubes of their height and breadth. The average targets offered by each to the enemy are as the cubes of 1,585 and 1,642, or as 106 to 118, an advantage in favor of the Japanese of about 12 per cent.—Scientific American.

A Nice Place to Live.

"On the Broken Hill road," says the Bulawayo Chronicle of an incident in that part of South Africa, "on a recent night a lion entered a hut wherein were sleeping two white men. 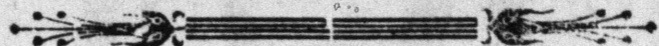
