## OVER THE STATE.

### Happenings of Interest in North Carolina.

A Wilmington man died of blood poison caused by scratching his hand with a nail.

Winston Salem. During a thunderstorm which visited Mt. Airy yesterday, the residence of Mr. G. C. Weleh was struck by lightning. The building and all the furniture, except a few pieces on the lower floor, were entirely consumed by the flames. The lightning killed a dog, but none of the family was injured. The loss is estimated at about \$2,000, with insurance to the amount of \$1,200.

Winston-Salem.—From parties, who came down on the morning train, it was learned that William Bohannon, a farmer residing on the edge of Yadkin county, near Rockford, committed suicide early this morning by hanging himself with a plow line. Bohannon was 35 or 40 years old and had been married three times. Family and financial troubles are given as the cause of his rash act.

### ABOUT APPENDICITIS.

A fine bull terrier belonging to a resident of Brooklyn was operated on recently for appendicitis, and is doing well. In the appendix was found a small roll of human hair, which proved to be a collection of the combed-out strands of his mistress' locks. Human hair is practically indigestible except to the ostrich. A mouse of it is sufficient to inflame the appendix. Most women burn their combings in the kitchen stove for luck.

Appendicitis is a horror I met a young man a few days ago, healthy to look upon, who told me he had appendicitis and would have an operation performed as soon as he could get the money and three months' leave of absence. There is nothing pleasant in the prospect.

Formerly appendicitis was warped in much obscurity and its effects were attributed to "gastric laziness." The earliest and full account of the disease was not given till 1886. Thus we are just twenty years in the grasp of the death-dealer. Inflammation of the appendix itself does not constitute, though it starts, the disease; and so long as only the appendix is affected, though there may be discomfort, there is no real pain; the occurrence of pain giving the signal that the peritoneum, the smooth membrane covering all the bowels and lining the abdominal cavity, has become inflamed in that portion which forms the outer covering of the appendix.

Appendicitis has increased amazingly in the last ten or twenty years, due to the widespread change of social habits and diets. The caecum is filled with undigested food, such as tough meats, lobster, crabs, nuts, pineapples, frozen or refrigerated meats, poultry, etc. Tea drinking has much to do with the onset of the disease the beverage being too astringent for health. Appendicitis is peculiar to youth, more than 80 per cent. of all the cases occurring under the age of thirty. Furthermore, 80 per cent. of the cases are fatal.—New York Press.

## BOUND TO SUPERIOR COURT.

### Second Charge Hanging Over Vick.

The preliminary trial of Luther E. Vick, former agent of the East Carolina Railway at Farmville, was held here Thursday before Justice of the Peace C. D. Roundtree. The prosecution in substance showed that at various times Vick had taken money belonging to the railroad company and endeavored to hide the embezzlement by false report of collections. Vick offered no testimony whatever in rebuttal and was required to give bond in the sum of \$1,000 for his appearance at September term of Pitt Superior court.

This action against Vick was brought by the American Surety Company, of New York, in which he was bonded as agent of the railroad company, and the Surety company claims that his shortage is \$1,127.

And it seems that this is not all that there is against Vick in this matter. Mr. W. V. Curtis, representing the Guaranty Company of North America, of Atlanta, was present as an interested spectator at the preliminary hearing. After it was over he told a reporter that Vick was bonded in his company as agent of the Southern Express Company at Farmville, and that he had a \$500 shortage against him for which his company wanted to take hold of him as soon as the railroad shortage case is disposed of.

### WHAT IS A BARGAIN?

When you rush to the "bargain counter" and actually find that for which you seek—a bargain—what have you really done?

You have secured for fifty cents an article which is worth a dollar; or have bought for five dollars a garment which was worth ten.

## REPORT ON COTTON CROP.

1. There has been a moderate increase of acreage—probably about 5 percent.
2. There has been a considerable increase in the use of commercial fertilizers in the sections where they are commonly used.
3. Abnormally low temperatures have retarded the growth and made a good deal of replanting necessary.
4. Complaints of lack of labor are general, thousands of hands having been attracted to other industries by the high scale of wages.

**EXCESSIVE BRIGHTNESS.**

Some of the Evil Effects of Too Much Sunlight.

It is a common belief, well supported by facts, that light is a powerful agent in the cure of many diseases and in the destruction of the injurious bacteria that prey upon the animal body. Experiments have shown that these little organisms not only will not multiply when exposed to sunlight, but are even rapidly destroyed. Experience has taught us that disease lurks in dark corners and that light rooms are as necessary to health as good ventilation, but we are only beginning to recognize that the sun is not altogether good for us. Its light must be used in moderation, for in excess it may do harm.

Of course every one knows that prolonged exposure to the powerful rays of the summer sun may bring on a sunstroke, but it is a fact not so well known that excessive light, even without direct exposure, may in time seriously impair health.

Light kills bacteria by destroying their substance, the protoplasm which constitutes the main portion of every living cell, whether animal or vegetable. But this effect is exerted upon the protoplasm of our own cells as well as upon that of the bacteria, the only difference being that the protoplasm of the single cell, which is all there is of a bacterium, is more exposed than that of the cells of our bodies and so is acted upon more promptly.

Animals and plants are protected against the injurious effects of light by their color, and it is a general rule that those plants and animals, including man, which live in the tropics and in other regions where the sun shines brightest are the darkest in color, while those of the cloudy north are blonds for the most part. People of the north who go to the south to live soon begin to feel the effects of the increased light. At first this acts as a stimulant. The newcomer feels better, the vital functions are quickened, there is nothing but praise for the wonderful climate and contempt for the indolent natives. But in a year or two a change comes. The immigrant loses tone, becomes irritable and works less and less. The light is working on his protoplasm, which is not protected by so thick a layer of pigment as that which the native has. His nerves give out, and unless he adopts the light shunning habits of those about him he must flee north or die.

A medical writer has recently advanced the theory that American nervousness is due to the excess of light here as compared to the cloudiness of the north of Europe. If this is so, the logical treatment of "nerves" would be rest in a darkened but well ventilated room and not exercise in the open air, as is generally advised.—Youth's Companion.

**The Wily Tibetan.**

Natives of Tibet sometimes impose upon inexperienced European hunters, according to a traveler: "A sportsman shoots at a herd, say, of ibex, which are always on difficult ground. His guide says he has killed one and advises him to give some of the nearest villagers 5 or 10 rupees to go and look for it. In the meanwhile an old head which has been brought for the purpose is steeped in water and dressed with the raw flesh of a sheep or goat and in a few days is shown as the one found by the villagers, who, of course, have never been sent, the guide pocketing the backsheesh and buying for a fraction of the sum a head as like the old one as possible from the first skinner he meets and palming it off on the unsuspecting sahib as the trophy of his skill."

## OLD TIME POSTMASTERS.

They Were Called Upon to Do All Manner of Queer Things.

The modern postmaster may think he has troubles of his own, but there was a time, along about 1817, when he was called upon to do all manner of queer things. For instance, in rummaging through an old trunk a venerable resident of Washington recently unearthed an age stained pamphlet which announced the inauguration of a "new daily and thrice a week paper," to be printed "at the seat of government." The announcement was dated April 5, 1817, and after a voluminous exposition of the virtues of the proposed paper the editor to be said:

"Postmasters are hereby authorized to receive subscriptions for the Gazette, and for all moneys collected and transmitted to the editor; at the city of Washington, a discount of 10 per cent will be allowed. Distant subscribers will have their papers carefully packed and punctually forwarded to order."

Then follows a set of blank spaces where the postmaster might append the names of the subscribers. The entire pamphlet was complete, and a copy was sent, presumably to every postmaster in the then United States. If every postmaster could thus be used as a "mail order agent" in these days of strenuous competition what a variety of duties they would be called upon to perform. But under the system that then existed this method was entirely proper, and it is said that the postmasters made considerable revenue from these sources. Needless to say this was before the days of the now celebrated "fraud order," which the postoffice department issues with every returning sun.

But getting back to the "prospectus." It is a weird affair, wonderfully and fearfully made. It actually states that "a competent reporter will be employed to furnish the proceedings of congress for the Gazette" and that all "interesting articles of intelligence will be carefully selected and published." When it says that "all public documents and state papers will be printed at full length" one is immediately reminded of the Congressional Record, a publication that has been without a rival in the memory of man.

It is also interesting that the editor to be, one Jonathan Elliott, advertised in April that he would start a paper in October. And he expected all these subscriptions to be forthcoming, evidently before the paper was established.—New Haven Union.

### A Ruse of Childhood.

A local business man was reminiscent over his boyhood the other day, says an exchange. "Every morning before school I had to go out on the farm to hoe potatoes with father. We lived on a farm you know. The potato patch was not a great distance from the house and I was supposed to stay there until mother called me to come in when it was time to dress for school. It wouldn't be long, of course, until I got tired. Then I'd watch father, out of the corner of my eye until he seemed engrossed in what he was doing, then I'd turn toward the house and yell, 'All right!' throw down my hoe and run for home. Mother was supposed to have called me to school. Father just thought I hadn't hear her. I worked that ruse along, and, for all I know, he hasn't found it out yet."

## A GREAT FRENCH CANYON.

E. A. Martel, widely known for his explorations of deep caverns in France, has added a new natural wonder to Europe's list of such things, and, it appears, a wonder of the first rank. It is a canyon in the department of the Basses Alpes, through which the river Verdon flows a distance of thirteen miles. Mr. Martel and two or three friends were the first to explore it last August. They found the walls in the highest places varying from 930 to nearly 2,000 feet in elevation. The trip down the canyon occupied three days and was attended with some danger. The stream flows with a very swift current over many natural obstructions, and the explorers observed that it is still cutting its channel deeper. It flows through rocks of the jurassic age. Mr. Martel says that this canyon far exceeds in grandeur any other known in Europe, not excepting the celebrated gorge of the Tarn.

### Curie Refused the Red Ribbon.

Mme. Curie has explained an incident in the life of her late husband. He had the distinction of refusing the red ribbon of the Legion of Honor. His reason was a matter of speculation. One insinuation was that the great chemist had a grievance that his wife was not decorated with him. Another, still less plausible, was that he did not care to accept a decoration which had never been conferred upon his father. Mme. Curie writes quietly to observe that all this is purely fantastic. M. Curie had a settled conviction that personal decorations were open to objections that outweighed their advantages, and, to her great joy, as sharing his opinion, he acted up to it in his own case. He had declined academic distinction before declining the Legion of Honor.

### Brookline Distressed.

Brookline people with an eye to the subdued in color are much distressed over a house that has been given blue blinds. The decoration is thought to be very glaring. For tint the deepest tints of azure skies are a poor second. It has been hoped that the blinds were hung simply as an experiment, but they are still hanging, and now the hope is that the color may have a quick fading quality, but there are no signs of that yet, and perhaps they will never fade. Some are beginning to call the dwelling "the house of frenzied blue."—Boston Record.

### Her First Time in Prison.

Sir Alfred Reynolds, who has done a great deal for British unfortunates, says that when a young girl goes to prison for the first time it is for her a very dreadful thing. He tells of a case which came under his notice as a visiting justice. A young girl, when she found herself in the prison, was utterly overcome with shame and became hysterical. The matron contrived to soothe her. When her time came to be released the girl said to the matron, "I've been so happy that I shan't mind coming back again."

### A Barbaric Autocrat.

Behanzin, the ex-king of Dahomey, after ten years' exile in Martinique has been allowed by the French government to change his residence to Blida, near Algiers. He is accompanied by his four wives, his son, his three daughters and three servants. He is about sixty years of age, with the blackest of faces and a short white beard. He smokes forty strong cigars a day. At the hotel Behanzin refuses to eat off plates or drink from glasses which have been served before. His four wives treat him with barbaric homage, kneeling before him, kissing his hand and when he rides or walks abroad holding an umbrella over the royal woolly head.

### The American Evening Call.

They have the evening visit in America, and the young man who has done his day's work knows that the families of his acquaintance are ready to receive him. But here the evening call is impossible but to intimates, and the casual visit of a mere acquaintance at half past 9 would suggest some sudden message of disaster. The woman who dines alone in her house knows that this is the end of her day. No one will come. It is not the fashion. But would not the institution of the "evening call" make for merriment, meetings of those whose duties keep them far apart during the afternoon?—London Chronicle.

**A Remarkable Watch.**

There is in the possession of the czar a very remarkable watch. It was made by a Polish mechanic named Jules Curzon. The late czar had heard some wonderful tales about the inventive ability of this man, and, wishing personally to test his skill, he sent him a parcel containing a few copper nails, some wood shavings, a piece of broken glass, an old cracked china cup, some wire and a few cribbage board pegs. Accompanying this was a command to make them into a time-piece. Within a remarkably short time the czar received them back in the shape of a watch. The case was made of china and the works of the other odds and ends. So pleased and astonished was the czar that he sent for the man, conferred several distinctions on him and granted him a pension.

**Reads by the Light of a Sausage.**

Professor Hans Molisch of Prague, according to the London Mail, has been able to read a newspaper by the microbic glow emanating from a sausage. All meat—beef is often as in 52 cases out of 100 and veal in 50 out of 100—contains the microbe which projects a greenish white light. With sausages it is not so frequent, but is, when present, much stronger. When the fat on the luminous sausage was scraped away it immediately ceased to give forth light, but as soon as the surface had again been covered by the fat oozing from the interior the light reappeared. Professor Molisch asserts that the presence of these microbes in meat is no sign of decay, but rather the contrary, as in no case have they been found in meat unfit for human consumption.

Here is the king's eating schedule for the day: Eight a. m., breakfast, tea, coffee, chocolate, milk, rolls and cold meat; 11 a. m., luncheon with the ministers of state, soup, two entrees, joint, vegetables, sweets and fruit; 4 p. m., tea or Spanish wine, cakes and sandwiches; 7 p. m., dinner, two soups, two entrees, two joints, vegetables, ices, sweets, fruits, Spanish wines, champagne; 9:30 p. m., tea, wines, cold meat, cakes and dessert.

**A Bronze Mummy.**

A miner who lost his life while at work 2,000 years ago has been taken from a copper mine in Chile recently. His whole body had been mummified by the action of copper oxide, which had given it a greenish tinge. The mummy is in a fine state of preservation. Coarse sacking, evidently the clothing of the ancient Inca workman, was found with the body, as were also two mallets, one fashioned out of granite and the other out of ironstone. These implements were tied with thongs into bent sticks made as double handles. Both the hide and the sticks were as fresh looking when found as if they had been in use only the day before.
