## PLAN TO FLOAT TO DISCREDIT SENATOR SIMMONS

North Carolina Senator is Surprised  
and Asks, Why

### NEWSPAPER STORIES UNFOUNDED

Special Communications, Purported  
as Being Sent by Special Washing-  
ton Correspondents Said to be False  
as Names Cannot be Traced.

WASHINGTON, Feb. 13.—Periodically some man using about Washington makes a strong bid for fame by causing to be published his "discovery" that Senator Simmons, even if his party should succeed in getting control of the senate, will not be made chairman of the powerful finance committee, owing to opposition which he would encounter from some of the more "progressive" Democrats. Singularly enough of these stories, while never fathered by any correspondent from that state, are always given publicity in North Carolina. The "One Jones" referred to by Senator Simmons in a statement given the press tonight, has been let gently but firmly out of the press gallery since his contribution to a Raleigh paper was aired. The other man mentioned, Clifford, could not be located without resort to search warrant, because neither the keeper of the gallery nor any of the members there, who were questioned, had ever heard of him.

The several senators who were approached on the subject when this rumor was first set in motion, all characterized such talk as sheer nonsense and it goes with the saying that if Democrats are fortunate enough to get control of the senate, Mr. Simmons will, in the very nature of the case, become chairman of the finance committee. This will be done not only because there is no opposition to him but by virtue of senate rules and regulations, and preliminary practices, as fixed in their operation as any law of nature.

## TO ELIMINATE PARTY BOSS

Congressman Small Believes Wilson  
Will Do It

### FINANCED BY SELFISH INTERESTS

Election of Gov. Wilson Means Elimination of Party Bosses and the Disruption of Political Machine Maintained by Selfish Private Interests.

WASHINGTON, Feb. 13.—Declaring Woodrow Wilson "the Democrat who embodies in his life the dominant issues before the country more than any other," Representative Jno. H. Small, of the first district of North Carolina, today gave his reasons for supporting the New Jersey executive in his fight for the presidential nomination.

Mr. Small has considered profoundly the fight which the Democratic party has to face and summed it up as "the elimination of the party boss, the destruction of the political machine financed by selfish interests and the wielding party power for the promotion of special privileges," and declared that upon the ruins of these organized plunderers must be reared the foundation of a true Democracy.

Body of Mr. Bryant Parker Found by  
By the Side of the Road.

KINSTON, Feb. 13.—While driving along the Trenton road, Sunday morning, Mr. Henry Gray, of Jones county, discovered the body of a man covered in snow by the side of the road, and uncovering it, saw that it was Mr. Bryant Parker, also of Jones county, frozen stiff, and dead. In the dead man's pocket was a bottle of whiskey, and the surmise is that he started to walk from Trenton to his home, nine miles, Saturday evening, and encountered the severe snowstorm that prevailed Saturday night. Overcome with cold, he probably lay down, as is characteristic of those benumbed with cold and met his death.

Mr. Parker was about 25 years of age, the son of Mr. Benjamin Parker, of Jones county, and a brother of Mr. J. N. Parker, of this county. He was not married.

### Farmer Attempts Suicide.

Salisbury.—Charlie Post, a prominent farmer 50 years old, with a wife and ten children, living near Organ church, Rowan county, attempted suicide, it is alleged, with a shotgun this morning. Mr. Post had been bothered considerably of late by relatives over some land and had been unable to sleep for three nights. This morning early he entered a small room at his home and in some way fired a gun. A part of the load entered his neck, producing wounds that, while painful, are not necessarily fatal.

Death of Mr. R. C. Charles, of High Point.

High Point.—Last night at about 8 o'clock Mr. R. C. Charles died at his residence on Elm street, after a lingering illness of some six months, caused by a stroke of apoplexy seven months ago. The funeral services were to be held this afternoon at 3 o'clock at the First Baptist church, of which the deceased was a faithful member. His remains were laid to rest in the city cemetery. He was aged 58 years and 11 months. He is survived by his wife and a grown son and daughter.

### Raleigh Snowbound.

Raleigh.—A seven-inch snowfall Saturday night had Raleigh considerably snowbound Monday, and when the melting began toward noon, roof troubles developed, especially on numbers of the buildings in the business section. The street cars had a hard time getting started and the line from Greenwood to the country club was not opened for the operation of the cars at all.

Little Girl at Spencer May Not Survive Burns.

Spencer.—Margaret, the 2-year-old daughter of Mr. and Mrs. J. Rufus Dorsett, was seriously burned at their home in Spencer Monday. While playing around an open fire the child's clothing ignited and its hands, chest and neck were frightfully burned. The parents were absent at the time. The little one's condition is critical.

### Death of Mrs. Emma Horner.

Wake Forest.—On Sunday evening, February 10, 1912, there passed away from the scenes of earth the spirit of Mrs. Emma Horner, one of our most estimable citizens. She had been in poor health for some time, being, in fact, an invalid for at least four years. She was some sixty years old at the time of her death.

## Gov. Woodrow Wilson Opens Campaign in Illinois

Delivers Address in Chicago Before the Famous Iriquois Club—Progressive Policies in Administering Public Affairs will not Hurt Business in the Least, He Declares

### REPUBLICAN PARTY SPRINGING FROM ABRAHAM LINCOLN "PECULIAR"

Attends Lincoln Birthday Luncheon—  
"Our Economic Affairs Cannot go on as now Organized"—Urges Progressive Change in Administration of Public Affairs—"The Republican Party is Badly Broken Up."

CHICAGO, Feb. 13.—Expressing the opinion that the country's business has nothing to fear from the application of progress policies in the administration of public affairs, Governor Woodrow Wilson, of New Jersey, opened his campaign for the Democratic presidential nomination in an address before the Iriquois Club today at the Lincoln birthday luncheon.

"I sometime think it a peculiar circumstance," he said, "that the present Republican party should have sprung from Abraham Lincoln. I suppose that is one of the mysteries of providence. The richness of a democracy is that it never has to predict who is to save it. We do not have to train men to interpret the United States. When an emergency arises there is always some genius who appears from the ranks of uncatalogued men to bear the standard and show the way to victory."

"As our economic affairs are now organized they cannot go on. The division is far more difficult to trace today than it was in Lincoln's time. No man is a friend of this country who predicts dire results. Every problem we have to meet can be solved without injury to business or any other sound interest."

"The Republican party is sadly broken. It has lost its way. It has been the business man's party in so many personally conducted campaigns that many believe nobody else knows anything about prosperity."

"America is a business country and business must be taken care of. I believe that the ills from which we suffer can be cured without harming sound business. I have no feeling of piety about any political doctrine except the one that gives equal rights to all."

"Business and politics must be separated. Give politics a chance without the domination of special privilege and great wealth. The biggest enemy business has is the man with a program which goes further than he can see."

## PACKER TO BE HEAVILY FINED

Selling Oleomargarine Puts Cudahy In  
Trouble

### MAY HAVE TO PAY

Company Was Indicted Yesterday And  
If Prosecution Is Successful Amount  
Of Fine Will Be As Mentioned  
Above.

ATLANTA, Ga., Feb. 12.—In order to sell \$4 or \$5 worth of oleomargarine a day in Atlanta, the Cudahy Packing Company has had itself open to a fine of \$132,500, according to an indictment returned against the company today in the United States court.

This unusual punishment has been invited, so the government charges, by petty illegal trafficking that in all could have profited the packers not more than \$1,000. The information presented to the grand jury was that the company sold about 60 pounds of oleomargarine a day to Thomas Hopkins, already under indictment as an "oleomargarine blockader," and received for it about 7 cents a pound, or \$4.20. It is alleged in the indictment that in order to cover up the sale of such oleomargarine to one man, the company falsified its books to show that the quantity was being distributed among several Atlanta restaurants. Indignant proprietors of the restaurants named have denied using oleomargarine and appeared before the grand jury at witnesses against the packing company.

### Shoe Machinery Hearing.

WASHINGTON, D. C., Feb. 13.—Of interest alike to shoe manufacturers and makers of shoe machinery throughout the country is the hearing begun before the house judiciary committee today on the two bills introduced by Representative Thayer, of Massachusetts, intended to prevent discrimination in the sale or lease of machinery used in the manufacture of shoes. The bills are aimed directly against the United States Shoe Manufacturing, commonly called the "shoe machinery trust," against whose officers criminal action is pending in the federal courts. The bills make it a criminal offense for any firm or individual to place any restrictions upon the free purchase and use of any tools, appliances or machinery used in the manufacture of shoes.

### Illinois Live Stock Breeders Meet.

BLOOMINGTON, Ill., Feb. 13.—With an attendance larger than usual, the Illinois Live Stock Breeders' association opened its seventeenth annual meeting at the Coliseum in this city today and everything indicates that the three days session will be eminently successful and profitable to the attending farmers and stock breeders. The program includes addresses by noted authorities on live stock topics, lectures and demonstration on cattle tuberculosis and hog cholera by Dr. A. T. Peters, superintendent of the state biological laboratory and Dr. H. R. Schwarz; the annual banquet on Wednesday evening and the usual stock judging contests for valuable prizes by persons competing for expert certificates.

### Iowa Retail Clothiers.

DUBUQUE, Ia., Feb. 13.—Nearly five hundred members of the Iowa Retail Clothiers' association are in attendance at the annual meeting of the organization which opened here today for a session extending over three days. The local members of the association have arranged an elaborate and attractive program for this occasion, which includes a number of interesting addresses and the annual banquet to be held at the Wales hotel tomorrow evening.

### Commission to Inspect Capitols.

JEFFERSON CITY, Mo., Feb. 13.—E. W. Stephens, the chairman, and the other members of the Capitol Building commission entrusted with the planning and the erection of a new capitol to replace the structure destroyed by fire on February 5, of last year, started today on a tour of inspection to visit the capitols of Arkansas, Mississippi, Kentucky, Indiana, Minnesota and Wisconsin, with a view of gathering valuable information which will guide them in the future work.

## AFTER 300 YEARS MANCHUS QUIT CHINESE THRONE

Sovereignty of Empire Vested On  
Chinese People

### REPUBLIC TO BE ESTABLISHED

After a Rule Lasting Over a Period of  
300 Years the Manchu Dynasty Has  
Abdicated—The Emperor to Be Respected as a Foreign Monarch—One of Agreements.

PEKIN, Feb. 13.—After occupying the throne of China for nearly three hundred centuries, the Manchu dynasty, represented by the child emperor P'i Yu abdicated today. Three edicts were issued, the first proclaiming abdication, the second dealing with the establishment of the republic and the third approving the conditions agreed upon by the Imperial Premier Yuan Shai Kai and the Republicans.

A contended point as to whether the throne shall be perpetuated or will terminate with the present emperor's death, is not mentioned. Four pledges for the treatment of the Imperial kinsmen follow:

First, the Princes, Dukes and others having hereditary titles shall retain their ranks; second, the nobility shall have their rights and privileges of ordinary citizens; third, their private properties shall be protected; fourth, the nobility shall be permitted exemption from military service.

## N. C. ENGINEER FLOATS MAINE

Man From Old North State Accomplish  
Engineering Feat

### MAJOR FERGUSON CONGRATULATED

Water in Coffer Dam is Now Fourteen Feet Deep and Maine Floats Easy Within Its Walls. Soon To Reach Level of The Harbor.

HAVANA, Feb. 11.—The wreck of the Maine floated free of the mud tonight when water was turned into the dam surrounding the wreck. The water within the dam is about 14 feet below the harbor level at low tide. It is the intention tomorrow to lower the water more rapidly, so that by nightfall the wreck will be raised to the harbor level, leaving more to be done except to break the dam and float out the ship.

Water was forced into the dam through a system of pipes fixed at the bottom of the ship the power being supplied by a pump which had been recovered from the wreck. The ship began to rise almost immediately. The midship section, which had been furnished with a bulkhead, rose more rapidly on account of superior buoyancy than the heavily weighted ship pointed stern, so that tonight the Maine is somewhat down by the stern. The hull still lists to port, which is being corrected by the use of ballast. No leaks of any importance have been discovered.

Southern Merchants' Convention. ATLANTA, Ga., Feb. 13.—Joined in a movement which has for its object the strengthening of the commercial independence of the south, nearly one thousand representative southern merchants assembled in this city today to confer regarding the betterment of existing trade conditions and to discuss various problems of interest and importance. The Atlanta Merchants and Manufacturers association took the initiative in bringing the merchants together and will act as host to the visitors during their five days' stay in the city.

The relation of southern agricultural interests to the development of commerce and manufacturing is the general subject selected for discussion. The reduction of the cotton acreage will be exhaustively considered, also the encouragement of diversified farming and the furtherance of the stock breeding industry. In addition the merchants will discuss advertising methods, semi-annual clearance sales and numerous other matters relating to their daily business.

The initial session of the convention was held this morning in the assembly room of the Piedmont Hotel and was devoted to the work of organization. This afternoon the visiting merchants inspected a number of the large manufacturing and mercantile establishments of Atlanta. The business sessions will be resumed tomorrow morning and will continue until Friday. A notable feature of the evening will be a dinner Thursday evening at which Prof. J. Laurence Laughlin, of the University of Chicago, will speak on the subject, "How Currency Reform Will Benefit the Merchants of the South."

### To Probe Canadian Freight Rates.

OTTAWA, Ont., Feb. 13.—Preliminary to a sweeping investigation which it is proposed to make into the freight rates charged by the railroads in the western provinces, the Board of Railway Commissioners met today to map out a line of procedure. The inquiry is expected to be the most important of its kind ever undertaken in Canada and the importance of the results on the commercial and industrial interests of the west can scarcely be overestimated. The railway commissioners were prompted to begin the investigation by the receipt of numerous complaints alleging discrimination against Alberta and Saskatchewan in favor of Manitoba and also making general charges of excessive rates throughout the west.

casual embarrassments, however, may sometimes be reasonably interposed."

In Jefferson's sixth annual address he reviews the disturbing conditions in our foreign relations due to the persistent activity of the pirates in the Barbary States and touches upon many other important foreign relations, applauds the Lewis and Clarke exploring expedition and points out the need of a settlement and fortifications near the mouth of the Mississippi. This message is one of the greatest historical documents from the pen of Jefferson.

It is said that, while the spoils system belongs to Jackson's time, nevertheless Jefferson started it by making many political removals from office.

Interesting side lights of history of the world and of this country are thrown on the canvas by the reading of Jefferson's addresses. Hamilton was killed in a duel by Aaron Burr. Zebulon Pike penetrated the Rocky mountains, his name immortalized by the discovery of Pike's peak. War was declared against Tripoli, and the practical attacks of Tripoli and other north African states were suppressed and peace made with them by Commodore Perry. England and France were at war—the reason why the United States was able to make the Louisiana purchase on such favorable terms or to make it at all.

Napoleon in speaking of the sale of the territory said, "This accession strengthens forever the power of the United States, and I have just given to England a maritime rival that will sooner or later humble her pride."

England asserted the right to search American vessels and to impress seamen, foreshadowing the war of 1812, called the second war for independence. The embargo act was passed. Aaron Burr was tried for treason for planning to establish an independent empire west of the Mississippi. Jefferson concluded his official career, as Washington had done, by refusing a further election.

We find a facsimile reproduction of Madison's declaration of war against Great Britain which brought on the war of 1812, and his state papers serve as a most illuminating history of the times during that second trial of the young nation's strength. Perry's victory on Lake Erie, the heroic death of Lawrence, the burning of the capitol and all other public buildings at Washington, the Hartford convention, which gave expression to a large number of disaffected New Englanders; the remarkable fact that a hard fought, decisive battle took place at New Orleans under the direction of General Jack

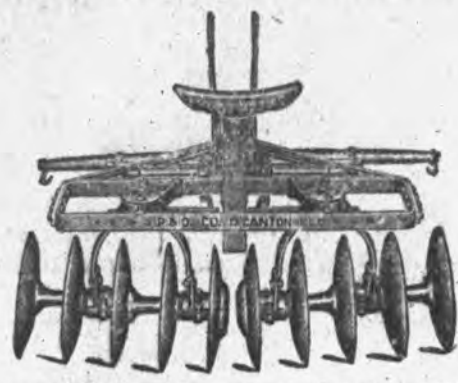

CHARLESTON, S. C., Feb. 11.—Final preparations for the great Men and Religious Convention for North and South Carolina are practically completed. Charles Steize of New York city, the social service expert, and Dr. Allen A. Stockdale, pastor of one of Boston's largest churches, arrived here yesterday for the beginning of the 8 day campaign. Tomorrow night at 9 o'clock the other distinguished speakers representing the International Movement, will arrive from Birmingham in time for a rest prior to the opening of the convention at 9:30 a. m., Tuesday, Feb. 13, at the Citadel Square Baptist church. These men include R. A. White, of New York city, expert on Boy's Work; H. F. LaFlamme, Toronto, expert on Missions; W. E. Bidenwolf, Chicago, expert on Evangelism; A. M. Bruner, Chicago, expert on Community Extension and F. S. Godman, New York city, on Bible Study.

Charleston has never seen such an unprecedented interest in religious matters as is being shown by practically every local Protestant church. The pastors and laymen of the city are practically united to make the convention the greatest in the history of religious work in the two states. Credentials are coming in by every mail and delegates are assured from more than 40 points in the two states. In point of population, Abbeville, Chester, Greer and Sumter are leading up to this time, with an average of ten delegates and more to follow. College presidents, leading pastors and men who stand in the fore-front in commercial and political life in the Carolinas are already entered as delegates. The reason for this is the fact that it is generally understood that no such convention program has been offered in the two states since Indians roamed in these parts. Not only is the program impressively strong from the standpoint of the speakers, but the entire time of the two days will be given up to the study of the Man and Boy problem in the individual church and this effects every church in North and South Carolina.
