HIGHER PHYSICAL EDUCATION TO BE BOOSTED BY BODY

United States Chamber of Commerce Requests Information Regarding Health

PLANS TO INCREASE INTEREST IN HIGHER PHYSICAL TRAINING

Eight Hundred Cities to be Asked to Help in Perfecting Plans for Future

A movement to make the present school commencement season mark a forward step in education is under way here and in many other representative cities of the country. A request made by the Chamber of Commerce of the United States for information as to what is being done for health and for physical education in the local schools has just come to the Pitt county Chamber of Commerce. The National Chamber is obtaining this information from 800 cities to determine what physical preparation is being given to those who later will bear the business and industrial burdens of the nation.

In the pamphlet which accompanies these questions, these statements are made:

"The conservation of health is a great economic problem challenging the best thought in America today. The business world has much at stake in the development of a citizenry which is physically fit.

"There are approximately 22,000,000 school children in the United States. A large majority of these have remediable defects such as deafness, malnutrition, decayed teeth, poor eyesight, incipient tuberculosis.

"In order to promote the physical well-being of all the people a proper system of physical examinations and health instruction must be universally carried on in the various grades of the schools. About one-half of the children leave school before they are sixteen years of age and yet most of the health instruction has been reserved for high school and college students.

"The purpose of health education must be to establish habits, not to accumulate facts. It does the child with the twisted back no good to commit to memory the names of the bones of the body; nor the malnourished child to recite the stages of digestion.

AIR TRAFFIC TO BE REGULATED SOON

Washington, June 12.—Senator Heflin, of Alabama, announced today, that he will introduce a bill before congress for the purpose of establishing a complete system of air traffic regulation, following two interruptions of his address Sunday by circling airplanes.

It is understood that there is strong sentiment in congress for such legislation. This resulted from interruption of President Harding's address during the Lincoln Memorial exercises recently.

BROWN MAY REJOIN BLUE SOX EARLIER THAN ANTICIPATED

Broken Leg Improving Rapidly, Pitcher Reports While Attending Game Here

Edward Brown, pitcher of the Greenville baseball club, who had the misfortune to break his leg in a practice game between Greenville and Washington several days ago, was in Greenville today to attend the game between Tarboro and the Blue Sox. While still unable to get around without assistance of crutches, Brown is much improved, and hopes to be able to return to the bench within the next month or so. His injuries are not as serious as at first expected, but he has a broken leg and that's about the worst plight a good ball player could be in.

This is the first time Brown has made his appearance in Greenville since breaking his leg. After leaving Washington he went to his home in Ayden, and remained there until he recovered sufficiently to get about on crutches. He said he is anxious to get back in the game, and will do so at the earliest moment possible.

Brown is the only man on the local club to suffer any serious injury so far this season. Doran cut his hand while sliding base a few days before the league opening, but was able to be in the first game. Smith, third baseman of the Greenville club, broke his leg last season, but was able to join the club this season. That he is making an effort to pay for his lost time is very evident by his work with the stick and in the field also.

SENATE PLANS TO COMPLETE SHOALS

(By International News.) Washington, June 12.—Decision will be reached by the House this week on the senate plan to authorize an army to complete Muscle Shoals, it was learned from administration leaders today.

The proposal embodied by the army appropriation bill will reach the House about Wednesday. If the House rejects it is indicated it will indefinitely tie up the appropriation bill as senators favoring the completion of Muscle Shoals have declared they will fight to the end for their proposal.

On the other hand, House proponents of the Ford offer try to strike out the plan on the ground that it will prevent acceptance of the offer at least a year or so.

AIRMAN SPENDS NIGHT OF TERROR IN SWAMPY WILDS

Big Panther Forces Cadet White to Seek Refuge in Branches of Tree

MOSQUITOES ADD TO MISERY OF AVIATOR IN FLORIDA WILDS

Has Clothes Torn to Tatters by Florida Sawgrass and Is Without Food 40 Hours

Arcadia, Fla., June 11.—Treed by a panther and compelled to spend the greater part of a night in the branches of a large cypress in the wilds of the Big Cypress country; devoured by mosquitoes; his clothes torn to tatters by the cruel teeth of the giant sawgrass of the South Florida swamps; without food for nearly forty hours—these were among the experiences of Cadet Raymond White, Carlstrom Field aviator, whose plane crashed in the wilds of southeastern Lee county last Thursday about noon, and who returned to the flying field this afternoon in one of the planes that had searched for him since last Thursday.

Cadet White, whose home is at Pritchett, Texas, was making a practice flight from Carlstrom Field to Okeechobee City and return last Thursday. The first part of the flight was completed without incident and Cadet White, flying alone, started on the return trip, becoming turned around and losing his bearings and his sense of direction completely almost as soon as he started.

Instead of flying northwardly, White headed his plane almost due south. When at a point about forty miles southeast of Immokalee, Lee county, his fuel tank ran dry and his plane crashed. The plane was completely wrecked but White escaped injury.

ROAD SENTENCES FEATURE COURT DURING MORNING

Several Defendants Draw Sentences During Session This Morning

Road sentences played an important part in this morning's session of county court, and as a result there are several sad but wiser men awaiting terms today. The docket this morning was one of the largest in several weeks, and is long after the noon hour before adjournment became possible.

Lennie Everett, colored man charged with escaping and aiding another prisoner in escaping from the county road forces, was sentenced to four months on the roads, sentenced to begin at the expiration of the term which he was serving when he decided to escape.

Sam Snyder, C. C. Cook, G. A. Johnson, R. F. Brady, charged with transporting liquor, were released on provisions that prayer for judgment be continued for a period of two years, each defendant paying cost of two years, each defendant paying cost of action. They filed notice of an appeal to superior court.

Hardy Jennings, charged with selling liquor, was released upon payment of \$30 fine.

Hubert Midgett, John Taylor, Frank London, Jelly Peel, Dave Hines, Will Turnage and Andrew Barrett, charged with gambling, were fined \$10 each and one-seventh of the cost. Upon failure to pay the fine they will be sentenced to 30 days on the roads.

AYDEN RED CROSS DISCUSSES PLANS FOR FUTURE WORK

Several Committees Report What They Expect to Accomplish at Early Date

The regular monthly meeting of the Ayden Red Cross branch was held Friday at three o'clock in the office of the National Bank. Chairman G. W. Prescott, presided over the meeting and in the absence of the secretary Mrs. K. A. Pitman read the minutes of the last meeting. Chairman Prescott had reports from each of his committees.

Mrs. Helen Turnage reported that the Junior committee had met and put all children into three groups according to age. Recreational activities will be planned for these. Young people and the oldest groups are to assist in making clothing for homeless children. Mrs. Turnage is to have meetings of her Junior Red Cross committee with the children Thursday at 2:30 o'clock in the afternoon.

Mrs. K. A. Pitman reported that the civic committee had the town completely lined up for the "Sweeping Jubilee" but the committee expected that it would be necessary to postpone same until streets were opened and drays could remove the debris. That the fountain proposed for the corner of Lee street had been taken up with the Ayden street committee and it was thought that they would surely be able to have same. Dr. McKinney had ordered catalogue and price list of fountains, she said, and these will be in sometime soon. She said plans were under way for financing the beautifying of the town this fall. The committee had secured a municipal dump heap where old automobiles, cans and unburnable material is to be hauled.

Chairman Prescott appointed Dr. Grady Dixon as a new member of the civic committee.

Mr. G. A. Johnson, chairman of the meeting committee will have a big meeting this morning. Arrangements will be made at a meeting of his committee Thursday at two o'clock.

Mr. Colin Stokes explained that the life saving corps was organized for service and that he hoped Mr. Byrd would be able to attend the next meeting.

W. B. Pace, county farm demonstration agent, gave a much appreciated talk on the necessity of having the farm boy given a chance at recreation. He stated that he was planning a camping trip of four days for the agricultural and poultry club boys and girls and was very anxious to have the Junior Red Cross cooperate with him in putting over the trip.

Mrs. Turnage told him she would let him know definitely at the end of the week. The meeting adjourned to meet again the first Friday in July at four o'clock.

EASTERN CHAMBER MAKING PROGRESS IN ALL SECTIONS

When once the plans and purposes are explained success is assured because there is something in the program that means better times in this eastern section of the state.

"I don't see how any paper or any body could refuse to support this wonderful work that you are putting on for Eastern Carolina. Count on me to aid the movement in any way possible." A banker, "It is the only safe and sane program for the people of Eastern Carolina to adopt now. A big merchant, "Unless the business men, bankers, and farmers heed the "Gospel" that you are preaching over this section, they are headed for ruin." The simple truth that he referred to, is Diversified farming, which means a well balanced farming program. The President Comments. Dr. Ellen, of Greenville, the president of the Eastern Carolina Chamber of Commerce, spoke very optimistically of the movement this morning, when he was asked how the campaign was getting along. He said: "It is moving along nicely. There isn't anything else for a movement of this kind to do, except succeed when it is backed by a program like this organization has. The reports from the vice president Manager, Mr. Bartlett, are very encouraging and the chances are that within the next thirty days, practically every county in the Eastern territory will be included in the list of members." BARON KATO NOW JAPAN'S PREMIER

His Acceptance Regarded as Beginning New Day of Conciliatory Policies

Tokio, June 11.—Admiral Baron Kato today accepted the Premiership. His non-party cabinet comes into power with the avowed intention of carrying on the agreements of the Washington conference.

The one condition on which Kato accepted the Premiership was agreement of army leaders to reduce the estimated army budget by 40,000,000 and to adopt a general policy of retrenchment. Kato will have the support of the Seiyukai majority party in the Diet and the Kenkoku, the largest group of persons in the House of Lords. It is understood that Shidehara has the refusal of the foreign office portfolio in Kato's cabinet.

INVESTIGATES LOSS BY FOREST FIRES IN THIS LOCALITY

Chief Forest Fire Warden Completes Survey of Pitt, Beaufort and Hyde

FINDS DEPLORABLE CONDITION EXISTING IN EVERY TERRITORY

State Geological Survey to Assist in Conserving Timber Supply in the Future

Mr. W. Darrow Clark, chief forest fire warden for the North Carolina Geological and Economic survey, was in Greenville today following an investigation of conditions of the forest lands in Pitt, Beaufort and Hyde counties during the past two months. He reports that the destruction of young forest growth in these three counties during the past year has been deplorable and that if it is allowed to continue at this rate it will not be long before a decent block of woods will be as scarce as a wild turkey.

Mr. Clark estimates that in Pitt county alone approximately 200,000 acres was burned over and that promising, thrifty young forest growth up to 30 years of age has been totally destroyed. In twenty to thirty more years it would have developed into valuable merchantable timber.

As to the value of the damage done, Mr. Clark estimates that in no case can it be put at less than \$10 per acre, and that over a large acreage it would amount to no less than \$50 per acre. Assuming, conservatively, the damage to the average acre would be \$20, this would amount to a sum total loss to the county of \$40,000 as a result of forest fire of one year alone. In commenting further on this very serious problem the chief forest fire warden goes on to say that nine tenths of these fires result from the utter carelessness of people who start them for various purposes and that accordingly they are prosecutable if due action is taken.

The state legislature at its last session, realizing the seriousness of forest fires throughout the state authorized the state geological survey to cooperate with the counties on a fifty-fifty cost basis in implying on part time, suitable men, to act as local forest wardens during the dry and dangerous periods of the year. The duties of these wardens would be to enlist the co-operated efforts of all the people in that district to use greater care in the handling of fire out of doors, to report to the warden as soon as any fire escapes, to assist him in running down the origin of forest fires and to support him in a strict enforcement of the laws of the state bearing on forest fires. It goes without saying that this cannot be done without the expenditure of some money. The state's portion is that if the county will appropriate a small sum, say \$500, the geological survey will allot an equal amount from state and federal funds for this purpose. This making a combined fund of \$1,000, to be used in protecting one of the counties own fundamental and basic assets, its growing timber.

AMERICA NOT TO TROUBLE CHINA

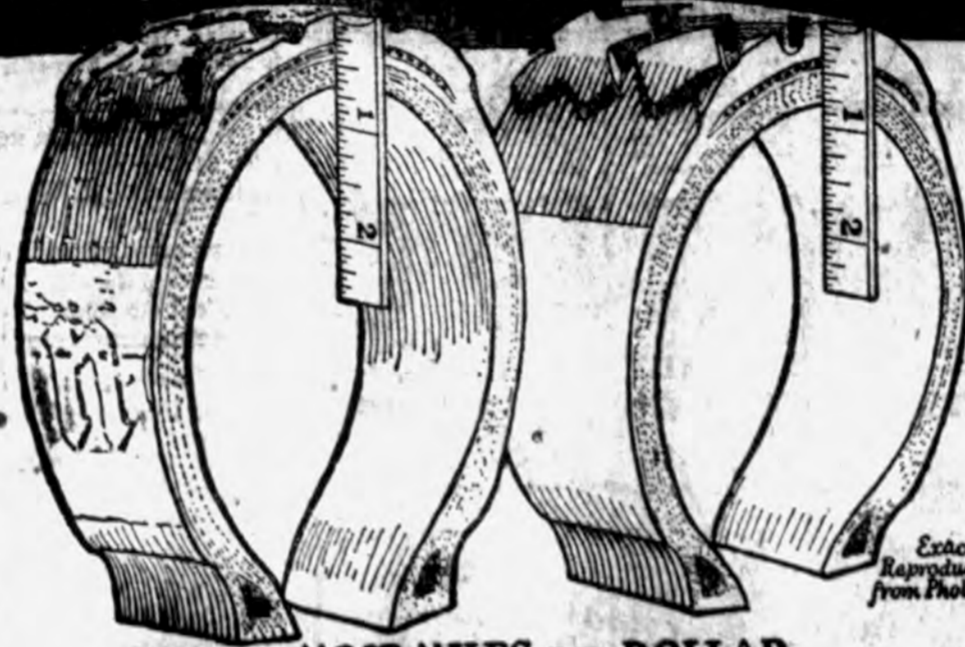
