Jr. Epworth League Assaulted While In Farmville Last Night

Truck Containing Members of Christian Organization of Local Church Held Up and Attacked by Mob of Lawless People on the Streets of Farmville Last Night

One of the greatest outrages ever occurring in this county was on last evening when the Junior Epworth League, of the Jarvis Memorial church of this city, while enjoying a hay ride were attacked by a mob upon the main street of Farmville, and showered with sandbags, water-bags, mud, stones and rotten eggs.

From the information gained from the three ladies who chaperoned the children, and who were the only grown people on the truck with the exception of the negro driver, as the truck entered Farmville one of the children without the knowledge of the ladies yelled at some passerby regarding Greenville's having defeated Farmville in baseball. This was greeted by a remark from the person hailed that they had better hurry out of Farmville as nobody from Greenville was wanted in their town. The ladies knew nothing regarding the base ball controversy between the two towns but they immediately ordered the children to make no further remarks about it and the party proceeded to the high school lawn where it was their intention to spread lunch. A short distance from the school the children were greeted by a barrage of eggs, mud, sticks, water-bags and the like. One of the chaperones as soon as was possible got off the truck and appealed to the mob of men and boys to cease their attack as the boys and girls on the truck were representing a Christian organization and were merely out for an outing. Her appeal was met with utter contempt, hisses and shouts that there were no Christians from such a place and the barrage gathered force rather than ceasing. No officers were in sight for the ladies to appeal to and they were informed by the mob that if any attempt was made to go back up main street in search of help that orders had been given that the fire hose be turned on the truck. The lady got back on the truck and ordered the driver to leave immediately and after being stopped twice by the mob they finally succeeded in getting out of town.

When the party reached Greenville they were in a deplorable condition many of the children's clothes being ruined by the eggs and mud and neither did the chaperones escape the same fate.

It is not known just who composed this lawless mob but according to statements of the ladies there were more men than boys taking part in the outrage.

Given a Cordial Welcome in Cordele by Citizens and Offered Assistance

PARTY REACHES ASHBURN EARLY MONDAY MORNING

Information Obtained From Studying Large Creamery Located at Ashburn

(H. L. SMITH)

After visiting the hog farm of M. C. Dornay on Aug. 5th, the Pitt county delegation proceeded on the journey. Enroute to Cordele, Ga., which was destination point for the night, one could plainly see that there was a united effort being made to diversify their crops. Velvet beans, peanuts, peas, potatoes, amber cane hogs and cattle greeted the party along the route.

Even and anon a large tract of pines would lift their stately figures high into the air as the visitors passed. To pass a large body of hundreds of acres of timbered land, unboxed for turpentine purposes, was indeed an inspiring sight.

About 5 o'clock Cordele was reached. Before the party even had time to register, local citizens had made their acquaintance and were offering their assistance in every possible way. The friendly spirit continued during the afternoon and night.

Sunday morning, the Pitt delegation, after being invited, attended two of Cordele's large Bible classes in the Sunday school. One of the classes had 137 men present. Such interest and activity is not seen every day. They have a real work in Cordele participated in by a manly set of men.

The president of the Kiwanis club wanted the privilege of entertaining the party early Monday morning, but the program, which had previously been arranged, would not permit. Suffice it to say that the Cordele spirit is fine and left a fine impression.

Early Monday morning, Aug. 7th, found the party at Ashburn, 6 o'clock found the members of the party at the milking barns of Turner county farmers. A large creamery is located at Ashburn and with this in view all the information possible was sought along the different lines. As you would drive from one barn to another you would observe the farmers bringing their cream to the creamery plant.

One of the farmers was stopped and quizzed as to the general situation. He said: "I continued cotton until it broke me. The first of January this year I started with six cows, using the cream for the creamery and giving the skimmed milk to the hogs and chickens. I have 11 in family. From these six cows I have schooled my children, paid my taxes, my doctor's bill and clothed my family. Of course I raised everything I could on the farm, but the money from these six cows is all the money I had." However, this man continued "I am going to increase my herd next year and will have more cream to sell. I believe there is a great possibility in cows, chickens and hogs. I believe the program we have started will remake our community." "I have every hope for the future," said this man.

One of the prominent men of Ashburn made this statement: "Should your party drive through Turner county three years from January 1st, 1923, I have no doubt but that will see modern farm homes on every hill side, with waterworks and all modern conveniences; you will see a people content and happy; you will see the merchants and business men prospering; you will see a community on a much sounder footing than they were before the war." Perhaps the reader is asking himself the question, "What will bring about this change?" The Ashburn man said: "The hen, the sow and the cow will do the job."

"Usually creameries do no count on making any money for the first two years," said our Ashburn pilot, "but ours has made money from the very beginning." Buter of an excellent quality is being made and placed with the large dealers.

FORFIED CITY IS FRENCH CURIOSITY

Carcassonne, Aug.—"See Carcassonne before you die" is an old French proverb which American visitors to France will do well to heed. Destined to command the ways of communication between the Atlantic and the Mediterranean, Carcassonne, one of the greatest curiosities in the world, is built about midway between the Pyrenees and the Black Mountains on the ruins of an ancient Roman fortress.

It is not only a fortified castle but a city entirely fortified, high on the hills overlooking the beautiful Aude Valley. Its double walls are almost a complete course of instruction in the art of fortification from the fifth century to the seventeenth.

In the first place it was an "oppidum gaulois" and then a Roman castle. The Visigoths came and made it a fortress, which they kept until the year 725, when the Moors from Spain chased them out. The Counts of Toulouse then made it their stronghold until 1240, when Saint Louis besieged and took it. He completed a system of defense and rebuilt the ramparts and a new fortress on the opposite side of the Aude. Several more centuries of struggle and the glorious history of the fortress was ended. During the late war German prisoners occupied it.

There are 1,000 inhabitants inside the two great walls with their houses and shops just as in an ordinary village, centered about the old cathedral of St. Nazaire, where one can see the gargole known as "The Tiger" in which Clémenceau, who represents Carcassonne in the French Chamber, found himself.

Every summer the comedie Francaise gives a series of productions in a grassy amphitheatre under these historic walls, against the fifty-three towers and embankments of this unique stronghold. To see Hamlet on the ramparts on a still moonlight night in July, or Mabeth receding the narrow stairs from the Bishop's tower is to recapture the romance of the Middle Ages.

JUDGE HEARS HIS FIRST JURY TRIAL IN 25 YEARS

Cincinnati, O., Aug.—"I guess I won't need a vacation," Judge Lueders said recently in starting the first trial by jury in Probate Court during twenty-five years. "This is change enough for me."

The jury was impaneled to settle a dispute between the county commissioners and two landowners who could not agree to terms on property which was to be condemned in order to abolish a grade crossing on the B. & O. Railroad.

WOMEN SEEK THE ACQUITTAL OF HOWARD BROWN

Young Boy Being Tried for the Murder of an Assyrian in Goldsboro

Goldsboro, Aug. 24.—Fifty women of the Goldsboro W. C. T. U. and the Women's Federal remained in court all day through the first phase of the trial of Howard Brown, the 17 year old white youth charged with the murder of Albert Beshara, a Syrian, April 26th of this year. They were present to stimulate public sentiment in favor of the acquittal of the youth.

The trial began this morning and the jury was selected by one o'clock at before the special venire appeared but not before the special venire of 160 jurors had been exhausted and a member of the jury hung on an arson case throughout last night was the twelfth juror selected. Three jurors were removed after they had been passed and put in the box, one because he had served on the grand jury that found a true bill against Brown.

The state examined five witnesses and rested. The first two testified as to the killing, and to seeing the defendant and the dead man within a few feet of each other when the five shots were fired.

Mrs. Gurley testified to seeing Beshara leave the Brown home, followed by young Brown on the day of the killing, Beshara running. Miss Pattie Hatch the first witness for the defense, testified to this, saying Brown returned, then went back down the street. The defense had five character witnesses all of whom said the youth was of good character.

Tomorrow the defense will open all day with him in the court room. He is quoted as saying before the killing that he would "have no damned Syrian alone at home with his mother." This remark is said to have followed persistent chiding at school about the alleged relationship between Mrs. Brown and Beshara.

His mother and father sat silently all day with him in the court room. Four lawyers are prosecuting and four defending.

TWO CASES DISPOSED OF IN THURSDAY'S SESSION OF COURT

A Divorce Case and Suit for the Collection of an Account Featured Session

Two cases were disposed of in yesterday's term of civil court. A divorce case required a short while but the case of L. Neal and company vs. J. A. Matthews, consumed nearly the entire session.

The divorce case was J. Horace Cox vs. Lucretia Cox. Absolute separation was granted and the court proving that the mother was not a fit person to raise the three children ruled that they be given to the father.

The suit of L. Neal and Co., vs. J. A. Matthews grew out of the plaintiffs trying to collect an account which they claimed the defendant owed them. All facts in the case were given consideration and the jury returned a verdict in favor of the defendant, ruling that the plaintiffs be paid nothing.

The civil term will be brought to a close today and on Monday the criminal term will begin.

SETTLEMENT OF RAILWAY STRIKE SEEMS FAR AWAY

Mediators and Executives Negotiate All Day in An Effort to Get Together

PLANS FOR MAKING SEPARATE AGREEMENT UNDER DISCUSSION

Railroads Stand Pat on Position Taken Relative to Seniority Rights it is Stated

New York, Aug. 24.—"We are like bats; we can't see the way out." Thus did the chief of one of the "Big Five" railroad brotherhoods describe the position in which the running trades found themselves tonight after their latest efforts to settle the great shopmen's strike, now nearing the end of its eight week.

Today peace negotiations centered on conferences between the brotherhood chiefs, cast as mediators, and the executives of more than a score of roads representing approximately 30 per cent of the rail mileage in the United States conferences which were called to order after the association of Railway Executives yesterday had stoutly declined to yield on the seniority question, but some of its members had indicated an interest in a suggestion that separate agreements might be possible.

Exactly 19 roads, aggregating about about a quarter of the country's mileage, were represented when the day's first session opened at the Yal Club this morning. After the luncheon recess, during which the mediators reported back to the striking shopmen at the Hotel Woodstock, several more executives slipped into the general conference until more than fifty main lines and their subsidiaries were represented when the parleys broke up shortly before seven o'clock. The Seaboard Air Line was one of the roads listed among the new conferees.

Although both sides professed themselves no nearer agreement than when they first went into conference, it was evident that the door to peace had not been entirely closed, for announcement was made that another session had been scheduled for tomorrow. Observers speculated with interest on the question of whether more roads would send officials to the next meeting.

KANSAS CONSTRUCTING "FLIVVER OF THE AIR"

Kansas City, Mo., Aug.—What may some day be the "River of the air"—the smallest airplane in the United States—is under construction in Kansas City and is expected to be launched within thirty days.

The "baby biplane" is being built by C. C. Melton and V. E. Ferguson in a shop in East Fifteenth street.

When completed it will weigh only 475 pounds. It will seat one passenger and will cost about \$500. It will be thirty horsepower, a reconstructed Ford engine furnishing the power. It will have a speed of seventy miles an hour.

Curious crowds daily throng the shop to inspect the tiny airplane, which has been christened "Melton's Hoopzine."

"Every man his own pilot," is Melton's motto. Melton said if the plane works satisfactory there will be "so many of them flying around that air policemen will be needed."

LET JUSTICE BE DONE.

It is to be regretted that any community has to have in it such people as those composing the crowd, who on last evening, attacked a band of children from this city who were out on a harmless outing. We have heard of mob violence and the like, but nothing in our estimation can be any meaner than for a band composed of men and boys of all ages to attack a party of children mostly girls with no protection other than three ladies who were the chaperones.

We know that the good people of Farmville do not sanction any such occurrences as that of last night and we hope and feel that they will give the matter a thorough investigation, ferreting out the guilty parties and seeing that the punishment they deserve be meted out to them.

REPORT ON UNEMPLOYMENT IN HAND OF COMMITTEE.

President Harding's Conference on unemployment issued the following statement to-day:

"The long anticipated report on unemployment and business cycles, prepared by the National Bureau of Economic Research, Inc., of New York, for the president's conference on unemployment, is now in the hands of the committee on the Business Cycle."

"This report, in which a score of experts have been working for the past six months contains a summary of practical experience in meeting the regularly recurring business depressions and their attendant unemployment with which the country has been so often saddled in past years."

"On the basis of the various phases of this report the committee has begun to draw up recommendations for mitigating the severity of the business cycle and for a tentative program towards carrying them into effect."

"On October 2 next the committee, consisting of Owen D. Young, chairman; Joseph H. Deffrees, Matthew Woll, Clarence Mott Wooley, Miss Mary Van Kleeck, and Edward Eyre Hunt, will meet again in Chicago. They will then act on the final draft of these recommendations in the hope of giving to business a working basis for co-operation. On December 1 the report is to be published, with an introduction by Secretary Hoover."

In addition to this statement Mr. Hunt said: "I believe that this report will provide a basis on which American business may deal successfully with the evils of periodical depressions, and their burden of unemployment and business failures. So far we have had the finest kind of co-operation from industry and commerce, and the committee feels certain that with this support continued he country will yet see a solution of the very serious problem of periodic booms and slumps."

CO-OPERATIVE MARKETING—WHAT DO YOU THINK OF IT?

Since the Co-operative Marketing Associations for the selling of tobacco and cotton were first talked of the Journal has gladly given column after column to the advocates of this new method for the selling of our crops, hoping that some plan had been hit upon that would be of benefit to the farmers. But we have seen so many farmers' organizations start and fall that our editorial columns have for the most part kept silent on the subject. We did not feel like advising the farmers to join something that we knew nothing about.

The plan of co-operative marketing sounds good, and we believe that the opening of co-operative warehouses throughout the tobacco belt has caused the auction warehouses to sell tobacco at a much higher price than they otherwise would have done, but the question arises, is the association helping the fellow on the inside?

Some months ago it was publicly stated by some of those canvassing for members that the association would very probably advance the delivery of tobacco something like 75 per cent of what would be a fair price, and after the tobacco was sold the growers would get the balance. The association opened its warehouses for receiving tobacco on Monday of last week, but instead of advancing 75 per cent, in no case is more than 50 per cent advanced, and seldom more than 22 1-3. It looks pretty hard for a fellow to take his tobacco to the co-operative warehouse and be advanced 5 cents a pound for his tobacco, when his neighbor, who is not a member of the association, can take the same grade of tobacco to the auction warehouse and get 15 cents a pound, all cash, with no strings tied to it.

Yes, the editor of The Journal, who now claims to be more of a farmer than a newspaper man, is a member of the association, having been fooled into joining by false statements like so many others. We were told six months ago by parties in whom we had confidence that more than 60 per cent of the cotton and tobacco to be grown in this section had already been signed up; that the association would operate the Clarkton warehouses, and that it would very likely be impossible to sell tobacco in Clarkton unless we belonged to the association, and as we had three acres planted in tobacco, we signed the death warrant. We have only carried one small load to the warehouse. It was graded and tied according to the direction of the expert grader. Only 212 pounds in the two grades. After carefully examining with fingers, eyes and nose the young man who passes on all tobacco sent there dumped both grades together and allowed us the very lowest figures, 72 cents on the 212 pounds. Good judges of tobacco tell us that it would have brought 15 cents a pound at auction, but this young man sized it up as worth about one cent a pound.

Another objectionable feature, one which does not affect this writer, however, is this: The farmer who has given a lien or mortgage on his crop is absolutely tied hand and foot. Before a check is made out to anyone a paper is shoved to him by the book keeper, on which he must sign his name to one of two blank lines. One is that nobody has a lien on his crop, and the other that Mr. So-and-So has a lien on his crop for so much, naming the amount. If he signs the first he gets his check, if he signs the second, the check is made out to him and the merchant he owes, and the grower can't get one cent on it until he goes to see the man he owes, perhaps begs him for just a little part of the check. This is a protection to the merchant, and we couldn't blame them all if they wanted to join the association and get everybody else to join, but woe unto the farmer who has to give a lien—simply slavery in a new form.

The Co-operative Association is a big thing, so big that it is necessary

to employ hundreds of young men just out of college to take charge of these warehouses. Many of these young men have never had the experience, and consequently know nothing about tobacco. On the other hand the auction warehouses are for the most part in charge of old warehousemen. Draw your comparison to suit yourself.

We hope we have raked up this co-operative association wrongly, and that all we members may soon be millionaires, but we are afraid that we have jumped from the frying pan into the fire, and the worse part of it is, we will have this mill rock around our necks for five years, if the association and the members live that long, which is doubtful indeed as to the former especially.—The Blade-Journal. Adv.

Spreckles, Sr., will file suit to gain control of his three grandchildren, the oldest of whom is nineteen. He will also try to have set aside the \$80,000 bequest in his son's will to Mrs. Wakefield. Mrs. Wakefield is thirty-nine and good looking. Mrs. Kendrick is twenty-four and suffering from tuberculosis. Kendrick is thirty-nine. Mrs. Wakefield must not be confused with Mrs. John D. Spreckles, Jr., second wife of the millionaire, who was Miss Sidi Wirt. Mrs. Wakefield is a grandniece of the late Collis P. Huntington, from whom she inherited millions.

ENGLAND SUFFERS BIG LOSS FROM THE DISABLEMENT NOW

Total Sickness and Disablement of the Population Now Amounts to 804,000

Glasgow, Aug.—"The total sickness and disablement of the population of Great Britain amounts to a permanently sick or disabled army of 804,000 persons," said Lieutenant-Colonel Freemantle, M. P., at the meeting of the British Medical Association.

"The financial loss to the treasury through the incapacity of these people amounts to two and a half million pounds per annum; the loss to the national income from personal service amounts to fifty million pounds per annum; the employment of 200,000 doctors, chemists, nurses and attendants for home sickness costs fifty-nine million pounds per annum; in addition, the indirect effects of epidemics on industry costs eleven million pounds annually.

"Altogether the direct material loss to the community of England and Wales from sickness and disability amounts annually to one hundred and fifty million pounds."

KELLY, CHAMPION OARSMAN, BUSY ON BIG BUILDING JOB

As Contractor, Has Half Million Dollars in Work; Trains Twice a Week

New York, Aug.—Unless the business of accepting and completing \$500,000 building contracts disappears very suddenly it is not likely that the rowing world will ever again see John B. Kelly, of Philadelphia, Olympic champion sculler, in active competition.

Right at this moment Kelly has contracts to the amount of a round half million dollars to be filled, and the end is by no means yet. He has become one of the most foremost contractors in and around Philadelphia, and rowing now comes under the head of an expensive luxury.

Kelly is no Adeline Patil. He has retired from the sculling game, not because he feels that he has reached the end of achievement there. Like all oarsmen the river never loses its charm for him, and at least twice a week he goes out in a shell for exercise. But he cannot now afford to indulge in intensive training nor trips

to distant regattas any more than John D. can afford to wear hand-cuffs. Both are too busy making money.

The Olympic champion is just as good as he ever was. He proved that a few weeks ago when he left Tom Rooney, a former national champion, five lengths astern in a practice dash over the quarter-mile distance. To the casual eye he seemed to be only a few days away from top form when he rowed an exhibition with Walter Hoover at the national regatta recently. Therefore it is not a question of waning speed either.

Kelly's success in the contracting game is purely self created. When he first came into prominence ten years ago or more he was a brick-layer.

CHINA TO BUILD FIRST RAILROAD ALL BY HERSELF

Unassisted by Foreign Capital or Engineers, Orientals Will Construct Branch Line

WIL BE 100 MILES LONG
Survey and Grading Completed; Work Temporarily Halted as Funds Run Short

Washington, Aug.—China proposes to engage in a railway construction enterprise all her own—constituting an innovation in the history of Chinese economic development. The enterprise will be guided by no foreign hand; no foreign funds will figure in the financing of the project; no foreigner will tender advice; not a foreign engineer will be employed in the construction of the task the new and ambitious China has set for itself.

The Chinese government proposes to build an extension railroad from

the now operating Peking-Suiyuan Railway. The extension will run to Paotowchen, a distance of one hundred miles farther west to the Yellow River, according to advice received by the United States Department of Commerce. The survey of this line has been completed and most of the grading work has been done. But financial stringency compelled a suspension of further work.

The proposed extension was estimated to cost \$6,746,000; but according to present plans a temporary type of construction will be used, including light rails and makeshift bridges. The stations and other necessary buildings will be little more than field shelters. With the present drastic economy there is still needed about \$1,255,000 for material and labor.

If the laying of the track can be started at an early date traffic to Paotowchen may be opened before the end of this year. This will extend the length of the road to approximately 500 miles.

For it seems that the old days are gone—gone beyond dreaming and desiring; those great, grand old days when swart men, lusty men, went up against swart, lusty men for the sheer glory and honor of the fight and left all thought of cash and kind in the lockers at home.

Especially, in view of the fact that at a meeting of the Greenville and Washington directors on Wednesday night, August, 23rd, the president stated that he had allowed his enthusiasm to run away with him and had acted too hastily in taking the two games from Greenville, as there was no evidence that the plate had been moved when Farmville's games were played, and that Farmville's claim without evidence supporting it should have been disallowed. Also the president further stated at this meeting that if Greenville would agree to compromise and play Farmville a three game series to determine the winner of the second half, that he would make a statement to the public that Greenville have been treated badly in the matter. Greenville took the position that it had either won the second half or it had not won it, and that in either event there was no justification of a further series with Farmville, and that to enter into such an agreement with Farmville would be to admit the charges made against Greenville concerning which there was no evidence and which Greenville has always vigorously resented.

Washington took the position that Greenville had been treated unfairly at a meeting of the league directors at which Farmville had voted twice through its President manager's vote, untying the issue, by sustaining the unjust charges against Greenville, it
