MEMBERS OF PICNIC PARTY PRESENT TRUE ACCOUNT OF RUTHLESS ASSAULT UPON THEM ON VISIT TO FARMVILLE

**Declares Assaulting Party Was
Composed of Grown People
As Well as Others**

**MAYOR CLARK SAYS
IT IS FARMVILLE'S
DUTY TO INVESTIGATE**

**Greenville Officials Declares
Any Attempt to Dodge Issue
Is Admission of Weakness**

In view of the slanderous article appearing in Sunday's News and Observer from the Farmville correspondent concerning the shameful treatment accorded a group of our Greenville young people in that town on last Thursday evening, we, the undersigned members of said group of young people, wish to give to the people of Pitt County a frank and truthful statement of the whole matter.

The Junior Epworth League of the Jarvis Memorial Methodist Church, under the direction of Miss Lill Wilson, lady manager and assistant to the pastor, proposed a hay-ride. Mr. W. H. Norris kindly furnished a large truck for the occasion and also a colored driver, Jack Brown. Jack was the only man in our party. Beside the three lady chaperones, this party consisted of thirty three boys and girls, ranging from ten to sixteen years of age—only two or three of the number being as much as sixteen. There were about ten boys and twenty-three girls on the truck.

We left Greenville a little after dark, intending at first to stop at Ballards for lunch and recreation, but when we had reached Ballards the happy young people were so thoroughly enjoying the ride together that it was suggested that we go on to Farmville. It did not occur to a member of our party that we would be unwanted in our neighboring little city, and so far as the recent unpleasantness to which the Farmville correspondent refers, certainly the lady members of this party knew nothing of this, nor did many of the children. There was not a ball-player in our party nor any one who entertained any feeling other than one of kindness for Farmville and Farmville people generally. As we entered the streets of Farmville, Miss Wilson suggested that we give cheers for Greenville. This was done right heartily in the usual school-boy style as we rode up and down the main street a couple of times. Miss Wilson also suggested that we drive by the Methodist parsonage and cheer for Brother Rumley and family as the leaders of our church in Farmville. We found him out of town. In passing the home of Mr. J. Y. Monk it was suggested that as he was a leading citizen he be cheered. This was done. While riding down the main street, some boy in our party, elated over Greenville's defeat of Tarboro in the afternoon's game, cried out "Who won the last half?" and the crowd replied with enthusiasm "Greenville." This cheering was not intended to give offense, nor did any member of our party think that it would be so construed. But it seems that when baseball was mentioned it was the touching of a match to the powder.

Our party, after riding around the streets a while as just stated, decided on the school-grounds as a proper place to spread their lunch. The truck was halted near the school grounds and Miss Wilson and a number of the children alighted to make ready for lunch. Just at this juncture while two of the ladies remained on the truck, one of whom was our pastor's wife, a car came up close beside, loaded inside and out with boys and grown young men. Nothing was thought of this at first, as no member of our party up to this juncture had had any intimation that we were unwelcome guests. As this car got opposite where the ladies were seated, someone from the car threw a clod of dirt which struck one of these ladies squarely in the forehead, breaking into fragments and filling the hair and eyes of both with dirt and sand to say nothing of the painful blow itself. Our readers can better understand than we can explain the sensation that this created. It

came so utterly unexpected and was such an unprovoked assault that the ladies were at first dumb from surprise. Miss Wilson, hearing a commotion looked around and saw a large group of men and boys hurrying up toward herself and the children in a threatening attitude. She tried to reason with them, and when she spoke, one man who appeared to be about twenty-five or six years of age, and seemed to be the leader of the party, said "Hush boys and let us see what the lady has to say." Miss Wilson then spoke and asked what cause for offense had been given. "We are a party of Christian young people who have come over from Greenville to have a pleasant evening with you. Why do you treat us this way? At this she was greeted by hisses and jeers and someone in the crowd sneeringly replied that there were no Christians in Greenville and that we were not wanted there at all. Furthermore we were repeatedly dared to drive down Main street again and told that if we did so the town would be turned upon us. Just about this time a nicely dressed gentlemanly appearing man came out to the truck from a close-by house and warned us that we had better get out of Farmville as trouble was brewing for us. He also cautioned us not to go down main street as he said they had prepared to turn the hose upon us. This was the only courteous word that was offered in our defense from such brutal treatment. Beginning to realize somewhat the unpleasantness of the situation, Miss Wilson requested all the boys and girls to remount the truck as quickly as possible in order that we might get out of town. This was done with difficulty owing to the fact that the mob crowded about us so closely. When we did attempt to drive off we were assaulted with stand, mud, bags of water, stones and eggs. Several were struck with stones, among these being at least five lovely young girls. Another girl had her dress torn almost from her person by one of the ruder boys in the mob. Many eggs were thrown, and some of our party were almost drenched with them. Frank Wilson, son of our Mr. Frank Wilson, the King Clothier of Greenville, a thirteen year old boy, was struck right in the eye with an egg hurled with unerring precision. A few suit which he was wearing was just about ruined. The wife of our pastor, Mrs. Scoville, was also bespattered with eggs as well as sand, as was Miss Wilson.

It was in the midst of such treatment that our truck halted for a few moments in front of the mayor's home. Very naturally our young people were greatly excited and some of the girls were crying and more or less loud talking was going on. A lady, who it seems was the mayor's wife, came out and stated that there was a very sick lady next door and requested the party to be quiet. Miss Wilson did her best to quiet them, and got away as quickly as possible. We were followed out of town for some distance.

The above is a true and accurate statement of what occurred by us and to us on this regrettable occasion. If called upon we are willing to go on the stand and make affidavit to the above facts. Furthermore we assert most emphatically that no vile language was used such as we are reported to have used by the correspondent to the News and Observer. No insult was offered by any member of our party to any lady or to any one else for that matter. One or two of our number say that after one of our boys had been struck several times by eggs and was being taunted by a youth riding a bicycle close beside the truck this boy was heard to tell the other that he was a yellow dog. Certainly such a remark was not without justification.

Very naturally we in common with many others in our city feel very much aggrieved at the treatment accorded us while in Farmville and are at a loss to understand how the people of Farmville can permit such conduct to go unrebuked. Before bringing this article to a close, we would like to say, that there were several

HEAVY FINANCING REPORTED TODAY BY CORPORATIONS

Issuing Stocks Instead of Selling Bonds Features New York Activity

New York, Aug. 27.—Large corporation financing through stock issues instead of the sale of bonds was the outstanding development of the security market last week. For the third consecutive week, new bond offerings established a new low level for the year, totalling only \$7,777,000 as compared with \$13,700,000 the week before and a weekly average to date of slightly less than \$50,000,000.

Following the lead of the Illinois Central Railroad, directors of the Chesapeake and Ohio have called a special meeting of stockholders September 26, to approve an increase of \$30,000,000 in the capital stock of the company. The American Telephone and Telegraph Company also announced a forthcoming stock issue of \$115,000,000 to take care of business expansion. Several other large corporations, including one of the big Eastern railway systems, are reported to be contemplating additional stock financing in the near future.

Bond prices continued to move to higher ground during the week, although European issues were heavy under the dampening influence of weakened exchange rates. Local dealers report that their shelves are nearly empty and investment bankers are said to be seeking both issues of worth with which to meet the expected improved demand next month. Large institutions are in the market for high grade bonds, but the supply is scarce.

Several large financing projects are in progress, including the financing of an automobile and textile company, the financing of a sugar company and an issue of \$44,500,000 in equipment trust certificates by a Northwestern railroad system. The Pennsylvania Telephone Company also is reported to be negotiating for the sale here of a refunding issue of bonds to replace the \$25,000,000 issue of 7 per cent notes sold in January, 1920.

HARRINGTON TELLS WHY WASHINGTON PLAYS FARMVILLE

President of Club Says Greenville Agreed to Proposal for Final Games

On Saturday night August 19th the directors of the Washington Baseball Club met in Washington, and discussed the league meeting which had been held in Farmville on Friday, August 18th. As a result of that meeting it was decided to play a series with the winner of the second half, the percentage to be figured disregarding the action taken at the league meeting, except that one game was to be forfeited by Greenville to Farmville on account of the eligibility of Pitcher Boelling. As it turned out Greenville was the winner according to that computation, and they were notified that Washington would play with them a series of seven games.

After Farmville was declared the winner of the second half under the league rules, they have insisted that Washington, the winner of the first half, play a series with them under the official rules of the league. Washington stated to Farmville that they were in honor bound to first play this series with Greenville as it had obligated to do, and stated to Farmville that they would play them upon the expiration of the series with Greenville which under the agreement would not have expired until next Wednesday. This was not satisfactory to Farmville. In order to arrive at some settlement of a very deplorable and unsatisfactory controversy between the three owners involved, Washington asked Greenville if it would be satisfactory to them to terminate the Washington-Greenville series on Monday night. Mr. Gay Smith, manager of the Greenville Club readily agreed to it, stating that he would be glad to aid Washington in arriving at a settlement.

After Greenville had released us from our obligation to play them through Wednesday, Washington then notified Farmville that it would play them a series beginning Tuesday, the series to be played under the league rules. This proposition was then agreed to by both parties.

GOVERNMENT WILL ANNOUNCE POLICY IN STRIKE ISSUES

Formal Announcement Will be Made Within Next Few Days It Is Believed

HARDING EXPECTED TO REVEAL ATTITUDE IN NEXT FEW DAYS

Some Doubt as to Whether Congress Will Arm President With Proper Power

Washington, Aug. 27.—The exact scope for the administration's policy in dealing with the rail and coal strikes is expected to reveal itself within the next few days as a result and executive action which appeared tonight to be nearing completion.

Whether the emergency legislation to be definitely urged upon by Congress will include the presidential authorization to take over and operate coal and rail properties was a question that still remained unanswered, but it was indicated that administration officials probably would make a final decision on the point in the very near future.

In some quarters it was believed that the proposal to arm the executive with these emergency powers would be finally threshed over among the leaders who are with President Harding on his week-end cruise down the Potomac, and that a definite answer of policy would follow the return here of the presidential yacht Mayflower tomorrow morning.

Those in the President's confidence said before he left here for the cruise last night that although he still believed industrial peace would be restored without a resort to government operation, he was inclined to feel that as a precautionary measure he should be given full authority to act before Congress begins its contemplated recess.

In addition to Secretary Hoover and Attorney-General Daugherty, two of the cabinet members who have been particularly active in shaping the government's course during the strike period, the President was accompanied on the Mayflower by Chairman Cummins, of the Senate Interstate Commerce Committee, who already has drafted for introduction in the senate a bill authorizing the executive to take over and operate any individual road which does not adequately perform its functions as a common carrier. Before he went aboard the Mayflower Senator Cummins had indicated that his measure and a similar one relating to coal mines would be formally introduced early this week.

CRIMINAL COURT OPENS WITH BIG CROWD PRESENT

Morning Hours Consumed in Judge Calvert's Charge and Preparation of Calendar

The August of Pitt county superior court for the trial of criminal cases convened in this city this morning at ten o'clock with Judge Thomas H. Calvert, of Raleigh, presiding and Solicitor J. H. Davis, of New Bern, prosecuting. Practically the entire morning hours were consumed in the judge's charge to the grand jury and the preparation of a temporary calendar from the criminal docket. The actual trial of cases began immediately after noon adjournment and the remainder of the week will witness the most intense activity.

The grand jury is composed of George Worthington, J. H. Warren, J. F. King, C. H. Langston, J. W. Cook, J. W. Whitford, Fred O'Neal, W. N. Cox, J. B. Peed, S. F. Harper, foreman, B. F. Clark, J. H. Bullock, Joe Sutton, J. D. Williams, S. S. Smith, J. R. May, Z. V. Whitchard, and Guilford Evans.

An unusually large crowd attended the opening session here today, and it is expected this will be the case the remainder of the week. Quite a number of cases of more or less interest to the various communities will be given hearing from day to day and some of these very likely will require considerable time in disposing of. Judge Calvert, however, will make every effort to discharge each case as expeditiously as possible and by the end of the week it is more than likely the docket will be completely cleared.

SMITH CONTINUES STORY ON TRIP IN SOUTHERN STATES

Secretary of Chamber of Commerce Tells of Stay at Thomasville, Georgia

PARTY VISITS BIG FARM OPERATED BY PROMINENT GROWER

Gain Much Knowledge of Stock Raising and Development of Fine Orchards

(W. L. SMITH.)

After concluding the stay at Monticello, Ga., on the afternoon of Aug. 8th, the Pitt delegation proceeded to Thomasville. Immediately after arrival at Thomasville, the Chamber of Commerce took possession of the party and the famous stock farms were visited.

The first farm visited was that of A. Holman. An up-to-date dairy was inspected and a more sanitary plant would be hard to find. It was a joy to go through this place and see the modern equipment and fine cows.

We were told that good individual cows have brought as high as \$1000 each; calves have sold for \$1000, and that one bull brought \$25,000.

Such pastures as you would think impossible lay out on every side of the barns. You could look in every direction and you would see fat contented cattle grazing. The management stated that practically all of the feed given to the herd was grown on the farm.

"In order to have a fine lot of cattle like this, it requires constant care and attention stated the management. "But," he further stated, "if you will give the attention necessary, there is good money in cattle."

The next farm visited was that of E. Mack. Perhaps this is the most widely known stock farm in the entire South. The purpose of this farm is for show stock and does not feature the commercial end at all.

Mr. Mack piloted the party over his barns and equipment, as well as taking a stroll over his pastures. Said Mr. Mack: "This animal weighs 2,300 lbs, and I have refused \$25,000; this animal, at 12 months old, weighed 1,500 lbs; these 240 cows are grazing on 360 acres."

"I will leave next week for a show tour, going to Wilmington, Del., Syracuse, N. Y., and Kansas City, Mo.," said Mr. Mack.

Mr. Mack took 40 first prizes during 1921 at various fairs and exhibitions. To view those white faced herford cattle is a rare treat and will repay anyone who admires quality and beauty, that is not duplicated every day.

In addition to the large stock farms the small farmers are also thinking in terms of live stock and it is no unusual thing to pass home after home and see both fine hogs and cattle.

The party also passed orchard after orchard given to the growth of peaches—the large paper shell variety. The trees showed that careful attention is given, judging from the appearance. This industry, alone, has been quite a factor in the development of Thomasville and surrounding county. It, however, like all other worthwhile enterprises, will utterly fail unless the right attention is given.

The experiment station was visited and a survey made of different test plots. The explanations given were greatly enjoyed by the party.

Thomasville is also favorably known because of a large number of picturesque estates, possessing a pleasing architecture and forming a circle on the rural boundary lines of this enterprising city. Many of these estates, with stately plant as the natural background, present a picture of indescribable beauty.

The Thomasville pilots, under the auspices of the Chamber of Commerce, showed every courtesy to the Pitt delegation. The time passed all too quickly for so important a center as Thomasville.

NEW BERN MAN ATTEMPTS SUICIDE OVER LOVE AFFAIR

Slashes Throat While in Presence of His Sweetheart

New Bern, Aug. 27.—James McGrath, age 19, a sailor on the revenue cutter Pamlico, is in St. Luke's hospital after having attempted to take his life by stabbing himself in the presence of Miss Clara Bell Huff, at the home of her grandfather, Mr. H. Huff, early yesterday afternoon. In spite of his own and the girl's brief declaration that the cutting was accidental, opinion is that it was deliberate, for the wound, while not serious, is too deep, it is believed to have been done as the body said.

Questioned last night, Mr. Huff stated that he was not at home at the time of the stabbing, but that on his return he met McGrath on the street, bleeding from his wound, and at the latter's request aided him in reaching the hospital. "He told me," Mr. Huff said, "that he was teasing the knife up in the air and that it slipped and cut him. More than that and my grand-daughter's reiteration, of the statement, I do not know."

Interviewed at the hospital young McGrath would not discuss the "accident," as he termed it. He stuck to his contention that it had been as Mr. Huff stated, and refused to have it thought that he had attempted to take his life. At the time he seemed to be resting well, and not in any apparent pain. During the afternoon the girl's mother called at the hospital, and as she left he said to one

STEADY GROWTH IN U. S. EXPORTS.

The quantity of cotton cloths exported from the United States in the fiscal year just ended showed a material increase over the preceding year and a big gain when compared with the pre-war average. The value of course showed a decline, for the average export price per yard in the fiscal year 1922 was but about one-half as much as that of the immediately preceding year. The quantity, exported in the year ending June 30, 1922, says the Trade Record of the National City Bank, of New York was 675 million yards against 556 millions in the immediately preceding year, but the 1922 value was only \$77,000,000 against \$141,000,000 in the year preceding. The quantity exported increased 10 per cent while the value declined 45 per cent. The average export price of the cloths sent out of the country in the fiscal year 1922, was 12.5c per yard against 25.4c in the fiscal year 1921.

This increase in the quantity exported in 1922 occurs, says the Trade Record, especially in the Orient. China alone took over 30 million yards against 12 millions in the preceding year, and the Philippines 87 million yards against 43 millions a year earlier. To Asia and Oceania as a whole the exports of the fiscal year 1922 were 162 million yards against 96 millions in the preceding year. To Europe, the great cotton goods manufacturing outside of the United States, the total in the year just ended was 40 million yards against 20 million in the preceding year, and to South America 115 million yards against 124 millions in the fiscal year 1921. The one grand division which showed a marked decline was North America, to which the exports of the year were but 239 million yards against 279 millions in the preceding year and practically all of this fall off occurs in the shipments to Cuba to which the exports in the fiscal year 1922 were but 30 million yards against approximately 90 millions in the year preceding. These figures of distribution are exclusive of about 50 million yards for which destination is not yet shown in the official reports of 1921 and 1922.

A CROOK AND A BANK.

While in the opinion of many lawyers a person whose carelessness causes another to suffer injury or property loss by fire is actionable under the common law, the Wisconsin Industrial Commission is urging a law in that state making persons responsible for the damages of fires started through carelessness. The matter is strikingly driven home by this comparison:

"A crook robs a national bank of one million dollars. The police powers of the state and nation are put to work to apprehend him."

"A man deliberately sets fire to a grain elevator containing one million dollars worth of grain. Some fire marshal deputy, alone and unaided investigates the fire in the hope of discovering sufficient evidence to bring the guilty man to trial, perhaps before a jury strongly prejudiced against circumstantial evidence."

"A man's sheer carelessness causes a fire that destroys one million dollars worth of his neighbor's property. Nothing is done to punish him because a certain amount of misplaced sympathy is wasted on him because of his own law."

"Farmers are held for damage from spreading fire; railroads for fire spreading from their right of way. Why not extend this liability to the man with a basement of rubbish, a defective chimney or other known fire hazards? Pennsylvania has such a law. It is the most effective way of preventing carelessness."

grown men in the mob which assaulted us, and that it was not composed of irresponsible boys entirely by any means. Most of the party had on long pants.

Mayor Clark States Position.

The foregoing succinct statement by Rev. Mr. Scoville is a clear exposition of the facts surrounding the deplorable affair at Farmville. But even more disgraceful than the cowardly assault itself is the attempted justification of the acts of violence, and defense of those who participated therein, by the unsigned news item appearing in Sunday's News and Observer.

To say that the three refined Christian ladies and the truck load of children, seven boys and twenty six girls, were even capable of provoking a community to assault and mob violence, is to admit the lack of respect for law and order and the inefficiency of officials.

The anonymous news item above referred to, states that the truck drove all over town two or three times; and that some of the young boys (?) followed it throwing water and eggs. If this be true, where, oh where, were the police, and where were the substantial, law abiding citizenship, that such a situation should have been allowed to be repeated two or three times? If the truck load of children were disorderly why didn't the police take them in charge before they had driven even once "all over town." Instead of

waiting for the mob to form and amass supplies of over ripe eggs, water bags, mud, rocks, etc.? It is admitted the truck arrived in Farmville between nine and nine-thirty p. m., at which time all stores had closed except the drug stores and the only young boys took part in the attack where did the eggs and water bags come from? Who opened up to furnish the supplies of ammunition? Who brought out and connected the fire hose? Was this the work of only young boys? Who drove the armored automobile around the truck as the volleys of eggs and rocks were fired?

"The aforesaid anonymous article, which adds insult to injury, reads further, 'and the party moved on towards Greenville using the most vile language ever uttered, which the men and women all along the street heard,' and further, 'Grown people of Farmville had no part in the affair.' Would the nameless scribe have the people of Greenville believe men and women of Farmville stood by, passively witnessing a dastardly assault on their defenseless wives and children, and never even raised a hand or a voice to stop it? If there was cursing and the 'most vile language used' how did the passive men and women along the street know from which side the violence emanated? Especially is this true when considered in connection with the fact that since the occurrence, Greenville automobiles passing through Farmville have been

hissed and jeered at, with cries of "eggs, eggs."

It is true that the Mayor of Farmville, Mr. Moore, called up on the phone the writer of this article Saturday, and suggested that a joint committee representing both towns make an investigation and place the blame; and in deference to his request which was sponsored by some of the prominent citizens of Farmville a diligent effort was made to secure such a committee, but to no avail. The Greenville citizens stating frankly that they thought it was Farmville's place to clean its own house, and that they did not care to subject themselves to further insults, in case of a visit to Farmville. Thereupon the mayor of Farmville was informed of the situation and asked to apprehend and punish the guilty parties. Then it was that the grossly unjust, slanderous and insulting news item appeared unsigned in Sunday's News and Observer. The article from Greenville being a product of a Greenville paper and clipped therefrom.

Greenville's position is that if it were possible to imagine the happening of such a shameful affair in Greenville, the guilty parties, both men and boys would have already been apprehended and punished, and Farmville would not have been embarrassed by a suggestion that its women and children were responsible, and a request to help wash any dirty linen for Greenville.

The people of Greenville generally do not blame the people of Farmville generally for this unfortunate affair, for they have the utmost respect and confidence in the moral, law abiding element of the Farmville citizenship, but they do feel that it is the duty of that type of citizenship and the authorities to erase this stain in no uncertain terms by proper punishment to the guilty parties; and they do resent the publication of the slanderous article already referred to in which an effort is made to justify the outrages of a lawless mob of hoodlums, bullies and toughs.

The above article is written in a friendly spirit, yet with a desire to present the logic of the situation and impress upon the good citizens of Farmville what Greenville sincerely believes is their duty in this mat-

ter. Situated as I am, if I did not resent the false impressions conveyed and sent out in the Farmville anonymous news item, with the very vigor of my soul, I would be unworthy of my citizenship among the Christian people of my community.

This matter is up to you Farmville in the fullest sense, and any attempt to dodge the facts or shift responsibility is an admission of weakness and inefficiency on the part of the who are the standards by which they would have Farmville judged.

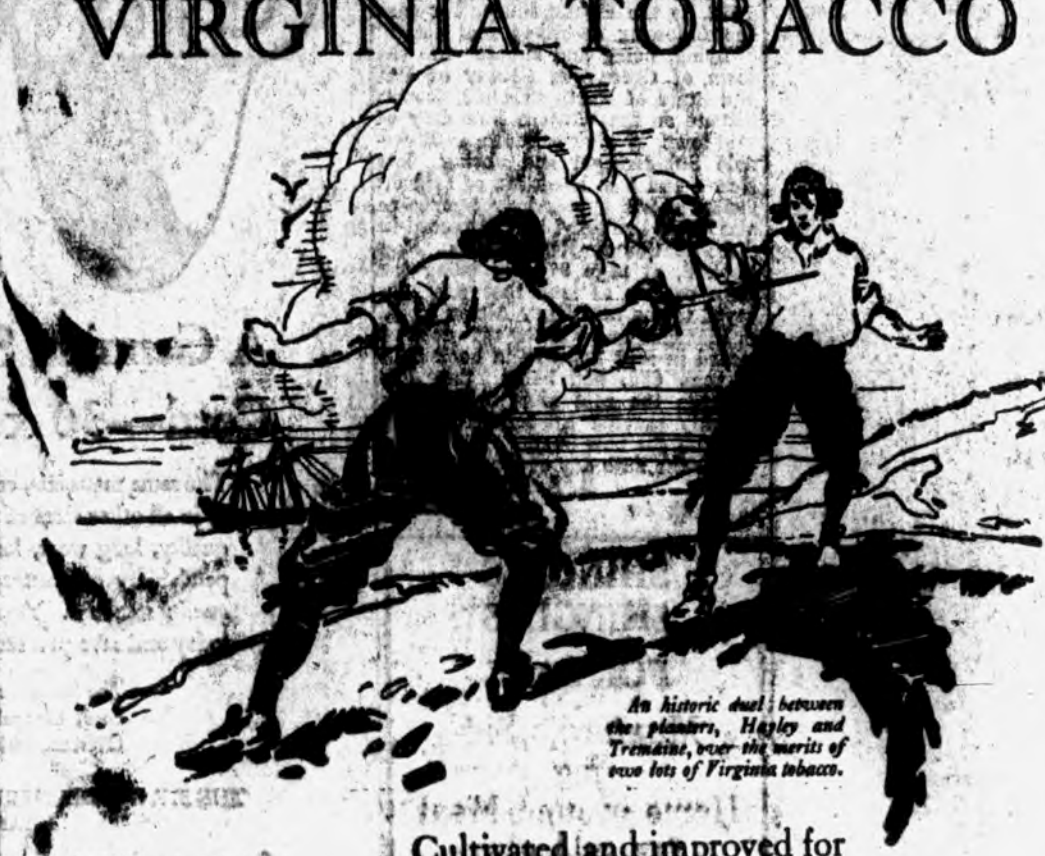
EPISCOPAL CHURCH

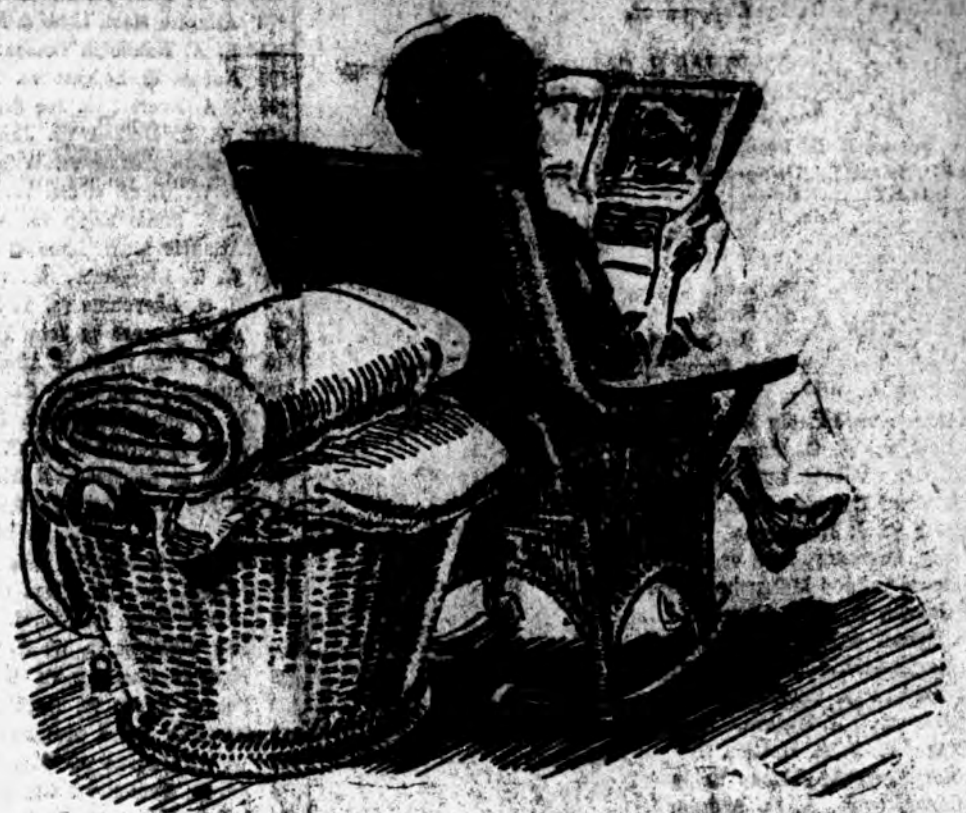

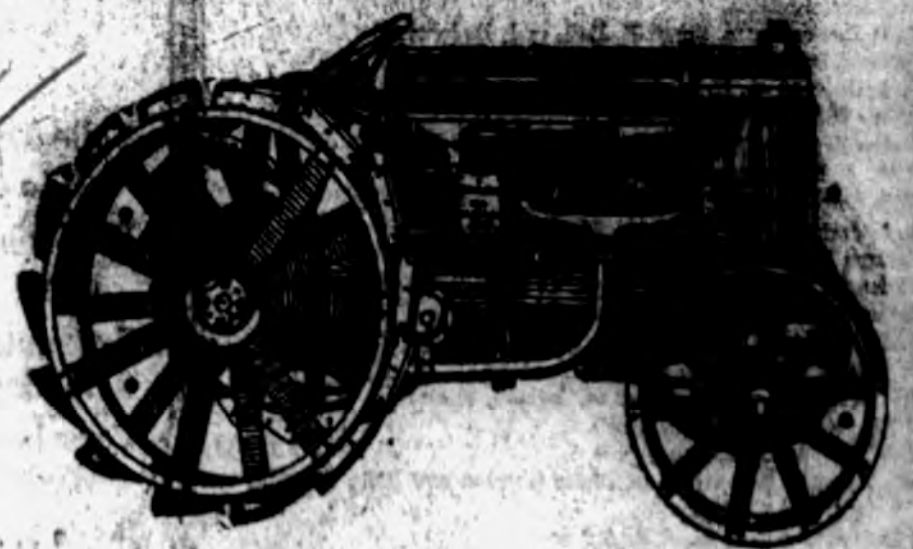

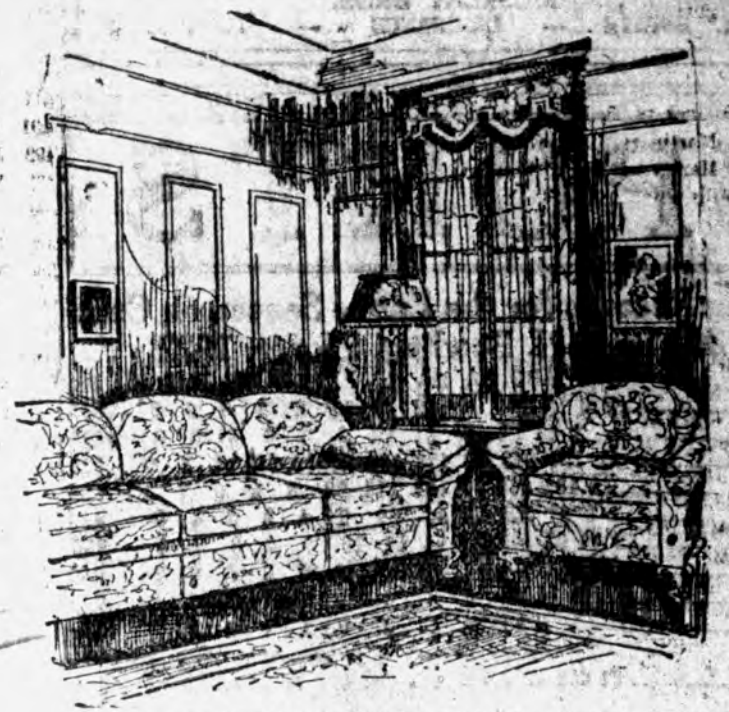
