

REIGN OF TERROR SPREADS IN SMYRNA

GREEK WARSHIPS BOMBARD THE CITY AS WAVE OF FLAME TWO MILES LONG SWEEPS ALONG WITH DEATH AND DESTRUCTION

Wharves and Warehouses Occupied by Refugees Threatened by Conflagration

LOSS OF LIFE WILL PROBABLY REACH INTO THOUSANDS TODAY

Harbor Filled With Floating Corpses as Panic Spreads to Every Quarter of the City

London, Sept. 16. — Smyrna has been bombarded by Greek warships, according to a central news dispatch from Athens received here today. The attack is centered against the Turkish quarters. The fire, which was reported to have been extinguished has again broken out and is threatening the wharves and warehouses where fugitives have been quartered. Tremendous additional loss of life has occurred in the last few hours and it is feared that it will be impossible to estimate the number of dead. It is believed the casualty list will reach into thousands, however. The harbor is full of floating corpses and panic prevails throughout the city. The Smyrna correspondent of the London Daily Mail describes the conflagration as history's worst. An unbroken wave of flames two miles in length swept over the city the last few hours.

TARIFF REPORTED BACK TO SENATE IN QUICK ORDER

House Adopts Conference Report on Measure by a Vote of 210 to 90

Washington, Sept. 15.—The House, by a vote of 210 to 90, adopted today the conference report on the administration tariff bill. Ten minutes later the measure had been reported back to the Senate, where it was made the unfinished business for tomorrow. Final legislative action before the end of next week was looked for by Republican leaders. Three attempts were made in the House to get the bill back into conference for a third time, but two were blocked on points of order and the third was defeated by a direct vote, 193 to 108. The vote was on a motion by Representative Garner, Democrat, Texas, to instruct the House managers to insist on the original proposal of the House for a duty of 1.60 cents a pound on Cuban sugar in place of the 1.76 cents a pound agreed upon in conference. On the roll call on final passage of the bill, fourteen Republicans voted in opposition and five Democrats in support.

Democrats supporting the bill were: Favrot, Lazaro and Martin, Louisiana; Hudspeth, Texas, and Lea, California.

Meyer, London, New York the single Socialist member, voted against the measure.

Thirty-four Republicans and Mr. London voted for the Garner motion for a reduction in the duty on sugar and nine Democrats voted against it. The Republicans included: Clouse, Tennessee.

Democrats opposing the Garner motion were: Aswell, Favrot, Lazaro, Martin, O'Connor, and Wilson, all of Louisiana; Hudspeth, of Texas; Lea, California, and Taylor Colorado.

FORD'S PLANS TO CLOSE DOWN MONDAY OVER COAL GOUGING

(By International News.) Detroit, Sept. 16.—A hundred thousand men here and in this vicinity will be thrown out of work today and many factories throughout the country making Ford parts will be forced to shut down following the closing of Henry Ford's plants here. The closing down has been set for Monday. Already men of the Detroit plants have been notified that they would be laid off indefinitely. No word has yet been received from Edsel or Henry Ford.

Officials at the plants said they believed Ford would make good his threat to shut down because of gouging in the coal industry.

GENERAL ADVANCE IN PRICES NOTED ON LOCAL MARKET

Tobacco Market Sells 1,893,872 for \$456,783.47 During Entire Week

GENERAL AVERAGE IN PRICES SHOW A SUBSTANTIAL GAIN

Farmers From Surrounding Counties Elated at Splendid Showing Here

For the week ending with completion of sales yesterday the Greenville tobacco market sold a total of 1,897,872 pounds of bright leaf for approximately \$456,783.47. The average price paid for this amount was \$24.11, according to information given out this morning by Mr. H. A. Bost, secretary of the Greenville Tobacco Board of Trade.

For the entire season the market sold approximately 6,837,924 pounds of tobacco at an average price of \$23.45.

This week was one of the most successful since the opening of the market last month, as prices showed considerable strength on all grades of bright leaf and sales were heavy virtually every day.

One of the most notable features of the week was the large number of growers present from other counties. The opening of the four mile bridge over the Roanoke river at Williamston opened up a way for hundreds of farmers to reach this market who heretofore were forced to sell in other sections.

The visitors were highly elated at the splendid prices prevailing from day to day and made no attempt to shield it. They expressed themselves as highly gratified at the splendid treatment received at the hands of warehousemen and said conditions here were better than anywhere they had ever sold.

The price situation was exceptionally favorable in the sale of heavy bodied tobacco and farmers who had that kind for sale reaped great benefit from their labor. All tobacco, however, brought good prices and not a single farmer failed to receive living prices for his offerings.

Officers stated this morning that they hoped everyone would make it a point to attend this meeting if possible, as many matters of importance will be considered.

CHILD LABOR LAW RECEIVES GREATER ATTENTION IN CITY

Dr. D. R. Markham Finds Number of Violations, but People Ready to Co-operate

SURVEY WILL BE CONTINUED HERE WITHIN TWO WEEKS

Danger of Tax Enforcement of Toilet Law Fully Realized by Manufacturers

D. R. Markham, authorized agent of the North Carolina State Child Welfare commission, who continued the survey of child labor conditions here this week, left this morning for Raleigh. He will return to Greenville within the next two weeks and complete the survey which was started here several months ago.

Mr. Markham said he found a number of violations of the child labor and toilet law, but that everybody was ready to co-operate with him in enforcing the legislation. He said business men and manufacturers exhibited a commendable spirit of co-operation and promised to lend their support in the effort to prevent employment of children under sixteen years of age. These children, they agreed, should be in school and unless everyone helped, they agreed the law could not be made as forceful as it should be.

The danger of tax enforcement of the toilet legislation was realized by every person with whom he came in contact, Mr. Markham stated, and the next few weeks should see continued improvement in conditions here. The violations of this law probably will exceed that pertaining to employment of children, it was pointed out, but after the people are educated up to the high standards set by the commission little trouble will be experienced in complete enforcement.

Only two more days will be necessary in completing the survey after he returns here, Mr. Markham said, and it is expected by that time a great improvement will be noted in local conditions. The public can keep well informed as to the laws by reading literature sent out by the commission. Standard requirements of the toilet law follow:

In buildings hereafter erected, toilets shall be located in separate parts of buildings or grounds for males and females, white and colored.

All toilets shall be separated by substantial walls of brick or timber. Toilet arrangements or facilities may be furnished by employer off premises.

Employer shall keep toilet rooms in cleanly condition.

A misdemeanor for any employee who shall willfully intrude or use any toilet not intended for his or her sex or color.

All toilets shall be lettered and marked in a distinct manner.

Toilets shall be provided to separate the white and colored.

Toilets shall be provided to separate the males and females.

BODY OF MINISTER AND UNIDENTIFIED WOMAN FOUND BY CHILDREN

(By International News.) New Brunswick, N. J., Sept. 16.—The bodies of the Reverend Edward Hall, rector of the Episcopal church here and an unidentified woman were found by children. They had been dead forty-eight hours. The minister was shot once in the forehead and the woman three times. No weapons were found near the bodies.

BISHOP DENNY TO DELIVER SERMON TO METHODISTS

Richmond Minister to Preach at Jarvis Memorial Methodist Church at 11 O'clock

WILL ALSO PREACH TO BETHEL PEOPLE TOMORROW NIGHT

There Will be no Evening Services at Local Church Because of Bethel Services

The Methodist of Greenville are expecting a red-letter day at the Jarvis Memorial church tomorrow. Bishop Collins Denny of Richmond, by special invitation of the pastor, is in the city and will preach at the eleven o'clock hour. It is also likely that Bishop Denny will attend the session of the Sunday school and thus see the need of this rapidly growing congregation for adequate equipment in this department of their work. In fact, the express purpose of the bishop's visit is to rally all the Methodist forces of the city for the purpose of raising the necessary funds to complete the Sunday school plant now in course of construction.

Bishop Denny is regarded as one of the most scholarly men in the entire church, having served as a professor in the faculty of Vanderbilt University for a number of years before his election to the high office which he now holds. It was at the general conference held in Asheville, this state, twelve years ago that Bishop Denny was called to the bishopric. During these twelve years he has presided over many of the strongest conferences and everywhere he goes he establishes himself with the people as both a great preacher and a great churchman. The Methodists are justly proud of having such a man as one of their chief pastors. No doubt there will be a capacity congregation to hear him. The public generally is cordially invited.

At the evening hour the Bishop will preach in the Methodist church at Bethel, and as many of our people will want to hear him in Bethel also, the pastor of Jarvis Memorial announces that there will be no evening service here.

NEW YORK CENTRAL MAKES PEACE WITH RAIL BROTHERHOOD

Railway Heads See Beginning of End of the Recent Labor Disorders

PENNSYLVANIA LINE TO FOLLOW PATHWAY BLAZED BY OTHERS

Conductor's and Trainmen's Brotherhoods Also Affect Peace

New York, Sept. 15.—The beginning of the end of all the labor troubles that have from time to time beset the transportation lines of the nation for the past several years was believed by many railway heads and union chiefs to have come today when the New York Central Lines made peaceful settlement with two of the operating brotherhoods and the Pennsylvania System began negotiations toward a similar end. Arrangements for like conferences here next week between brotherhood leaders and six other big Eastern carriers were under way tonight.

By today's agreement the various roads making up the New York Central system agreed to continue for one year, beginning September 30, the present wage scale and working rules for their trainmen and conductors and to withdraw from the United States Labor Board their requests, made more than a year ago for a downward revision of wages and the elimination of time and a half pay for overtime work.

The New York Central gave out a statement indicating it would soon call into conference the leaders of the engineers and firemen in the hope to amicably come to terms with them. Tomorrow that system will bring together its officials and leaders of the striking shopmen in the hope of ending the strike that began July 1.

W. G. Lee, president of the Brotherhood of Railroad Trainmen, announced here tonight that a conference in Pittsburgh today the Pennsylvania had agreed to continue its present wages to all four brotherhoods, but a later dispatch from Pittsburgh said the announcement was regarded there as premature, since the conference with trainmen and conductors would continue tomorrow, while those with the engineers and firemen had not yet begun. Brotherhood leaders assembled here said, however, they understood the Pennsylvania would follow the lead of the New York Central.

DEPARTMENT AXIOUSLY AWAITS FINAL REPLY FROM CONSTANTINOPLE

(By International News.) Washington, Sept. 16.—State department officials today were anxiously awaiting a reply from Constantinople to the American proposal that this government co-operate with the allies for relief of refugees in Asia Minor. In the absence of definite information the department would make no statement as to the responsibility for the burning of Smyrna.

SIX MILLION DOLLAR FIRE SWEEPS THROUGH NEW ORLEANS WHARF

(By International News.) New Orleans, Sept. 26.—Damage amounting to six million dollars resulted from fire which swept two thousand foot of the wharf here and a two story shed in front of the United States army supply base on the river front. A wall of flames a half mile wide through the buildings attracting thousands of people to the scene. The fire was one of the most spectacular in city's history despite heavy rain.

CIVIL COURT WILL END TODAY AFTER SUCCESSFUL TERM

Calendar of Over 150 Cases Probably Will be Completely Cleared

MANY JUDGMENTS RETURNED DURING FRIDAY'S SESSION

Day Was Featured by Large Number of Cases Being Dismissed

The civil term of Pitt county superior court which convened in this city last Monday morning with Judge Thomas H. Calvert of Raleigh, presiding, will be brought to a conclusion sometime this afternoon after one of the most successful sittings in many years. The calendar has been cleared of a greater number of cases this term than in several months, court officials stated today and resolutions of thanks have been extended Judge Calvert for the way he succeeded in getting work to move along so smoothly and with such rapidity.

There were some hundred and fifty cases on calendar for the term and so intent was the court in clearing the slate that session was continued through today. When adjournment is ordered this afternoon it is very likely their ambitions will have reached a state of materialization.

From thirty to forty cases have been disposed of each day this week, with exception probably of a day or so when long drawn out issues prevented so many cases from being reached. The record is considered short of remarkable and bespeaks splendid co-operation on part of the presiding official and his assistants.

In yesterday's session the Pitt Lumber Company was awarded judgment for \$36.83 against J. R. Ashen. The defendants immediately filed notice of appeal to supreme court.

Alfred Wainright was awarded the sum of \$50 against John Smith. P. T. Anthony and E. B. Thomas, trading as Anthony & Thomas were awarded judgment for a cow against W. A. Casper.

The case of L. C. Cooper against W. M. McArthur, was continued until another term of court in order to give the plaintiff time to inquire into certain matters desired.

In the case of Robert Green, guardian for J. A. Andrews, against A. B. Ellington, the defendant was awarded judgment for \$3.20.

While the senate committee investigating Ford's proposal for Muscle Shoals hasn't found it advisable to make any favorable report, supporters of the automobile manufacturer are working over time in an effort to get committee to accept the proposition. That Ford's offer is the most popular of any cannot be questioned. The public believes he is capable of converting the Shoals into a great industry capable of employing millions of people and for that reason if for no other they are going to use their influence in his behalf. Henry Ford has not only made his automobile industry one of the greatest in the country, but he is engaged in several other enterprises which have proven successful in every way. It is these successes that have inspired such great confidence among the public and which have caused even the poorest class of the country to desire his ownership of the great nitrate plant.

PROVIDING A GREAT NEED.

The plan of the Pitt County Medical Society for establishing a county clinic and the beginning of a health education campaign will be received with the utmost interest on all sides as there is nothing in which the county is more or less interested. The people have for a long time felt the need of a clinic or laboratory, but not until right recently did its real necessity become so evident.

There are hundreds of poor people of the county unable to receive proper medical attention. If the clinic were in operation, however, they could be looked after in a way that would do much towards keeping down disease. The great spread of disease is due mainly through neglect of people to look after it in time. They are not to blame, however, as they are poor in many instances and unable to pay the regular fee demanded by the ordinary physician.

This does not mean that our physicians do not look after those in need and unable to pay. They do this to such an extent that very few have made more than an average living out of a profession that should have made everyone of them independent at a comparatively young age.

The clinic, however, opens up a new means of handling the proper class of people. In fact, it is conducted in such way that the patient receiving treatment and the doctor also may retain their self respect without feeling doubtful about it. The great good to be accomplished by the health campaign cannot be doubted in the slightest sense of the word. People have never given this important matter the time they should. If each section should be visited by a prominent physician, however, crowds no doubt would turn out to hear what he had to say in their interest.

It is true public health work has developed amazingly in past years. But it is also very evident that there is still room for branching out. Lectures of an informative nature would do much to help the individual protect himself from dangers of disease of which he knows very little.

The program considered by the society is one of the most ambitious in history of the county. In fact, it is so much so that unless those able to co-operate do so, it cannot possibly be made the great success it should be. It is urged that everyone do what they can to support the society in its effort to better humanity, as we are all to derive benefit, either directly or indirectly.

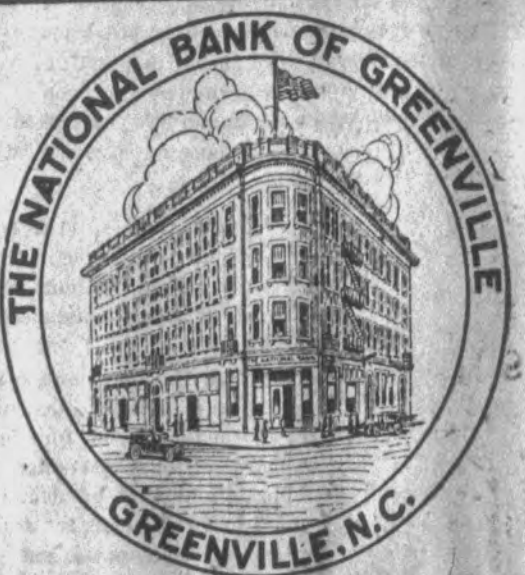
