Beloved Citizen Laid to Rest By Members of Local Pythian Lodge

S. K. PHILLIPS PAYS SPLENDID TRIBUTE TO FINE CHARACTER

Presbyterian Church Adopts Resolutions of Regret as Result of Death

The funeral services for Robert Ernest Pittman, who died at his home early last Saturday morning, were conducted by his pastor, Rev. S. K. Phillips assisted by Rev. Leland Smith, at the Presbyterian church yesterday afternoon and the Knights of Pythias laid him to rest in the family burying ground at Falkland. He was the son of Mr. J. B. Pittman, prominent farmer and citizen of Pitt county, and leaves to mourn his loss, besides his wife and little boy, two brothers, Mr. Henry Pittman of Falkland and Dr. Earl Pittman of Oak City, and two sisters, Mrs. Lonnie Pierce of Farmville and Miss Ethel Pittman. Mr. Pittman moved to Greenville in January 1915, and was one of the city's most beloved citizens.

His pastor in speaking of the lessons of his life, paid a high tribute to his sympathetic service for everyone in trouble, his unconquerable spirit of optimism, and his hope and faith in Jesus Christ. Few men had more friends than Mr. Pittman, because these fine traits of character, and his church in which he was a deacon, his ledge, his city and county, have lost a worthy son and co-workers. The following resolutions were adopted yesterday at a joint meeting of the session and deacons of the Presbyterian church:

Whereas the Sovereign head of the church has seen fit to call from our circle of friendship and service, Robert Ernest Pittman, our beloved brother and fellow-officer;

Be it resolved, that the session and deacons of the Greenville Presbyterian church, do hereby record our submission to that will and our faith in its love and wisdom. Be it further resolved, that we record our sincere appreciation of Brother Pittman and his services as a member and officer of this church, and express to his wife and loved ones, our deepest sympathy in their loss and our prayers that God's grace may sustain them.

Be it further resolved, that a copy of these resolutions be sent to his wife, and a copy placed in the sessional records, and read before the congregation.

W. H. WHICHARD DIES AT HOME NEAR STATON MILL

W. H. Whichard, aged 71, highly respected farmer, passed away at his home near Staton's Mill Sunday morning. Funeral services will be conducted from the home this afternoon at three o'clock, interment following in the family burying ground. Mr. Whichard was one of the best known men of his section and was held in highest esteem by a wide circle of friends. He is survived by four sons and four daughters, all of whom reside in this immediate section. Policeman Jess Whichard of Greenville is one of the sons.

MANY CASES GIVEN HEARING IN POLICE COURT HERE TODAY

Heavy Fines Imposed Upon Number of Defendants for Violations Sunday

Another comparatively-heavy docket faced Mayor D. M. Clark in this morning's session of police court and a majority of the cases required more than ordinary time in disposing of. The most important case were those against William Hawthorne, George L. Mardre and J. C. Perry, charged with trespassing on the Training College campus. They were fined \$10 and one-third cost each.

Mardre was also fined \$50 and cost on a charge of driving an automobile while in an intoxicated condition. A similar fine was imposed on Hawthorne for being drunk and disorderly while on the Training College campus.

Ben Everts charged with being drunk and disorderly, was released upon payment of \$15 and cost of action.

Henry Cox, charged with being drunk and disorderly, was released upon payment of \$20 and cost.

Emma Staton, charged with running disorderly house, was sentenced to thirty days at the county home, but was released upon payment of cost and a capias to be issued October 5th. If she is found in the town of Greenville later she will be required to begin sentence at county home.

John T. Joyner was bound over to the next session of county court under bond of \$100 on a charge of larceny.

Heber Sutton, charged with having liquor for sale, was bound over to county court under bond of \$500.

Zeno Everett was fined \$10 and cost on a charge of drunkenness and disorderly conduct.

SIX HOURS FOR SELLING COTTON ON CITY MARKET

Morning Hours Will be 10 to 12:30 and Afternoon 1:30 to 4:00 O'clock

At a meeting of the Greenville Cotton Board of Trade in the Chamber of Commerce rooms on Saturday night, it was decided to have six morning hours for the purchase of cotton, from 10.00 to 12.30, while the hours for the afternoon would be from 1.30 to 4.00.

In keeping with the arrangements made last fall, cotton will be delivered at the board of trade office at the Norfolk Southern depot, where it will be weighed, graded and sold.

FEDERAL GOVERNMENT TO FIX TAXES ON OIL COMPANIES IN MEXICO

Washington, Oct. 2.—Only the federal government can fix taxes on oil companies in Mexico, according to a decision of Secretary Robels, president of the Obregon cabinet in a report received here. He rebuked the state of Vera Cruz for an attempt to impose taxes recently.

ARMED CRUISER PITTSBURG SENT TO THE NEAR EAST

Philadelphia, Oct. 2.—The armed cruiser Pittsburg, in command of Captain John Eleman, left here today for the Near East. An extra detachment of marines was aboard. At Gibraltar the vessel will pick up Vice Admiral Long who will remain in European waters two years.

NEW YORK WINS OUT IN BOTH OF THE BIG LEAGUES

Yankees and Giants to Begin Championship Battle Next Wednesday

New York, Oct. 1.—With New York's two clubs wearing the diamond crowns for the second year in succession—the first time in baseball history—that one city has held such a monopoly on pennants—the American and National Leagues today closed the 1922 campaigns among the most keenly fought and nerve-racking in the annals of the game.

The Giants and Yankees will renew their world's series rivalry in the opening game Wednesday.

For the Yankees, victory came by the narrowest of margins, a single game, and after a tense brilliantly played battle with the St. Louis club throughout the season.

The American League championship was clinched yesterday when the Yankees, after losing three straight to Cleveland and Boston, rallied to down the Red Sox. New York, however, lost today to Washington, while the Browns, who came down the stretch with a rush after apparently being eliminated in the last series with New York, closed with their third straight victory over Chicago. The results narrowed the percentage differences to but six points. New York showing a record of 94 won and 60 lost, while the Browns won 93 and lost 61.

LIQUOR REVENUES FALL OFF \$5,000,000

Washington, Oct. 2.—Revenues on liquor fell off five million dollars during the months of July and August, the treasury department announced today. The slump is due largely to enforcement restrictions against the drawing of non-beverage liquors.

FOREIGN OUTLOOK HOLDS ATTENTION OF UNITED STATES

Near Eastern News Affects Industrial and Financial Situation in U. S.

SLIGHT RECOVERY SHOWN IN BUSINESS WITHIN PAST WEEK

Falling Off in Railroad Earnings Proves Great Disappointment, However

New York, Oct. 1.—Further evidence of improvement in the financial and industrial situations during the past week found an offset as far as business and financial sentiment is concerned in the foreign outlook.

Reactions in securities markets has furnished a background for somewhat gave views as to the possibility of war between Turkey and Great Britain. Despite the fact that conservative quarters are skeptical as to an actual outbreak of hostilities, the possibility of a clash in the neutral zone along the Dardanelles acted as a curb on buying, in addition it was pointed out by some observers that the German reparations problem still remains and that a new crisis will be presented early in the year, unless some comprehensive plan for dealing with the difficulty shall be agreed to in the meantime.

Industrial activity at home showed, however, a further recovery from the effects of the strike. The steel industry was reported to be operating at a rate close to 70 percent of capacity as compared to 50 percent during the August shutdown. Coal supplies are no longer a limiting factor.

Further settlements have been made between individual railroads and their shippers.

The latest car loading statistics, those for the ended September 16, show another new high record for the year, the total being 945,919 cars.

Some disappointment has been expressed over August railroad earnings. A number of the roads show deficits and others heavy losses in both gross and net income as compared with August a year ago. On the other hand, some roads show improvement.

Wheat prices are continuing to fluctuate with the war news, but covering of shorts in the expiring, September option brought some strength into the market.

A slightly firmer tone has persisted in the money market, although call money has eased off materially after the flurry caused by tax payment operations. The principal feature of the Federal Reserve statement is a continuation of the holdings of acceptances bought in the open markets by the reserve banks. The system's reserve ration remains practically unchanged.

ROAD SENTENCES FIGURE LARGELY IN COUNTY COURT

Several Defendants Also Required to Pay Heavy Fines in Today's Session

Road sentences and fines played an important part in this morning's session of county court, and while a few defendants appealed to a higher court, the majority accepted the penalty fearing to take another chance.

Tom Johnson, charged with a assault with a deadly weapon and carrying a concealed weapon was sentenced to six months on the county roads, but filed notice of appeal to superior court bond being fixed at \$500.

In another charge of assault with deadly weapon he was sentenced to eight months on the roads, but appealed to superior court under \$500 bond.

J. H. Johnson, charged with giving worthless checks, was sentenced to two years on the county roads at hard work.

Alvin Coward, charged with attempted assault and carrying a concealed weapon, was sentenced to 12 months on the roads.

Tom Simmons was fined fifty dollars and cost or six months on the roads on a charge of carrying a concealed weapon.

Joseph Artist was fined \$25 and one-third cost for gambling.

Hardy Jennings was also fined \$25 and a third cost for gambling.

Thomas Johnson, in another case of assault with a deadly weapon, was sentenced to 12 months on the roads. He filed notice of appeal to superior court, bond being fixed at \$500.

Harrison Exum was fined \$25 and one-third cost for gambling.

L. L. Murphy was fined \$100 and cost on an assault charge.

FEDERAL RESERVE BOARD SAYS THERE WILL BE BIG SURPLUS TO EXPORT

Washington, Oct. 2.—The American farmer—the backbone of American prosperity—provides the chief hope, through his bumper crops, that the country can go through the winter with a minimum of handicaps following the twin industrial strikes.

The farmer according to officials of the Federal Reserve Board, is to have a good season. He will get higher prices than last season. He will have enough surplus to supply a greater volume of goods to foreign buyers.

While the strikes have cast billions of dollars in wages and other losses the farms have gone ahead by their increased output in rolling up more agricultural wealth.

The Federal Reserve Board foresees many complex problems this winter, as an outgrowth of the strikes although the general business situation is believed to be inherently sound. Business activity has kept up at a high level relatively, according to report of bank agents. Labor disturbances have, of course kept business somewhat suspended in many of the chief industrial localities, where railroad and coal labor has been idle, but the country as a whole is on a good footing, the reports declared.

Although the farmers have larger output and will reap larger prices it is not improbable that they will find some degree of disappointment in the rising price movements in different commodity groups. But their net gains over last year shouldered more favorable because of their more favorable crops and price reports for the coming season.

KEMAL AGREES TO HOLD ARMISTICE IN NEAR FUTURE

Hope of Ultimate Peace Seen in Action of the Turkish Leader

SUSPICION AROUSED OVER CONCENTRATION OF TURKISH TROOPS

Turks Retire Slightly But Movement in Other Sections Not Liked

London, Oct. 1.—With the virtual acceptance by Mustapha Kemal Pasha of a conference at Mudania Tuesday, or as soon as possible thereafter, the whole Near Eastern situation is considered temporarily easier.

However, the fact that Turkish troops are still concentrating in the Ismid zone, notwithstanding that they have retired slightly in the Chanak zone, would indicate, according to remarks made after British Cabinet's second meeting today, that "Kemal is still playing a game."

While the Cabinet members appear to be much gratified at the happy conclusion for the moment of a difficulty which might have necessitated the use of force in the Chanak zone, there are other bridges to cross. Up to the present there is no information from General Harrington, the British commander at Constantinople, that Kemal will attend the Mudania conference, although General Harrington's dispatches indicate he might.

At the end of several cabinet meetings Saturday, information from the Near East was considered not altogether satisfactory and two additional meetings were held today.

The Mudania meeting will be a purely military affair to arrange, according to the original Allied note to Kemal Pasha, that the neutral zone shall be respected and also to agree upon lines behind which the Greeks are to withdraw in Thrace, both points pending a peace conference. There will be present military representatives of the three Allied powers as well as of Greece and Turkey.

It is pointed out that the very basis of the conference is respect for the neutral zone and before it begins the Turks will be expected to evacuate the Chanak area entirely. On this point there has been quibbling until the British cabinet permitted General Harrington to send a virtual ultimatum to the Turks to clear out. Although the Turks have not yet withdrawn completely, they have evacuated the heights of Eren Keul and have desisted also from parading before the British wire entanglements.

Ayden people are planning a community fair. This news will be greeted with interest by persons in all part of the community as such attractions have a tendency of drawing people together as nothing else can do. Every community should make an effort to hold a fair of some kind. A competitive spirit of a commendable nature is generally produced and every one derives great benefit from it. Competition is the life of everything and that produced by the fair should be sought by all thriving and developing communities.

Clothing manufacturers claim the high cost of motoring is causing men to wear their clothes longer. That may be the way they look at it but it would be difficult to get others to believe it. The truth is prices are so high the average man is forced to make his garments last as long as possible, it matters not whether he is the owner of an automobile or not. If the manufacturers can arrange for a reduction of prices they will be convinced that automobile cost little to do with it.

If Pitt county farmers let the boll weevil get the best of them after receiving advice from so many prominent business men then they deserve the worst the pest can do for them. Any farmer can get along all right under boll weevil conditions if he should make it a point to produce more food crops, raise more chickens and cows and hogs. If the cotton crop is reduced more time can be given to these things. At the end of the year it is likely bank accounts would be larger and prosperity more general than ever before. It is to be hoped advice of our business men will be heeded. They have studied conditions and realize the boll weevil must be fought in a systematic way if he is to be defeated.

Democrats are in favor of light wines and beer. That doesn't mean all Democrats are in favor of such, but merely those in Massachusetts. It matters not where the Democrats are from, they are wrong in favoring something directly contrary to the constitution. The prohibition amendment is as much a part of the national constitution as any other, and should be carried out in every sense of the word. Whiskey and any intoxicating beverages, it matters not how light, has been ruled out and every party should do what it can do to uphold the principles involved. If the whole Democratic and Republican party contended otherwise, we would still stick to what we have said. John Barleycorn is dead, and he should be presented stay dead a long, long time.

People in this part of the county will be gratified to learn of the restoration of the two Norfolk Southern passenger trains operating between Belhaven and Raleigh. Transportation has suffered to no little extent in past weeks, and the traveling public has been up against conditions which they haven't experienced before since the war was in progress. Now that the strike is practically over the railroads should do everything possible to improve their service. The public is paying higher rates for what they get than ever before and it is only right the best of service should be given in return. The railroads, it is true, may be in bad condition financially, but even then, they should be able to make improvements sufficient to take care of public demands at this time. The restoration of regular train service, however, should be accomplished and then let the others follow as it becomes possible.

The British have dispatched an ultimatum to Kemal Pasha demanding him to quit neutral zones immediately. Whether the request will receive more than passing attention will be made known within the next few hours. Kemal has exhibited a spirit of obstinacy the allies shouldn't put up with much longer. They should get busy and make him put up or shut up. It is either conquer the foe now or be eternally troubled by them. Turkey will never reach that state of civilization gained by other parts of the world, and if they should be permitted to gain possession of territory under dispute they will be a menace to civilization as long as it exists. Something must be done. It must either be done now or later, and the alternative is plainly up to Great Britain and Greece, and even America if conditions should become more serious.

Josephus Daniels says the record of the Republican party is a record of failure. That may be so, but he would have a hard time convincing members of the party of it. In fact, the most of them claim to have accomplished wonderful things and are trying to get the public to believe it. If they have really done anything it would be advisable for them to get busy and convince the public of it before next election day. Such declarations as Mr. Daniels is making has a tendency of producing considerable doubt among those not acquainted with conditions, and if anything has really been accomplished they had better present it to the public in a concise way before the people get a chance of expressing their opinion.

## WYOMING GLACIER PERILS EXPLORERS

Four of Party Are Trapped in 2,000 Foot Sink in Ice and Snow

Lander, Wyo., Oct. 2.—How the lives of four members of an exploring party were in peril for many hours in the icy fastness of Wyoming's newly discovered and largest glacier was related here by E. H. Fourn, president of the Lander Commercial Club, under whose auspices a party of scientists, Government officials, photographers and writers made a pack-train trip into the wild Wind River country northwest of Lander.

Nine men were in the party that left the beaten paths, with a twenty-five-horse pack train, at the "J-K" Ranch, on Big Wind River. The party climbed to the summit of the Continental Divide and established a base camp in the mountains above timberline.

"Four members of the party started for the huge glacier one morning," Fourn said, "intending to return the same night. When they failed to reach camp at dark we sent out search parties. We kept a huge fire all night and continuously discharged our rifles.

"It was not until late the following day that we discovered the four missing members in the bottom of a 2,000-foot sink. It took them many hours to scale the walls of this depression. They had been without food for thirty-six hours and suffered extremely from cold during the night spent at the foot of the unexplored glacier.

"The newly found glacier is seven miles long and has an area of twenty-five square miles. It clings to the eastern face of the Continental Divide near Fremont Peak, in the Washakie National Forest.

"Few white men have ever been in the vicinity of the glacier. Many years ago a group of Indians, known as the 'Sheep-eaters,' are said to have lived in the wilderness near the glacier. These Indians were outcasts of various tribes who banded together for self-protection and de-

## BEAUTY AIDS HIDE NATURE, SAYS DEAN

Detroit, Sept.—Artificial aids to beauty, used by the flapper of today, rob her of individuality, but it is not a moral issue, and the world is all wrong in making a fuss over it, in the opinion of Miss Jean Hamilton, of New York, who recently took over her new duties as dean of women at the University of Michigan.

"It seems to me that failing of older people is partly responsible for the fact that the younger generation despises supervision."

# EXPULLED GIRL SUES COLLEGE FOR 50,000

## "No Jurisdiction," Is Judge's Court Cannot Reinstate Her; Decision

Philadelphia, Sept.—Suit for \$50,000 damages is being pressed against Bryan Mawr College trustees and Dr. Carey Thomas, former president, by Marjorie Barker, of Michigan City, Indiana, who was expelled from the college April 2, 1921, after she had been accused of petty thefts in the dormitories.

Miss Barker, who is twenty years old, sought vindication at the hands of the college authorities immediately after her suspension and claims she was given no opportunity to clear herself of the charge brought against her. She then sought action in the Montgomery County Courts at Norristown, Penn., to compel Bryan Mawr authorities to reinstate her, but the Court ruled it had "no jurisdiction" over a privately endowed institution such as Bryan Mawr and was forced to recognize the right of the college to drop a student at any time, without explanation.

In the opinion rendered by Judges Swartz and Miller there was a strong intimation that while the Court could not force reinstatement of Miss Barker she had grounds for a damage suit against the college.

The damage suit has been filed by Sdnator Pepper, of Pennsylvania, Miss Barker's lawyer, who it is reported on good authority in legal circles here, has undertaken the case without charging any fee, because of his desire to see justice done.

Miss Barker is socially prominent in the Middle West, where her family occupies an assured position. She will some day inherit a large fortune thru the connection of her family with the Haskell-Barker Car Company interests.

She was popular at Bryan Mawr where she was in the Sophomore class at the time of her expulsion. In her suit for reinstatement a petition signed by 100 schoolmates from Michigan City, attesting her honorable character, was presented to the Court. When she attempted to seek vindication from the college authorities the girls in her dormitory, from whom she was charged with stealing, vouches for her, but all to no avail.

According to Miss Barker's story, she had packed her trunk for her return home over the Easter holidays in 1921 when she was summoned before the dean, who peremptorily told her she would not need to return to college after the holidays. On inquiring why she was told several small articles from other girls' rooms had been found in her possession, Miss Barker immediately asked a trial to prove her innocence and was informed that such was not the procedure at Bryan Mawr, where the authorities reserve the right to dismiss anyone they see fit, without arousing a public scandal. Dr. M. Carey Thomas, president of the college, said it was customary to simply inform undesirable students not to return when they left college for a holiday and that several such cases had been handled quietly in the manner in previous years.

But Miss Barker desired reinstatement and especially that the stain against her name be removed. According to members of her family it was her plan to return to Bryan Mawr and finish her course there if her attempts at reinstatement had succeeded. As they have not she is virtually barred from any college in the country because of the unwillingness of Bryan Mawr authorities to transfer her credits elsewhere.

In a statement issued shortly after the opening of the suit for reinstatement, Miss Hilda Smith, dean of Bryan Mawr, said that Miss Barker's scholastic work was rather below the standard at the time of her expulsion and that it was doubtful if she could have made a sufficiently good average

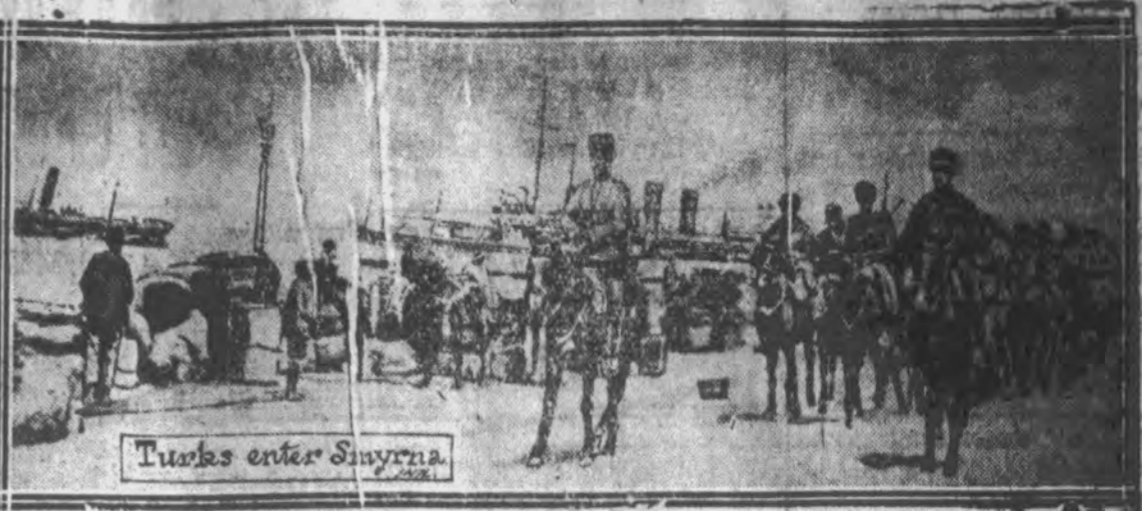

Mr. Clemens, Mich. Sept.—Mt. Clemens is to be safe for resorters—and very dry. The only thing wet for miles around will be the baths. If you go there for a quiet week or two you'll get peace and quiet all right—but nothing else. Even a "hit" friendly game" will be hard to find.

So says Rev. Caleb Rutledge, the "fighting parson," who won the Republican nomination for sheriff on a "bone dry" platform. The Republican nomination is equivalent to election in Macomb county.

"I am going to close every booze joint in Macomb county," Rutledge declared after he was informed he had swept the field. "I intend to start a war on the bootleggers who have been plying their trade over the Lake St. Clair route. I know the people are sick of the present conditions, where gambling is going on freely in the heart of Mt. Clemens, and confidence men are daily fleecing visitors to the city."

Rutledge, who has had a notable record in the Upper Peninsula, where he caused more than a thousand arrests for violations of the prohibition laws, will name a number of women on his deputy staff to aid him in hunting the bootleggers.

**40,000 TONS OF RAIL BOUGHT BY SOUTHERN**

Washington, D. C., Oct. 2.—Forty thousand tons of rail, mostly of one hundred pound section, enough to lay two hundred and fifty miles of track, have been ordered by the Southern Railway System for delivery during the first six months of 1923.

The new steel was purchased from the Tennessee Coal, Iron and Railroad Company and will be rolled at its Ely, Ala. plant. The greater part will be one hundred pound rail.

As this new rail is laid, an equal mileage of eighty-five pound rail now in service on the main lines will be eliminated to use on branch lines which are now equipped with lighter rail.

Hundred pound rail is now being laid between Washington and Manassas, Va., a distance of thirty-three miles, on the Southern's Washington Atlanta double track line and other portions of this line will be so equipped during 1923 with the rail just purchased.
