

CITY ALDERMEN IN CALL SESSION HERE LAST NIGHT

Action Deferred in Request of Standard Oil Company to Open Gasoline Station

SEWER COMMITTEE PRESENTS NEEDS OF SEVERAL DISTRICTS

Clerk Authorized to Give One Per Cent Discount on Taxes Paid Prior to December 1st

The board of aldermen met last night in a call meeting. The Mayor and all aldermen being present except Alderman G. A. Clark.

The first matter taken up was a request from the Standard Oil Co. to install a gasoline filling station at Five Points on the Munford property. Mr. Jones representing the Standard Oil Co. and Mr. Munford being present and Mr. J. B. James their attorney presenting their petition for said permit. After Mr. James, Mr. Jones and Mr. Munford had been heard on the matter or and a short discussion by members of the board, action was deferred until Thursday night, Nov. 2nd at the regular meeting of the board, at which time definite and final action will be taken.

F. J. Forbes, chairman, special sewer committee made his report to the board recommending that sewer extensions be made as designated on map as projects, 1, 2 and 3, and according to estimate of Engineer Rivers would entail an expenditure of about \$12,000. Project 1 beginning in South Greenville and extending to S. E. Greenville from E. Evans street, through the Gilbert and Forbes property to the mill run. Project 2 being in east Greenville opposite the Teachers' College and extending from 2nd street to the river. Project 3 being in W. Greenville between Chestnut and 5th streets, \$15,000 was appropriated by the board for these extensions, also to cover water extensions, new fire alarm boxes, connections and etc.

The board authorized the clerk to give one per cent discount on all taxes paid prior to December 1st, and one half of one per cent on all taxes paid subsequent to December 1st, and prior to Jan. 1st.

Motion was adopted authorizing the mayor to appoint a charter committee for the purpose of revising the Town Charter for presentation at next General Assembly, the following committee being appointed, Messrs. Hearne, chairman; Hall and Sellars. The board unanimously adopted resolutions requesting the school board to meet in conference with the board of aldermen next Thursday night at regular meeting for a discussion of certain matters concerning and of vital importance to both Town and school boards. The clerk being ordered to notify the school board to this effect and requesting its full attendance upon said meeting.

The following matters were also taken up and disposed of, C. E. Rountree elected to fill the unexpired term of D. J. Whitehead on the Firemen's Relief Committee. A sum not exceeding \$50 was appropriated for decorating the streets for fair week. Special transfer license for fair week were fixed at \$5 for the week. Refund of \$5 granted to H. T. Boseman. New plumbing ordinances adopted, in which grease traps are eliminated. Swinging steel cots ordered put in guard house.

GREENVILLE HIGHS BLANK WARSAW IN FINE CONTEST

Locals Wins 16 to 0 in Fastest Game of the Season on the Local Gridiron

The Greenville Tigers greatly increased their lead for championship honors at the fair grounds in this city yesterday afternoon when they completely blanked the strong aggressive team from Warsaw by the score of 16 to 0. This was the first time the two teams had been matched against one another this season. From the very first Greenville showed remarkable strength in defensive and offensive and succeeded in plugging up a lead the visitors found impossible to overcome.

The Tigers made two touchdowns and one field goal in the third and fourth quarters. With a few more second's play in the second quarter Greenville would have added an additional goal, but as they were on the yard goal line ready for the last dash the whistle called things to a finish. By end runs in this quarter the Warsaw club carried the ball within one yard of the goal, but in their effort through line plunges they were shoved back from six to eight yards, during which scrimmage the ball was lost. Greenville recovered the ball, made several line plunges, carried it to the center of the field where they lost it through a fumble.

Warsaw attempted to make a forward pass at this juncture, but Hardy, Greenville's left half back, intercepted the ball and made a rigid end run for a distance of forty yards before he was downed. It was at this point that the ball was carried within one yard of the goal line and the whistle blew for the second quarter.

Wesley Harvey, playing left end for Greenville, played an exceptionally good game and pulled off tackles of a spectacular nature. Hardy, left half back and Brown, full back, played their usual good game and did much towards the victory. Mike Mayo, quarter back, possibly the lightest high school football player in the state, made gains through the lines at every attempt. Greenville's scores were made in this manner: Brown, one touchdown, one field goal; Berry Jenkins, one touchdown.

Those featuring for Warsaw were Gresham at quarter back and Draughan at full back.

Greenville met with greater opposition in line plunges than any other game this season, and many times were forced to rely upon forward passes. With only two or three exceptions they completed their passes for good gains. Warsaw players were considerably heavier than Greenville, and it is a matter of general satisfaction that the Tigers were able to hold them at critical moments. Coach Duncan was gratified at the splendid showing of the entire club and this morning praised ever man for his great work.

SEVERAL ACTIONS GIVEN HEARING IN CITY COURT TODAY

David Cogwell Bound Over to the Superior Court Under Bond of \$500

Annie Braddy, colored, charged with selling whiskey. From the evidence it appeared that Annie is one of the worst characters in town for dispensing liquor headache. She has been arrested many times but seems always to be able to slip through or pay her way out. The mayor bound her over to county court under \$500 bond which she promptly furnished in cash, although from evidence produced it was shown she didn't work for any one. Evidently the thirty have made her to prosper.

Gus Vines, colored, charged with being drunk and down. Sentenced 30 days on county roads.

Gus Vines, colored, charged with carrying concealed weapon, to-wit: a pistol. Bound over to county court. David Cogdell, colored, charged with breaking and entering a box car, on N. S. and taking and carrying therefrom flour. This is the same party with whom Chief Jones had such a punctuated dispute under a box car when capturing him. The mayor bound him over to superior court under \$500 bond.

Rev. C. H. Bascom Accepts Call to Decatur, Ga.



At a vestry meeting in St. Paul's Episcopal Church last night, Rev. C. H. Bascom tendered his resignation as rector of the church, having accepted a call to the Holy Trinity Church, Decatur, Ga., the resignation to become effective November 22.

The news will be received with regret by the many friends of Mr. Bascom in Greenville and other parts of the country. Mr. Bascom, with his wife and little daughter, Sarah, came to Greenville four years ago.

He is the oldest minister in Greenville from the standpoint of service. During his four years here he has not only been a preacher but a pastor as well, making no distinction between denominations.

He has always been ready to be of service to humanity and his service to the city with more unselfish devotion to the great cause which he represents and to say that he will be missed by those to whom he has ministered would be expressing the matter mildly.

Bishop Mikkell, of Atlanta, Ga., in a letter to Mr. Bascom, set forth the needs of the church in Decatur in an interesting manner. Decatur is a suburb of Atlanta, but is really a part of the city. The rector of the church has a part in all the church life of the city. The church became a parish two years ago and has a great opportunity for growth. In the last year or two the Sunday School has more than doubled and the only disadvantage the church has is that the building is too small to accommodate the large congregations which attend. There is a movement on foot to put on an extensive building program and with Mr. Bascom as rector, with his vision for a great future, the church will be enabled to go forward rapidly.

During Mr. Bascom's ministry here the church has more than doubled in membership and the members have been inspired to nobler and higher things. Prior to coming here he was minister at Berlin, N. H. Greenville people wish him every success in his new field of endeavor.

FIVE MILES FINE SIDE WALKS BEING LAID IN AYDEN

Ayden, N. C., Oct. 28.—The street paving program which has recently been completed in this city now gives Ayden 67,000 square yards of asphalt which is about four miles; 36,000 lineal feet curb and gutter which is approximately seven miles or 6,000 square yards. The concrete curb and gutter included making a total of 3,000 square yards of paving, which is said to be the most paving per capita which any town in the state can boast. These figures are not exact but very close, according to Engineer R. E. Reed who is at present compiling a statement of the exact number of feet of asphalt and concrete curb and gutter.

Laying of the concrete sidewalks is now progressing very rapidly. There will be approximately five miles of these when completed. The work on sidewalks in the business section has been delayed on account of waiting on the telephone company, to move line poles which are in the way of the construction force.

Nothing has been done however, to the railroad crossings and these are getting in bad shape. We have been informed that boards will be laid between the tracks which would be a considerable help in crossing, but concrete between the tracks would be much more desirable and would make much better crossings. Something should be done to relieve these bad crossings immediately.

BILLION DEFICIT CHARGED AGAINST THE GOVERNMENT

Officers of the Budget Say Administration is Planning Some Way to Raise Funds

(By International News).

Washington, Oct. 28.—A government deficit of nearly billion dollars confronts the administration, it was disclosed by estimates furnished this afternoon by members of the budget.

President Harding and his advisers are said to be considering recommending new tax proposals to congress. No agreement on the new tax legislation has been reached, but it is understood the administration is weighing the question of deriving more money from the sale of luxuries.

There is no thought of increasing income taxes, it stated, and it is up to the administration provide some legislation to make up to the deficit.

MARITAL LAW PROCLAIMED IN ALL PARTS OF ITALY

Rome, Oct. 28.—The proclamation of marital law in all parts of Italy was issued today to become effective at noon. The drastic step was taken because of the war threat between the Fascist army reported to be approaching the city and regulars guarding the town.

RED CROSS POST WAR PROGRAM TO ASSIST VETERANS

Organization Sets Aside \$3,030,682.90 for Support of Physically Shattered Soldiers

Washington, Oct. 28.—In the post war program of the American Red Cross, four years after the end of the greatest clash of arms in all history, first call upon the services and the funds of the organization is still for minimal ration to the ex-service man physically shattered in that conflict. According to its policy relating to the disabled veterans and their dependents, the National organization has asked for the fiscal year ending June 30th, 1923, a total of \$3,030,682.90 in its budget, an increase of \$360,000 the amount spent for soldier service last year. This total will be increased by nearly 3,000 chapters engaging in service to veterans by more than \$5,000,000 so that approximately \$8,000,000 of Red Cross funds will be devoted this year to services the government is not authorized to render and for which it has neither the funds nor the facilities.

Care of the ex-service men and their families is regarded as a primary Red Cross responsibility, and that it should be neither indiscriminate nor rigidly requires patient study of an intricate problem and continual readjustments to situations as they exist and develop.

"The functions of the Red Cross," says Judge John Barton Payne, National chairman, in his annual report, "is not to usurp the government's responsibilities but to supplement official activity; harmoniously cooperate with official plans and methods; seek out the individual in the standardized mass and his peculiar needs."

The Red Cross acquires and distributes information among the men and their families acquainting the U. S. Veterans' Bureau with the personal equation in individual cases; prepares and furnishes comforts, recreation, and the many necessary services which the government, by its very nature, can procure only from voluntary assistance. These obligations and privileges fall primarily to the Red Cross chapters, who volunteer members are kept acquainted with the official situation through liaison Red Cross officers attached to the district offices of the Veterans' Bureau. There has been a drawing of the chapters into more direct and immediate communication with the Veterans' Bureau.

"Simplification of methods, however, has not decreased the government's need of Red Cross assistance, as is made evident by the continual call for increased funds and personnel. To the extent of its financial and personnel resources the Red Cross must continue to discharge this mandate from the people."

Outside of the active Red Cross chapter membership few persons appreciate the magnitude of the problem of the disabled ex-service man. And on Armistice Day, Nov. 11, when the American Red Cross inaugurates its annual round-the-world Roll Call for the enrollment of the 1923 membership, there will be under treatment in government hospitals more than 25,000 veterans. In the opinion of the Surgeon general of the army the peak of disabled men under reconstitution will not be reached until 1926.

Some of the noteworthy accomplishments in soldier service during the fiscal year ended last June 30 were recorded in the annuals of 2,679 Red Cross chapters in all parts of the country, 350 more chapters than were engaged in this special field the year previous. The chapter is the unit of the Red Cross organization and through its volunteer is accessible to every disabled veteran and to members of his family at all times. Between July 1, 1921, and June 30, 1922, the chapters reported 1,665,079 individual instances of service to ex-service men and their dependents, at a cost estimated from reports now at hand of more than \$5,340,000.

GREAT PROGRAM COMPLETED FOR FINE ATTRACTION

Mayor Issues Proclamation Making Thursday General Holiday for Town

Great preparations are being made for the Ayden Community Fair which is to be held in the Ayden Warehouse on West Main street next Thursday, November 2nd.

The entertainment committee is making elaborate plans for the great event, a complete program of which appears in this issue. Preparations for furnishing the crowds expected with oats and refreshments are being made by the religious and benevolent societies of the town. These will be permitted to have booths free of charge.

The mayor has issued a proclamation making Thursday a holiday and urging that all the stores and other places of business be closed from 10 a. m. to 2 p. m. so that everybody can visit the Fair. It is expected that there will be at least 1,000 school children present as the schools within a radius of several miles have been invited and the superintendent of schools and county officials are expected to be present to witness the big parade and take in the fair.

Floats of secret societies and many merchants will be in the parade it is stated. Exhibits from all the schools are solicited, and these should be handed to Miss Beulah Barrick, chairman of this department, not later than Monday afternoon.

The clinic for examining babies in the "Batter Baby Clinic" will be held from 11 to 3 o'clock. The entertainment committee will have charge of the program in the afternoon at which time gymnastic races and outdoor sports will be engaged in.

There will be no admission fees charged for either the exhibits or to enter the fair grounds, and everybody is invited and urged to be present in Ayden next Thursday morning at 10 o'clock when the first community fair will be officially opened in that city.

Conditions in the United States haven't returned to normal and aren't likely to do so until the high cost of living and profiteering are eliminated. It begins to look as if normalcy is further away than the general run of people anticipated, but it isn't too far to reach if everyone gets down to business and do their best in this direction. As long as profiteers are permitted to continue their practices normalcy will still remain in the balance and cost of living will stay sky high. But when this has been done away with we ought to see a favorable change.

The Eastern Carolina Chamber of Commerce eventually will become one of the greatest organizations in the state. It has outlined an American program and when this has been completed the section will see improvements we have needed for years and years. An organization of this kind is necessary to every thriving state, and eastern North Carolina people should consider themselves very fortunate in having it in their midst. An ambitious program was outlined at the meeting in Kinston Thursday night of this week and we may expect to see results in the near future.

Today committees of the Salvation Army will make their final rounds of the city and county and it is hoped those who have failed to contribute will do so as liberally as they would have others do if they were seeking aid from the army. The Salvation Army workers have rendered humanity a greater service than any other set of workers in the world and it is the duty of the public to give freely so their great work may continue without interruption. Ask the American doughboys what kind of treatment they received at hands of the Salvationists during world war. Their answer has been reiterated time and again since the great conflict come to an end the world should be pretty well informed. Are we appreciative of this great service? Then, let us give until it hurts so activities of the organization may continue.

Pitt county farmers should get busy and see what they can do for the success of the Pitt county fair this year, as agricultural products are always the biggest part of the attraction. The first two years of the fair saw things represented only in a small way and it would be shameful indeed were such progressive and successful growers as those in Pitt county to let the fair pass without showing the world what they are capable of doing. Promoters of the fair will be only too glad to have exhibits of the farm and every grower it matters not where he may reside can rest assured he will receive a hearty welcome. Agriculture is the principal industry of this section of the country, and naturally it should command first place at the fair. This is exactly what fair managers would have and if the growers will only cooperate as they should this great ambition will be fully realized.

Unguarded crossings are daily resulting in the loss of life and property in various parts of the country. While Greenville has suffered only slightly in this way the last several weeks the time is not far away, however, when we will again wish proper protection had been provided. We don't know who should be responsible for such conditions, but who ever they are they should more seriously consider the lives of the public and erect overhead or underground passages. Such a provision would eliminate the prospect of great loss of life and thousands of people might pass the railroad without fear of having their lives snuffed out without a minute's warning. No one can tell when accidents will occur, but we can protect ourselves against them. This matter has been discussed very frequently through the columns of this paper, but nothing has been done yet.

Time for action has come, however, and we hope it will not be deferred much longer.

Voters should not forget to register for the general election to be held November 7th. This is an important matter as those who fail to do so will not have the right to cast their vote in behalf of their favored candidate. Much interest is centered around this election because the future of the Democratic and Republican parties is largely at stake, Democrats claim they are gaining ground in many of the states that went Republican two years ago and Republicans contend they are holding their own. That the first mentioned party has gained the confidence of the public cannot be questioned. That Republicans haven't lived up to expectations also cannot be questioned. In this instance it is very natural to expect the vote to swing around in favor of those who have something to their credit.

All Greenville will regret to learn of the resignation of Rev. C. H. Bascom, pastor of St. Paul's Episcopal church of this city. He is the oldest minister in the city at this time, from the standpoint of service, and the years spent here have resulted in wonderful development of the church which he has served so faithfully. It is not often a minister is liked by members of other congregations as well as those of his own church. Mr. Bascom's service has not been confined to his own congregation, but he has given liberally where ever needed and for this reason his loss will be received with keen regret.

Dr. J. W. Martin, of Davidson college, in an address before a conference of Presbyterian churches, said Christian education is as essential to success of the business man as any other kind of education. The truth of this assertions in indubitable. The Christian man or woman always manage to get along better than the general run of people. Their faith in their county and themselves carries them on to victory when others fall by the wayside, overcome by the ways of the world. All great men attribute their success largely to their effort to live Christian lives. They find pleasure in doing good for others and as they continue doing so they are well rewarded. The man or woman that follows the straight narrow road need fear the problems that face them in the business world. They have the faith and that is all necessary.

Tobacco growers who use a little commonsense next year and plant enough food crops to provide for their own families will find themselves in better condition than they are today. The reason so many are pleading hard times today is because they confined all their time in production of tobacco and failed to plant anything for home consumption. The secret of success lies in diversification. Growers in other sections have discovered the fact. And if they can make it apply to their cases certainly North Carolina growers can also. It matters not how the prices range on tobacco and cotton in the future the man with food crops will find himself on the road to success. Experience is a good teacher and the

farmer that fails to profit by experiences of the past two seasons will never be able to learn enough to assure prosperity.

THE GOOD WORK CONTINUES.

Contracts have been let for additional hard surfaced roads in North Carolina. This information will be received with keen pleasure in all parts of the state as there is nothing in which the general run of people are more directly interested than improved roads. The state program is an ambitious one in every sense of the word. It connects every county seat and will enable the automobile driver to verse one section to another without leaving the hard roads.

There is nothing that helps a state or section go forward more than these kind of roads and North Carolinians have a bright future before them. When it becomes so we can go from one extreme part of the state to another transportation will be twice as good as it is today. It will have a tendency of reducing freight and passenger rates as everyone knows the railroads will endeavor to compete with automobile trucks which certainly will be placed in service when the entire road section is completed.

The federal government did the right thing when it proposed to aid states and counties in their road work. It opened up a way whereby each section might build its roads without having to spend its own money for it. In other words it went fifty-fifty with states and counties and white

only a few states took advantage of the proposition an enormous sum of money is involved.

North Carolina is in the front rank in hard road construction and will soon be in first rank of everything else.

GREENVILLE COPS BECOME TERRORS TO BAD ELEMENT

Actions of Chief Jones and Department Result in Reducing Crime

From past and recent occurrences it appears that Greenville has the best pack of human blood hounds there is in this section of the country, being able to detect robber by sight, smell or instinct.

Last spring when there was such an epidemic of robberies throughout the towns of Eastern Carolina, Greenville was singularly unmolested and the crooks seemed to be wise in laying off, for their one V. M. blunder that got them caught and took up their play house was when they made their first attempt in Greenville. Along about that time it will be remembered that Winterville was raided time and again, Ayden, Bethel, Grifton and other towns in the county also made unwilling tribute on repeated occasions to the robbers—a back door midnight. Although those towns were kept in fever heat making every effort to apprehend the robbers, nothing was accomplished, and the thieves continued to reap a harvest in clothing of all sorts until emboldened by their success they undertook to pull a big one in Greenville. Which attempt succeeded wonderfully in landing them behind the bars and breaking up their nice little game. Although in restoring much of the stolen property to the merchants who had lost same.

Thursday night at 8:30 another gentleman of color by the name of David Coggell undertook a little game of robbing a box car on his own hook. It seems that the said David was busily engaged in relieving a car of flour consigned to Howard Hodges, of its contents, when the watchful eye of Snodde Smith the N. S. Baggage master detecting that something irregular was happening to the perfectly lawful car, called into conference Chief Jones and his squad. The chief took up position on the right flank some 30 feet distant, placing Officer Wooten on the left flank and ordered Officer Sam Whitehurst to make a frontal attack on the center. The quarry being flushed, first attempted a movement around the right flank, but being blocked in this direction decided to change to a line plunge under the car, here he was tackled by Chief Jones and although slugging the chief on the cheek and dragging him some 15 feet under the car he failed to reach the goal, and was penalized to a position behind bars in the city lock-up to await the decision of a referee.

Thursday morning at 4 o'clock when the N. S. west bound train, rolled in, a strange looking, keen eyed negro in a slightly intoxicated condition called off and brought himself under the observant eye of night officer, Joe Nobles. Joe could not diagnose the trouble at the time being, but his instinct told him there was something wrong with Mr. "Nigger." So cornering him in the waiting room he proceeded to propound some very pertinent and personal questions, the answers to which the suspicious looking transient slightly mixed up, getting his feet tangled, tripping himself, so to speak. His eye being keen and quick but his mind, possibly due to drink not being so nimble. Any way Joe investigated his premises on suspicion, finding thereon a money bag and a cash register bag, both of

which contained many nickles, dimes and pennies amounting to some \$6 or \$7. Also finding on his person gold watch, several watch chains, a new razor, several pocket knives, gloves and etc. Needless to say he was tendered free lodging in the city jail for the remainder of the night and yesterday when inquiry was made of the towns down the line to ascertain if any robberies had been committed therein, it was developed that the stores of K. G. Johnson and Tucker Bros., of Simpson had been entered and at that time blood hounds had been secured from Washington in an effort to trail down the robber. Upon this information Chief Jones took said night hawk for a joy ride down to Simpson where he was positively identified as having been seen in the early part of the night. ATTORNEY THINKS HALL-MILLS CASE IS NOT MYSTERY

Mott Declares Statement That is Only Development of Day in Mysterious Killing

New Brunswick Oct. 28.—"The Hall-Mills case is complex but it is not a mystery." This was the statement today of special deputy attorney general Mott, who has taken over for the state, the investigation of the double murder of the Rev. Edward Wheeler Hall and Mrs. Eleanor Mills, choir singer, on the Phillips farm six weeks ago.

With an assertion by Mr. Mott that he had found a witness to corroborate at least a part of the story told by Mrs. Jane Gibson, farmer, who claims to have witnessed the double shooting and identified two members of the death party, this cryptic statement constituted the chief developments of the day.

In connection with this mention of a corroborative witness a flurry of excitement was caused by the appearance in the waiting room witness—a girl of 21 and considerable good looks—who in company with state troopers spent an hour near the scene of the murder. Whence this girl came and whether she departed remained a mystery.

Mr. Mott received newspaper men this afternoon and answered a series of question concerning developments in the case, but declined to add much to that already known.
