NEW WITNESS IS FOUND IN JERSEY MURDER MYSTERY

Case Given Additional Interest by Finding of Eye-witness to Tragedy

Somerville, N. J., Nov. 20.—As a startling climax to the first session of the grand jury which today delved into the mass of evidence surrounding the murders of Rev. Edward Wheeler Hall and Mrs. Eleanor R. Mills, his choir leader, detectives announced tonight they had discovered a new witness whose testimony might overshadow in importance that of Mrs. Jane Gibson, the "pig woman." Strangely enough this new witness, whose name is George Sipel, is known to his former neighbors in Middle-bush as "the pig man." The particular episode of the tragedy which officials say he witnessed will put him in the position of corroborating the testimony of the "pig woman," according to the detectives. That Sipel would be a star witness before the grand jury has been known to officials in the case for days, they declared tonight. That his name comes up at this time, they say, is the result of a letter attributed to Sipel's wife and appearing in a New Brunswick paper while the grand jury still was in its first session. The letter constituted an attack on Mrs. Gibson for bringing Sipel's name into the case and stated that the "pig woman" sought to enmesh him as a witness to substantiate her eye-witness story of the murders.

ARMS AND THE MAN TO BE PRESENTED IN THIS CITY DEC. 4TH

Clifford Devereaux and Company to Also Give Other Play While Here

On Dec. 4, at High School auditorium the Clifford Devereaux Company, headed by Mr. Devereaux himself, will present Bernard Shaw's "Arms and the Man." Many of the Shavian characteristics are present and Mr. Devereaux plays the whimsical humorous Serbian officer, who is really a Swiss, about whose fortunes the story centers.

There is a new-rich Bulgarian officer with a charming daughter, who is engaged to a Bulgarian officer but who wonders if he is the hero she would have him be. In a charge the enemy (the Servians) are routed and put to flight and one of their officers, the Switzer, takes refuge in the rooms of the aforesaid young lady. First at the point of the pistol and later through genuine sympathy she helps him to escape.

When the war is over the Swiss-Serbian officer turns up unexpectedly to return the coat loaned him for a disguise upon the occasion of his escape. An impudent maid, ambitious above her station, betrays to the Bulgarian officer the fact that his fiancée has entertained the Switzer and by a clever trick wins the bourgeoisie soul of the Bulgarian for herself. The daughter of the house and the Swiss officer find themselves and all ends delightfully.

There are excellent opportunities for the clever actor all through the play. Numerous deliciously amusing complications arise.

It is frequently said that in a time of stress it is indeed well to spend an occasional hour in pure, wholesome mental refreshment. Clifford Devereaux, the charming and cultured Miss Graf and this company of artist players provide just such an evening in Shaw's delightful comedy.

NEGRO MURDERS WILSON OFFICER AND GETS AWAY

Town and County Commissioners Offer Reward of \$900 for Apprehension

Wilson, Nov. 20.—While attempting to quell a disturbance among negroes in East Wilson, Jack Syke, Wilson policeman, was shot to death by a negro, Oscar Melvin, at 5:30 o'clock this morning. Will Anderson, a negro eye witness to the shooting is being held by the police as an important witness. Anderson states that he will be able to identify the slayer of Policeman Sykes.

Before the officer had time to draw his pistol, Anderson told the police, his assailant fired five times. Three balls struck the policeman in the breast, one in the head and one through the left arm.

A reward of \$900 has been offered jointly by the Wilson town and county commissioners for the apprehension of Melvin.

The first trace of him was obtained when he traded off his hat for a cap a short way out of Wilson. He then went to his brother's house and changed his clothing. He was traced from there to the swamp, in the vicinity of the Wilson Country Club, which was soon surrounded by several hundred armed men.

He was seen in the undergrowth and fired upon several times, but was apparently uninjured.

Late in the afternoon bloodhounds arrived on the scene from Raeford and tracked him a distance of four miles to the station at Black Creek. There the scent was lost. It is supposed that he made his get-away no a freight. How he managed to elude the nearly five hundred men who surrounded the swamp is not known. The people here are extremely wrought up over the affair and feeling is running higher than it has since Louis West and his gang shot up the town.

WORLD'S CONGRESS BEGINS SECOND DAY SESSION IN CHICAGO

Nine Foreign Countries Were Represented at First Session This Morning

(By International News.) Chicago, Nov. 21.—The Southern Commercial congress assumed an international aspect in the second day's session. Nine foreign countries were represented by speakers of considerable prominence who will be heard the next few days.

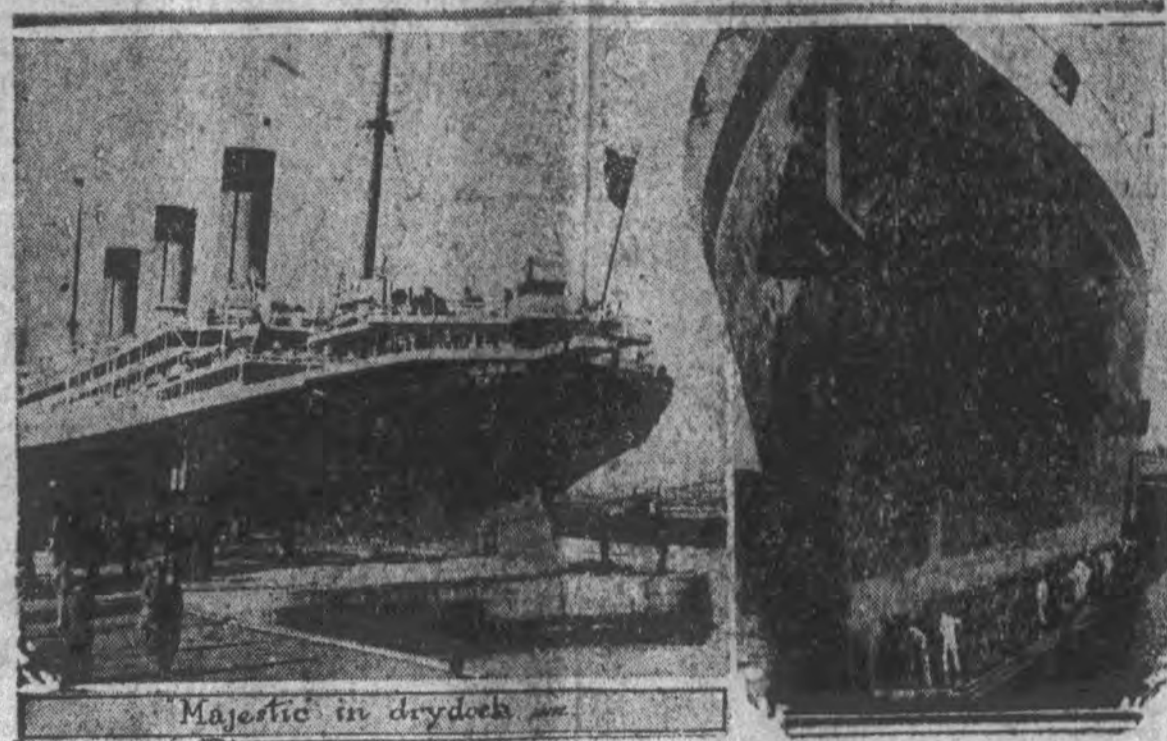
Italy, Peru, Ecuador, Czechoslovakia, Bolivia, Bulgaria, Finland and Greece presented delegates and their problems. Opportunities in trade between foreign countries and the United States will be one of the principal issues to be considered.

One of the chief speakers of the conference will be German ambassador Weidfeldt, who will discuss reciprocal relations between Germany and the United States. Italians criticized the three percent immigration law.

GOVERNOR PARKER TO FIGHT KLUCKERS IN STATE OF LOUISIANA

Washington, Nov. 21.—Governor John M. Parker, of Louisiana, proclaimed war to a finish on the Ku Klux Klan of his state today. He denied that he had been seeking aid from the federal government. Parker said he would return to Baton Rouge tonight to don his fighting armor. He said he would use all resources—financial and legal—within his power as governor to rout the klan from its strongly entrenched position of dominance in Louisiana political affairs.

Largest Liner is Docked in United States



The White Star liner Majestic, formerly the German liner Bismarck, greatest ship in the world, had to go to the United States Navy drydock in Boston, Mass., to be hauled out for clearing and the installation of new eighteen-ton propellers, which, it is believed, will make her the fastest ship afloat. She was docked in the record time of forty minutes, and almost before the pumps had gotten the water out of the dock hundreds of men were scraping her befoiled sides.

ANOTHER LARGE CROWD ATTENDS TENT MEETING

Mrs. McAdams Delivers Forceful Sermon on "Devil's Pitchfork"

The service last night at the tent went far beyond expectations of the evangelists. A splendid crowd was present and listened attentively to Mrs. McAdams as she spoke on the subject of the "Devil's Pitchfork."

She took her text from Genesis 3:4 "Ye shall not surely die." She pictured to her hearers a fork with four prongs. The first was unbelief, second hypocrisy, third anger, fourth delay.

Mrs. McAdams is still telling the church members to get right and then the outside world will come. The discourse was directed to the church. She said the devil was still talking and reasoning with the church members as he did Eve and he is surely getting Eves and Adams all over town on the same old pitchfork.

No doubt every church member under the tent got located while the fork was being explained. Mrs. McAdams says she will preach at least two more weeks to the church members and then start on the outside world. Her subject tonight will be "Let your light shine. Everyone is urged to come out and hear this message."

KLAN DECLINES TO DISCUSS CHARGES

Atlanta, Nov. 21.—The Ku Klux Klan doesn't care to discuss Governor Parker's charges, aside from a sweeping denial that the klan was not engaged in politics or had participated in acts of violence. Chief of Staff Savage said at the imperial palace here today.

LOOK INTO LENOIR'S APPLE POSSIBILITIES

Kinston, Nov. 20.—The Chamber of Commerce here will probably send an "apple commission" to Delaware to view the famous orchards of that State, it was said by officers of the body today. The organization, together with the Qiwanis club and others interested in the local "diversification campaign," believes apples can be made a profitable "side line crop" in this territory.

Production of apples in Eastern Carolina will require some scientific knowledge, it has been learned. Soil, climate and climatic conditions here may be even superior to those in Delaware, but the winds must be taken into consideration. The winds are an important factor. In Delaware, bordered by the sea, the prevailing winds are from the mainland. Here the condition may be the opposite. Government meteorological advice will be sought. Apples will not grow "with wet feet."

TWO COPPER STILL CAPTURED BY LOCAL OFFICERS MONDAY

Four Barrels of Beer Captured by Officers Four Miles From Pictolus

The illicit whiskey traffic again suffered severely at hands of the law when county officials yesterday afternoon captured two splendid copper stills and four barrels of beer four miles from Pictolus. The stills were not in operation at time of the capture and no operators were apprehended.

One still was of a 120 gallon capacity and the other 100. They were superior to the usual kind used in the manufacture of rum in this section of the county and showed signs of constant operation. It is believed both outfits were used in the distillation of corn whiskey of an ordinary brand. The stills were brought back to Greenville and placed in the confiscated cell at the county jail where they will be objects of much attention the next several weeks. After the usual time they will go the way of all stills—to the junk pile.

While other business has occupied attention of county officers the last several weeks they have been able to keep their eyes on members of the traffic and it may be other captures will occur at an early date.

FEDERAL RESERVE PLANS EXTENSION OF FARM CREDITS

Washington, Nov. 20.—Liberal facilities for the extension of credit to the agricultural industry was seen today by federal reserve officials in recent rulings of the board regarding the eligibility for re-discounting of the paper of co-operative marketing associations.

The most recent ruling excludes growers' drafts drawn and accepted by co-operative associations from the provision of the federal reserve act which limits the amount of paper by one maker, a federal reserve bank may rediscount for any member bank to ten per cent of the capital and surplus of the member banks.

Removal of the ten per cent limitation from co-operative marketing associations was regarded by officials as of extreme importance in furnishing credit facilities to these organizations. The board has also ruled that the carrying of a crop is an agricultural operation and the farmers note for the carrying of his product is eligible for re-discount.

CUSTOM HATCHERY PROMOTERS BUY LARGE INCUBATOR

Wishbone Mammoth Incubator Purchased at Meeting Here Monday Afternoon

(Auspices Pitt County Chamber of Commerce.) At a meeting of the stockholders of the proposed custom hatchery Monday afternoon in the chamber of commerce rooms, order for a Wishbone Mammoth, 2,400 egg capacity, was placed with the American Incubator Manufacturing Company of New Brunswick, N. J.

Mr. D. J. Cassidy, factory representative, met with the stockholders and explained the Wishbone. Mr. D. D. Overton, in speaking of incubators, said: "there are just two makes when it comes to real service and the Wishbone is one of them."

While there are several places in Eastern Carolina that are considering purchasing incubators, it remained for Greenville and Pitt county to be the first section to actually place order for a mammoth machine.

Dublin, Nov. 21.—Annie McSweeney who went on a hunger strike five days ago in front of the Mount Joy prison here, where her sister Mary is hunger striking, collapsed. Friends made a bed for her and covered her with rugs.

CONDITION OF LOCKE CRAIG REPORTED WORSE TODAY

Asheville, Nov. 21.—Hope for recovery of former governor Locke Craig whose health has been steadily declining since his retirement in 1917 has been abandoned. He grew worse last night. Two sons, naval lieutenants, have been summoned to the bedside of their father.

AUTOMOBILE THIEF CAPTURED MONDAY IN CAPITAL CITY

Roy Brown, Thief of Sheriff Dudley's Car, to be Returned to Greenville

Roy Brown, colored boy who disappeared with Sheriff Dudley's car last week is being held by authorities in Washington City. Sheriff Dudley received a telegram to this effect last night and left this morning to bring the car and negro back to Greenville. Two other darkeys, by the name of George Harris and Albert Savage were arrested with Brown, according to the telegram, but they are not wanted in connection with the theft and will very likely be released when Sheriff Dudley reaches Washington.

Brown will be faced by two charges following his return to Greenville. The first involves the theft of an automobile tire from the basement of the court house and the second stealing Sheriff Dudley's car. His sentence for stealing the electric fans from the Christian church last year expired last Saturday. He suffered from the rheumatism and was allowed to work around the court house instead of being confined to jail. He evidently tired of the life of a janitor and decided to take the car and go to other parts of the country. Instead of being a trusted prisoner this time, however, he will likely be placed behind the bars despite rheumatism and all other afflictions assailing him.

It was contended that his appointment was an affront to white people who will have to deal with him. It was said he couldn't be confirmed.

NEAR EASTERN CONFAB BEGINS AT LAUSANNE

Hope That Meeting Will Result in Peace to World Expressed by Members

Lausanne, Nov. 20.—Hope that peace on earth would result from the labors of the Near Eastern conference was voiced by the speakers at the brief opening session today.

This sentiment was voiced first by President Haab, of the Swiss Confederation, who presided over the opening plenary meeting and it was dwelt upon by Lord Curzon and Ismet Pasha in their response on behalf hour. The business of the assembled in the Lausanne Casino, where the impressive inaugural ceremony was held.

Today's sitting required only a half hour. The business for the conference will be actively begun tomorrow.

Richard Washburn Child, American Ambassador to Italy, and Joseph C. Grew, Minister to Switzerland, the two principal American representatives, received a warm welcome from the delegations from other lands.

The prospects of American activity in the conference gave world-wide significance to the confab.

Benito Mussolini, the new strong man of Italy, with his air of alert determination, drew all eyes as he moved to his place not far from Venizelos, whose activities and popularity practically forced the abdication of a Greek King and who is here to apply all his diplomatic skill to save what he can for his country in the peace with Turkey which the conference is to formulate.

The price of farm products are firm these days, although they seem to have an upward trend. Just so they don't reach the inflation period during the war. We have seen enough of that and hope to be delivered from anything further of the kind.

That demonstration given Woodrow Wilson Armistice day seems to bid good things for the Democratic party. It indicates the public has seen enough of Republican administration to swing the Democrats into power when the next presidential election rolls around.

Mrs. Felton of Georgia had the pleasure of taking her seat in congress yesterday morning, although she remained there only a short time. She desired that honor for the good of the women, it was said. If she remained no the job awhile she might not think it was for the good of anything or anybody.

Farmville is doing everything possible to keep pace with Greenville. They want a curb market and promise all kinds of co-operation if the county chamber of commerce will assist them in making the market possible. We trust Greenville won't be very slow in getting the market established as it is something we have been badly in need of for many a day. Farmville is taking a progressive step in asking for assistance of the chamber and we trust they will get it.

We regret exceedingly that the public failed to support the football team of the high school this season. The boys have established a remarkably fine record and would have probably done even better if everyone had rallied behind them in better style. Attendance has been so poor that the club is in sore financial straits at this time and will have to rely upon support of other sports to get them out of the hole. Basketball season will open pretty soon and we trust each game will be largely attended. This will inspire the players to greater things and at the same time help them to get out of the hole made during football season.

The danger of running automobiles at a high rate of speed in the city has been plainly demonstrated of late and it is to be hoped everyone will regard the safety of others and remain within the law. Recently several children have been run down and painfully injured and it is short of a miracle why they were not killed or more seriously hurt. This was done by cars running at a slow rate. Think what would happen if they had been running fast. No one is justified in running fast on city streets. It is direct violation of city laws and jeopardize the safety of our citizenship. The thing should be stopped and unless it is city authorities should apprehend everyone possible and see that they pay fines in proportion to the extent of their crime.

Bishop Cannon who spoke in Raleigh Sunday declared that France betrayed the Armenian people through a secret treaty with the Turks. It was this treaty that brought about the massacre of so many Christians not long ago. It is a pity this could not have been averted and more so because of the loss of faith in France. Fortunately Great Britain had no entangling alliances and was able to defend the helpless as best she could. The Turks have done enough against humanity and we can conceive of no enlightened nations entering into a secret agreement with them. France will be condemned for her course and this will cause the other part of the world to stand aloof until she has been vindicated.

If the commercial hatchery goes through as it should and Pitt county people are inspired to buy cows through offers of the various city banks this section should be well supplied with fresh eggs and milk in the next year or so. Milk and eggs are absolutely essential to every healthy community. There is nothing better for the growing child and any home that buys a cow and plenty of hens will be doing the wise thing. The banks are to be commended for providing a fund to lend people desiring to purchase cows and no doubt will be well rewarded. The hatchery is backed by a number of substantial business men and will certainly be a great success if properly patronized.

Teachers in the city schools should warn their children of the danger of crossing streets in congested parts of the city. By so doing they may be instrumental in preventing numbers of accidents resulting in serious injury to the children. Little children have featured in many accidents of late. If they had been warned of the danger of crossing streets there is a chance that the accidents would not have occurred. The matter should be kept in mind all the time. As teachers should point out the danger every day if necessary until conditions improve. Parents might also do the same with good results.

Not content with making automobiles, running railroads and doing other things of the kind Henry Ford has purchased a coal mine in the state of West Virginia hoping to relieve the severe coal shortage confronting the industries. With a few more industries the Detroit manufacturer should be able to monopolize along many lines and get by with it too.

MANY THOUSANDS DIE FROM CANCER IN UNITED STATES

Washington, D. C., Nov.—The Department of Commerce announces that the returns compiled by the Bureau of the Census shows that over seventy-six thousand deaths were due to cancer in the death registration area of the United States in 1921, and assuming that the rest of the United States had as many deaths from this cause in proportion to the population, the total number of the deaths from cancers in the entire United States for 1921 was 93,000, while for 1920 the number is estimated as 89,000 or 4,000 less than for 1921.

The trend of the cancer death rate is upward, the rate for 1921 being higher than that for any earlier year in 23 of the 34 states for which rates

are shown in the following table. The cancer death rate in the registration area in 1921 was 86 per 100,000 population, against 83.4 for 1920. In comparing the death rate from cancer in one state with that in another, the Bureau uses "adjusted" rates in order to make allowance for differences in the age and the sex distribution of the population, because generally speaking, only persons in middle life and old age have cancer, so that a state with many old persons may be expected to have more deaths from cancer than a state with comparatively few old persons.

The highest "adjusted" cancer rate for 1921 is 99.6 per 100,000 population for the state of Massachusetts, and the lowest is 47.6 for the state of South Carolina.

For a few states adjusted rates have

been calculated separately for the white and colored population. In this group of states the highest adjusted cancer rate for the white population is 95.9 per 100,000 population for New York and the highest rate for colored population is 90.6 also for New York. The lowest adjusted cancer rate for the white population is 51.5 for Tennessee and the lowest for the colored population is 36.4 for Florida. Summarized briefly, the adjusted rates show that the Northern states have comparatively high and the Southern states comparatively low cancer mortality, while there is little difference between the adjusted cancer rates of the white and colored races of the same states. In other words the white and colored races seem equally susceptible to cancer, but both races seem less susceptible in the South than in the North.

WESTERN UNION OFFICERS

COMPLETE FINE SESSION

A three days' conference of the officials of the Southern Division and fifty of the managers of the Western Union Telegraph Company's offices in Virginia, North Carolina and South Carolina held at the Murphy hotel, Richmond, Va., was concluded last Wednesday.

Mr. E. M. Canada, District Manager of the company in Eastern N. Carolina attended the conference and addressed the meeting regarding the telegraph needs in this section.

Among matters taken up at the conference were the betterment of the service in Virginia, North and South Carolina and the Southern Territory, and the improved cable service to Europe and South America. Under the new plans of the company, telegrams are now transmitted in fifteen minutes between the principal points throughout the United States, and in fifteen minutes to London and Liverpool, and in twenty minutes to Rio de Janeiro, Santos, Montevideo and Buenos Aires in South America.

Cable letter and week-end letter services have been resumed to Great Britain and Ireland. Both forms of service are designed for plain language and social communications which do not require instantaneous transmission but still are of sufficient urgency that they should not be subjected to the delay incident to carriage by trans-ocean mail. Each form of service, in its own way, supplies a distinct convenience of which the cable using public will no doubt be quick to take advantage.
