GREENVILLE TOBACCO MARKET WILL CLOSE FOR THE CHRISTMAS HOLIDAY SEASON ON FRIDAY, DECEMBER 15TH

Market Will Reopen Tuesday, January 9th, Tobacco Board Decides

FARMERS ADVISED TO MARKET REST OF THEIR TOBACCO SOON

Local Market Has Established an Envyable Reputation This Season

The Greenville Tobacco market will close for the Christmas holiday season following completion of sales Friday, December 15th, it was decided at a meeting of members of the Tobacco Board of Trade this week. The market will re-open for business Tuesday, January 9th.

As most of the tobacco has been practically disposed of it is quite likely the season after Christmas will be very short and farmers are advised to get their tobacco ready for sale as soon as possible.

The Greenville market this season has sold from the broadest territory in history of the market and had there been a normal crop in the county the market would have probably gone over the thirty million pound mark. The market has made new friends, which under normal conditions, will mean that it will be the strongest in the state.

Greenville people feel proud of the splendid record the market has made this season. It has established the highest average of any other market in the state and this fact has meant much to the growers who came from afar. The outlook for continued growth is considered very bright indeed and tobaccoists face the future more confidently than ever.

MELLON PROPOSES GENERAL DECREASE IN U. S. TAX RATES

Secretary of Treasury Makes Many Recommendations in Annual Report to Congress

(By International News) Washington, Dec. 6.—Undaunted by the deficit in government revenues, Secretary of the Treasury Mellon in his annual report to congress, declared that the country should not be subjected to additional taxation. He advocated a lowering of the surtax on large incomes from fifty to twenty-five percent, contending that this would result in capital being drawn from its hiding places and put into productive work, creating new tax sources.

The real danger, the report stated, is seen in a decline of taxable incomes above the three hundred thousand mark. The report condemned the tax exempt security and recommended constitutional amendment to forbid it. It said that eleven billion dollars in tax exempt bonds are now being held by investors, increasing the rate to a billion.

This year the administration is striving to cut the deficit by further reductions and expenditures. Optimism was expressed in the business outlook for the future. Prices of commodities have risen, inventories are low, and the volume of business to higher levels, labor is fully employed, and the year will close with bountiful crops, depression of agriculture has been believed, banking business is sound and money rates reasonable.

GREENVILLE WILL RAISE FUNDS FOR NEW BERN PEOPLE

Committees Appointed at Meeting Held at Chamber of Commerce Today

MAYOR CLARK SAYS EVERYONE IS ASKED TO GIVE LIBERALLY

Committees to Meet at Chamber of Commerce Tomorrow at Ten O'clock

Definite steps for the aid of the suffering people of New Bern were taken at a meeting held in rooms of the chamber of commerce this morning by Mayor D. M. Clark and representatives of a number of civic organizations of the city. While the Red Cross has been receiving clothing for the stricken people for several days this is the first time a movement for financial aid has been launched and the public is urged to contribute as liberally as possible when the committees begin soliciting following a meeting tomorrow morning.

The gathering this morning unanimously endorsed the movement to aid New Bern sufferers and authorized Mayor Clark to appoint a soliciting committee for the purpose of raising a financial contribution from the town at large, the committee not to be representatives of any organization, but all funds to represent the spirit of the people of the entire city.

All clothing contributed will be handled by Miss Louisa Hubbard through the Red Cross and all persons contributing are requested to either send same to the high school or call Mr. Rose to send Boy Scouts after it.

While the meeting was in session (this morning) a call from Mr. Barlow, of the New Bern chamber of commerce stated that the situation there was several times worse than had been stated by the papers. It was stated that New Bern people could not cope with the situation, and that financial assistance, clothing and food were needed immediately.

The mayor appointed the following committees and requested that every one named report at the chamber of commerce Thursday morning at ten o'clock unless prevented by sickness or unexpected difficulties: Miss Maude Lee, chairman and general director, assisted by Secretary H. The committee will be sub-divided and organized at the time of the meeting tomorrow, and everything will be in readiness for a complete canvass of the city.

HARDING COMPLETES MESSAGE TO CONGRESS

(By International News) Washington, Dec. 6.—President Harding today began the final drafting of his message to congress. The message contains more recommendations for relief of the farmers of the country than any presidential paper in recent history. He will probably deliver the message Friday, although the exact hour is undetermined. His engagement to lunch with Clemenceau will prevent the president from going before congress.

Woman Commits Suicide

Johnson City, Tenn., Dec. 6.—Mrs. May McCloud died early this morning in a local hospital following the taking of poison yesterday afternoon with suicidal intent. It is claimed she swallowed nearly two ounces of the poison and remained unconscious for ten hours before her death. She was 18 years of age, the wife of a railroad employee here, reported to be missing.

SOUTHERN COTTON COMMISSION WILL BE MADE OFFICIAL

Permanent Organization Decided Upon by Southern Cotton Congress

EVERETT NAMED AS CHAIRMAN OF THE COMMISSION

Commission Will Consider Problems Confronting Cotton Industry

Memphis, Dec. 5.—Permanent organization of the Southern Cotton Commission, which for two years has operated as an unofficial body, to consider the problems of the cotton growers and to suggest remedies for many of the ills from which the industry has suffered, was unanimously decided upon at the closing session here late today of the Southern Cotton Congress.

Resolution providing for the continuance of the organization, with its membership named by the Governors or legislatures of the cotton producing states, was drafted and approved and will be submitted to the various legislatures at the earliest possible moment.

Taking for granted the adoption of such legislation, the permanent organization was formed with R. O. Everett, of Durham, N. C., as chairman, and Thomas B. King, of Memphis, as secretary.

A legislative program for the cotton producing states, which have the backing of the commission and which looks toward closer co-operation of the states with the United States Department of Agriculture in all matters relating to the eradication or control of crop pests, quarantine laws and also for making the recommendations of the department and of the cotton commission effective in the various states, was drafted and approved.

ROWLAND MILLS TO BE REBUILT IN THE NEAR FUTURE

Head of Concern Announces That Fire Will Mean Larger Plant Than Before

New Bern, N. C., Dec. 5.—The best news in connection with Friday's great fire was given out today when A. R. Turnbull, of the Rowland Lumber Company, lessee of the Roper Lumber Company, which suffered a \$250,000 fire loss, announced that he would rebuild and enlarge the mill providing that satisfactory arrangements could be made.

Mr. Turnbull met with a number of prominent citizens in the mayor's office today. He stated that if the mill property could be purchased from the Roper people he would not only rebuild the plant but also would erect a veneer plant.

A committee was appointed consisting of Mayor Clark and Harry M. Jacobs, who were directed to get into communication with the Roper Lumber Company officials and ascertain what arrangements could be made. Needless to say, the people of New Bern as a whole rejoice to learn of Mr. Turnbull's attitude in the matter. In spite of his own huge personal loss, he has contributed a check for \$1,000 to the local relief work.

SIXTY MILE BLIZZARD STRIKES GREAT LAKES

Chicago, Dec. 6.—The cold spell which has gripped the northwest nearly the entire week shifted to Chicago and the Great Lake regions today. The mercury was falling steadily this morning and a sixty mile blizzard was lashing lake Superior and tying up shipping. The wind caused heavy damages and snow is piled up four feet high. Three vessels are reported to be missing.

NEW BERN BEGINS WORK OF CLEARING AWAY FIRE RUINS

Governor Morrison Will Survey Following Arrival in the City Today

HIGHWAY BUILDERS ASKED TO ASSIST IN BUILDING OF ROADS

Financial Aid Continues to Pour in From all Sections of the State

New Bern, N. C., Dec. 5.—Aided by citizens of all walks of life hundreds of the men made homeless by last Friday's fire, which swept nearly 40 blocks of the city and razed more than a thousand buildings, today began the work of clearing away the debris. Dynamite was used extensively to lower walls and chimneys.

Governor Morrison, who was due to arrive here tonight sent a message to Mayor Clark, in which he stated that he would not arrive until tomorrow and he would be accompanied by State Highway Commissioner Frank Page. The Governor stated that he would then make a survey of the ruins.

Mayor Clark stated he had been requested to give assistance in sanctioning a road building program which would furnish employment to several hundreds of unemployed negroes and aid road construction in this section. Governor Morrison, Senator Simmons and others are to be asked to bring to bear their influence on the Commissioners to grant this plea.

Carter Taylor, Chief of the Southern Division of the Red Cross issued a statement, in which he said the situation was well in hand and that every effort was being made to prevent any possible epidemics. Mr. Taylor said the negro sections had been divided into four districts and the Red Cross nurses would inspect sanitary conditions. He stated that good progress was being made toward relieving the unemployed, and that the Army and Navy Department have responded to the appeals for aid.

Financial aid continues to reach the committee; Goldsboro has raised \$5,000, Kingston, Washington, Greenville, Statesville, Wilmington, Rocky Mount, and other cities are raising large sums to aid the sufferers.

Mayor Clark told the Associated Press tonight that he wished to express his gratitude to the State at large.

HOUSE FARM BLOC DESERTS PROGRAM OUTLINED BY FORD

Bill is Introduced Providing Government Operation of Muscle Shoals Plant

(By International News) Washington, Dec. 6.—The House farm "bloc" has deserted Henry Ford by withdrawing its support of his plan for the lease of Muscle Shoals when the bill introduced by Representative Dickinson, Republican of Iowa, bloc leader providing government operation for fertilizer products and sale of excess water-power.

The bill creates a government corporation consisting of five members, three of whom will be appointed by the president and the others by the secretary of agriculture and the secretary of war.

Representative Dickinson said he objected to giving any individual benefit of a hundred and five million dollars and of obligating the government for fifty million additional and also placing property in a private corporation which would be an added advantage for controlling fertilizer costs.

Confirmation of Pierce Butler has been blocked by Senator LaFollette and others of his kind. We weren't surprised after hearing that the senator was opposed to Butler. President Harding should not let this kind of opposition prevent him from filling moral obligations to the country. If he wants Butler on the Supreme court bench such fellows as LaFollette should not be permitted to stand in the way. As result of this activity the public no doubt will be elated to see Butler come out victorious.

The next legislature will be slow in voting bonds for any purpose. The public has seen so much of bond issues the last few years it is sick of the business. There are other ways of providing public utilities than the eternal way of voting bonds and it is up to the legislature to work out a plan and let cities and towns follow on a smaller scale. The bond craze became so general immediately after the war that the country is burdened at this time. The next and this will increase unless there is some slackening up in the pact. We trust the legislators will be more careful and conservative this next term, and see what can be done to remedy the situation.

The farmer is facing serious hardship in America because of distortion relationship of prices and many are moving to the cities to avoid further worries. While some may succeed in the city, the majority will find themselves in hot water from the time they get there until the day when they had their way back to the farm. It may be rather hard to have to endure such hardship as some are putting up with at present, but it would be much better to stick to the old boat and let her reel and rock as much as she wants to. Every cloud has its silver lining and the farming industry isn't destined to remain under clouds always. The wise grower remain on the farm and looks to that time when conditions adjust themselves and America once again becomes a land of peace and plenty, but most of peace.

SHOOTING TOO GOOD FOR ANDREW

If there is any foundation to the charges brought against Prince Andrew, brother of former King Constantine, it is easily seen that shooting is too good for him. It shows he is an adherent of the Turk as his father was of the Kaiser. It is said he was bribed by Mustapha Kemal's agent to send 40,000 Greek troops across the desert to their destruction. The forces were completely annihilated and following investigation divulged the culprit.

The criminal should be publicly tried and convicted. Court martial is too good for him. He should not be shot to death as ministers charged with other crimes of a similar nature. Shooting such a man to death would not satisfy the people. They should place him where suffering would be intense and even then we doubt if the enormity of the crime would decrease in public eye.

There is too much deception in public life to justify selfish ambition and every time anyone is caught they should be punished until others operating along similar lines quake with fear. The loss of so many men was a severe blow to Greece, but been apprehended and justice will be done.

We never know what time disaster is to strike in our midst and should rally to the sufferers, thankful we have escaped such enormous loss. Clothing, food and money are necessary to continue relief work under way at New Bern, and those who contribute may rest assured of receiving the heartfelt thanks of those in distress.

MOORE STRESSES A VITAL NEED

Roger Moore, of Wilmington, governor of the 37th district of International Rotary, made an impassioned appeal in behalf of boy's work in an address delivered before local Rotarians the first of the week and awakened in his hearers a desire to see the work assume greater scope than ever before. Mr. Moore presented several pertinent facts regarding condition prevailing in North Carolina and declared that the legislature must take some step to care for the hundreds of "unprivileged," dependent children in our midst.

A census recently taken showed from 25 to 35 hundred children unable to get any kind of home at all in this state because of inadequate accommodations of the orphanages and other places of the kind. As result of this over eight thousand cases of delinquent children were handled by juvenile court authorities.

Think of such a condition prevailing in a state as wealthy as North Carolina. It is almost unbelievable, yet when we begin to look around and consider the situation in our own community can we wonder the number is so great. Some thing must be done to improve this situation, and it is up to such organizations as Rotary to bring about desired results. It club members, with undivided support of other organizations, should throw their souls into this great work not many months would pass before these dependents will be provided for.

We can't let the situation continue as it is for the sake of civilization. The thing to do is to get busy and when the next legislature gets in session carry the need before it. The unprivileged deserve the same privilege as all others and it is our duty to see that they get it. Mr. Moore brought a vital subject to us and it is up to us to do our part.

WOMAN'S PARTY UNDAUNTED BY NOVEMBER 7 SLAP

Los Angeles Woman Writes to President Harding to Enlist His Aid.

Washington, Dec. 1—Not one whit discouraged by the failure of women candidates in the recent elections to "come through," leaders of the National Woman's Party are continuing to plan ways and means of eventually gaining for the "gentle sex" a position in the political life of the nation tantamount to that now occupied by "mere man."

Although frankly disappointed at the outcome of the elections, which failed to witness the seating of a single woman in the next Congress, leaders of the party nevertheless are more confident today than ever that their cause will ultimately triumph. "If you believe it's so" is the attitude of the party leaders. Optimism pervades the atmosphere around headquarters.

The prime objective of the party is to gain for women an equal representation with men in all legislative bodies throughout the country.

"The ideal from the Woman's Party point of view," Miss Alice Paul, vice-president of the organization, said recently, "would be a 50-50 representation of men and women in all legislative bodies."

"We were disappointed at the failure of women candidates to gain a single seat in the next Congress in the recent election, but the splendid showing made by them was encouraging and served to materially strengthen our belief that in the not far distant future women will have achieved a 50-50 proportion, thus giving them the decisive influence which they ought to have in national politics."

Russian Children in Dire Need of Clothing-- Many May Die from Exposure, Says Report To Hoover



"Rags—why, America doesn't know what rags are in Russia," was the exclamation recently made by a world-famous Russian singer who was on his way to America. And his comment is more forcefully borne out by a cablegram sent by Col. William N. Haskell, head of the American Relief Administration in Russia, to Herbert Hoover, head of the organization, in which Colonel Haskell forecasted that millions of children and adults saved from famine last winter face death from exposure this winter because of the lack of warm clothing. Particularly urgent is the need of the children, for many of these who have been going to A. R. A. kitchens for food will be unable to go now because of the lack of wraps of any kind. In the homes for children too, the need is almost as urgent, for the general costume of the little ones in these institutions has been found to consist of but one

garment—made of flour sacking, or other coarse material. As fuel is almost impossible to obtain, the plight of these little ones, in a winter as severe as that of Canada is desperate, Colonel Haskell says. In some ways the condition of the adult population is even worse, for the cost of such clothing as there is for sale in the cities is far above their reach. With a pair of shoes costing more than a month's wages and an overcoat of even fair quality equivalent in price to a year's pay, the Russian workman is "out of luck." To help in meeting this crisis, the American Relief Administration has instituted a system of "Clothing Remittances," similar in plan and operation to the famous Hoover Food Remittances, and several hundred banks and other organizations which co-operated in handling money for food packages are being asked to do the same for persons who wish to send clothing remittances.

For \$20—which is the price of a "Clothing Remittance"—any person or group may have delivered to any designated person in Russia a package containing approximately the following clothing material: 4 2-3 yards of 56-inch, 20-ounce dark wool cloth sufficient to make one suit of clothes for either a man or woman or for two children's outer garments; 4 yards of black cotton lining; 16 yards of muslin sufficient for four suits of underclothing; 8 yards of flannel-lette, sufficient for two men's shirts or two women's shirt waists, and buttons and thread sufficient to make up the material. Many Food Remittances were sent for "general relief"—that is, were not designated to any particular beneficiary, and it has been decided that Clothing Remittances may be handled in a similar manner. These will be used in the most urgent cases, some of which are pathetic.

THE GERMAN DYE INDUSTRY

The United States, formerly dependent on German monopoly for its dyestuffs, has taken up domestic production so successfully that by 1920 home manufacturers were nearly double the total imports of 1914. Because of the loss of this American market, and the markets of other countries which have established their own industries as a result of wartime conditions, the National Bank of Commerce in New York believes that Germany's dye industry will not resume its prewar proportions, although it will still be able to maintain its place as one of the leading German manufactures.

"Encouraged by the demand for dye during the war, the American dye industry expanded rapidly," the bank says in the December issue of its magazine, Commerce Monthly. "Not only were products perfected so that they compared favorably with German dyes, and in some instances surpassed them, but the range of colors made in the United States also was increased. A few months after the signing of the armistice in 1918, in order to safeguard the young industry from the competition of German dyes dumped on the market, an embargo was placed on the importation of dyes and dyestuffs, except such as synthetic indigo and alizarin dyes were not obtainable from domestic sources on reasonable terms as to price, quality and delivery. This embargo was superseded by provisions in the Emergency Tariff Act and in the Tariff Act of 1922. The American dye industry enjoyed a remarkable growth, reaching a peak production of 88,204,000 pounds in 1920.

"Production of dyes in the United States during 1920 was nearly double the total imports during the fiscal year 1914. Domestic requirements in many varieties were met and a large export business was built up. At the end of 1920, however, a large stock was carried over into 1921 which in connection with the industrial depression and reduced export trade, cut the output of 1921 to less than half that of the preceding year. Imports into the United States during 1921 were less than 4,000,000 pounds, of which one-third came from Germany.

"The United Kingdom was using 20,000 tons of dyes annually, valued at approximately \$2,000,000, in the

years immediately preceding the war, and of this amount nearly 90 per cent. came from Germany. After the outbreak of the war the dye industry of the United Kingdom began to increase its output, and imports from the United States and neutral countries helped to some extent to meet the demand. During the last years of the war Switzerland was supplying 85 per cent. of England's dye imports.

"Beginning with February, 1920, however, German dyes again began to come on to the market in appreciable quantities and volume increased so rapidly during the year as to endanger the British industry. As a protective measure the British Dyestuffs Act, controlling the importation of dyes, became effective January 1921.

"Italy also had laid the foundation of a dye industry during the war. The existence of the industry there, as in other allied countries, was threatened by the competition of cheaper German dyes and to obviate this danger the Italian Government prohibited the importation of foreign dyes and intermediates after June 3, 1921 except under special license.

"The effect of the establishment of domestic dye industries in these and other countries is reflected in the exports of dyes and dyestuffs from Germany. Exports of aniline and other coal tar dyes fell from 64,288 metric tons in 1913 to 17,847 in 1920 and 23,334 during the year ending April 30, 1922, while exports of dyes and dyestuffs, except such as synthetic indigo and alizarin dyes were not obtainable from domestic sources on reasonable terms as to price, quality and delivery. This embargo was superseded by provisions in the Emergency Tariff Act and in the Tariff Act of 1922. The American dye industry enjoyed a remarkable growth, reaching a peak production of 88,204,000 pounds in 1920.

BANKER FAVORS RECOGNITION OF SOVIET RUSSIA

By CHARLES A. SMITH, International News Service Staff Correspondent.

London, Nov.—"The first act of the new British government in the sphere of foreign policy should be the recognition of the Soviet Government," Sir Edward Mackay Edgar, famous British banker and chairman of Sperling Brothers, gave this as his considered opinion in an interview with International News Service.

"So far as I can see," said Sir Edward, "Russia is the dominating problem confronting the new government. What are we to do with Russia? On the answer to that question hangs the peace of Europe and the security of the British position in India and throughout Asia.

"At present Britain seems to have no policy in regard to Russia. Or if she has one it is very like President Wilson's policy in regard to Mexico. Mr. Wilson would not recognize any government in Mexico because he disapproved of its origin. The consequence was that Mexico wallowed in bloodshed and chaos, when a helping hand would have set her on her feet again.

"Britain is making the same mistake with Russia. She disapproves of the Bolsheviks and therefore will have no truck with them. That is to say, she will sit with their delegates at international conferences and make trade agreements with them, but she will not recognize them.

"All this is bad policy, and British trade is beginning to find it anything but amusing. The Urquhart agreement stands out as an example. The agreement was not ratified simply because the Russian rulers cannot stand the way they are being treated by the British Foreign office.

"In my opinion, the new government could not make a better start than by ending the futile and, to British, trap, costly quarrel with Russia."

MARKETING PLANS TAKING DEFINITE SHAPE IN STATE

Eastern Carolina Chamber of Commerce Reports Splendid Progress

The Executive Committee of the Eastern Carolina Chamber of Commerce, in regular session Friday afternoon, in Greenville among other things awarded Wilson the big Exposition that this organization expects to hold early in 1923. The dates set for the big winter show are: March 19, 20, 21, 22, 23 inclusive. The award was made on a competitive basis, due to the fact that the Eastern Carolina Chamber of Commerce takes in about forty counties and several of the towns in these counties, were desirous of getting this big event for 1923. Wilson's bid was \$5,200.00, a house hold it in and lights and water. Chairman H. H. Taylor of the Executive Committee said immediately after the meeting that plans will be begun immediately towards getting things in readiness for the mammoth exhibition of the agricultural and industrial possibilities of Eastern North Carolina.

Definite plans were decided upon for handling the Eastern Carolina Marketing Exchange, which will be operated under the auspices of the Eastern Carolina Chamber of Commerce. The purpose of this organization will be to aid in finding markets for the farm produce in car lots such as sweet potatoes, trucking of all kinds, Irish potatoes, watermelons and the like. Nothing will be handled except in car lot shipments. A special committee will be named to aid in handling this feature of the work. It is believed by many that this will be a very helpful organization in the matter of aiding in the development of Eastern North Carolina.

Herford County Adopts This Week. Herford county, through the bustling town of Kinston, cast her lot with the Eastern Carolina Chamber of Commerce, making the 21st county to come in. This represents about half of the territory and it is believed that fully thirty five counties will become active members by the end of the first year which will be April 10, 1923.

IRISH FREE STATE HAS NOW BECOME BRITISH DOMINION

King George Sanctions Legislation Creating the Irish Free State

HEALY APPOINTED GOVERNOR GENERAL OF THE PROVINCE

Ireland Begins New Government With Great Ceremony and Unusual Display Pomp

London became the law of the land this afternoon, when, following the ancient ceremony of responding to a summons from "The Black Rod," the speaker of the House of Commons headed a procession of the members of the lower House to the upper chamber of Parliament to hear the King's assent to the two Irish bills—the constitution and the consequential provisions bill—read by a royal commission.

Immediately after the ceremony announcement was made of the appointment of Timothy Healy, a native born Irishman, famous as a parliamentarian and as the first Governor-General of the Irish free state.

The entire ceremony took only a few minutes. The constitution bill had passed both houses of Parliament unanimously and unamended. The consequential provision bill had been subjected to minor amendments in the upper chamber, but these were agreed to by the lower House.

As the procession was returning to the House of Commons from the House of Lords, some strangers in the lobby of Parliament House began singing "The Red Flag." They were promptly ejected by the police.

King George will make a special journey from Sandringham tomorrow to hold a privy council in Buckingham Palace at which he will sign a proclamation declaring the acceptance of the Irish constitution by the British and Irish Parliaments. The constitution will come into operation immediately on issue of the proclamation.

WHY THE PEOPLE CUT GOBBLERS

Greed of Retailers Responsible for Glutted Poultry Markets Now

The greed of Norfolk Va. retailers who sought to make a killing out of Thanksgiving turkey played havoc with the Norfolk wholesale market this week. Norfolk housewives refused to buy turkeys at 75 cents to 85 cents a pound and the Norfolk market suffered a glut from which it will not quickly recover.

The foregoing fact is of peculiar interest to hundreds of Northeastern North Carolina farmers who shipped poultry to the Norfolk market for the Thanksgiving trade. Live turkeys sold at 45 cents a pound and dressed turkeys at 50 cents a pound on the Norfolk wholesale market. Some extra fancy birds brought as high as 60 cents. But when the consumer fared forth to buy his bird the Norfolk retailers had tacked 25 cents a pound on profit. The largest grocery store in Norfolk offered turkeys at 75 to 85 cents. And the average housewife just wouldn't pay such a price.

The Norfolk wholesale market is glutted with poultry this morning and a lot of dressed poultry is going to cold storage.

In Elizabeth City the consumer got about his raw a deal as in Norfolk. Those who were not fortunate enough to get their turkeys from the country at 40 to 45 cents a pound paid 75 cents on the local market. In New York City, where consumers made a fight for 50 cent turkey, the dealers got the best of it by keeping the stuff off the market. Still turkey sold at 60 to 70 cents a pound in New York, which is cheaper than they sold in Elizabeth City and Norfolk.

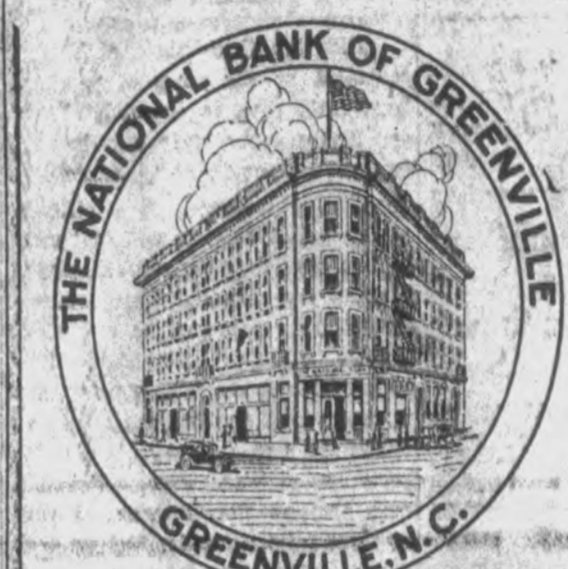

DO YOUR CHRISTMAS MAILING EARLY—O REGRET IT



Every year, at Christmas time, the Post Office system is swamped with the flow of Yuletide presents. Millions of packages are mailed, some so carelessly they never reach their destination, or, if they do, with all their contents ruined. This year the Post Office slogan is "buy early and mail early." Postmaster Edward M. Morgan is shown in New York examining some of the poorly wrapped parcels that never reach destinations.

ELECTIONS INDICATE POLISH STATE UNITY

That the three parts of Poland, separated by 150 years of partition, have really become consolidated into one homogeneous state may be seen from certain results of the recent elections. For instance, the strongest parties polled votes in sufficient numbers to elect deputies and senators in parts of the re-united State formerly cut off from one another. Another example of the unity of the state organization is shown in the fact that in the case of the National Christian Union the two men who headed the party list in Warsaw come from former Austrian Poland, whereas Warsaw was formerly under Russian domination. There were other cases of this kind in which various party-placed representatives at the head of lists in regions other than that which they had been identified.

In other words, there is no evidence of sectionalism. Even when a party

did not obtain representation in all three of the former subdivisions, it did, if it showed any real strength, obtain representation from two sections. For instance, the Socialists and Populists obtained representation from all three parts of Poland, and the National Labor Party from former Russian and former Prussian Poland.

While those familiar with conditions in Poland have long known that there have been no technical objections towards Communism, the elections themselves most emphatically showed that the Communists have no real strength. Only two Communist deputies were elected, one from Warsaw and one from Dombrowa, which are both in that part of Poland formerly controlled by Russia, and in which social progress was most interfered with by the Russian government.

While there has been criticism of the practice of placing many lists of candidates in the field, it may be said that this practice is not without its good points. It tends to permit all

voters to cast their ballots with the least possible restriction. They are not compelled to choose between one of two parties, neither of which satisfy them, but are able to vote for the list of candidates which is wholly satisfactory. This is particularly useful in a country where political education of the great mass of voters is still necessary, and where it is essential that they be given evidence that their ballot is theirs to do with as they see fit. True, this means that many votes are wasted, but this is more than offset by the sense of responsibility developed in the individual voter. It may be supposed that as the voters become more accustomed to the use of the ballot they will be willing to restrict themselves to a smaller number of lists of candidates, but it is thought that such a restriction should be self-imposed. That it will not be long in coming may be seen from the fact that some of the parties, which fared poorly in the parliamentary elections of November 25, withdrew their candidates in the Senatorial elections of November 12th.
