TEMPORARY ORGANIZATION OF PITT COUNTY BANKERS ASS'N. FORMED AT MEETING OF BANKERS LAST NIGHT

Eight Banks of County Represented at Dinner at Rotary Club Last Night

J. L. LITTLE TO ACT AS CHAIRMAN OF ORGANIZATION

Permanent Organization to be Formed at Meeting Here in January

At an interesting session of county bankers at the Rotary club here last night a temporary organization of the Pitt county Bankers Association was formed with J. L. Little, president of the National Bank of Greenville being elected chairman of the temporary organization and H. L. Smith, secretary of the Pitt County Chamber of Commerce as secretary. The session was featured by timely talks by prominent bankers of the county, a splendid dinner and many other matters vitally affecting the banks of the county.

The bankers were called together through an invitation of the Pitt county chamber of commerce. The dinner was given by the three banks of Greenville. The idea of the meeting was a discuss plans for organizing the bankers association, whose aim it would be to aid and assist in all movements and to exert every effort for the upbuilding and betterment of the county. Eight banks of the county accepted the invitation, others being absent because of unforeseen difficulties. Banks represented were: The Citizens Bank of Farmville, Bank of Farmville, Bank of Grifton, Bank of Stokes, Greenville Banking and Trust Company, National Bank of Greenville and Farmers Bank of Greenville.

The meeting was called to order by H. L. Smith, secretary of the chamber of commerce, with J. L. Little acting as chairman. Following the dinner a short address of welcome was delivered by W. H. Wollard, cashier and vice-president of the Greenville Banking and Trust Company.

P. L. Clodfelter, cashier of the Farmers Bank, of Greenville was called on to express the purpose and object of the session. He spoke briefly regarding the organizing of the banks in order that they might lend their influence to the chamber of commerce and other civic organizations in working for the upbuilding and betterment of the county. He presented four vital points as a basis of organization. They were: First. To promote friendly relations between the banks of Pitt county. Second. To have uniformity in customs and usages of the banks. Third. To reform abuses and adopt and use advantageous methods for the economy of operation and for the upbuilding of business. Fourth. To discuss ways and means for future development of Pitt county from which its business must be derived.

Mr. Clodfelter explained the meaning of the points and asked for a discussion. At this juncture it was decided to form a temporary organization with the above officers being elected. Mr. Smith was elected secretary until the permanent organization is formed.

A committee was appointed by the chairman to work out plans for the permanent organization and to get every banker in the county to be present at a meeting some time during the month of January at which time the permanent organization will be perfected.

The committee is composed of P. L. Clodfelter, G. T. Gardner, W. H. Wollard, F. J. Forbes and W. R. Willis.

Timely talks were made by D. E. Ogleby, of Farmville, F. J. Forbes, of Greenville, W. R. Ellis, of Farmville, G. T. Gardner, Grifton; W. H. Wollard, Greenville; Gilbert Peel, Stokes; J. D. McLawhorn, Ayden and J. H. Waldrop of Greenville.

It was decided that the association would hold four meetings a year, one of which will be a general get-together meeting. Considerable interest was manifested in the plans of the ses-

Every Branch Rendered Distinguished Service in Increasing Membership

Mr. G. W. Prescott, chairman of the Ayden branch called the Red Cross office yesterday and stated that they had their boxes of clothing ready for shipment and that their Red Cross branch was going to solicit all over town and send in a financial contribution to help with the relief.

The Farmville branch sent off two hogsheds of bedding and clothing on Wednesday. Mrs. J. I. Morgan was chairman of the committee in charge, and their Red Cross branch also sent a financial donation. The Magazine Club and the Merry Matrons Club were most active in assisting in the collecting of the clothing.

Mr. A. W. Ange at Winterville phoned in and said that their clothing and bedding for New Bern relief was to be shipped at once. Mrs. B. T. Cox is in charge of the work there.

Rev. J. P. Harris of Bethel stated this morning that large boxes of clothing and bedding had been sent by members of the Red Cross in Bethel. The spirit of helping and co-operation has been splendid everywhere though many of our best workers have been unable to assist on account of the flu.

Two hogsheds of warm and useful bedding and clothing were shipped yesterday by the Greenville people. Every one has answered the appeal in a most generous way, and we are happy that Pitt county has made such a splendid showing.

RED CROSS LISTS NURSES TO HELP IN FLU EPIDEMIC

All Available Colored Nurses Have Been Listed to Help Those in Distress

There have been a number of persons and doctors who have been trying to get nurses to help out in the influenza epidemic. Often a trained nurse is not necessary and in many instances it is impossible to get them. Accordingly the Red Cross has listed all the emergency nurses available among colored women in Greenville. Numbered among them are capable women experienced in nursing influenza during the last epidemic.

Many calls have already come and it means that the list of available emergency nurses is growing shorter, so the Red Cross is asking particularly that only families call where it is absolutely necessary to have a nurse. A number of members of the Red Cross have volunteered to send soup or nourishment to any homes where needed. If any such service as above is needed please call 130, as Miss Rosa Exum, secretary of the Pitt county board of health has kindly consented to receive calls.

If anyone knows of any colored woman who is capable of giving good references please call Miss Maude Lee, who is a member of the Pitt county Red Cross executive committee and who has kindly volunteered to take charge of this department of the work while Miss Hubbard is in New Bern.

It is particularly urged that you should not fail to recommend any practical emergency nurse to Miss Lee as it will enable her to supply more families who are all in bed with the flu and unable to care for themselves during this emergency. The same plan as above will be carried out at Farmville. Report from Mr. G. W. Prescott, chairman of the Red Cross at Ayden and from Rev. J. P. Harris in Bethel state that they have no families at the present time where everyone is sick with flu.

AMERICAN LEGION MEETING DELAYED UNTIL LATER DATE

Session Which Was to Have Been Held Last Night Deferred Until Later Date

The annual meeting of the Pitt county Post of the American Legion which was to have been held in this city last night was postponed until a later date. The postponement was found necessary because of the inability of the majority of members to attend.

METHODIST BISHOP AT POINT OF DEATH

Knoxville Dec. 9.—Bishop Waterhouse, of the Methodist Episcopal church, who was struck by an automobile here Tuesday, was reported to be rapidly sinking at a hospital today. He has been in an unconscious condition since the accident.

DR. ERNEST DUNN VICTIM OF OPEN GAS PIPE FUMES

Prominent New Bern Citizen Found Dead in His Room With His Dog by His Side

New Bern, Dec. 8.—The body of Dr. Ernest W. Dunn, member of a prominent local family, was found this morning in a room of the residence he occupied on Craven street. Death was due to asphyxiation and evidently had taken place several hours before the discovery of the body. The dead body of his Scotch collie dog, also was found in the same room.

Persons passing by the residence late yesterday afternoon noticed the odor of gas and commented upon it. However, they thought that it was merely a poor connection somewhere, and no one paid any particular attention to it.

This morning the odor was so strong that Dr. Watson, who has a room on the second story of the building, notified the gas company and asked that they send a man around to make an investigation.

Mr. Weather, manager of the local gas office, went to the house immediately. The odor was strongest just outside the room occupied by Dr. Dunn. Efforts were made to open the door but it was found to be locked from the inside. Mr. Weathers and Dr. Watson, accompanied by a police officer, then went around to the rear of the residence and Weathers was boosted in through a window which had not been latched. The body of Dr. Dunn was found lying across the bed. The dog was found on the floor, close by.

NEGRO BURNED AT STAKE FOR MURDER OF WHITE TEACHER

Florida Mob of Thousand Men Take Charlie Wright From Sheriff and Burn Him

WRIGHT CONFESSES TO HAVE MURDERED THE YOUNG WOMAN

Criminal Exonerated Another Negro Held on Charge of Complicity

Perry, Fla., Dec. 8.—Charlie Wright, negro, accused of the murder of Miss Ruby Hendry, young school teacher, was taken from the Sheriff and burned to a stake at the scene of the crime early tonight by a mob estimated at several thousand men.

Albert Young, negro, was taken from the Sheriff and his party as they returned to Perry to lodge the two men in jail. Wright had been arrested at Madison, Fla., early in the day and Young was taken at Kinderien, Ga. Capture of the two negroes came after six days of search in which thousands of men from Florida and Georgia counties had participated at one time or another.

Both the negroes were taken to a small stream a few hundred yards outside the town, where last Saturday afternoon the young woman's body was found by a passing train crew. Both negroes were given an audience and Wright is said to have exonerated Young as the second negro who waylaid the young woman. He committed the murder, he is said to have confessed, while another negro robbed her. He did not name the other negro but said it was not Young.

Following Wright's talk the mob proceeded to strap him to a stake. Wood and grass were placed at his feet and set afire. His body was burned to a crisp. Young was turned back to the authorities and tonight is in the county jail.

No other disorder was attempted. The mob which began to stream into Perry throughout the day began to break up.

THREE NEGRO BOYS CHARGED WITH ROBBERY

Young Fellows Arrested This Morning on Charges of Store Breaking Sunday Night

Robert Cherry, Joe Outerbridge and another boy by the name of Melvin, thirteen and fourteen years old, are held in jail here today on a charge of entering the store of Sherman and Cawn Sunday night, an attempt to enter the store of J. R. Abeyonius and connection with chicken thievery throughout the city. They will be given preliminary hearing before juvenile court Monday morning.

Entrance to Sherman and Cawn's store was made through the rear door. A small quantity of goods was carried away, and it is likely this will be recovered.

Last night plans to enter the Abeyonius store were frustrated and today the young robbers were placed in custody by members of the local police department. They submitted when arrested.

It is believed by police that one or two of the boys are wanted in connection with chicken thievery reported in different parts of the city the last several days.

Railway Labor Board. Washington, Dec. 8.—The railway labor board has outlined its usefulness, leaders say. They agree with President Harding on the subject. It will be at least a year before necessary legislation can be passed on account of other urgent measures.

TIGER CONCLUDES VISIT TO CAPITAL OF UNITED STATES

Finds Comfort in the Message of President Warren G. Harding

Washington, Dec. 8.—Georges Clemenceau, closing his visit to Washington this afternoon with a "formal" address, expressed the hope that diplomacy would find the way to bring America back into European affairs through what he interpreted as an "overture" by President Harding in his annual message the Executive had read to congress a few hours earlier.

"I was greatly comforted," said the war time Premier of France, "when I read in the message of your President the following lines. They are not very long, but they are very suggestive.

"The four-power pact, which abolishes every probability of war on the Pacific, has brought a new confidence in maintained peace and I can well believe it might be made a model for like assurances wherever in the world any common interests are concerned."

"So you see," continued the Tiger, "that even those who are supposed to disagree really agree at the very bottom of their feeling and reasoning power. That is what I ask and I hope this is something like an overture, that some light will be coming and I will be very glad if it comes from America, and I hope that diplomacy will have something to say about it, and talks may be engaged in, which I am sure can bring nothing but good for us all."

Senator Heflin has predicted that congress will ratify Henry Ford's offer for Muscle Shoals after March the fourth. Whether he is merely venturing a guess or has inside information cannot be said, but there is one thing certain, and that is, Ford would be the best man for the place. He has incurred the displeasure of many of his worst opponents in attempting to gain control of the Shoals and if he should get it he will have fought a good fight.

Greenville people shouldn't forget to purchase liberally of the tuberculosis Christmas seals to be sold here this year. There is no better way to spend money than for this purpose, and purchasers may rest assured of doing their part by suffering humanity. There are thousands of people in this county suffering from tuberculosis. Their cases are hopeless unless the public does what it can to assist them. The sale of seals is one way the Red Cross is trying to serve the sick people, and the public should buy as liberally as this becomes possible.

Do your Christmas shopping early and avoid the rush always in evidence during the holiday season. People complain of not being able to get what they want Christmas. That's because they don't shop early enough. People who visit the stores several days before Christmas have an advantage over those who delay until the last minute. They get the pick of everything, and when the belated shoppers arrive they find the best things bought up. Remember this fact and shop at your earliest convenience.

The number of workmen thrown out of employment by the great fire at New Bern will be without work for any great length of time if reports coming from New Bern count for anything. With work of rebuilding the structures in the devastated area in progress it looks like several hundred men will be needed. It may be true some are trying to shirk duty while the needy are being cared for, but the city will look after that part and every man capable of earning his living will be put to work and will not be allowed to partake of the people's generosity without doing his part. The situation in New Bern is a serious one indeed. The fire was bad enough but the labor trouble that will naturally ensue will involve many problems that were wholly unexpected. Time, however, will work great wonders, and those endeavoring to become parasites to the community will find themselves shifted to some other community where they won't find living quite so easy.

We are glad to see Mayor Clark dealing out heavy fines to violators of the city traffic regulations. This is the only way in the world speeding will be stopped, and the heavier the fines the more effect it will have upon that class of people guilty of violations. Every court should make it a point to mete out justice in such cases. The violation has become rampant in Greenville and if it is reduced the mayor will be forced to deal severely in every case coming before his court. The general increase in automobiles makes speeding more dangerous than ever and every city should begin to more fully enforce the traffic regulations, regardless of those involved.

HAVE YOU SUBSCRIBED?

Greenville people should not fail to subscribe liberally to the New Bern relief fund now being raised in Greenville. The cause is one of the greatest we have had an opportunity of contributing to in recent years, and no one should fail to give until they feel it.

Suppose, for instance, every person able to do so would give a dollar. Well, it is probable the Greenville contribution would be larger than any other city in the state, except some of the larger where rich men have given a hundred or a thousand dollars a piece. While every one is not able to give quite as liberally, they might at least give something.

This would help swell the fund and help us make an appreciable showing. If you haven't given get busy and do so immediately while you have the chance.

A PUBLIC MENACE.

We are going to continue to hammer away at the unprotected railroad crossings until we see some signs of an improvement.

There is no question about the danger of these crossings and unless something is done the loss of life and property will be incalculable. It may be rather expensive to consider placing flagmen at every crossing in and around Greenville, but we can have them at the most important ones where traffic is the heaviest.

If other cities of similar size can maintain them Greenville can also. It is just a matter that has been neglected until it begins to look like the public will forever be menaced by the danger. As we have reiterated, something must be done and the sooner it is the sooner loss of life will be averted.

BOND ISSUES SEEM NECESSARY

We stated the other day that we were opposed to the issuance of bonds and hoped the legislature would take some step to discourage the practice, especially since conditions are so uncertain in this country. While we meant exactly what we said, we desired to leave the impression that we did not favor indiscriminate issuance of bonds.

There are times when the country would be in bad fix were not funds available through bond issues. This is especially so in our great road building program and other progressive measures that mean so much to the country.

Bond issues, like everything else, can be carried too far. This has been especially evident the last several months when bonds were issued for some things that might have been deferred until conditions adjusted themselves and business became more normal. There have been very few indiscriminate issues in North Carolina. In fact, probably less than any other state in the union and our legislature will not have such a big job before it in discouraging those overstepping proper bounds.

When bonds are needed for something that is almost indispensable there is nothing to do but issue them. That's about the way we are situated when it comes to good roads and other improvements, and no one will question the advisability of raising funds by bonds in such cases.

A SPLENDID ROAD SYSTEM.

Pitt county people have a right to be proud of the magnificent road system now under construction. Two of the roads have already been completed and in a few months another two will be ready for traffic. We have over a million dollars

available for hard surfaced road construction in this county and when this is all expended our system will unquestionably be one of the best in the state. Not many counties took advantage of the government's offer of a half million dollar loan about three years ago, but Pitt county did and that's one reason we are due to have such a splendid system.

The value of good roads is beginning to be realized in all parts of the country at this time. But while others are awakening to the advantage Pitt county is constructing her's and will be deriving benefits from them when the others really begin.

The possibilities opened up to us through the good roads cannot be summed up at this time, but eventually they will become evident. We are mighty glad we voted bonds to match the government offer and trust another opportunity meaning as much to us will not be turned down. This is an era of development and government aid should never be refused.

TWO MEN ASPHYXIATED AT MEMPHIS, TENN.

Memphis, Dec. 8.—Harry Forsythe choir director of this city and an aged negro were found asphyxiated in a bathroom in the Forsyth home here today. A gas heater is blamed for the tragedy. The tragedy was discovered when water leaked through the floor to a lower apartment.

EXECUTIONS BRING BITTER ATTACK ON IRISH GOVERNMENT

Violent Protests Launched in Stormy Debate in the Dail

Dublin, Dec. 8.—The executions of Roderick O'Connor, Liam Mellowes and two other rebels early today as a form of reprisal brought the government into conflict with the Labor members of the Dail Eireann at the afternoon session.

While defeated for the moment in their attempt to bring about a debate on the executions, the Laborites served notice they were not done with the question and warned the government that such acts would tarnish the good name of the Irish Free State before the world.

Tom Johnson, leader of the Laborites, was on his feet at the opening of the session with a demand for a statement from the government. President Cosgrave peremptorily refused, but Mr. Johnson pressed his demand, whereupon the President appealed to the chairman to proceed with the scheduled business, the election of a committee on the appointment of ministers.

The Labor leader retorted that executions such as these were far more important than election of any committee, and that they might end upon there being no need for such election. He moved suspension of the standing orders to allow the matter to be debated, but President Cosgrave objected, a division was taken and the Labor motion was rejected 34 to 14.

Mr. Johnson then gave formal notice that he would raise the question later, declaring it needed urgent attention and the Laborites withdrew their nominations for the committee to appoint ministers so that it would not be representative of all parties, as prescribed by the Constitution. To this move President Cosgrave replied that the election would proceed as scheduled and that if any of the members neglected their duty it was their own affair.
