AMERICA MUST EXTEND NAVAL TREATY OR BUILD ADDITIONAL WAR CRAFTS APPROPRIATION COMMITTEE ASSERTS

Government Cannot Avoid a New Naval Program Unless Limitations Are Extended

REPORT DECLARES LARGER EQUIPMENT IS PLANNED ABROAD

Project for Negotiations Comes As Complete Surprise to President Harding

Washington, Dec. 13.—Blunt notice that the United States cannot avoid a new naval program in swift cruisers and fleet submarines unless treaty limitations are extended to such craft, was served by the House appropriations committee today in reporting the \$293,806,538 naval appropriation bill. A six line provision placed in the bill by the committee requested President Harding to negotiate with Great Britain, France, Japan and Italy for such an extension of the treaty, limitation of aircraft to be included.

The committee report said large cruisers and submarine programs were planned abroad, adding:

"In other words, competition is on again in the single direction to which the unratified agreement (the Washington naval treaty), does not extend and if it be allowed to go unchecked the purse strings again must be relaxed and this government, like all others, will be constrained to launch a new program to the extent necessary to keep up at least abreast of any of the other powers."

President Harding was not consulted by the committee with relation to its limitation conference request. The project for negotiations apparently came as a surprise even to naval officials. It was originated by Chairman Kelly of the naval appropriations sub-committee.

The chief reason prompting Mr. Kelly to propose a new naval conference was understood to have been the light cruiser program recommended by the navy general board. No mention of this is included in the published copies of committee hearings on the bill. The program urged, however, as necessary to keep the United States navy on a parity with other navies in cruisers, included sixteen new light cruisers, within the cost \$168,000,000.

NEAR EAST CONFAB SAVED WHEN TURKS ENTER THE LEAGUE

Development Means Peaceful Continuation of Conference, British Believe

Lausanne, Dec. 14.—The Near East conference was saved from collapse when Ismet Pasha, head of the Turkish delegation, announced the intention of Turkey to join the league of nations.

He also presented a compromised plan from Turkey for safeguarding Christians in the Asia Minor district. This development means peaceful continuation of the conference, it was asserted in British quarters.

SENATE COMMITTEE CONTINUES PROBE OF GASOLINE TRUST

Washington, Dec. 14.—Senatorial investigation of alleged manipulations of the gasoline trust was resumed today by the senate manufacturers committee, with President Teague, of the Standard Oil Company of New Jersey, on the stand. The probe was launched by Senator LaFollette as result of a deal in oil stocks.

REBUILDING IS CONSIDERED IN CRAVEN CAPITAL

Civil Engineer Going Over Property in Preparation for Replacing Houses

New Bern, Dec. 13.—An opportunity that has long been looked for by New Bern has been taken advantage of and before one house is rebuilt in the burned area of the city a civil engineer will go over it and lay it out to conform as near as possible with the plan on which the town was extended fifty years ago.

One of the first steps taken in reconstruction of the burned section and simultaneous almost with the actual relief work was the appointment of a committee to make suggestions on widening streets, closing some of the multitude of short alleys that were to be found in the settlement, and otherwise improve that part of the city.

This committee was selected from among property owners who lost in the fire, members of the board of aldermen, and other representative citizens. In consultation with a local engineer this group made a survey of the ground and set down its recommendations which were promptly presented to the board. The vote of adoption was unanimous, and the board immediately authorized the employ of an engineer. In the meantime no building permits will be issued by Fire Chief Bryan, Mayor Clark announces.

Before the fire growing New Bern found itself in an unfortunate situation. There were only two ways open for expansion: north up a narrow strip along Neuse river, and west on another small strip along the Trent, for extending across the peninsula on which the city is built, and within half a mile of the court house, was the belt which was struck hardest by the fire.

It was a frightful price to pay—the human suffering and property loss—but a large area of the city has been cleared for a new direction of expansion, and the logical one. It is going to mean more valuable property in the place of the tenement homes that littered the highest land in the corporate limits. It may mean that many of the negroes will not go back where they were.

NINE KILLED AND SEVERAL INJURED IN TRAIN WRECK

Passenger Train Collides With Switch Engine on Houston and Texas Railroad

Houston, Texas, Dec. 14.—Nine persons were reported killed and thirty-five injured when a passenger train on the Houston East and West Texas railway side swiped a switch engine at Humble, Texas.

Occupants in the smoking car of the passenger train were literally cooked when a steam pipe ripped off the switch engine and was hurled into the coach.

Bodies of the dead were removed to a morgue at Humble. "An investigation is now under way to fix responsibility for the wreck.

COUNTY SCHOOLS WILL CLOSE FOR HOLIDAYS DEC. 22

Superintendent Fitzgerald Also Says They Will Re-open January First

Public schools of Pitt county will close for the Christmas holidays December 22nd and re-open January 1st, according to an announcement made this morning by Superintendent R. G. Fitzgerald. This date affects county schools alone and does not involve Greenville.

Work has progressed nicely at all schools despite bad weather and illness, Superintendent Fitzgerald reported and the outlook for the future is very bright. Attendance has been practically normal until the last two or three weeks when it fell off about twenty per cent.

Mr. Fitzgerald believes things will start off smoothly after the holidays, and is very optimistic concerning the outlook.

SPLENDID REPORTS FEATURE MEETING OF THE BAPTISTS

Dr. Charles Madrey Shows Convention How Things Have Gone Forward in State

Winston-Salem, Dec. 13.—The feature of today's session of the N. C. State Baptist convention was the report of corresponding Secretary C. E. Madrey, showing the year to have been the greatest in achievement in State missionary work in the history of the denomination in North Carolina. The board employed 202 missionaries during the year at a total cost of \$56,342.53.

In the Department of enrollment and country church work the board employed four all-time workers and four part-time workers. Much time was given to the campaign for stewardship and tithing.

In the student summer campaign five men were assigned to the Enrollment Department. They did work in eleven associations with fifty churches. They conducted twenty-three revivals adding ninety-nine by baptism, five by letter and five by restoration, making a total of 109. They made nine every member canvasses and twenty-six community surveys; organized three B. Y. P. U.'s; conducted twelve B. Y. P. U. training schools and twenty-two Sunday school institutions, distributed 1,633 tracts.

In the report of education submitted by Dr. R. T. Vann, it was set forth that no State in the South is making such a stride in the education of all the people. Eight years ago the state was spending something like 4,000,000 on elementary schools. Last session of 1921-1922, North Carolina spent \$16,000,000 for common schools. In eighteen months the state has spent \$12,000,000 on school houses. Approximately \$42,000,000 has been spent by North Carolina for public education in one year. There are 550 high schools in the state.

RECORD CAR LOADINGS OF BITUMINOUS COAL

Washington, Dec. 13.—More cars were loaded with bituminous coal last Monday than on any day in the last three years, the total being 45,886 cars, according to reports filed today by the railroads with the Car Service Division of the American Railway Association, which said it had no record of daily loadings prior to three years ago.

Monday's record exceeded by 429 cars the best previous total which was reached on November 22, 1920, and exceeded by 588 cars the loadings on October 30 last, when the total was the highest for any day since the beginning of the strike of bituminous miners last April 1st.

CLEMENCEAU ENDS VISIT TO AMERICA AND STARTS HOME

Tiger Declares He Will Return Again, But Only as a Ghost

New York, Dec. 13.—His speaking mission ended, Georges Clemenceau, war-time Premier of France, sailed for home on the steamship Paris today, declaring he would return again, "but only as a ghost."

The aged statesman, who closed his strenuous tour with a short speech before the American Committee for Devastated France last night, appeared in fine health and rare good humor as he took his place on the upper deck to watch New York vanish behind him.

Just before the Paris cast off, the Tiger kissed Mrs. Charles Dana Gibson on both cheeks, laughingly enjoining her not to "dare tell her husband." Mr. and Mrs. Gibson were Clemenceau's hosts during his stay here last month.

Others at the pier to see him off included Jules J. Jusserand, the French Ambassador, and Mrs. Jusserand; Gaston Liebert the French consul here; Col. E. M. House, who arranged the Tiger's American tour, and Bernard M. Baruch.

Clemenceau, who spent last night on the Paris, was up at four o'clock this morning, and after breakfast took a promenade of about three miles around the decks of the steamer.

Clemenceau was cheered by crowds both on the pier and on the ship as the Paris slid out from her pier with her band playing the "Star Spangled Banner." Standing on the deck, he waved his old gray hat in response.

The Tiger's farewell message to America was given in the form of two telegrams—one to Woodrow Wilson and one to Otto Kahn, banker, in answer to farewell messages, which it was said, were typical of thousands received at the last minute.

TRIAL OF MINERS IN HERRIN AFFAIR NOW IN PROGRESS

Introduction of Testimony of Three State Witnesses Feature of Session

Marion, Ill., Dec. 13.—Completion by the prosecution and defense of their statements to the jury and introduction of the testimony of three witnesses for the State marked the opening today of the trial of five men charged with murder in connection with the Herrin mine killings.

Among the spectators, who crowded the Williamson County Court House, were Frank Farrington, President of the Illinois Mine Workers Union, and Oral Garrison, Secretary to John L. Lewis, President of the International Mine Workers, who took down the proceedings in full.

Beside Judge D. T. Hartwell sat the jury of 12 men in blue and khaki shirts 11 of them farmers and one a union miner. Among the farmers are two former miners.

The crowded listened in silence as state Attorney Delos Duty repeated the history of the fatal Herrin riot and outlined the testimony upon which the State hopes to convict the five defendants.

The clearing, the only question before the jury, was one of murder and that there was no issue in the case between capital and labor. Mr. Duty told of the efforts to operate the mine by the Southern Illinois Coal Company workers had been attacked by a mob with non-union men and declared these of between 800 and 1,000 strike sympathizers.

Mr. Duty said the State would prove that during the night preceding the killings an agreement had been made whereby those in the mine were to lay down their arms and leave the mine and also "a man named Hunter, who was presumed to represent Governor Small, made arrangements for the men to put up the white flag and leave under the promise of the safe conduct out of the country."

The killing, he said, of the 20 non-union miners followed.

NEW CASES FILED AGAINST BUILDERS OF CANTONMENTS

It was said that Contractor Gordon, of Atlanta, Georgia, might be one of those involved in the additional suits.

UNITED STATES NOT IN FAVOR OF CALLING ANOTHER CONFERENCE

Washington, Dec. 14.—The government of the United States is not in sympathy with the calling of a world conference for the limitation of armament. Officials are skeptical as to the outcome of a conference of this kind at this time.

MESSAGE OF PEACE WILL BE RESTORED TO FORMER OWNER

Agreement Reached in Hearing at Raleigh Brings Noted Case to an End

COURT ORDERS ALL WHISKEY ON SHIP TO BE POURED OUT

Claude Graham Pleaded Guilty to Possession and Transportation of Liquor

Raleigh, Dec. 13.—As a result of agreement between District Attorney Irvin B. Tucker and counsel for the defense, Claude Graham, super cargo of the booze ship "Message of Peace" yesterday pleaded guilty to the charge of possession and transportation of whiskey a nol pros was taken by the district attorney against Captain Arthur Coleman and Graham in the cases charging them with conspiracy and with perjury, and Judge H. G. Connor ordered the 1,000 cases of whiskey which made up the cargo of the British vessel confiscated and destroyed, and the vessel returned to its owner, Captain Coleman.

The agreement reached upon overtures of the counsel for the defense when the case against Coleman and Graham for conspiracy was half finished, brought the prosecution to an abrupt close. A mistrial was ordered and the nol pros was taken by the District Attorney.

The whiskey, which has been stored in the customs house at Wilmington, under a triple lock, will be destroyed. Effort yesterday on the part of the District Attorney to find some way of disposing of the whiskey to good purpose without violating the North Carolina laws was of no avail and the entire twelve thousand cases, including five thousand of a fine grade of Scotch whiskey, will be poured into Cape Fear River.

Under conviction in the case of conspiracy, there could have been no confiscation of the whiskey, it was pointed out yesterday. The submission of the supercargo to the charge of possession and transportation, however, permitted this.

The case against the officers of the Message of Peace was begun in District Court Tuesday and the selection of a jury and the taking of testimony for the government consumed the entire day. The agreement yesterday brought the cases to a close.

No action will be taken against Captain Walter Peomans, of the coast guard station at Ocracoke, who was accused by a witness in the trial of holding a lantern while Coleman removed liquor from the vessel for sale to two Boston sportsmen. R. A. Kohloss, Federal prohibition director for North Carolina stated yesterday.

LEGION LEADERS FROWN UPON PLANS TO LINK BONUS WITH BEER ACT

Washington, Dec. 14.—American Legion leaders have decided to frown upon all plans to link to bonus with the proposed beer and wine act, it was learned today by International News representatives. This conclusion was reached at a recent conference held in this city.

TWELVE MEN AND WOMEN ARRESTED ON ROBBERY CHARGE

Chicago, Dec. 14.—Twelve men and women were arrested here today in connection with the robbery of \$19,000 from P. Caldwell, bank messenger. Several thousand dollars in cash have been recovered. The police dragnet has also been set for the two bandits who robbed James Harrison, diamond broker, of a \$100,000 worth of unset diamonds and two thousand dollars in cash.

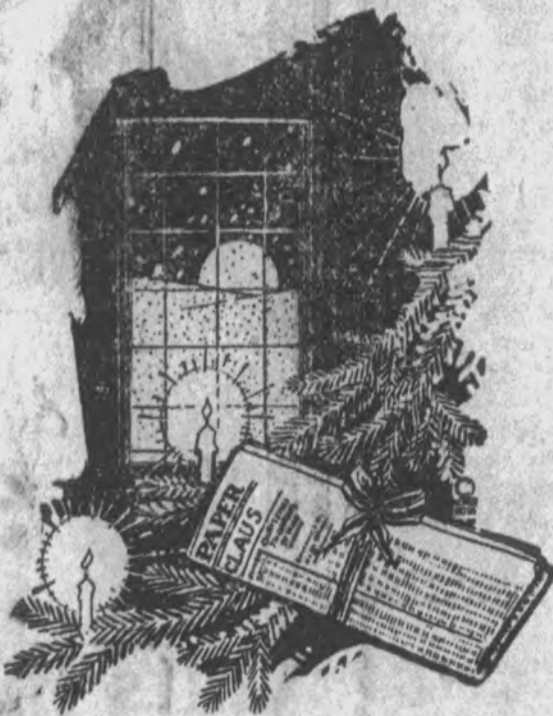

STRING OF PEARLS IS VALUED AT \$150,000

Paris, Dec. 14.—A string of 200 pearls totaling 465 carats, sold in a public auction at the Paris Hotel des Ventes for 1,922,875 francs. That is nearly \$150,000 at the rate of exchange on the date of sale. This sets a new high record for prices of pearls in France. The string is part of the sequestered German property which the French Government is selling and applying to reparations.

STARVATION THREATENS

TZARITZIN RESIDENTS; NO RELIEF IS PLANNED

London, Dec. 14.—Two hundred and fifty thousand people are already approaching starvation in Tzaritzin and the local Soviet authorities have as yet made no plans for their relief. His statement was made here recently by Dorsey Stephens, of Los Angeles Cal., former supervisor of the American Relief Administration in that gubernia, who has just reached London on his way home.

This year's crop in Tzaritzin amounts to between 19,000,000 and 20,000,000 pounds. Mr. Stephens said, of which five million are being collected as a grain tax. Compared with the normal crop of sixty million this makes a poor showing, and consequently the district is classed among the "shortage areas," of which there are several this year in Russia, despite the good general average harvest.

PROTEST INDIAN BILL

New York, Dec. 14.—The board of managers of the Colonial Dames of the state of New York have sent a telegram to Senator Calder protesting against the passage of the bill depriving the Pueblo Indians of their lands and water rights. The passage of such a bill would, in the opinion of the society, be a national dishonor. The society has 900 members of Colonial descent.
