ROTARY CLUB IN INITIAL MEETING OF THE NEW YEAR

Many Features Marked Session at the Beautiful Home Here Last Night

SPIRIT OF OPTIMISM EXPRESSED IN TALKS OF VARIOUS MEMBERS

Stunt Committee Put on One of the Most Interesting Stunts in Months

The first meeting of the new year was held last night by the Greenville Rotary Club, being presided over by President J. E. Winslow.

After supper was over minutes of the last meeting were read and approved. Mr. Albert Muilberger tendered his resignation as a member of the club, this being accepted with expressions of regret.

CHAMBER ADOPTS GREAT PROGRAM FOR YEAR OF 1923

Plans Outlined at Luncheon of Directors Here Yesterday; Meeting Was Great Success

According to information coming to a reporter of this paper, the directors of the Pitt County Chamber of Commerce had a most interesting meeting at the Rotary Club New Year's Day, in the form of a noon-day luncheon.

After taking up various phases of the Chamber's work, the directors adopted the following program of work for 1923, which had been suggested by the membership at large, from time to time:

- 1. Poultry development. 10,000 laying hens by this fall. 350 poultry club members.
2. Permanent pastures. This to be brought about in co-operation with the county agent and other agencies. Every farm should have ample pasture.
3. Family Garden. Every family in county should have ample acreage to garden so plenty of fresh, crisp vegetables can be had every month in the year.

- 4. Brood sows. Two to every farm, properly cared for will mean a net revenue of \$1,250,000 annually to Pitt county.
5. Family milk cow. Have at least one good cow to every farm. This will mean healthy children, fertile soils and a larger bank account.
6. Curb Market. Development the Curb Markets, recently started in Greenville, Farmville and Ayden. This avenue will provide a place for the assembling and sale of all kinds of vegetables, chickens, eggs, etc.

- 7. Sweet Potato Storage House. A movement will be launched to have at least an additional storage house erected this year. Bethel took the initiative in this movement last year.
8. Employment Bureau. The purpose of this Bureau will be to place every person possible wanting work of any kind. The maximum amount of good will be accomplished in proportion to the co-operation given by the public at large.

- 9. Traffic Bureau. Every firm in Pitt county is urged to send all paid freight bills to the Chamber of Commerce for audit, as they not only have a good connection, but 10 per cent of the Bureau's part remains with the Pitt County Chamber of Commerce for their services.
10. Freight Rates. A careful study will be given to this matter by your directors.

- 11. County Fair Plans will be formulated so as to have the very best fair in the entire state.
12. Automobile Tour. The tour taken by the Chamber of Commerce last summer proved to be so interesting and helpful, another tour will be arranged for this year.

- 13. A picnic will be given for the Agricultural club members.
14. An Agricultural school for Pitt county will be discussed and plans laid for its erection.
15. A special program in behalf of Americanism will be staged during the year. Some well-known speakers will be secured to handle this subject.

- 16. A mammoth clean-up week will be observed throughout the county.
17. Information Bureau. The Chamber of Commerce is now arranging to have a complete file of information of all kinds. Any person desiring data on any subject is invited to call at the Chamber's office, where same will be given then or secured at the earliest possible date.

- 18. Community Spirit. Plans will be laid as to make for a real dynamic, all-inclusive unity, which established makes it possible for any and all kinds of constructive work.
19. Fire Prevention Week. A special program will be worked in co-operation with State and National authorities in behalf of so important a measure.

- 20. Circulating Library. Details of this fine project will be gathered and future announcements made.

DECLARES ABOLITION OF CAPITAL PUNISHMENT WILL MEAN THREE MURDERS TO EVERY ONE NOW

Facts Compiled by Old Veteran Show Conditions as They Actually Exist

While in charge of the State prison under the Kitchin administration I made a specialty of gathering all the information concerning prisoners and prison life.

Maine abolished capital punishment in 1887 and today statistics show a larger per centage of murder than any other of the New England states. Rhode Island abolished it twice as many years ago as did Maine. The 12th U. S. census shows that these two states which have discharged capital punishment have 173 per cent more murders than the four New England states that remained under the law.

In the District of Columbia where juries are empowered to return verdicts qualified by the words without "capital punishment" there are over 500 per cent more murders than in Massachusetts.

Murder in Michigan increased from 16 in the 6 years prior to the abolition of hanging to 152 in the same period after 10 years of abolition, 2,500 per cent increase.

Murder in Iowa increased very rapidly from 1872 to 1876 until for this reason the death penalty was restored.

Murder in California and Colorado increased so rapidly that both states re-necanted the Statute. Not content with lynching by the rope or the bullet, a mob at Limon, Col., on Nov. 16, 1900, seized a boy who had murdered a little girl, adjudged him guilty on the spot, and had the father of the girl to prescribe the method of punishment. He decided on burning at the stake.

Murder in France increased 38 per cent in consequence of which the guillotine was restored in 1900. Austria was one of the first to abolish it and had to restore it in less than a decade.

Germany tried it in eight of her provinces, murder increased so that it was restored.

Switzerland abolished it and had to restore it on account of the great increase of murder.

Murder in Italy upon the abolition of capital punishment became a business as brought out in the Camorista trials. In 1910 there were 3807 mur-

der trials. All the U. S. census reports authoritatively demonstrated that the weakening of the death penalty in civilized states is a return to barbarism.

Humanity of capital punishment. Enemies of capital punishment are telling the legislators of many states that it is founded in a principle of vengeance. This objection was answered many years ago by the great jurist Daniel Webster. "The criminal law says Webster in his speeches, vol. page 156, is not founded in a principle of vengeance. It does not punish that it may inflict suffering. The humanity of law feels and regrets every pain it causes and hour of restraint it imposes. And more deeply still every life it forfeits. But it uses evil as a means of promoting greater evil. This is its object. When the guilty are not punished the law has failed of its purpose; the safety of the innocent are endangered. All countries that have abolished it proved that it doubles and trebles crime."

"The land cannot be cleansed of the blood that is shed therein but by the blood of him that shed it." Moses.

Justice Harlan of the U. S. Supreme Court says, "I am of the opinion that capital punishment is proper in all cases of aggravated murder.

Justice Brady of U. S. Supreme Court says, "I am of the opinion that capital punishment as a deterrent of crime is much more effective than imprisonment. In every instance where it has been removed murder have largely increased.

Dr. H. A. Hughes, a strong supporter of capital punishment says, "During the first year of the reign of Queen Victoria there were four attempts on her life. Parliament met and passed an act providing for the speedy execution of any who attempted to take the life of the Queen and from that day to the day of her death 30 years afterward, no one made an attack on her.

SAYS GREENVILLE NOW IN NEED OF MUNICIPAL DOCK

R. A. Zoeller Writes W. L. Hall Regarding Proposal to Open Tar River to Shipping

W. L. Hall, member of the Pitt county chamber of commerce, is in receipt of a letter from R. A. Zoeller, regarding the establishment of a municipal dock at Greenville. The letter contains many interesting points and should receive more than ordinary attention from business men of the city because of the crying need of the proposed dock.

As Mr. Zoeller says a suitable dock here would result in a great reduction of freight rates. With large boats plying Tar river shipment could be received from New York, Baltimore, Philadelphia and Norfolk at greatly reduced rates.

1. Should Greenville have competitive water freight transportation and why?

2. Should Greenville have a Municipal Dock where any boat could load or discharge freight on payment of a tonnage charge and why?

FINAL EFFORT TO END REPARATIONS TROUBLES TODAY

Prime Minister of Three Nations and Italian Delegate to Meet

GREAT BRITAIN AND FRANCE UNABLE TO REACH AGREEMENT

Belgian Minister to Attempt to Act as Mediator and Effect Agreement

Paris, Jan. 1.—The Prime Ministers of France, Great Britain and Belgium, together with the Marquis Della Torretta, representing the Italian Prime Minister, will go into conference tomorrow in what is regarded as the final effort of the Allies to reach a settlement of the reparations questions. There was a sober and even anxious spirit in Allied circles tonight in face of the probability, that if the conference fails separate and direct action by France will follow. The main questions to be decided are: First, whether a moratorium can be granted to Germany, and, second, upon what terms.

France and Great Britain are sharply divided on policy. The French insist upon seizing the productive resources of Germany on the left bank of the Rhine and on the Ruhr valley as guarantees that when the moratorium terminates, Germany will resume her reparations payments. President Millerand, in replying to the New Year good wishes of the diplomatic corps today, made it clear that France stands upon her conception of justice and her rights under the treaty of Versailles.

"Complete peace can be established," he declared, "only on the basis of the treaties and through respect for the rights acquired and the obligations incurred."

The British government disapproves stern methods or penalties and desires to work out a plan under which Germany will be allowed a moratorium of at least two years, this time to be employed in so re-organizing her resources that she may successfully shoulder her debts. Any settlement likely to be successful depends, in Mr. Bonar Law's view, on some form of international loan for Germany and together with his associates on the British delegation, he has received with approval the suggestion of the American Secretary of State that an international committee determine the amount of reparations to be expected.

The conviction held by Premier Poincare of France is that a change in heart on the part of Germany is required above all other considerations. He believes Germany's plans for the future are based upon a policy of resistance to the execution of the Versailles treaty, and any effort to help her regards as useless unless the Brin government decides in earnest to fulfill its obligations.

Washington, Jan. 2.—The comptroller of currency has issued a call for the condition of National banks at the close of business Friday, December 29th.

FIFTEEN INJURED WHEN DIXIE FLYER WRECKS NEAR MACON

Macon, Ga., Jan. 2.—Fifteen persons were injured when the Dixie Flyer, running between Jacksonville, Chicago and Detroit was derailed six miles from Macon. Nine coaches left the rails and turned over. Six rolled down a twelve foot embankment. Mrs. Kitchens of Waycross, Ga., is believed to be in dying condition as result of injuries sustained. Seven other persons were seriously injured and were brought here for treatment. Steel cars believed to have saved many lives.

NEW YEAR GETS BIG RECEPTION AT CHICAGO, ILLINOIS

Not Much Liquor on Broadway, But Other Places Report Plenty of it

Chicago, Jan. 1.—Father Time looked on imperturbably and the new baby of 1923 may have blinked perplexedly at what he saw as the nation welcomed the New Year. The view was one of variety—prohibition aridity in many places, cases in others, but generally, perhaps with a few hilarious exceptions, a somewhat decorous, but happy reception of the new accession.

Some of the outstanding features of the New Year celebration as reported from many cities were:

Broadway, a proverbially torrential canyon, was dried up by prohibition agents and the New York police, who made 190 or more arrests in a funeral atmosphere when the white lights were dimmed by fog.

A squad of prohibition agents and police were chased out of the Hotel Chase, a fashionable St. Louis hotel, by celebrators, one of whom, a woman, clung to a policeman's collar as riot calls summoned police reserves. No arrests were made there, although two men were slightly wounded and a woman injured, although a dozen arrests were made elsewhere in that city.

Prohibition agents at San Francisco were arrested by a policeman and summoned to court for violating a traffic ordinance, although the city's celebration was characterized as one of the sanest in years, but noisy.

Chicago celebrated hilariously in time-honored style, although church service and family and neighborhood parties probably outnumbered the noisy and moist celebration in which hotel and cafe proprietors estimated at least a half million dollars was tossed away. A few raids and arrests were made by police and prohibition agents. It was generally agreed that the dusty New Year predicted by dry agents had been a muddy one.

New Year resolutions are no longer new today. Most of 'em are broken.

Greenville people celebrated the New Year in an appropriate manner and things started off favorably. If we can get them to continue favorably the remainder of the year ought to be everything to be desired.

France has declined to favorably consider the latest proposal received from Germany. Germany is in a bad plight and too much can't be expected of her. France should consider the proposal to close up the controversy.

The town ought to start off the New Year by pinching and severely prosecuting anyone violating the city traffic legislation. The situation cannot be improved so long as fines are imposed in the place of road sentences. Wealthy people can "pay a fine" and don't mind it. But when it comes to road sentences, not many of them would like that. New York has found such action advisable and there is every reason to believe Greenville would also.

With spring on the way the committee having the city playground under consideration should get busy and see if the project can't be established by the first spring month at least. It is understood that a little piece of ground is holding up work. It is to be hoped those causing the delay will come across and do the right thing. The project means more to the children of the city than can be realized at this time. This should be our first consideration. Money, land nor anything else should stand in the way under such conditions, and we trust the thing will soon be put across.

Kinston is planning a bond issue for public school improvement and it begins to look as if the election will be put over. Certainly it won't be defeated when the city's future will be largely determined by the success of the issue. Every city is economizing as much as possible at this time, but when it comes to education economy cannot stand in the way, that is, if it is to reduce school facilities. There is no doubt about the progressive spirit of Kinston people and for that reason it is safe to say the bond issue will go through all right.

The future is very bright for Greenville and Pitt county people and by strict application to business success is assured. The system of hard surfaced roads now under construction should do much towards increasing the volume of business in this city, and our merchants should have confidence in the future, even though business is rather sluggish at this time. It is natural to expect things to be rather dull the first of the year, but eventually they ought to brighten up visibly. The roads will bring people to Greenville from a greater radius than ever before. If they bring the people it is perfectly natural to expect they will bring trade also. The outlook is brighter by far than last year when out road mileage was much less than at present. When our entire system is completed conditions will be far better and where there are two or three thousand shoppers here on Saturday the number should be practically doubled in the future. The good roads mean much of this section and the possibilities opened through them cannot be conceived at this time.

history, having taken the count of ten, we would have you note with interest the ten ways in which we can kill an organization, as well as your self:

- 1. Miss as many meetings as you can.
2. If you do attend, don't come on time.
3. If the weather is not suitable, stay at home.
4. If you attend be sure to find fault with work of the officers and other members.
5. Decline all offices as it is easier to criticize than to do things.
6. Get sore if you are not elected to an office or put on a committee, or if you are don't attend meetings.
7. If chair asks your opinion tell him you have none, but later tell others what should have been done. Do only what you absolutely have to do, and when others get busy to help matters, howl because of the clique running things.
8. Delay paying your dues as long as you can, and delay answering your letters.
9. Don't bother about getting new members—"Let George do it." We will choose for ourselves this very night whether we will take the count of ten with 1922, or whether we will throw aside the unhappy thought, the selfish spirit, and join in happiness and service with victorious 1923 and live the ten-ways in which we can help an organization.
10. Attend all meetings.
11. Be on time always.
12. It's part of your important business, let nothing keep you away.
13. Encourage officers and workers, show your appreciation of the work they do for you.
14. Cheerfully accept an office or place on a committee, it gives you an opportunity to render a service.
15. Set a good example to officers and other members by your faithful performance of duty.
16. Wisely and discreetly join in all deliberations and show yourself interested in other's suggestions.
17. Have the utmost confidence in your fellow workers, freely give, freely receive—help.

4. Would you use your influence to have the city build and equip suitable dock to economically handle water freight to encourage and foster water freight competition This dock to be forever owned and controlled by the city as a municipal dock for transportation purposes.

### Open Letter to the Citizens of Greenville and Pitt County:

Greenville should have a municipal dock, to be forever owned and under the control of a commission for the purpose of encouraging water transportation, and to give a basis for an argument to go to congress with as a request to put in locks and dams to give Greenville eight feet of water the year around.

This can be accomplished within reasonable cost and I believe it would be done if the city of Greenville would establish a municipal dock and patronize a boat line in order to get some tonnage going on the river, and request congress to build the lock and dam. This is being done on other rivers of no more commercial importance than our own Tar river.

The U. S. Army Engineers are not disposed to recommend permanent improvements on rivers where the communities located on the streams will not signify their desire to assist by building municipal docks.

There is a line of boats going into operation on January 1st that gives the best opportunity we have had for river operation to Greenville and with proper encouragement from the citizens of Greenville, it is the intention of the Tar river freight line to undertake this operation giving a 20 per cent reduction in freight rates from New York, Baltimore, Philadelphia and Norfolk.

#### MORE PATRIOTISM NEED OF U. S., SAYS CARAWAY

(By Senator T. H. Caraway, Democrat of Arkansas, a Minority Spokesman in the Senate)

Washington, Dec. 20.—A revival of patriotism and a greater respect for the law loom as the greatest benefit to be derived by the American people during the coming year 1923.

Any improvement in our economic life, through a recreation of our foreign commerce, upon which it will solely depend, must come as a result of our participation in the adjustment of differences among the people of Europe. Our participation in the friendly settlement of their problems—not only reparations but commerce as well—must result in a reawakening of our own national spirit. This, I believe will lead to a greater respect for the law and a tolerance for differences of opinion. It will bring, too, a revival of patriotism.

The outstanding needs of 1923 are legislation for farmers' credits and improved marketing facilities to enable them to get their products to the consumer without the tremendous waste that characterizes this service at present. There must also be a reduction in freight rates, which today are prohibitive in many sections of the country.

Politics will be dormant this year for 1923 is what is known as an "off year." Nevertheless the people will be watching their legislators with even more carefulness than during the year just ended. In the new year, however, politics will be devised on which the election of 1924 must swing. And in the final analysis these will revolve around the American farmer, who surely is coming into his own at last.
