WARDIN ADDRESSES POULTRY RAISERS AT FINE MEETING HERE

Much Interest Manifested in First of Series of Ten Meetings to be Held in County

(Auspices Pitt County Chamber of Commerce.)

Mr. E. G. Wardin, of the State College of Agriculture at Raleigh, opened a campaign for better poultry in Pitt county, with the initial meeting in Greenville on yesterday morning in the Chamber of Commerce rooms.

Mr. Wardin, who is a practical poultryman, spoke interestingly to an attentive group of men and women, by way of summary, we have the following:

- 1. Do not keep a scrub hen. Give attention to the hen that will respond with the maximum.
2. Dual-purpose fowls are recommended for the farmers and among these breeds are the Plymouth Rocks and Rhode Island Reds.
3. For eggs only, use Leghorns, Wyandottes, etc.
4. It is cheaper to produce eggs than meat.
5. Proper care must be given without proper care, including a floored pen, it is impossible to get the desired results.
6. A good food for baby chicks is rolled oats.
7. After the chicks are ten days old, feed a mash of the following: Wheat bran 75 lbs, ground oats 35 pounds, corn meal 30 pounds fish scrap.
8. The very best food for baby chicks is mash according to proportions above stated, with buttermilk. Buttermilk is an excellent food.
9. Any old house will not do for poultry raising. The idea that the reverse of this is true accounts for the lack of progress made in the industry. The house should face the South, with both ends and the back entirely closed. A house 10 x 12 would give 120 square feet and would be sufficient for 30 barred rocks or 40 leghorns.
10. A good food for hens is corn and oats 50-50.
11. A good food for broiler: Nine pounds ground oats, 1 pound ground barley, mixed with buttermilk. Feed three times a day.
12. Supply fresh water three times a day.
13. Lice and mites, as a result of an unclean house.

After an interesting meeting in the Chamber of Commerce rooms, a trip was made to the Fair Grounds for a practical demonstration in culling hens. The demonstration was made individuals from the flock of Barred Plymouth Rocks, numbering 200 and belonging to W. H. Dail, Jr.

BRITAIN DESIRES FAIR SETTLEMENT OF DEBT TO U. S.

Wants to Pay Debt in Manner That Will be of Benefit to Both Nations

Washington, Jan. 8.—Great Britain wants a fair business settlement of her five billion dollar war debt to the United States on such terms as will produce the least possible disturbance in the trade relations of the two countries, Stanley Baldwin, the British Chancellor of the Exchequer, declared today in an address before the joint meeting of the British and American debt funding commissions.

"We are not here to ask for favors or to impose on generosity," said Mr. Baldwin. "We want a fair business settlement, a square deal, a settlement that will secure for America the repayment to the last cent of those credits which the United States government established in America for us, their associates in the war."

Mr. Baldwin's address was in reply to one of welcome by Secretary Mellon, chairman of the American commission, who expressed particular appreciation of the courtesy of the British government in having designated as its delegates men so distinguished. He called attention that this was the first time a Chancellor of the Exchequer had left his country to participate in a mission of this character.

The Treasury head assured the British representatives that the American commissioners were no less sensible than themselves to the virtual necessity of effecting a definite settlement upon a basis entirely just to both.

The British Chancellor, in his reply, approached the problem in a broad general way, declaring the settlement would determine the material welfare of the great mass of wage-earners in Great Britain and the United States. He submitted extensive statistics as to financial conditions in Great Britain and a study of these figures was begun immediately by the American commission.

Five armed men driving automobiles stopped the girl on the road. They were driven off by the approach of a car bearing federal officers.

Mrs. C. P. Hugo Schoellkopf, wife of a multi-millionaire Buffalo, N. Y., chemical manufacturer, attended a New Year's Eve party in the New York City apartment of Frank Carman. On her way down stairs she was dragged into another apartment, drugged and robbed of \$500,000 worth of gems. The police arrested Carman as an accessory to the robbery. Mrs. Schoellkopf refused to appear in court against him, asserting her belief in his innocence.

Carman was on yesterday released by the New York authorities after being held in connection with the robbery. When the news of the arrest reached Carman's aged father at his home in Coshocton, O., he fainted and died a few hours later.

HEARING IN SUTTON CASE CONTINUED UNTIL SATURDAY

Young Man Will Face Manslaughter Charge as a Result of Killing of Phillip Jefferson

The preliminary hearing in the case of the state against Guy Sutton originally scheduled for tomorrow has been continued until Saturday morning when it will come up before Justice of the Peace J. T. Smith, in this city at ten o'clock. The charge of manslaughter on which Sutton will be tried is the outcome of the tragedy which occurred here three years ago when Phillip Jefferson, aged 19 of this city was knocked down and killed by an automobile driven by unknown parties. Saturday of last week, Roy Nichols the other occupant of the car, suffering from a guilty conscience, came to the city and confessed to being in the car at the time the killing occurred and named Sutton as driver of the car. A warrant was sworn out for Sutton and he was placed under a \$5000 bond for his appearance here Wednesday. When arrested he did not deny the charge and made arrangements for the bond. The confession has created no little interest among those who remember the occurrence and no doubt everyone is awaiting impatiently the outcome.

LEGAL OFFENSES LAUNCHED TO LINK K. K. K. WITH MURDERS

Bastrop, La., Jan. 9.—Threats have been made against five Mer Rouge citizens by the exalted cyclops of the K. K. K. since the night of the hooded murders in Moorehouse parish was the testimony of Daniel, the father of one of the victims before an open hearing today. Daniel also stated that his own name was on the list to either move or be killed. He was the first witness to testify this morning and was one of the first to link the K. K. K. cyclops with the activities. The state has officially launched its legal offensive in an effort to link the K. K. K. with the murders of Daniels and Richards. C. C. Davenport will also take the stand and tell of his own experiences in the hands of the mob and describe how they were dressed. It is expected that at least four names will be called and the state will make arrests immediately.

KNOW NORTH CAROLINA.

A Georgia Verdict. The road system in North Carolina is only one evidence of North Carolina's general prosperity that appeals to the people of other states, and particularly to the people of Georgia, whose natural conditions of living are practically the same. North Carolina's public school system is maintained more progressively than is that of Georgia, through no fault of Georgia's most excellent department of education. The higher educational institutions of North Carolina are adequately maintained, while those in Georgia are admittedly starved. The state contributes more to the university system in that state in one year than Georgia does in four. The same can be said of the other institutions—the eleemosynary, the corrective, the penal. Why is all this? North Carolina has relatively a quarter of a million less population than Georgia. All of the five largest cities combined will scarcely exceed in population the one city of Atlanta. Wilmington, the seaboard metropolis is a much smaller city than Savannah. Charlotte, the largest trading center, is not as large as Macon. Neither Winston-Salem nor Durham nor Greensboro, her great tobacco manufacturing cities, is as large as August. And yet it is a state of small cities and towns, each fielded with the stacks of industry, and each the center of prosperous rural communities. The reason for it all is not that North Carolina has any better people than Georgia, for there are no better; not that North Carolina has any more natural advantages than Georgia, for in these both states are practically blessed alike—but that North Carolina has revised her old and antiquated tax system so that the state is provided with funds sufficient to carry on the functions of government in keeping with the demands of a progressive age. And the people of the cities and the towns and the country have prospered as the state has prospered. North Carolina is thus an object lesson that the Georgia legislature should heed.—Atlanta Constitution.

A NATION AT WORK

BY FAITH HUNTER DODGE (Special to The Reflector) Paris, Jan. 8.—It was in Bassoles that it happened, the little incident which epitomized for me the spirit of the French people in their new pioneering adventure—the reclaiming for cultivation and civilization of their war devastated areas. Miss Williams, American agricultural expert in the Department of the Aisne, Monsieur Do'n, head of the local "cooperative" group and Monsieur Polleux, president of the agricultural "syndicate," were seated about a round, green oil-cloth-covered table in one of the two rooms of Monsieur Polleux's temporary residence, carrying on an earnest conversation concerning the placing of five cows and one bull, gifts to the American Committee for Devastated France. A Solomon's wisdom was necessary if those five cows and one bull were going to be adequately distributed among the seven hundred farmers of that territory. Madame Polleux, in her flannelette dress and neatly tucked blue apron, was stirring something in a shiny old pot on a shiny new cook stove, and telling me about her wonderful American friend who had gone back to San Francisco. Madame's hair was beautifully combed, as a French house wife's hair always is, I guess, and shone with as bright a gleam as the pans and pots hanging in a row on the barracks wall behind the stove. In front of me hung two large framed certificates—the frames carefully protected by oiled paper; one certifying the conferring of a silver medal by the Society of Agriculture, the other the entry of a name in the "Book of Gold of Agricultural Merit." With such inspiration looking down at them perhaps the solemn group at table would not find it as hard as I thought to solve the difficult problem facing them. Quickly they agreed on the dis cards. Farmer X, Y, and Z were already the possessors of cows; farmer A could not accept a cow because he had no barn or shed in which to house her; farmer B might not wish to contract to give back to the committee four calves, the offspring of the original gift. As to the rest, it was a question of agreeing upon the greatest need. On an oak desk behind the table an old black marble clock, which had somehow survived the war, ticked away the minutes; on either side of it a shell-case, made into a tall vase, held roses which were artificial, and withered leaves which were real; in front of it two precious little apples—also real—proclaimed the return of something like luxury to this resurrection land. Here were other near luxuries in the little room; in the corner a sewing machine, and, suspended from a hook near the door, a cane, an umbrella, and a tape-measure. The last flicker rays of the November sun were deserting the tiny high window, with its snowy curtains; on the leak oil lamps waited their turn to light their own little corner of the world. The door was opened and quickly closed again to keep out as much as possible of the chilliest wind the winter had brought thus far. An old man, Monsieur Polleux's father, left his wooden shoes at the door and

joined us. Somehow, like the old marble clock, he had managed to survive the storm of war. Bassoles seemed a lonely place for him; I asked what he found to do. "Oh," he answered, "it is never lacking, something to do: Clean the animals, feed the animals, water the animals! There's the chickens and ducks. There's Brissette, they all say she's a diabolical cow, she kicks with force and long range of a cannon. No one can milk Brissette—except me. Me, she understands...." Monsieur Do'n joined our conversation to add some acid invectives against Brissette and an unruly bull, a town character, it appeared, which was widely feared and hated, but which played child-like derision all the commands of Polleux the elder. Then my delightful host, instead of sitting, as his years entitled him to do, near the stove in an easy chair (of course, there were no quite ordinary kitchen chairs available), excused himself and went out to clean the animals, feed the animals, and water the animals," put the chickens to roost and probably say an affectionate good-night to the diabolical Brissette and the wicked bull. In the devastated regions, even for the very, very old, as for everyone else, "it is never lacking, something to do." For Polleux is merely an individual, he is the prevailing type, working without complaints, refusals, or petty bickerings. In the war—no doubt, revolt or cowardice; and in the making of reconstruction—no surliness, indolence, or vain excuses. Just work, a great unflinching determination to work. Then it was the nation's lift the French are working for. Again, as in the war days, there is no vain display of their heroism or their misfortune. But the results of their toil are here in the north and east of France—tangible, visible. First we see restored transportation—a tour de force, accomplished I do not know, but accomplished. With transportation, mining and industrial activities have been resumed. In 1919 I heard American mining experts pronounce their official judgment as they visited the great flooded and plundered coal mines of Lens. "Rendered useless for at least five years to come, perhaps forever," was their verdict. But even then men, women and children were building themselves homes, somewhere above the ruins of ten houses of brick and stone crushed and pulverized by war and buried in mud and water. As well try to sweep back the ocean with a broom as attempt to drive them away. By July, 1921, they had built more than one thousand permanent houses in Lens. Before the war France produced over twenty-seven million tons of coal, of which about twenty-one million came from the mines requisitioned or destroyed. The production has now reached about five million tons through the continuous labor of the mine employes and the clearing away of debris and pumping operations undertaken at the expense of the state. About four million tons of coke were produced annually before the war in what are now the devastated regions. The coke production in 1921 was seven hundred and fifty thousand tons, and that may be the top figure for 1922. But the coke ovens of Bethune, Neoux and Anzin are partially at work, and by January the new ovens in Bethune, Azincourt, Douchy and Lens will furnish, it is hoped, twenty-

five thousand tons a month, or one quarter of the pre-war output. Even industry is coming back to life in spite of the dearth of raw materials and the evident insufficiency of coal. Near railroad terminals, at road-crossings, wherever transportation is available, one hears the humming of machinery. In the Department of the Aisne no factory remained four years ago; the Tergnier area was a desert and all the workshops of St. Quentin, Chauny, Hirson, La Fée, Thiechoc and St. Gobain were memorials. Today they are in full swing. Go with me to Lille, before the war chief of all the industrial cities of northern France. Its mills, which produced a large part of the cotton and woolen goods of France, stood four years ago like sickly, empty cardboard boxes, their machinery rifled or backed to pieces. Lille was a cemetery of factories, whose sole monuments were dead chimneys, ten thousand smokestacks, with no columns of black smoke mounting from them to the blue. The Deule canal, with its fantastic, battle-torn bridges, lay quite and clear, except where the chaotic debris of battles replaced the loaded barges and oily stains which used to cover it. Nothing at all remained of the workmen's houses, their shops, schools or churches. Today, half of the textile factories have resumed production; several hundred permanent houses of stone, brick and cement have been built; terminal facilities for the northern railway have been completed, and I am told they are the best to be found in any European city. All this is only a drop in the bucket, but it shows in which way the wind is blowing. The citizens are at work and Lille will be rebuilt. Nor is the work of rebuilding, in spite of individual zeal, done in a haphazard manner: the French who, by the adoption of laws governing the heights of buildings and types of architecture, have made Paris a city of unexcelled perspectives understand the art of municipal construction. A comprehensive town-plan has been adopted by Lille. All big corporations must conform with it, and permission to build be given by the mayor. The story of Lille has been told not so much to show what labor has done in one city as to present a typical case of the accomplishments of unremitting toil throughout the industrial areas of devastated France. What has been achieved in the reconstruction of industrial towns has been duplicated in other branches of reconstruction. Even the reclamation of forests—the longest and hardest task, perhaps—has been begun, and here and there is seen some evidence of accomplishment—the clearing away of barbed wire—and debris, the evaluation of forest damages and the growing from American seeds of young trees later to be transplanted. Everywhere tasks are many and complicated—not alone for the refugees who have returned to their ruined homes, but for the whole nation which has shouldered the burden of financing them in their endeavors at reconstruction. French vitality, it would appear, it not diminishing. The French philosophy of living—and working—has changed only in so far as it has been intensified. The French pioneer carries on today the torch lighted by Samuel Champlain and Count Frontenac, and bequeathed to him by Brazza, Montell, Parle, Archinard, and the whole glorious band of pioneers of the heroic age of French colonization, who left the French flag floating over the banks of the Niger, the Ivory Coast, African jungles, Cambodian villages on piles, the bazaars of Tunisia, the walls of Timbuctoo, the potteries of Dahomey, the jewels of Dakar, the exotic gardens of Madagascar, and the Kmer are of Indo-China, the pioneers who planted and guarded the French flag in Guiana, La Reunion, Martinique and far Tahiti. Beholding France today, one sees a picture of toilers, not isolated patches of industrious effort, but the whole landscape appearing as one mighty factory, with production running at top speed. Thus Frenchmen, working ceaselessly and intelligently, in close cooperation one with the other, are examples for the whole world to follow. They are pioneers clearing paths for us all.

Tuesday, January 9th, 1922

We hope that when Ambassador Harvey arrives from London with information as to conditions in Europe that he will also bring along some suggestion as to how to clear up the present European middle.

A drive over those of the hard-surfaced roads that are already completed will bring most of us to the realization that we can well afford to put up with the terrible detours which we now have to use for the sake of eventually being able to travel almost entirely by the improved roads.

Though yesterday was Jackson day and was celebrated by the Democrats in many cities, probably the biggest celebration will be on January 12th when the Democrats of Marion, Ohio, President Harding home town, will hold their Jackson day celebration and Democratic jubilee over the results of the last election and form plans for the campaign of 1924. Everyone loves to visit the old home town but no doubt this is one day that the president would prefer to spend in the capital.

Some time ago the city of Atlanta began putting jail sentences on all offenders for driving automobiles while in an intoxicated condition. According to the statements of several who have served their ten day sentence it is unlikely that they will again commit the offense. It seems that our present legislature might take a tip from our sister city and pass some such law for the state to take the place of the present statute which provides for a fine of \$50 for the first offense, as it seems that the fine is ineffective.

In the hope of reaching some settlement of conditions in Europe, England is urging France to cancel about twenty billion dollars in reparations claims. As an inducement for France, England offers to cancel the French bonds which she holds, provided that the United States will cancel the debts owed to her by Europe.

As a net result of these transactions France would give up about ten and a half billions of claims on Germany, and would be relieved of about ten billions of exterior debt she now owes. Including the German claims, England would cancel debts due her amounting to twelve or thirteen billion dollars, and the United States would also cancel claims amounting to about twelve billion dollars. Germany would be released from the payment of twenty billion dollars of indebtedness, but would still owe twelve billions, of which about six billions would be due France three billions due England, and the balance due to other European States.

If this settlement would secure the peace of the world and reopen normal European markets to American products the United States could well afford to sacrifice our existing claims, which are, at the best, of very doubtful value. But would the settlement have any such effect? Germany protests that she cannot pay thirty-two billion dollars. If by this she means immediate payment in cash, manifestly she cannot, but neither can she pay twelve billions. It is clear that all she can do is to pay in goods, which the creditor nations must absorb in some way.

CONFERENCE CONVENTION POSTAL EMPLOYEES TO BE HELD AT WINSTON-SALEM

The conference convention of the postal employees of the State of North Carolina will be held at Winston-Salem instead of Raleigh as originally planned, according to a statement made public today by the Post Office Department.

The meeting is scheduled to take place on Tuesday, January 16th.

Change in the conference convention from Raleigh to Winston-Salem was made necessary because it was impossible to secure hotel accommodations at Raleigh for the fifteen hundred or more postal workers of North Carolina that are expected to be in attendance.

The Post Office Department will be represented by Third Assistant Postmaster General W. Irving Glover and superintendent of post office service, W. R. Spilman. Postmaster John T. Benbow of Winston-Salem will have charge of the arrangements and the Chamber of Commerce of Winston-Salem will assist in making the meeting a success. The program calls for a special conference of the large users of mail of North Carolina to discuss postal questions as well as an open forum at which postal employees from practically every post office in the State will be given an opportunity to take the floor and present their particular problems.

SEEK NEW BLOOD IN CONSULAR SERVICE

Washington, Jan. 8.—The American consular service will shortly be re-organized to create greater inducements to men of ability and ambition to serve Uncle Sam abroad members of the House Foreign Affairs committee declared recently.

The committee members said they realize the urgent necessity of bringing into America's consular fold young men capable of maintaining the nation's standing abroad, but who hesitate because of the uncertainty and unattractive salaries attached to foreign service. They are impressed with the need of making consular pay attractive to talented men of superior financial circumstances and, accordingly, will expedite legislation making salaries more proportionate, reducing the higher ones and increasing the lower ones.

Urges Better Pay.

For some time Secretary of State Hughes has been urging such a salary re-arrangement. He recently told the committee the service "offers little to a poor young man highly qualified for the work by natural ability and education."

"Suppose," Hughes said, "a young university graduate, with predilection for the consular service, with knowledge of French, Spanish, German, Italian, should come to me and ask what chance there was for him in the consular service I would have to tell him, if he had no private means of his own, he would have to put away from him all thought of marriage, deny himself most of the things a young man naturally likes and craves and resort to the most self-sacrificing existence in order to live on the pay of a beginner in the consular service."

This the Secretary declared, does not tend to enhance the efficiency of the service and is harmful to the country and its foreign interests. He urged equalization of salaries, suggesting a reduction from \$12,000 to \$9,000 in the annual salaries of the Consuls General at Paris and London he present incumbents not to be affected by the decreases.

Not Partisan Plan.

"You have got to democratize selection of men for the diplomatic field," Hughes continued, "and I want to emphasize that this proposal has no partisan or political aspect whatever. My sole desire is to use both the diplomatic and the consular services to the highest degree and to put them on the basis where they ought to be. We have got to give the young man entering the field the assurance that he can live, get married and support himself along reasonable American standards."

For the diplomatic service to be recruited wholly from young men of wealth, Hughes asserted, is not conducive to its best interests.

"I am the last man in the world" he declared, "to deny credit to young men of fortune in the service. I do not know what we could do unless we could draw on men of culture and refinement who could afford to join us abroad. But it would be a great misfortune and undemocratic for this government to arrange its affairs in a way which would exclude the others."

Hughes advocated establishment of a retirement fund and retirement on part pay of men of lengthy service in the consular field. The fund would be made up of contributions from the consular pay, the amount being fixed at 5 per cent. He recommended 65 as the retirement age.

The consolidation of the large railroad system into one of the largest systems east of the Mississippi River has brought into the public eye the two brothers heading the combine—Oris P. and Martin J. Van Sweringen, of Cleveland Ohio, two practically unheard-of financiers. They obtained a common school education in Geneva, O., where later they sold newspapers for a living. Going to Cleveland 20 years ago, they entered the real estate business in a small way, and it was not until they interested capitalists in the purchase of a large tract of land near Cleveland that they began to attract attention. Now their interests operate and control the New York, Chicago & St. Louis & Southwestern, the Lake Erie & Western, the Fort Wayne, Cincinnati & Louisville and the Chicago & State Line railroads, all of which they have consolidated into one big system.

ARMY ON RHINE IS HEAVY DRAIN NOW

(By International News.)

Berlin, Jan. 8.—A lot of wine has been consumed by the French, British, Belgian and American troops occupying the Rhine Valley, if the amount of glassware used by them, as stated officially before the Reichstag by Deputy Stuecklen, is any indication.

Between Autumn, 1920, and last summer the armies of Occupation, according to Stuecklen, requisitioned 2,000 Rhine wine glasses, 51,000 claret glasses, 15,000 port wine glasses, 45,000 champagne glasses, 58,

000 liquor glasses, 26,000 beer glasses and 9,000 wine decanters.

In the same period 8,900 coffee sets, 4,300 tea sets, 36,000 tea cups and 36,000 coffee cups were purchased by the German government for the use of the Allied troops. Under the treaty of Versailles the German government must pay all the expenses of the occupation.

Although the price of linen in Germany is now so high that only the very best restaurants furnish linen napkins—in most places a very inferior paper napkin is provided—since the fall of 1920 Germany has bought 170,000 napkins and 1,875 miles of linen for bed clothes, for the use of the occupying forces.

Some of the other items purchased on behalf of the armies of occupation follow: 1,400 drawing room suites,

2,600 library suites, 180 club sets, 2,900 club armchairs 2,100 upholstered suites, 2,300 adult bedsteads, 3,500 children's cots 800 ladies' writing desks, 500 dressing tables, 16,000 flatirons, 18,000 carpets, 1,800 wicker work sets.

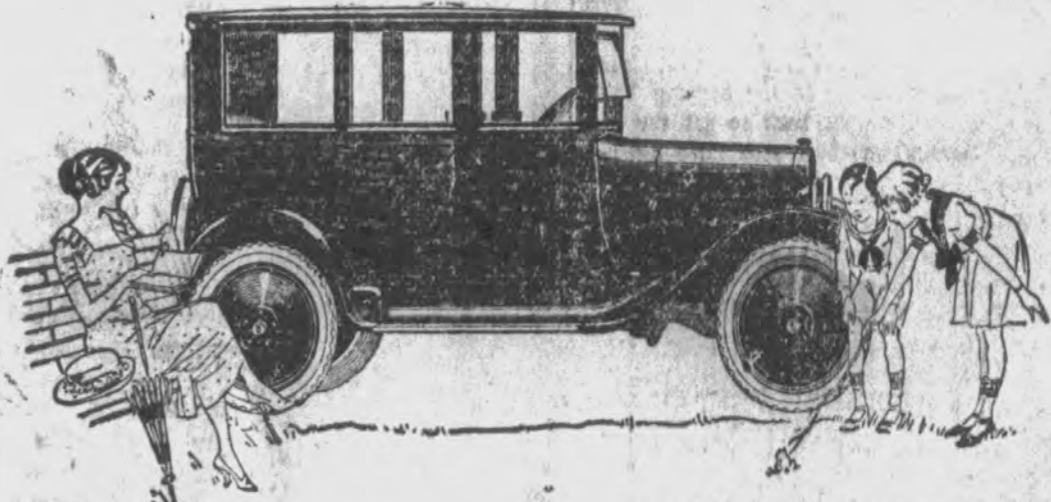

The new wireless outfit is a Marine Corps set which was used during the war on mammoth tanks by the combat forces of the United States on French battlefields. It replaced a smaller navy receiving set which formerly was at the White House.

President Harding operates the set himself. According to friends he spends many hours, usually after a hard day's work in the office, listening to concerts, speeches and radio programmes from such distant points as Chicago, Detroit, New York, Philadelphia and Pittsburgh. He always finds keen joy whenever he "tunes in" on some famous orchestra, or a programme by a well-known singer.

Because he has denied himself all social engagements during Mrs. Harding's convalescence, the President has turned to the wireless for his evening's amusement instead of going to the theatre or to local entertainments. This is said to be the chief reason he ordered the larger radio set, in order to be able to hear broadcasts from the big wireless stations of the country.

AUTO FOOT NEWEST MOTORIST'S MALADY

Boston, Jan.—"Auto foot" is the latest of foot troubles. It is due to "stepping on the gas." Dr. Nathaniel Levinton, Boston foot specialist, finds this complaint becoming more and more common.

The constant pressure on the ball of the foot on the accelerator causes pain in that part of the foot, followed by numbness of the entire foot and leg.
