ROAD SENTENCES FEATURED IN COUNTY COURT YESTERDAY WHICH WAS ALL DAY GRIND TO COMPLETE LENGTHLY DOCKET

Bootlegging and Other Illicit Liquor Interest with Careless Driving of Automobiles are hit Hard by Cooper

Yesterday's session of the Pitt county court was featured by one of the largest dockets that the court has experienced in a long time. The entire day was consumed with the hearings, all of which with a few exceptions were disposed of, road sentences being the chief penalties imposed. Several defendants appealed to Superior Court and were placed under bonds in proportion to their offense.

Ben Moore, charged with larceny and sentenced to eighteen months on the county roads, appealed to Superior court under bond of \$1,000. Ben Moore, carrying concealed weapon, found guilty and given six months on the county roads.

George Bazemore, charged with reckless and careless driving, was found not guilty of driving car while intoxicated, but was found guilty of reckless driving and fined \$25 and one half the costs. Defendant appealed to Superior court under bond of \$300.

Blount Leggett was found guilty of assault and given ninety days on the county roads. He appealed to higher court under bond of \$200.

Thad Brown was found not guilty of the charge of assault with deadly weapon.

Elisha Taft was found guilty of abandonment and, upon prayer, judgment was continued for a period of two years. Elisha Taft, carrying concealed weapon, was found guilty and given six months on the roads.

T. W. Bonner, charged with assault with deadly weapon, was found not guilty of this charge but was found guilty of reckless driving. He was fined \$25 and one half costs. He appealed to Superior court under \$300 bond.

Willie Frank, charged with defraud and swindle also practicing medicine without license, was found not guilty.

Hamp Teel and Lennie Everett were charged with assault. Teel plead guilty and court entered prayer for judgment. Everett did not appear.

Charlie Nelson plead guilty of the charge of larceny and was given four months on the county roads.

Pete Martin and John Jones were found not guilty of gambling while Tom Johnson, Rich Burnett, George Blount, Rube Johnson Bud Woodard, Charlie Jefferson and Ails Griffin were found guilty on the same charge. Defendants were allowed to pay a fine.

Daniel Tyson for assault with deadly weapon was given eight months on the county roads. He appealed to Superior court under a bond of \$800.

The following cases were transferred to Superior Court for trial by jury; Marion Tripp, liquor and for sale; Annie Brady, receiving and possessing intoxicating liquors for sale and selling same. Isiah Peyton, carrying concealed weapon; Isiah Peyton, assault with deadly weapon. Peyton was placed under a bond of \$400 in the latter case.

Louis Taft was found not guilty of the charge of having too much liquor.

Luther Kennedy, charged with larceny was required to pay costs and remain on good behavior for a period of two years.

Henry Dupree, charged with having too much liquor, was found guilty of having liquor for the purpose of sale and was given twelve months on the county roads.

The following were found guilty of gambling and sentenced to sixty days on the roads: Andrew Barrett, John Jones, Dewey Barrett, Dave Hines and Hardy Jennings.

J. Henry Brady, charged with having a store open on Sunday, plead guilty and judgment was suspended upon payment of half costs.

Amos Edwards, charged with receiving and selling whiskey, was given twelve months on the roads but

UNDERGROUND STREAMS MAY SUPPLY POWER IN NEBRASKA CITY'S PLAN

(By International News.) Lincoln, Neb., Feb. 2.—Millions of dollars worth of wasted energy will be harnessed and put to work in the vicinity of College View and Nebraska City if the plans of business men of those communities do not go a'gley.

Engineers employed by citizens of College View have reported that district is underlaid by swift subterranean streams of pure water. It is not impossible, the engineers said, to harness these underground currents and convert their energy into sufficient power to light every city and run every trolley car in the State.

PASSAGE OF SHIP SUBSIDY APPEARS TO HAVE LITTLE CHANCE

Predicted that British Proposition will Finally get Through in Some Shape

Washington, Feb. 6.—President Harding faces two tasks in the less than four weeks that are left of the present congress. The first of these to be pressed by the administration forces is the acceptance of the British war debt settlement proposition without any complications with the soldier bonus question; the other the driving through of the ship subsidy bill.

That the British proposition will finally get through in one shape or another is freely predicted here but there is wagging of heads in the wrong way for the President's hopes in the matter of the ship subsidy bill. As one of the newspaper men who keeps in close touch with Senate affairs says, the ship subsidy bill "is on the rocks and the administration life saving crew can't pull it off," while another says of it: "The ship subsidy bill is drowned, with no hope of resurrection."

Canvass of both Houses are reported to have revealed a sentiment said to be overwhelmingly in favor of giving authority to the war debt commission to settle with the British on the terms that have been announced as being those proposed by the American commissioners and accepted by the British government. In the House the bill for this will be introduced by Congressman Burton, of Ohio, a member of the American commission, and in the Senate by Senator Smooth, the Senate member of the American commission. It will be sought to press legislation in both houses simultaneously on the question.

The President will press his ship subsidy views upon the Senate by means of an open letter to Chairman Jones, this urging that the Senate take up the ship subsidy bill and press it to a conclusion, just as quickly as possible. Just here there has arisen a hitch in which the British war debts settlement and the ship subsidy views upon the Senate by cord. Senator Joseph E. Ransdell, of Louisiana, the lone Democrat who has thus far shown up in advocacy of the ship subsidy bill, is on the fighting line against letting the British debt matter have precedence over ship subsidy bill. His declaration to this effect and the statement he has issued as president of the National Merchant Marine Association, which begins its annual convention here next Monday, is a challenge to having the British matter passed upon first. His declaration is that "Congress will make England a virtual gift of the annual interest she is to pay us on the four billion loan if the shipping bill is permanently sidetracked to take up the British debt agreement in July."

VIRGINIA LADY NARROWLY ESCAPES DEATH IN AUTO WRECK OCCURRING TODAY

Washington, Feb. 6.—Miss Edna Kennedy, age twenty, of Farmington, Va., is laying at the point of death as the result of injuries received when the driver of an auto mobile in which she was a passenger lost control of his car, crashing into a tree. Miss Kennedy suffered a fractured skull and broken leg. Four other occupants of automobile received painful injuries.

WELTERWEIGHT BOXER DIES LAST NIGHT FOLLOWING BOUT

New York, Feb. 6.—Andy Thomas, a welter weight boxer died here last night following a bout with Johnny Clifton Thomas collapsed in the ring and died a short while later in a hospital here. It was discovered that death was due to concussion of the brain.

QUEEN'S CONTEST BEING PLANNED FOR EXPOSITION

Each Town in Eastern Carolina Requested to select Queen for Exposition in Wilson.

The committee that has charge of the program for the Eastern Carolina Exposition at Wilson, N. C., March 19-25, has worked out a very unique plan of advertising each town in eastern North Carolina. This will be known as the "Queen's Contest of the Exposition."

The plan of operation is as follows, each town in any of the forty-six counties covered by the Eastern Carolina Chamber of Commerce, is entitled to enter a Queen in this contest. Wilson county and Wilson, will not have a contestant in this particular contest. Each town will nominate her queen by any method which the local people may see fit. This queen will be certified to the Exposition by the local people from the town from which she comes. She will be supposed to attend the program for Thursday afternoon and Thursday night of the Exposition. At the afternoon program each Queen will be introduced to the audience as Miss Kinston or Miss Greenville, Miss Goldsboro or what ever town she may have come from. Ballots will be distributed and each person on the inside of the Exposition buildings will be entitled to vote one time for his choice. This same procedure will be followed at the evening program and the voting will close at 9 p. m. Thursday night. The ballots will be collected and the tellers will retire and bring back the winner of the Exposition. At the same time that she out of town Queen will be voted on, the Wilson county Queen will be voted on and elected, but will be separate from the other voting. Friday night at 9 o'clock these two Queens will be crowned and each will be presented with a \$500 diamond ring from the Eastern Carolina Exposition. As soon as you nominate your Queen please notify the secretary-manager at Goldsboro, so that her name may be registered as a contestants. The entrance for Candidates will close March 12th, and no Queen will be allowed to enter after that date.

It matters not how small the town, you are entitled to one queen. Get busy select her and let your town get the publicity that will naturally go along with this contest.

DR. PEACOCK NOT FOUND IN FLORIDA SAYS THE OFFICER

Special Agent France Returns to Raleigh from Two Weeks' Hunt Empty Handed

Raleigh, Feb. 6.—After spending a fortnight in Florida co-operating with the authorities there in an effort to bring Dr. J. W. Peacock back to the insane department of the State penitentiary, to which he was committed following his trial for the murder of the chief of police of Thomasville and from which he escaped last August, D. C. France, special agent for the State, returned yesterday and reported failure to the Governor and the superintendent of the State prison. Mr. France was sent from Raleigh supplied with a warrant for the arrest of Dr. Peacock on the charge of escaping from the State prison, which is in violation of a North Carolina statute, and with requisition papers from Governor Cameron Morrison on the Governor of Florida. Governor Hardee, of Florida, signified his intention to honor the requisition, but Dr. Peacock was not to be found.

At the time the facts became public that the escaped man was in Florida and had been adjudged sane by a court of that State, Dr. Peacock was quoted as saying that he was willing to return to North Carolina and fight for his liberty here. He had moved on from Lakeland before the arrival of Mr. France, however, and the special agent told Supt. Geo. Pou, of the State prison, today that he found no evidence of Dr. Peacock having resided there.

ROTARY THE PROFITS MOST WHO SERVES BEST

Speaks a universal language, knows no national boundaries, and proclaims throughout the world the brotherhood of man.

Discovers the good in the other fellow, capitalizes disinterestedness and unselfishness, and cultivates the will to serve.

Promotes decent and orderly living, maintains the laws of the land and prizes good citizenship as an inestimable virtue.

Keeps the old man young, holds the young man to a steady course, and helps the boy to be a dependable man.

Lifts the joint interest of a community above partisanship, co-operates with all intelligent agencies for social betterment, and urges every man to some participation in public enterprises.

Believes in a world-wide peace; strives honestly to make that long hope a fact; and fights, if necessary, to preserve the hope for the ultimate establishment of the fact.

Clings to a belief in the sacredness of womanhood, centers the hope of the universe in the home, and recognizes the claims upon society of generations yet unborn.

Calls for an economic policy that makes for individual independence, emphasizes an educational system that strengthens the hand, the mind, and the moral fibre, and insists upon an equitable distribution of the fruits of labor.

Sings merrily upon a holiday, shouts often at play, and rings with laughter unashamed.

Squares religion with business, elevates religion above sectarianism, and gives and glorifies the faith that makes possible things unseen and unheard.

"This is my birthday, and a happier one was never mine."—Long-fellow.

The poet's line might well be quoted by Rotarians, since Rotary's eighteenth birthday finds our organization with more than 1,300 five clubs distributed among twenty-seven countries, with a membership of nearly ninety thousand. Yet though we can congratulate ourselves on this expansion we cannot escape the added responsibility that this expansion implies. For with each new club that spreads more widely the Rotary ideals each of the present clubs must assume added ties of service, must increase its responsibility to humanity at large.

We call it "Rotary's birthday," and in a way the expression is true. But the philosophy of Rotary is not new, save in the sense that it is a modern expression of a very old thought. For many centuries thinking men have realized the necessity of substituting brotherhood and service for hate and fear, if world progress were to continue. There is a very pressing need for this substitution at present. A weary world, still suffering from the ravages of the greatest conflict in story, needs all that leadership and brotherhood can do to alleviate its pain and reorganize its industry. In public opinion we have a power which we cannot equal by huge armaments massed to sustain the balance of power, nor by international laws prepared by various legislative bodies. Rotary, with the strength of its eighteen years with increasing world-wide influence, can do much to mould public opinion by setting an example.

Our Friends of Other Nations There is a constantly increasing number of men in the world who are coming to a realization of the fact that of all possible human undertakings, the greatest is the promotion of friendly relations among men. No matter how much a man may declare for international peace and friendship, he will prove to be a poor instrumentality by which to promote friendly relations between his country and others if he is obsessed with the idea that his country stands as representative of all that is good and other countries stands as representative of all that is evil. The promotion of friendliness among nations did not enter very much into the scheme of things during the early days of Rotary; rather has it become a later development growing out of the evolution of Rotary. Not alone those in Rotary, but all the world in recent years have experienced an impulse to think and act with broader vision and with more determined purpose. Rotary has always stood for acquaintance, friendship, interest in

the welfare of others, and a desire to help others succeed. Such a program is easily expanded from the individual and the community to the world, so let each Rotarian diligently search for the good to be found in our Rotary friends of other nations. Let us err, if we must, in over estimating not in underestimating, the virtues of men from other countries.

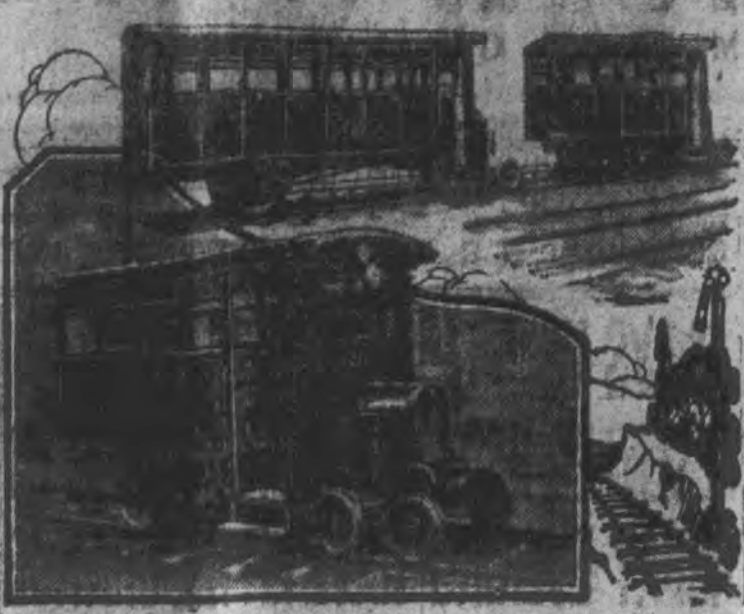
Millstones. At regular intervals along the road of life are placed the millstones that mark the passing years—and also the passing achievements. In actual life a milestone is more than a mere indication of exact locality. It is a sign of commerce, a record of human progress. In this respect there should be no distinction between the milestones of daily life, and those imaginary milestones marking epochs in our lives. Each should be a record of things done—not necessarily the record of material gain but the record of a successful life—successful in the highest sense.

Each time that we influence another person we make a permanent record on our milestone of life and by that record all who follow us must judge our character. But the hopes and fears of future humanity are dependent on the sum total of our records.

Upwards of half a million men, through membership in these clubs, have caught the vision which came to the first Rotarians in Chicago in 1905. With the fine courtesy that might be expected from members of such organizations they all recognize Rotary as the original organization and are frequently saying nice things about Rotary which are hereby gratefully acknowledged. The ideal of service is as deep and as broad as the human race itself. The more men there are inspired by that ideal the better it will be for the world.

REO HELPS SOLVE RAILROAD'S PROBLEMS



"Railway transportation in the United States is at the present time passing through a period without parallel in its history and the cause of this radical change is the gasoline motor. Says Mr. Roy T. Cox of the A. G. Cox Mfg. Co.

"Scattered over the country, and especially in mining and lumbering districts, are scores of short line railroads. The owners of these minor lines, which were built in days preceding the advent of electricity as a motive power, finally awoke to find that their steam rolling stock was worn out or obsolete.

"True, there remained the alternative of converting them into electric power, but this method involved a heavy initial outlay of money, with the added burden of operating and maintenance expense.

"While the railroads were casting about for a way out of their difficulties, along came J. Blaine Worcester, a manufacturer of Middletown, New York, with a plan which met with instant favor with many railroad operators.

"His plan was to take a stock gasoline truck chassis and fit it with flanged metal wheels similar to those used on steam and electric roads. As the idea developed it was discovered that the Speed Wagon, which was the chassis selected, possessed a power plant of a hauling capacity sufficient in excess of the needs for an ordinary load to meet the exacting demands of this new service demanded of it.

"With this fact proven, Mr. Worcester designed a number of passenger coaches with carrying capacities from 10 to 20 passengers. On the smaller cars, the only changes made in the regular stock chassis is to add the flanged wheels and adjust them to the rail gauge. The heavier cars require a lengthened frame slightly reinforced springs and a special four wheel front truck.

"The lower illustration shows the type of cars now in use on the Williamsport-Unionville line. One of the over 60,000 miles and is still giving uninterrupted service.

"The electric field is also a fertile one for the "Railroad Reo," as Mr. Worcester calls his steel rail car.

"Many operators have found the "Railroad Reo" an invaluable addition to their equipment. These cars are usually operated on the "one man" principle and the gasoline consumption and other operating expense is infinitely small compared to electricity or steam. There is much less shock and vibration encountered on the steel rails than the same truck with pneumatic tires would receive on the best highway. The gasoline mileage is no greater and forty miles per hour is a normal speed."

HOME OWNERS ARE COMMUNITY BUILDERS

America has marvelous wealth. It is rich in fertile soil, in its mines, in its water power, in its forests. But above all, America is rich in people rich in workers on the farm and in the factory. Its largest single industry, however, is agriculture.

One-third of the toilers of America are farmers; more than one-half the people of America live under rural conditions. The farm home has been an important factor in American history. It has been the nursery of great men and noble women. It should belong to the one who tills the soil.

The American home began when the first Indian pitched his tepee on the western continent. Its evolution has been marked by the characteristics of the people of the various ages.

The home of the pioneer was built, not as he should have preferred to have it, but as the necessities of the time required. He lived alone and placed his cabin without regard to social experience. He lived a lonely and independent life, but the beginning of the family group dated from his advent.

The pioneer established the farm home in America and the land farmer, who followed him, brought it to a high state of perfection.

The land farmer lived in a time of plenty. He reaped the first values of a virgin land. He developed personality. He perfected the family group. He built a homestead representing his idea of domestic and family comfort. He built for permanence and established the classic period of American life. The typical American home as it lives in sentiment, in literature, in idealism, was the home of the land farmer.

He considered his estate as belonging to his family group, but had no idea of community prosperity.

Realizing that the home owner is the community builder, the people of every community, whether in town or country, should adopt some cooperative plan which will tend to convert the tenant into the home owner.

But much depends upon the individual. Buying a house and lot or a farm is more of a philosophical conclusion than a physical or financial transaction. He, who is afraid to own his home, may be a good citizen, but the best citizen is he who has the courage to own property; to pay taxes on it; to build it up and improve it; to help support the community; to be useful to himself, to his children and to the world.

Such a man embraces the opportunity which home owning only affords—the privilege and duty of merging the struggle for life into the struggle for the lives of others. This takes the life from the tool for existence. It makes life worth while.

The money invested in a home is securely invested. It is not subject to the accidents and misfortunes common to capital invested in trade or manufacture. Money used for the purchase and improvement of a home is as well secured as the nature of human affairs will permit.

The beauty of the country, suburban or small-town home, the pleasure and tranquility which it guarantees and the independence which it affords are not provided by any other form of investment.

A community of home owners is a community of good schools and churches of excellent social conditions, of high moral environment, of beautiful homes and general prosperity. (Auspices Pitt County Chamber of Commerce.)

Authorizing and directing the Mayor to have cemetery map put in shape and recorded in register of deeds office. On motion the following amended ordinance was unanimously adopted.

Three, Section One.
Be and it is hereby ordained by the board of aldermen in regular session assembled, that section one of chapter three of the ordinances of the Town of Greenville be amended by striking section one of chapter three and inserting in lieu thereof, section one and section 1-1-2 as follows:

Section One. Every person found guilty of any riotous or disorderly conduct within the town limits, or within one mile thereof, or shall be heard using vulgar, boisterous, or profane language or who shall engage in illegal or improper diversion, or shall be guilty of using indecent or immoral language or shall be guilty of indecent, immoral or improper conduct, or insulting language or behaviour on any public street, road or elsewhere, in the town of Greenville or within one mile thereof, shall be deemed a disorderly person and upon conviction shall be fined fifty dollars or imprisoned thirty days for each offense.

Section one and one half. All persons found staggering, wandering or lying about drunk, or in a noticeably intoxicated condition on the streets, or in any public place in the Town of Greenville or on any highway or any public place within one mile of the corporate limits of the town, shall be taken and lodged in the town jail until in a fit condition to be tried, or released on bond, and upon conviction of drunkenness as defined in this section shall be fined fifty dollars or imprisoned thirty days for each offense.

Petition for lights on Fleming street up to and including the colored schools at an estimated cost by Supt. Williams of \$125.00, on motion unanimously allowed.

Alderman Hearne reporting for the Play Ground and Park committees, stated that he had been negotiating for some time with Mr. W. E. Hooker and Mr. W. H. Ricks in an effort to obtain concessions of the ravine and hill east of the town branch between 4th and 5th streets sufficient to justify the town in putting in a culvert through the property and converting same into a park and play ground or Athletic Field, and that he felt convinced that they had finally reached a basis of agreement whereby the project could be made a success by and with the co-operation of the Rotary and Kiwanis Clubs and other Civic organizations. On motion the board unanimously went on record as supporting the plans of Alderman Hearne and the committee, and the Mayor directed the committee with the support of the board to proceed and to take steps such as execution of agreements with Mr. Hooker and Mr. Ricks as may be necessary to the reclaiming and converting of said property into useful and beautifying purposes.

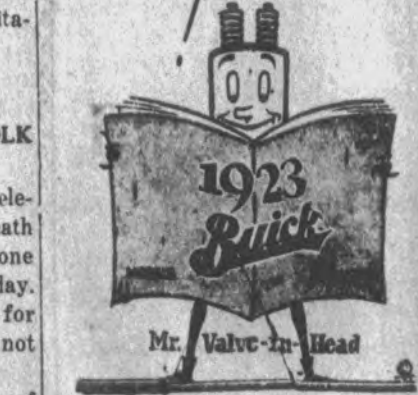
