There are but two days left in which to settle the very important question of who will win the Oldsmobile, who the Star-touring car and the two handsome sets of furniture, diamond ring and wrist watches in The Daily Reflector's great subscription drive.

BOND GANG LEADER IS OUT ONCE MORE

Escapes From Hospital, Where He Was Taken After Being Wounded When Captured

Athens, Ga., April 5.—(By Associated Press.)—For the second time within ten days Gerald Chapman, leader of the million dollar mail robbery in New York in 1921, was being sought today, after a sensational escape from prison guards.

During a momentary absence of his guards last night Chapman knotted sheets together, donned a guard's suit and escaped from the hospital here, where he was recuperating from four bullet wounds inflicted by a posse after his escape with Frank Gray from the hospital ward at the Atlanta penitentiary. Shortly before his escape a nurse took Chapman's temperature, which was 100 degrees.

CYCLONE SWEEPS EAST WAKE COUNTY

Score of Persons Injured and Hundred or More Buildings Blown Down

Wendell April 4.—A score of persons are said to have been injured, some of them probably fatally, a hundred or more large buildings blown down and property damaged to the amount of \$100,000 by a cyclone which cut a path a half mile wide and between seven and ten miles long through Eastern Wake county shortly before eight o'clock tonight, according to reports received here.

The cyclone which is said to have originated in the edge of Johnston county took a northeastern course east of Wendell and fearlessly skipped here and there demolishing every thing in its path for two hundred yards or more and then leaving the path for the next two hundred yards untouched. If swept within one mile of Wendell where it wrought damage to the extent of \$15,000 on the farm of J. P. Richardson, and is declared to have blown down a building in Zebulon, which is tonight cut off from communication. All the physicians in Wendell and country adjacent are busy in the stricken district and frequent calls are coming into local drug stores for medical assistance. Thus far no deaths have been reported though a negro woman and child have been sent to a Raleigh hospital in a serious condition.

The injured thus far known are: John Debnan, colored tenant on Mr. Richardson's farm, his wife and small children.

Tom Parham wife, and several small children.

Mrs. E. T. Cozart, slightly hurt.

Two other families residing on the Richardson farm whose identity could not be established.

The State highway between Wendell and Middlesex is hopelessly blocked with debris, and according to reports tonight will require considerable work before it is cleared for traffic.

Norfolk-Southern train No. 1 was delayed about 20 minutes, when it struck a tree blown across the tracks, smashing its cowcatcher. The train was able to continue to Raleigh.

A great many buildings were demolished as the tornado swept its way across the farms of J. C. Collins, Charlie Johnson, Norman Deans, W. T. Roberts, W. R. Johnson, and practically all livestock on these farms is reported to have been killed.

On the farm of J. P. Richardson, one mile East of Wendell, six of the eleven tenant houses were blown down together with fourteen large tobacco barns, twenty pack houses and two granaries.

One of the houses, occupied by John Debnan, negro, was blown to splinters and Debnan's wife and ten children were injured. The mother and one child, regarded as probably fatally injured were removed tonight to a Raleigh hospital.

The damage on this farm alone, it is estimated was \$15,000.

On the farm of W. T. Roberts, six or seven barns and some stables were blown down while the kitchen of the dwelling of Norman Deans was blown off and a granary demolished.

The cyclone accompanied by a heavy downpour of rain exercises all the freakish traits of the usual cyclone. For a space of a half mile or more it wiped out every building in its path and then, for two hundred yards, apparently skipped off, settling back in the same track again with unabated fury.

M. H. Griffin, who investigated the extent of the damage tonight placed it at more than \$75,000 while some other estimators fix the loss at beyond \$100,000.

"Tobacco barns were wiped off the ground at the foundation" said Mr. Griffin on the return from the Richardson farm. "The wind must have been terrific. Great trees were yanked up by the roots. The house in which the Debnan family lives was torn to splinters. Other houses were picked up and carried for a distance and planted again with a crash."

EARL OF CARNARVON REPORT MURDERED GIRL WAS MARRIED THIS MORNING, SAID

Marriage Records of Town Near New York Are Being Scrutinized by Police

New York, April 5.—(By Associated Press.)—Marriage records in nearby towns were being scrutinized today by the police to determine if Dorothy Keenan, slain model, had been secretly married under an assumed name to a young man of wealth shortly before she was chloroformed. Authorities were informed that the dead model had confided to friends she had eloped to New Jersey at the fag end of an all night party and gone through the marriage ceremony. When pressed for the name of the man, friends say she evaded a direct answer, but named two men often seen in her company.

While the press of the world was still devoting no small amount of its space to the notable contributions to the world's art and history which Lord Carnarvon and his fellow explorers had uncovered came the news that he had been suddenly stricken down and was lying seriously ill in Cairo from the bite of an insect.

By the public at large the misfortune which the Earl had met was regarded as a lamentable incident of what might happen in a tropical climate such as that of Egypt. But to the credulous students of Egyptian mysticism the news did not come as a surprise.

Even before Lord Carnarvon was stricken with blood poisoning, announced as due to an insect bite, there had been talk of the curse laid by the ancient Egyptians with mystic incantations on any who dared disturb the sleep of a Pharaoh after he was stricken. The old legends spread and hundreds were to be found not before superstitious, who were ready to believe that the old Egyptian curse had fallen on the rich and famous Englishman.

There were some who even questioned whether it was an insect that had dealt him the poisonous stroke. It was suggested that he might have touched some poisoned object in the tomb itself set thirty centuries ago to revenge the dead king on any who might disturb his rest.

Marie Corelli, the noted writer, recently made such a suggestion.

SERIOUS ACCIDENT TO LITTLE GIRL IS AVERTED TUESDAY

Mary Rachael Teel Falls Distance of Ten Feet into an Old Well Site

What almost proved a serious accident occurred Tuesday, when little Miss Mary Rachael Teel, the young daughter of Mrs. Mary Teel fell a distance of about ten feet into an old well site.

The little girl had gone over into the yard of Mr. Closs Hearne where an old pump hole had been covered over with planks. Not realizing the danger of such a place she attempted to walk across the boards which were so rotten that they gave away under her feet, and as a result, she fell, but fortunately landed on some cross sections of timber that had been placed down in the well to steady the piping of the pump. Had she failed to stop on these timbers she would have fallen into about ten or twelve feet of water.

Mary Rachael immediately gave alarm which attracted her mother and several neighbors, and with the aid of ropes she was pulled to the surface and to safety. Her only injuries were a few abrasions of the skin about her lower limbs.

Young Boy Will Be Taken to Concord Institution Today

Enoch Briley, a fifteen year old boy of the county was brought here yesterday and placed in the hands of welfare officer, K. T. Futrell by a Virginia officer who acted upon advice of Pitt county authorities. Young Briley is motherless and the whereabouts of his father is not known at his time. The only schooling he has ever received was for a few months only, following his being brought here early last fall homeless, juvenile judge, J. F. Harrington turned the boy over to Mr. J. H. Highsmith of the Bethel section who was providing a good home for him, and at the same time giving him the opportunity of attending school. Not being satisfied of a roaming disposition young Briley decided to go to Virginia. After much searching he was finally located at Whaleyville, and it was from that point that he was brought here yesterday. It appears that although the boy has almost reached his sixteenth year he has never had any educational advantages, and as a result he is yet unable to read or write.

This is the fourth member of this family that has been sent to the institution at Concord, and each one of those preceding Enoch have found elegant homes in the State. This afternoon he will be taken by an officer to Concord where he will remain until another home has been secured for him.

LOUISIANA TOWN IS SWEEPED BY TORNADO

Fourteen Persons Are Killed and Fifty Others Injured by Tornado

Alexandria, April 5.—(By Associated Press.)—The death toll from the tornado which swept Alexandria and Pineville is placed at seventeen, thirteen white and four negroes being in the undertaking establishments here. The list of injured is placed at sixty and the property loss is estimated at half million dollars.

New Orleans, April 5.—(By Associated Press.)—Following in the wake of unprecedented rains a tornado last night swept down upon the little town of Pineville killing fourteen persons, injuring at least fifty others and laying waste everything within its path of several hundred yards in width. The number of missing had not been determined today. No news has been received from Boyce and Goodpine is reported to have been in the path of the tornado.

FIRST VIOLATOR OF TURLINGTON ACT NABBED IN AYDEN

Claude Mills, of Chicod Township is Caught With Small Quantity of Corn Liquor

Claude Mills, a white resident of Chicod township, is the first known violator in Pitt county of the new Turlington or state liquor law. The accused was in Ayden yesterday partaking too freely of hooch of the inferior variety, which is the only brand possible in these parts this day and time. The officers were forced to take Mr. Mills into custody because of his conduct. Being arrested they found on his person one small tin of corn whiskey which makes him a violator as above stated.

He was given a hearing before Mayor J. B. Eure of Ayden and bound over to the county court under \$200 bond. The laws governing the Turlington act makes the first offense a misdemeanor and the judgment imposed is left to the discretion of the presiding officer. Those guilty for the second time are charged with felony and their imprisonment is supposed to be from four months to five years in the state prison.

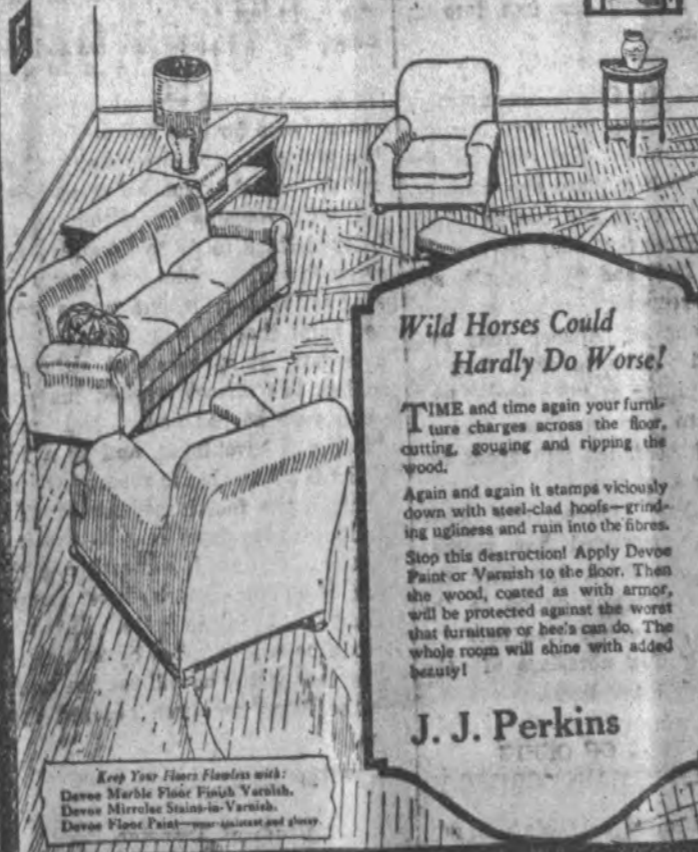

**WINTERVILLE BOY WINS COUNTY PRIZE IN RAT CAMPAIGN**

Leland Forlines Wins \$25.00 for Reporting 114 Rat Tails to Red Cross

The complete reports of the Anti-Rat Campaign waged in Pitt county under the direction of the North Carolina Extension Department and the United States Biological Survey passed the expectations of Mr. C. Carr, expert in this work who came to Pitt county at the request of Mr. W. B. Pace, county agent, to lay out the best known plans for rat extermination. Mr. Carr stated that he scarcely thought any child in the county would be able to get 100 rat tails because the bodies could not be found after using the Barium Carbonate, the poison distributed by the Red Cross but Pitt county did.

Leland Forlines from Winterville won the county prize of \$25 with 114 rat tails.

Ayden, Farmville, Bethel, Grifton, Greenville and Grimesland all offered local prizes and the following chil-

dren came out for first prize in their respective localities: Virginia Jones, Grimesland; Edward Windham, Farmville; William Harrington, Ayden; Willie Lang, Grifton; and Bibb Barnhill, Bethel. Jim Dupree won the ten dollar prize given by the town of Greenville, having turned in 56 rat tails. The children winning the next highest Greenville prizes were—Jim Tucker, 51; Downell Elkes, 40; Louise Barnett, 38; Leroy Coward 33; J. B. Eastman, 14. The prizes will be given from the Red Cross office Saturday morning. Each child will kindly bring

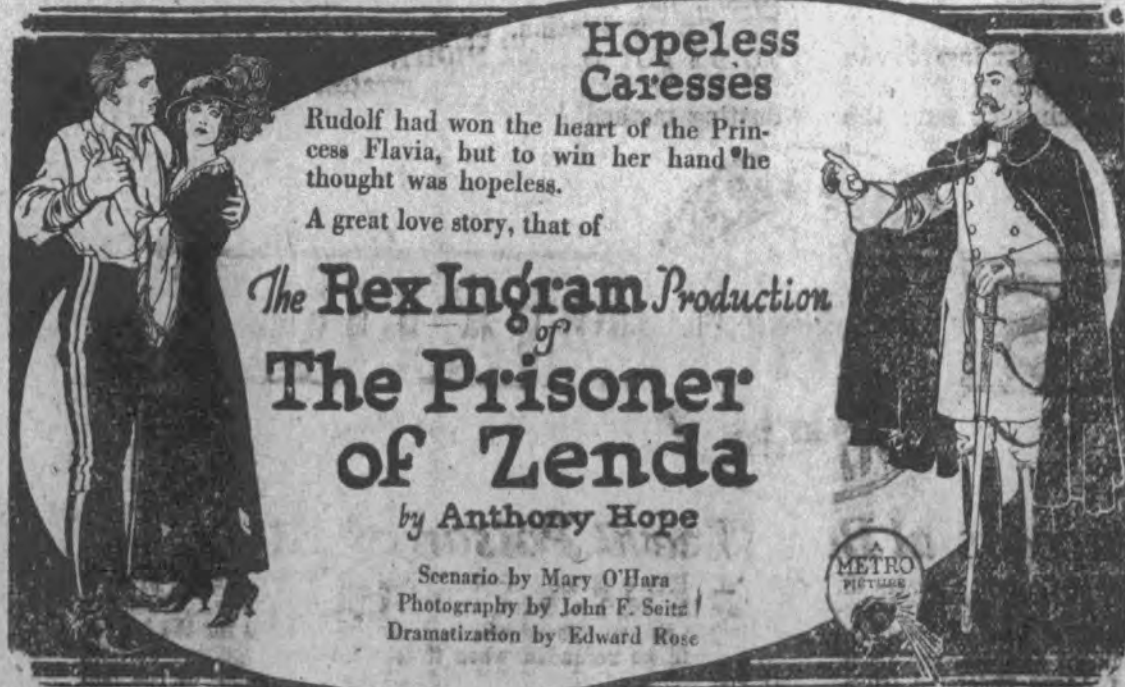

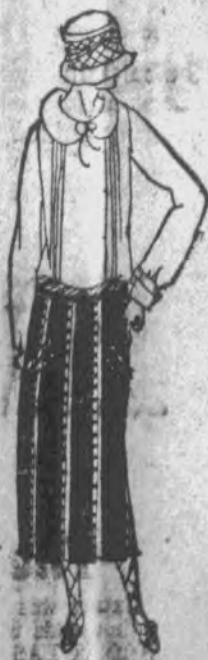
