## Hughes Advocates U. S. Participation In the World Court

WASHINGTON, April 28.—Participation by the United States in a permanent court of international justice was advocated tonight by Secretary Hughes in an address before the American Society of International Law as indispensable to any plan for the prevention of war and the promotion of peace.

"Whatever else we should have," Hughes declared, "we need at once a permanent court of international justice. No plan to promote peace can dispense with it. We shall make no progress toward the prevention of war if we adopt a perfectionist policy."

Among the "actual needs" for a world court the Secretary cited the requirement of the nation for such a tribunal as a means of disposing of "its own controversies" and judicially adjusting international disputes. Existing means of arbitration, he said, "leave much to be desired." He declared the court "an establishment separate from the League (of Nations), having a distinct legal status created by an independent organic act."

"If you are to treat participation in a permanent court of international justice as a hindrance to our progress," he added, "you must rewrite American history."

**Points out Necessity.**

"In making this proposal," Hughes said, "the President has been animated by the desire to promote world peace and stabilization; he has sought to give effect to a long cherished American aspiration and to pursue in the projected course the clear line of our traditional policy. With full appreciation of the intensity of feeling aroused by the controversy of recent years we can not fail to realize the importance of having the subject considered upon its merits and the supreme need is an understanding of the facts which should remove uncertainty and quiet apprehension."

"As the President has explicitly stated, it is proposed to support the Permanent Court of International Justice; it is not proposed to enter the League of Nations. Those who desire that by this method the United States shall become a member of the League are indulging vain hopes, and those who are alarmed at such a possibility are entertaining vain fears. The test is a clear one. If the Senate should approve the President's recommendation, the United States would still be outside the League. Acceptance of the President's proposal as to the International Court will not obtain for the United States a single right or subject it to a single obligation under the Covenant of the League."

## Cecil In Farewell Word Believes U. S. Will Help Europe

NEW YORK, April 28.—Convinced that the American people have accepted the view "that isolation was an impracticable ideal, if it was an ideal, and that some attempt must be made to answer that great question of what are we going to do about international co-operation," Lord Robert Cecil took leave of the United States today.

In a farewell address Lord Robert made it clear, that he does not suggest "that America accept the League of Nations," but added, "American people will devise some method for helping Europe out of its troubles."

## EVANGELIST IN STRONG SERMON ON ETERNAL LIFE

Will Deliver 3 Sermons In Warehouse During Tomorrow

"What is Eternal Life?" was the subject of evangelist Louis Entzinger at the warehouse last night.

A number of scriptures were given, which were illustrative of the truth that moral goodness cannot save. A clean, upright, moral life is a fine recommendation for an individual, and should always be in evidence in the life of one making a profession of faith, but, according to the speaker, absolutely has nothing to do with salvation.

"Works," said the preacher, "follow salvation, but never has any part in bringing it about." Eternal Life is the free gift of God. Therefore, it remains for the human family to accept God's son, which is salvation.

Evangelist Entzinger also pointed out that it requires more than a mere historical faith to appropriate the free gift of God. It requires a personal, heart belief upon the part of the individual. When this condition is met salvation is the immediate possession.

There will be no services either this afternoon or tonight, giving all a chance to prepare for a great day on tomorrow.

At 9:45 in the morning at the Memorial and Immanuel Baptist churches, each of the Bible schools will have their regular sessions. Plans are being made for a large attendance.

Plans are being made for a get-together service in the afternoon at 3:30, which is especially for all of the teachers and officers of the two Sunday schools, as well as for the entire membership of both churches. Sunday school workers of the other denominations have a cordial invitation to attend.

Closing the day at the warehouse, the largest attendance of the meeting is anticipated.

At all of these services Mr. and Mrs. Butler will continue to bring their inspiration in song, accompanied by Mr. Holloway at the piano.

The fine co-operation of the various churches of the city and the neighboring towns is expected to continue throughout the meeting.

## Arrests Suspects In Flogging Okla. Family

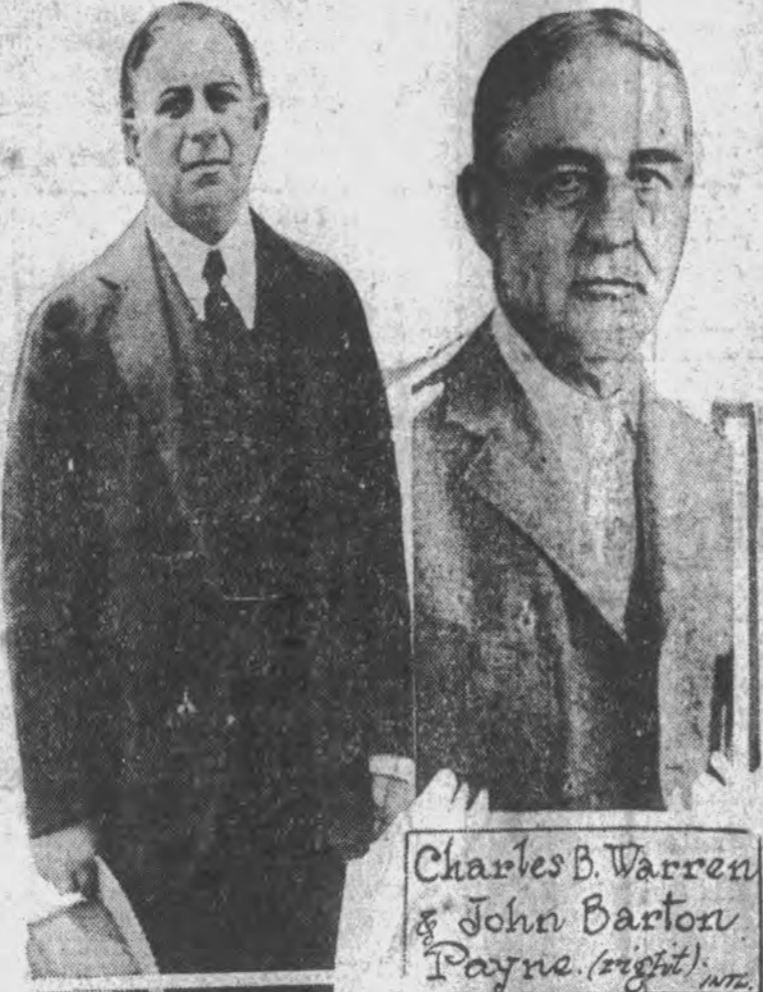

## SCOUTS TO CANVAS CITY FOR CLOTHES NEAR EAST RELIEF

House to House Canvas Will Be Made Wednesday, May 2nd

The Boy Scouts, under the supervision of Mr. Victor Davis, will on Wednesday afternoon, May 2nd make a house to house canvass for the purpose of collecting clothes for the Near East Relief.

After the clothes are collected they will be carried to the High School building where they will be put in tobacco hogshead and sent on their way to the Near East where many adults and children were found last winter who had dragged themselves for miles suffering from frozen feet, pneumonia and acute rheumatism. Nearly all of these could have been saved by the clothing which Americans have cast off. In summer they have burlap bags and flour sacks to wear, but they will not keep out the cold of a winter whose climate closely approximates that of our New England states.

Mr. W. H. Woolard, the county chairman, is particularly desirous of receiving as many as possible of coats, trousers, sweaters, dresses, blankets, wool shirts, heavy shoes, wool gloves, boots and shoes (should be tied in pairs) shopworn garments, sheets for bandages, new cloth and any warm, heavy clothing in which there is still some wear.

In case Boy Scouts fail to call for clothing, kindly call W. H. Woolard, No. 103 or Victor Davis, No. 67. Either of them will see that the package is called for. Remember the date Wednesday, May 2nd.

## 22, Including Woman, Held as Communists

PITTSBURGH, Pa., April 28.—Twenty-two alleged communists including one woman, are under arrest following raids last night by city, county and federal officers.

The prisoners, according to the authorities had planned a big May day demonstration in Allegheny county. Several rooms in the court house were used to store the captured illegal material of various kinds.

## 40 HURT STORMING ENGLISH STADIUM

LONDON, April 28.—The new stadium at Wembley Hill, with a capacity of more than 100,000, was the scene of wild disorders today, when it opened with the association football final to decide the championship between England and Wales.

According to the best information more than 40 casualties resulted when the doors were opened. After the gates were closed and the immense stadium packed the crowd stormed the doors.

It is not known whether any fatalities resulted.

## SEVERAL DEFENDANTS PAY FINES IN POLICE COURT

Clyde Wayne, charged with driving automobile and not having exhaust muffled, allowed to pay cost.

Frank Emundson, charged with receiving and possessing intoxicating liquors for the purpose of sale, being called and failed to appear, bond was forfeited. Emundson is a blacksmith at the fair grounds, who came here with race horses. Apparently he has left for parts unknown.

John Lauteres and Tommie Ricks were charged with disorderly conduct. The evidence was that Tommie Ricks created a disturbance in John Lauteres' place of business and when John undertook to put him out it brought on considerable disorder in the way of cursing, etc. The mayor held that Tommie Ricks was in fault but that John Lauteres used too much force, therefore, he fined Tommie \$5 and one half the cost and John one half the cost.

Jack Williams, colored, charged with vagrancy. Judgment was suspended upon the payment of cost.

## GREENVILLE HIGH TEAM LOSES GAME TO SCOTLAND NECK

Ragged Fielding Puts Locals on Short End of 5 to 3 Score

By ragged and slow fielding inability to hit, the Greenville High School base ball team dropped one to Scotland Neck on the local diamond Thursday afternoon 5 to 3.

For some unknown cause there appeared no pep among the locals, and with one or two exceptions the players showed practically no interest. Several times they would handle a hit ball so slowly that the runner would beat the throw by several feet. Just such practices as this is responsible for Greenville's defeat. Zeno Brown experienced somewhat of an off day, as he was hit quite frequently when bingles meant runs. He started the first inning in air tight form, after walking the first hitter he caused the next three to retire to the bench by the strike out route, and many times during the remainder of the contest when the home plate was threatened by a runner, he would tighten up and not allow the batsman to leave the home station.

There was one very unusual occurrence connected with the game. In the third inning the visitors hit safely four times in succession, but failed to score a single man, as the forced man was thrown out in his attempt to reach home. While the local twirler allowed seven hits to his opponents measly three, he kept them well scattered with the exception of the third inning as above stated.

Scotland Neck gained a good lead in the beginning which they retained until the seventh inning, during which stanza Greenville showed two scores across to tie the count. But the visitors came back and with a couple of hits on their part and slow fielding on the part of the local infield sent two more runners safely across breaking the 3 and 3 tie. This lead they held for the remainder of the game, although Greenville threatened a finish in the ninth when the bases were filled with one man down. And the succeeding hitters banged the old apple, but unfortunately for the locals it fell into the hands of the outfielders of the Scotland Neck crew, and game ended thusly.

If the championship series among the teams of the Eastern part of the State does not interfere, New Bern will be seen here on Tuesday to meet the locals at the fair grounds park.

## VIOLATES SCHOOL LAW PARENT FINED

During the present school term Welfare Officer K. T. Futrell has seen given considerable trouble by parents in various parts of the county by their failure to comply with the State laws relative to school attendance among the children. According to Futrell many of the patrons manifest an indifferent air when approached on the subject.

Since the opening of the schools last more than 50 parents have for this neglect been given a hearing before various justices of the peace. In nearly every instance the violator has been forced to pay a fine. In many cases it has been necessary to summons some individuals for second hearing for the same violation.

The most recent case given a hearing was this morning when J. B. Moyer of the Lang's school section of the county was found guilty of the charge of not complying with the State compulsory school attendance law. Justice Tyson imposed a fine of \$10 and advised the defendant that if there was a second defense he would be assessed with the maximum fine in such cases.

## Court Calls "King" Benjamin House of David Head Fraud

GRAND RAPIDS, Mich., April 28.—The House of David colony and Benjamin and Mary Purnell, self styled "King and Queen" and leaders of the cult were characterized as frauds in a written decision today, filed by Judge John Sater.

In his opinion he awards compensation to John and Margaret Hansel for their services while members of the colony.

Purnell and his associates are now under investigation by the authorities of this state. The former fled when the civil suit was instituted and has not been found, despite efforts of officers to locate him. It is believed that he has sought seclusion on an isolated island in Lake Michigan, where former followers declare he went when the federal and state investigation was first started regarding the affairs and moral conduct of the colony.

## GRAND COMMANDER DELIVERS ADDRESS COMMANDERY HERE

John J. Phoenix Here on Annual Visit of Inspection

Bethlehem Commandery No. 29, held a special meeting last night to entertain the grand commander of the Grand Commandery of North Carolina, John J. Phoenix, who is here on his annual visit of inspection. The program was featured by an address by Mr. Phoenix, several short talks by members of the commandery, and the conferring of degrees on three candidates.

The meeting was called at six o'clock, at which time first degree work was put on. At 8:30, a recess was taken and the entire body was invited to the Kitlow Cafeteria where they enjoyed a delightful supper.

Upon the return to the lodge room the final degrees of the Temple were conferred at the conclusion of which the Grand Commander made a short but impressive talk to the commandery which is one of the youngest in the State, congratulating it upon its fine showing made in degree work also for winning the loving cup at the Grand Commandery meeting held in Winston-Salem last year. In conclusion he urged upon the members the importance of attending the Grand Commandery meeting which will be held in Charlotte next month, and stated that he hoped a large delegation would go from the local commandery. After his address, which was both interesting and inspiring, several of the members made short talks along lines pertaining to the present and future work of the commandery.

The meeting was largely attended and each member departed with the determination to make the commandery a greater success by giving to it his encouragement and support.

CAPE TOWN, S. A., April 28.—All but two of the life boats belonging to the Portuguese steamship Mossamedes wrecked several days ago at Cape Frio, are now reported to have been picked up. The Mossamedes carried 230 passengers.

## RALEIGH MAN TRIED FOR HOLDING UP A GREENVILLE CAR

D. B. Ferabee Fined \$100 for Stopping Auto On Highway

Mr. D. B. Ferabee, of Raleigh, who on Tuesday night of this week, on the Washington road, stopped a car in which were Mrs. E. B. Ficklen, Mrs. J. S. Ficklen, of this city, and Mrs. E. W. Myers, Miss Jessie Myers and Mrs. Martin Douglas, of Greensboro, giving them a bad fright, was on yesterday morning given a hearing in Recorder's court, in Washington, and released upon the payment of a fine of \$100 and costs.

The evidence showed that on last Tuesday evening a car, driven by a negro chauffeur, Will Smith, and containing the ladies, who were returning from Washington where they had been attending a reception, was brought to a stop about three miles from Washington, by a car containing two men, and which was standing in such a position that it was impossible for the Greenville car to pass. They were asked to move and in response to the request one of the men, Mr. D. B. Ferabee, jumped from his car to the running board of Mrs. Ficklen's car and began using violent and abusive language to the chauffeur, trying at the same time to remove the key. The ladies, who by this time were nervous and badly frightened, appealed to Mr. Ferabee's traveling companion, Mr. Dechert, also of Raleigh to help them by removing him from the running board, but without avail, as he let their request pass unnoticed. About this time a car going toward Washington approached and Ferabee seeing it coming, jumped into his car and left for Washington.

Mrs. Ficklen, who had taken the number of the men's car gave this to the occupants of the other car with the request that they notify the police of Washington as soon as they arrived there. When the Greenville automobile reached Pictolus the ladies also called the officers and gave them an account of the hold up.

Upon reaching Washington Ferabee and Dechert were arrested, placed in jail and the following morning given a preliminary hearing. It was shown both men were drinking heavily at the time and Dechert was released as he was guilty of nothing but refusing to comply with the ladies' request, while Ferabee was bound over to yesterday's session of recorder's court, at which time he was fined \$100 and costs.

Court officials stated that they pushed the case as an example, showing that ladies can ride on the public roads, of our state, without being inconvenienced or insulted by travelers, and that the law stands ready at all times and under all circumstances to protect the womanhood of the state.

The high school baseball team is not receiving the support it should from the citizens of Greenville. The boys are playing good ball and winning games, but it is impossible for them to win every game, and it should not be expected. Let's go out and support them and encourage them in every way possible.

What difference does it make if the Duke of York has married outside of the realm of royalty? Everybody can't be kings and queens. If that were possible "spades" wouldn't be needed any more and "clubs" would be put away. Because with all their pomp and dignity the royalty couldn't afford to have family rows.

Such meetings as the one held in Greenville Wednesday as relating to the educational system are wonderful and their results are far reaching. Nothing helps a community more than a good school and competent teachers. L. E. C. Brooks, who knows the educational system of this state, perhaps better than any other man, is a splendid speaker and the advice and instructions which he gave the school officials in the three sessions of the meeting, made an indelible impression which cannot be blotted out, but which will be felt in the generation to come. Greenville feels highly honored in having been host to such a splendid delegation of the state's educators.

His many friends throughout Pitt county will regret to learn that Mr. S. B. Underwood, former Superintendent of public instructions for this county, but now Superintendent of Raleigh City Schools, has been forced, on account of his health, to give up his work temporarily. Superintendent Underwood is one of the state's foremost educators and it not only active along educational lines but in all matters pertaining to the best in social and business circles. While in Greenville he was intensely interested in the clubs and churches as well as the schools. His advice and services will not only be missed by Raleigh people but

by his friends throughout the state who wish for him a speedy restoration to health.

## OUR TANGLED FOREIGN POLICY

What are foreign affairs to the American public at large? What is a foreign policy? Do we not differ in foreign affairs according to the visibility of the individual and his distance from the sea shore? Does not our attitude turn partly upon whether one is a native son, a naturalized American, or one of the millions of foreigners within our borders.

Time and again we see foreign questions such as that of Irish independence or Russian recognition injected not only in Congress, but in state legislatures.

It is a paradox, but for a century or more the Indian was treated as a foreign enemy. As the historian has it, the pilgrims first fell on their knees and then on the aborigines. We were fairly consistent and insistent in our "go west" policy regarding the red men. In fact, this Indian mandate may be properly termed our first foreign policy. Horace Greeley said: "Go West young man;" the dough-boy used it in a different sense; the red man got it both ways.

At best there are three weak points to consider in our foreign relations: Our lack of unity; our untrained and ever-changing diplomatic service; and lastly, a weakness inherent in a democracy such as ours—the idea of popular control of an essentially intricate and complex organ of government—an inability to recognize that there comes a point in every government undertaking in the execution of a law, even when the fate of a nation is at stake, when a single mind must cast the final die.

## JUDGE GARY IS PEEVED

Just because the federal government declines to throw down the immigration bars to let cheap foreign labor cut the wages of the American workmen, Judge Gary, of the United States Steel Corporation is peeved with the administration. With all the power and resources at its command the corporation fought the immigration law. For once the astute financier lost a fight. The concern needs common labor and is looking to the south to supply it.


During the war thousands of negroes were enticed to enter its employ with disastrous results. Most of them were summarily dismissed over night and left stranded at the peak of business depression.

Agents of industrial concerns and railroads are now secretly working throughout the south, including Pitt county, repeating promises of a few years ago with limited success. Those who experienced the previous treatment should take part in chasing unlicensed agents out of every section where their presence is known.

Judge Gary and other heads of industrial plants want labor. They do not care under what promises it is obtained. The vital point is—"go get it," let the "fall guys" pay the price.

## AN IDEAL PRINCESS IS GLORIA SWANSON

Star Reverse Reincarnation Theory in New Picture, "My American Wife."

A motion picture actress must of ten reverse, in practice, the theory of reincarnation, says Gloria Swanson, famous Paramount star.

And to prove that it can be done, she dons a bejeweled costume and headdress, steps into a setting representative of the architecture of the ancient race of the Incas in South America and becomes to all appearances an Inca princess of hundreds of years ago.
