Farmer Drowns In River

Thomas Padgett, Seized With Cramps In Water, Loses Life

Thomas Padgett, 28, farmer, living on the farm of R. L. Moore, a few miles from the city was drowned yesterday while swimming in the Tar river.

According to reports Padgett was seized with cramps, and before his outcries for help could be answered, he disappeared beneath the water. After a few hours search the body was recovered.

Padgett leaves a widow and three children. Funeral arrangements have not been completed, it was said today.

He was popular among his neighbors and his death proved a shock to the entire section in which he lived.

He Slays Daughter, Her Friend, Then Fatally Shoots Self

LOUISVILLE, Ky., June 25.—William Zinsmeister, regarded as a desperate character, created havoc among nearly half a hundred persons enjoying themselves at a picnic given by a church club on the banks of the Ohio river, near here, yesterday, by killing his 15 years-old daughter, a girl companion 16 years old and wounding another girl and two youths. A few minutes later, when on the point of being captured he turned a pistol on himself and sent a bullet through his head.

Friends of Zinsmeister say he objected very much to his daughter going with young men and say this might have been the motive for the slaying. He is said to have warned his daughter several times not to go to the picnic.

According to reports Padgett was seized with cramps, and before his outcries for help could be answered, he disappeared beneath the water. After a few hours search the body was recovered.

ABERDEEN, S. D. June 25.—Ten persons were said to have perished and scores of others injured when a tornado laid waste a wide stretch of prosperous farming country for 40 miles in the vicinity of Reeder and Hettinger, late Sunday, according to reports received here today.

Newspaperman of Harding Party Killed, Two Hurt

DENVER, June 25.—Sumner Curtis, of Washington, representative of the Republican national committee accompanying President Harding's party on its Western trip, was killed and three other men were injured seriously when the automobile in which they were making a mountain tour plunged off the road into Bear Creek Canyon, 25 miles from Denver, yesterday. The injured are Donald Craig, manager of the Washington Bureau of the New York Herald, and Thomas Dawson, Colorado state historian and veteran Washington newspaperman.

Thomas French, driver of the car, died on the way to a hospital. The extent of the injuries sustained by Mr. Craig and Mr. Dawson have not yet been learned definitely. Mr. French was a representative of the Great Western Sugar company. An operation was performed immediately at the county hospital in an effort to save Mr. Craig's life. His scalp was severely lacerated and it was feared he had sustained a fractured skull and internal injuries.

Dawson suffered fractured ribs, injuries to his spine, a lacerated foot and possible internal injuries, according to physicians at the hospital.

President Harding telephoned to the hospital to learn the condition of the injured as soon as he received word of the accident. The President expressed deep regret over the tragedy.

FUN MAKING INSPIRED BY RUM DOES NOT HIT HUMOROUS SPOT WITH MAYOR; 24 CASES HEARD

Twenty four defendants were in police court today before Mayor Clark, answering a range of offenses from disorderly conduct, violation of dry laws, assault, petty larceny, gambling, vagrancy to operating business without license.

State Mothers Aid Fund Will Help Rearing Children

RALEIGH, June 25.—Partnership of the state, the county and the mother for the rearing of citizens is the central concerted idea embodied in the \$50,000 appropriated by the General Assembly of 1923 which becomes available July 1, Public Welfare officials state tonight. This fund is to be administered by the state board of charities and public welfare which has prepared application blanks, a sample of which with explanatory letter has been sent to all county superintendents of public welfare, chairmen of boards of county commissioners, and members of county boards of public welfare. The state board has also calculated the pro rata share of this fund available for each county on the basis of the census of 1920.

The fund for mothers' aid, according to the law, is designed to help mothers who are mentally, morally and physically able to rear their own children, but who, without such aid, would be prevented from doing so by reasons of poverty only. Those eligible must have been deprived in some way of their husbands' support. Public welfare officials explain that this aid is based on the assumption that the home is the best place for the rearing of a child, and the mother the best person to do it.

Conquest of Boll Weevil By Air Is U. S. Officials Believe

WASHINGTON, June 24.—Conquest of the boll weevil by the airplane is possible in the opinion of experts of the department of agriculture who, in co-operation with the Army Air service have conducted extensive experiments in the south. "Preliminary studies have shown an official report issued today said, that dust poisons distributed from airplanes can be effectively strewn over cotton plants as far as worm control is concerned. Whether such dusting would be effective for boll weevil control is still problematical, the report said, adding, however, that experts were optimistic in the belief that with improvements in the dust feeding equipment boll weevil control can be secured.

"The time may not be distant," said the report, "when cotton planters in this county will band together and from a little air service of their own to combat their arch-enemy—the cotton boll weevil." While individual cotton planters would not be able to adopt the method on account of the large expense, it was added, the plan could no doubt be satisfactorily worked out on a co-operative basis among a sufficient number of cotton planters in various communities so that their share of the expense would be nominal.

More Liquor Laden Boats In U. S. Ports

NEW YORK, June 25.—Four trans-Atlantic passenger liners, two British, one French and one Italian, arrived at Quarantine today with large quantities of liquor under seal.

The manifest of the White Star liner Cedric from Liverpool showed the following wet stock: 7,931 bottles of ale and stout; 1,156 gallons of wine; 60 gallons of spirits, and 6 516 gallons of liquors and cordials.

The Cunard liner Caronia's sealed supply consisted of 3,116 bottles of ale and stout; 48 gallons of wine; 47 gallons of spirits, and her medical stores were listed as 23 gallons of wine and four gallons of spirits.

The French liner Providence, from Marseilles, brought 2,694 bottles of wine for passengers and 70 bottles for the crew; 127 bottles of cognac and rum; 90 bottles of whiskey and gin; 383 bottles of champagne; 214 bottles of liquors and 30 barrels of beer.

The supply of the Italian liner Conte Verdi, making her first visit to New York, was not stated on the manifest, but it was said all wines and liquors were locked in charge of the ship's surgeon.

LONDON, June 25.—No subject in recent days has occupied attention of the British newspapers or given the public a better topic for animated discussion than the liquor seizures in New York.

The London newspapers seldom before have printed so many dispatches under American date lines, and the greater majority of these relate to liquor confiscations. Suggests Assured Allowances For County Doctors

SAN FRANCISCO, June 25.—The American Medical Association has a membership of 88,519 physicians out of the approximately 150,000 in the United States. Dr. Olin West, secretary of the association, reported to the house of delegates meeting.

GOVERNMENT WILL ENFORCE DRY LAWS, HARDING DECLARES, TO CONTINUE VIGOROUS FIGHT

DENVER, June 25.—President Harding served notice in an address here today that the federal government was determined to enforce the prohibition law even should the burden of enforcement continue to be increasingly thrown upon it by the states.

Moreover, the executive voiced the conviction not only that the prohibition amendment will not be repealed, but that whatever changes may be made in the Volstead Act "will represent the sincere purpose of effective enforcement, rather than moderation of the general policy."

Striking straight out at those who violate the law, the President said the issue is fast coming to be recognized as one between the "wets" and "drys," but as one of whether the laws of "this country can be and will be enforced."

"So far as the federal government is concerned," he said, "I am very sure also, so far as concerns the very great majority of the state governments and the local governments, it will be enforced. A gratifying, amazing progress has been made in the last few years toward better enforcement."

While Mr. Harding made no direct reference to the situation in New York state, he did say that "the spectacle" of a state nullifying its own authority, and asking the national government to take over an important part of its powers, is new. He added that "when the implications of

Shift Responsibility

The President disclosed that a good deal of testimony is reaching Washington that some states having prohibition enforcement codes and even some which successfully enforced "dry" laws before national prohibition are "disposed to abdicate their own police authority in this matter and to turn over the burden of prohibition enforcement to the federal authorities."

"Doubtless," he said, "this is largely due to a misconceived notion, too, widely entertained, that the federal government has actually taken over the real responsibility. The fact is quite the contrary. The federal government is not equipped with the instrumentalities to make enforcement locally effective. It does not maintain either a police or a judicial establishment adequate to or designed for such a task. If the burden of enforcement shall continue to be increasingly thrown upon the Federal government, it will be necessary, at large expense, to create a federal police authority which in time will inevitably come to be regarded as an intrusion upon and interference with the right of local authority to manage his local concern."

One of the main functions and prerogatives of the association is the fixing of dates for market openings throughout the cotton growing belt. It has been suggested that the Greenville market be opened Sept. 4. That date, however, is not acceptable in some quarters, and the Greenville group will make every effort to obtain the sanction of the association to decide on Aug. 21 as the opening date here.

Tobacco men say that the latter date would prove generally more desirable than early September.

DISSENSION IN RANKS OF TOBACCO CO-OPS

Despite the best efforts of executives and supporters of the Cooperative Tobacco association to explain away dissension within its ranks, reports covering wide territory indicate that a large number of erstwhile advocates of the movement are through.

Discord and repudiation is not only confined to a large group in North Carolina, but extends to the burley growers of Kentucky, also Tennessee. Wisconsin apparently has had enough of the cooperative plan of selling and marketing, and Connecticut has followed suit.

Here in Pitt County a great many growers do not hesitate to express their complete dissatisfaction and disgust with the methods employed by the association. A number regard their contracts as a millstone, rather than a benefit, and would gladly welcome release. It is an open secret that the association has rough sledding ahead in this county. It is true, that a small group of growers met the other day and pledged their faith in the movement. However, this is not construed as indicative of the real sentiment of the rank and file of farmers of this county.

Courts have been resorted to as last means to enforce some of the obligations of the contract between farmers and the association. Decisions in some instances have favored the organization. But any cooperative plan conceived to benefit collective interests that requires legal enforcement is bound to lose influence and break down the morale among growers who are supposed to supply the motive power for the existence of such an organization.

Eliminate confidence and enthusiasm in any project and it will inevitably go to pieces on the rocks.

Pitt County farmers give a number of objections to the methods of the association, any one of which appears to justify their attitude. Regardless of what public sentiment, either one way or the other may be concerning the association, there is no denying that the movement has not proved out in every quarter just what hundreds of its advocates

expected. The policies of some of the officials of the association does not rest well with many of its former boosters. The manner in which several warehouse managers have been treated, in notable instances summarily dismissed, is not looked upon as keeping the faith, while payment plan for the product is not to the entire satisfaction of numerous groups. Whatever may be the outlook for the association in other states, it is certainly NOT ENCOURAGING IN PITT COUNTY.

The Reflector can be depended upon to stand squarely behind and fight for the advancement of the farming interests. However, it does not believe, and will not endorse, any movement that ultimately means the exploitation of agriculturists for the benefit of a group of swivel chair promoters and quasi executives.

THE LAW OF INFLUENCE

Over in Japan, in one of the great Buddhist temples, there is a curious carving representing three monkeys who silently for centuries have been preaching to the frequenters of the temple a very direct and pertinent message. One monkey has his hands over his eyes, another has his hands held over his mouth, while the third has his hands across his ears. Under the carving is the inscription: "See no evil, speak no evil, hear no evil."

What a wonderful world this might be if all Christian lands should heed this admonition! Surely there is something splendid and worth while in this exhortation from one of the non-Christian religions of the old world!

But suppose that in place of this strictly negative injunction we should substitute a positive determination to "See the good, speak what is good, listen to the good." What a transformation would soon be wrought in this old world of ours!

Benjamin Franklin once said that "if a man loved learning he would soon become learned."

This is the law of influence. We become in time like that which we admire. Unconsciously and gradually we are transformed into the likeness of the ideal which we have set before ourselves.

This was what happened to the disciples of Jesus. By constant association with their Master they unconsciously caught the contagion of His spirit. After His death when two of them were apprehended by the authorities for preaching strange doctrines, we are told that when "they saw the boldness of Peter and John and perceived that they were unlearned and ignorant of men, they marveled; and they took knowledge of them that had been with Jesus."

We are all more or less creatures of imitation. The important thing is to select the right kind of a life after which to pattern our lives. This was what St. Paul did.

Selecting the life of Jesus as the great goal of his admiration, he made the solemn determination: "That one thing I do, forgetting the things which are behind and reaching forth to those things which are before, I press toward the mark for the prize of the high calling of God in Christ Jesus."

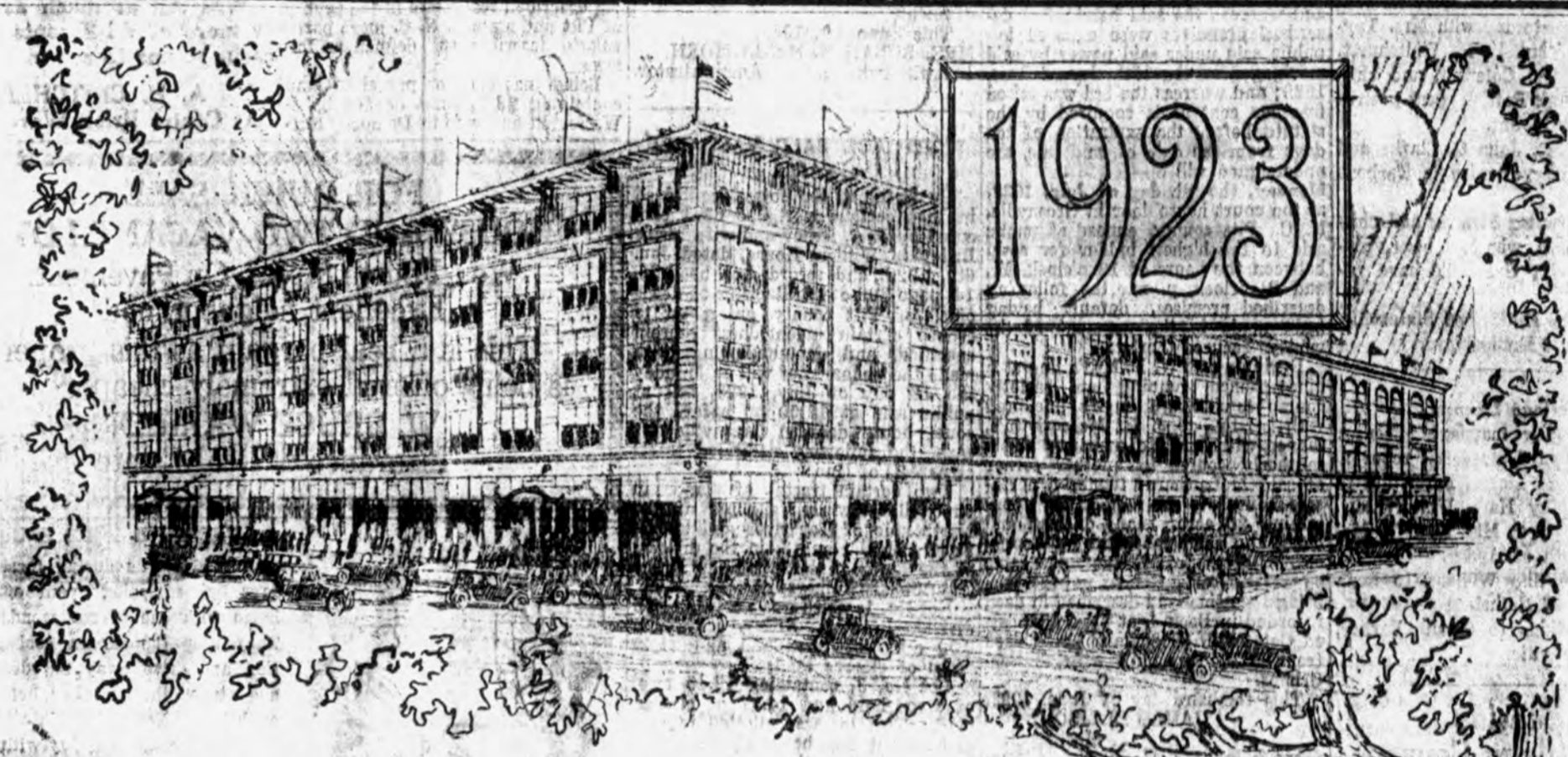

Wimbledon Passes As Supreme Test In World Tennis

WIMBLEDON, Eng. — England, upon whose historic turf the "world's" tennis championships will be held this year for the last time, beginning June 25, has captured but a small share of the laurels gathered in the decade that these title events have been here. America and Australasia have virtually monopolized the honors in men's events, while the scintillating performances of Miss Suzanne Lenglen have carried France's tricolor to victory on a large proportion of the women's championships.

The Wimbledon events have carried the "world's" title designation since 1913, when it was conferred in perpetuity by the International Lawn Tennis Association. Objection on the part of the United States to this award, however, and the fact that frequently the lists failed to include many of the leading stars, combined this year to cause the abandonment of the events as they are now conducted, effective in 1924. One of the first results of this move was the acceptance by the United States of an invitation to become affiliated with the international federation.

British Commander Writes In Praise of American Troops

BOSTON.—The saga of the first volunteer troops of the United States to arrive at the front in France—a regiment of engineers recruited from the operating staffs of the New England railroads—has just been written. It is entitled "A History of the 14th Engineers, United States Army, from May, 1917, to May, 1919," and dedicated "To the Memory of those members of the regiment who died in France."

Incorporated in the volume is a tribute to these 200 railway men of New England by General Aylmer Haldane, who commanded the 6th British Corps while the 14th Engineers were attached to that body from August, 1917, to May, 1918. The British referred to their allies affectionately as "The 14th American E. E.'s (Royal Engineers)."

"At the time the 14th Engineers came under my command our failure to recognize earlier the urgent need for light railways was being repaired, but the personnel necessary to operate them was lacking," General Haldane writes. "The arrival, however, of our comrades from across the Atlantic speedily changed the aspect of affairs in this respect, and soon in many directions trains were carrying men, supplies and material from the railroad at Boisleux-au-mont to the vicinity of the forward trenches."

Seek to Unionize Steel Mills.

CHICAGO, June 23.—Twenty-five representatives of labor organizations meeting here started a movement to organize workers in the steel mills. Samuel Gompers, President of the American Federation of Labor, pledged the support of organized labor to the movement. "The late action of the steel manufacturers in deciding to continue the twelve-hour day leaves the workers no hope for relief except through organization," Mr. Gompers said.

Marine Commandant Will Address Legion

ROCKY MOUNT, June 23.—Major General John A. LeJeune, commandant of the United States Marine Corps, has accepted an invitation to address the annual convention of the North Carolina Department of the American Legion here on September 12. The convention will be held on September 12 and 13.

General Hine, director of the Veterans Bureau, is expected to attend the convention and deliver one of the principal addresses September 13.

Wins Essay Medal.

HICKORY, June 25.—Miss Louise Cline, of the senior class of the Hickory High School, has been awarded the medal offered by the Abel A. Shuford chapter United Daughters of the Confederacy, for the best essay on General Robert E. Lee.

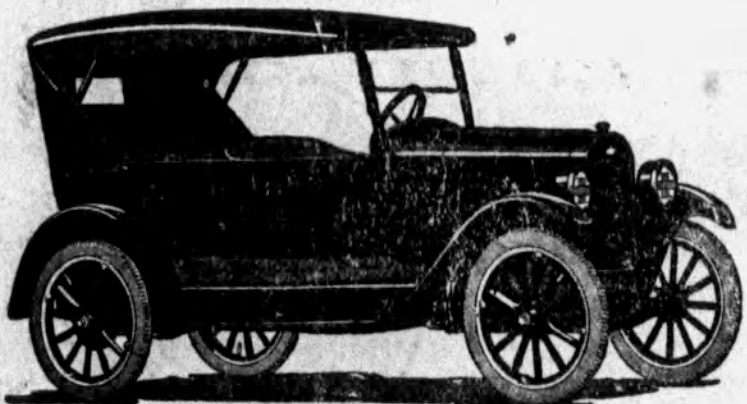

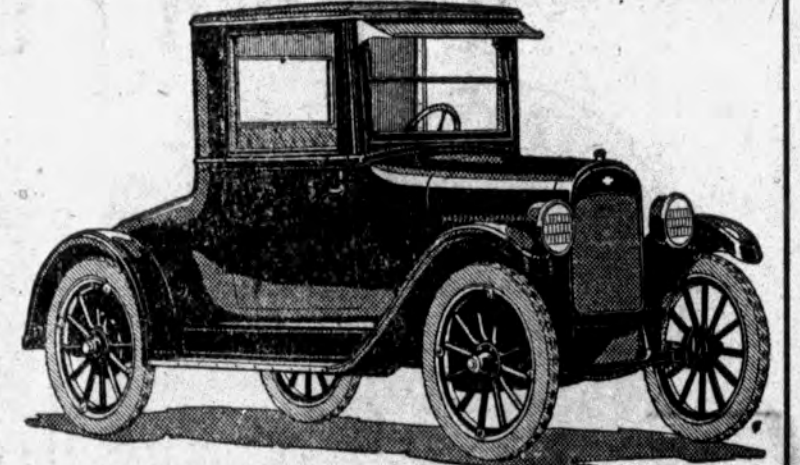
