State Progress Is Extolled By Bankers' Group

"I have visited every state in the Union but three, and I can unhesitatingly say that without exception North Carolina is leading in constructive development," L. B. Gould, New York banker, told a representative group of Greenville business men at the Country Club, last night.

The party came here at the invitation of the Chamber of Commerce. They were taken for an automobile trip yesterday around the city and other county points. An old fashioned barbecue and brunswick stew supper at the club brought the visit to a close.

H. A. White, president of the Country Club, made a happy, informal speech of welcome. It was the consensus of opinion that the trip of the financiers will do much to dispell erroneous impression said to exist of North Carolina as a state of backwardness in the large centers.

The bankers came to the state to get first hand knowledge following an urgent invitation from the JOINT STOCK LAND BANK, at Durham. Despite the brief time spent in the state, the industrial and agricultural sections were both visited.

Gould stressing multiple advantages of Pitt county, said that persons of the north who are going to Europe and the west on vacation trips, should be educated to the value of coming here and see a country that was startling in its capacity for development. "Profoundly moved," was the way W. T. Reid, expressed his appreciation of what he had seen.

CO-OPERATIVE EXECUTIVE SAYS FEW BLUNDERS HAVE BEEN MADE BY THAT BODY

G. A. Norwood, president of the Tri-State Tobacco Co-Operative association, addressing a meeting of less than 200 Pitt county members, non-members and others drawn by curiosity in the court house yesterday, declared that the association had blundered in handling some of the angles attached to the business of marketing. He explained this, was only natural and true of any large commercial enterprise. He fervently urged members to stick to "the cause," and stressed the point that more money was paid to North Carolina tobacco growers last year in the two payments, than if the association had not been in existence.

All of the great tobacco manufacturers are supporting the association, he said, with the exception of the Imperial. This concern, he asserted, was not inclined to do business with any powerful organization. This reference was construed to mean that the association was too gigantic for the British concern to deal with.

Called "Contract Breakers."

Pitt county farmers who have filed suits against the association were characterized by J. Y. Joyner, as "contract breaker." He said the plan of the association was founded upon the principles of economic freedom and justice. He repeated the stock worn spellbinding declaration that the farmers were the creators of all world wealth. He cautioned the gathering to support the movement. Joyner said peaceful means was preferred to handle the product of growers. If that course failed, then legal methods would be employed. He asserted that the middlemen and other factors stood between the growers and consumers, standing at either end of a toll bridge, and its the intention and purpose of the organization to tear that toll bridge down, he shouted. Greenville, Rocky Mount, Kinston and Danville, Va., were mentioned as the only places where real opposition against the association.

"Stick," He Pleads. In an eloquent outburst Joyner admonished audience to stick together, as God like real men "hates cowards and quitters." Supplementing his remarks, Norwood declared that final payment

would be made to farmers on last year's crop when it is sold at "our price." He did not venture to say when this would be, but added, that it was not the purpose to dump it on the market at a sacrifice. "We have whipped practically every big tobacco interest, and we will whip the others before we are through," he said. R. J. Work, Rocky Mount, presided.

Humphries in Fulton superior court. A temporary restraining order in the meantime enjoins Imperial Wizard Evans and other officers of the Klan from drawing checks on Klan bank accounts and from otherwise handling business of the order.

FOUR DEAD IN EXPLOSION ON NAVAL VESSEL

NEWPORT, R. I., June 30.—In an explosion on the United States Destroyer Williamson at sea, four were killed, four injured, three probably fatally today. Chaplin Lincoln, New Bern, N. C., third class fireman is among the dead. The others are: Abermather Millican, firemen third class, Fairfield, Ill.; Clifford Latch, third class fireman, Lebanon, Pa.; H. "The executive committee desires to hold these meetings, as soon after the schools open as is convenient," said Miss Kelly, "in order that teachers may attend and get information and inspiration from the meeting early in the teaching year."

Aug. 21 Fixed Open Tobacco Market Here

The Greenville tobacco market will open Aug. 21. That date was definitely fixed late last night at a meeting of the Tobacco Association of the United States at Asheville.

E. B. Ficklen, Greenville tobaccoconist, was named a member of the board of governors. Considerable discussion between warehousemen and buyers followed before a decisive schedule of opening dates covering belts was reached. Under the operation of the schedule auction sales in the bright tobacco districts will begin Aug. 1, in South Carolina; Aug. 2, Georgia; in Eastern North Carolina, Aug. 21, and Sept. 25, in the belt including Winston-Salem, Durham and Danville, Va.

B. B. Sugg, F. D. Foxhall, W. Z. Morton and J. F. Brinkley, Greenville warehousemen attended the session of the association, and worked hard to impress upon the organization the claims of Eastern Carolina for opening of the market in this territory Aug. 21. There was considerable talk of fixing Aug. 28, as the time of opening on this market. According to advices from Asheville the association was convinced that the argu-

ments offered by the local delegation justified granting the earlier opening date. E. B. Ficklen, also took a prominent part in the deliberations of the meeting.

TRIED TO BALANCE CAPITAL, LABOR SCALES, HARDING SAYS

HELENA, MONT., June 30.—President Harding declared here that those who imagined his administration would sympathize with projects for "the deflation of labor and the overthrow of labor organizations" have come "to realize their error."

"Nothing has been farther from the purpose of the present administration," he said in the tenth prepared address of his western trip, an address devoted to the discussion of labor, social justice and women in industry. The President said what his administration had "earnestly sought" is to lessen the occasion for conflict between capital and labor and to bring to both a realization of the obligation they owe "to the great public interest."

Quite frankly the executive stated that he knew there were some elements which had hoped for "a great and decisive conflict" between organized employers and organized labor, and that these elements were not all on either side of the "imaginary dividing line" between capital and labor. "On the capital side of the line," he said, "were those who hoped that

the administration would lend itself to their program of breaking down organized labor and sending it back to the era of individual bargaining for the individual job. On the labor side of the line were those who hoped, by exorbitant demands and an attitude of uncompromising insistence, to force the nationalization of some of our most important industries and services. Between these two extreme groups we have tried to hold the scales even.

"How well have we succeeded? At least, we have saved the nation from the extremists of both sides. I believe our policy, and its results, have reflected the sound judgment of the overwhelming majority of the American people. I believe this people is firmly and finally committed to the ideal of preserving the fullest rights of private initiative and private enterprise, together with the right of organization on both sides of the line between capital and labor, and always consistent with the right of the public to be served efficiently and at a reasonable cost.

NEW GRADE CROSSING LAW

The new grade crossing law becomes effective in this state tomorrow, July 1. This law requires that no person operating any motor vehicle upon a public road shall cross, or attempt to cross, any railroad or interurban track intersecting the road at grade, excepting only electric railroad tracks in a city, town or village, and other tracks at which there is a gate or watchman at the crossing.

Railroad companies have placed new signs required by the law on both sides of each public road grade crossing in Pitt County.

The new signs consist of a white board 40 by 50 inches, 10 feet from the ground, on which is painted the words:

"N. C. LAW, STOP!"

There is also painted on these boards a cross, to attract the attention of approaching motorists. The signs are located 100 feet from the nearest track.

It is hoped that a sound public sentiment will support this new law and its observance. Accidents to motor vehicles at railroad grade

crossings have increased in the country at large nearly 50 per cent since 1917, according to figures compiled by the interstate commerce commission.

In 1917 there was 2,076 accidents in which 1,083 persons were killed and 3,000 injured. In 1921 there were 2,940 accidents, in which 1,259 persons were killed and 3,976 injured. In the first nine months of 1922, 2,221 accidents have been reported, in which 797 people were killed and 3,011 were injured. In the week ending June 2, 1923, there were 95 fatal accidents of this character, responsible for the death of 55 persons.

ROCKEFELLER'S GIFT TO INSULIN

Through the gift of \$150,000 by John D. Rockefeller, Jr., to 15 hospitals in the United States and Canada the use of insulin in the treatment of diabetes is assured in a far larger number of cases than has yet been possible. It is a boon equally to the medical profession and the large class of patients who could not afford this new and costly scientific discovery. For necessarily the supply has been limited and the opportunities for benefitting by the Banting method have been restricted to relatively few cases.

That a final cure for diabetes had been found in the Toronto laboratory was an early overstatement, due no doubt, to excess of enthusiasm among those spreading the news of this triumph of science.

Dr. Simon Flexer, whose word may be taken as conclusive, calls insulin one of the great discoveries of the age. But efficiency is not to be doubted, its use must be supplemented by other means of treatment, such as special diet. The fight for normal health is not won merely by the injection of the serum, but it can be assured with its aid under rules of rigorous self-restraint in the choice of proper foods.

Insulin will not relieve the diabetic patient of the necessity of standing guard over himself, but it goes to the aid of nature in supplying to the body what nature fails adequately to supply. Already it has revolutionized the treatment of a disease that had resisted the attacks of science, and made the saving of life a daily achievement where previously doubtful.

The recovery of former Secretary of State Robert Lansing, just reported, is a notable instance of the value of insulin.

10 CENTS AND SOME MILLION VOTES

Everyone will hope that the fair promises extended by President Harding to the farmers of Kansas are borne out by future facts, and that prosperity and contentment return to the agricultural classes because unless they do there can be neither full nor real prosperity and contentment among the other classes of the people. The burden of blame for the depression that has been suffered by the agricultural interests for several years, the president both ungraciously and unjustly tried to shift to the shoulders of the previous administration, he seeming to ignore the fact that his political party has had control of the legislative department of the government for over four years, and of both legislative and executive departments for over two years. But that he recognizes the republican party has had ample time to bring relief is evident in the claims he set up for legislation intended to benefit the farmers of the nation that has been enacted by republicans.

He recited the various bits of legislation and executive direction from the laws to prevent gambling in agricultural futures, to the tariff, to the revival of the War Finance Corporation and to the recently enacted agricultural credit bills as proofs of the fact that the republicans had both protected the home markets and secured foreign markets for the American farmers. But that the farmer himself still remains in ignorance of all these benefits was attested to by one Chester O'Neil, a practical wheat farmer, whose views the president solicited after his speech. Farmer O'Neil said the wheat growers made no money last year and would be equally devoid of profit this year. That practical wheat grower took a pencil and figured that it costs the farmer \$15.20 to grow an acre of wheat and that he received \$15.30 for the product or a profit of 10 cents an acre. He added: "And the ten cents won't feed us."

If we mistake not those ten cents to feed and clothe the farmer and his family have had a lot to do with the shaping of political affairs in the western states where the people have not yet felt the benefits from the protection to the home markets and the restoration of the foreign markets about which the president said he took so much pride. The

same ten cents have been an actual fact while the restored prosperity has been largely a pleasant vision of spread eagle oratory.

MORE WONDERS FOR WIRELESS

On the occasion of a meeting the other day in Paris of government officials, radio enthusiasts and others to pay tribute to his wireless achievements, Prof. Eduoard Branly announced that he had been able to transfer by wireless not only a luminous point, but also a circle of light. This convinced him that the time is coming when the sight as well as the voice can be carried to long distances on the waves of ether. He said experiments in both France and Germany had established that high frequency oscillations of ether waves carry sound vibrations, and that the same principle could be applied to other vibrations which operate on the physical senses.

While the projection of sight may seem a different undertaking, it can not be regarded as an impossible one. Much easier will the task of projecting heat waves through long distances seem, and is there any one who can doubt that the wireless transmission of heat will be one of the commonplaces of the future? What wonders may then be accomplished as much for the utility as for comfort of men! No section of the world need be any more warm nor any more cold than would be necessary to nourish particular vegetation or the people of that section. And there should be no fear of sudden changes in temperature destroying agricultural products when the proper amount of heat could be regulated.

With wireless sight and wireless heat transmission in being, the whole world will become little more than one big family, and men can live in each others' yards, no matter how many hundreds or how many thousands of miles they may be separated on the world's surface. Every day we are learning how very tiny this globe of ours is, for all its great stretches of undeveloped territory, and every day we are being taught how very careless we are of its natural opportunities.

F. J. FORBES, TELLS KIWANIS CLUB BASIS OF BANK CREDITS

The outstanding feature of the meeting of the Kiwanis Club last night was an address on the basis on bank credit by F. J. Forbes, cashier of the National Bank of Greenville. Forbes discussed the question from various angles and brought out numerous illuminating facts.

Bert James former president of the club, recounted many of the incidents of his trip to the international meeting of Kiwanis recently held in Atlanta, which he attended as a delegate from here. One of the principal things that made a deep impression, he declared, was the importance of character building as one of the main objectives of the body.

In the absence of President Fitzgerald, Vice-President J. B. Harding, presided. James was in charge of the program. Following the usual supper entertainment features were enjoyed.

The address of Forbes, in part follows:

By F. J. FORBES

Cashier for the National Bank.
The purpose of my talk is to give you certain interesting facts about the basis of bank credit. You will recognize that the basis of all bank credit is as well as all business credit is character.

In banking, the word "credit" has various meanings. We say banks deal in credit. For example, when you deposit money, your account receives credit for the amount deposited, and the bank continues to owe you until you withdraw your money.

Again, in business language, the bank extends "a line of credit" to a customer by agreeing to lend him reasonable amounts whenever he needs money. When you borrow money on your note at the bank you are granted credit because of your promise to repay. When you endorse the note of a friend who borrows money from the bank, the loan is made upon the joint credit of both. If your friend does not pay the note when due, you are required to pay it.

Credits in All Business.

When a railroad, a manufacturing concern, a town, or a government issues bonds, it uses its credit. Those who buy the bonds rely for payment of their money, when the bonds mature, upon the maker's credit standing and promise to pay. When a merchant buys goods without paying cash at the time of purchase, credit is granted him. When goods are sold over the counter to a customer who carries a charge account, credit is granted. In both cases, credit is granted in the belief that later on the bills will be paid. Thus credit enters into all business and particularly into the business of banking. Without credit, our present day business system could not exist.

Credit implies confidence. Credit transactions are possible only because people have confidence in each other, and confidence can exist only where good character exists. Without good character, there is little chance of success in any business undertaking. The business man of strong character has fixed habits of honesty, industry and thrift. Like Longfellow's "Village Blacksmith," he can "look the whole world in the face." He has nothing to conceal. When he needs the help of the bank, he presents to the banker all the facts concerning

New Premier England Had Rapid Political Rise, Says One Report

LONDON.—There is a common impression that the Rt. Hon. Stanley Baldwin is a rather young man to attain the Premiership of Great Britain, but this is due to the few years service he has rendered in politics before attaining the highest position any subject of the king can hold. The living ex-Premiers reached the distinguished post at an earlier age than Mr. Baldwin, who is 56. Lord Roseberry was only 47 when he succeeded Gladstone. Lloyd George became Prime Minister at 53, Lord Balfour at 54, and H. H. Asquith at 56. Bonar Law was 64 when he took the task last October.

the financial situation and, because he deals openly and frankly, he wins the banker's confidence, and sound advice as to the right course to pursue.

Bankers are in constant touch with the credit standing of local business concerns, and have much to do with their general reputation. Every successful business man looks upon his credit standing at the bank as a most valuable asset, and he maintains it by square dealing. He knows that the bank can help him in many ways to establish and maintain a good business and credit reputation. There is truth in the old adage: "Honesty is the best policy." It pays to be honest. Doubtless there are a few men who are honest in business largely because it does pay, but most men are successful in their business and in their lives, because their characters are built on the policy of honesty industry.

Must Pay Obligations.

A man must pay what he owes. If he refuses to pay his debts, it soon becomes known that he is not of good character, and is not worthy of confidence. Those from whom he would buy, refuse to trust him. The bank declines to grant him credit. Then comes business failure and a long uphill fight to get on his feet again and to live down the mistakes and dishonor of the past. The habit of honesty should be formed early in life, and adhered to under every circumstance. Make it your fixed purpose never to contract a debt that you are not reasonably sure of being able to pay.

Honesty is not the only factor involved in credit. One may be extremely careful to keep promises or agreements, and yet may not deserve credit at the bank. Here for instance, is Mr. Jones, a man of forty, of excellent morals, who has enjoyed a fair income for many years, and who now sees an opportunity to purchase a business for himself. He requires financial assistance. He calls on a banker, who has known him for a long time, and asks how he may obtain the necessary credit. The banker inquires as to the nature of the business, what the cost will be to purchase it, and what Mr. Jones can command in ready money, or other resources. The banker learns that Mr. Jones, at the age of forty, has no money, or property of his own. It is clear to the banker that Mr. Jones lacks the ability to manage wisely his affairs. He has not had enough determination and strength of character to save money. He has not learned to adopt his expenses to his income, and so has not yet proved that he could make financial progress, even under more favorable circumstances. Moreover, it is usually true that, if men do not invest some of their own money, that is, have an interest in the business they take up, they lack incentive and become easily discouraged. The business lags and eventually fails, in which case, those who have provided the capital for it lose their investment. The banker knows that it would not be wise for anyone to assume such a financial risk, and Mr. Jones probably finds that the bank can do nothing for him. He must give up his opportunity to some one else who has saved money.

Rifle Association Arranges Tryouts For World Match

NEW YORK.—Preliminary matches for the selection of teams to represent the United States in the international championship events at Camp Perry, O., beginning in September, have been arranged in all parts of the country by the National Rifle Association. The matches at Camp Perry will mark the first international championship shoot in this country since 1913.

The Swiss team, one of the greatest in the world, is coming to the United States in an effort to recapture the Argentine trophy, emblematic of the world team championship, which it lost to the American team in 1921 and failed to retake in 1922.

Following the preliminary small bore matches now in progress, regional try-outs will be held throughout the country under auspices of the N. R. A. from August 1 to 15. These tryouts will be over the regulation international course and riflemen will be permitted to use any make or bore of rifle, provided no telescopic sights are used. Winners of these events will be sent to Camp Perry for another elimination contest from which a team will be selected to meet the invaders on September 18 and 19.

Refused to Vaccinate, Farmer Loses His Hogs

Dunn.—Due to the prevalence of hog cholera in Harnett county, county agent, H. A. Edge decided to put on a campaign to vaccinate the hogs of the county and called on Dr. F. D. Owen who has charge of this work for the State College and department of Agriculture, to help him out. The matter was given much publicity and the farmers were urged to list their hogs with the agent. A great number took advantage of the event and had their hogs immunized from the disease by the double treatment given by Dr. Owen. About 1,000 were treated.

Now it costs about 35 cents to \$1.25 to vaccinate an animal, depending on its size but one good hog owner decided that he wouldn't go to that useless expense. About a week after the treatment had been administered to the 1,000 hogs, cholera broke out on the farm of the man who refused to have the work done. He called for help. He went posthaste

for the county agent, and Edge being a conscientious sort of fellow wanted to help his farmer friend out. He used the serum alone treatment and vaccinated the six fine hogs but some of them were already sick and Dr. Owens reports six fine shots were made only two of the six will be saved.

Largest Solar Cameras To Photograph Eclipse

PITTSBURGH.—In the hope of determining whether there is motion within the corona during an eclipse of the sun, a party of American scientists, under the direction of Dr. John A. Miller, of Swarthmore College, is preparing to conduct a series of important experiments from the top of a high mountain in Central Mexico next September.

A year or more has been required to complete the arrangements, and the actual working time of the scientists will be only 189 seconds, the duration of the eclipse. If the day should be cloudy, all the labor and expense of preparation will have gone for naught.
