DANGER FEARED IN RUM TANGLE

Admiral Fiske, Says U. S. Is Drifting Toward War By Action

NEW YORK, July 2.—Through the attempted enforcement of the national prohibition laws on foreign ships Rear-Admiral Bradley A. Fiske, retired, believes that the United States is drifting toward war. He advocated a conference of 100 of America's leading citizens to devise some means whereby the friction caused between this and foreign governments could be removed. Dry Leader in Bad. New York, July 2.—District Attorney Banton whose office dropped investigation of the charges against Superintendent Anderson of the saloon league of this state has renewed his investigations, it was announced today. Banton explained that he had obtained new evidence against Anderson and would place it before the grand jury and ask his indictment on a grand larceny charge.

HOLD MAN WHO SLEW POLICE - CAPTOR



John L. Whitfield, negro desperado, arrested in Detroit, Michigan, after several sensational escapes from other police, has been sent to Cleveland, O., to face trial for the murder of a policeman who had arrested him. While riding to the police station in Whitfield's automobile the negro killed the policeman, burned his body and buried his remains. On his subsequent flight he took with him Marie Price, 14-year-old white girl. Lieutenant Charles O. Nevel, of the Cleveland police force, furnished the clues which led to Whitfield's arrest.

FRENCH MOVE TO OCCUPY KRUPP PLANT IN ESSEN

BERLIN, July 2.—The Krupp plant was partially occupied today, according to an Essen dispatch and work has ceased in those departments effected.

So far as is known in German quarters the sections occupied comprise only the foundries, boiler works, electric plant, locomotive and car construction departments.

It is not known whether the occupation is temporary for the purpose of making reparation, or whether it is to be continued indefinitely.

Fire Destroys Building After Safe Is Blown

Will Command Giant Airship ZR-3

HIGH POINT, July 2.—Fire believed to have been started by robbers after blowing the safe in the Effrid department store here early today, destroyed the building. The loss is roughly estimated at \$60,000. The flames gained rapid headway and for a time adjoining properties were threatened.

According to the store manager between \$1500 and \$2000 was placed in the safe Saturday night, but when an examination was made today the money was missing. The explosion attracted the attention of the police. When firemen arrived the structure was in a mass of flames.

It is believed that the robbery and fire is the result of amateurs. Experienced safe crackers, police explain, always take precaution to prevent loud explosions following their work. Color that the job was the result of amateur crooks is given by the fact that seasoned safe blowers do not use explosives but employ the easier and safer method of acetylene torch.

There is no clue to the identity of the burglars.

Will Not Enforce Auto License Law For Next 10 Days

RALEIGH, July 2.—More than two million dollars has been received in automobile license up to July 1 it was announced today. This is twice as much as paid last year and 113,000 licenses have been issued.

State officials have made informal requests of sheriffs and other peace officers not to enforce the rigid law concerning licenses until the department has a chance to catch up in its work.

Every inspector has been called in to help out in filling the record book of applicants for licenses.

Industrial Activity Business Progress

NEW YORK, July 2.—Weakness in the chief speculative markets in the face of continued evidences of a rate of industrial activity was the feature of the past week in finance and business. Speculative sentiment was decidedly uncertain. Selling, which attracted most attention in stocks, also was sympathetically in evidence in cotton and wheat. On extreme reactions good buying appeared, but taken as a whole, the markets closed distinctly lower.

A certain amount of emphasis was given to a switch a bullish to bearish position by a well-known statistical agency. It was considered typical of the psychology of the moment, however, that a market which had shown itself sensitive to extravagant rumors of the past few weeks should be sensitive to an influence of this kind.

Flogging Prisoners Practice of Ancient Times, She Asserts

GREENSBORO, July 2.—"If we say that in North Carolina we cannot control prisoners without beating them we are admitting either that our prisoners are worse than those in other states or that we handle them less intelligently," Mrs. Kate Burr John, son, commissioner of public welfare, told members of the Men's Bible classes of Greensboro today in a mass meeting at Guilford county court house to consider prison conditions in this state.

Vance, Lee, Moore, Allghany, Irrell and Columbus were cited by Mrs. Johnson as conditions having honor among men which there is no use of the lash and where prisoners often are worked without guards. The commissioner also mentioned the state prison camp referred to in the report of Superintendent George Ross Pout to the governor where, according to Mr. Pout, there had been no flogging in many months.

"Flogging long since has been abolished as a part of prison discipline by many of the enlightened nations of the world," she said.

Sees Danger Ahead For Old Parties In Ford Candidacy

NEW YORK, July 2.—Henry Ford and an independent party will cause both old parties anxiety, Norman E. Mack, former chairman of the national democratic committee said here today. "From indications," he continued "the republicans and democrats will select candidates from their own ranks. Mr. Ford is a wonderful man and has a good following, and is more in line with the democratic party than the republican. I look on him as a progressive man, and as a third party candidate will make both old parties

One of Rowan Banks Closed, Will Roepen

SALISBURY, July 2.—Plans for the reopening of the Bank of Rockwell, at Rockwell, one of the Rowan banks which closed its doors following the closing of the Peoples National Bank of Salisbury, have about been completed and it is expected that the institution will throw its doors open for business week. This action is awaiting authority by the bank examiner from the state corporation commission, which must first be secured before business can be resumed.

History of Cotton To Be Shown in Exchange Museum

One of the most novel museums in the world will be thrown open to the trade and visitors when the New York Cotton Exchange takes possession of its new home at Wilkiam and Beaver streets the latter part of this month. The museum, which will be the only one of its kind in existence, will visualize the history of cotton raising and the uses to which it has been put from the days of the Pharaohs down to the present time.

Located on the twentieth floor of the most modern exchange building in the country, the cotton museum will contain exhibits depicting the transformation of the bloom of the cotton plant into the innumerable products which have made cotton one of the world's greatest industries.

A model of an electrically operated cotton mill, equipped with the most modern appliances, will be shown alongside the crude weaving frames on which cotton was first spun by hand. A modern cotton gin, in miniature, will also be one of the exhibits. Another interesting model will be that of one of the old Mississippi river stern-wheel steam boats, famed in song and story.

U. S. Commission Puts Into Effect Commodity Rates

WASHINGTON, July 2.—The new commodity rates prepared by railroads covering the southeastern territory effective July have been allowed to become operative, despite the protest filed with the interstate commerce commission by various traffic organizations.

The protestants as the commission to prevent the rates becoming effective until investigation could be made. It is charged that the schedules would involve increased freight rates in the southeastern states.

Hardings Enthused With Beauties of Yellowstone Park

ON BOARD PRESIDENT MARDING'S TRAIN, July 2.—The two days spent by President Harding in Yellowstone Park has offered strong advantages to the prospects to add the region to the park area. Harding said yesterday after traveling over the park that he not only approved legislation, but that he would use his influence, to bring about the passage by congress of such an act would make the addition possible.

Both President and Mrs. Harding had previously visited the park, but as they boarded their train declared the visit had been thorough enjoyable. The presidential party spent today traveling through Montana and Washington. Harding will speak at Spokane tonight, discussing hydro-electric development and other projects on the Pacific coast.

Everything Ready For Fictic Battle

SHELBY, MONT., July 2.—Final preparations were made today for staging the fourth of July heavyweight championship battle between Jack Dempsey and Tom Gilpin, as the bout loomed less than 24 hours away. Major J. E. Lane of Lewisport, the new justice, took charge of the business management.

Major Lane predicted a crowd of at least 18,000 persons. He was busily engaged throughout the day in conference with the ticket selling force, Eddie Kane Gibbons manager, and local officials and business men. Major Kane declared the final \$100,000 of Dempsey's guarantee would be paid at Great Falls tomorrow and that the holding of the fight would not be jeopardized by any delay.

Elks Injunction Case Is Postponed Until August 1

Advices from Raleigh say that the hearing on the restraining orders against F. A. and R. M. Elks, Pitt county tobacco growers brought by the Co-operative Tobacco Growers association set for hearing last Friday, has been continued until August 1. The case will be heard before Judge T. H. Calvert. The association seeks to restrain Messrs. Elks from selling their tobacco through any other agency than the association and relates specifically to growing crops

Negro Suspect In Murder Case Taken After Thrilling Chase

ROCKY MOUNT, July 2.—After a thrilling man hunt which covered this entire section and was marked by a pitched battle between negro suspects aboard a freight train and officers at Selma, officers are certain that they have captured one of the negroes which participated in what is regarded as the most brutal and cold blooded murders which has ever occurred in the city.

The homicide occurred shortly before 10 o'clock Saturday when two negroes entered the store of W. W. Andrews on Bassett street, and after making several trivial purchases and loitering around until the store was emptied of customers, shot and instantly killed W. S. Bigles, well known white man of the city and clerk in the store, beat Andrews into unconsciousness, rifled the cash register of the day's sales and made their getaway.

Norwood Will Quit As State Chairman

SALISBURY, July 2. J. Dave Norwood, chairman of the state democratic executive committee since December 29, 1921, whose sensational financial collapse three weeks ago has made him the target of a widespread demand that he vacate the chairmanship resigned today.

Mr. Norwood explaining the cause of his resignation said he had "neither time nor the money to remain as state chairman and would insist that the executive committee accept his resignation." A meeting of the state executive committee has been called by Norwood at Raleigh Wednesday, when his resignation will be acted upon.

Collins Pays Shaw Cash For Running Him Down

After sentencing J. E. Collins, charged with running down Dan Shaw on the Dickinson avenue extension June 24, to eight months on the roads, Judge L. G. Cooper in county court today reconsidered and permitted Collins to pay Shaw \$100 his medical fees and a fine \$100. Felton Whitfield, charged with larceny pleaded guilty. He paid the cost and judgment was suspended good during behavior. Robert Harris, on a charge of assault with a deadly weapon, was transferred to the superior court. William Wooten and William Gatlin, larceny, were fined \$100 each. Willis Fleming, accused of receiving and transporting liquor was permitted to pay the cost. Judgment was suspended for two years.

NEW STOP LAW IS NOT HEEDED ON INITIAL DAY

The state law requiring all automobile drivers to come to a halt 50 feet this side of all railroad crossings which became effective yesterday was generally disregarded, the first day of operation. Motorist apparently failed to observe the big signs placed at either side of railroad approaches inviting attention to the fact that they must stop. It was a new proceeding with them. However, in some cases the requirement was observed.

The law is mandatory and sheriffs and other peace officers are charged with its enforcement. If all the violators were arrested yesterday enough money would have been realized to discharge the county's indebtedness.

Instructions have been given to the county traffic officers and other officers to see that the statute is carried out.

WILMINGTON.—The program of the North Carolina association of Real Estate Agents, which is scheduled to be held at Wrightsville Beach August 15-17, is being prepared and committees now are at work completing arrangements.

Will Seek Dam Location In the Colorado Valley

LAWRENCE, Kans.—A trip through 400 feet of almost inaccessible canyon of the Colorado river as geologist for a government party is to be the summer vacation of Dr. R. C. Moore, state geologist of Kansas, and head of the department of geology at the University of Kansas. The party, under the leadership of Colonel Birdseye, director of the topographic division of the Geological Survey, is to leave Lee's Ferry, Arizona, about August 1, and expects to finish the survey by the middle of October.

White Man's Justice To Be Taken To The Arctic

EDMONTON, Alta.—Headed by Judge Lucien Dubuc, a judicial party has left Edmonton for Herschel Island, in the Arctic, where eleven Eskimos will be tried on charges of murder. This is the first occasion on which Eskimos have been tried for murder in their own country; all previous trials have been carried on "out side," it is said. Those to be held at Herschel Island represent tribes from all over the western Arctic. Their capture and subsequent handing over to the police at Herschel by the Royal Canadian Mounted Police was commended.

Truck Driver Held For County Court, Other Cases Heard

Dixie Ballings, was charged before Mayor Clark today with driving a truck while intoxicated. He was held for the county court in \$200 bond. He was also accused of driving the machine without displaying a state license and not having sufficient lights. He paid the cost in the two latter cases.

For allowing a dog to run at large John Windham, was assessed the cost. Jim Cox, was drunk and down according to the evidence. He was fined \$10 and costs. His troubles did not end here. Charged with receiving and transporting and possessing liquor he was held for county court in \$200 bond. Romeo Ebron and Alice Ebron, colored were up for disorderly conduct. They were fined \$10 and cost. It cost Willie Hadley, colored, court cost, to turn a team around in the middle of the street.

ATTORNEY EVANS IS DISBARRED BY COURT FOR YEAR

**DO YOU KNOW THAT—**  
Some communities with extraordinary opportunities have been made a sort of morgue by chronic objectors?

**HALTING A VICIOUS PRACTICE**  
Frequency with which persons involved in accident cases attempt to settle through the agency of courts of original and appellate jurisdiction for money, violations of state and municipal laws in an unwarranted imposition upon our judicial system.

It is becoming common procedure particularly in cases growing out of automobile accidents. The first move immediately following such unfortunate disasters is financial settlement. Usually all parties involved are brought before a court charged with specific violation of either state statutes or municipal ordinances.

Courts have been all too prone to permit cash settlement for alleged damages to machines or personal injuries, losing sight of the fact that they are charged only with the responsibility of determining whether or not the laws have been violated, and not to pass on the question of damages. That is clearly a civil action, in which the court has no jurisdiction in the issue at bar.

In this connection it is gratifying to know that Mayor D. M. Clark, has laid down a precedent which undoubtedly will have wide effect in impressing upon those who come before him on misdemeanor or graver charges that he will not take judicial notice of money settlements as between the parties.

The other day Dan Shaw, who was run down by an automobile driven by J. E. Collins, suggested to the court that he was ready to withdraw his complaint for the reason, he explained, that Collins had offered to settle the fees for medical treatment and to reimburse him for lost time at his employment.

Mayor Clark, promptly and very wisely informed Shaw, that he did NOT HAVE ANYTHING TO DO WITH ANY SETTLEMENT. He might care to make with Collins. That part of the case was clearly out of his jurisdiction. His duty was to ascertain whether the defendant Collins had violated the law. The mayor passed on that question and that one ALONE.

Whether by custom or whatnot, it appears to be the popular opinion that courts directed to hear and determine misdemeanor and criminal cases may be employed at will as a COLLECTION AGENCY to collect damages that legally and properly are essentially civil actions. The idea of using the courts as a short and quick route to satisfy damage claims, is altogether wrong in principle and unjustified. The tendency to merge minor and major violations of our laws with civil actions should be effectually throttled. Its continuance is to encourage abuse of the functions of the judiciary.

If the precedent established by Mayor

Clark, is followed by Magistrates and municipal courts of other sections, greater respect for the law would be entertained. The public needs to be educated that it cannot CASH damage bills through courts that do not have power in such cases.

**LEGION TEACHES FLAG REVERENCE**  
Recent action of the American Legion in drawing up a code for flag observance strikes a responsive chord in the hearts of all lovers of the Stars and Stripes.

This code, covering proper civilian usage of the American flag and conduct in its presence was adopted at the conference of national organizations called by the American Legion, and a permanent committee authorized to disseminate it throughout the country.

Each of the more than sixty organizations represented is to promote the study of the words and music of "The Star-Spangled Banner," and its teaching in all schools and in juvenile organizations, as suggested by President Harding. State legislatures are asked to enact uniform laws requiring display of the flag in and over all schools, parks, and playgrounds, and over other public buildings.

The code covers fifteen rules for display of the flag and a list of fifteen "things to avoid," in addition to setting forth the proper use of bunting, the salutes and pledges of the flag.

The suggestion of a fine arts commission that the flag is "the wrong shape" meets with little approval.

The flag is now 1.90 in length to 1 in width, 19 feet long when it is 10 feet wide. The proportions say the arbiters of beauty should be 1.67 to 1. The flag is too long for its width to satisfy the sense of beauty of those who make beauty their business.

The general consensus of opinion seems to be that regardless of the laws of proportion, the flag, in its present shape, has been so long identified with all that is revered in American ideals that a change in it would be a desecration, not an "improvement."

**"BOOTLEGGING ALIENS," HAS AS LIQUOR**

The immigration laws of the United States are set at naught by "immigrant bootleggers" in the view of many high in administrative circles, who see in the million or more aliens in this country illegally a danger equal to that of illicit liquor.

The administration realizes the problem is a far-reaching one. There is some apprehension that the illegal entrance of aliens is due to collusion. The recent riot aboard a sailing vessel in which several Chinese were killed, has emphasized the immensity of the problem with which the Government has to deal. Many Chinese who were to be smuggled in were aboard the vessel, the price per capita being \$500. They will have to be deported at Government expense, which will approximate a cost of \$200 each.

Immigration officials say there are fully 5,000 Chinese now in New York who should be deported and at a cost of \$200 each it would be an expense of \$1,000,000.

Aliens entering the United States illegally at Pacific coast ports can be more cheaply brought across the continent, at a cost of \$100 each, and deported from New York on shipping board vessels.

Secretary of Labor Davis will devote much time this summer to drafting a new immigration law. Davis is an ardent advocate of the registration of aliens at the ports of entry, and he is right.

It is about time for folks to know that they cannot take the same chance as fish do in water. Recent drownings should be a lesson.

If they hurry, those Mexican troops who are reported chasing the boys who kidnaped an American may get their share of the ransom.

**To Extend World Drive Against Use of Alcohol**

WESTERLILLE, O.—Plans of the World League Against Alcoholism were announced in a statement issued today by Dr. Ernest H. Cherrington, general secretary. Dr. Cherrington said that William E. ("Pussyfoot") Johnson now is arriving in London, whence he will proceed shortly to South Africa to aid in a prohibition campaign. He then plans to go to Egypt.

Dr. Cherrington will sail August 1 for the British Isles and Europe, primarily as one of the representatives to the seventeenth international congress at Copenhagen, Aug. 20-26.

NEW YORK, July 2.—Ellis Island, facing its greatest onslaught of immigrants since the enactment of the 3 per cent law by congress, was a place of hoppiness today as would be quickly passed for entry onto the United States.

Medical and immigration inspectors working until nightfall scanned the streams of humanity taken to the island from four of the eleven ocean liners anchored at Quarantine. More than 1,000 of the 2,074 aliens arriving at the island, it was estimated, were permitted to go to New York.

The July quotas for various nationalities, which had haunted the

aliens as they speeded across the ocean and waited aboard ships to dash for Quarantine on the stroke of midnight, were not reached during the day at Ellis Island. Quotas for Greece and a number of smaller nationalities were expected, however, to be filled.

## Young Americans Promise Well For Paris Olympics

NEW YORK.—A potential Olympic champion for the United States, that's what experts predict for Frank Hussey, sensational Stuyvesant High school sprinter, who was credited recently with equalling the world's record of 9 3-5 seconds for the 100-yard dash, a mark held jointly by Charley Paddock, Howard P. Drew and D. J. Kelly.

Whether or not Hussey's mark goes down in official records along with those of Paddock, Drey and Kelly, it stands out as one of the greatest track performances of the season. The schoolboy marvel's performance occurred in the public schools track and field championships, and was subjected to the closest official scrutiny. Three A. A. U. timers caught him in 9 3-5 and a fourth even a trifle faster, close to 9 5-10. All testified that his start was perfect, but it was thought a slight wind that blew diagonally across the track might influence official decision on Hussey's achievement.

## May Finish Mexico's Theatre.

MEXICO CITY.—American theatrical interests have offered to complete the unfinished national theater in this city in return for a 50-year lease on the structure at a nominal rental. To finish the building would cost about \$3,500,000.

## Crops Throughout State Clean, Despite Extended Dry Spell

RALEIGH, July 2.—Crops in North Carolina are remarkable clean as a result of excessive drought and frequent cultivation, according to the semi-monthly crop report of Frank Parker, agricultural statistician of the department of agriculture. The dry conditions are showing most effect along the northern border, the report states.

"The cotton crop is generally good, wonderfully rapid growth having taken place, plants are branching and squares forming well. Stands are fairly good in the main belt. The weevil effect have been noticed in only a few border counties. Root lice is bothering some

"Tobacco is suffering heavily from the dry weather. Stands are regular, especially on stiff soils. The growth is stocky and leaves close together. Good color in the southern half of the state, but yellowish, small, and sickly in the main, or old belt area, where the acreage is slightly reduced.

## U. S. Treasury Balance Shows High Surplus

WASHINGTON, July 2.—Complete figures covering the government's financial operation for the fiscal year ending yesterday, made public by the Treasury, show receipts for the 12 months of \$4,007,135,480 and expenditures of \$3,697,478,020, indicating a surplus of \$309,657,460.

**Banks Public Servants.**  
Banks are public servants, but that does not place them under obligation to serve those who are unfair in their business dealings or who are lacking personally in the great principles underlying opportunity. Therefore, to be known as a careful and thrifty person is the best assurance that the bank will extend financial help when it is needed.

How essential it is that each of us cultivate the habit of saving. On every hand we see reckless waste. It is not always easy to practice thrift, but such practice leads to success. The ability to save money, even in a small way, has much to do with future business success and prosperity. Some one has said: "Opportunity does business on a strictly cash basis. She smiles on those with a bank account and laughs at those without one."

Many people who are unfamiliar with business, think that one should shun contracting a debt as one would shun an attack of malaria. They fail to distinguish between contracting wise and unwise debts. It is desirable and wise to use one's credit, that is go into debt for the purpose of a home, because such a debt encourages the family to save and to live on a sound basis. The earnest young student should, if necessary, borrow a reasonable amount of money to complete his education. This is an investment in personal ability, and will pay dividends in greater success.

Another wise use of credit is to borrow for the purpose of buying good bonds. Suppose you desire to buy a Liberty Bond for \$100. You can pay \$20.00 down and borrow \$80.00 from the bank, and pay this latter amount out of savings. Such a debt would be regarded as a wise investment, and would help you to financial success, because you would save in order to pay the amount borrowed. Many a prosperous business man began his fortune with such accumulations.

## Caution in Borrowing.

There are circumstances, however, under which one should never borrow money. Never incur a debt in a speculative venture. Many people get afflicted with the get-rich-quick fever, and in their attempt to gain sudden wealth, they invest not only their own money, but often that borrowed from other people. Beware of the luster for easy money. Of the people who speculate, ninety-five per

cent lose. Neither should debts be incurred for the purpose of pleasure-giving possessions. Such debts are an abuse of the charge account. They are millstones around the necks of countless families. The person who lives beyond his income is destroying the very rock upon which his future success must be built.

Life's success rests on the principles of character. "Every good tree bringeth forth good fruit, but a corrupt tree bringeth forth evil fruit." If we form unwise habits, we shall be as a corrupt tree, which is hewn down. If we form wise habits, we shall be as the good tree and enjoy happiness and prosperity.

The progressive bank adheres to the same standards that are expected of its patrons. Because it is well managed, it commands the confidence of its customers. Its business methods are beyond reproach.
