MR. J. G. BOWLING DIED AT FAMILY HOME HERE TODAY

Jerome G. Bowling, for nearly a score and ten years a resident of Greenville, died at his home early this morning. Funeral services will be held in the Memorial Baptist church Saturday morning at 10:30 o'clock. Burial will be in Cherry Hill cemetery.

Mr. Bowling had been confined to his room for the last few weeks, but his condition was not regarded serious until just a few days ago, when dangerous symptoms developed. Every medical application was given, but he failed to respond. When he came unconscious late yesterday it was realized he could only survive a brief period.

Twenty-six years ago Mr. Bowling moved to Greenville, and at once became prominently identified with the tobacco industry and was well known throughout the tobacco belt for his splendid judgment and unswerving integrity. He was intensely interested in the development of Greenville and took an active part in all civic projects. He was also a leading factor in the activities of the Memorial Baptist church.

Mr. Bowling was the son of the late Captain William Bowling, and was born in Orange county, Feb. 22, 1854. He was married twice. His first wife Miss Annie Mangum, Orange county, he wedded in 1879. One son Luster L. Bowling, of Durham, was born of that union.

Mr. Bowling married Miss Emma Currin, Granville county. She died in Greenville nearly three years ago.

The following children survive: Misses Nannie and Ethel and Mr. Luther H. Bowling, Greenville; Otho Bowling, Wilson; Luster L. Bowling, Durham, also, these sisters and brothers: Mrs. Sam Jones, Oxford; Mrs. Martha Holloway, Durham; Mrs. James Bowling, Durham; Dr. E. H. Bowling, Durham, and B. P. Bowling, Rougemont.

In the death of Mr. Bowling, Greenville and Pitt county loses one of its sterling citizens. He was a man of high ideals, courageous, thoughtful in his speech, and his opinions on public questions.

Gov. Morrison To Scan State Financial Report In Raleigh Today

RALEIGH, July 13.—Whether or not Governor Morrison's optimism over the report of the committee investigating the condition of the State Treasury is justified, will develop some time today when Secretary of State W. N. Everett shows him a copy of the report of the auditor which covers some 80 pages, each page 18 inches in length and several feet in width.

HEALTH BOARD WARNS AGAINST TYPHOID PERIL

RALEIGH, July 13.—Six cases of typhoid fever among the members of one family in Union county and five cases among the children of a Cleveland county family reported to the State Board of Health called forth today a warning from the board that the typhoid season is just beginning, and that every precaution, against this preventable disease should be taken during July, August, and September when illness from this cause reaches its peak.

In both instances of family epidemics the disease has attacked children. The Union county family is one of negroes with the youngest of the sick children a baby of three years, and the eldest a boy of 16. The Cleveland county family is a white one with the youngest victim six years of age and the eldest 17 years.

Experience of the health officials, it was stated, has demonstrated that annually the typhoid rate, both case and death, rises with the warm weather and the increase of house flies, considered the greatest factor in the transmission of the germs of typhoid and other intestinal diseases. Each year for the past ten years the typhoid rate has been consistently lowered in North Carolina, it was stated, until last year the total number of deaths for the first time since accurate statistics have been kept dropped under three hundred, being 298.

Father Charged By Daughter, Assault

ALBEMARLE, July 13.—The evidence in the case of Justus J. Efrid, charged with criminal assault on his daughter, Mrs. Agatha Shankle, was presented to the jury by counsel when court adjourned here for the day. The case involves two charges, one a capital offense and the other a felony.

The testimony of the girl was a gruesome story of intermittent abuse of a father against his child, who, at the time, according to her statement, was about 12 years old, but is now 20 and since married. The father denies a charge of any crime, but admits indiscretion and indecent conduct towards his child. Efrid is now 62 years of age and is the father of 18 children, 17 of whom are living.

Warehousemen Plan Get-to-Gether Meet

HENDERSON, July 13.—Tentative plans are being made by the local warehousemen for a district meeting of tobacco warehousemen including Oxford, Warrenton, Durham and other nearby points, to be held in Henderson at an early date for the purpose of getting together in a proper organization to control operation of their warehouses and business.

It is customary to open and close the warehouses in this district simultaneously with the beginning and the close of the tobacco season, and it is the purpose of this association to agree upon dates, methods, etc., to be followed by the respective warehousemen in this district.

Says Growers Don't Understand New Cotton Legislation

ATLANTA, July 13.—United States Senator N. B. Dial, of South Carolina, appeared before a joint session of the Georgia assembly, and in an address explained the ground on which bases his demand for changes in the Federal futures contract law. In opening his remarks, Senator Dial expressed his surprise at the small number of people in the South who understood the provisions of the new cotton futures contract law, which goes into effect on August 1. He ventured the assertion that not one in five hundred of the cotton growers in the South were familiar with the act.

DURHAM MAN KILLED, 30 HURT IN TRAIN WRECK

MEMPHIS, Tenn., July 13.—One person was killed and about 30 injured, some seriously, when the Memphis Special on the Southern railroad was derailed two miles from Larksville, Ala., early today, according to reports received here. Ten of the more seriously injured were carried to a hospital in Huntsville. The wreck occurred when four Pullman cars and two coaches broke from the engine and combination mail and express cars and hurled down an embankment.

HUNTSVILLE, Ala., July 13.—Fifteen persons injured in the wreck of the Memphis Special near Scottsboro early today have been brought to a hospital here. L. H. Carr, aged 19, of Durham, N. C., was killed and at least 12 were seriously injured.

ALEXANDROPOL.—Three thousand and at the American Near East Relief orphanage center here, who for the past two years have been treated for trachoma by Dr. R. T. Uhls, of Kansas City, Mo., have been discharged as cured. Practically all of the 19,000 children concentrated at Alexandropol by the Near East Relief are suffering from trachoma in various stages. Ninety-two thousand treatments have been administered in one week under Dr. Uhls' direction at the various orphanage eye clinics.

STORM BOUND, FARMER KILLED, CROPS SUFFER

WILSON, July 13.—Sidney G. Turnage, farmer of this section, was killed yesterday when caught beneath wreckage of a barn torn down by a storm which swept this section late yesterday.

A number of tobacco barns and pack houses were wrecked but there have been no reports of damage to dwellings.

Hail which is said to have accompanied the rain did considerable damage to tobacco and cotton.

Plans To Launch Air Attacks From Great Altitudes

LONDON.—Keels are now being laid in Great Britain for huge rigid airships which will hover above the clouds with a number of small fighting machines on board ready to launch at a foe, says an aeronautical expert in the London Daily Chronicle. The task of these new machines in war, he says, will be to carry aloft to immense heights and to transport, if necessary, thousands of miles, squadrons of swift, deadly, steel-built "attack-planes." These will be launched from high above the clouds, and will rush at 90 miles an hour and more earthward to harry other aircraft and raid the commerce of the seas.

"The airships will have the power, lacking in a small machine," the writer says, "of long-distance flights at a great altitude, while, on the other hand, the small planes they carry will be able to outfly and outfight any machine laden for a long journey."

"In the case of specially-organized attacks by these formidable air-borne fighters on 'planes carried at sea by mother-ships, the tactics of the craft sent darting down from airships will be to dive pell-mell on their surface-launched opponents, and strike them deadly blows before they can gain the vantage point of altitude."

MONTPELIER, Vt., July 13.—Senator Dillingham of Vermont is dead here following an operation for general trouble three weeks ago. He failed to rally to treatment and died here today. He had been member of the United States senate for several years. He will be buried at his home near here Sunday.

Wilson to Be Called As Moose Witness

WASHINGTON, July 13.—A subpoena for former president Woodrow Wilson as a witness in the Moose case was prepared today. The subpoena was prepared at the request of counsel for the defendants but it is not yet decided whether or not it will be served. The character of the testimony expected from the former executive was not made public by the counsel.

Firpo Shakes Fist At Dempsey, Willerd Is Through, He Bawls

NEW YORK, July 13.—Luis Firpo, in which he lost his title to Jack Dempsey. But while the same courage remained he could not muster the strength to answer that devastating attack of Firpo's.

Firpo's great speed and ability to attack his big target at more angles gave him an early advantage. But the South American often displayed bad judgment of distance and this, coupled with Willard's ability to block his opponent's rushes, resulted in little effective battling.

Willard, except for an occasional jab with his left, stayed on the defensive, waiting for a chance to shoot in an uppercut. But Firpo, a shifty object, gave him few opportunities.

In the first Firpo cut Willard's ear and in the fourth he pummeled the big Kansan about the ring with a drive to the head. Jess absorbed heavy punishment, but came back in the next round with his only real offensive.

Flicker Before End. After that one flicker of his fist Willard subsided. Firpo poked the way for the end with a slashing attack in the seventh, weakening the big Kansan with rights to the body. The end came in the eighth after one minute and fifty-five seconds of fighting.

Thus ended a fight that has no parallel in ring history for a bout in which no championship was at stake.

NEW YORK, July 13.—Firpo looked fondly today at the contract handed him by Tex Rickard agreeing to fight Jack Dempsey for the heavy weight title.

One hundred thousand persons witnessed last night's scrap and Firpo is looking forward to the throngs that will be present when he steps into the ring to tear the laurels from the head of Dempsey.

Dempsey, who was victor over Tom Gibbons on decision only, after Gibbons had remained in the ring for the entire 15 rounds, was not at the ring-side last night, but was on the Pacific coast resting up from his fight with Gibbons which was his first in two years.

Jack Kearns who was at ringside stated that his prodigy was ready for Firpo at any time.

The estimated proceeds of last night's fight were \$400,000, of which Willard received \$20,000 and Firpo \$80,000.

NEGRO GIRL, DIS APPOINTED IN LOVE, DROWNS HER SELF

Believing that the cross of a blighted love was more than she could bear Edith Speight, 18, colored, decided to end it all yesterday and jumped into the Tar river to her death. The girl was employed on the farm of O. W. Eakes, about four miles from the city. She came there from Walsenburg about eight months ago.

The girl stripped her self of all clothing and left a scrawled note in one shoe, saying "Lord I can't bear it." When she did not return to the Eakes home at the usual time yesterday a search was instituted. Her clothing was found but no trace of the body. Subsequently a note was discovered dated June 12, in which she accused James Simmons, of having breaking his promises to marry. The epistle explained that it was her determination to drown herself, but that "she should not rest another moment." She called on the "Lord to receive my soul, but I just can't help it."

Coroner Wilkerson examined the body and issued a death certificate of suicide. Her people have been notified.

A SHANTY TOWN COMING BACK

Uproot an American shanty town in the full fever of a broom rush, set it down in all its mushroom vigor amidst the ruins of some old world cataclysm and you have a conception of the historic city of Albert.

Here is a city, which had grown hoary with age and had been beaten down by war, literally rising from the grave, taking on new youth and starting all over again; a people bludgeoned, bleeding, bowed, benumbed by the cruelties of civilization's greatest tragedy, setting their hands afresh to the workaday common places of community life where they left off—literally challenging destiny.

Albert is coming back! No doubt about it. The spirit of the town is simply unconquerable. One hopes she will rise from her ruins to a new and surpassing grandeur.

Just now she is a town of shanties. Shanty homes, shanty stores, shanty offices—nothing but shanties for blocks and blocks. The city government, the mayor's office, the police department, the assessor, all function in shanties. Long sheds of them spread across the spacious square where once stood Albert's beautiful city hall. Most of the town's merchandise is sold in shanties. Housewives shop from shanty store to shanty, trudging across and along pavements still topsy-turvy from their deluge of World War shells. A shanty town, out and out!

All of which must not be construed to mean that Albert has lain dormant or idle during the five years that have elapsed since the Armistice was signed. Her industrious people have been working with might and main all the time. But they had to dig out and clear away before they could start to rebuild. As all the world knows, the town was almost pulverized by the rain of shot and shell which swept her from every point of the compass during the war. Her ruination resulted in all but annihilation. A mass of twisted steel alone remained to mark the site of the once proud city when the German invaders were driven back for the last time. Hardly had the thunder of the big guns died away before her people came pouring back to set about their herculean tasks of reconstruction.

It is an appalling prospect but the Albertian spirit in peace, as in war, was indomitable. There were no hesitants, no doubting Thomases! The work of recovery has

gone steadily forward. Officials and other spokesmen for the town assured the American visitors that it would continue to go forward and on a growing scale.

Yes, Albert is coming back!

MR. BRISBANE, MEET MR. JEFFERSON, PROHIBITIONIST

Mr. Arthur Brisbane, who knows a hundred thousand dollars worth of things a year about everything under the sun and who is the best editorial writer in the country, occasionally has some medical information which causes dissent and amusement to the American Medical Association, and now and then says something about prohibition which meets with disagreement on the part of "professional" prohibitionists.

One of Mr. Brisbane's favorite ideas is that if Thomas Jefferson were alive he would be in favor of turning the country over to the brewers, merely prohibiting "strong" liquors and encouraging the substitution of beer in the name of temperance.

Jefferson did favor the encouragement of brewing somewhat more than a hundred years ago. Nevertheless Jefferson was the most radical prohibitionist of his day.

Truth is not truth unless it is considered in relation to all the circumstances, times and seasons. Jefferson, who knew very little about beer and nothing at all about the brewing industry as we know it today, believed that whiskey "kills one-third of our citizens and ruins their families" and he advocated taxing the whiskey out of existence. Beer was little consumed in the colonies and Jefferson did not know that so far from serving as an offensive weapon against the evil of distilled liquors, the rise of the brewing industry would greatly increase the consumption of alcohol, as afterward it did.

Dr. Benjamin Rush, who is generally conceded to be the father of the anti-alcohol movement in America, one of the signers of the Declaration of Independence, was not nearly as radical as Jefferson in his temperance sentiment. The Methodist Episcopal Church, which is certainly quite as radically dry today as any other organization in existence, condemned the practice of distilling at the General Conference of 1780, but said nothing whatever as to brewing. Jefferson was even more of a prohibitionist than many of the leaders of the Methodist Church at that time, for some of them did not agree with the General Conference pronouncement against distilling, and on the contrary were not opposed to the "properly conducted" sale of whiskey.

The great author of the Declaration of Independence was the first one to secure the passage of a national prohibitory law, which in that case applied to the Indians.

One is led inevitably to the conclusion that Jefferson may be claimed as one of the fathers of the prohibition movement and that if he were alive today, having at his command the record of semi-treason and corruption of the brewing industry, the vast increase in the consumption of alcohol caused by the common practice of beer drinking, the economic evil inflicted upon the country by the maintenance of an anti-social trade which destroyed almost the entire savings of the American people every year, he would spurn with loathing the proposition to nullify the United States Constitution in behalf of a special interest so inimical to the welfare of the people he loved.

British Exports to Brazil Exceed Those of U. S.

RIO DE JANEIRO, July.—American exports to Brazil, according to figures published by the federal department of commercial statistics, were surpassed by British shipments last year for the first time since the beginning of the world war. The total value of American exports to this country in 1922 was almost equal to that of the year before hostilities

began in Europe, but less than one-quarter of the total reached in the high tide year of 1920.
 The reason for this tremendous decrease in Brazilian imports of American products, according to opinions expressed by business representatives here are the unfavorable exchange rates on Brazilian money, the relatively higher cost of doing business confronting American exporters, and the general retrenchment in Brazil.
