Interests that are behind the movement to make the project permanent are seeking a new location. No decision has been reached just where the new site will be

situated. However, an effort is being made to obtain a location that will prove equally as convenient and adaptable as the present quarters. During the weeks that the market has been in operation its growth has been rapid. No word of dissension has been heard from either grower or buyer. That's a record of service and satisfaction. Ample notice will be given of change of site.

New York Dry Leader Is Indicted For Larceny Of Anti-Saloon League Cash

NEW YORK, July 21.—The three indictments returned here against William H. Anderson, superintendent of the Anti-Saloon League of New York, on three counts, two charging grand larceny in the first degree, and one forgery in the third degree, proved no surprise to those who have been following the investigation of the district attorney's office.

Anderson was immediately arraigned in court and pleaded not guilty. He was released in \$5000 bond. He then issued this statement through his publicity agent:

"I shall bear as a medal of honor and a service badge my indictment for political purposes by the most corrupt and powerful wet political organization in the world as part of the Tammy conspiracy to put the nullification governor of New York state in the White House in defiance of the conscience and character of the nation."

The first grand larceny indictment charged that Anderson feloniously obtained \$4,578 from the league in March of 1921.

The second grand larceny indictment alleged that he feloniously obtained \$1,750 on February 3, 1921.

The forgery indictment set forth that he had falsely ordered \$4,400 to be entered in the league's books in March, 1921, as the hotel and traveling expenses of O. Bertall Phillips, a collector for the league.

Grand jury investigation of Anderson's handling of the league's funds was pressed after he had steadfastly refused to be more specific concerning the expenditure of \$24,700 than to state that it had been used "for publicity purposes."

Indoor Jail Sport Puts Chas. Stocks And Mate in "Den"

Time hung heavy on the hands and minds of Charlie Stocks and Jess Mills, prisoners being held in the county jail on charges yesterday. They were restlessly pacing the corridor of the bastle, when a brilliant thought struck one or the other. In effect it was to see whether the walls of the prison would withstand the onslaught of an attack with spoons.

"Great idea," said one. "You are on," was the reply. Gleefully they plunged themselves into a genuine afternoon of indoor sport. The "sport" must have developed considerable work, as they dug a hole about 15 inches in circumference, when one of the jail guards stopped their work and made them "happy" by placing them in dark cells, until they have learned that prison walls are not constructed to be torn down with spoons. They are repentant today.

Advance Season For Dog Days Opens In Mayor Clark's Court

Some Greenville folks have evidently lost sight of the fact that this is not the open season for allowing dogs to run a large. At any rate a few found it out today when they appeared before Mayor Clark and were reminded that penalty attaches to vagabond canines. C. L. Perkins, E. J. Garrett, Dail Laughinghouse and Henry Brown, the latter colored, were charged the costs for transgressing the law.

Jesse Willard, when his name was called to answer a charge of being drunk and disorderly failed to appear. His bond was declared forfeited and a capias issued. The next number on the program was Charles Spruill, colored. It was testified that he hurled a few mouthfuls of epithets at Lizzie Watson. He paid the cost, at so much per epithet. Louise Whichard, colored, tramped before the court, to explain why she exercised her vocal powers in denouncing Annie Redmond, in language not intended for polite company. When she paid the cost the docket was cleared.

Old Carolina Clubs Leased By Pythians

At a recent meeting of the Knights of Pythias, it was decided that the old quarters of the Carolina club would be leased by the Pythian Club. As soon as contemplated improvements are made the club will move to its home. The club will rent the hall to the Pythian lodge for its ceremonial and other work. Officers of the club are: President E. E. Rawl, vice President J. S. Brown; Secretary-Treasurer, J. K. Wooters.

A drive is on to obtain more than 100 new club members. Of that number more than 75 have been secured.

To Erect New Wire Fence at Jail Yard

Material for the erection of durable wire fence around the jail yard has been received, and will be placed in position as soon as an expert arrives from the factory to do the work. Since the collapse of the old wooden fence, easy verbal communication with prisoners in the corridors has been possible from the outside. The new barrier will stop that practice.

COURT DOES NOT GET RUFFLED BY DIRE THREATS

LUMBERTON, July 21.—Anonymous letters received by Judge Sinclair, presiding at the trial of the flogging cases, and Attorney Stephen McIntyre of the prosecution in which dire threats are made if the case is permitted to continue has had no effect whatever upon either the court or the lawyer.

The letter to Judge Sinclair was printed in ink with a pen and warned him that any four among the 12 men of the jury were impudently "the herculean spirit and giant power," and suggested that any efforts to convict the defendants would be as chaff before a storm. One of the significant threats in the letter to McIntyre read: "Your intelligence tells you that the exposure of this morning brings an invisible, invincible hand that his mightier than the courts themselves and upon your unworthy carcass."

The massive accused both the court and the prosecution of adopting a system of "prosecution."

McIntyre declined to comment upon the letter. The case is expected to go to the jury this afternoon.

The threats contained in the letters are not taken seriously and are accepted more in the light of some jokesmith.

Judge Sinclair busied himself preparing his charge to the jury while the counsel argued the case. He has made no statement as to whether any action will be taken by the court regarding the anonymous warning.

The trial of Harry Talaferro, charged with attempting to tamper with witnesses and, who, according to the police, claimed to be a Ku Klux Klan detective will be started as soon as the jury retires in the flogging cases.

Scapa Flow Hulks To Be Salvaged and Sold

LONDON.—The German fleet scuttled at Scapa Flow in June, 1919, is to be raised, cut up, and sold for junk. The admiralty has signed a contract with a private company which has purchased part of the sunken ships, and will start operations at once to raise them.

The company is said already to have found a market for the hulks. If the operations are successful, a contract will be signed for the remaining section, which includes the largest of the ships.

The vessels sunk comprise ten battleships, five battle cruisers and 29 destroyers, their total tonnage being about 416,000. The contract already agreed to covers 20 destroyers and one of the battle cruisers.

Free Will Baptist Seminary Opens Soon

The Ayden Free Will Baptist Seminary, Ayden, will reopen its doors to all ministerial and high school students on Sept. 4. The course of study this year as planned by the members of the faculty is broader than at any time heretofore. Besides the regular high school and ministerial courses, the Seminary is offering courses in music, shorthand, typewriting, bookkeeping, and commercial law. A seventh grade teacher has also been employed to take care of students who may be unable to meet the high school entrance requirements.

The course of study as outlined will permit a student to fit himself for college, for the ministry, or for business, thus permitting students who do not intend to enter college to specialize in one or more of these departments. The regular high school course as outlined by the state department of education will be followed in the academic department.

CREDITORS MEET SETTLE AFFAIRS OF BARRET & CO.

AUGUSTA, GA., July 21.—Financiers of New Orleans, North and South Carolina who met here today are striving to hold together the crumbling house of Barrett & company, which was known as one of the largest cotton factors in the world. The liabilities and assets will balance, according to an announcement by James Hull, Jr., a member of the counsel of the firm and they will be studied at a meeting of the bankers today.

The plans for liquidation were worked out at a meeting yesterday the creditor bankers having already having representatives on the field before announcement was made of the failure of the institution. Frank H. Barrett, president of the concern said today that he had given up his seats on the New York and New Orleans cotton exchanges because he was unable to meet his obligations. No other reason was given for the firm's plight.

The obligations of the firm will total \$1,000,000, but the local banks are not involved, it was stated.

Tablet To Be Placed Over Graves in Arctic

WASHINGTON.—Included in the cargo of the schooner Bowdoin, in which Dr. Donald MacMillan recently left on another expedition into northern ice fields, was a bronze tablet which will commemorate the memory of American soldiers in one of the most northerly monuments in the world.

The tablet, to be placed on Cape Sabine, Ellesmere Island, more than 800 miles within the Arctic circle at latitude 78 degrees, 45 minutes north, will mark the scene of one of the most tragic passages in the history of American Arctic exploration. It will be in honor of 16 officers and men of the United States army, members of the Greeley expedition of 1881, who gave their lives in the interest of science.

New Coal and Wood Yard Is Now Under Construction Here

Greenville is to have another coal and wood yard. Such news will be gladly welcomed by the people generally, because in the past the demand in the winter has for many years been greater than it was possible to supply satisfactorily.

Mr. W. T. Bryan who is at the head of the new enterprise states that they have sufficient trucks and other delivery conveyances to make prompt deliveries at all times. The yards located near the Fair grounds in the western part of the city which are now under construction will be completed shortly, and will be second to none in eastern part of the state.

The company has already received several cars of coal to take care of the business people, who usually prefer buying their fuel in the summer preparatory to the winter. Mr. F. R. Elmore will be in charge of the yards, and until their 'phone is installed call 200 for prices and immediate deliveries.

Air Flivver Does 65 Miles An Hour At High Altitude

LONDON.—Last year's dream of aerial flivvers has come true. An experimental glider fitted with twin engines of five horsepower and two tiny propellers has, in its first test flight, hit up a speed of 65 miles an hour and attained a height of 2,500 feet. The flight was made from the airdrome at Lympne, within two hours after the little plane had been unpacked from a motor lorry.

It seemed easy to assemble the many parts and not at all difficult, from a financial standpoint, to keep it in the air.

PARRAL MEXICO, July 21.—The body of Francisco Villa, the most outstanding character in contemporary Mexican history, combining strong "horse sense" and fiery impulse was brought here to the city hall today.

Thousands of persons flocked around the military caisson on which the slain rebel chieftain was borne paying homage that might be suitably done to a king or emperor. The surging crowd comprised all classes from those who had hated him in life to his followers through many sensational and thrilling revolutionary campaigns.

The report first sent out that Villa had been shot by his secretary, Miguel Trillo, during a quarrel proved to be entirely erroneous. Villa, Trillo and three of the former's men were assassinated yesterday by a band of seven who have long cherished a hatred for Villa and his followers. While it is not known definitely, still there is reason to believe that the assassins were possibly hired by friends of the family of Francisco Herrera. That family entertained a bitter hatred for Villa, and have frequently declared they would "make him pay." It is claimed that the rebel chieftain was responsible for many deaths in the Herrera family. Another theory is that the Robin Hood of Mexico was killed by some of his own men through a spirit of vengeance.

Federal troops have been sent to his ranch at Canutillo to prevent any disorder that might rise incident to the disposition of his estate. It is understood that Villa was only given a life interest in the immense holdings and that it will now revert to the government.

MEXICO CITY, July 21.—President Obregon, planned to accord full military honors to Villa, but since it has been announced by the war department that his name was not carried on the military rolls of the government that part of the funeral will be abandoned.

It is reported that three of the assassins who killed Villa and his men have been captured. Federal troops are still making a rigid search for the entire band, said to number seven.

JERUSALEM SHRINES OCCUPIED BY AMERICAN UNITS

JERUSALEM.—The three most important "holy places" of the Armenian Catholic church are now occupied by American relief units, according to the annual report of the Armenian Patriarch here.

SENATOR SMITH'S ATTACK ON THE IMPERIAL TOBACCO COMPANY, RIDICULOUS

Press dispatches credit Senator E. B. Smith, South Carolina, with attacking British financial interests and mentioned the Imperial Tobacco company of Great Britain as a powerful factor in setting the price for the labor of the southern farmer and his children.

The senator is quoted as making references to the relations between Great Britain and the United States designed to inspire prejudice and class hatred. The speech was delivered before a group of farmers and members of the Tobacco Growers Co-Operative association "to celebrate the opening of its warehouses for the crop of 1923."

It is barely possible that Senator Smith, was persuaded by the co-operative interests to come to the rescue of an ill-fated venture that is about to founder on the rocks of disaster and save it if possible by one of his characteristic inflammatory speeches. If the senator is correctly quoted his utterances were

both ill-timed and undignified. However, such remarks coming from a United States senator is the only thing that gives his explosion a passing thought, much less credence.

Again if Smith had made such declarations on the floor of the senate they would have been passed unnoticed for it must be remembered that the South Carolinian has no particularly distinguished record either as a debater or author of legislation in that body.

Unfortunately for the country a good many people of his own state take him seriously.

The senator is a poor opologist for the co-operative selling plan, when he attempts to discredit the Imperial Tobacco company. Officials of the co-operative association have boldly declared that they have made every other buyer "come to terms and they would get the Imperial." The English company has held aloof from controversy with executives of the association and have bought what and where they wanted without consulting or following the dictates of the organization. They have paid better prices than the association—and not on the deferred payment plan. Growers realized that potent

fact early last season and it is growing with indelible impress.

IN THE LIGHT AGAIN

Maurice Baring compares the Temple of France to a wheel which goes round and round, carrying its inmates, who may never leave now into the light and now into the dark. The comparison is apt when the ups and downs of literary reputation are considered. Examples are many: Wadsworth and Byron, for instance.

Just now there is a swing of the wheel that is carrying Tennyson back into public favor. There was a day when the laureate occupied a position on a lofty pedestal, and those who refused to fall down and adore became anathema to the cognoscenti. Then it began to be debated whether he was a great Victorian figure or a Great Victorian Bore. Finally, he was relegated to literary obscurity and the cold charity of neglect.

Now behold Tennyson redivivus! The wheel has come again into full circle. People are beginning to read, talk, write about Tennyson once more. Serious studies of the dead Victorian laureate have recently been published. Tennyson is quite likely to be in vogue again.

The penalty of being in the light is that of courting criticism, or inviting a search for weaknesses. In Tennyson, they are varied and numerous. He wrote for an audience of young women of the nobility; he was a hypochondriac, one biographer says, because he drank too much port and because his verses abound in either pretty sentimentality or in distressing emphasis of things of the grave. But on the other side Tennyson has the credit of never having written a line which, dying, he would wish to blot. He had the art to write a lyric and to tell interestingly a story in verse, and he had a habit of perfection in thought and expression. The easy movement, the grace and readableness of his "Idylls of the King" may well be considered models.

Certainly, Tennyson is deserving of a permanent place in the Temple of Fame, and he of moderns who have doubtful claims to must not be crowded out by the noisy group permanency. He is not the greatest of English poets, but he is one of the best, and a new generation may find a refreshing pleasure in reading him.

TEACHING A DOG OBEDIENCE

The first thing that should be taught a

young dog is obedience.

To do this he must be given a name so that when he is called he will come promptly to you. This in itself is not a hard task only a little patience is necessary. As early as possible, select a name and then call him to you frequently using the name. When he is close enough, praise him and pet him and then offer him a bit to eat. This should be repeated often during the day and until such a time that he will come to you readily at the mere sound of the name selected for him.

But never, during these first lessons, be harsh with the puppy. They have lots to learn and as they grow older they will understand soon enough what is expected of them. To teach the dog to come at the sound of a whistle is another lesson that is taught in practically the same manner. Blow a whistle when he is some distance from you and call his name. The new sound will attract him, but he will not come until his name is called.

By repeating this practice frequently, he will begin to understand that he is to come to you at the sound of the whistle as well as the name. Here again he should be rewarded with a choice morsel of food, and before long you will have a dog obeying the sound of his name as well as that of the whistle.

Proposed Tunnel Will Bring Oceans Nearer Together

DENVER, Colo.—Actual work on the Moffat tunnel, through the continental divide west of Denver, is expected to begin early next month. The first shovelful of dirt may be turned on August 1, Colorado Day. Everything is in readiness to start. Bids for construction are being advertised and the bonds are being offered for sale.

The Moffat tunnel will cut the rail distance between the Atlantic and the Pacific oceans by 70 miles. Its construction is an engineering feat of much difficulty, and it is of great national importance, for it will open up a large section of land in northwestern Colorado rich in natural resources. The campaign to construct this tunnel has been carried on for the last 50 years. Early in the sixties the pioneers of what is now the state of Colorado realized adequate transportation was necessary to develop the territory, and set about to get it.

The tunnel commences at the headwaters of South Boulder creek in Gilpin county near the town of Teller, passes under James Peak and emerges a trifle more than 6 miles west at the headwaters of the Fraser river in Middle Park Grand county.

The western side of the tunnel is 4 1/2 miles from the town of Fraser Colorado. The tunnel will be available immediately to the Denver & Salt Lake railroad, now completed to Craig, Moffat county. The plans of this line include building into Salt Lake City. It also will be available later to the Denver, Rio Grande & Western railroad which now is building a cutoff to connect with the tunnel. The actual saving to the Denver & Salt Lake railroad will be the tortuous climb of 23 miles over the crest of the continental divide, where the Moffat road now crosses the divide above timberline at an elevation of 10,660 feet.

On the Denver & Rio Grande the distance to Salt Lake City will be shortened by 173 miles through building the cutoff to connect with the tunnel.

The tunnel will be 6.04 miles long. The project consists of a main tunnel 20 by 16 feet in the clear and a pioneer tunnel paralleling it. Trains through the tunnel will be operated

by electricity. Provision has been made so that automobiles and other traffic may pass through the tunnel in special cars. The tunnel elevation at the east portal is 9,190 feet, at the west 9,100 feet.

EXPERTS ASSERT LIGHTNING RODS PREVENT FIRES

NEW YORK.—Property owners throughout the country are urged to equip their buildings with lightning rods by the National Board of Fire Underwriters, which today declared that 99 percent of the fires caused by lightning could thus be prevented. The losses by fire caused by lightning total \$30,000,000 annually.

A widespread indifference to this form of protection exists, however, due to the swindling methods employed by lightning rod dealers in the past, and the fact that it is highly difficult to obtain an expert who can determine whether or not installation has been correctly done.

Careful research by electrical authorities including Dr. Charles P. Steinmetz of the General Electric Company, and Thomas A. Edison have proven conclusively the efficiency of the lightning rod as a safety device, the Underwriters declare.

To guarantee property owners that their lightning rods have been properly installed and are a protection instead of a menace, the board of fire underwriters has adopted a plan whereby a representative of their organization inspects all installations in his district, and affixes a "master label" to the work if it proves worthy. "Insurance companies will grant a reduction of insurance for lightning rods in states where reductions are allowed, only on those buildings where the master label is attached along with the identification tag of the company which made the installation," the statement declares.

Laboratory service will be provided by the fire underwriters, where materials submitted by lightning rod companies will be tested for certification. The master label will be attached to the work of only those companies which maintain an inspection service along with their installation service, the underwriters have ruled. No lightning rod company is barred from this laboratory service.

Losses in Meat Through Bruised Stock Decrease

CHICAGO.—Of the 12,435,386 head of cattle killed in 1922 in 68 of the principal markets of this country, 1,498,246 were bruised, but the loss of meat from this cause averaged a half pound a head as compared with a pound a head loss for beef animals killed in 1921, says a report made public by the Illinois Humane Society.

"The reduction shown is 50 percent and is attributed to the campaign now on for the better handling of cattle in transit and in yards," says the report.

"As to losses in transit," the report continues, "returns from eleven western markets from which the principal statistics were obtained show there was a slight decrease in losses in 1922 as compared with 1921. This is gratifying for the reason that the railroads, on account of strikes and other causes, had a difficult proposition to keep their service at anything like standard in 1921.

Film Fans of Europe Demand Graceful Girls

BERLIN.—Young women with graceful hands and feet are now being sought by European film directors in their efforts to compete with American film. American pictures long ago made it difficult for the film studios of central Europe to market pictures abroad, or even at home, if the heroines were not young and beautiful.

The practice of featuring famous actresses regardless of their looks has gone into the discard. For a long time the German and Swedish moving picture producers clung tenaciously to the theory that histrionic art was the chief feature of a film, but today they are looking for youth and beauty of figure, as well as beauty of face. Europe's red business man wants to see girl shows, and he wants youth in his musical comedies and movies alike. As a result German movie actresses are all dieting.

INFLUENCE "HOME, SWEET HOME" WAS BROUGHT OUT IN SPLENDID SERMON BY REV. JOHN HARTLEY

(Continued from Yesterday.)

By REV. JOHN HARTLEY.

There is something sacredly beautiful about Washington's definition of a home: "The place where mother is." It is transcendently beautiful.

That reminds me of Francis Murphy, the modest apostle of temperance who, excepting only John B. Gough, has led more men from inebriety to Christian safety than any other man who ever lived. When Murphy in his dark drinking days lay a criminal in a cell up in Maine with the law not yet enforced in its sentence upon him; when missionary after missionary and minister after minister went to his side to plead with him and see if they could not get at something that was good in him—no, it was all covered over with the power and habit of sin, which had come to be deep guilt upon his nature. But one day a kindly man took a child of Francis Murphy into the cell of the prison where he was, and she stooped over, with the tears dropping upon his breast, she said to him, "Papa, we are homesick at our house without you," and what there was left of manhood and hope and divinity underneath all this overbearing debris was reached. How simply and sweetly, though perhaps unconscious-ly, that child distinguished between house and home—"we are homesick at our house without you."

Other Examples Cited.

Take another illustration: I am taking a long walk with my friend across the moors and hills. We have not met before for many years—never, in fact, since we were at school together. They talk pleasantly about the past, and recount reminiscences of youthful exploits, while every now and then we pause in our walk, while he points out some interesting features, in the landscape, for the district is strange to me. The sun dips slowly in the west and our shadows lengthen before us as we go. Our conversation drifts easily from the past to the present. My friend is taking me to see his wife and bairns. To talk of them is manifestly a pleasure to him.

At length we reach the brow of a hill, and below us a pleasant valley swims in a golden haze. On the slope of the opposite hill, a number of pleasantly situated houses front us, and here and there the windows flash blood-red in the light of the western sun. My friend is silent for a moment, but I see his face brighten.

Then laying one hand upon my shoulder he points with the other, and says eagerly, "There is my home, the last house but one to the left," and his eyes catch a distant look as though he sees beyond its walls.

Sees Inside of Home.

And in truth, he does. I see the house as clearly as he does; indeed, more clearly, for my sight is better than his. But he sees what I cannot see. He sees the home within the house. The house is built of brick, with stone dressings, and has a gable in the roof. But the home is built of love and reverence, and mutual trust and confidence. I know not if the house satisfies his aesthetic sense; but I know the home satisfies his heart.

There his whole nature has met. And that is the true secret of the home.

There he can talk of what he has done without being charged with self-adulation.

There he may lounge without being thought ungraceful. There he may remove the mask of austerity and severity which he has worn during the business hours. There he may express affection without being thought silly. There he may forget the troubles, annoyances and exasperations of business, forlorn earth pilgrim? no home? Then die! That is better. The grave is brighter and grander and more glorious than this world with no place to rest from this scene of greed and gouge and loss and gain. God pity the man or woman who has no home!

The Four Pillars.

There are four pillars that bear up the home. Whether the roof be thatch or tiles, whether the walls be logs or marble, whether the situation be beautiful or ugly, where the four pillars stand the home can be solidly built. Where the pillars are wanting the costliest material, the loveliest site, the stateliest edifice will be in vain.

The four pillars that bear up the "Sweet Home" are:

1. Love. 2. Order. 3. Industry.

4. Virtue. 1. Love. Wherever love may be lacking, there ought to be love at home. "Love that seeketh not her own, is not easily provoked, thinketh no evil, beareth all things, endureth all things."

That's the spirit of home. Helping the weak, shielding the defenseless, passing by the evil, with as little censure as possible, hoping for better things. Home is no place for death's—head mutterings, or "Hark from the tomb a doleful sound" sort of spirit. Home should be the scene of unfettered joy; the brightest and most cheerful place on earth.

The man who can charm and gratify his club with the brilliance of his conversation and the keenest of his wit, but who never contributes any intellectual stimulus to his wife or children, ought to be sent to a penitentiary. The woman who wins the most eulogistic resolutions for her genius in decorating a church or bazaar; but whose own home exhibits not a single sign of the decorative gifts ought to be set to scrubbing floors, 'till she has learned a better way. The young man who expends so much politeness over somebody else's sister as to have none left for his own, will make that other girl as miserable, some day as he now helps to make those who have to live with him. Shall I venture also to say that the young woman who has no ambition to be an angel in her own home will never be made one anywhere else, not even by the endearing insistence with which some offensive young man calls her by that name? Take a stanza from the Cotter's Saturday Night.

"At length his lovely cot appears in view,
Beneath the shelter of an aged tree:
The expectant ever-things todlin sacher bro'
To meet their dad in flichter in noise an' glee."

Could any thing be finer? Every breast beams with love. The old dad is full of strong affections; the mother's heart overflowing with tenderness; the children all burning to show their love in talk and carcases; and even the old dog Nero scampers in and out wagging his tail in token of some pleasure which canine will never express.

"From love so sweet, O who could roam?
Be it ever so homely home is home."

Nature Harmonious.

II. Order. Nature is full of order. Among all revolving and swift-flying planets there is not a clash nor a jar. In the heavens above, on the earth beneath, and in the waters under the earth all nature is harmonious. There should be order in the home.

The family is a kingdom. The father is the king; the mother is, or should be, the loving and beloved queen and the children are the subjects. Love is the law, peace the atmosphere, sympathy and forbearance the essence. I have heard parents pride themselves on having a family that move at their bidding, "like a well drilled military corps." That is to say the children have been made as much like machines as possible. They act with clock-like precision. But it is to be feared that the high state of discipline which prevails in some households has been brought about by a process fatal to all filial affection.

Many a general is feared and implicitly obeyed without being liked or loved—obeyed by many who would like to put a bullet through his heart. Would parents purchase domestic order at this price? Home is not a barrack, nor a place in which to suspend placards with a tedious schedule of petty rules all enforced by pains and penalties. To rule the children in that way may secure order and obedience, but there is no sure way of wending out of their hearts every root and fibre of affection. Love will do more towards securing and maintaining order and filial obedience, than authority. Not blind affection, but affection by wisdom and sustained by fortitude.

III. Industry.

"In every land, great or small
'Tis industry supports us all."

Should Know Work.

Every member of the family should know his work and do his work in the home, and for the home. The youth who has low views of work, will never have high views of God or man, nor will God or man ever have high views of him. The idler is

"Like a watch that lacks both hands, as useful when he goes as

when he stands." St. Paul did not hesitate to say that "If a man will not work neither shall he eat." And again we endorse the Apostle's saying: "If a man provide not for his own household he both denies the faith and is worse than an infidel" worse than Tom Paine, worse than Chas. Bradlough, worse than Robert Ingersoll. I believe it.

Work is neither an accident, blunder nor degradation, it brings a man into harmony with the world he lives in, and with God Himself. The persevering painstaking industrious man of Nazareth has forever dignified toil by becoming himself a toiler. Perhaps no joy in life is purer or stronger than the joy of having "done something" to increase the happiness of home. When all hands are at it, there is "honey in the hive."

IV. Virtue is another pillar that helps to uphold the "Sweet home." An unspotted character is the gift of God to maintain the sanitary conditions of home "virtue, the strength and beauty of the soul, is the best gift of heaven."

Virtue is her own reward.

We need not all be great, but we must be good. The young as well as the old can be virtuous.

"Well may your hearts believe the truths I tell;
'Tis virtue makes the bliss where'er we dwell."

And, in passing, I will say that the virtue cultured in the home circle are an absolute necessity for the state. If there be not enough moral principle to make the family adhere, there will not be enough political principle to make the state adhere. "No home means the Goths and the Vandals." The same storm that upsets the ship in which the family sails will sink the frigate of the constitution. Jails and penitentiaries and armies and navies are our best national offenses. The door of our home is our mightiest fortress.

Home Sacred Temple.

Often a father raises a son that is better than he is, but when a mother raises a son better than she is, God help the home.

Let us, then, by love, order, industry and virtue set up the most sacred temple we can ever rear on earth. A home, and, remember, there is no right beginning or maintaining of it except as the altar of the Lord of the home is reared and honored, and for that reason he has given us a very comforting promise: "Where two (husband and wife) are gathered together in my name, there am I in the midst of them."

Incense rising morning and evening from the family altar pleases God and sanctifies the home. At that altar parents lighten their burdens refresh their powers, and sweeten their relations, and at that altar the children learn to love and trust the unseen.

"As for me and my house, we will serve the Lord," said Joshua, the Israelite statesman and general. Some of you had fathers who said the same. Your old home was not only built on the four pillars of (1) love, (2) order, (3) industry and (4) virtue; not only ruled by the law of love and pervaded by an atmosphere of peace, but roofed and sheltered by prayer.

Gather for Devotion.

Ever morning the family was to gether for devotional exercises. Some what fitly you sat and listened. Your father made no pretention to rhetorical reading, and he just went through the chapter in a plain, straightforward way. Then you all knelt. It was about the same prayer morning by morning and night by night, for he had the same sins to ask pardon for, and he had the same blessings for which to be grateful day after day and year after year. The prayer was longer than you would like to have it, for the game of ball was waiting or

the skates were lying under the shed. Your parents some what rheumatic and stiffened with age, found it difficult to rise from their kneeling. The chair at which they knelt is gone, the Bible out which they read has perhaps fallen to pieces, the parents are gone, the children scattered north, east, south and west, but that whole scene flashes upon your memory today. Was that morning and evening exercise in your father's house debasing or elevating? Is it not among the most sacred reminiscences? You have gone over mountains and across seas, but you never for a moment got out of sight of that domestic altar. For how much would you have that scene obliterated from your memory? Many a time it has held you steady in the struggles of life. You once started for a place and that memory jerked you back, and you could not enter.

Effect of Prayer.

The broken prayer of your father has had more effect upon you than all you ever read in Shakespeare and Milton, and Tennyson, and Dante. The memory of it will linger 'till the angry brain can think no more, and like the spies that pierce the sky, which ever way we turn, will ever be pointing upward. From such a home came John Ruskin, the greatest power in modern literature. From such a home came Alfred Tennyson, the greatest poet of modern times. From such a home came William Ewart Gladstone, the prince of statesmen. From such a home came Charles Haddon Spurgeon, one of the greatest preachers of the nineteenth century.

Friends if you want to sing "Home Sweet Home" with your eye on your own hearth, with your hearts affections encircling your own family, make Jesus Christ the centre of your home, for home is ever most homelike, most heaven-like, when He is most at home.

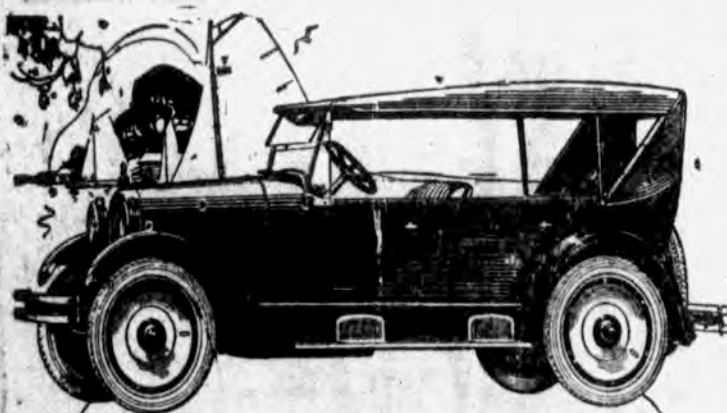
