## MINE PUMPMEN TO STAY ON DUTY IN EVENT STRIKE

### Coal Properties To Be Free From Water, Both Sides Agree

HARRISBURG, Aug. 30.—An agreement was reached today under which union mine pumppmen and engineers will remain at work even if miners strike to prevent mines flooding and causing-in during period of idleness.

Under the terms of the proposed adjustment of differences in the wage scale miners now working 12 hours would receive 23 cents a day less for working eight hours instead of 12 hours and overtime for more than eight hours, in addition to any general increases granted.

### Plans Completed for Meeting Road Builders of Nation

RALEIGH, Aug. 30.—Plans are practically completed for the 1924 convention and road show of the American Road Building Association, of which Frank Pace, chairman of the North Carolina Highway Commission, is president. It was announced today at the Highway Commission offices. The convention will be held in Chicago the week of Jan. 14.

H. K. Witherspoon, editor of the North Carolina Highway Bulletin, and Charles M. Upham, state highway engineer, who had charge of North Carolina's exhibit, at the association's convention and road show last year, already are planning for a more extensive display at the approaching event. Maps, showing the growth of the state's highway system since the last show, models of improved roads and photographs of some stretches of highway in this state will be exhibited.

Mr. Upham has been appointed by Mr. Pace to manage the road show. The engineer is expected to go to Chicago some time in advance of the convention in order to complete arrangements. Exhibits are expected to be entered by practically every state in the union. Road machinery and material manufacturers will also maintain exhibits.

Returning From Orient.

"It would not seem to be a matter of serious doubt that much may be accomplished in the direction of creating and preserving harmonious relations between nations and toward the reduction of causes of international disagreements, if the principles of international law should receive consideration at a new conference of the nations in accordance with recom-

### Forged Notes Used To Convict Man Of Killing Sweetheart

NEW YORK, Aug. 30.—An opinion handed down by Judge McLaughlin, of the court of appeals, declares that William Creasy, of Covington, Ky., was sent to the death house at Sing Sing prison on the strength of a forged letter known by the prosecutor who appeared against Creasy to be such, it became known today. Creasy's conviction for the murder of Edith Lavoy, Freeport, N. Y. school teacher, who was said to have refused to marry him, was set aside last month by the court of appeals when a new trial was ordered.

Ninety-four bidders submitted proposals for 12 of the 13 projects offered in yesterday's bidding, with the aggregate of low bids totaling \$2,427,105.34. No bids were received on the thirteenth project, that being the short stretch of paving out of Wilmington on Route 20 toward Charlotte. No contracts have yet been awarded.

## NO FOUNDATION FOR DISTURBANCE IN CUBA, REPORT

WASHINGTON, Aug. 30.—A message received today by the Cuban legation said peace prevailed and that "there was no foundation for the report of political disturbance," and quiet reigned throughout the republic.

It has been learned that erroneous reports published in Cuba led the legation to obtain from the state department a definite statement that American Ambassador Crowder had made no statements that the United States was backing any group of faction in the Island.

When information was sought what the attitude of the American government would be in case of internal trouble, legation officials were told that the United States, as a matter of course, could not state in advance its possible position in a hypothetical case.

## Smoot Declares Bonus Will Pass In New Congress

WASHINGTON, Aug. 30.—Prediction that the new congress would pass a soldier bonus bill is made by Senator Smoot, (Rep., Utah), who is slated to be the next chairman of the finance committee.

He made this statement after a conference with Secretary of the Treasury Mellon. He is understood to have told Mellon that bonus legislation is inevitable in view of the changed line up in both houses and that the treasury department must face the problem of financing it.

In view of this outlook, Senator Smoot declared that the prospect of tax reduction was not favorable and that congress might provide some new levies, such as a sales tax, to meet the cost of the bonus.

Considerable speculation is going on as to what President Coolidge will do if the bonus question is put up to him.

American Legion representatives who have called on him predict that he will sign the bonus bill but the United States chamber of commerce which took a leading part in this fight against the bonus last year, urged the President today to oppose it.

## Hold Undertaker On Inciting Riot, Count

PITTSBURG, Aug. 30.—Patrick J. McDermott, Carnegie undertaker, arrested in connection with the rioting Saturday night at Carnegie, during which Thomas B. Abbott, a Klansman, was killed, was released from the Allegheny county jail today on \$10,000 bond after a charge of inciting to riot had been filed against him. McDermott had been held upon order of Coroner Wm. J. McGregor, but today he was turned over to the district attorney's office.

The filing of the inciting to riot charge and his release on bail followed shortly afterward.

## Girl Leaves Suicide Note; Seen With Beau

FAYETTEVILLE, Aug. 30.—Susi Hardy, 15 year old girl, East Fayetteville, who left a note on the bank of the Cape Fear River stating that she was drowned in the river, and for whose body the river was dragged was seen by several persons today, according to information gathered from reliable sources.

The girl is said to have been seen at 5 o'clock this afternoon going in the direction of Hope Mills, with a youth who works in the cotton mill where she is employed.

Admiral Knox Dies Suddenly.  
ANNAPOLIS, MD., Aug. 30.—Rear Admiral Henry Knox died suddenly last night on a train en route from St. Louis to Greenville, Ohio. It was announced here today. Death was due to heart failure.

## Police Prepare For Clash At Funeral of Slain Gangster Head

NEW YORK, Aug. 30.—In grim Essex Market court, whence "Kid Dropper" walked to meet death at the hands of a rival gangster, Mrs. Jack Kaplan, the Dropper's widow, met with friends today to plan the funeral of the fallen terror of the East Side.

Conversing in low tones, under the eyes of a score of detectives and uniformed policemen on guard to prevent a rumored outbreak of gang warfare which it was feared would result from the Dropper's slaying, the little group agreed on ceremonies with which the gang chieftain will be laid away. The body was taken to a Harlem funeral parlor where services will be held. Scores of detectives will be on guard to insure against possible interference by the Dropper's enemies.

## Sales Beginning To Show Better, Prices Gradually Advance

## Irish Government Leading In Polling

DUBLIN, Aug. 30.—The election situation with unofficial returns and estimates continually coming in, is such that it is almost impossible to form any accurate idea of how the returns stand. No count is yet complete for any constituency, and those candidates whose names have been mentioned as among the elected have not yet been officially declared so.

The declarations announced today, however, greatly increased the confidence of the government and its supporters, and tended to lower the hopes of the Republicans. Labor made a poor start, and neither the farmers nor the independents fared well in the first round of the balloting. The outstanding feature of the elections has been the extraordinarily heavy pollings of the ministers.

## Two Sisters, 60, and 70, Wed Same Day

MISHAWAKA, IND., Aug. 30.—Edna Thornyke, and Ella Thornyke, maiden sisters of Mishawaka, aged respectively 70 and 60 years, the former a well-known school teacher, were married Sunday at Winona to Frank Delamarter, 78, and Emerson Babcock, 65. Babcock was a widower, and Delamarter a bachelor.

## Two British Pastors Slain By Chinese

SHANGHAI, Aug. 30.—Rev. W. A. Whiteside and Rev. F. G. Watt, of the British mission church were shot and killed at Sechwang province, Aug. 14, according to a letter from Min-chow.

## GREECE SEEKS SETTLEMENT IN SLAYING ITALIAN DIPLOMATS

LONDON, Aug. 30.—Demonstration against Greece is being shown throughout Italy because of the killing of five members of the Graco-Albanian boundary mission, at Albania last Monday, according to dispatches. No acts of violence are reported, but the government has been called on to prepare against any possible serious outbreaks.

ATHENS, Aug. 30.—It is understood that Greece is not disposed to accept what is regarded as some of the humiliating conditions imposed by the Italian note because of the killing of five Italian diplomats. In event of a deadlock to reach an amicable adjustment of the affair, Greece will submit question to league of nations. The Greek government has expressed sorrow and offered to indemnify families of the Italians murdered on Greek territory. The Italian note demands the payment of 50,000,000 lire, salute the Italian flag and punish the Greeks responsible for the assassination. An answer was requested within 24 hours.

## FRANK WILSON IS FREED OF CHARGE KILLING T. HARRIS

### Tragedy Occurred In Chicod Section Few Months Ago

Frank Wilson, on trial for killing Troy Harris, in Chicod township a few months ago was acquitted by a jury in Pitt county superior court yesterday.

The trouble it was declared grew out of dispute over Wilson's sister, who was visiting at the home of Harris. Wilson, it was alleged, went to the former's home for the purpose of taking his sister away. Anticipating trouble with Harris, Wilson it was contended entered the room with an open knife. He was followed by Harris and a struggle ensued, resulting in the fatal stabbing of Harris.

The trial of Ivey and Henry Harris, brothers, charged with killing Wiley Jones, in Falkland township a few weeks ago was called today. Testimony of the prosecution occupied the entire attention of the court at the morning session. Defense introduced evidence this afternoon.

Mayor D.M. Clark is appearing for the Harris brothers.

The case will go to the jury this afternoon.

## Requests For Help Exceeds the Supply

RALEIGH, Aug. 30.—Requests for help received by the North Carolina federal employment service during the week ending Aug. 25 exceeded the number of applications for employment, according to the weekly report of director of the service. There were 634 requests for help, while there were only 600 registrations, and of these 620 were placed.

## Disclaim Attempt to Criticize Red Cross

GENEVA, Aug. 30.—Extraordinary efforts are being made at Geneva to lessen the importance of the sensational incident affecting the American Red Cross and the international Geneva organization, and the Geneva officials even hope that they may induce the Americans to come here from Paris and attend the closing of the Red Cross sessions.

## Seek End of Tangle Between Turkish State and Church

CONSTANTINOPLE.—Principles of the future relationship between the Oecumenical Patriarchat and the Turkish government, have been set down by the governing body of the Orthodox church in Constantinople in a decree.

The principles of the decree are that the Patriarchate abandons its former political and administrative activities and remains purely religious institution of pan-Orthodox character retaining its jurisdiction over marriage and cognate questions.

## GRAND JURY FINDS RECORD OF COUNTY SCHOOL BOARD, 1920-21 CORRECT; AUDITING OTHER YEARS

According to the report of the Pitt county grand jury submitted to Judge J. Lloyd Horton today the records of the county board of education for the years of 1920 and 1921, "appeared to give full details."

The report continues: "Mr. Fitzgerald, came before us in response to the charge of the court to ascertain if the records of his office were kept in such manner as to enable an intelligible audit. Mr. Fitzgerald submitted copies of audits made by Hillton & company, of Norfolk for 1920 and 1921 and Geo. R. Doble, of Rocky Mount for 1921-22 and stated that audit for 1922-23 was now being compiled by Hill & company, Rocky Mount and Norfolk. All of these auditing firms are known by reputation by members of the grand jury.

"The reports of the two previous years appeared to be complete and with adverse criticism. Mr. Fitzgerald stated that copies of these reports had been furnished the county commissioners and the state superintendent of public instruction, and that the above mentioned audits were made at the request of the county board of education to comply with the state law. ## FRESH AIR AND HEALTH

Merely to live, everybody must have sufficient air to breathe, and to be healthy, the air should be sufficiently pure and sufficiently moist. Of the truth of this statement there seems to be no doubt. It might be regarded as a time-worn platitude. But the government's health service regards the subject of fresh air in homes and factories as worthy of a special bulletin and entitled to particular attention. Perhaps the health experts are right; their suggestions can at least be considered without doing harm to any one, and such consideration might result in no little good.

In the open air, away from noxious gasses, says this bulletin, ventilation looks after its self. Elsewhere, particularly in houses and in other closed places it might be looked after. No matter how pure the atmosphere in such space may be, any one who enters it at once begins to pollute the air with his breath, and ultimately it will become injurious to health unless renewed by either natural or artificial means.

Such renewal is necessary because, when breathing, one takes oxygen from the air and returns to the air carbon dioxide, which, although not poisonous, cannot with safety be breathed again because it is a product of combustion and therefore devitalized.

Of course, the simplest way of getting a steady supply of fresh air is by opening the windows, but unless these are properly constructed and placed they seldom distribute the air evenly and often cause persons in one part of the room to suffer from heat and bad air, while others are shivering with cold. In factories, if natural ventilation is insufficient, the use of large electric fans, so placed as to draw off the foul air and drive in the fresh, offers the best solution of the problem.

Many persons still cling to the belief that

night air is unhealthy. This belief, says the bulletin, is a survival from the days when people barricaded themselves to keep their enemies from stealing upon them under cover of darkness. Night air is exactly like day air, and neither is anything like so injurious as the air in a room when windows and doors are closed all night.

## FRANCE WILL NOT YIELD

In his reply to the last British note on the subject of German reparations, Premier Poincare makes it plain that France cannot and will not surrender any of its claim or any important concessions while Germany maintains its present policy of resistance. The Premier's reply is expressed in forcible language and cannot be taken as showing marked resentment at the British policy of interference, a policy that so far has given no evidence of good results.

On the contrary it has strained the friendly relations between England and France, and no small part of the British press is emphatic in declaring it uncalled for and offensive in the highest degree.

One of the strongest features of the Poincare reply is found in his charge that Germany has made no effort to pay. Germany has says the Premier, done nothing to establish order in the budget. It has practiced, since the end of the war, a policy of waste and dilapidation. It has increased the numbers and the pay of the public officials. It has wasted in the collection of taxes, giving all sorts of privileges and immunities to the great steel manufacturers and shipbuilders.

It has built a great merchant fleet which today rivals the fleets of England and France. It has dug canals, increased the telephone system and has undertaken, without calculating the cost, all sorts of public works, such as France today is obliged to postpone.

This arraignment of Germany by France is none too severe. It is fully justified by facts that are known to Great Britain and to the rest of the world. Germany has made no effort in the past and is making none today to settle its debts, and to all appearances means to continue its policy of quiescence as long as it is allowed to do so.

France is wholly within its rights in its demands. France went into the Ruhr with a fixed determination and will remain there until Germany is forced to terms.

## Many Ideas On Lincoln Wrong, One Educator Asserts

URBANA, ILL.—To prove what he states is the falsity of some of the current beliefs and conclusions as expressed in much of the literature on Abraham Lincoln, Dr. D. K. Dodge of the department of English University of Illinois, this school year will conduct a course in Lincoln's letters and speeches. Dr. Dodge is regarded as one of the greatest living authorities on Lincoln.

"I expect to show by documentary evidence that Lincoln's famous Gettysburg speech was not scratched on the back of an envelope while he was riding to that famous battlefield, but was one of his most carefully prepared speeches and one upon which he worked about 10 days," Dr. Dodge said in announcing the course.

"The lost speech supposed to have been delivered at Bloomington, Ill., was not lost at all, as it was delivered the next day at Galena, Ill. Contemporary newspapers described in detail the meetings at which Lincoln spoke, but it was not then the custom to publish speeches and one upon which he spoke and thus it was natural that no record of his remarks are found.

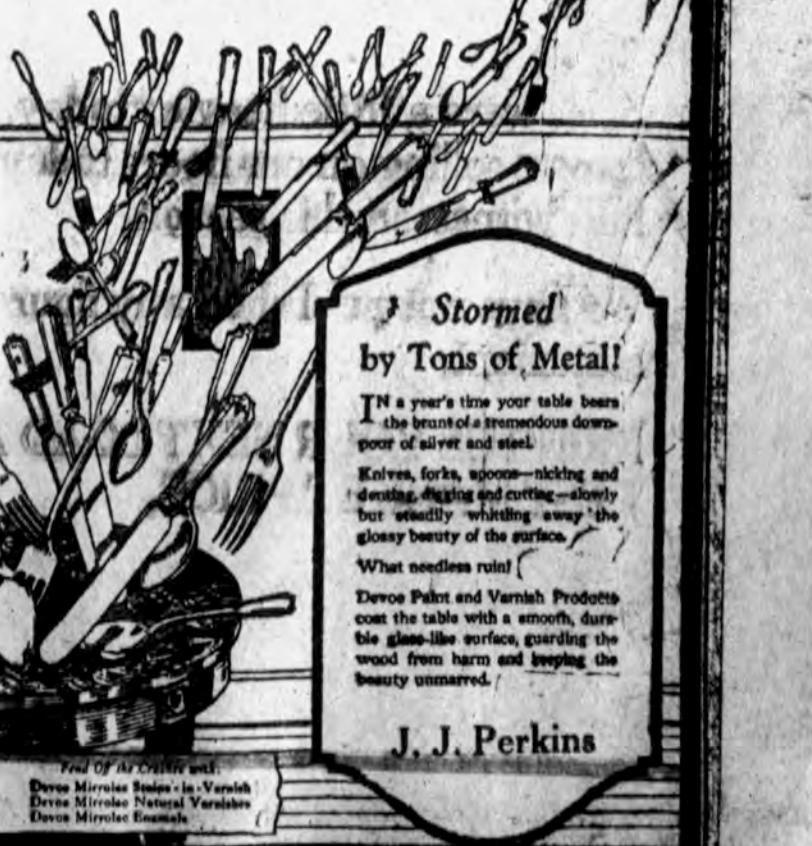

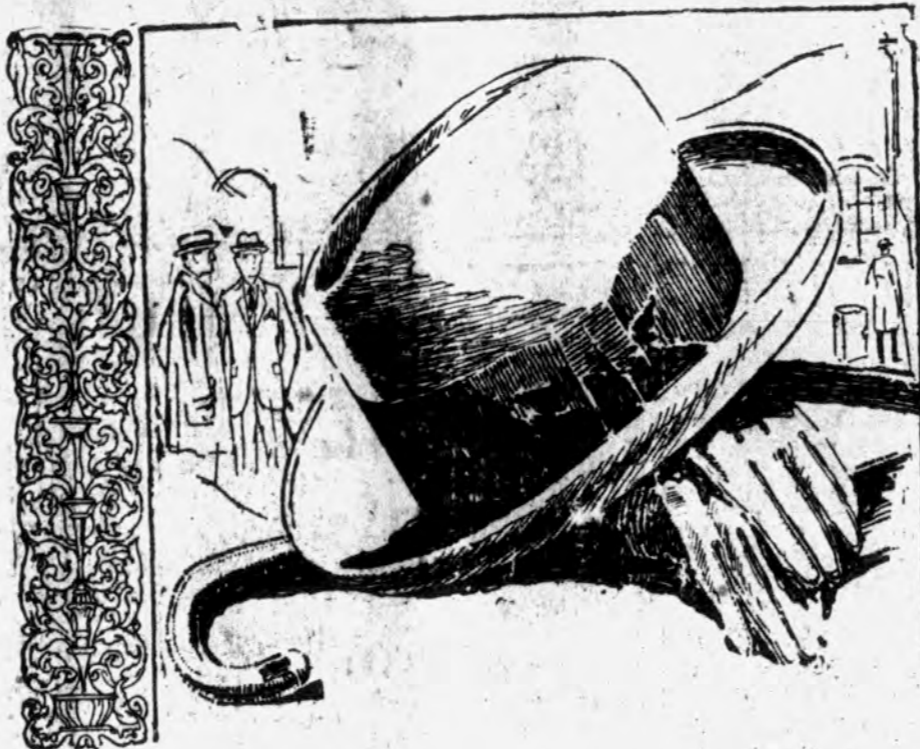
