

Diversification of farming for Pitt county is just as essential as diversification of thinking. The mental horizon which is limited to a few acres which a man will cultivate in a one season crop will never broaden into a wide vision until farmers learn to raise at home diversified crops which will insure a constant money turn over and comfort for their families.

Farmers in other sections of North Carolina and other states are gaining independence who follow diversified farming. There is no longer denying the ravages of the boll weevil in this section. Its advent should be commemorated by planters with a monument that they have abandoned the crop except as a by-product and they are going to concentrate their efforts upon diversified production.

If the farmers of Pitt county can only be aroused to the necessity of this departure in agricultural production its multiple advantages would be realized both in money return and less anxiety and work. Sometimes it takes a shock to bring folks to their senses. Often disaster comes in the disguise of blessing. Kill the boll weevil by substitution of other products and save money!

## HOME DISTRICT OF BERKELEY, CALIF. LAID BARE BY FIRE

### Forest Flames Fanned By the Wind Renders Numbers Homeless

BERKELEY, CALIF., Sept. 18.—Fire swept over the hills of Cragmont and the Euclid avenue district last night and destroyed hundreds of homes with a property loss estimated at 10 million dollars. The fire area covered 60 blocks in the most exclusive district of the city. Approximately 2,500 people were rendered homeless. No lives are known to have been lost, although two students were seen to plunge into the vortex of the flames when the roof of a house collapsed.

According to report received here a number of small towns and resorts or either entirely destroyed or badly damaged. The flames sprung into presence almost without warning and spread beyond the control of the fire department and fire foresters.

El Dorado a small town was virtually wiped out and the population of 150 were forced to flee for their lives. Colfax another small place is ruins and the residents had barely time to escape.

The fires were the result of forest flames which were fed by undergrowth and fanned by strong north-west winds.

## Roaring Planes Encircle London's Busy Airdrome

LONDON.—For the first time since its creation many Londoners who stayed in town on bank holiday discovered London's great airport at Croydon, and were duly surprised to find it very like a main-line railway station.

There is a level crossing near the entrance, where a flagman holds up the road traffic while big Handley-Page and other planes roar across the roadway prior to leaving earth for Paris, Rotterdam, Cologne or Hamburg. Once past the flagman, the visitor comes to a compact village in which headquarters of various air services are situated round an up-to-date hotel, adjacent to a postoffice, meteorological office, air administrative headquarters and customs establishment.

Enormous charts are set up on which the progress of various services are flagged by an official who is in constant wireless touch with planes on their way to and from various capitals. Should any particular plane be arriving late, it is ordered to wait and taxi around until an outgoing liner is clear and so avoid risk of a collision.

## BIG ARRAY OF GUN TOTERS AND LIQUOR LAW VIOLATORS CLAIM ENTIRE DAY OF COUNTY COURT

Robert Jones, carrying concealed weapons, six months on roads; Elizabeth Burnett, maintaining immoral resort, appealed to superior court; Frank Drake, receiving and transporting whiskey, fined \$20 and cost; Alfred Wainwright, possessing whiskey \$10 and cost; David Cavaris, assault with deadly weapon, six months on roads;

## LEAGUE WHEELS WHIRL TALKING ITALY'S STAND

GENEVA, Sept. 18.—The machinery of the League of Nations whirled today as never before. The delegates attacked problems of vast interest and the council of the League in a noteworthy public session frankly debated the question of Italy's refusal to recognize the competency of the league in the Greco-Italian crisis.

The famous Article X of the covenant, which was the main subject of debate, in the United States senate when the question of American adherence was before the American public furnished renewed interest before the commission on amendments to the covenant, when Senator Alvarez, the Chilean diplomat, presented a powerful defense of the Monroe doctrine, which he declared was worth more to the American states than Article X of the covenant ever could be. And this was so, he emphasized, because the American naval and military forces stood ready to enforce this doctrine, which forbade any state from interfering in a territorial sense in the affairs of the American continent.

## COAL DIGGERS BACK TO MINES ON WEDNESDAY

SCRANTON, PA., Sept. 18.—Anthracite miners, representing union workers throughout the Pennsylvania hard coal fields today ratified the new two-year wage agreement drafted by their officers and operators' representatives in Harrisburg September 8. They voted to return to work Wednesday and plans were made at once for the signing of the new contract on the same day.

James A. Gorman, secretary of the joint conference which negotiated the agreement, announced tonight the operators' and miners' representatives would go to Governor Pinchot's home at Millford, Pa., for the signing. This is scheduled for 1 p. m. Wednesday. The fact that the contract will not be signed until afternoon, however, will not affect the resumption of operations Wednesday morning.

## Woman 69, Hikes Over 1,000 Miles From Fla..

NIAGARA FALLS, N. Y., Sept.—Gray haired, small of stature, but with a healthy glow on her tanned cheeks, Mrs. Amanda Chapman, 69 years old, of Miami, Fla., arrived in this city after a hike of 1,462 miles from Miami and 428 miles from Montreal.

She was accompanied by her daughter, Irene R. Chapman, 25 years old. They plan to walk to Chicago, their old home and thence to Los Angeles.

The woman came up the east coast of New York and Montreal.

## SPAIN DOMINATED BY DIRECTOR WHO STARTED REVOLT

Starting with an insurrection in a military garrison in Catalonia, led by Primo Rivera, captain general of the province, Spain is now under the directorate of Rivera as the supreme military power of the nation. King Alfonso refused to follow the dictates of the premier and Spanish ministry to continue the unsuccessful war against Morocco. As a result, the sovereign dissolved parliament and accepted the resignations of the ministry.

Rivera has been authorized by the King to form a new cabinet from the military and best qualified civilians. The revolt was not directed against Alfonso but political leaders. Rivera announces he will start an offensive military campaign against Morocco. King Alfonso and his English Queen, Donna Victoria are doing much to bring order out of chaos. Foreign Minister Alba is reported to have fled.

## PEOPLE IN PANIC AS EARTHQUAKE ROCKS CITY; BUILDINGS DAMAGED

MALTA, Sept. 18.—A severe earthquake shock was felt here at 7:35 a. m. Many buildings were damaged and the churches were filled with worshippers attending masses when the tremor came. People rushed from their homes into the streets in panic. Many were in danger from falling stones. A number of openings in the streets were made by the shock.

## Army Could Not Dry Up Michigan, Says Police Head

LANSING, MICH., Sept. 18.—"We could not enforce the prohibition law in Michigan if we had the United States army," Colonel Roy C. Vandervoort, commissioner of the department of Public Safety and Commander of the state police declared today. "So long as the people maintain their present attitude toward prohibition, the law is not enforceable."

"A man cannot speak with complete understanding of this liquor situation from the office of pulpit," said Colonel Vandervoort. "He must ride the roads 24 hours a day in all kinds of weather, eat and sleep along the river fronts, push on in shacks and holes, when he does not know from one second to the next where a shot will come from, or careen along the roads at night on a chase with the motors roaring and guns barking. Then he can begin to understand."

## Quaker Refuses to Remove His Hat In Court, Draws Fine

ITHICA, Sept. 18.—Steadfast adherence to his religious principles, which forbid him to remove his hat in any public building, resulted in William Mekeel, a farmer, being sentenced to pay a fine of \$20 or serve thirty days in jail, by Justice Charles A. Hitchcock in Supreme Court here.

Mekeel not only refused to remove his hat but also refused to pay the fine, but some philanthropic spectator who wished his name withheld, paid the \$20. Several days ago Mekeel, who had been called as a trial juror, was noted by the Judge, sitting in the court room with his hat on. Ordered to take it off, Mekeel refused, explaining that, as a member of the Society of Friends, he could not. Justice Hitchcock ordered a commitment drawn up for Mekeel's arrest and declared that he would fine him \$50.

## Will Drive Klan From Oklahoma, Walton Says; Extend the Military Zone

### WIFE TO DIVORCE HUSBAND TO LET HIM WED RIVAL

DENVER, Sept. 18.—Acting to carry out a promise which she made last June, to obtain a divorce in order to permit her husband to legalize his marriage to another woman Mrs. Evadene Wright of Denver today filed suit in District Court for divorce from Newton E. Wright, son of a former Presbyterian minister in Denver.

If Mrs. Wright is successful, Wright will be free to legalize his union with Arabella Stoddard of Detroit.

The case first came to the attention of authorities last June when Mrs. Wright caused her husband's arrest in California, where he was said to have been living with wife No. 2 Mrs. Wright charged he had failed to support her and their 11-year-old son. She declined to file a bigamy charge, but said she would permit Wright to go to his second wife in Detroit and later would seek a divorce that he might legally marry wife No. 2 and give a name to their child.

### BOND ISSUES TO BE PAID FROM AUTO, GAS, TAX

RALEIGH, Sept. 18.—North Carolina will pay off its bond issues with proceeds from automobile license and gas taxes, declared Secretary of State W. N. Everett here today.

Everett asserted that the people should co-operate more with the officials in the enforcement of the auto licenses laws. Every cent realized from the licensing of automobiles, said the official, saves that much in taxes to the people, and leaves that much more for the further conduct of the good roads program. If taxpayers who have come up and paid their license taxes would only report those who have not done so, then would help themselves for there would then be this additional money for road building.

The taxpayer who laughs at the law breaker who is operating his car without proper license is in reality laughing at himself, asserted Mr. Everett in effect.

### PAR CLEARANCE TALK RENEWED BY U.S. BOARD

WASHINGTON, Sept. 18.—The Federal Reserve Board's advisory council spent half of its first meeting of the fall session today with a discussion of the controversial par clearance question but when it adjourned tonight members declared little progress had been made and there was no indication of the form of recommendation that may be made. The problem of dealing with banks which fail to adhere to the voluntary free collection system appeared no easier for the council to solve than it has been for, the board.

Besides the question of par clearance, the council took up half a dozen items affecting the mechanical end of the banking business but all, it appeared, were laid aside for further discussion.

### Alabama Using Strap On Prisoners

BIRMINGHAM, ALA., Sept. 18.—The whipping strap which was abolished by former Gov. T. C. Kilby, has been reintroduced in at least one coal mine camp, it became known today, as the result of an inquiry into the whipping of a prisoner at the Banner Coal Mines last week.

OKLAHOMA CITY, OKLA., Sept. 18.—Extension of absolute martial law to Muskogee county the most important section of the eastern half of Oklahoma looms as the next move Governor Walton will make the state fight against the Ku Klux Klan.

The state chief executive telegraphed to officials of Muskogee that "as my secret committee has reported that your community is dominated and controlled by an organization which would usurp all powers of the civil authorities against citizens, whether innocent or guilty and that they might be summarily seized and in some cases murdered by hooded mobs afraid, in order to clean out the organization, will be compelled to take county under martial law."

Because of conditions, it was announced today, the annual state fair at Oklahoma City and Muskogee would be postponed. Officials of these organizations said the financial losses would amount to hundreds of thousands of dollars.

### To Root Out Klan

Military court inquiry here today began investigation of the acts all of the masked organization. It is expected in some quarters that the inquiry will lead to a demand for the records and other data in the files of the state headquarters of the Klan. Governor Walton again reaffirmed his determination to root the Klan of the state. The troops in Oklahoma City continue in control of affairs, however, the civil authorities and courts are not being interfered with. With the exception of clearing off the streets of all persons without proper credentials between midnight and 5 a. m. there is no other sign of military occupation.

### Machine Guns Removed

Machine guns which were mounted on the courthouse and city hall were removed late yesterday with the return of police power to local authorities.

State headquarters of the Ku Klux Klan remained open today but no statement was made by officials as to the organization's attitude toward the governor's declarations of martial law.

### Extend Troop Zone

The adjutant general returned to Tulsa to continue to direct the military activities there.

A company of troops from Enid was expected here to reinforce the local contingent comprising one infantry and one machine gun company.

### Threaten Legislators

Troops at the capitol, besides guarding the entrance, are posted at the doors of the house and senate chambers. This is believed to have resulted from rumors that certain legislators are endeavoring to convene the assembly without the constitutionally prescribed call from the Governor. Governor Walton has threatened to imprison all legislators who attempt to meet here.

## KEEPING THE TAXES DOWN

Recently there appeared a statement that at the end of the fiscal year a surplus existed in the treasury.

When it was suggested that a reduction of taxes might follow, Senator Reed Smoot of Utah warned the public that taxes could not be reduced. The Utah Senator is more frank than some other Senators and does not hesitate to speak very plainly.

Senator Curtis of Kansas says there must be found new sources of taxation.

He has found one, the billboards, the advertising signs along the highways, as legitimate subjects for Federal taxation.

Instead of cutting down taxes these Senators, and perhaps others, are planning to increase taxes.

They want ore money to spend. That is what they consider to be their missions to spend money, not to save it.

The man in Congress who advocates saving money is not considered to be a good politician.

But the people's attitude on this question is not the same as that of these distinguished men.

Progress has been made in putting business into the government, eliminating the duplication of work, reducing the number of useless employes and practicing economies.

If the good work is continued as it has commenced, in a little time a reduction in taxes could take place.

The majority of the people think they are paying high enough taxes now.

They think they are getting too much government and that it is costing them too much. They want to see some plans carried out which will consider their pocketbooks a little and enable them to enjoy just as good government as they have today and pay less for it.

These are old fashioned notions but they exist and must be reckoned with.

## NEW TESTAMENT REVISION

The announcement, made the other day, that the New Testament had, again, been revised may have aroused the interest of Biblical schools and of not a few churchmen, but so far there has been little or no favorable comment upon the work. The revision has been made under the direction of Professor Edgar J. Goodspeed of Chicago University, whose evident aim was to modernize the language of the Testament, to replace the words of the King James' version by twentieth century colloquial terms. No doubt, Professor Goodspeed, who is recognized as one of the best Greek scholars of the country, was inspired by the best of motives and hoped that through his efforts the meaning of all chapters would be brought within the comprehension of even the most unlearned of readers.

New Testament revision is no new thing. In 1881 a commission of English and American scholars, after several years of work in London, gave to the world a new version, which it was thought at the time would take the place of the old. It signally failed to do so, either in Great

Britain or in this country, and very few of the churches are now making use of it. Although it has not entirely disappeared, it never won general approval, and the old version still holds sway.

These revisers made comparatively few changes in the language, but Professor Goodspeed has gone much further and has put St. Paul's famous letter to the Corinthians into such words as these: "If I can speak the language of men and angels and have no love I am only a noisy gong. Even if I give away everything I own and give up myself, but do it in pride, not love, it does me no good. Love is patient and kind. It is not envious and boastful. It does not put on airs. It is not rude. It does not insist on its rights, does not become angry and is not resentful."

Professor Goodspeed goes even further than this in the changes he has made. All the Biblical terms of money value, weights, measures and distances are replaced by such modern words as dollars, cents, bushels and miles; a guard becomes a policeman and a cubit so many feet and inches. Throughout this new version, modern paraphrasing is used, with modern punctuations and quotation marks.

All the quaint dignity of the King James version is lost by this revision. The substitution of modern colloquialisms, sometimes approaching slang, for the far more impressive words of the ancient book will not appeal either to Biblical scholars or to devout church members. The New Testament as it stands today, has remained in use for more than five centuries, and there is no demand for a revised version.

They've been saying some hard things about President Coolidge's new secretary, Bascom Slemp, but the toughest one we've heard is that he resembles his picture in more ways than one.

Broken necks, broken engagements, broken promises, are all being repaired with more or less success these days, but no one has had the temerity to attempt to mend a broken egg.

We may not always see eye to eye with the Japanese, but we sincerely admire the fortitude that withholds them from sitting down to weep in the face of an appalling disaster. Determination to rebuild a greater capital and a greater port is the spirit that gets there.

Experts report that the tendency of the present day youth is to favor white collar jobs. This seems the more surprising in view of the difficulty of keeping collars white in any kind of job.

George M. Cohan, playwright, has prepared a dozen new productions for the stage this season. Cohan is evidently planning for annual retirement early this year.

Coolidge begins plans to enforce the prohibition laws, according to Washington dispatches. It is high time somebody besides the committee of 25 began plans for that purpose.

"Exalted Cyclops" is the title of a high official of the Ku Klux Klan. If we recall our mythology correctly, a Cyclops was a chap with one eye, and he wasn't very far sighted with that.

Pretty soon the girls will insist that the principal test of a desirable suitor is his ability to drive an automobile with one hand.

The Prince of Wales was given a dish of hash to suggest American boarding house life. He can never know the real experience, however, until he faces the necessity of raising a month's overdue board bill.

To the suggestion that the human race is made of two classes, just fools and another kind of fool, we would add a third more dangerous than either: "those who know better."

**LAST WORD IN LIFEBOATS**

COWES, England. — A strange motor-boat painted red and blue, bulky in the beam, with a single mast and peculiar contraptions on her deck, came out of Cowes Harbor at dawn recently and made her way through Spithead at 11 knots. She was the William and Kat. Johnston, described as the largest and most complete lifeboat in the world.

The new craft is fitted with every device man's ingenuity can conceive for fighting storm and saving life. Her length is 69 feet, and she is 15 feet wide. She is driven by twin propellers in protective funnels, and her engines are two six-cylinder 90 horse-power motors.

The engines are encased in separate watertight compartments. In their rigorous tests they were run with these compartments full of water for three hours, and kept going full speed all the time. Forward and aft of the engines are cabins, each capable of holding 25 people.

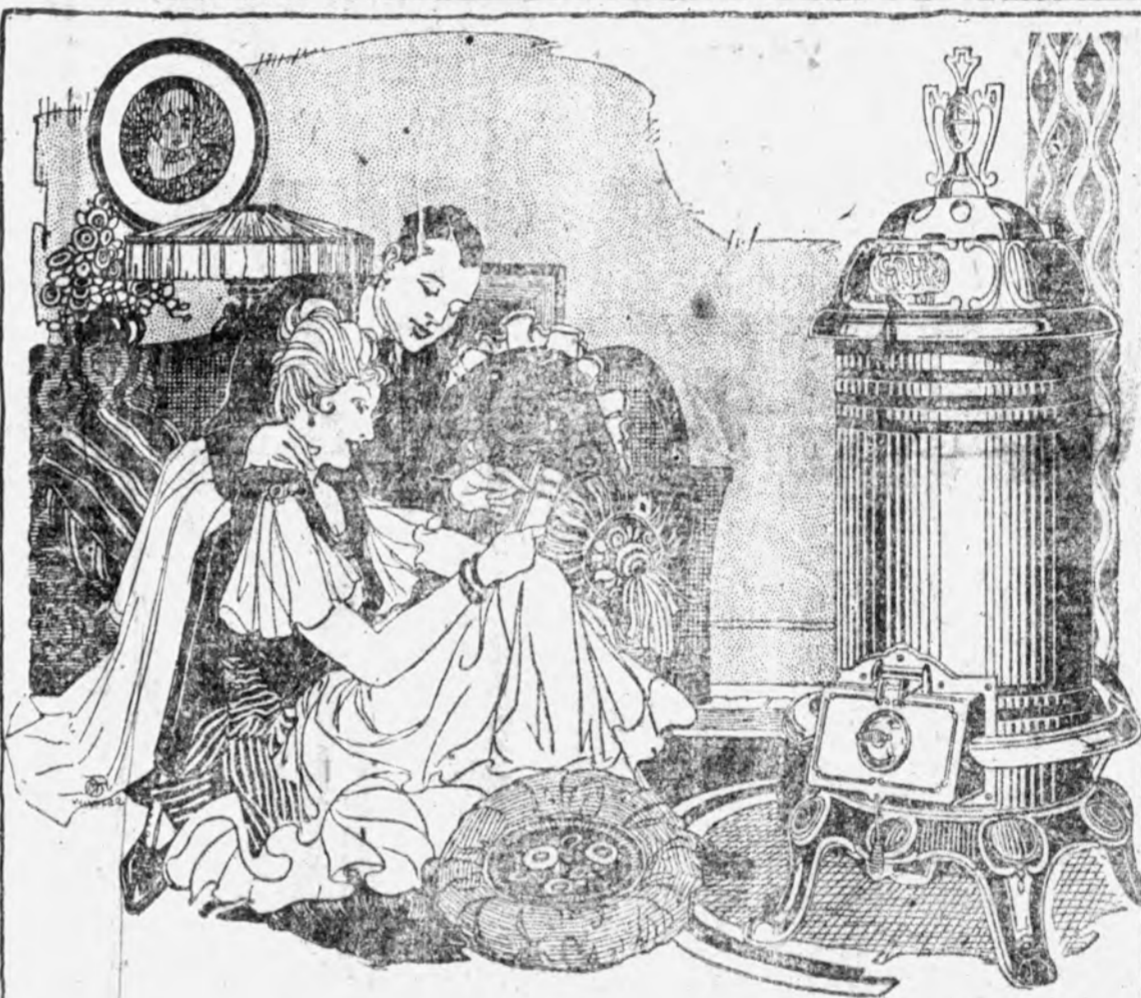

**EX-CROWN PRINCE  
LEADS SIMPLE LIFE  
AS DUTCH EXILE**

AMSTERDAM.—Friends of Frederick Hohenzollern, at one time heir to the German throne, who have visited the exile on the island of Wieringen, in northern Holland, say that he would like to go to the United States and begin life afresh. He realizes there is little chance of his being allowed to return to Germany, and on that account he would like to try his fortune in America. It is difficult to say how Frederick would get on in competition with other men, a thing he has never experienced. The life that would suit him best, his friends say, would be that of an American country gentleman. But the present indications are that he will never be anything, for years to come other than an exile, something halfway between a tourist enjoying an island holiday and Napoleon on St. Helena.

Frederick has been living at Wieringen for five years. He is now 41 years old. His hair has turned completely grey since the war. His face is much fuller, but it is also more furrowed, and his forehead is more wrinkled. His eyes and his gestures are as lively as ever. He has the same abrupt way of speaking. His movements, too, are sudden and abrupt. His attitude toward life is simple. He is not given to deep thinking. He takes things as they are without worrying over their ultimate consequences. He is relatively free from illusions, particularly from the illusions that fill the world in which his

imperial father lives at Doorn. The former crown prince is a convinced monarchist. At the same time he is not embittered because Germany is a republic. He does not meditate the overthrow of the republic, his friends aver. He accepts it with a shrug of the shoulders, although he believes the monarchy would be better for the German people.

**Bolshevists Study  
American Policies**

BERLIN.—Bolshevism has created a laboratory of world politics in Berlin, something new in political science. This institution has little to do with dusty textbooks and dry lecturers. It sends its investigators to the scene of interesting political activities in all parts of the world, and they bring reports to the official staff which keeps abreast of the world press and interprets the information it collects in terms of international consequences.

French army officer who was sentenced to death in France for the part he played in promoting rebellion among the French marines and sailors who were sent against the Bolshevik troops at Odessa in 1919, is among the experts on the Bolshevik staff who are conducting this new laboratory. Jean Aren, who was wounded by the assassin who killed Voroshilov, the Russian unofficial delegate at the Lausanne Conference, is another member of the laboratory staff.

The woman was not in the market for a title, either with or without a prince, but she promised to mention the alluring prospect to some of her friends, and thus extracted further information about the property from the enterprising real estate man. He withheld the name, but assured her the island is well located and is highly desirable both as a summer and winter residence. It has an old castle which is in need of repair, several hundred acres of vineyard and farmland badly in need of modernization, and two villages, also badly in need of repair, with about 500 inhabitants.

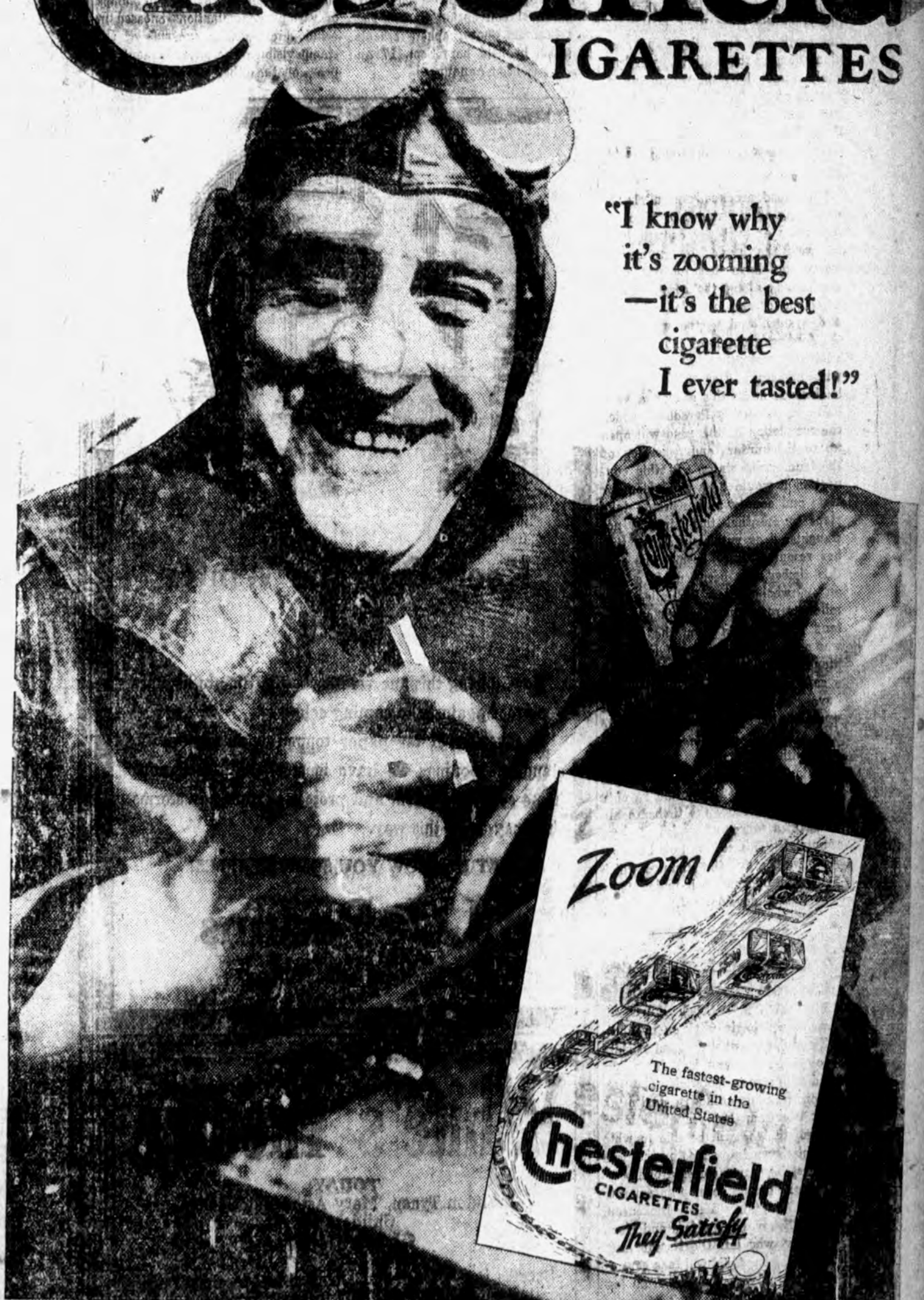

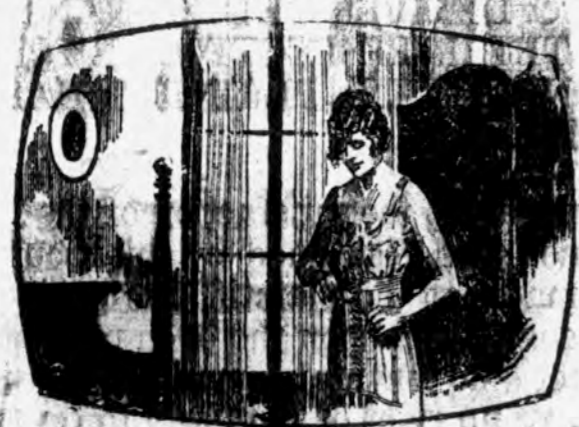

**"CONQUERING A SEA OF SAND" IN BUILDING STATE HIGHWAY ROUTE TOLD BY ENGINEERS WHO BUILT IT**

RALEIGH, Sept. 18.—Writing in this month's issue of the North Carolina Highway Bulletin, official publication of the state highway commission, A. L. Cornell, Jr. and G. B. Cooper, resident engineer employed by the commission, in an article appearing under the heading, "Conquering a Sea of Sand," tell of the progress of the construction of state highway route No. 30, which runs from Wilmington in a northeasterly direction towards Virginia's southern border.

"Beginning at Wilmington and running in a northeasterly direction through the towns of Jacksonville, New Bern, Washington, Williamston and Gatesville to the Virginia line," reads the article, "that portion of the state highway system known as Route 30 presents many interesting features of highway construction, of which the first 50 miles, known as the Wilmington and Jacksonville highway, will be dealt with in this article."

"Pender and Onslow counties traversed by this highway are situated in the extreme southeastern part of the state bordering on the Atlantic Ocean and by reason of this location are very sandy and poorly drained. This territory is sparsely settled owing to the difficulties of transportation which the construction of this road will relieve in a large part. This section of the state was settled at an early date by people from the New Bern section on the north and from the Cape Fear plantations on the south who were probably attracted by the wonderful resources of the territory in the way of fish, oysters and game and also the great forests of virgin timber which at that date covered the whole coastal plain.

"The road practically parallels the coast line at a distance of three to five miles or just far enough back to avoid the heads of numerous creeks and bays that jut out from the sounds along the coast. These bays, and creeks are filled with fish and oysters, and in the winter are the feeding grounds of thousands of wild duck and geese. These together with numerous deer that roam the backwoods make this section a veritable "Sportsman's Paradise," which the completion of this road will open up to the hunters and fishermen of this and other states. In this connection it would be a good idea for state and county authorities to take steps to see that this game is not slaughtered as ruthlessly as the timber resources have been. The way this timber has been cut is a blot on our whole state. For miles after mile the road runs through cut-over land that judging from the stumps was a wonderful growth of long leaf pine and had it been properly cut on a sane and conservative basis would have still been a great source of wealth to the state. It is not too late yet to adopt a reforestation plan and with the almost subtropical climate which the proximity to the Gulf stream affords it would be only a few years before the timber could be again a source of wealth to these countries. This section now lies dormant waiting for the stimulus which a modern highway will undoubtedly give toward development.

**Princeton Coach Places Gridiron Hope in Rookie**

PRINCETON.—Coach Roper tomorrow will begin work on his football squad, somewhat depleted of stars through graduations last June, but filled with strong material. The pre-season training grind is starting a week later than last year, but Roper believes that he will be able to whip a great eleven into shape by the time the first big game comes around. Princeton must develop linemen to replace Captain Mel Dickenson, "Pink" Baker, Ollie Alford and Howard Gray, who left Old Nassau last June. The backfield will take care of itself, the only serious loss from last year's varsity being Jack Cleary. Charles Caldwell and Harvey Emery, both of whom played well at defensive halfback last year, have returned. The new Captain, "Whooops" Snively, first string lineman as well as a backfield star, probably will be coached to command Princeton's aerial attacks.

**Ruined Russians Smile At World's Rough Hand**

LOS ANGELES.—Building new American careers out of the wreckage of prosperity wiped out in the Russian revolution is a task optimistically undertaken by former subjects of Czar Nicholas who have found themselves stranded in Los Angeles, according to Elizabeth Beglaroff, Russian secretary of the International Institute of the Young Women's Christian Association.

Some, however, are more fortunate. For instance, there is a former military officer who has found success as a college instructor in mathematics. Another, a former general in Kolchak's army, conducts a school for Russian-American children, but a third former officer of high rank, an aristocrat of the old regime, is unable to find even menial work. **Landlord Not Liable to Tobacco Grower Cooperative Association For Crop of Non-Member Tenant.**

ORDER DISSOLVING RESTRAINING ORDER

This CAUSE coming on to be heard before Hon. J. Lloyd Horton, upon the temporary restraining order heretofore issued in this cause, at Chambers in Greenville, N. C., on Saturday, September 15, 1923, and being heard upon the complaint, affidavits and oral testimony offered by both plaintiff and defendant, and a serious question having been raised both by the answer and the evidence offered as to whether E. D. Bowen is a member of said Association, and it being made to appear to the satisfaction of the Court that most of the tobacco grown upon the lands of the said E. D. Bowen is cultivated by tenants who are not members of the Association; and it also being made to appear to the satisfaction of the Court from admissions of counsel for the plaintiff that the plaintiff association is deducting from the first advance made to its members five cents a pound for the failure of its members to deliver the tobacco grown by their tenants who are non-members, and the Court being of the opinion that under the contract which the plaintiff alleges that the defendant signed and which is at issue in this cause, THAT THE PLAINTIFF HAS NO RIGHT OR AUTHORITY TO DEDUCT ANY SUM ON ACCOUNT OF THE FAILURE OF THE LANDLORD TO DELIVER THE TENANT'S PORTION OF THE CROP ACCORDING TO THEIR RESPECTIVE RENTAL AGREEMENT, AND THAT BY SUCH CONDUCT THE PLAINTIFF HAS BREACHED ITS CONTRACT WITH ITS MEMBERS.

And it being further made to appear to the satisfaction of the Court from admissions of counsel that unless enjoined and restrained by this Court, that its purpose is to deduct from any advance made to the plaintiff five cents per pound for all tobacco which the defendant's tenants sell upon the open market, or deliver to any other person regardless of whether said tenants be members of said Association, which this Court is of opinion they have no right or authority to do under said contract, and the doing of which would be a breach of the contract on the part of the plaintiff.

It is therefore Ordered, Adjudged and Decreed by the Court, THAT THE TEMPORARY RESTRAINING ORDER HERETOFORE ISSUED IN THIS CAUSE BE AND THE SAME IS HEREBY DISSOLVED AND SET ASIDE AND THE DEFENDANT IS HEREBY PERMITTED TO SELL AND DELIVER HIS TOBACCO UPON THE OPEN WAREHOUSE FLOORS OR OTHERWISE AS HE MAY SEE FIT upon entering into bond in the sum of \$1,000.00, conditioned to pay to the plaintiff all such damages as the plaintiff may finally recover of the defendant in this cause.

The above decision was handed down by Judge J. Lloyd Horton, in Pitt County Superior Court Saturday, September 15. It means that tobacco grown upon properties of landlords cultivated by tenants who are not members of the Association that the Association has no right or authority to deduct any sum on account of the failure of the landlord to deliver the tenant's portion of the crop according to their rental agreement.

The Court makes it clear that the association is without right to collect 5 cents per pound liquidated damages as against landlords for tobacco sold by non-member tenants, and deducting same from the landlord's CROP IS A BREACH OF CONTRACT.

Further, Judge Horton, in dissolving the restraining order against the defendant held that the Association is making deduction for tobacco sold on the open market by non-member tenants had breached their contract with the defendant, E. D. Bowen. In view of the circumstances the Court permitted Bowen to give bond and sell his tobacco upon the open warehouse floors or "otherwise" as he may see fit.

This sets at rest confusing reports covering the right of non-member tenants to dispose of their tobacco to their best advantage.
