Courtesy which costs nothing is one of the best and most important business builders there is, while discourtesy drives away customers and should be one of the blackest offenses on the store calendar. Absence of courtesy is quickly observed, particularly by the transient patron.

It too frequently happens in dealing with the transient purchaser that the transaction is regarded by the retailer as if he were doing the customer a favor to sell him goods. Fortunately that is not the case in Greenville. Merchants and clerks in some places frown upon the person who would use the telephone or buy a two-cent stamp when in a hurry. That's short-sighted business policy.

Possibly it is not either understood or appreciated that thousands of retailers are spending vast sums of money to get customers into their stores, while others get them for nothing—just the price of courtesy. It is true that salesmen are often called upon to wait on customers who would try the patience of Job. Yet it is their duty to exercise that patience to maintain business favor.

Troops Ready to Give Protection to Blacks In Mitchell Outbreak

SPRUCE PINE, Sept. 28.—With troops on duty to afford every protection efforts are being made today to bring back the negroes numbering between 150 and 200 who were driven from this vicinity by a mob of armed men Wednesday, following an attack by an escaped negro convict on an aged white woman. The negroes were employed by highway contractors and mining companies. Work on two highway projects has been abandoned until the return of the laborers.

Troop F calvary, Asheville, of the state national guard and another company from Morganton are here on orders from Governor Morrison. Adjutant General Metts is in command. The latter has directed Major Robinson of Roxboro to take charge. Last night 15 ex-service men were sworn in as special deputies. They are all crack marksmen and will assist the military in protecting the negroes. These deputies will work under the direction of Captain Edward Hensley, war hero.

There has been no evidence of mob violence since Wednesday when the negroes were rounded up, marched through the streets to the railway station and ordered to board box cars and leave the town with the injunction never to return.

Last night small bodies of men gathered about the streets and watched the movement of troops, but there was not the slightest indication of resistance or desire for trouble.

It is understood that a number of warrants will be issued for the leaders and members of the mob. While parading through the streets Wednesday, the mob with guns on their shoulders posed for a picture. The photograph, it is believed, will furnish the means of identifying the leaders. Persons who witnessed the parade declare the negroes were not handled roughly. They were merely told they must leave and not return. The blacks offered no resistance and left the section as quickly as possible, some by train, others by trucks, while a number trudged over the mountains on foot.

WARD, WEALTHY BAKER, FREED OF MURDER CHARGE

WHITE PLAINS, N. Y., Sept. 29.—Walter S. Ward was acquitted yesterday of the charge of murdering Clarence Peters.

As the foreman announced the verdict, a cheering throng of spectators, mostly women, climbed over rows of benches and chairs to grasp the hand and kiss the face of the wealthy baker's son.

Ward, blushing, smiling and chewing gum, tried in vain to fight his way through the milling crowd that packed the court room and reach the side of his wife, who had fallen into the arms of his brother, Ralph, when she heard the jury's verdict. Mrs. Ward was in an ante-room. Ralph burst in with the glad tidings and with a murmur she sank into his arms.

It was not merely a polite demonstration that greeted the verdict of "not guilty." It was an outburst of emotion. For ten days the court room has been packed and most of the spectators each day have been women.

BODIES OF VICTIMS OF RAIL WRECK, STILL IN WATERY TOMB

CASPER, Wyo., Sept. 29.—Twenty hours after Chicago, Burlington & Quincy train No. 30 dropped through the bridge spanning Cole, Creek, ordinarily a dry course, changed into a torrent of raging waters by continued rains only two of the 30 or more bodies submerged in the coaches have been recovered. Rain and snow forced rescue workers to abandon further attempts to get the bodies from the coaches submerged in the creek. It is said a number of bodies have been washed down the stream.

The body of Dan Schultz, baggageman, was recovered after it had washed free of the wreckage. Professional divers are among the rescue party, but railroad officials believe an attempt to reach the watery tomb is too dangerous. Further efforts will be made today to hoist the cars above the waters with heavy cranes.

LESS THAN THIRD OF CHILDREN IN ORPHANAGES STATE ARE ORPHANS

RALEIGH, Sept. 29.—Less than a third of the 3,002 children, white and negro, in orphanages in North Carolina are full orphans without either father or mother, according to detailed information compiled by the state board of charities and public welfare and mailed to orphanage officials at the request of the North Carolina Orphans association. Miss Mary G. Shotwell, of the staff of the board, has recently completed assembling information relative to each of these 3,002 children, which necessitated visits to all the child-caring institutions in the state.

Uniform cards containing this data have been carefully tabulated, giving some hitherto unavailable statistics, and are now on file in the office of the State Board. Of the 3,002 children in orphanages in North Carolina 402 have fathers living; 1,046 have mothers living; 248 have both parents living; and 946 are full orphans. One hundred and ninety-one are illegitimate. There are 1,193 children who belong to 357 families containing three or more children. Twenty-six hundred and ninety-five of the children cared for in orphanages in North Carolina are white and 307 are negroes. Fifty-four of the living parents are inmates of the state hospitals for insane. In the cases of those children whose fathers are alive, some are insane, some invalid and some have deserted their children, according to the reports.

METHODIST WOMEN'S FEDERATION HOLD ENTHUSIASTIC CONVENTION; NORTH MAKES STIRRING ADDRESS

The Pitt County Federation of Methodist Women of the M. E. Church, South, convened in Jarvis Memorial Church, Greenville, for its initial meeting since organization in June, Tuesday, Sept. 25.

The President, Mrs. J. W. Lovelace of Farmville, called the meeting to order, and Rev. V. P. Scoville, pastor of the Greenville church led the devotional exercises, after which he, on behalf of the Church, the Woman's Missionary Society and the City, extended to the Federation a cordial welcome, which was responded to by Mrs. O. C. Stroud of Ayden. Mrs. Lovelace then stated the object of the Federation, which is to organize Mission Societies in every church in the county. This is the newest movement in missionary work, and is a national one.

A business session followed, and as the Secretary, Mrs. J. W. Mr. Gorman was the second son of Mr. and Mrs. J. N. Gorman, of Greenville, and was born in Chass City, Va., Jan. 21, 1891. He was a devout member of the Memorial Baptist Church and was active in the Baracca class of the Sunday School. For a number of years he was actively engaged in the tobacco business with his father. He was widely known in business circles and possibly enjoyed the friendship of more farmers in this district than any man of his years.

Besides his wife, who was Miss Evelyn Lang, Mr. Gorman is survived by his daughter, Edith Lang, his parents, Mr. and Mrs. J. N. Gorman, and three brothers, Richard, Thomas and Calvin.

FARMER RELIEF PROPOSALS

President Coolidge has before him definite recommendations from the Secretary of Agriculture, Mr. Wallace, regarding relief measures for the American farmer. Outstanding among them are a proposed reduction in the freight rates on agricultural products "of at least 25 per cent," especially on export products, and the establishment of a government agricultural export commission or corporation with board powers.

The Secretary of Agriculture, in a two-hour session of the cabinet, gave a resume of conditions, both domestic and foreign, with particular reference to the wheat situation. He announced that he had little faith in the efficacy of arbitrary government price-fixing of wheat crop, as has been proposed by several members of Congress from the northwest. Such a course, he said, might afford temporary relief, but unless production of wheat were controlled it would only make conditions worse.

It is interesting to note that Secretary Wallace did not, at this time, advocate a special session of Congress to enact legislation to aid

the farmer. One of his proposals, a reduction in freight rates on agricultural commodities, requires no legislation. It can be handled by the Interstate Commerce Commission, and, in fact, it is known that the commission has already been requested by the administration to give this matter its close attention. The other proposal, calling for an export commission or corporation, would necessarily have to have the approval of Congress. The War Finance Corporation already has been given additional powers to aid in the export of agricultural products, but apparently Mr. Wallace is of the opinion that these powers should be considerably broadened, or that a new agency should be provided.

The railroads, naturally, will not look with favor upon the proposal to cut their earnings on the transportation of agricultural products. But if the burden of transportation charges is greater than it should be—and that such is the case has been declared many times by men who have studied the subject—there should be prompt action by the commission.

The statement issued by the Secretary following the cabinet meeting admits the government has a very definite responsibility not only to the wheat farmers, but to farmers in general, to come to their assistance at this time. The "war administration," the statement points out, was in part responsible for the present wide spread between what the farmer obtains for his products and the prices he must pay for supplies he must purchase.

The war administration controlled prices of agricultural products; it caused a large extension in cultivated acreage and increased production, creating a surplus which is now burdening the farmer; it has caused a decreased per capita consumption of wheat and meat; it caused large advances in freight rates; it brought about large increases in the wages of labor, and encouraged the cost-plus system in industries other than agriculture, thereby adding to inflation of costs.

The Secretary put his finger on the sore spot—the wide difference in the prices which the farmers pays today for his needs and the prices which he gets for his products.

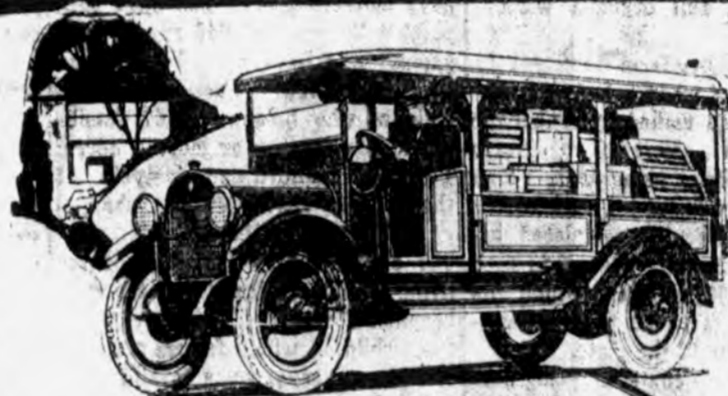

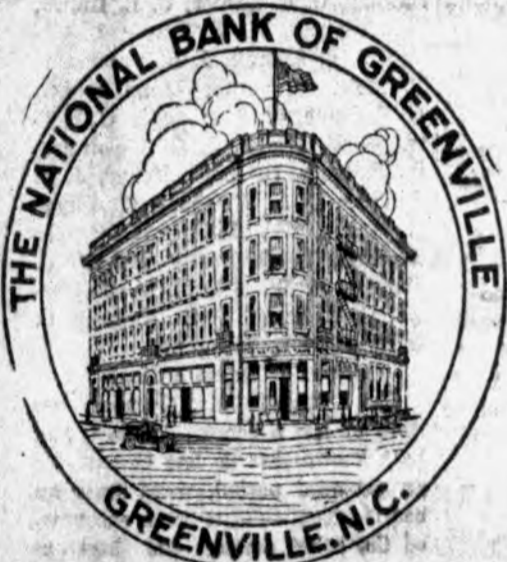
