### POSTMASTERS AND POLITICS

Postmaster General New has announced that the army of postmasters and postal employees is not to be mobilized as such in the interests of the republican party during the national political campaign next year. Addressing the twenty-third annual convention of the National Association of Postmasters, the Postmaster General said he intended to keep the Post Office Department absolutely above suspicion in the matter of politics.

It is a healthful sign. The postal service is a part of the great civil service of the country, which after all, is responsible for governmental efficiency and service to the people. Too much politics in the government service is as detrimental to that service as too much politics is to any big business organization. Furthermore, to use the civil service, or any branch of it, as a great political machine is injurious to the country at large. It is no more nor less than using government funds raised from the whole people through taxation, to help retain a political party in power. This is true no matter what party may be the beneficiary of such a machine.

The postal service has not always been above suspicion in matters political in the past. Post office jobs have been regarded as the plums which fall in the mouths of deserving republicans—or democrats—on the change of an administration. The efficiency of the appointee has been considered not at all, whereas the ability of the appointee to "get votes" has been a requisite. The Postmaster General, in a measure, has been regarded in years gone by as the politician of the administration, the man who could crack the whip and turn out delegates for the renomination of President at a national convention, the man who could well be selected to act as chairman of the national committee to run a campaign for the administration. With thousands of jobs at his disposal, he was popularly believed to be in a position to make promises of preferment to "come through" when an election had been carried.

Postmaster General New, in his effort to show that politics is to be taboo in the postal service next year, even went so far as to announce there would be no postal conference conventions next year, for fear that they might be considered—or might be used for the purpose of influencing the coming elections. These conferences, he said, should be resumed after the campaign was over.

### AMERICAN BANDITRY

Robbing the paymaster or the money messenger has become a standard occupation with a certain class of Americans. Nearly every day somewhere in the United States such a crime is committed. Now it is a paymaster on his way to discharge the pay roll who is held up. Again it is a messenger on his way to the bank with cash who is waylaid. The thieves acquire accurate knowledge of the habits and routes of the messengers with money, and, working in gangs with guns and motor cars, they operate swiftly and in many cases successfully. The total of funds stolen in this way in the course of a year is very large. Many lives are lost in this warfare between the crooks and the owners of cash.

Recently one of these crimes occurred in New York—the scene of frequent bandit work—in the center of the business district, in daylight. Two messengers were on their way with \$15,600 to a bank to make a deposit, leaving the establishment by the rear entrance. Just as they reached their waiting car they were confronted by a gunman who commanded them to hold up their hands.

One of the messengers whispered to his companion: "We're cornered! Let's shoot it out." He began firing from his pocket—all money messengers must be armed nowadays—and the robber fell. But his companions ran toward the car, from their own

motor car across the street, firing as they advanced. Before the melee was ended the messenger who started the firing was slain. The money was saved.

Conveyance of money through the streets has become extremely hazardous. Some banks in the large cities use collection wagons, steel lined, with squads of armed men in charge. So numerous are the pay-roll robberies that a great many large employers are paying off by check. But the problem of getting the cash into the banks remains, short of the armored collection car, to be solved.

This is truly a desperate situation. This crime of banditry in the crowded cities would seem to be profitable enough to attract men despite the heavy risk. There appears to be no lack of recruits for the ranks, however heavy the casualties from gunfire or from prosecutions. The remedy, it is plain, lies in safeguarding valuables more securely, in making it more difficult, if not impossible, for the gunmen to seize the cash in transit. To this end banks and business men throughout the country are cooperating now, with the result of a general change of practice.

### PROTESTS FROM THE RAILROADS

Secretary Wallace of the Department of Agriculture has succeeded in arousing the ire of the railroad executives of the country by his suggestion that the freight rates on all farm products be cut twenty-five per cent. Such a reduction, the executives declare, would result in little gain to the farmers, but would mean a disaster to the carriers of the country.

One of the railroad presidents insists that to take off twenty-five per cent of the gross earnings would mean the removal of a larger sum than the roads are now earning net. Other officials of important lines assert that the chief carriers of agricultural products are already trailing behind in the point of earnings. Such a cut, they declare, would mean approximately two cents a bushel more that the farmer would get for his wheat, hardly a boon of sufficient size to warrant any such drastic assault on railroad rates.

There is very little danger that any such cut will be made, and it is difficult to figure out just why Secretary Wallace offered the suggestion. In some quarters it is looked upon as a sop to the agricultural interests of the country, in the hope of keeping the farmers in line for the Republican Presidential candidate for next year.

At first glance, it looks like a political move, though there is no evidence at hand to prove that the Secretary is backed up by other members of the Cabinet. President Coolidge has already put himself on record in favor of giving the railroads a square deal, and there is nothing to indicate that he has any immediate intention of changing that policy.

The Interstate Commerce Commission will soon begin hearings on railroad rates, but its chief aim will be to bring about more equitable figures without any great increases or decreases in the present rates. There is no doubt that much of the discontent among farmers is due to the cost of getting their products to market, as well as to the low prices offered in the north and foreign lands.

Secretary Wallace may be sincere in his efforts to help the farmers, but he has not offered a practical solution of the problem.

Record-breaking building operations might seem to promise lower prices for houses if it were not for the fact that young persons persist in growing up, getting married and hunting homes.

For some time German's government has consisted of a prolonged cabinet crisis.

Another earthquake, this time in the vicinity of Quebec, calls attention to the fact that the earth is having a shake-up geologically as well as politically.

Now approaches the "winter of our discontent" made hideous by the high price of coal.

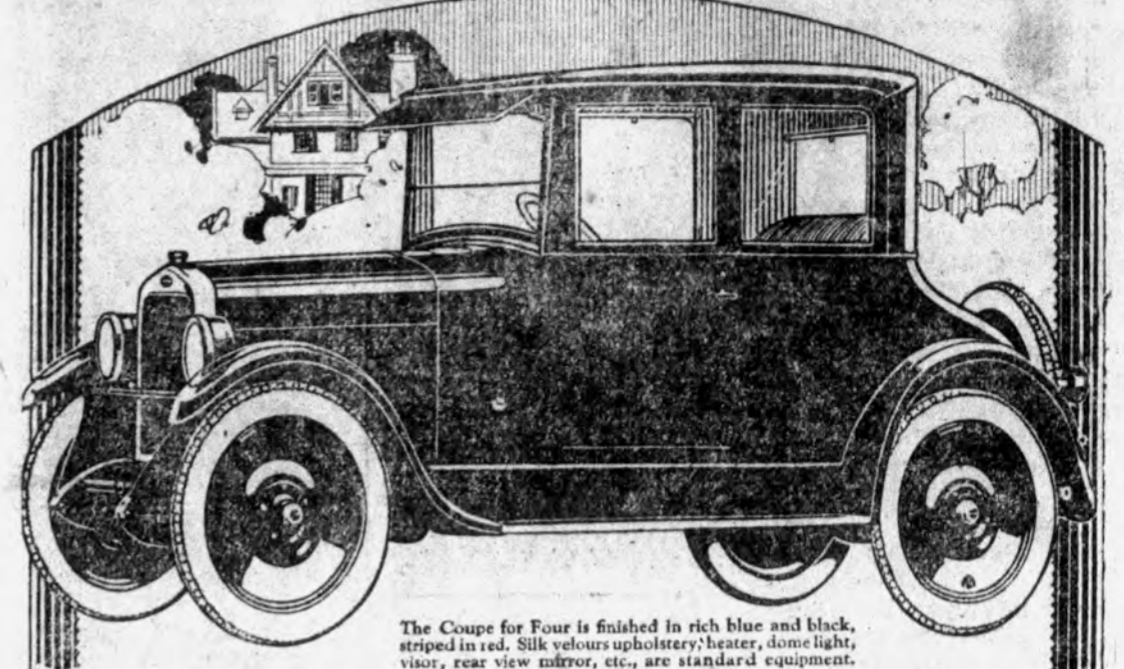

# Community Action To Assure Better Child Health Nationally Is Chief Reason For Big Conclave

The American Child Health Association's first annual meeting in Detroit, October 15 to 17, will be unique in that it will not only draw together some of the most eminent child health authorities in the United States, but from other nations as well.

Among the chief speakers will be Herbert Hoover, president of the Association, who will deliver the opening address; Dr. George E. Vincent, president of the Rockefeller Foundation; Mrs. William Brown Meloney, noted author and editor, and a director of the Association; Mayor Frank E. Doremus, of Detroit; Dr. Haven Emerson, professor of Public Health Administration of the College of Physicians and Surgeons, New York, who was Health Commissioner of New York from 1915 to 1917; Miss Maud Brown, who is a child health education specialist of nation-wide reputation; Dr. William J. French, director of the Fargo, N. D., child health demonstration; A. D. Jamieson, secretary and scout executive of the Detroit Council of the Boy Scouts of America, and Monsieur J. Maquet, Directeur-General de l'Oeuvre Na-

tionale de l'Enfance, and Secrétaire de l'Oeuvre Nationale des Orphelins de la Guerre in Belgium. M. Maquet was given a place on the program at the suggestion of the Commission for Relief in Belgium Educational Foundation. He will speak on "Belgian Colonies for Dehilitated Children."

Some of the topics for discussion and papers to be read will deal with "community programs for child health," "how the general public can bring about better co-ordination of community activities for child health," "the workers in child health education and their duties," "practical methods of teaching health to children," and "the newer phases of public health nursing, and the health of the child in relation to athletics and physical training."

This is a tentative list and is expected to be augmented as the convention draws nearer.

The convention, as the association's first, is expected to be the forerunner of others which will serve annually to bring together the child health experts of the country for suggestion and solution of subjects which will raise child and maternal

health in the United States to a higher plane. Since its organization in January, from a merger to the old American Child Hygiene Association and the Child Health Organization of America, the association has grown rapidly until now the membership numbers nearly 5,000 and extends to many foreign lands.

The aims of the Association are to achieve this child health improvement through helping communities to increase their own health protection to a maximum, through teaching, literature, the founding of scholarships for doctors, teachers and nurses in health work, and by other means designed to increase the health knowledge of parents and children.

Herbert Hoover is president of the Association. Dr. L. Emmett Holt, noted child health authority, is first vice-president; Courtenay Dinwiddie is general executive, and Ella Phillips Crandall is associate general executive. Headquarters of the Association are at 532 Seventeenth Street, Washington, and executive offices at 370 Seventh Avenue, New York City.

**Problems of The High Cost of Living  
And of Avoiding Household Drudgery  
Solved By Soft Coal Miners' Wives**



No wonder this miner's wife from Logan County, West Virginia, is a plump and healthy-looking person. Her expensive washing machine saves her all the labor of the family laundry; and, no matter how much she uses it, how much "juice" it eats up, the cost will be the same—twenty-five cents a month. For she rents her home and her lighting from the coal company that employs her husband.

There is an old adage about the way to a man's heart. It should be a corollary to it now—the way to his peace of mind. You reach the first through his stomach; the second through his wife. Get her happily settled in her home, and you'll find it hard to move him.

Of course efficiency experts word the case differently. In a brief recently submitted to the United States Coal Commission by the Bituminous Operators' Special Committee, such an expert says:

"On one point all coal operators agree, and that is, that labor turnover is expensive, and, furthermore, that the labor turnover is influenced approximately fifty per cent. by houses and living conditions."

To spare themselves this expense, operators put their capital instead into elaborate company towns, al-

though such towns are necessarily built in remote regions and destined to last only a limited period, because the more you work a coal mine, the shorter its life becomes. For that reason miners themselves cannot be expected to build. Hence the origin of the company-owned town which the operator supports—because it pays him to keep his laborers contented. Regular towns they are too, with churches, schools, hospitals, "movie" theatres, pool rooms, clubs. The houses rent for a \$1.00 or \$2.00 a month per room for the same type of accommodations that cost two hundred percent. more in adjacent towns. No wonder the industry is overmanned! Combine these living conditions with the high wages paid for mining—a comparative study of thirty-six big industries shows that miners' salaries outdistance those of other laborers by a big percentage—and you have two reasons why there are at least two hundred thousand more men in the coal business than it needs. Down-trodden slaves exploited by heartless operators for their private profit? That's how some people describe the miners. But can you describe a miner's wife and her electric washing machine in that pic-

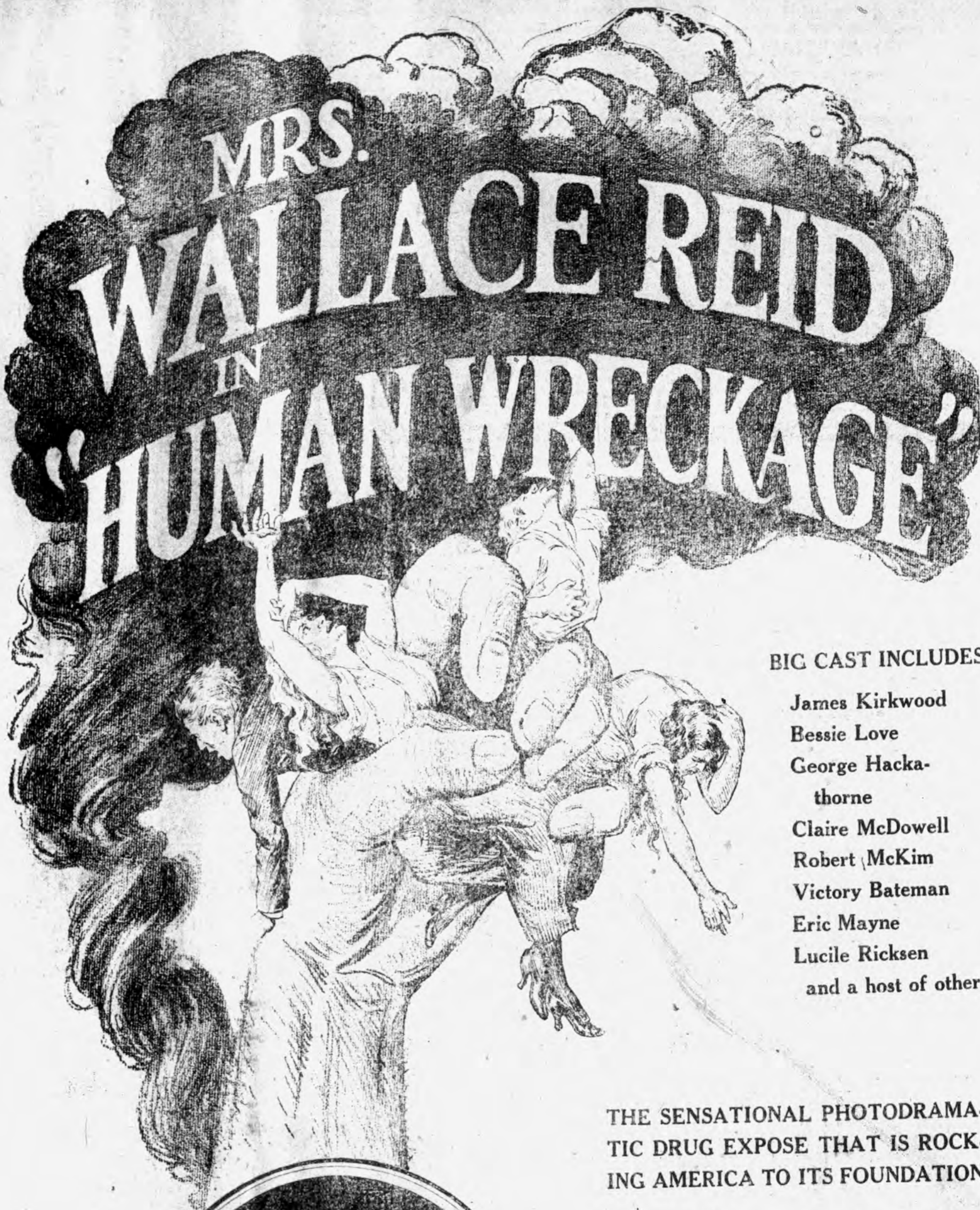

**TEAM WORK OF VITAL INTEREST TO BANKING, G. W. PRESCOTT TELLS COUNTY BANKER'S ASSOCIATION**

(This paper on "Team Work and Its Value in Banking" was read by G. W. Prescott, cashier of the First National Bank, Ayden, before the meeting of Pitt County Bankers' Association, Wednesday.)

By G. W. Prescott.

The subject of team work and its value is of vital interest to every bank and in discussing this question it is important to know something of the relation of the employee to the institution he serves. This relation is more than a matter of salary. While every employe should receive a compensation commensurate with the services rendered and feel like a just reward will come to those who faithfully and efficiently perform the duties assigned them, this should not be the only objective in accepting a position which carries with it the responsibilities and opportunities afforded in the banking profession.

The employes of a bank are a vital part of the institution—just as essential as the customers or the capital, and I think it is the duty the bank owes its employes to help them increase their skill and stimulate their ambition. It should give to them the enthusiasm, the skill and the pleasure to the extent that they merit, them by loyalty, efficiency and proficiency.

**Enthusiasm Necessary.**  
No organization can render the efficient service required of it unless the working force in charge of its operations are imbued with the spirit of pulling together for the betterment and upbuilding of the institution.

No greater asset has any bank, even though not listed in our financial statement, than a progressive, efficient, co-operative set of men and women who are alert and alive to the best interest of the institution and any one on the pay roll of a bank who does measure up to this standard is a costly liability.

Banking is a business, the importance of which should be recognized by every employe from the janitor to the president. When we consider the almost incomprehensible figures of banking statistics the profession becomes deeply interesting and even fascinating. Yet banking to most people is a mystery and is little understood even by those who are dependent upon its services.

**Wide Purposes Served.**

According to some writers on banking the earliest idea of the bank was a safe place for deposit. Those who possessed valuable goods coin and precious stones would take them to an institution whose duty it was to safeguard the property. Gradually these institutions were called upon to meet certain demands until they developed into something resembling the institutions of today.

Whether this account of the origin of banking is correct or not is of no immediate importance. The bank of today finds its reason for existence in conditions of commercial life which have only incidentally to do with the safe keeping and storage of money and valuables.

**"Service" Must Be Slogan.**

The bank of today has developed far away from its earliest origin. It now finds its principal function in the performance of services to the community which at the beginning were a minor part of its work or were not even recognized at all. Service should be the slogan of every bank and unless the men and women who make up the working personnel of a bank are filled and thrilled with the spirit of service, working together, co-operating for the best commercial interest of the community, that bank cannot perform its functions with the degree of force that will commend it to the public as worthy of support.

The roots, the bark, the fiber and the leaves all combine to form the giant oak, the cedar and the pine and the failure of either to properly function with the others produces an imperfect piece of timber. The bundle of sticks is a beautiful emblem of the strength in co-operation. Separate the sticks and the strength of a child may destroy them; but while united a giant's power might be exerted in vain to break them.

**Plan of Co-operation.**

Just simple co-operation or team work in the banking business is not sufficient. It is necessary for the employe to know something about banking. There are two methods of securing this information—experience and study.

Thousands of our best bankers have secured it through experience, painful years of practice and hardships. Today we have the opportunity of profiting by the experiences of others.
