REV. J. A. ELLIS IN POWERFUL SERMON ON ARMISTICE DAY

Greatest Anniversary Service Ever Held In City; Many Attend-

Armistice Day was appropriately celebrated in Greenville, yesterday, the day being featured by services in the Jarvis Memorial Methodist church in which all churches of the town united to pay honor to the ex-service men of the late world war. Dr. J. A. Ellis, of Raleigh, delivered the sermon while a most interesting musical program was also enjoyed.

The church was decorated in keeping with the occasion, with service flags, American flags, chrysanthemums and potted plants. A large design contributed by the Greenville Floral Company, made of flags and flowers, with the white dove of peace holding streamers of red, white and blue, bearing the inscription 100 per cent Americanism was arranged in the center of the pulpit and attracted the attention of all attending. The ex-service men attended in large numbers and occupied reserved seats in the center and on the right, while the Boy Scouts occupied the front seats on the left. The main auditorium and the Sunday school rooms were filled to their capacity with people from all sections of the county who gathered to pay their respects to those who served and those who died for democracy.

Dr. Ellis, pastor of Pule Memorial Baptist church, Raleigh, an ex-service man, delivered a most powerful and appropriate sermon, using for his text, Math. 20:26. "But it shall not be so among you but who-soever will be great among you, let him be your minister," and developed his thoughts from one great subject, "Greatness through Service."

The speaker declared that it was not necessary for a people to be intellectual nor wealthy to be great but that if they ever reached greatness they must reach it through service. He reviewed the services rendered by the people at home during the years of '17 and '18 and paid a tribute to those who never donned a uniform yet who played just as important part as the lads who went "over the top." He recited in connection with the greatness of service, "Mother of Men," and "The House by the Road," in the latter showing where the services rendered mankind by two old people inspired a poet to write the beautiful poem.

Mr. Ellis further declared that America could accomplish great things if it would mobilize its men and win the world for Christ, just as its mobilized its soldiers and won the world war. "The home is back of all government," stated Dr. Ellis, and when the home fails then the nation fails. The child is taught in the home before it reaches the school and then it should have the value of service instilled in its young mind. If America is to be great, and live up to its great opportunities it must be great in service and unselfishness. If she tries to save herself she will fail. Now is the time for her to reach out to all nations and let her voice be heard in the League of Nations and other ways in which she can "serve."

The speaker related many instances showing the great service rendered by the boys during the war and told of their unselfishness in a most touching manner. He appealed to the large audience to live up to the great issue of service and bear the torch which the boys had passed to them or their deaths would have been in vain.

The day's program was by far the greatest ever presented on an Armistice Day and came at the exact time of the signing, the eleventh hour, the eleventh day and the eleventh month.

A committee from the Pitt County Post of the American Legion planned the events of the day and is to be congratulated upon its success and for the splendid program rendered.

GOV. MORRISON IN SPLENDID ADDRESS DAVIDSON TODAY

Endorses Sentiment Ex- pressed in Wilson's Armistice Address

DAVIDSON, Nov. 12—Endorsing the sentiment expressed in Woodrow Wilson's Armistice Day speech and adding an extended discussion of the views on the foreign policy of the American government, Governor Cameron Morrison addressed the assembly here today celebrating the opening of a new state highway, the anniversary of Armistice Day and Davidson College Founder's Day.

Governor Morrison stated that there had never been and never would be a middle ground position for the United States with respect to foreign affairs. We ought to walk right into the League of Nations and from the front stage a fight for world peace or we should boldly declare that the war is over and deny all responsibility for world affairs and return to our isolation to view without responsibility or concern the struggle of a lacerated world, said the governor. The main weakness, said Mr. Morrison, with the Republican form of government is that it always reflects itself when confronted with difficult foreign affairs. The American government had overcome this only to become involved again after the signing of the armistice, for immediately partyism and factionalism broke loose in America, and when Woodrow Wilson submitted a tentative organization to make permanent world peace the weakness of the republic quickly disclosed itself.

Morrison asserted that this nation cannot hold a middle ground position but that we ought to go into the League of Nations at once or withdraw from foreign affairs except those of vital concern to our domestic issues as our present position is making us ridiculous before the world.

Grant Appointed Head Denver Mint

WASHINGTON, Nov. 12—Robert J. Grant, supervisor of the Denver mint, has been appointed by President Coolidge as director of the mint to succeed F. E. Coby who recently resigned.

CHARTER GRANTED LUCILLE SHOPS CHAIN OF STORES

RALEIGH, Nov. 12—Secretary of State W. N. Everett has issued a charter to Lucille Shops, Inc. to operate a chain of stores for the retailing of men and women's wearing apparel with headquarters at Charlotte. The amount of capital stock is \$125,000 and the incorporators are M. Z. Zimmerman, A. F. Moses, and R. C. Faucett of Winston-Salem and U. A. Zimmerman of Bethlehem, Pa.

SUPREME COURT DECISIONS TODAY HANDS DOWN 3

WASHINGTON, Nov. 12—The California-Washington alien land law was held valid and constitutional by the United States Supreme Court today.

Justice Butler stated that it was clearly in the power of the state to prohibit aliens from purchasing or leasing lands if such alien was ineligible to citizenship of this country or had not expressed intentions of becoming a citizen. He held also that there was nothing in this act that was repugnant to the agreements between the United States and the foreign nations.

The Interstate Commerce Commission order prohibiting railroads from collecting a penalty charge of \$10 per car per day on lumber or other forestry products was sustained by the court.

The Tax Equalization Act of Georgia was also declared constitutional. This case was the result of a suit brought against the sheriff and other county officials of Warren county, in that state, based on the contention that no hearing was granted the taxpayer before the county assessors before the tax was made effective. The court held that the taxpayer was guaranteed a hearing before an arbitrator and that it was not necessary that he be given a hearing before the assessors made their levy.

Veterinary Medical Association To Meet In Greensboro Soon

GREENSBORO, Nov. 12—Delegates from the eight southeastern states were arriving here tonight for the annual meeting of the Southeastern States Veterinary Medical Association which will open here tomorrow morning for a two day session. The delegates will represent Virginia, Carolina, South Carolina, Alabama, Georgia, Mississippi, Louisiana and Tennessee.

The convention will open with an address of welcome by C. W. Roberts of the Greensboro Chamber of Commerce, a response being made by Dr. J. G. Forneyhough, state veterinarian of Richmond, Va. The annual address of the president, Dr. M. Jacobs, of the University of Tennessee. The report of the secretary treasurer, Dr. John I. Handley of Atlanta, Ga., will follow immediately.

After addresses by Dr. John R. Mehler, chief of bureau of animal husbandry, Washington, D. C., Dr. R. H. Parker of Gastonia, N. C., and Dr. A. G. G. Richardson of the University of Georgia, the convention will recess for lunch after which the delegates will be given an auto ride about Greensboro.

The afternoon program includes several addresses and at the night session a banquet will be served followed by other addresses. The next day's sessions will be taken up with business transaction and addresses followed by a barbecue. The convention is expected to adjourn Tuesday night.

TENNESSEE FARMER KILLS SEVEN OF HIS TEN CHILDREN

CHATTANOOGA, Tenn., Nov. 12.—Buck Garrison, a farmer, shot and killed seven of his ten children at his home near Dayton, Tenn., late Sunday afternoon according to information received here today. Garrison's wife and the other three children escaped death. Posses are scouring the vicinity for Garrison, but so far he has not been apprehended.

News of the tragedy was brought to Dayton by the wife of Garrison, who had run several miles, according to latest reports from that place. Arriving excited and out of breath she gasped the meagre details of the crime. She stated that her husband had shot the children one at a time with a shot gun stopping each time to reload the gun. According to her statement Garrison had been drinking heavily lately.

German Reply Very Unsatisfactory To The Allied Council

PARIS, Nov. 12—The German note replying to the protest of the Allied Council of Ambassadors against the return of Ex-Crown Prince Frederick William to Germany was received here today. It is understood that the nature of the note is very unsatisfactory to the allies and the members of the council were hurriedly called for a meeting this afternoon to give the note consideration.

This note it is said states that Ex-Crown Prince Frederick William has the same rights as any other German citizen and that the German government has no reproach to make against him.

FRANK A. BARNES CONFEDERATE SOLDIER DIES IN PHILADELPHIA

PHILADELPHIA, Nov. 12—Frank A. Barnes, former Confederate soldier and prominent figure in Maryland politics several years ago, died today while here on a visit at the home of his granddaughter. He was 86 years. At one time he was Adjutant General of Maryland but recently he has been making his home in Wilmington, N. C.

Conflicting Reports Regarding Arrival of Ex - Crown Prince

LONDON, Nov. 12.—Former Crown Prince Frederick William has arrived at his estate at Oels says a Berlin correspondent of the Central News. At Wusthausen, near the German capital, he was welcomed by a short speech by the burgomaster.

CELS, SILESIA, Nov. 12.—At 11 o'clock Oels was patiently awaiting the arrival of Ex-Crown Prince Frederick William and no definite information as to when he would join the Ex-Crown Princess here would be learned.

Nathan Mayo Achieves Success In Southern State

TALAHASSEE, Fla., Nov. 12—Another native North Carolinian has achieved success in a Southern state with the elevation of Nathan Mayo to the position of commissioner of agriculture of Florida. Mr. Mayo assumed his duties on November first.

Mr. Mayo was born on a plantation in Nash county, the son of Colonel James M. Mayo of Richmond, Va., who married a North Carolinian. In 1886 the family moved to Ocala, Florida where the boy received his early education. His earliest venture into business was at the age of 12 years when he went into a cold drink venture under the name of Mayo and Livingston, the business being housed in a piano box.

Later he became a partner of a drug concern but did not care for the confinement. At the age of 23 he removed to Summerfield, Fla., where he entered the general merchandise business, the store which he organized has now recognized as one of the largest general merchandise companies in that section of the state.

The new commissioner has extensive interests along agricultural lines, having a large farm and owning a citrus grove. He has twice served in the legislature of the state.

Shennandoah Flight Postponed Later Date

WASHINGTON, Nov. 12—The giant naval dirigible Shennandoah will not make her scheduled flight today over New England from the Lakehurst, N. J., hangar on account of unfavorable weather. According to an announcement the same flight over Newport, Providence and Boston will be made the first day that the weather is favorable.

COOLIDGE BEGINS WORK ON MESSAGE TO NEXT CONGRESS

Agriculture, Taxation, Transportation, May Be principle topics

WASHINGTON, Nov. 12—President Coolidge today began actual work on his message to be delivered to congress when it convenes. Upon the result of this effort it is acknowledged by his closest friends depends to a great degree his political future. Coolidge realizes as much as his friends the importance of his first message and pronouncement of his political views and will devote his entire time to work on the document during the three intervening weeks before congress convenes. It has been agreed between the president and his secretary, C. Bascomb Sloop that all appointments during that time be limited to those that are absolutely necessary in order that nothing may interfere with work on the message.

Although the actual work on the document began today a great deal has been accomplished toward the message for the past three months in conference between the president and officials and private citizens which covered discussion of the government's problems. Coolidge has talked with experts on international affairs, railroad heads, labor leaders, farmers, bankers, newspaper men, politicians and just plain ordinary citizens and the information gained will no doubt be of great help in preparing this his first message to congress.

With this information at hand the president sat down this morning to write his message. The principle subjects which will be treated in the address are fairly well known by those who have followed closely the trend of the president's conferences. The topics will probably be agriculture, taxation, transportation, merchant marine, government expenditures and international affairs including the world court and the recently negotiated convention with Mexico.

The three subjects which it is likely will be given major consideration are agriculture, taxation and transportation. With an idea of assisting the farmer the chief executive, it is expected, will urge legislation promoting co-operative marketing and ask the creation of an agency for selling American farm products abroad.

Separatists Leader Arrested Early Today

BERLIN, Nov. 12—Adolph Hitler, leader of the recent Munich revolt, was arrested early today near Lake Starnitz in southern Bavaria. He offered no resistance to the arrest.

GOOD TIMES

That keen and canny observer of the times, Judge Elbert H. Gary, sees in our present industrial and business situation nothing but rounds for optimism. Prosperity is here, he declares, and backs up his statement with good reasons for the faith that is in him. The steel and iron industry, dependent in its reactions upon so much that is basic in the country's material conditions, will show "a considerable profit" for the year; the demand for immediate consumption has been and still is along some lines, in excess of ability to supply. Judge Gary sees in the establishment of the eight-hour day for labor in the iron and steel mills a wholesome and hopeful event. He views the political chaos with marked optimism, remarking hopefully that "business will have cordial, appropriate and effective assistance from the national government, limited only by fixed rules and principles and the general welfare of the people."

Judge Gary sagely stops short in his predictions at the point where his intimate knowledge of conditions ceases. But reports from the country at large bear out his optimism. The forces that produce and the forces that construct are, for the most part, content with what the year has brought forth and heartened by what the future promises. Building activities have been notably vigorous, harvests are bountiful and agricultural values, with some exceptions, firmer than for several autumns past.

In the past three basic industries, then—steel and iron, building and agriculture—the country is prosperous. From springs like these the flow of trade is naturally strong and free.

RECLAIMING WASTE LANDS

"When the South comes to Congress next session, as it undoubtedly will, asking for federal assistance in the reclamation of its waste lands with a view to opening up new areas to farm home development, we of the West should and I believe will lend a helping hand," declared Representative Addison T. Smith of Idaho, chairman of the House Committee on Irrigation of Arid Lands. "It was votes of Southern senators and representatives back in 1902 that made possible the enactment of the national reclamation law that has done so much for our western states," continued Mr. Smith, "and in appreciation of the support

then given us, we promised to aid the South whenever it determined to ask similar legislation affecting its own waste areas. We have been a little slow about redeeming our promise, although never until now has a comprehensive movement been launched in the South looking to a broadening of the national reclamation policy."

Representative Smith, co-author of the Smith-McNary bill that was before the last Congress, a measure that will not be revived in its old form, as it involved too large an initial outlay of federal funds, has not prepared a new bill for presentation to the 68th Congress, and will not draft his new general reclamation bill until after he has attended the Forestry, Reclamation and Home-Making Conference at New Orleans, November 19th to 22nd. He will address that Conference on what irrigation has done for the West, and will get the ideas of delegates to the Conference as to the character of general reclamation bill that should be presented to the new Congress. Representative Smith realizes and admits that the West alone cannot expand the policy of federal irrigation of arid lands, any more than the South, unsupported, can get through Congress a bill that will provide federal aid in reclaiming the overflowed, cut-over and other waste lands of the Southern States. He believes the interests of the two sections are intertwined, and that only through a combined effort can a new reclamation bill be passed, general in its scope, and not sectional.

"Government irrigation has been given something of a black eye before the public," said Representative Smith, "due largely to the inability of the government fully to recover the moneys it has thus far invested in irrigation projects. Criticism of the government reclamation policy is more serious than the facts justify, for irrigation as a whole has been eminently successful, as evidenced by our thriving farms and cities; our contented settlers, and our abundant crops. Irrigation farmers, like all other farmers, have felt the current depression common to agriculture generally, but in the main our irrigation farmers are doing well. A certain element on government irrigation projects, encouraged to believe they could safely repudiate their contracts with the government, have given cause for a criticism of the entire reclamation policy, but the investigation now under way in the Interior Department will develop and broadcast the facts.

"What irrigation has done for the West, drainage will do for the South," he continued. "The South has its vast areas of waste lands that can be made to support farm homes, and the cost of drainage will not be so high as has been the cost of bringing water to our arid lands, and then draining them. And there is a crying need for real farm homes. As I understand it, the movement which has resulted in the calling of the New Orleans conference has not for its purpose the development of vast broad commercial farms, but rather true farm homes such as abounded in Ohio, for instance, a hundred years ago.

"The need of today," continued Representative Smith, "is for more farm homes, where a man can take his family, erect a comfortable house with modern conveniences, and raise enough to support his family in comfort. That was the old idea of the home, and that idea is coming back."

CHILDREN'S BOOK WEEK BEING HELD THRUOUT NATION

Importance Of Books Explained by Organ- izations, Others

The fifth annual Children's Book Week is being held all over the nation this week, Nov. 11 to 17. Public Libraries, Women's Clubs, Parent-Teachers' Associations, the Schools, Churches, and other organizations concerned with children each year take the opportunity of this week to emphasize the importance of books for boys and girls. Exhibits of books to bring for children, motion pictures based on standard children's classics, discussion of the books children really like to read, consideration of authors and illustrators who are devoting their talents to the children's books, these are some of the features of the week in various communities.

All of the town organizations are interested in the child but the Women's Club and the Public Library particularly are standing behind and fostering this matter of right reading for children, which is the aim of children's Book Week. Co-operating beauty are the city schools. In the schools during the week the children will not only be given talks on the meaning and variations of book plates, but they will also design some themselves. Time will be devoted to talks on books, there will be book discussions and book essays in class rooms, and emphasis will be laid on the importance of building home libraries. The ministers of the town in conference last week enthusiastically endorsed the purposes, and aims of Children's Book Week, and on Sunday, spoke to their Sunday schools on children's reading. On Friday afternoon at the Public Library there will be for free distribution a recommended list of books called Foundation Books for the Child's Own Library. This is a list of 35 standard books running from Mother Goose to biography for boys and girls.

Each year over a million children come to reading age. "What books shall we buy for our children?" is a question every parent should endeavor to solve conscientiously. The schools teach the children to read, the Public Libraries give opportunity to boys and girls for forming the reading habit and for developing good taste in books. A growing appreciation of the importance of children's reading is marked in the book stores, and the book publishers of the country are leading the world in the production of interesting books for boys and girls. The books that actually go into the forming of a child's home library are the ones that form his growing taste. His ability to use books for information and pleasure when he is grown older, depends on his acquiring the reading habit when he is a child.

Better books in the home, the school and the library!

LOCALS

S. B. UNDERWOOD CONDUCTS Y. W. C. A. SERVICES AT THE TEACHERS COLLEGE

Mr. S. B. Underwood, at the Sunday evening services of the Y. W. C. A. at the Teachers College, made an excellent talk on the three-fold ministry of Christ, and its application to our life, home, and the leading feature of the service was a violin solo by the Jennette Wedmore.

Mr. Underwood told his audience that one cannot look on a person's life without inquiring some of the things that have made it what it is. Therefore, he asserted, it will do us good to look at the life of Jesus Christ, and at his mission. The more we look at His life, the more we think about the things that He taught, the principles that He laid down, and, consequently, the more surely we will become like Him.

Jesus Christ was in no sense a recluse. Monastic principles did not appeal to Him, Mr. Underwood declared. He loved people. Something in His big heart went out to people. They were His sheep: He was their shepherd. Only when His physical needs made it imperative did Jesus go off alone, and during the time of solitude He sought new strength and help. Where there were crowds, one could find Jesus, and He always had a sympathetic message. Mr. Underwood thinks that we are most like Jesus when we think most of our fellow-men.

Milton says that there is no spiritual growth in hiding ourselves except for rebuilding in order that we may go out with a fresher and newer message. If we mix with people, we appreciate their goodness and their faults, and there is created in us a desire to serve.

Jesus ministered in three ways by teaching, by preaching, by healing. Only a relatively small portion of his time was given to what we call preaching. It is pleasant to remember the masterful way He had of imparting knowledge of laying down principles, and of ministering to those in pain and trouble. Mr. Underwood thinks that Christ, as the greatest of all teachers, should be the model for all teachers. If those who teach give succor from pain, accomplish every task assigned to them, and follow the footsteps of Christ, the stamp of Divine approval is placed upon their work.

Various vocations are too strictly divided into sacred and secular groups. People carry out the commands of Christ when they build up and develop all sides of their nature. Mr. Underwood believes that Jesus wants us to have trained minds, because a trained mind is capable of so much greater service than the untrained mind.

We should attend to our physical needs too, Mr. Underwood declared. Christ's ideal for us is a sound physical body in which to house an alert mind. To Mr. Underwood the passage, "He looked into the faces of the multitude and had compassion upon them," means that Christ saw the need of the people expressed in their countenances, and He met these needs directly and immediately.

He told the students not to consider what they are doing now merely as a preparation for future service. If we carry out everyday tasks acceptably, we are performing our duty as Christians. When you begin a task, think about it, and, if it helps mankind, it has divine approval.

As Jesus goes up and down the earth today, uncertain, not knowing where to turn, disturbed, anxious, His great heart must go out with compassion and His compassion does not merely stop with sympathy. To have compassion to Him means to take steps for relief.

The call for laborers in the vineyard comes clear and strong. "Furnish support whenever you find need. The realization of need is a challenge to the fulfillment of that need." We need leaders, Christian workers. "Be conscious of your obligation," Mr. Underwood urged, "try to be leaders, have compassion on the multitude, hear their call, do your noblest." If you fail to do these things, you are untrue to Jesus Christ, the teacher, the preacher, the healer.

The Lord answers the prayers of Jesus through you and me, and if we fail to answer the call, we are blocking the purposes of God. We should keep ourselves in tune with the infinite. We should put ourselves in line with the divine plans, and help God to bring us nearer to Him.

Dr. A. Taylor Claims Rural Communities Grossly Overchurched

ST. LOUIS, Nov. 12.—Asserting that the average rural community is "grossly overchurched," Dr. A. Taylor of Indianapolis, today suggested to the convention of the American Life Association in session here, that residents of rural districts co-operate in religion for "the sake of a common service." Dr. Taylor is secretary of the board of temperance and social welfare, Church of Christ (Disciples).

"The average rural community is grossly overchurched," declared Dr. Taylor, "and cannot support three or four churches. Most of them are without pastor, program or effective means to reach young people."

"Christianity teaches brotherhood and co-operation. Every other rural institution seeks unity and co-operation. Schools are consolidating, cooperative organizations for marketing are well on the way. Religion will not be denied the expression of its essential spirit of friendship and co-operation."

In suggesting that the rural churches "co-operate on the basis of community needs and for the sake of a common service," Dr. Taylor said: "The co-operation will be on the basis of the things held in common. Full liberty will be allowed on all personal differences. All worship the same Father and follow the same Christ. Let each practice the ordinances and keep other items of faith as his conscience dictates, just as is now done. It is quite as easy for neighbors to do that under one roof as under three or four."

Living Conditions Necessary Surgeons Rural Districts Now

ST. LOUIS, MO., Nov. 12.—"Reasonable living conditions," are necessary to restore permanently physicians and surgeons to rural communities, Dr. H. P. Colwell of Chicago, today told the convention of the American Country Life Association, in session here. Dr. Colwell is secretary of the council on Medical Education and Hospital, of the American Medical Association.

"The objectionable features of country practice," said Dr. Colwell, "are loss of well-to-do patients, long drives, bad roads, hard work, loss of income, increased expenses, poorer facilities for practice, no hospitals, no libraries, no laboratories, few church, school and less of time or opportunity for professional or personal development."

"What wonder, therefore, that the country doctor after struggling in vain against the rising tide of difficulties finally decides to follow his disappearing clientele to the city. It is quite clear also why the young physician, after graduating from medical school, usually in debt for his medical training, prefers to remain in the city rather than go to the country."

"Census figures show that of the total of physicians in the United States 63 percent are in cities of 5,000 or greater population. Leaving and abating in liquor manufacture only 37 percent, in cities or towns of

less than 5,000. In other words in cities of 5,000 or above there is one physician for every 541 people.

"To permanently restore doctors for rural communities requires restoration of reasonable living conditions in those districts."

TROOPS END COMMUNIST RIOTS IN HAMBURG



During the recent fighting in Hamburg, Germany's greatest seaport, on the River Elbe, communists for two days terrorized the city. German troops, rushed to aid the police, put down the rioting, with considerable bloodshed. A number of the communists, with hands behind their heads in token of surrender, are being marched to jail.

OUR TRADE WITH EUROPE AND WITH THE WORLD

Manufactures form a steadily increasing percentage of our exports especially to the non-European world.

September trade of the United States with Europe and with the world as a whole shows gratifying gains and this is especially true in the figures of our commerce with Europe. The September imports from that continent exceed by over \$4,000,000 those of the same month of last year, and the exports thereto are \$37,000,000 in excess of those of September, 1922. The imports from that continent show an increase of about 5% in dollar value and the exports thereto are 22% greater than those of September of the preceding year. Merchandise sent to that grand division in September form 53% of the total exports as against 52.6% in September of last year and 50% in the twelve months ending with September, 1923.

Europe which needs our foodstuffs and raw manufacturing material has always been, says the Trade Record of The National City Bank of New York, our biggest customer, though the share of the total exports sent to other

grand divisions has steadily increased with the growth in our exports of manufactures, which are especially in demand in the non-European world. Prior to 1900 Europe took from 75 to 80 per cent of our total exports while all other parts of the world took from 20 to 25 per cent. With the enormous increase in our exports of manufactures, which jumped from \$485,000,000 in 1900 to \$1,732,000,000 in the calendar year 1922, it is quite natural that the per cent of the exports sent to the non-manufacturing world should show an increase and the share sent to manufacturing Europe a corresponding decrease. So it turns out that the share of our total exports which went to North America other than the United States was in the calendar year 1922 24% against 13 1/4% in the fiscal year 1900, to South America about 6% against less than 3% in 1900. As a consequence of this increase in the exports of manufactures it is quite natural that the percentage which manufacturing Europe took of our total exports should show a decline, and thus the share of our 1922 exports sent to Europe stood at 54% in 1922 against 60% in the fiscal year 1913, though the total value of merchandise sent to that

continent in 1922 was far in excess of that of 1913, standing in dollar values at \$2,083,000,000 in 1922 against \$1,479,000,000 in 1913. The big growth in our exports of manufactures which has changed the percentage of our exports to the various grand divisions, adds the Trade Record, can only be fully appreciated when we compare the totals of the current year with those of the pre-war period. The latest figures of our exports by great groups of articles indicate that the value of manufactures exported in the calendar year 1923 will exceed \$2,000,000,000 against \$1,100,000,000 in the year immediately preceding the war, \$475,000,000 in 1900, \$188,000,000 in 1890, and \$122,000,000 in 1880, when Europe was taking 86% of our total exports and the balance of the world only 14%. With the big stocks of manufacturers which we are able to offer to purchasers abroad, the non-manufacturing world now takes 45% of our total exports against 14% in 1880 when we began the enlargement of our production of manufactures for the export trade. Manufactures form from 75 to 90 per cent of our exports to the non-manufacturing countries, while manufacturing material and foodstuffs form the bulk of the exports to manufacturing Europe.

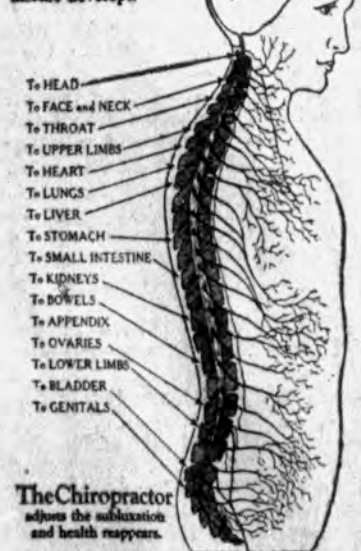
