200 REBELS KILLED; MANY WOUNDED IN ATTACK ON HERMOSA

Huerta Forces Leave Dead and Dying On Field; Fight 30 Hrs.

MEXICO CITY, Dec. 20.—Delayed rebels who were attacking Villa Hermosa the capital of the state of Tabasco have been defeated after a battle lasting 30 hours. According to reports 200 rebels were killed and a large number wounded.

General Gonzalez, military commander in Tabasco, fought gallantly. The rebels fled, leaving their dead and wounded on the field. A large quantity of war material was captured.

A report from General Martinez, commanding the column marching upon Vera Cruz reports "no further developments" today. General Martinez is sending to Mexico City 56 prisoners taken during the skirmish around San Marcos.

VERA CRUZ, MEXICO, Dec. 20.—Newspaper correspondents from the front telegraphed today that the Obregon troops had not abandoned the railway line and had not withdrawn to Muenzo station, as stated by rebel headquarters.

It was reported that the situation was unchanged from yesterday when the rebels columns remained at a standstill around San Marcos. Insurgent leaders, say that troops are centering about Esperanza and Oriental.

The advance by the Obregonists on Puebla, it is believed, is a step toward removing the menace of a flank attack by the rebels. If this movement succeeds and the revolutionists are routed the way will be cleared for an advance against the insurgent troops from Vera Cruz.

Retreat Announced. VERA CRUZ, Dec. 20.—Revolutionary headquarters here announced a general retreat of the Obregon forces from Apizaco.

The retreat of the federal forces was caused by the rebel troops of General Maycotte proceeding from Puebla and renewing the attack on Apizaco, flanking the Obregonists.

The forces which attacked Apizaco are the same as those which on Sunday came to the rescue of the rebels at San Marcos, but arrived there after the Obregonists had been routed from the railway junction town. The Maycotte forces then returned to Puebla to attack the flank of the Obregonists operating there.

Strength of Forces. For the first time the newspaper correspondents with the rebels mention the approximate strength of the rebels advancing on Mexico City. They assert that the figures they give have been confirmed by them. Six thousand men have their base at Puebla under Generals Villareal and Maycotte, and another six thousand are in the two columns advancing from Vera Cruz.

MOVIE DIRECTOR OFFERS TO SELL WIFE TO NEGRO

LOS ANGELES, Dec. 20.—Elsie La Maie, motion picture director and theater man, agreed to sell his wife, Helen, to Lou Harris Baker, a wealthy negro of the Juarez, Mexico, underworld, for a half million dollars, according to a divorce complaint filed here today by Mrs. La Maie.

According to the complaint, La Maie broached the alleged \$500,000 marriage purchase offer to his wife in 1919, and at that time told her she could keep \$150,000 of the "profit." Notwithstanding her rejection of such a proposal, the complaint continues, La Maie continued negotiations with the negro for four years, and recently became "violently angry" when his wife persisted in her refusal.

Verbal Cross Fire Subsides In Church Battle In Gotham

NEW YORK, Dec. 20.—Verbal gunfire subsided in the theological battle being waged in New York between Modernists and Fundamentalists of various faiths.

The broadside of statements which for the last few days has marked the controversy in the Protestant Episcopal church, centering on the threatened heresy trial of Reverend Lee W. Heaton, of Fort Worth, suddenly ceased.

Virtually the only contribution to the discussion came from Reverend Dr. Stuart L. Tyson, vice-president of the Modern Churchmen's Union, supporting Mr. Heaton. Dr. Tyson declared the next move was up to the Fundamentalists and that the Modernists were in the same position as Belgium in 1914—wanting peace, but peace with honor.

Wheat Farmers Cut Production Acreage

WASHINGTON, Dec. 20.—Wheat producers have heeded to some degree the warnings of agricultural experts to reduce their acreage, it was indicated in today's report of the Department of Agriculture, which announced 40,191,000 acres had been sown to winter wheat this fall.

That is a reduction of 5,759,000 acres, or 12 per cent, from the acreage sown a year ago, but the area is 191 per cent above the pre-war (1909-13) average annual sowing.

COTTON GINNED OVER 9 MILLION BALES, REPORT

WASHINGTON, Dec. 20.—Cotton ginned prior to Dec. 13, totaled 9,548,805 bales, including 232,536 round bales; 17,267 American Egyptian, 753 Sea Island, as compared to corresponding period last year of 9,488,852 bales including 161,781 round bales, 24,013 American Egyptian and 5,039, Sea Island, the Census Bureau announced today.

Deposed Chief Of U. S. Engraving Bureau Turns Old Job Down

WASHINGTON, Dec. 20.—Steps were taken by the administration today to terminate the controversy originating from the discharge by President Harding of thirty officials of the Bureau of Engraving and Printing nearly two years ago.

Reappointment as director of the bureau was tendered by Secretary Mellon to James L. Wilmoth, who was among those ousted by the President's executive order, but he declined to accept the offer. The Secretary action, taken after two conferences with Mr. Wilmoth today, was accepted not only as serving to vindicate the deposed director, but to pressage a change in the administration of the bureau as it is now constituted.

Many Mobile Officials Caught in U. S. Dragnet On Whiskey Charges

MOBILE, ALA., Dec. 20.—Mobile today waded through a stretch of agitation seldom equaled in its long existence. Continued astounding developments in the United States government war against whiskey traffic produced excitement and quavers aplenty to vibrate back across the dim and uneven trail of history to the days of Bienville and D'Iberville, who founded the city more than two centuries ago.

Before the day of shocks and sensation completed its contribution to the chronicles of the past, a score of individuals, public office holders, listed among their number, had been enrolled as defendants against Federal charges in connection with the cleanup crusade. Bonds fixed in the cases climbed to the aggregate of approximately \$175,000.

Congress Adjourns For Holidays; the Deadlock in Senate is Unbroken

WASHINGTON, Dec. 20.—Congress began a two weeks holiday today, with the senate organization still incomplete and the session since Dec. 3, presents practically a blank record of legislative accomplishment.

With some of its committees functioning during the holidays the house will be able to get down to serious business after it meets Jan. 3.

The senate will come back to renew its efforts to break the deadlock over the chairmanship of the interstate commerce committee unless leaders, during the meantime, are able to bring about a compromise.

MAKES HIS "PILE" IN WALL STREET; START OWN IDEAL OF NEWSPAPER

NEW YORK, Dec. 20.—After accumulating a fortune of more than \$2,000,000 in Wall Street John Borg, one of the leading members of the curb market today announced his retirement from the brokerage field. He declares that he had turned over the business to younger members of the firm "who earned it."

"I have made my pile," Borg said "and have all the money I need. I am going to devote more time to play and indulge in my pet hobby—the newspaper field. While I am not a newspaperman, I have my own ideals of how a paper should be run in serving the community in which it is located."

STORES TO KEEP OPEN EVENINGS TO SERVE LATE XMAS SHOPPERS

A majority of Greenville merchants from now on until Christmas Eve will keep stores open evenings to serve those who cannot find time during the day to do their shopping. Most of them will maintain the usual Saturday closing hour on Christmas Eve.

Merchants report satisfactory trade and believe that with the close of the pre-Christmas season that a new record will be established in the volume of sales.

Everything desirable for gifts can be had in Greenville. Local concerns anticipating a large holiday trade bought accordingly. The stocks still offer a wide variety of choice in every conceivable line.

That this fact is appreciated is indicated by numerous persons patronizing the Greenville market this season who never did before.

It is a subject of comment that the purchases this year are mainly of the practical useful kinds. Buyers are investing in gifts of the necessary and durable class, rather than the less useful that formerly prevailed.

There is a brisk demand for toys. Future citizens are just as exacting about their playthings as ever before, only with this change—they are demanding a more expensive line of toys of educational and constructive type.

PLAN TO "RAISE RED FLAG OVER WHITE HOUSE" REVEALED BY AGENTS

WASHINGTON, Dec. 20.—Intercepted Soviet instructions from Russia to the Workers' Party of America, outlining detailed plans for a proletarian revolution in America to "raise the red flag over the White House," were made public by the state department in support of Secretary Hughes' refusal to enter into any negotiations with Soviet Russia.

The department's announcement said that the Department of Justice "has assured the state department of the authenticity of these instructions."

Part of the program outlined provided for the organization among industrial workers in the United States of "fighting" units.

"The members of the fighting units in addition to all other matters," the instructions said, "must once a week be given instructions in shooting and receive some instructions in pioneer work (sapper work)."

Summarizing the results to be obtained, the document said: "We are firmly convinced that work in the direction designated by us will give enormous results in the sense of preparing thousands of new propagandists, future leaders of the military forces of the party and faithful fighters during the social revolution."

CUPID SETS RECORD FOR DAY; FOURTEEN HEARTS HIT BY DART

Dan Cupid established a new record yesterday, when 14 heart struck couples applied for licenses to tie the nuptial knot hard and fast. Court officials say the number was the largest issued in any one day in the history of the matrimonial branch of the county.

However, county officials are ready and willing to speed his work and are prepared to issue the "privilege" for "better or worse" to as many that may apply suffering from the indescribable heart sensation—continues called love.

The affirmative will be argued by the Rev. John Roach, of the Calvary Baptist church. He will be opposed by the Rev. C. T. Tucker, of the West Side Unitarian church.

Two Episcopal clergymen and a Christian Science preacher will be his judges at the debate this evening.

Test Huge Dirigible Before Polar Flight

LAKEHURST, N. J., Dec. 20.—Commander F. R. McCrary, of the Navy dirigible Shenandoah, announced tonight that the craft had proven satisfactory in the first of the tests to be made in connection with the proposed flight to the Polar regions next year. For 24 hours the dirigible held secure at the mooring mast outside its hanger, while the wind varied from a six to 20 miles an hour speed and shifted from one point of the compass to another.

New methods by which the ship may be brought down by 100 men instead of the more than 300 used heretofore were also declared successful by the commander.

GUARD DOUBLED IN COURT ROOM; FOX TRIAL NEARS END

Hundreds Crowd To Hear Closing Speeches In Klan Murder Case

ATLANTA, Dec. 20.—Hundreds of persons crowded into the Fulton county superior court room today to hear the closing arguments of counsel in the trial of Philip E. Fox, who is charged with killing W. S. Ceburn, Ku Klux Klan attorney.

Robert W. Allen, Dallas, Tex., member of the counsel for the defense made the opening address for Fox. Allen was followed by Hugh M. Dorsey, former governor of Georgia, leading attorney for the defendant. Solicitor General J. A. Boykin will close for the state.

The 8-year son of the defendant was in court today for the first time. He sat in his mother's lap facing the jury. Fox appeared haggard, pale and extremely nervous.

Additional deputies were on duty in the court room and Fox's guard was doubled.

The case was expected to go to the jury this afternoon.

WILL DISCUSS FREIGHT RATES AT GOLDSBORO

A meeting to discuss the freight rate situation has been called for Goldsboro for Friday, December 28, and will be held in the Chamber of Commerce rooms at 11 a. m.

The object is to review the present rate structure and the recent action of the Virginia Corporation Commission. The Virginia interests want to re-open the Virginia-Carolina rate case, with a view to getting the interstate commerce commission render a decision in their favor, which, of course, would be to North Carolina's disadvantage.

Greenville business men, especially the largest receivers and shippers of freight, are acquainted with the Virginia-Carolina rate case and know the final favorable decision rendered by the interstate commerce commission and which is now in effect. It is that this present rate may not be taken from us that the Goldsboro meeting is called.

Senator Simmons and Governor Morrison, according to information received by the Pitt county Chamber of Commerce, will be present and address the gathering.

The Chamber of Commerce is also in receipt of requests from Wilson, Goldsboro, New Bern, and Wilmington urging that Greenville be well represented.

SOUTHERN PINES, N. C., Dec. 20.—"Honeymooning" in Southern Pines Mr. and Mrs. Burton S. Tucker, are here to stay until they are "good and ready to leave," they said today.

Interest in the couple was aroused by the publicity they have given on account of their variance in age and the report that they had been indicted in New Jersey on charges of conspiracy and perjury in violation of the marriage laws. Tucker is 17 and his bride, is said to be 51.

JERSEY CITY, N. J., Dec. 20.—Assistant Prosecutor Aloysius McMahon announced today that, while clemency might be extended to Burton S. Tucker, aged 17, indicted yesterday on charges of conspiracy to violate the state marriage laws, of perjury and of subornation of perjury in connection with his marriage October 2 to Mrs. Susan Simpson, many years his senior, no leniency would be shown to his wife, who was indicted for conspiracy and perjury.

Husband Kills Wife, Her Sister and Self

DENVER, COL., Dec. 20.—Mrs. Carrie O'Mallie and her sister, Miss Flora Hansford, were shot and instantly killed by William O'Mallie, husband of Mrs. O'Mallie, who then shot and killed himself in the apartment of his wife in the downtown section of the city.

The double slaying and suicide was carried out before the view of three minor children of the couple.

The world grows younger about this time of the year. The spirit of youth, a blithe disregard for what may come after, takes hold of us and, despite weather conditions or misfortune, we are optimists for a season.

Human sympathy rises superior to selfishness just now, and compassion and pity for ourselves is forgotten in consideration for others. Faith and innocence, hope and certainty of the ultimate goodness of all things are upon us, and we are content.

We are hypnotized for the nonce, transported back over weary years, made to recognize the tranquility that comes with perfect faith. We may even restore a childish faith in Santa Claus and fairies, and blame be to him who disillusiones a youngster of such beliefs.

There is not one of us who does not recognize the benefits of this child season; not one who does not glow with the satisfaction of a return to innocence.

And all the learning of the wisest man is a mournful thing if he has left behind entirely the child he used to be. If our enthusiasms are stultified, our reactions to our surroundings sluggish, our sympathies dulled, we have lost something out of life that nothing replaces.

Those who have deliberately left the child behind them long ago and are now disheartened, morose and selfish, will be no great loss to a weary world when they go. But without the pure gold of childlike innocence and joy the race of mankind would be poor indeed.

Russia Looks Forward More Prosperous Year

MOSCOW. — Both the Russian people and the Russian Government hope to enter the year 1924 with less strain on their purses than during the closing year. High costs of operation in both government and private industries left many deficits at the end of this year, despite high prices. The government is trying to introduce economy in all departments, and by curtailing credits to merchants and even to its own trusts, to force down prices all around.

Russia, for all practical purposes, went on a gold basis late in 1923. All prices in the Moscow and other metropolitan stores are now marked in gold rubles. The year 1924 may see the total disappearance of the unguaranteed paper money. While this cautious campaign to secure a stable currency was proceeding, the sudden transformation to a gold rate did away with bargains in Russia. The result was that in December prices for commodities other than foodstuffs were from four to five times the price of a year ago.

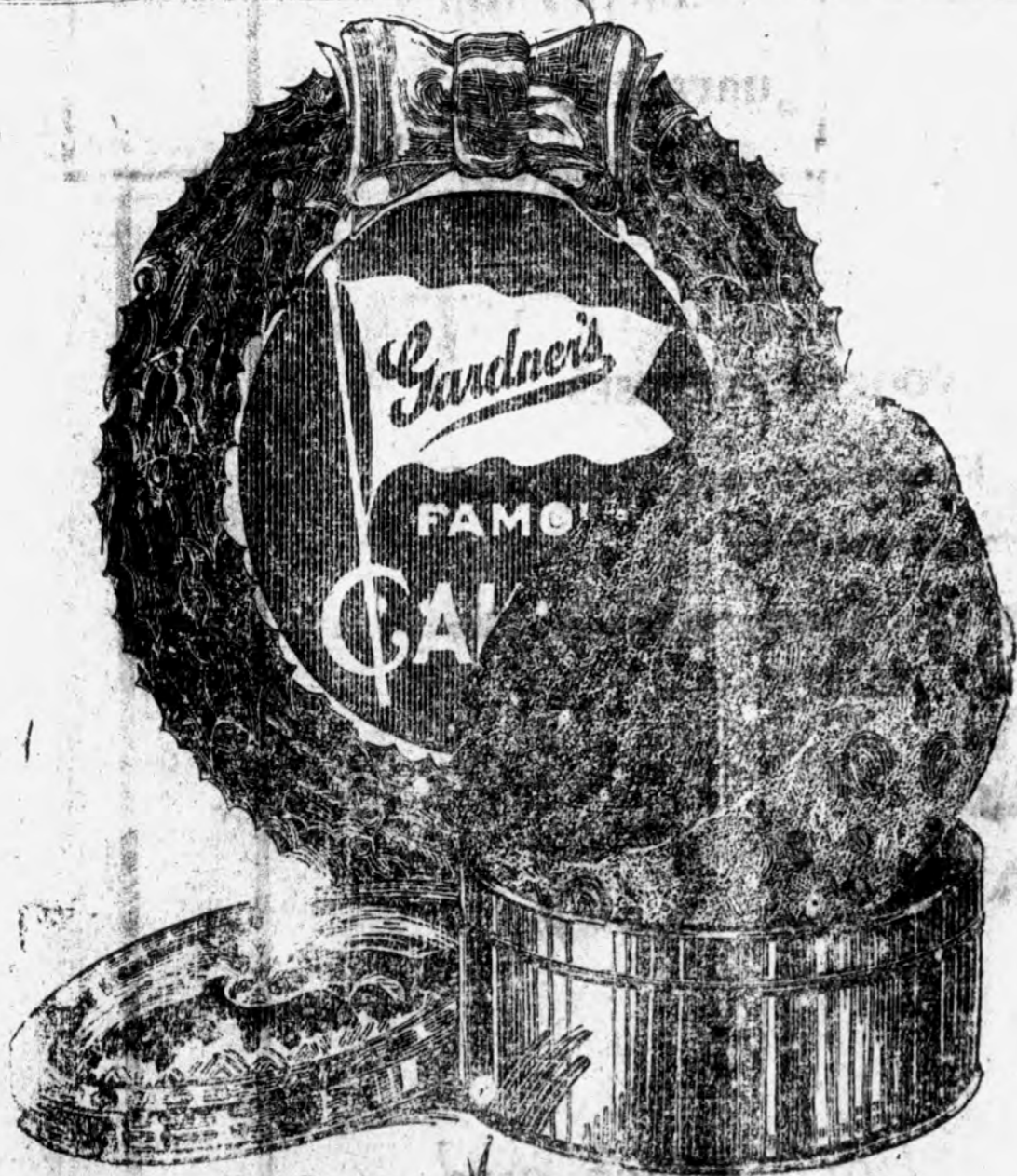

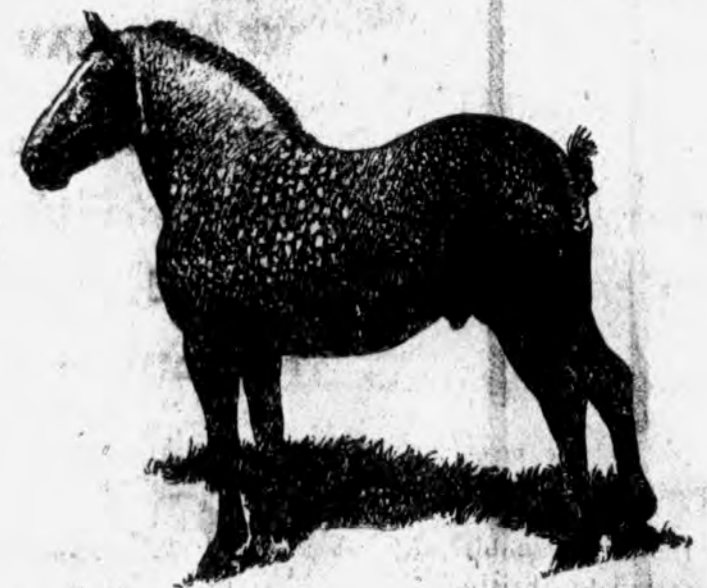

Harnessed Rapids May Create Entire New City

SEATTLE, WASH.—A city of 50,000 persons engaged in electro-chemical industries may rise on 6,000 acres of sagebrush beside the Columbia river, to exploit water power rivaling that of Niagara Falls, if success follows plans referred by the Federal Water Power Commission in Washington, D. C., to Colonel W. J. Borden, army engineer for this district. Such a city would stand at Prist Rapids, Wash., 150 miles east of Seattle, on the other side of the Cascade mountains.

A subsidiary of the General Electric Company has applied to the commission for a license to construct a dam two miles long and 90 feet high, a dam declared here to be in blueprint half again as long as the barrier across the Mississippi river at Keokuk, Iowa.

Election In Bulgaria Resembles U. S. System

SOFIA.—The conduct of the elections in Bulgaria last month gave the day an atmosphere similar to that of an election day in America. The voting booths were in the public schools and as each voter presented himself he was obliged to show his registration card to the president of the voting precinct.

In the voting room the tickets of the various parties, a different color for each, were arranged on the table. The voter selected his ballot, placed it in a plain envelope and sealed it. Then he deposited the envelope in a ballot box. No markings of any kind were permitted on ballots or envelopes, a single mark on either causing the ballot to be declared void when the counters were doing their work.

GERMAN EMIGRANTS ARE DISSATISFIED IN ADOPTED COUNTRIES

LEIPZIG.—Germany's enforced emigration apparently results in many persons getting into lands where they are not contented. German papers abound in letters from emigrants who are dissatisfied with their new homes and warn their fellow-countrymen to exercise greater care in choosing a land for adoption.

Most of the complaints are from men of the middle-class who have had experience as clerks, salesmen, teachers and accountants. Artisans and farm workers are not numerous among the grumblers.

In fact, most of the letters urge that only artisans and men experienced as farmers try their hand in South America, Canada and the United States, and Germans are warned to select a land where they will not have to compete with negro labor and other workers whose living standards are below those of Germans.

Brazil is commended by many correspondents to the German press as a place where emigrants can soon earn enough on coffee plantations to buy land of their own. Argentina is less favorably mentioned because of the keen competition of the Italian farm workers who are satisfied with a lower wage than a German can live on in the style he desires.

One correspondent writing from Mexico warns his countrymen not to be fooled by rosy pictures of that country. An artisan writing from Chile says it is hard for German mechanics to compete in that country with artisans from Spain, Portugal, Italy, Dalmatia and Syria who are contented with very low wages.

Report Don't Threaten Officials, German Law

BERLIN.—When a German has fault to find with the service rendered him by some public official, he must be very careful about threatening to report the delinquent official to higher officials. That constitute threatening an official and is punishable under the German law. It ranks with bribery, or attempted bribery.

A disgruntled Berliner who did no like the way a post official carried out his work threatened to make a report to the control if the methods were not changed. This was reported by the official who objected to the action of the patron. The lower court held the patron had violated the law and the supreme court of Germany has sustained the decision.

LEAGUE OFFICIALS EXPECT MORE CO-OPERATION, ITALY

GENEVA.—League of nations officials expect active co-operation from Italy as a result of the recent visit of Secretary General Drummond to Premier Mussolini. Italy is the latest nation to notify Geneva of its support of the proposal adopted at the last assembly of the league to teach children in the schools the purposes of the league.

Italy has agreed also to grant all possible facilities to groups of students or Boy Scouts and Girl Guides who may be traveling through Italy. The movement to facilitate the traveling of youths was launched at the last assembly.

THEOLOGICAL STUDENTS TO CONVENE IN INDIANA

INDIANAPOLIS.—Students from approximately one thousand theological seminaries and colleges throughout the United States and Canada will be here this month for the biennial convention of the Student Volunteer Movement. The meetings will begin Dec. 28, and continue daily until Jan. 1. Arrangements have been made to care for more than 6,000 visitors. It was stated, among them several hundred colored students.

LESS OCEAN TRAFFIC TO U.S. WELCOMED BY QUARANTINE DOCTOR

NEW YORK.—The filling of the immigrant quotas of most of the foreign nations and the usual winter decline in tourist traffic are appreciated more perhaps at the quarantine station maintained by the United States public health service on Staten Island than anywhere else. During the summer and autumn with the rush of immigrants and tourists doctors and others attached to the station had little spare time.

Often there were dozens or more ships anchored off Staten Island at one time awaiting permission to proceed to their berths. Consequently the doctors who inquire into the health of every incoming passenger, as well as the crews of passenger and freight vessels were kept on the jump from sunrise to sunset.

Notwithstanding the falling off in traffic with the coming cold weather, it is not unusual in the course of a day for 15 or more vessels to drop anchor off Staten Island. However, the vessels more often come singly and with the shorter days the members of the staff find more leisure time.

JAPANESE IMPERIAL COURT TO DISPOSE OF STOCK HOLDINGS

TOKIO.—The Imperial court has announced a decision to dispose of its holding in public companies to the amount of 10,000,000 yen (\$5,000,000) in order to enable it to meet heavy losses occasioned by the earthquake and fire.

The household holds stock in the Bank of Japan, Nippon Yusen Kaisha Yokohama Specie Bank, Industrial Bank, Formosan Bank and other companies amounting to hundreds of millions of yen. Furthermore the land, buildings and household effects of the Imperial court are valued at more than \$3,500,000.

Town Supplies Electricity Free.

ADIRAD.—This town, in the heart of a gold placer district, finds it unnecessary this year to make a tax levy.

The municipality has a reserve of \$3,500 in the treasury. Revenues from federal licenses will amount to more than the expenses of the town government.

Soprano Scorns Paper Marks.

DORTMUND.—Emmy Laisner a Berlin soprano who was engaged to appear with the Dortmund Music Society, refused to sing unless she was paid in foreign money or some sort of stable currency. As the management had only German paper money the concert had to be cancelled.

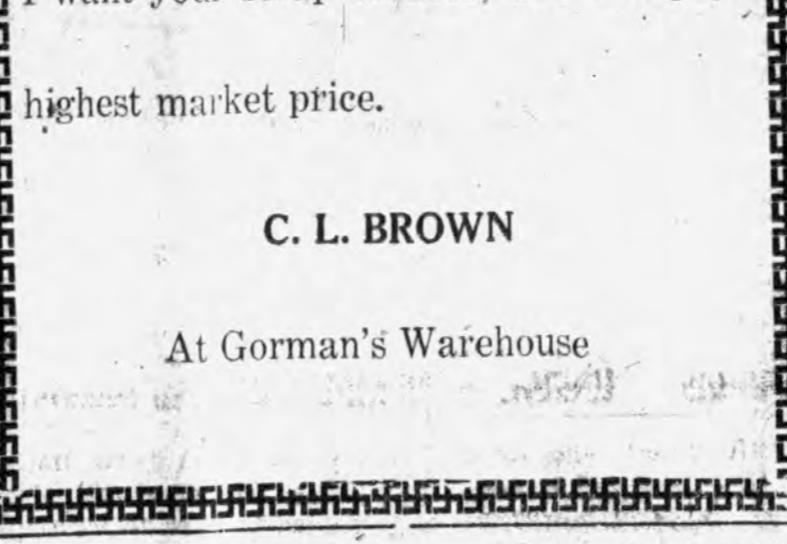

PROFESSOR PREDICTS NEW DEVICE TO HELP DEAF HEAR SPEECH

EVANSTON, Ill.—Every indication points to success in developing a hand-device which the totally deaf may carry and by which they may receive impressions of oral speech. Professor Robert H. Gault, head of the psychology department of Northwestern University, announced here today.

Professor Gault bases his announcement on the progress of a year of intensive work on the problem, and in making experiments in detecting words and sentences by tactual contact.

"Today it is safe to say that the human being can feel sound waves by touch, and can clearly translate such tactual impressions into words and sentences," said Prof. Gault.

More than a year ago Prof. Gault started work with two students, Geo. and John Crane, brothers, of Fort Wayne, Ind., and succeeded in communicating with a metal tube various words and sentences which the Crane brothers detected with the hand only.

At that time one of the brothers sat in a room and spoke through the tube while, the other, in an adjoining room, ears muffled and with hand over the receiving end of the tube, announced his interpretation of the sound vibrations. This year Prof. Gault has been utilizing an accousticon for amplifying vibrations at the sending end, while he employs a small receiving disk held in the hand at the other. Prof. Gault himself has been working upon long vowels, and upon several short sentences which a graduate student, S. N. Stevens, sitting in an adjoining building 60 feet away, repeats.

Prof. Gault says the long vowels, a, e, i, o and u, are more difficult to detect than are sentences. However, by long and patient practice, he says he has reached a point where he "feels" the long vowels correctly about 85 percent of the time. Upon sentences he does better, he explains because of the stressing of words. Tactual hearing of these four sentences has given the following results: D'd Jack like teachers?—93 percent perfect; Henry did not begin.—94 percent; He did like work.—87 percent; Say, d'd Jack accept?—100 percent.

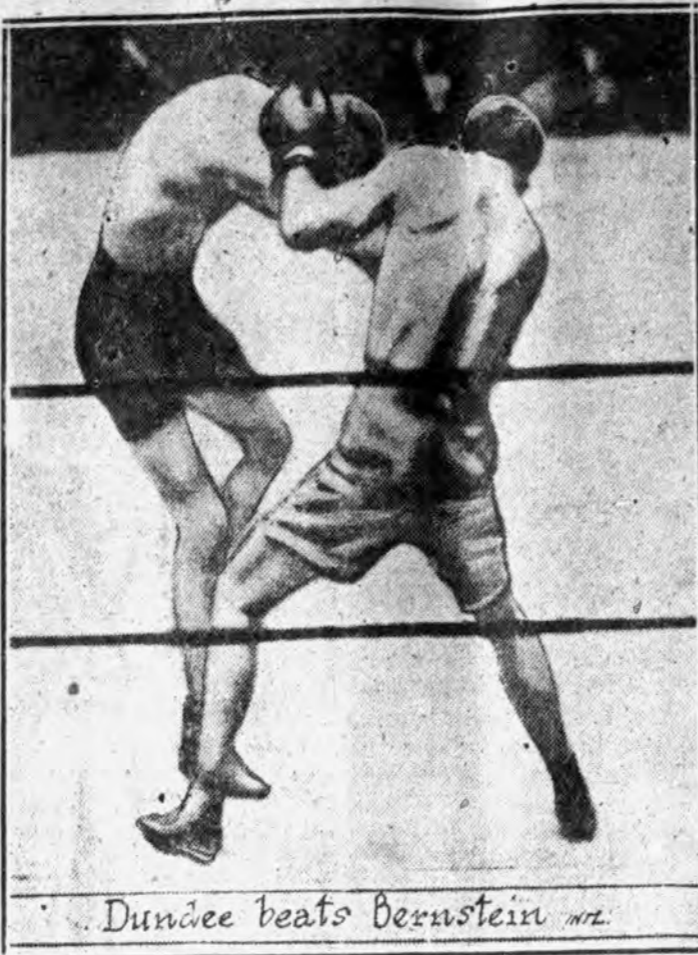
Town Lots Valued High.
