Over 200 Children Hear College Girls Tell Interesting Stories

The Library Committee of the Woman's Club had a story telling hour Saturday afternoon from four until five o'clock.

They had arranged the children to go into the Chamber of Commerce rooms, so as to interfere as little as possible with the regular patrons of the library.

At three o'clock the children began to come to the library for the stories. At three-thirty there were about thirty waiting, as quiet as lambs, in the library for the hour to arrive.

At this time Mrs. H. L. Smith, and Miss Moxley opened the Chamber of Commerce rooms and the children came in steadily, and took their places. In a few minutes all the chairs were occupied by two, the tables, desks, floor and every inch of space was filled.

By four o'clock the rooms were packed and jammed.

It was the desire of the Committee that the children should get as much as possible from these stories, but packed as they were, it was almost impossible to give them anything.

An S. O. S. call was sent out to the Pythians club, and they answered, as you might expect such an organization to answer. They opened their doors and invited the children in their large club room, where there were chairs for most of the children and plenty of floor space for the rest.

The children attending the story telling the first Saturday numbered over two hundred. The stairs were filled by a group of College girls under the supervision of Miss Agnes Whitesides.

Says North Carolina Offers Opportunities In the Oil Game

WASHINGTON, N. C., Jan. 28.—That North Carolina offers the same opportunities in the oil game that Texas did some years ago is the opinion expressed by B. C. Banks, an oil expert and mining engineer who has made extensive explorations in this state. "For the past four years I have made tests from Cape Fear River to Deep River, near Portsmouth," said Mr. Banks in speaking to a group of Beaufort citizens at the courthouse here. "I know that you have oil in this section, but how much cannot be prophesied because no matter how capable an oil engineer may be, it is impossible to determine the amount of oil certain lands may hold without drilling for it."

The plan is now to sink a test well near Havelock and should oil be found in paying quantities, wells in other sections of Beaufort county will be sunk, explained the mining engineer.

COOPER HEARING POSTPONED ON ACCOUNT FAILURE JUDGE CONNOR TO ATTEND COURT IN WILMINGTON

WILMINGTON, Jan. 28.—The failure of United States District Judge, H. G. Connor, to arrive prevented the opening of the term of United States District Court scheduled here for today for the trial of Lieutenant Governor W. B. Cooper, Thomas E. Cooper, Horace Cooper and Clyde W. Lassiter, charged with violating the national banking laws in connection with the failure of the Commercial National Bank of this city. Judge Connor was detained at his home in Wilson by the critical illness of his wife.

Officials here are uncertain whether or not Judge Connor will be able to come to Wilmington this week.

District Attorney Tucker and his assistants announced today that they were ready to proceed with the trial as soon as Judge Connor can attend court. Defense attorneys said that they were also ready.

MRS. CONNOR CRITICALLY ILL

WILSON, Jan. 28.—Mrs. H. G. Connor, wife of United States District Judge Connor, is critically ill at her home here and physicians hold out little hope for her recovery. Judge Connor who was due in Wilmington today to open a special term of Federal court said that he would go to Wilmington as soon as his duty to his wife would permit.

BRINGS SUIT FOR \$2,700 AGAINST BALTIMORE BANK

ELIZABETH CITY, Jan. 28.—Mrs. Penelope Lyons, of this city, has brought suit against the Fidelity Bond and Deposit Co., of Baltimore for \$2,700. The woman claims that this is the total amount due her by the company for enabling the company to capture J. D. Sykes, Jr., alleged defaulting collection teller of the First Citizens National Bank. Sykes is said to have absconded on Sunday prior to Labor Day 1922 with \$25,000. One thousand dollars of the claim is stated as the reward offered with 10 per cent of all the money recovered. The bonding company disputes the claim on the grounds that Mrs. Lyons was an accessory before the facts of the crime which they allege.

FORTY PERISH IN MINE EXPLOSION

SHANKTOWN, PA., Jan. 27.—Forty men lost their lives in the explosion which late yesterday wrecked the ancashire mine of the Barnes and Tucker Coal Company here, according to the best estimates obtainable last today.

Seventeen bodies have been brought out, and nine miners, who were saved by the prompt efforts of another miner, are in hospitals recovering from the effects of shock and gas. Experienced rescue crews, led by J. D. Parker, of the Pittsburgh station of the Bureau of Mines, are working in one hour relays to penetrate the working and reach the entombed men. All hope that any is alive has been abandoned.

"While no one is quite sure," said Engineer Parker, "there is every reason to believe there were 0 victims of the mine disaster. Seventeen bodies have been located, and there is hardly a possibility that the 23 other miners escaped. The rescue work is proceeding favorably. The main heading has been explored to the face of the mine, and the crews are now going into the side entries. We expect to have the mine completely explored tonight."

100 Cases Whooping Cough Now Being Treated Wake Co.

RALEIGH, Jan. 28.—Approximately 100 cases of whooping cough are now being treated in Wake county, of which about 50 are said to be in New Light Township, according to a statement issued by Dr. A. C. Bulla, county health officer. Apex is also said to have a large number of cases. Dr. Bulla and his assistants have visited the more serious affected towns in an effort to stop the spread of the cough. Raleigh was termed as having exceptionally few cases.

Issues Call For Aid Fire Sufferers

HIGH POINT, Jan. 28.—Mrs. W. C. Hammond has issued a call for aid for the sufferers in the disastrous fire that occurred here, leaving five women, a 7 year old girl and an infant destitute. Aid may be sent to 219 E. Washington St., High Point.

14 Believed Killed Either Asphyxiation Or Explosion Today

PAWTUCKET, R. I., Jan. 28.—Fourteen persons are believed to have lost their lives either by asphyxiation or an explosion and fire in a two family cottage at Cumberland Hill, Pawtucket, early today.

The bruised, cut and badly burned bodies of Michael Conway and six members of his family were recovered from the ruins also that of Adelaide Hammill. The bodies of six other members of the two families are believed to be buried in the wreckage.

The tragedy occurred when Emmet Conway being awakened by gas fumes went to his mother's room and aroused her. An older son, Thomas Conway was in turn aroused and he went to the basement to ascertain the source of the escaping fumes. As he opened the basement door there was an explosion supposed to have been caused by gas fumes from the basement coming into contact with the burning jet in the hall.

The mother and her two sons were able to escape from the shattered building.

Specialist Rural Education Visits Teachers College

Miss Mabel Carney of Teachers College Columbia University spent Friday at East Carolina Teachers College in company with some of the officials of the State Department of Education. Miss Carney is one of the country's chief specialists in rural education and holds a chair in that department at Columbia. She is Secretary of the Rural Education Department of the National Education Association.

She was accompanied by Mrs. T. E. Johnston, Miss Hattie Parrott and Mr. N. C. Newbold with whom she has been conferring with reference to the training of rural teachers in North Carolina. The morning was spent in conference with President Wright and various faculty members. In the afternoon visits were made to the college's training schools here and at Winterville. Lunch was had with the students in the dining hall.

Just before the party left to return to Raleigh, the ladies living in the Faculty House were hostesses at tea.

Supt. Penitentiary Will Investigate the Escape of Convicts

ASHEVILLE, Jan. 28.—George Pou, superintendent of the state penitentiary is scheduled to arrive in Marshall today to conduct an investigation into the escape last week of 18 long term prisoners from the state convict camp in Madison county. Eight of the prisoners have eluded capture so far and it is feared by officers that they have made good their escape.

Four of the men recaptured were caught in this city. All were still wearing stripes.

NEGRO BURNED TO DEATH IN WINSTON-SALEM

WINSTON-SALEM, Jan. 28.—Wesley Martin, negro, 32 years old, was burned to death last night as the result of a fire which did considerable damage to a negro rooming house in which he was staying.

When found Martin was lying on one side of the bed with his body badly burned. He was an employee of a local tobacco concern.

BANK CONTROVERSY IS NOW SETTLED

WASHINGTON, Jan. 28.—The right of a state to prevent national banks within its borders to establish branch banking establishments was upheld today by the United States Supreme court which at the same time ruled that the same prohibition was contained in the federal statutes themselves.

The decision settled a controversy that has been before bankers of the country for several months. The case was brought by the First National Bank of Saint Louis, Mo., which demurred from the state law which prohibited it from establishing branches and losing in the lower federal court had appealed to the United States Supreme Court. The decision of the lower court was confirmed.

MR. JOHN LEGGETT DIES FROM INJURIES OF AUTO ACCIDENT

Blinded by Lights Runs Into Wagon Receiving Fatal Injuries

Mr. John Leggett, 46, who on Monday night suffered serious injuries when his automobile ran into an unlighted wagon on the hard surfaced road near Vandford's store, died yesterday day morning at 11:15 o'clock in the local hospital. The funeral services will be conducted from his late home this afternoon at 2:30 o'clock, interment following in the family burying ground. The Modern Woodmen of America, of which he was a loyal member, will have charge of the services at the grave.

Mr. Leggett was returning to his home near Bell Arthur at the time of the accident. A car with a bright light, blinded him, causing him to run into a wagon which he failed to see. The wagon was completely wrecked but the occupant escaped without injuries.

The deceased was held in high esteem in his community. He is survived by his wife and several children.

PLANS BEING MADE FOR CARING FOR NEEDY OF THE CITY

Meeting of representatives from all the civic and religious organizations in the community met at the Chamber of Commerce room Friday afternoon and discussed the idea of pooling a fund for the purpose of handling indigent charity and hospital cases. Representatives from the following were present: Woman's Club, Kiwanis Club, Rotary Club, King's Daughters, Round Table, Emmanuel Baptist Church, Methodist Church, Memorial Baptist Church, American Legion, Sharon Lodge No. 78, Greenville Chapter No. 50, Pitt County Medical Association, End Century Club, San Souci Club, Episcopal Church, American Legion Auxiliary, Presbyterian Church, Red Cross, Bethlehem Commandery.

All those present at the meeting expressed themselves as being highly in favor of this plan and promised hearty co-operation in any plan that can be devised.

Chairman Futrell was instructed to appoint a committee to meet with the Welfare board at its next meeting to advise with them and make a plan to do this work in a systematic way.

This committee is to devise a plan whereby every person in the Greenville Township will be asked to help in this work.

It is hoped that a good neat sum can be raised by which all real cases of need can be amply provided for.

Several of the organizations present at this initial meeting pledged definite amounts per month to start this movement.

Diplomas Presented Eight for Completion Scoutmaster's Course

RALEIGH, Jan. 28.—Diplomas for the completion of the regular scoutmasters' course have been presented to eight of the original 16 of the class that was started some time ago in the City Court room here. Gorrell Schumaker, Scoutmaster of Troop 1, of Haynes-Barton and Professor A. F. Roller, the Scoutmaster of Edenton Street Methodist Church Troop were among those receiving diplomas. The other six members of the class who also received diplomas were students from the State College.

W. T. Dart, Scout Executive of Raleigh, stated that there are now ten troops in this city with a total membership of 200.

30 BANDITS RAID DISTILLING PLANT

CHICAGO, Jan. 28.—Bandits numbering 20 to 30 raided the Hammond Distilling plant at Hammond, Ind., now used as a government warehouse, early today, according to the unique story of the three guards and forced them to drink whiskey until they were thoroughly intoxicated. The bandits then robbed the warehouse of 60 barrels of whiskey. The guards who were arrested for questioning declared that the bandits had three motor trucks and that two were used to carry away the whiskey, the third being left behind.

URGES LEASING OF MUSCLE SHOALS TO POWER COMPANIES

WASHINGTON, Jan. 28.—A bill authorizing acceptance of the offer of several southern power companies for lease of the government nitrate and power plants at Muscle Shoals was introduced today by Representative Hull, Republican of Iowa and member of the House Military committee.

WASHINGTON, Jan. 28.—No word as to whether Henry Ford will appear before the House Military committee to discuss his offer for Muscle Shoals had been received by the committee when it resumed its hearings this morning under a program that calls for conclusion not later than Wednesday.

A telegram was sent Mr. Ford by Chairman Kahn requesting him to testify before the committee today or tomorrow but no reply as to his intentions has yet been received.

The first witness in the hearings this morning was Thorndyke Saville, associate professor of hydraulic engineering of North Carolina.

Anniversary Week of Boy Scouts To Be Held in High Point

HIGH POINT, Jan. 28.—Boy Scout Anniversary week will be held from February 8 to 14 during which time a recruiting campaign will be carried on for both members and leaders, according to a statement issued by the chairman of the Boy Scout Executive Committee of this district, Logan Porter.

Recruiting stations for boys will be established throughout the city where those unfamiliar with the details of the organization may obtain information. Scouts will visit men of affairs in business and professions and tell them the real purpose of the scout movement and seek to interest them in the work, at least indirectly, if not directly. All the scouts of the city will attend services in a body on Sunday, February 10, and on the 15th a Fathers' and Sons' banquet will be held.

THE OIL LEASES SCANDAL

There has been a great deal of evasion and concealment on part of certain persons who have figured prominently in the investigation of oil leases by the Senate committee. There has been some plain lying. Not all the witnesses have yet been heard. Some will have further opportunity to testify on certain obscure points.

The public is more than ever suspicious because of misleading or untruthful statements that have been made to the senate committee. For if the purpose in making them was not to deceive the committee and the public or to hide the facts, then what was the purpose? Gentlemen who on their honor protest their innocence of any wrongdoing cannot hope to establish a reputation for unquestionable integrity when they are caught repeating falsehoods.

When former Secretary Fall, who signed the Sinclair and Doheny oil leases, said that he obtained from Edward B. McLean the \$100,000 used in adding to his ranch property in New Mexico, McLean confirmed Fall's statement. Later, when McLean, under examination at Palm Beach, admitted that he gave Fall checks for \$100,000 and the check were returned to him uncashed, Fall confirmed McLean's statement.

Fall, on Dec. 27 in a statement to the Senate committee, declared that "I have never approached E. L. Doheny or any one connected with him or any of his corporations, or Mr.

H. F. Sinclair or any one connected with him or any of his corporations, nor have I ever received from either of said parties one cent on account of any oil lease or upon any other account whatever." Yet months before, when he was Secretary of Interior, he had executed the California oil lease to Doheny's company and received from Doheny \$100,000 in cash in a satchel. To be sure, Doheny, who had refrained from disclosing the facts when previously on the witness stand, calls it a personal loan for friendship's sake that had no relation to the oil lease.

Now comes Col. H. W. Zevly, personal counsel to Harry F. Sinclair, with the statement on the witness stand that he personally paid to Fall \$25,000 received from Sinclair, to whom Fall as Secretary of the Interior had turned over the Teapot Dome oil lease. Sinclair has denied the payment of any money to Fall, Fall has denied receiving any money from Sinclair, and Zevly, acting as intermediary and actually traveling in Fall's company this week from El Paso to Washing, testifies that \$25,000 of Sinclair's money was delivered by him to Fall.

Seldom has more reckless lying been heard in a police court. But the lying, prearranged or spontaneous, is the least shocking part of the whole foul business. When a Secretary of the Interior, intrusted with the responsibility of safeguarding immensely valuable public property in oil lands, uses his official power to surrender possession of then to great oil magnates and also by their favor pockets large sums of money for his personal use, it outrages common sense to pretend that there is nothing wrong.

The Senate committee has not yet got clear to the bottom of the oil leases. But it has uncovered enough to make it necessary that steps be taken at once to cancel those leases. If they have not been invalidated by corruption in obtaining them, they are still an indelible reproach to the men who obtained them and the official who granted them. Because Fall is out of office and disgraced, the case cannot be permitted to rest there. The Administration owes itself and the country the duty of following it through to the end in the courts.

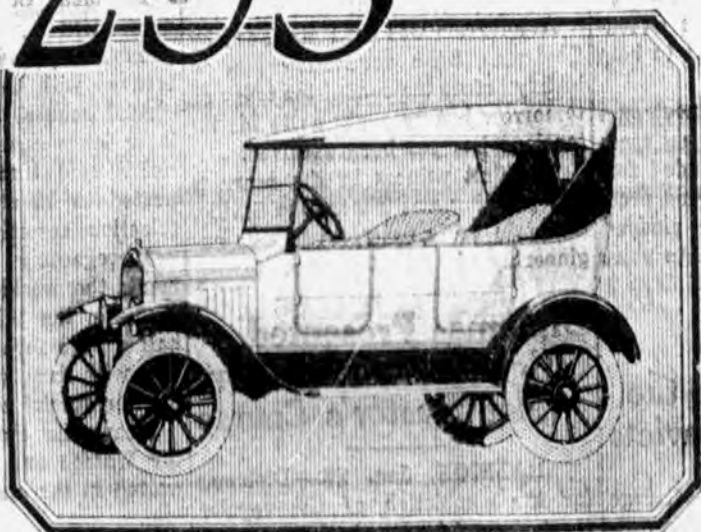

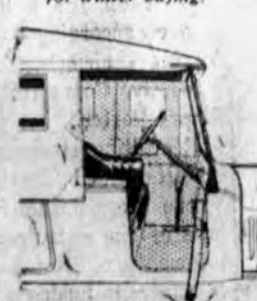

Extension Bureau of Designs Improvement Received by Schools

Mrs. Matherly visited the following communities under the bureau of the North Carolina University: Holly Springs, Haw River, Morehead City, Louisburg, East Durham High School, Smithfield, Johnson county Training School, Troy, Carrboro, Greenville, Winterville, Bethel, Ayden, Grifton, Hoelina, Semora University, Rich Square, Cullowhee State Normal, Cullowhee Graded School, Bryson City, Magnolia, Charley Crossroads, Calypso, Apex, Leaksville, Silver City, Liberty, Long Creek, Woodlawn, Newell, Paw Creek, Hoskins, Mathews, and Hickory Grove.

A letter from L. W. Umstead, principal of the Magnolia school, which was recently received by the Extension Bureau, expressing the appreciation of the school for the bene-

fit it had derived from the aid of the bureau, is said to be typical of the work that is being done throughout the state.

The letter said in part: "In November of 1922 we applied to the Extension Division of the University of North Carolina for aid in the beautification of the school grounds. Mrs. Matherly, field agent, visited the school a few days later and obtained the necessary information for making the blue-print. Shortly afterwards the plans were forwarded to us and the total cost was \$4.35. Mrs. Matherly's traveling expenses in the case.
