FRIENDS DECLARE M'ADOO AVAILABLE FOR A CANDIDATE

Bonus for Soldiers One of Principal Planks of Platform

Chicago, Feb. 19.—Styled by friends as "preeminently available for president and the hope of progress throughout the nation," William G. McAdoo, former secretary of the treasury, is in the race for the Democratic Presidential nomination today.

A conference of his supporters from nearly every state in the United States met here yesterday to discuss the effect Mr. McAdoo's connection with the Doheny oil interests after his services in the Wilson cabinet upon his candidacy, unanimously approved his and passed resolutions demanding his leadership.

"We deny, and condemn the recent infamous conspiracy attempting to besmirch his name and proclaim that he has emerged from the attack stronger than before," the resolution said. "We unanimously demand his leadership."

Called on to address the assembly after their vote of confidence Mr. McAdoo put forth the principles of his platform. These are some of the things "need be done to protect the rights of the people and satisfy the demand for progress."

Drive corruption out of Washington; call a new world conference to deal with the political and economic problems and submit the questions of American foreign policies to national referendum; take the grip of Wall Street off the Treasury department and Federal Reserve System; repeal the Fordney-McCumber tariff act; prompt railroad reform; put agriculture on its feet again; strong enforcement of the Eighteenth Amendment; reduce taxes; adopt a constitutional amendment prohibiting child labor; establish a national labor code; clean out the Veterans' Bureau; and pay a soldiers' bonus. Until the government is purged and made clean, honest and efficient again there can be no progress and settlement of the problems facing the American people.

Special Counsel Begins Its Work

Washington, Feb. 19.—Having gone through a period of close senatorial scrutiny with the stamp of approval Atlee Pomerene and Owen J. Roberts, special government counsel today began preparations for their work in a conference with President Coolidge.

The two attorneys discussed the general situation but said that they reached no final decision relative to the details of the legal procedure to be instituted to recover naval oil reserves. The first steps, it is indicated, will be suits to annul the lease of Teapot Dome reserves obtained by Harry F. Sinclair and the Elk Hills lease granted to E. L. Doheny. "Haste is of utmost necessity," Roberts said, "we must remember, however, that our case of first necessity must be well founded. We do not propose if humanly possible to institute anything that would compel us to file an amended complaint or in any retrace our steps."

Carolina Playmakers Also 'Match Makers'

Chapel Hill, Feb. 19.—In fulfillment of the prophecy made by several of the "Carolina Playmakers" that the organization would live up to its reputation of being "The Matchmakers" as well, another marriage within the fold has just been announced. It was that of Miss Anne Morgan Majette, who is assistant to Professor H. Koch, director of the Playmakers, and Daniel L. Grant, also of Chapel Hill. Miss Majette is a native of Jessup, Georgia, and Mr. Grant is secretary of the General Alumni Association of the University of North Carolina. The wedding which took place the past week was supposed to have been a secret, but the news leaked out and the "Carolina Playmakers" are happy over their good record.

Washington, Feb. 19.—Members of President Coolidge's cabinet after today's session declared that the matter of the oil lands lease disclosures had not been discussed at the meeting.

Meeting To Be Held Goldsboro to Discuss Freight Rate Situation

An invitation has been extended to the Secretaries and President of eastern Carolina Chambers of Commerce by the Goldsboro Chamber of Commerce to be their guest at the Kenon Hotel Wednesday evening, February 20th, at 6:30, to discuss the freight rate situation affecting the interests of eastern North Carolina.

The water commerce committee is expected to make a report in the near future and it is generally believed they will recommend terminals and the improvement of our waterways. Those of our leaders who have given serious thought to the subject believe this project necessary and vital to the proper development of this section, however, it is not going to be easily accomplished and the purpose of this meeting is to perfect plans in advocacy of the project and to overcome objections.

Invitations have been extended the following towns: Greenville, Rocky Mount, Wilson, New Bern, Elizabeth City, Morehead City, Kinston, Wilmington, Fayetteville.

Secretary Smith of the local Chamber of Commerce in speaking of the matter today stated that he would be glad to have some one business man accompany him on this trip, inasmuch as President D. L. Turnage will not be able to attend.

Granville Citizens to Share in Edwards Estate of New York

Granville, Feb. 19.—That citizens of this city may enjoy part of the distribution of the Edwards Estate of New York City the 99 year lease of which has just expired was learned here when H. Jackson, and J. L. Taylor of this city were notified that they among the legal heirs. The New York lawyers who are handling the estate talked with the Granville citizens over long distance phone and told them that as they were related to the Pettus family of Virginia whom it is said are also heirs of the Edwards estate, that they would come in for a part of the estate.

HIGH COST LIVING WILL BE BIG ISSUE FRENCH ELECTION

Paris.—The high cost of living in France promises to be one of the principal issues, injected by the opposition to the present government, during the campaign for the forthcoming general elections.

Posters are being prepared for placarding in all the municipalities of France, emphasizing the increase in the price of necessities of life under the present rule. In the lists prepared it is noted that bread and wine, which the average Frenchman regards as first in the necessities of life, have been subjected to the smallest relative increase.

DIAMOND JUBILEE CELEBRATED LAST NIGHT BY PYTHIANS

Interesting Addresses On Friendship, Benevolence and Charity

Members of Tar River Lodge No. 93, Knights of Pythias, who had been looking forward to the Diamond Jubilee, or the Sixtieth Anniversary of the Order of Knights of Pythias, were not disappointed as they came together last evening in the local Pythian Hall for this occasion.

The Vice-Chancellor stated why the assembly: "To fittingly celebrate the Diamond Jubilee of the Order of Knights of Pythias and to recall to mind that, on February 19th, 1864, Justus H. Rathbone and a few of his intimates met in the city of Washington, D. C., and founded our noble fraternity, which since that time has grown in wealth, power influence and membership until now we have on our roster, in good standing, the names of nine hundred thousand true men, whose simple creed is an abiding faith in the Fatherhood of God and the Brotherhood of men and the Immortality of the Soul."

The Vice-Chancellor also stated that the first cardinal tenet of the order Friendship, which means union of hands and hearts by that golden cord which bound Damon and Pythias. Illustrative of this he quoted from Sam Walter Foss, "The House by the Side of the Road."

Rev. Leland W. Smith gave an interesting address on friendship and frequently referred to ancient and modern writers, giving choice phrases illustrating his points.

The other three speakers of the evening were S. O. Worthington and F. C. Harding of Greenville and J. R. Turnage of Ayden.

Mr. Turnage spoke on Charity; Mr. Worthington made an address on Benevolence while Mr. Harding used Patriotism as his theme. It was indeed a rare treat to sit and listen to the these ably prepared addresses on so interesting a subject.

A feature of the evening's entertainment and one which added much was special musical selections by Misses Jessie Bullock and Emma Malison.

Adding much to the enjoyment of the evening was the presence of a number of the wives of the Pythians. The closing number consisted of light refreshments, after which every one "folded his tents like the Arab and as silently stole away."

OIL COMMITTEE IN EXECUTIVE SESSION THROUGHOUT DAY

Confers With Benkard and Attorney; Pomerene, Roberts Attend

Washington, Feb. 19.—The Senate oil committee undertook today to run down the story of heavy speculation by high government officials in the stock of the Sinclair interests before and after Sinclair obtained the Teapot Dome lease.

H. H. Benkard, of the New York brokerage firm of J. P. Benkard and Company, accompanied by his attorney S. D. Bowers and A. H. Cook, office manager of the Benkard firm were in conference with the committee in executive session and it was decided to send expert accountants to New York to examine the books of the firm.

Bowers said that Benkard was subpoenaed to produce the records of certain transactions. J. P. Benkard & Company have no knowledge or information that its records in any way are connected in any way with any transactions with any one bearing upon the matters under investigation.

Chairman Lenroot issued a statement saying that the members of Benkard Company had appeared before the committee to produce certain records requested and that they had expressed a willingness that accountants be sent to New York to examine all the books and records of the concern that might have any bearing upon the oil cases.

Harry Payne Whitney, New York financier, had also been subpoenaed to appear before the committee this morning but committee attaches failed to locate him in Washington. Atlee Pomerene and Owen J. Roberts, special government counsel in the oil cases were summoned to the committee room soon after the members of the Benkard firm had arrived.

Wilton J. Lumbert, counsel for Edward B. McLean, publisher of the Washington Post who is under subpoena to appear before the committee, sought a conference this morning with Senator Wheeler but found that the Senator was in attendance at the executive session of the oil committee.

Senator Greene's Condition Critical

Washington, Feb. 19.—Senator Greene, of Vermont, is in a critical condition this morning suffering from the wound he received Friday night when he was hit by a stray bullet in a shooting that accompanied a chase of alleged bootleggers by prohibition enforcement parties.

Dr. Carlton Gives Up Dentistry Practice

Spencer, Feb. 19.—Dr. John W. Carlton, who for the past 25 years has practiced dentistry in this city has relinquished his entire practice to Dr. George B. Allbright, his associate, and will devote his time exclusively to Bank of Spencer of which he is vice president, it has been announced here. Dr. Carlton has been an official in the bank for 21 years, he was one of the pioneer settlers of the town of Spencer and served in the legislature in 1909.

"Birthday Health Examination" Slogan

Raleigh, Feb. 19.—"Have a Health Examination on Your Birthday," is the slogan of the nation-wide health movement that the North Carolina Tuberculosis Association has joined in with many other states of the Union in hopes of giving aid to the thousands who unknowingly have the first stages of tuberculosis. The plan is to have all persons seek advice of medical authorities at least once a year and to have them carry out the advice of such physicians. The North Carolina Tuberculosis Association has given its hardy support to every plan that in any way would tend to reduce the number of persons that were in the slightest affected by the disease, it was stated, and it now intends to make an active effort to have the people of the state show out this plan.

13 Lives Snuffed Out In New York Fire Today

New York, Feb. 19.—13 lives were snuffed out within a few minutes by a fire believed to have been of incendiary origin which early today swept from basement to roof of a five story tenement house in the heart of New York's lower east side ghetto.

Seven of those killed were children.

The blaze, unequalled in rapidity in the annals of the fire department, flared up the staircases forced by the draft of the tenement's open front door below and cut off escape of the eight families occupying the building. Some of those on the two upper floors were awakened to find the flames leaping at their bedside and met death before they could attempt to rush through the roaring furnace that confronted them.

Tenants opened their hall doors to find a vortex of flames mushrooming down from the roof through the smoke choked corridors and families on the lower floors retreated in panic to the windows and by seemingly impossible means succeeded in reaching safety. Several of those escaping were severely burned and otherwise injured.

The dead included five boys, two girls, four women and two men. One infant's charred body was found at the breast of its dead mother.

The fire was discovered by a passing policeman who saw the smoke and flames rising against the inner side of a window. He rushed into the house and up the staircases hammering with his fist upon the doors and shouting warnings to those within.

CHIEF COMMITTEE RED CROSS HOLDS INTERESTING MEET

Miss Moxley Makes Fine Report Concerning Work in County

The monthly executive committee meeting of the Pitt County Chapter of the American Red Cross was held in the Chamber of Commerce yesterday morning, with Mr. H. E. Austin, chairman, presiding.

Miss Jane Moxley, the executive secretary, stated that Junior Red Cross work had been presented in school at Bethel and that they will organize at once.

At Farmville, it was stated by Miss Moxley, the work has been definitely organized in the colored school and in the white schools through the 5th grade.

The report, as disclosed by Miss Moxley, showed that she had been active during her first month as secretary of the Pitt County Chapter.

With a view to getting the different colleges of the State to include Pitt county towns in their itinerary, when they come east with their Glee Clubs, Bands, plays, etc., it was suggested that Miss Moxley correspond with these institutions and ascertain their terms and probably dates. It was pointed out if the report was considered favorable, the Red Cross could act as a booking agent and assist the various towns in securing high class entertainment.

Rev. J. P. Harris, representative of the Bethel executive committee, stated that the following had been appointed executive committee from his town: Miss Mabel Barnhill, chairman; W. C. Stroud, J. B. Bowers, Dr. J. D. Hemingway and J. P. Harris.

The committee also decided that Miss Moxley should attend a special Secretaries' Institute to be held in Atlanta, Ga., March 17-23. Those attending the meeting: Chairman, H. E. Austin, A. B. Ellington, J. P. Harris, H. L. Smith and the secretary, Miss Jane Moxley.

Kiwansians of Twin-City Are to Sponsor Boys' Pig Clubs

Winston-Salem, Feb. 19.—The organization of a Boys Pig Club is the next great feature activity that the club will purchase six Kiwanis Club of this city will sponsor thoroughbred pigs and distribute them among the boys of the rural districts of Vance County, according to J. A. Barron, chairman of the Public Affairs Committee. A prize of ten dollars will be given to the boy raising the best pair of pigs. The boys must return two thoroughbred pigs and these in turn will be given out in the district again. It was estimated by J. C. Anthony that approximately seven thousand pigs would be the result of this campaign inside of three years.

Daugherty Has No Statement to Make "At This Time"

Attorney General Daugherty remained silent and defiant today in the face of the renewed attack upon him and the Tuesday's cabinet meeting passed without the announcement of his resignation. The Department of Justice officials declared that he had no intention of surrendering to his critics but Senators who have taken the lead in urging his resignation have advised the president to ask him to retire and believe that their advice will be followed by the president.

Daugherty, arriving at this morning's cabinet session about half an hour late, would talk about nothing but the weather. When he emerged from the meeting an hour later and questioned by newspaper men he appeared nervous but insisted that his resignation had not been discussed at the cabinet meeting and that he had no statement to make at this time.

Washington, Feb. 19.—Attorney General Daugherty after the cabinet meeting today said that he had no statement to make "at this time." "Nothing was discussed at the cabinet meeting that should cause me to make a statement," he said.

135 Dogs Straying Around Twin-City Have Been Killed

Winston-Salem, Feb. 19.—Over 135 dogs found straying about the city have been killed by the orders of city officials within the past 14 days, according to a statement issued by the police department here. An order was issued last month requiring owners of dogs to keep them confined or suffer the penalty of being fined and also the loss of their dogs.

Action on Removal of Headquarters of Y W C A Postponed

Charlotte, Feb. 19.—At the convention of the Y. M. C. A. secretaries held here it was to defer action on the proposal to remove the general headquarters from Charlotte to Greensboro for the convenience of the secretaries. Action on the removal plan will not be taken until next year.

Baptists of Pilot Mountain Asso Are Planning Campaign

Winston-Salem, Feb. 19.—Plans for the holding of meetings in the Baptist churches throughout the district of the Pilot Mountain Association in the interest of the \$75,000,000 campaign were laid at the conference of the pastors and laymen of the Pilot Mountain Association held in Salem during the past week. Beginning February 25 the meetings will be held in the churches and efforts will be made to have all of the pledges of the churches and the church members this is the final year of the five-year paid up by the end of the year, year period which was set aside as the time for the payment of the pledges.

HOUSE IS STILL IN DEADLOCK OVER INCOME TAX RATE

Republican Leaders Are Confident That Vote Will Be Close

Washington, Feb. 19.—An eleventh hour appeal by the White House to House insurgent leaders urging agreement with the organized Republicans on the Mellon income tax rates schedule failed to break the deadlock of the groups.

When the income tax rates question is taken up in the House Republican leaders admit that the vote will be close with the Democrats united for the Garner Democratic plan and with the insurgents still holding out against the treasury rates and threatening to vote with the Democrats if their compromise is not accepted by the administration.

House consideration of the tax bill reached the amendment stage yesterday with insurgents and organization Republicans still split over income tax rates and Democrats confident they have the votes to pit over their substitute schedule.

Under the agreement reached when the measure was taken up last week, general debate ended at 4 p. m. Reading of the bill under a rule which permits the offering of amendments with discussion limited then was begun.

By a vote of 140 to 67 the House rejected the first amendment offered—by Representative Frear of Wisconsin, Republican insurgent—which would have authorized the Federal government to tax state and municipal securities.

The income tax rate section will be considered tomorrow, with votes likely on another amendment by Mr. Frear, which would not disturb the present 50 per cent surtax, but would cut normal tax rates in half, and on a proposal of Representative Garner, Democrat, Texas, to hike normal tax rates and reduce the surtax maximum to 44 per cent.

Republican organization leaders, who see no likelihood of obtaining a majority for the Mellon proposal for a surtax maximum of 25 per cent, were undetermined tonight whether they would receive a vote on a compromise proposition for a 35 or 37 1-2 per cent surtax maximum or devote their energies entirely to an attempt to defeat the Garner plan.

Wake Forest Will Celebrate Its 100th Anniversary in 1934

Wake Forest, Feb. 19.—Assurance that the hundredth anniversary of the establishment of Wake Forest College were evidenced in the appointment of the faculty to work out the definite plans for the celebration which will take place in 1934. The plans will be varied and cover a large scope of the work of the college. Questionnaires have already been sent to members of the faculty as well as the heads of the departments, asking what is needed to make the college a complete and perfect college in every detail by 1930. The date for complete expansion is set at this time, it was said, in order that the school may have a margin on which to work for perfection.

Sub-committees have been appointed to facilitate the work of the general committee. The sub-committees and their chairmen are: Dean D. B. Bryan, housing students faculty, and fraternities; Dr. C. C. Pearson, library; Dr. J. H. Gorrell, buildings and grounds; Dr. R. P. McCutcheon, instructional and professional needs; and Dr. A. C. Reid, needs and possibilities of an extension service.

HIS MOST HONORABLE ACT

Edwin Denby has resigned as Secretary of the Navy. It is at once the saddest and the most honorable act of his official career. As was said of the Thane of Cawdor, so it may be said of Denby: "Nothing in his life became him like the leaving it."

The charge against Denby is not one of profiting in a personal way from the public trough. No charge of personal gain from the infamous leasing of the naval oil reserves has been laid at his door.

But it was his signature that made it possible. He was asleep at the switch, and the infamy that comes to those negligent at a public trust must be laid at his door for that reason. Guilty of making it possible for others to carry out their nefarious purposes, he must be held equally guilty with them because it was he that made it possible. Had he stood firm, there would have been no oil scandal.

As if it were not enough to sign away public possessions without so much as making an effort to determine whether or not it was proper, Denby calmly announced that if it were to do over again he would do exactly as he had done. His regret was not in leasing two naval oil reserves but in not having more to lease.

It was bad enough to know that in high public position was a man who could be grossly negligent of the public interests, but it was

ten times worse to learn that he was proud of what he had done. Things have not yet come to such a pass in America that public men can boast of their negligence in public office.

Edwin Denby is not the only man in President Coolidge's cabinet who slept at switch Harry Daugherty is equally guilty of astounding negligence to a public trust. The officially appointed legal guardian of great public interests, he did not and has not turned his hand to undo the infamous oil leases.

Dougherty must also go. He has already to all intents and purposes abdicated his office, just as Denby did when he signed the oil leases. Daugherty admits his inability to perform the duties of his office, and President Coolidge is compelled to employ outside counsel by law in the hands of the Attorney General.

President Coolidge has shown patience that is admirable but he has exercised it in a bad cause. It was evident that Denby could not remain in office, no matter how wrong it might be for the Senate to petition for his resignation. The President placed himself in an untenable position when he was forced to stand by Denby's side in order to uphold what was clearly his constitutional right in refusing to accede to the Senate resolution.

That the President recognized the impossibility of adhering to that position is shown by the resignation of Denby that quickly followed. Had the President been engaged in a fight that involved a righteous cause, he might successfully have met the issue presented by the Senate resolution. As matters stood, he was forced to recognize that the Senate was right and that he was wrong.

With Denby out of the way and with Daugherty on the way of getting out or being forced out, President Coolidge must assume the responsibility for as sorry a mess of things as any administration ever had to stand for.

The President has been a part and parcel of that administration. He sat at the same cabinet table with those proven guilty of negligence. There is no evidence that he ever protested against what was done. There is no indication that he ever became aroused to the seriousness of the situation until the "startling revelations" were made through the persistent efforts of Senator Walsh, a Democrat, who was thwarted at every turn in his search for the details.—News and Observer.

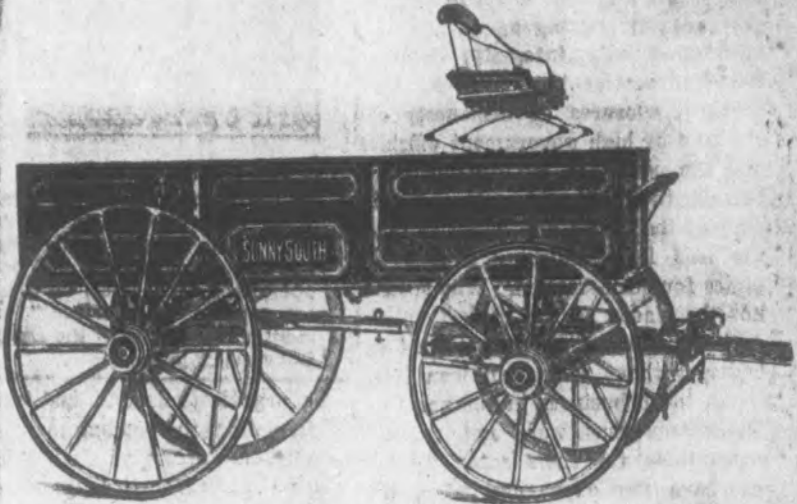

A. F. ROWE READS INTERESTING PAPER ON "BANK LEADERSHIP" AT PITT COUNTY BANKERS MEET

The following paper on "Bank Leadership" was read by Mr. A. F. Rowe, of the First National Bank of Ayden, at the meeting of Pitt County Bankers which was held in Greenville during last week.

"The usual conception of a bank is a place where money and valuables are kept, where credit is created and sold, and where the various fiduciary activities are carried on. But the more fundamental purpose of a bank is to increase human happiness. There can be no nobler purpose than striving for the development of the individuals of a community into a more united group of free, contented, generous, law-abiding, home-loving people. What institution is there in a community that has a better opportunity for setting an example of business honesty, integrity, faithfulness and service than a bank? The recent disclosures of dishonesty on the part of high government officials and the part that big organizations had in the dishonest acts make it evident that some one ought to take the lead in establishing a code of ethics for business men. Why should not the leader be the banks?"

Corporations were first defined as bodies without souls and men soon began to do business in the name of institutions that were not morally accountable for their acts. Hence, we have the expression "We, it's business, you know," and the person using it referring to a transaction which would not be thought correct of a truly just and upright man. There are many men who take pride in their goodness and virtues doing things in the name of a corporation or institution that they would not think of doing in their own name. They believe that being the employees or agents of a corporation, they are not responsible for their acts and since it exists without a soul their evil deeds are shifted, no one knows where.

Sometime ago a farmer was complaining about a note he had given a merchant and was asked the trouble. He told the following incident which was true no doubt. In the spring he gave a note to a supply merchant for the purpose of securing the supplies to be furnished his tenants during the season. The tenants were compelled to go to this merchant for their supplies and paid a high price, furthermore, ten per cent was added because the goods were supposed to be sold on time. Soon after the note was given the merchant discounted it at a bank. The farmer had to pay the note in the fall and reimburse himself from the crops of the tenants. The result was that the merchant got immediate cash for goods to be furnished during an entire season and charged a high time price for which the farmer was personally liable. Gentlemen, that's business, but is it sound economics? Is it good morally? Is it in accord with any kind of ethics? Can the thousands of souls in this county ever strive for the excellent when half of them are so hampered by business organizations? Until they can there can be no happiness and the ultimate in life cannot be attained. The success of this county is to be determined not by its four hundred but by its hundreds of illiterate, party deformed and mostly morbid tenants, both black and white.

In the early fall of last year a meeting was held by the business men of one of the towns in the county for the purpose of discussing the advisability of inviting all the citizens of the adjacent communities to come together and spend the day in thanksgivings for the abundant crops with which they had been blessed. Many speeches were made about the noble purpose of the proposed meeting, and one was ready to believe that the time had come when there was to be good will on earth and peace among men. All went well until the time came to set the day. Many suggestions were made but not approved. Finally, some one remembering that according to custom the President set aside a special-day for thanksgiving suggested that the day be the 30th of November. But alas, the negro in the woodpile came out. It was quickly agreed that that day would not do for by that time the farmers would have spent all their money. What had been the beautiful dream of a whole community assembled in thanksgiving had become the hideous thought of such a meeting dominated by business men for the purpose of personal gain. The business men of this county are as honest as those anywhere, but they are all too ready to sacrifice the most noble sentiment of human nature for their individual interest.

Aristotle defined the ultimate in life as "an activity of the soul in the direction of excellence in an unhampered life. How can individual souls strive in the direction of excellence when their bodies are hampered by the economic injustices imposed upon them by unethical busi-

ness organizations and institutions: I believe that the banking institution as a whole operate on a much higher plane of morals than most other business organizations. But the general practice of time merchants in this county, for one example, does not contribute to the best welfare of the county as a whole. When they weaken the productive power of the community, they lessen the purchasing power, and when that is decreased the whole community suffers. Lawyers, doctors and members of other professions have codes of ethics which govern them as groups in their dealings with their fellow man. While the educators and public spirited men and women are stressing higher standards of citizenship, it is a good time for the banks to use all the influence within their power in making the ten rules of conduct for individuals the rules of conduct for business men and business organizations. When these rules are put into practice, mail order catalogues will cease to come to Pitt county, a great many of the burdens of securing a living will be lifted from the people generally and all will find more time to strive for the eternal verities.

VETERAN OF MANY WARS MYOMING HOMESTEADER

Sheridan, Wyo.—Nick Wildt, a native of Siberia, has entered a re-posing phase on an adventurous career by taking up a homestead on a Wyoming ranch.

Wildt was drafted into the Russian army at the tender age of 9. At 17 he was a Cossack trooper. He fought at Port Arthur and in three other major engagements of the Russo-Japanese war. In 1908 he was assigned to the late Czar's personal bodyguard, and remained in this service in St. Petersburg for six years. In August, 1914, he took part in the first battle of the Russo-German war on the eastern front.

Wildt was wounded at Posen and taken prisoner, but finally escaped from Hamburg on a British submarine. He made his way to the United States in 1915, but returned to France with the American army two years later. He fought in six more engagements and was wounded as many times.

Wildt returned recently from Honolulu, where he completed his enlistment in the American army. He wears eight decorations, several of them bestowed by the Czar.

WANING PATRONAGE CLOSES COLOGNE'S HOME BREWERIES

Cologne.—The little home brew beer shops of Cologne, one of the town's well known institutions for some 200 years past, have about disappeared.

They were popular because many Germans used to believe they could, and did, make better beer than the big breweries. But this point of view has been changing for years; customers have been deserting the small places, and the last of them has given over its efforts to hold on to the past and, deserting its cellar vats, has become converted into a regular beer hall, dispensing the standard brands.

Slow Rehabilitation Of England Charged To Luxurious Living

Leeds.—The reason rehabilitation in this country is so slow, is that everyone both collectively and individually spends more than they can afford. This statement was made by Felix J. Blakemore recently in an address to the Chamber of Commerce here. He said the Board of Trade returns for 1923 showed an adverse balance against this country of \$1,000,570,000, indicating that while there had been a fall in the value of exports, the value of imports had increased and so depreciated the value of currency in foreign countries, causing a slight increase in the cost of living.

"How many people, if they could be detached from present prejudices

and could see through the eyes of 1913, would be able to recognize or even reconcile the standard of living of pre-war days with that demanded at the present time. The theatre, music hall and cinema make a far greater demand upon personal expenditure than they did in 1913. Food luxuries at every meal are more common today than in pre-war days, and it appears to be an undoubted fact that individually and nationally we are living above our income."

Mr. Blakemore asserted that unless all sections of the community were prepared to make some sacrifice and return to a more humble and less ostentatious method of living, the period necessary for the adjustment of the present economic difficulties would be greatly extended.

London.—Large canvases painted by old masters to hang upon the spacious walls of the rich man's mansion are hard to sell in these days of apartments and small houses. Bond Street dealers say the demand is almost entirely for small pictures, so that prices frequently are in inverse ratio to size.

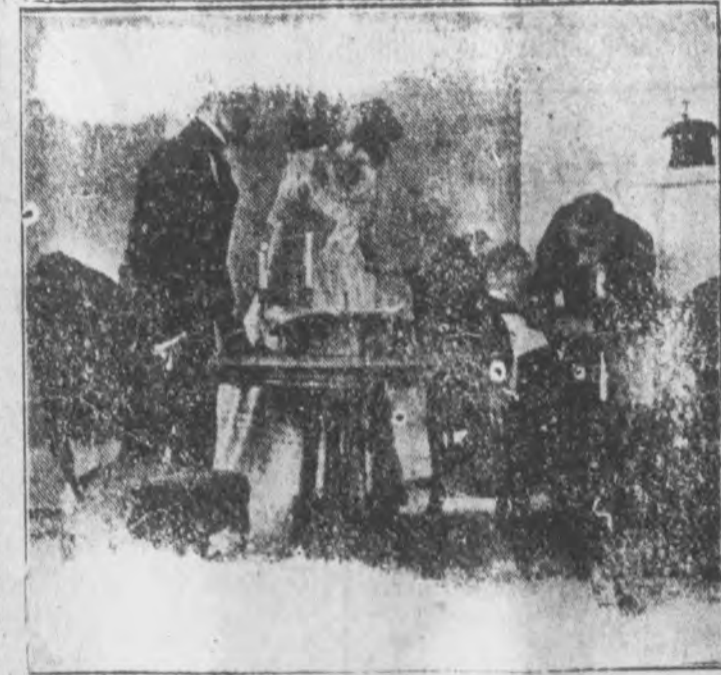
