

CANDIDATES FOR PRESIDENT NOT FILED IN STATE

Democratic Convention Meets in Raleigh On April 19

Raleigh, N. C., April 3.—The present outlook, judged by the records of the Secretary of State of North Carolina, is that there will be no efforts to capture the vote of the electorate in North Carolina by any of the aspirants for the Presidency on the Democratic ticket, it became known here tonight. Neither of the outstanding candidates, William G. McAdoo and Oscar W. Underwood have filed notice of entering the state. In the event that no one files there will be no Presidential ticket in the primary on June 7 and the vote of the Democratic State convention will govern. The convention meets this month, the 19th, at Raleigh.

Mr. McAdoo's campaign organization indicated sometime ago that he probably would file his candidacy for the Presidency in North Carolina and it was intimated at the same time that if he were to do so that Mr. Underwood also would file in this State. Neither has shown any signs of doing so, however, and so far as is known neither of the men has any speaking engagements in North Carolina during the next few months.

Talk of a third candidate, which has been going around the State in the last two months, has assumed definite form in many communities and friends of Josephus Daniels have indicated that his name will be presented to the convention this month. The McAdoo forces as well as those of Underwood are prepared to put up a stiff fight to capture the convention if possible, it is said, and if Mr. Daniels' friends place his name before the convention, there is expected a fight to control the convention which will be very much more exciting and out of the ordinary than otherwise. Though Mr. Daniels has discouraged any attempt to link his name with the Presidential bid and though he asked that his name be not submitted to the people in Georgia, those of his supporters for the office who have indulged in speech-making at the organization of various Daniels-for-President Clubs throughout the State have indicated that they expect to carry the fight to the convention and have high hopes of there being successful. Mr. Daniels exact attitude remains undetermined. Prior to the Teapot Dome disclosures he announced in favor of Mr. McAdoo but since that time he has had nothing to say.

If there is no filing for the Presidency there will be no Democratic ticket for that office and the will of the convention will govern. If there are candidacies for the primary vote, this will nullify any action of the convention and the delegates to the New York convention will be pledged to support the man who carried the primaries. The convention may pledge the delegates to one of the three candidates who have been mentioned or to any other or they may be sent to New York uninstructed. The latter course has prevailed generally in the past.

Fiery Cross Blazed On the Campus of Columbia University

New York, April 3.—The Fiery Cross blazed last night on the campus of Columbia University. It was set up and fired by a group of white robed and hooded men opposite the hall where Frederick Wills, negro law student has a room from which the fellow students have attempted to oust him. While the cross burned Wills remained in his locked room heedless of calls and knocks of his neighbors.

French, of Oklahoma City and Robert El Wolfe, of Columbus, editor of the Ohio State Journal. Both will be questioned as to gossip about oil deals at the Republican National convention in 1920.

"Young" Stribling Beats McTigue.



W. L. ("Young") Stribling, the sensational 19-year-old Macon, Ga., fighter, won a popular decision in a 12-round fight with Mike McTigue, world's light heavyweight champion, in Newark, N. J. Stribling outpointed the champion in every round and knocked him down in the tenth. Since decisions are forbidden in Jersey, McTigue retains his title.

The witness also declared that papers from his own personal files in connection with aircraft cases, had been taken from his brief case by Captain Volandt.

GOV. MORRISON IS WEDDED TO WIDOW OF GEORGE WATTS

Leave Immediately After Ceremony for Tour Northern Cities

Durham, April 3.—Cameron Morrison, governor of North Carolina and Sarah Ecker Watts, widow of George W. Watts, Durham millionaire financier, were married here yesterday afternoon at 4 o'clock at the Watts mansion on South Duke street. Rev. Dr. David H. Scanlon, pastor of the Durham First Presbyterian church officiated at the ceremony, which was witnessed by the governor's sister, Miss Ida Morrison, his daughter, Miss Angela Morrison, and a few friends, consisting mostly of state officials. Immediately after the ceremony Governor and Mrs. Morrison motored to Greensboro where they boarded a northbound train for their honeymoon trip.

The bride, one of the wealthiest women in North Carolina, is a native of Syracuse, N. Y., and was married to the wealthy Durham capitalist in that city on October 25, 1917. Some years ago she was a trained nurse but had given up that profession prior to her marriage to Mr. Watts.

Governor Morrison had been a widower since 1920, his first wife having died during his gubernatorial campaign in that year.

Although the governor and Mrs. Watts had known each other for several years it was only in the past fortnight that their romance was learned of by even their closest friends. During the past two months, however, the governor has been a frequent visitor in Durham.

Early this afternoon the Governor and his party, comprising state officials, and his daughter and sister, motored to Durham from Raleigh and went to the Durham county court house. The license was issued at 3:10 o'clock by Deputy A. J. Barber, of the register of deeds' office. The license application was signed by General J. Van B. Metts, of the governor's personal staff and Mr. Morrison's age was given at 52, while Mrs. Watts' was given as 51.

Since the death of Mr. Watt's on March 6, 1921, Mrs. Watts had carried out her husband's philanthropic work. An estate of \$13,000,000 was left by the Durham financier, who was 70 years old when he died. The fortune was accumulated mostly through investments in tobacco manufacturing. Only one daughter, Mrs. John Sprunt Hill, of Durham, survived Mr. Watts, besides his widow.

North Carolina May Have Another Winter Resort Soon

Fayetteville, April 3.—Plans are being made here for the establishment of another winter resort in North Carolina similar to Pinchurst, according to a statement made here by Percy Rockefeller of New York. Mr. Rockefeller has an estate, Overhills, near here and the general plan upon which he is working, it was said, will be to lay out the resort between Fayetteville and this estate. He asserted that he would continue his preliminary planning and probably would have a definite announcement to make in a few days.

Pinchurst has come to be one of the leading winter resorts of the country. With several golf courses, polo, tennis and other winter sports, it yearly draws hundreds and thousands from all sections of the country. Many of the winter residents of Pinchurst have been going there for several years and are well known to the North Carolina inhabitants of the town.

Two Women Killed When Sanitorium Is Visited by Fire

Morganton, N. C., April 3.—Two women were killed and one man and woman badly burned, perhaps fatally when fire destroyed the north wing of the Broad Oak Sanitorium for nervous diseases. Forty two patients were in the building when the flames were discovered by the night watchman. It was at first believed all patients had been removed but later it was discovered that several were missing.

U. S. Senator C. C. Dill, of Washington, has introduced in the senate a resolution calling upon President Coolidge to remove Theodore Roosevelt, Jr., as Assistant Secretary of the Navy because of his former connections with the Sinclair Oil Company, and the fact that he ordered U. Sinclair, multi-millionaire oil magnate, was indicted by a Federal Grand Jury in Washington for refusing to answer questions put to him by a Senate investigating committee. Will H. Hays, formerly Postmaster-General, has renewed his contract to serve as Czar of the movies until March, 1928, at a salary, said to be \$300,000 a year—\$822 a day.

THIRTY-SEVENTH ROTARY DISTRICT CONFERENCE OPENS IN RALEIGH THIS MORNING

Raleigh, N. C., April 3.—With representatives of forty Rotary clubs in North Carolina and Virginia present, the annual conference of the Thirty-Seventh Rotary District opened here this morning. After the registration period it was estimated that the total number of visiting Rotarians and their wives exceeded nine hundred. All during last night incoming trains brought the visitors and many who were unable to leave their businesses yesterday arrived during today. Automobiles from Virginia and many North Carolina cities were here in numbers, many of the delegates having motored through the country for the conference. At the railroad yard at the North end of Salisbury street, a "Pullman" city was seen early today, many of the visitors occupying the cars while here, by special arrangement.

Registration started early today at a local hotel chosen as the headquarters of the conference. Here District Governor G. Franklin Lenz of Newport News, Va., welcomed hundreds of fellow Rotarians during the day. At ten o'clock the conference was called to order by President John Park of the Raleigh Club after which the address of welcome was delivered by Josephus Daniels of the same club. The District Governor then convened the assembly and responded gracefully to the address of welcome. The Rev. Henry G. Lane of Raleigh delivered a prayer and the meeting then got under way.

During the business session which followed appointments were announced to several committees and the election committee was named. Shortly before noon seven former District Governors were presented to the conference and the club presidents also were introduced.

District Governor G. Franklin Lenz of Newport News, Va., delivered his annual address, touching on the work of Rotary, its influence in the communities where it had been established and the great task that faced Rotarians in the betterment of their communities. He called on Rotarians everywhere to lead the way in civic movements of their communities.

An interesting address on Rotary International, its Organization and Activities was delivered by John J. Gibson, director of the international organization with headquarters at Toronto, Ontario, Canada.

Following Mr. Gibson's address, the Rotarians separated for luncheon into four groups at banquet halls about the city. Each group was under direction of a Rotary Club and a definite program was carried out

at each luncheon, Norfolk, Virginia; Greenville, N. C.; Portsmouth, Virginia, and Washington, N. C.; clubs had charge of this portion of the program and directed the activities at the four group meetings.

At this afternoon's session, Walker Pettyjohn of Lynchburg, Va., led the Rotarians in songs after which an address on Rotary Fundamentals was delivered by Charles J. Smith, president of the Rotary Club of Roanoke, Va., Mr. Smith after outlining as of the highest value in getting together men of the Rotary type, the unique basis for membership, touched on the compulsory attendance rule as a factor in holding the clubs together. He declared that the friendships developed by Rotary organizations were invaluable to the men in their business as well as private lives and asserted that the individual member was bettered and his business improved by the contact with men of the Rotary type, the constant exchange of ideals and the high type of work for the community which all Rotary organizations undertake as part of their community offering. He added that ethics in business were improved by men who got together for the purpose very often of exchanging ideas gotten in the every day life which tended to improve business practices.

M. Eugene Newson of Durham, N. C. discussed the unfiled classifications in clubs and urged upon the men the value of a standard for classifications and the value of a classification survey. There followed his address a short discussion open to all.

Douglas S. Freeman, editor of the News Leader of Richmond, Virginia addressed the members on Rotary service in the community, state and nation, stressing ideals to be striven for in the betterment of relations and the concrete idea of service as conceived by Rotarians.

Following Mr. Freeman's address short talks were given as follows:

HUSBAND AND WIFE IN SUICIDE PACT IN RICHMOND, VA.

Holmes Cummins Dead, While Widow Is In Grave Condition

Richmond, Va., April 3.—Attending physicians today held little hope for the recovery of Mrs. Holmes Cummins, nationally known under the pen name of "T. D. Pendleton," who was found yesterday with a bullet wound in her breast lying near the body of her husband, a prominent clubman and insurance broker, who had been shot through the head. She was barely alive and frequently lapsed into periods of unconsciousness. She told the authorities that she and her husband decided sometime ago to end their lives. Ill health was assigned as a motive.

Officers advanced the theory that Mrs. Cummins had shot herself and then passed the pistol to her husband. They believed the tragedy had taken place perhaps 12 hours before the arrival of police.

The woman was taken to a local hospital for treatment.

Mrs. Cummins was formerly a writer of short stories, contributing to a number of popular periodicals under the pen name of "T. D. Pendleton." Cummins was a graduate of Virginia Military Institute and a member of the V. M. I. and Westmoreland Clubs here. He was for 25 years representative here of several insurance companies.

Cummins was 54 years old; his wife's age was given at 42. They had no children.

At the hospital last night attendants said the woman's condition was "grave." When questioned about the affair, Mrs. Cummins said to officers: "I shot my self, and Holmes took the gun and shot himself." She expressed tonight a wish to live, attendants said.

Police went to the apartment yesterday afternoon when they received information that "something was wrong" there. They declined to disclose the source of the report. Breaking in the door, they found Cummins' body slumped in a corner on the floor, the pistol dangling from his hand. Mrs. Cummins lay on the bed, which was stained with blood. The woman was scantily clad, while the man was in street clothing but without a coat.

Cummins was said to have suffered from asthma for several years. A few days ago he left a hospital where he was undergoing a treatment, his widow said.

A SHORT HISTORY OF RADIO

Replying to charges by Federal Trade Commission that eight leading industrial companies had secured a monopoly in foreign and domestic radio business, Pres. Swope of General Electric Company, said:

"The connection of General Electric Company with question of radio communications in this country were handled by American Marconi Co., controlled by British Marconi Co."

Mr. Swope pointed out that to establish radio communication for the United States free from domination of foreign interests, the General Electric Company was induced to take the lead in reorganizing the American Marconi Company which eventuated in the formation of the Radio Corporation of America. Mr. Swope said: "To make Radio Corporation the most efficient instrument for transoceanic communication, General Electric made a contract with Radio Corporation giving the latter the benefit and advantage of all inventions it had made and would make in future. To strengthen further the position of Radio Corporation in this art, similar contracts were made with other companies, the idea being to put Radio Corporation in possession of those patents necessary to make it an efficient organization for radio transmission and enable it best to serve public interests."

"This was all known to the government, and a representative designated by the government sat on the board of Radio Corporation for

some time after its organization. Officials of Radio Corporation appeared before a Congressional committee, where all these relations relating to formation of Radio Corporation were told in detail. Several months ago the Federal Trade Commission published its statement as result of investigation of Radio Corporation of America and its relation to the various companies interested in it. This report was widely published. There was no indication in this report of any adverse opinion or action on part of the Federal Trade Commission.

All that has been done has been with the idea of making Radio Corporation an efficient instrument of radio communication in interest of the government and the American public."

Is a national policy which seems to question the honesty or sincerity of every large business organization or group of business interests that attempt to render a highly efficient public service, going to encourage either the inventor, the investor or the organizer of progressive business undertakings? If every man, group of men, or company which attempts to render a nation-wide service is eventually to be accused of carrying on activities in restraint of trade, what incentive do we offer for real development? Radio communication has been the greatest experiment of the age. It has required courage and perseverance to put capital into an industry as new and untried as this.

A WORLD LANGUAGE

A great world telephone system, making necessary to all nations the use of a common language, or a common understanding of language, will some day join all the people of the earth into a common brotherhood. Such is the logical conclusion of John J. Carty, Vice-President, American Telephone and Telegraph Company.

The ultimate system of providing the communication of the world will consist of both wire and radio, each supplanting the other in proportion to its capabilities, for each has its limitations, he says. "Thus science and industry will ultimately annul war and bring about an era of peace and good will."

The recent action of the Federal Trade Commission in attacking on the ground of monopoly, the radio, telephone and electric manufacturing companies which are trying to develop world wide communication, will not encourage expansion along these lines.

Turn out on sugared paper, spread quickly with jelly or preserve and roll up at once. The cake will crack if spreading and rolling are not quickly done. Sliced jelly roll is delicious with custard. Sufficient for one jelly roll. 4 eggs, 1 cupful sugar, 2 tablespoonfuls melted crisco, 2 cupfuls flour, 1 teaspoonful lemon extract, 1 teaspoonful baking powder, 1 teaspoonful salt, 4 tablespoonfuls milk, Jelly or preserves

Dr. Otto Wiedfeldt, German Ambassador to the United States, is preparing to return home. His place will be filled by Dr. Solz, now German Ambassador to Japan. By throwing \$200,000 on the market in a lump sum, buying an equivalent sum in francs, Myron T. Herrick, American Ambassador to France, is said to have greatly aided in stabilizing the French franc, and to have made 1,500,000 francs to be applied to the purchase of an American Legation in Paris. The Live-At-Home Program Meeting With Big Response

Raleigh, March 21.—The live-at-home program begun by North Carolina is meeting with hearty response in the state and is now being adopted by a number of other Southern states, according to B. W. Kilgore, director of the Extension Service of the North Carolina State College of Agriculture and the Department of Agriculture. Mr. Kilgore is in receipt of letters from five other Southern states commending the plan and requesting all available information about it, so that similar movements could be inaugurated in those states.

Virginia is the latest state to adopt such a plan, Mr. Kilgore said. He has just received a letter from Professor John R. Hutcheson, director of Extension service at Blacksburg, saying: "Following your lead we are putting on an Agricultural Independence Campaign in this state to begin the first week in April. I have asked the Governor to issue a proclamation in regard to the matter. I am therefore writing to ask that you send me a copy of the proclamation that the Governor of North Carolina used in regards to your campaign."

This information has been supplied Professor Hutcheson, together with copies of the North Carolina boll weevil program, enlistment blanks for the live-at-home movement and other material issued by the workers of the State College of Agriculture in furtherance of the movement in North Carolina this year.

Arkansas is also following closely in the footsteps of North Carolina on this project, it was stated. Dan T. Gray, formerly in charge of livestock work in North Carolina, is now Dean and director the Extension service of the former state. The officials of the Arkansas Extension service have copied the North Carolina enlistment blank and have added two items to the ten that already appeared on the pledge. T. Roy Reid, assistant director of Extension in Arkansas, wrote to Director Kilgore and said:

"In a conference of our supervising agents and specialists, we decided to adopt the plan which is being used in your state so successfully as a part of the program which we put on this year for a 'Prosperous Arkansas.' It is our plan to present an honor certificate to the farmers who agree to do eight of the things mentioned on the pledge, and then carries them out. Your courte-
