Senator John W. Harrelld, Republican, Oklahoma, made a voluntary statement to the Senate Department of Justice investigating committee relative to his activities and connections with the prosecution of the Miller Brothers Indian land fraud cases.

The Senator had been mentioned in connection with the case in the testimony of former United States Attorney Peck, Oklahoma, who worked up the cases.

Senator Harrelld said that he had heard rumors that Peck was to be removed and replaced by another because Miller Brothers wanted to get him out of the prosecution before the cases came to trial.

Pennsylvania Senator Proposes Peace Parley

Washington, April 7.—A joint resolution proposing a world peace conference was introduced today by Senator Pepper, Republican, Pennsylvania. The Senate would advise the president under the resolution that the time is suited for the assembling of a conference similar to the two held in the past at the Hague.

Senator Pepper's resolution brought the Democratic Senators to their feet. Democratic leader, Senator Robinson, Arkansas, said that he agreed that there is need of another arms conference but he added that he did not agree that there was any grounds for congratulation on the results of the Washington arms conference which limited itself to limiting capital ships already practically obsolete.

WILLIS SUCCEEDS CLODFELTER AS CASHIER OF FARMERS BANK

Clodfelter to Go With F. S. Royster Guano Co. — Will Remain Resident of Greenville

Clergymen Make Charges and 'Hubby' Is Busy Explaining

Asbury Park, N. J., April 7.—Local officials and business men are today busy explaining to their wives as a result of sermons by six clergymen preached yesterday charging that Mayor Clarence Hetrick, county and city officials and business men attended a banquet last Thursday night at an inn in Deal where it was stated that the guest drank much liquor and five women danced.

The sermons constituted a step in a joint campaign against bootleggers and immorality launched here Saturday at a meeting of civic and church leagues and the Ku Klux Klan.

Mayor Hetrick admitted that he had attended the dinner but denied that anything improper had taken place in his presence. He said that there was no rudeness, no vulgarity, no drunkenness and no nude women and that the women in the cabaret were properly clothed.

Automobile Party Capture Bald Eagle

A great deal of interest was created on the streets of Greenville Saturday by the exhibit, in front of the office of The Reflector of a very large specimen of the great American bald eagle.

The bird is exceedingly rare in this locality and is said to be the second one to have been known of here—the other having been shot in the county several years ago.

Capture was made by an automobile party consisting of Joe Staton, John Bunn Briley, June Edwards and Charlie Bell, who were returning from the seacoast and were near Grimesland. The eagle started to cross the road in front of the car but was blinded by its lights and after a rather exciting fight was captured and caged.

It measured six feet nine inches from tip to tip of its wings and weighed 10 1/2 pounds.

Texas Senatorial Election Shows A Majority Mayfield

Washington, April 7.—The recount of the ballots cast in the Texas Senatorial election in 1920 was practically completed today and on its face showed a substantial majority for Senator Mayfield, Democrat.

SEN OIL COMMITTEE INQUIRES FURTHER CONVENTION DEALS

Four Witnesses, Including Former Treasurer National Democratic Committee Appear In Featureless Session

Washington, April 7.—The Senate oil committee devoted another featureless session of its inquiry into stories of oil deals and contributions to political campaigns of 1920. Four witnesses followed one another in quick succession at the big witness table but none added materially to information previously placed in the records.

Wilbur H. Marsh, former treasurer of the Democratic National committee, testified that he must consult the records of the committee before he could tell how much E. L. Doheny contributed to the Democratic fund in 1920; W. L. Kistler, Oklahoma oil man, disclaimed any connection with Republican campaign collections that year; J. B. French, Oklahoma City, told the committee that Jake Hamon had informed him of expenditures of \$100,000 in the 1920 election and of \$25,000 to pay the hotel bills of Harding's convention headquarters in Chicago; Bobert F. Wolfe, publisher of the Ohio State Journal, Columbus, insisted under repeated questioning that he had no first-hand information about the famous 2 o'clock hotel conference of the Harding nomination and that he never, until recently, heard of any attempt to make an oil deal for the nomination of Gen. Leonard Wood.

The question of contributions to national campaign funds by all interests received momentary attention of the Senate oil committee today. Wilbur H. Marsh, former treasurer of the Democratic National committee, the first witness was questioned about contributions by E. L. Doheny to the Democratic war chest. Marsh said that he had no recollection of any specific contribution of E. L. Doheny to the 1920 campaign fund. It would be necessary he said to consult the records of the committee which are now in Washington at committee headquarters.

Marsh was excused and W. L. Kistler, Tulsa, Oklahoma, president of the Producers Refining Corporation, was then called to the stand by the committee. He said that he was not at the Republican National convention in Chicago in 1920 but identified himself as a Republican at this time. He was not requested to solicit campaign funds in 1920, he said under questioning, but was asked to make a contribution which he did subscribing \$325.

Lightest Vote in Years In Michigan Primary

Detroit, Mich., April 7.—The lightest vote in years is indicated in today's presidential preferential primary throughout Michigan. Reports told of unfavorable weather, wet snow in most cases, combined with a lack of interest in general had curtailed the turnout of electors.

American Merchants Killed In Albania

Rome, April 7.—Martial law has been proclaimed in Albania following the murder of two American merchants on the Tirana-Scutari highway, according to advices from Albanian quarters today. The names of the murdered men were given by the American Embassy as Robert Louis Coleman, San Francisco, and George B. DeLong, New York City.

## SANITARY RURAL HOMES

We feel that there can be no better time than this, the beginning of Spring, to call attention to the urgency of sanitary precaution—particularly in the rural districts.

The many forms of parasitic and germ carrying life are becoming active after their periods of hibernation and now is the time to start warfare against them.

W. A. Anderson, head of the department of sociology of State College of Agriculture has covered the subject very ably in a series of articles—of which the following is a part:

"Of equal importance with water supply in the sanitation of the rural home is the disposal of sewage and waste materials. Rural people are not aware of the danger to health from exposed human excreta, manures, and other waste matter and so make no provision for their sanitary disposal. In the south, in eleven different states, on 95,988 farms of 189,596 visited or on 51 per cent of them, there were no toilets of any kind. Such a condition is typical of North Carolina's rural districts. Manure piles are exposed and trash and waste materials that make breeding places for disease-carrying insects are scattered about. Dish-water, garbage, and refuse are thrown just outside the kitchen door, drawing flies and thus spreading disease. The rural population must recognize that such conditions are imminently dangerous. That education along these lines needed goes without saying. The careless disposal of waste materials is extremely dangerous. Trash and manure piles are breeding places for disease-carrying insects, especially the fly. These insects carry germs to the food consumed by humans.

The problem then, of the sanitary disposal of sewage and waste materials in the country is to "so dispose of the filth that none of it, however small, may reach either the mouth or skin of persons." It is not an expensive or difficult matter to dispose of it in this way.

The method of preventing the transfer of disease germs from manure to individuals is simple. If barns are properly cleaned and the manure put directly upon the farm land this difficulty would be solved. Incidentally

such a method would save double labor and save a large percentage of the valuable elements in the manure which are usually lost.

Waste waters from the house should not be thrown just outside the kitchen door. The bacteria they contain are bound to be carried to the house on the feet of people or flies. Such water should be poured into a sewer, if a sewerage system is on the farm, or dumped into the toilet tanks.

Trash piles should be burned. Fire will quickly destroy any insects and improve the appearance of the farmstead.

The most important problem in sewage disposal is that of human excreta. There are simple and inexpensive ways to dispose of it which are excellent from the sanitary standpoint. Rural North Carolina is an unsewered area. Methods of excreta disposal must, therefore, take this into account. Two types of toilets are excellent for farm use. The one is the removable-receptacle type, the other is the stationary-receptacle type. The factors of importance in the use of either of these types are proper construction, proper use, proper upkeep, and proper disposal of contents.

In the removable-receptacle type construction is simple. The buildings should be constructed to afford privacy. It must contain a water-tight receptacle, that is protected from flies or animals, and so arranged that it may easily be removed for cleaning. A box receptacle is perhaps the best. Inside of a box constructed to allow removal is placed a large cylindrical water-tight can. The box is fly-tight, being covered either with wood or partly fine mesh screen and well ventilated to remove odors. Wood receptacles warp easily, therefore galvanized iron cans prove best. The wood box can be made a part of the out-house building. Such a sanitary toilet requires little attention. To disinfect the waste matters and prevent bad odors a chloride of lime solution (1 pound to 8 gallons of water) may be used. This is cheap and very effective.

The disposal of the contents must be done regularly and with care. It should be buried, after thorough disinfection, in a trench at least a foot deep. The burying place should be a good distance from the house and where water coursing through the soils will not enter wells used for domestic purposes.

There are several kinds of stationary receptacle toilets. The fly-tight pit type is sanitary if deep enough and far enough away from the water supply. Some are constructed of concrete, based on the principle of the septic tank. This form of toilet should be constructed with care and according to carefully drawn plans. Such plans may be obtained from the Public Health Bureau of the United States Government. Where water systems are established more elaborate toilets can be constructed, but for the open country, both from the sanitary and economic view-point, these types, if properly tended and constructed, are very satisfactory.

To summarize, the sanitary rural homes in North Carolina requires proper location, proper construction, adequate ventilation, a well protected pure water supply and the disposal of all waste materials in such a manner that will not spread disease.

STATE NEWS

Raleigh, April 5.—More than six thousand dollars was collected in the police courts here for fines and cost during the quarter ended March 31, according to J. M. Hoover, clerk of the court. The fines for the quarter amounted to \$3,982 and the cost amounted to \$2,116, both fines and cost totaling \$6,128, the records show.

According to the docket there were 486 cases tried during this period. There: 61 dismissals; 14 not pros; 11 appeals; 12 suspended sentences; 21 probable causes; and 21 sent to the county road. Five bonds were forfeited; one prisoner escaped; three were ordered out of town; and three women were sent to the county home. # FIRST PLACE AMONG CONVENTION CITIES IS CLAIMED BY CHICAGO

Chicago.—Its central location, virtual hub of railway systems of the country, ample hotels and market advantages are said by the Chicago Association of Commerce to be contributing factors toward Chicago having become the leading convention city of the United States.

Figures just announced show Chicago last year to have been the host to 753 conventions with an attendance exceeding 700,000. These are exclusive of the hundreds of small group meetings which were not registered. Selection of the "New Athens," Chicago self-styled, as the site for the international eucharistic congress in 1926, which is expected to bring more than 1,000,000 visitors in one month, was based largely on these conditions, commerce officials believe.

A dozen new hotels were built last year and more than a score are projected for 1924-25. The normal hotel capacity of Chicago is in excess of 100,000 rooms per day. It is claimed, while materialization of the new projects within the next few years will double this capacity.

"The diversity of activity in Chicago is so great that there is found a replica of virtually every human problem, be it manufacturing, educational, sociological, medical, mercantile or financial," the association asserts. "Situating in the heart of a population of 50,000,000 within a night's ride, more persons are able to take advantage of these activities than in any other city. On the social side, the features are unlimited."

## Mongolian, Scientist Says, Was Ancestor Of American Indian

Santa Barbara, Cal.—That the American Indians and an ancestry common with the Mongolian tribes of Siberia and crossed to Alaska over the Bering Sea are conclusions of John P. Harrington, of the Smithsonian Institution.

Mr. Harrington arrived at this belief after extensive research on the Pacific Coast. He fixes the discovery of America by the Indian at more than 20,000 years ago. Explaining his belief that the Indians went directly to Alaska across the Bering Sea, instead of over the chain of Aleutian islands at a time when the islands may have been an isthmus connecting the two continents, he says:

"From a long strip of Siberian coast the Alaskan shore is in plain sight across Bering Strait, which at one point is only 50 miles in width. The two small Diomed Islands also help to break the passage. This strip of water at times is frozen over and could have been crossed either on the ice or in boats which were made by the Indians even at the earliest times."

Mr. Harrington discounts the theory advanced by some anthropologists that the Indians migrated from the Polynesian Islands.

"From my studies of the Indian races of the Pacific Coast I believe that the Indians, after crossing from Siberia gradually spread from Alaska down the Pacific Coast and thence over all north and south America. This is based on the singularity of physical characteristics, the widespread occurrence of customs and myths and an exhaustive study of the languages."

## A FROCK FOR A PLACE IN THE SUN



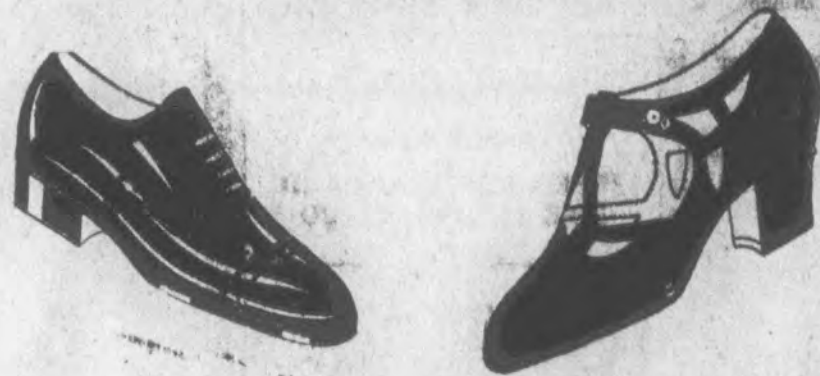

In the future the police department has instructions to, and will indict every person caught violating this ordinance. Please be on your guard.
