Dawes Plan Meets With Approval

INDUSTRIES TO BE RETURNED GERMANY

Foreign Mortgage To Be Put on Railroads to Secure Gold

Paris, April 9.—The report of the experts who have been engaged for the past few months in the task of ascertaining the ability of Germany to pay her war indebtedness and the best manner of safeguarding the interests of the allies was handed to the reparation commission this morning.

The two chairmen, General Charles G. Dawes and Reginald McKenna have gone deeply into the intricacies of the many problems involved with the object of working out a plan of collection rather than the recommendation of palliatives.

The report insists that if Germany is to be compelled to pay she must have a free hand to restore economically sound conditions in the Ruhr section, and if France and Belgium have to be satisfied by a continued occupation of the Ruhr they must keep their hands off the Rhineland and Ruhr railroads and the other Ruhr industries.

It is reported as likely that an American will head the new Gold bank of issue in Germany.

The report emphasizes the importance of the sound business principles of fairness, justice and mutual interest in all efforts at collection of the reparation payments and warns against any action that would continue or increase the industrial and economic demoralization of Germany.

It details plans for the inauguration and operation of a gold bank of issue through which the payments to the account of the foreign debts would be made and the commissioner of which would be in authoritative position to report on the condition of Germany at all times to increase her payments.

The Dawes experts had two major problems; first, to stabilize the German budget; and second, to restore German money currency to a gold basis.

Railroads estimated by the experts at 26 billion gold marks with a revenue capacity of more than a billion gold mark annually were declared available for application to the reparations.

They proposed a mortgage of 11 billion gold marks at five percent and with a sinking fund of one percent.

In order to bring back the gold basis, the experts propose a new bank of emission to displace the Reich bank. It will have fourteen directors—seven Germans, one American, one English, one Italian, one French, one Dutch, one Belgian and one Swiss with a president who will be a German.

The powers of emission will be limited by an Allied controller who, in order to prevent inflation, will forbid any credits to the treasury. The new bank will not discount treasury bonds except to private individuals.

The capital of the new bank will be 400,000,000 gold marks, 100,000,000 of which will be taken up by the Reichsbank. The balance will be divided into 3,000,000 hundred mark shares which will be offered to the public.

Features of New Bank. The aim of the new bank will be to buy in all the Rentenmarks, which it will do with the subscribed capital of 400,000,000 gold marks, with Reichsbank gold totaling 400,000,000 gold marks and with an additional 400,000,000 to be raised by an international loan.

A special department of the new bank will be created to receive the various receipts provided for in a second plan, which is a railway society with a capital of 22,000,000,000 gold marks organized on the same lines as the bank.

This capital will be divided into 11,000,000,000 ordinary shares to be taken up by the German government and 11,000,000,000 preference shares bearing 6.5 per cent, of which 5 per cent will be for interest and 1 per cent for sinking fund. These obligations will be deposited with the Committee on Reparations, which will issue them to the world markets.

first mortgage of 10,000,000,000 gold marks on industrial and land property of these shares 6,000,000,000 will go to the Allies for issuance and 4,000,000,000 to the German government.

The committee further recommends an entirely new series of gold taxes on spirits, tobacco, wines, beers and matches estimated to yield, 1,200,000,000 gold marks a year, which will be remitted to the bank's accounting department and divided equally between Germany and the Allies.

The committee declares that it is certain Germany herself will be unable to make any payments until the excise year of 1928-29, and so still another tax on transportation, valued at 290,000,000 gold marks annually, will be imposed, which will be the basis for another series of international loans with which to pay reparations during the next four years and the expenses of keeping the troops on the Rhine.

Loans Expand Annually. For 1924 and 1925 the experts expect to borrow only one billion gold marks, each successive loan being in proportion to the amount of the transport tax and other taxes available as guarantees. Two hundred millions will be borrowed on railway gross receipts and an 800,000,000 international loan will be gaged on the railways the interest on which will be taken care of by the 90,000,000 gold marks unused from the transport tax.

The 1925-26 loan will be 1,250,000,000 gold marks; for 1926-27, it will total 1,500,000,000 gold marks; for 1927-28, two billions; and the experts believe 1928-29 will be a normal year without a loan, with Germany able to pay a surplus of 2,500,000,000 gold marks to the Allies from half the customs duties taxes and half the capital tax on the gross receipts of the railways.

New Taxes Proposed. This two and a half billions the experts consider should be paid by Germany with an equal amount from then on yearly until they acquit themselves of the full debt the total of which the experts leave to the governments to decide. But as this two and a half billions will only pay the interest on the "A" and "B" reparations bonds, the experts conceive that Germany should institute a sinking fund for these bonds by further payments based on a 4 per cent prosperity index with the payments increasing in the ratio of prosperity. It is expected that the German fortune will be doubled within 25 years.

It should be strongly emphasized that the committee has not considered the German capacity for payment, nor a moratorium, nor sanctions, while the entire fabric rests on French willingness to abandon the reparations system so laboriously built up in the Ruhr. The fact that the French are on the Rhine and Ruhr is entirely ignored by the experts.

The committee headed by Reginald McKenna frankly state that they have failed in the purpose for which they were called—to bring back to Germany the German wealth cached abroad, which the committee values

BISHOP DARST IN SPLENDID SERVICE EPISCOPAL CHURCH

Class of 11 Candidates Presented by Rector For Confirmation

A crowded church greeted the Right Reverend Thomas C. Darst, D. D., Bishop of the Diocese of East Carolina when he ascended the pulpit last night to preach.

The preliminary service had been taken by the Rector of the church, the Rev. James E. W. Cook, assisted by the choir, under the leadership of Miss Betsy Greene, organist. The church choir was augmented by the Junior Choir; and the appearance and singing of these young people called forth a graceful recognition from the Bishop. Taking as his text, the words of Job, "Lo, these are parts of His ways; but how little a portion is heard of Him? but the thunder of His power who can understand?" Doctor Darst pointed out that the original Hebrew might be translated, "Lo, these are but the fringe of His garments." He graphically described Job and the arguments that his friends presented to explain God's dealings with him. They tried to "catalogue" God, saying He was this and that, and acted thus and so. Job listened in silence as long as he could, and then breaks forth into a magnificent description of the power and glory of the Godhead; and finishing with the assertion that when we realized all this we have only touched the fringe of His garments. God transcends all our thoughts of Him. God cannot be "catalogued." With the eloquence of splendid simplicity, the Bishop illustrated how true this is in the realms of Nature, Personal Experience, History, and Revelation. In the development of his thought, he said he was not afraid of the discoveries of Science, nor of the conclusions of Philosophy. These, when true, must blend with the truth of Revelation. Dr. Darst clearly showed that he does not endorse the positions taken by the so-called Modernists; while believing in an ever-enlarging conception of God.

We only touch the fringe of His character with all our knowledge, and we can do no more until we stand in the sunlight of His Presence and no longer see through a glass darkly but "face to face." After the sermon, the rector presented a class of eleven, nine of whom were adults, for Confirmation.

This ancient rite of the "laying-on of hands," observed by the church since Apostolic days, was then observed, and the Bishop's prayer spoken over each candidate fell like a benediction on all present: "Defend, O Lord, this Thy Child with Thy heavenly grace; that he may continue Thine for ever; and daily increase in Thy Holy Spirit more and more, until he comes unto Thy everlasting kingdom. Amen."

Bishop Darst left Greenville this morning for his home in Wilmington, and before leaving again expressed his pleasure in being able to visit our city.

INDICTMENT WILL HAVE NO EFFECT ON INVESTIGATION

Washington, April 9.—The Senate committee appointed to investigate the Department of Justice and the official acts of Harry M. Daugherty announced, after executive session, that the investigation would proceed with renewed force despite the indictment in Montana of the committee's prosecutor, Senator B. K. Wheeler.

At a meeting held behind closed doors, the indictment returned against the Montana senator was discussed at length. Afterward Chairman Brookhart made the following statement: "This investigation shall proceed and proceed with a force and determination not shown before."

George W. Stork of the Department of Justice was then called to the stand in open session and was questioned regarding a list of departmental cases on which he had worked. Stork's testimony yesterday had to do with the Old Hickory Powder Plants of Tennessee, but today his examination swung into phases of other post-war cases involving the Bosch Magneto Company. Stork said he had worked up the proceedings, "I indicated Duffy after investigating the case" he said.

23 Annual Meeting N. C. Academy of Science, May 2 - 3

Durham, April 9.—The twenty-third annual meeting of the North Carolina Academy of Science will be held at Trinity College on May 2 and 3, according to an announcement made here by Dr. Bert Cunningham, head of the department of Biology of Trinity College, and secretary of the Academy. Scientists from all over the state are expected to attend. The North Carolina Academy of Science was organized for the purpose of stimulating interest in the subject and to afford an outlet for the work done by those of scientific inclinations in the state. The annual meetings have been held every year since the founding of the organization and it is claimed that they have furnished source of new enthusiasm and educational opportunities.

The growth of the Academy has been such that it has become necessary to divide the organization into sections of the various sciences. There are no separate sections for mathematics, chemistry, physics, and a combined section for the other sciences.

The officers of the Academy are: (President, Professor C. M. Heek, of North Carolina State College; Professor J. P. Givler, North Carolina College, is vice-president; and Dr. Bert Cunningham, of Trinity College is secretary-treasurer.

SENATOR DENOUNCES INDICTMENT IN SENATE

Investigation Ordered Today By the Senate of Charges in Montana

Washington, April 9.—Rising to a question of personal privilege Senator Wheeler denounced the indictment made against him in a speech that attracted considerable attention in the Senate today.

The Senate Chamber and galleries were crowded.

Washington, April 9.—Investigation of the charges under which United States Senator B. K. Wheeler was indicted in the Federal Courts of Montana, his home state, were ordered in the Senate today.

Washington, April 9.—United States Senator B. K. Wheeler, Democrat, of Montana, indicted at Great Falls, Montana, under charges of accepting money improperly, having agreed to accept money after his election but before he had qualified for office intends to remain in office and continue the prosecution of former Attorney General Daugherty's administration.

Denying ever representing Gordon Campbell, oil geologist, I. C. Stevenson, promoter or the others indicted with him on matters before the department of the interior, as charged, he said, "This indictment is simply the result of my activities here on the investigating committee trying to show up corruption in the Department of Justice. I have, however, represented Campbell in litigation in Montana."

Former attorney General Daugherty, when informed of the grand jury's action, authorized the statement that the Department of Justice had nothing whatever to do with evidence against Senator Wheeler, all of it having been uncovered by the Post Office department.

When first informed of the indictment last night, Senator Wheeler said, that the charge was a frame-up and that there was nothing to it. He later issued an extensive statement in which he said in part:

"This indictment is merely the latest illustration of the corruption of the Department of Justice. The machinery of Federal justice has been utterly prostituted. On the one hand there have been failures to indict, failures to prosecute, convenient losses of evidence if the criminal belongs to the gang.

"The failure of the Department of Justice to indict ex-Secretary Fall, although months have elapsed since his connection with the oil leases has been exposed, illustrates how the Department of Justice protects the members of the conspiracy.

"This indictment which has been found against me is a characteristic answer to the damaging testimony that has been brought out by the Senate investigation of the Department of Justice.

"The record of the department under Daugherty furnishes endless illustration both of failure to indict where crimes were committed, and of the use of the machinery of justice as in this case, for reprisal.

"Here is an indictment brought on a presentation by a Daugherty appointee with the hope it will be tried before a judge who is also a recent selection of Daugherty.

"It is in truth an indictment evidently brought at the instigation of the Republican National committee officials in connivance with the late Attorney General solely for the purpose of interfering with the Senate investigation which is uncovering the facts of the great conspiracy. That is the sole basis of this attack.

"This action is the most convincing evidence that the investigation of the Department of Justice should go on—and it will go on—because it shows that even with Daugherty out of office his malign influence still moves his old pawns."

THE RAILWAY LABOR QUESTION

Commenting on the Howell-Barkley Bills now under consideration by Congress and variously known as the "Railway Labor Act" and House Bill 7353 and Senate Bill 2616, the New York Times says:

"The bill to substitute national boards of adjustment of railway wages for the Railroad Labor Board is unfortunately coupled with the national wages agreement of the wartime. The objection to the national wage 'agreement' was not that it raised wages, but that it wasted wages."

"It multiplied jobs and limited work to those listed in classes of duties divided and subdivided until there were overlappings and endless causes of dispute."

"The indefensible nature of the national wage agreement is shown by the perfectly amazing increase of transportation despite the fewer workers. The railways are not now wasting their labor costs."

"So far as the railway workers seek to abolish the Labor Board, and to restore national agreements and adjustments with waste of wages, it is contrary to public interest and unfair to all labor not included in national unions."

Summarized briefly, the following should be clearly understood concerning the Howell-Barkley bills. They would

1.—Set up National Board of Adjustment which shall be referred disputes arising out of advances or the application of agreements concerning rates of pay, rules or working conditions, which have not been decided in conferences between the affected parties. These boards are authorized to hear and decide such disputes.

2.—So constitute these Boards of Adjustment that employees who are not members of the so-called "nationally organized crafts," must join them to be represented on the Boards, practically forcing the closed shop upon the railroads.

3.—Through a Board of Mediation and Conciliation, arbitration boards, etc., set up a complicated and involved machinery to prevent railroads from changing rates of pay, working conditions, etc., but specifically permits employees to strike whenever they are so disposed.

The bills offer no promise of industrial peace except through arbitration, where the two parties agree in advance to abide by its results and the findings are entered as a judgment of a United States District Court. Under such an arrangement, the railroads are positively bound, but there is no such restriction on the employees.

At a time such as this when there is widespread demand for economy in Government and tax reduction, is it worth while to abolish one agency and set up another costing three times as much with no certainty that the cause of industrial peace will be bettered?

HOW ABOUT RE-ELECTION PROMISES?

For years the cry has been raised, "Let us have business men in public office."

One of the keenest business men in the world today is the present Secretary of the Treasury. Mr. Mellon has been executive surtaxes drive capital out of productive enterprises into tax-exempt bonds and instead of securing revenue from the rich the taxes which they have escaped by the tax-exempt bond route have been made up by citizens of ordinary means, and industry which furnishes the employment of this nation.

In his tax reduction program, Secretary Mellon is accused of reducing taxes of rich proportionately more than he reduces the tax on smaller incomes. The mere fact that he had the courage to make the greatest reduction where it was needed in order to bring capital out of hiding in tax-exempt securities and thereby secure new sources of wealth, the income from which would help bear the cost of government, shows that he is no politician.

That the Mellon plan starts with a reduction of 25 per cent on \$3,000 incomes climbs to a reduction of 29.24 per cent on \$15,000 incomes and ends with a reduction of 45.72 per cent on million-dollar incomes, is seized upon by opponents of the Treasurer's plan as conclusive proof that it is merely in the interest of "big business." They fail to see the clear reasoning that lies behind this well worked out plan, the ultimate aim of which is to make taxable the greatest aggregate amount of wealth, thereby dividing the tax bill among the greatest number of people.

Why reduce an excessive surtax at all unless the reduction is sufficient to cause capital to enter productive business?

Mr. Mellon has figured with mathematical certainty that in order to get large incomes into productive enterprise rather than into tax-exempt bonds, a reduction of at least 30 to 45 per cent is necessary and that in order to secure sufficient revenue, a greater reduction than 25 per cent is not possible on smaller incomes.

These figures are twisted around to confuse the average mind into thinking that the rich man is going to be taxed less than the poor man. This is not the case. Excessive surtaxes are reduced a proportionately greater amount than the lower tax on smaller incomes but individuals with larger incomes are still paying a much greater percentage of tax than those with the smaller incomes.

Mellon's plan is one such as a business man in politics would work out. The substitutes which have been proposed are largely of the old political order which seek to gain popular favor by appealing to the greatest number of persons from a purely selfish standpoint.

Politics has so far been able to kill a tax reduction program. Officials in Washington have practically broken pre-election pledges for tax reduction which is essential to continued prosperity in this nation.

Cobb Calls North Carolina Most Progressive of States

"North Carolina is the most up-and-coming state of the South, if not of the entire Union," declares Irvin S. Cobb, famous writer, in his "North Carolina Brought" just published. "All she needs is a press agent," adds Cobb, writing at some length on our beauties of climate and scenery which he considers unexcelled in any state. He deplors the fact that neither the thousands of Northerners who cross the state going South, in December and January, nor the great body of well-to-do folk from the far South who cross it going north in the hot months, know that in North Carolina we have close at hand the finest climate for both seasons. They they will find in winter—"A climate with enough frosty spice in the atmosphere, mornings and night-times, to give it zest, and enough of midday warmth to give it softness and a spring-like balm." And in the summer, "... Up in the North Carolina mountains, they might find the tonic of cool breezes and the medicine of a pine-laden air, and with these a panoramic grandeur that is not to be excelled and probably not to be matched anywhere between Martha's Vineyard and Yellowstone Park."

These books, as such as anything he has written, would seem to confirm the popular estimate of him as the greatest living American humorist. Cobb does not confine his praise to North Carolina to her climate. He calls her the most typically American beauties of climate and scenery which he considers unexcelled in any state. Her metamorphosis in a short fifteen years from one of the most backward states to the most progressive state in the Union.

He has unbounded admiration for her early settlers: "Her first citizens backed their way to the heart of the wilderness. They were not disdainful of earning their bread in the sweat of their brow; they were not afraid of getting horny callouses in their hands." Speaking of North Carolina's hospitality Cobb mentions that on his last visit here, to the Bob White Club, he and several of his friends were on a diet for weight reducing purposes. A certain famous cook called Uncle Jim caused them to fall from grace. In describing this Cobb writes: "For that week we had a new prayer, give us This Day Our Daily Bread!—And, lo, the prayer was answered."

Raleigh, April 9.—More than 500 delegates representing 300 clubs of the state are expected to attend the twenty-second annual meeting of the North Carolina Federation of Women's Clubs in this city during May 6 to 9, according to Mrs. Cornelia P. Jernan, president of the Federation, who has formally issued a call for the meeting. Mrs. Helea Gardner, United States Civil Service Commissioner, who is the first woman ever to hold such a Federal government position of nation-wide importance and who was appointed by the late President Wilson, will be the principal speaker of the sessions. The keynote of the convention will be "Woman As A Factor in The World's Work," and Mrs. Gardner will adhere to this line when she speaks on "Woman in Government Work."

The meeting will be marked by special business meetings and social affairs in honor of the visiting delegates. The Raleigh Woman's Club will give a reception in honor of the delegates at the club house on Tuesday evening following the formal opening of the convention at a local hotel. The combined men's civic organizations of the city are also planning several entertainments for the ladies of the convention. These organizations include the Lions, Rotary, Kwanis and other clubs.

RIO GIVES THOUGHT PROPOSALS TO TRIM AMERICAN TRAVELER

"American Millionaire" is one word, or should be hyphenated at the very least, in the opinion of most Brazilians. It is doubtful if many citizens of this country could be brought to believe that there exists a "poor American," or even one in "moderate circumstances."

Perhaps the motion pictures are responsible for some of this golden phrase. The film millionaire is always an American. The traveling American, however, must assume the rest of the blame. His generosity is famous. His tips are bigger and he pays bigger prices than anyone else. In fact he rather enjoys his reputation for reckless spending.

But while the American may enjoy a sense of generosity, he likes to believe that his spending is a matter of free will. He has no patience with being over-charged just because he is American.

For this reason, visiting and resident Americans are frowning over the adoption of a double scale of prices by the hotels, restaurants, and certain other business houses of this country, one set of prices being for Americans and the other for Brazilians.

The plan to make Americans pay more than others, was described in a story published recently by the *Jornal do Commercio*. The abnormal exchange situation was advanced as the reason. The dollar is now worth three times as many milreis as it was a few years ago. While the general increase in the cost of living has cut the purchasing power of the milreis in half, the dollar has steadily climbed in value, and the Brazilians feel that the Americans are getting all the best of it.

By charging special prices to Americans, the article says, the Rio de Janeiro hotel and restaurant men are killing two birds with one stone: they are increasing their receipts, and at the same time are able to keep prices down for their Brazilian customers.

There is a tendency to include other foreigners in the special price scheme on the suspicion that their income is established on the gold basis, but Americans are the main objective.

The visiting American, if he does not like the special price arrangement, can cut his visit short, but the resident who is obliged to remain for business reasons is out of luck—especially if it happens that his salary is paid in Brazilian money.

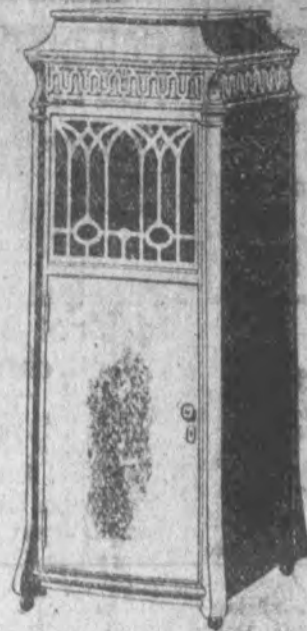

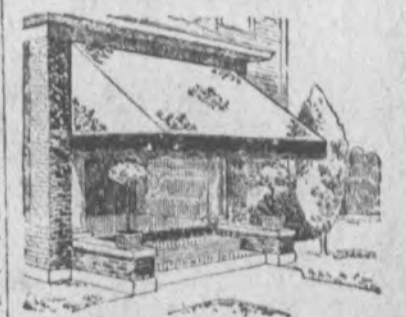
Every car is asked to drive to the building just across the street from the Exposition building, where all will assemble for dress and further instruction. It is exceedingly important that no one fail to comply with this request.

EVANGELIST M. F. HAM

Evangelist M. F. Ham, who is to conduct the revival services at the Forbes & Morton warehouse in this city, beginning Tuesday next, is a native of Allen county, Kentucky. He is the son of Rev. T. J. Ham, one of the outstanding Baptist ministers of that section and is the seventh in an unbroken line of preachers which has descended directly from Roger Williams, pioneer preacher of America.

Mr. Ham received his early education in the public schools and later as a student in Ogdon College, distinguished himself as a student and as a public speaker. Early in life he studied law, and successfully passed the bar examination, but at the time was too young to receive a license to practice his profession. While awaiting to attain the legal age, Mr. Ham became a commercial salesman and continued in this pursuit for five years. In 1900, at the death of his grandfather, Rev. M. F. Ham, for whom he was named, he returned to his home and surrendered himself to the ministry in answer to the call which he had been fighting for several years. In 1901 he held his first meetings in the hills of Kentucky and such remarkable results attended his ministry that he attracted the attention of the press and the pulpit throughout the country and in less than two years he was holding meetings in the greatest cit-

ies of the nation. Since that time he has held campaigns in every Southern state and most of the northern states and everywhere his ministry has been remarkably successful. In the 22 years of his ministry 80,000 souls have been added to the churches of the towns where he has labored exclusive of the great number who have been converted and reclaimed under his preaching. During the prohibition campaign in this country, he was one of the foremost figures in the battle, doing his greatest and most effect work in Texas. During this time 72 cities voted dry following his campaigns.

His work is distinctive in the evangelistic field in that he has held more meetings of long duration than any American evangelist. He recently closed a series of meetings in Nashville, Tenn., where he remained eight months preaching at least twice every day during that time. It is regarded as the greatest campaign of its kind ever waged in that city. His Houston, Texas, campaign lasted over four months and he has held a great many other meetings of considerable duration. His policy is to stay with a meeting till the harvest is reaped.

His meetings are especially noted for their spiritual power. For over twelve years Mr. Ham conducted his meetings almost entirely without the assistance of a singer and little emphasis was laid on the usual schemes to draw crowds. Some of his great-

est and most sweeping meetings were held during that time. Mr. Ham early convinces his hearers that he is not in the work to entertain, though he is an exceedingly dramatic and gripping speaker, and his audience soon learn to respect his high and lofty conception and presentation of Christianity and his deep sincerity of purpose.

He is a man of splendid physique, attractive and winning personality, modest bearing cultured and refined, and a gripping speaker who does not resort in any way to discourteous and indecent action to produce his results. He seldom fails to win the whole-hearted admiration and respect of every class of citizens in the cities where he labors, whether or not he convinces them of his religious convictions.

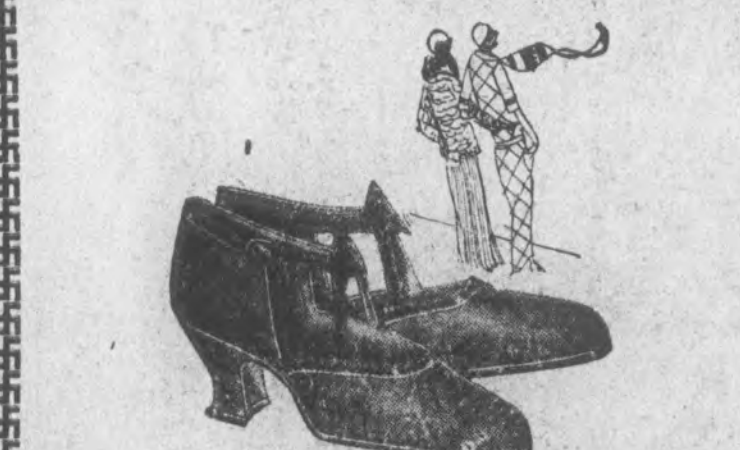
