FLAYS WORLDLINESS AS ENEMY SPIRITUAL MAN IN GOD'S SERVICE

Ham - Ramsay Evangelistic Campaign Drawing Great Crowds and the Message in Song and Sermon is Already Showing Great Signs of Influence and Power in the City

"Worldliness" was the subject of the gospel message delivered last night by Rev. M. F. Ham and the forceful speaker and interpreter of God's word brought to his hearers a practical definition of the term and with it a distinction of what worldliness means to the life of the individual, explaining that the worldly man has no place in the kingdom of God.

The first obligation that man has in service to God is the throwing out of the enemies that would turn the life away from God. These enemies were classed, the World and the Flesh and the Devil. Having already discussed the Devil in the opening sermon the evangelist spoke at length on the first mentioned enemy, the World. Man places an interpretation on the term "worldliness" that does not exactly coincide with the definition that is to be found in God's word. Man would the term refer to those who are living in revelry and indulgence of a carnal nature, but God thinks of the term as meaning more than merely that. It refers to a man who is making temporal and material things uppermost in his life. A man may be intelligent, and stand high in the opinion of christian men, and may even be spiritual himself and at the same time be worldly in his living.

Quoting from Galatians 1:4—"Who gave himself for our sins, that he might deliver us from this present evil world, according to the will of God and our Father," and again from I John 2:15-17—"Love not the world, nor the things that are in the world, if any man love the world the love of the Father is not in him. For all that is in the world the lust of the flesh, and the lust of the eyes and the pride of life, is not the Father, but is of the world. And the world passeth away, and the lust thereof; but he that doeth the will of God abideth forever," the minister based his teaching about worldliness not on any thing that he might say concerning it, but upon what God had said was meant by the term.

He remarked, "The love of the Father, saves you from the love of the world, the prince of light saves you from the prince of darkness, the spirit saves you from the flesh," and with these remarks the forceful minister waved over his audience the solemnity of the will of God as he poured out to them from the cruse of a Christ-filled life the power of God to cleanse men from their sins and turn them on toward a road upon which worldliness did not travel and find no encouragement. Not that he would not be there but that the spirit of the man so wrapped up in the spirit of God would be able to resist the temptation of the devil and all his forces.

The minister classified the enemies and friends of the physical man as representing a triangle in form and shape. The three foes of man, he termed the World, the Flesh, and the Devil, while the three friends forming the triangle of redemption, were the Father, the Son, and the Holy Spirit. The earth which is the habitation of man belongs to God and man is only entrusted with the privilege of living on it and enjoying its fullness. And God makes the distinction between the things of the world which are represented in the body and the things of the spiritual life which are represented in the soul of man. If man fails to recognize this distinction in life, he at the same time fails to see God in the workings of all human existence. For only through the eye of the soul can God be seen, and through the life that is spiritual can the power of the God be felt.

While man's body may be used continuously for evil, the soul of man is the great force of his existence, it is with the soul that man lusts, hates, covets, loves, worship, and lives, not with the body. And it is only through the influence of the spiritual spark in the soul that it will be made to become a power and influence for Christ and the work of the Master. Food is to be glorified with the body and the soul. Any disfigurement of the body is not pious on the part of

HELD UP WARDEN WITH WOODEN GUN

Joe Sullivan, Slayer of Detective Electrocuted This Morning

Little Rock, Ark., April 18.—Joe Sullivan was electrocuted at the State Penitentiary here for the murder of Luther C. Hay, a Little Rock detective, last July.

"Diamond Joe Sullivan was one of a trio of condemned murders who held up the warden of the Arkansas penitentiary with a 'wooden automatic' pistol on February 1, and after seizing a rifle and two pistols that had been thrown over the walls the night before, forced the warden to drive them from the prison stockade in his automobile.

His two companions, Emory Connell and Eulos Sullivan, were shot to death five days later by a posse composed of Little Rock police officers, newspaper men and special deputies. Joe Sullivan, suffering from cold and hunger and exposure from surrendered to the Jefferson county police earlier in the day. He declared that he had been shot accidentally by Connell two nights after the escape while they were traveling through a dense woods.

Connell and Eulos Sullivan were discovered by three local newspaper men in a short time after the posse had started a search of the woods where Joe Sullivan had surrendered. The two convicts were hidden in a fallen tree top and were said to have opened fire on the reporters as soon as they had been discovered. One of the reporters was hit in the foot by a bullet during the general battle that followed between the convicts and members of the posse. The three newspaper men were later awarded one third of the \$1,000 reward offered for the convicts, dead or alive.

Higher courts affirmed the death sentence of Joe Sullivan and denied a rehearing. Executive clemency has been sought but Governor McRae has steadfastly refused to interfere with the carrying out of the sentence.

Governor McRae has since pardoned two trusty convicts for their "loyalty and devotion" to duty in connection with the escape.

The gasoline tank burst and ignited the wreckage.

New Orleans Damaged By Wind, Hail Storm

Property Worth Quarter Million Destroyed—More Than Fifty Persons Are Injured

New Orleans, La., April 18.—Injured in the severe wind and hail storm that swept over the city last night, wrecking numbers of houses and damaging others, had increased to 50 today.

None of the victims were seriously injured.

The police estimate the property damage will exceed two hundred thousand dollars.

MEMORIAL PILGRIMAGE TO MOUNT VERNON

Winding Hot Campaign For Election of General Officers

Washington, April 18.—A memorial service with tributes to the general officers who have died, a pilgrimage to Mount Vernon and the placing of wreaths in the tombs of George and Martha Washington, resumption of balloting for honorary, vice-president general and an evening devoted to Pan-American relations comprised the activities today of the delegates to the Continental Congress of the Daughters of the American Revolution.

The following results were announced as the result of the balloting for eight vice-presidents general:

Those elected for a three-year term were: Miss Anne W. Lang, Dallas, Oregon; Mrs. Paul Duane Kitt, Chillicothe, Missouri; Mrs. Logan S. Gillentine, Murfreesboro, Tenn.; Miss Amy Gilbert, State Center, Iowa; Mrs. Norval Smith, Warren, Arizona; Mrs. Edith Scott Magna, Holyoke, Mass., and Mrs. T. E. Spence, Milwaukee, Wis., Mrs. Franklin Cain, St. Matthews, South Carolina, was elected for a two year term.

Mrs. Rhett Goode, of Alabama was unopposed for the office of Chaplain-General, but no election resulted for honorary Vice-Presidents-General, no candidate receiving the required two-thirds vote. Another ballot will be conducted for this office tomorrow.

GREENSBORO MAN IS TO MANAGE BAILEY CAMPAIGN

Bailey to Tour State Until Primary Is On—June 7th

Formal announcement has been made from the Josiah Bailey campaign headquarters that C. L. Shuping an attorney of Greensboro had been selected as manager of the campaign.

He will be in charge of headquarters in the Tucker Building at Raleigh. Mr. Shuping was manager of the Page campaign in Guilford county in 1920. In announcing the appointment, Mr. Bailey said:

"Mr. C. L. Shuping, of Greensboro, will manage my campaign, and is now in charge. For the remainder of the period between now and the primary, June 7th, I shall be canvassing the State upon the questions at issue.

"Mr. Shuping was campaign manager for the Hon. R. N. Page in the primary of 1920, in Guilford county, and proved his capacity by winning in Guilford a notable victory for Mr. Page. He was chairman of the Near East Relief campaign in Guilford in 1923. During the war, Mr. Shuping was executive secretary of the North Carolina Fuel Administration, and rendered in that capacity a very great service.

"I ask those who are supporting the causes represented by my candidacy to join heartily with him in his plans to organize for victory June 7th. My present offices, that is rooms 201 and 212, Tucker building, Raleigh, will be headquarters.

"I feel assured that in personal character, in loyalty to the Democratic party and to Democratic principles, in practical experience, and in executive capacity, we have in Mr. Shuping a leader possessing every qualification for a contest like that now at hand."

JAPAN AROUSED OVER EXCLUSION LEGISLATION

PREMIER KIYOURA SAYS NOTE MISCONSTRUED

Stock Market in Tokio Depressed by Reports of Senate Action

Tokio, Japan, April 18.—Recall of Ambassador Hanihara is not contemplated by the Japanese government, at least for the present, Premier Kiyoura told American correspondents today, after a meeting of the cabinet.

He declared the Ambassador's note, containing the 'gravest consequences' phrase, was very much misconstrued in America.

News of the status of the Japanese exclusion clause of the Johnson immigration bill had an adverse effect on the Tokio stock exchange and industrial stocks showed a decline of a few points.

The Tokio Asahi, in an editorial called the Senate's action in approving the Japanese exclusion provision of the immigration bill "a legislative crime." The editorial, concluding, says:

"The meanness of the Senators' action is shown by their distortion of Ambassador Hanihara's words to suit their own purposes. The Americans declare that the Yellow and other dark races are not entitled to consideration as human beings, since they do not belong to the Caucasian or negro races.

"American history and politics are full of references to 'open doors.' Commodore Perry came to Japan to 'open our doors' and much is said about the 'open doors' in China. Where, therefore, is the consistency in a 'keep out' sign hung on the doors of the United States for dark people. "Americans take pride in their power and wealth to do anything they like, but after all, it is a wise policy to make enemies of millions of Asiatics."

The Tokio Chamber of Commerce has adopted a resolution, which it is sending to the principal American Chambers of Commerce, expressing regret at the adoption of exclusion and pointing out the dangers to commerce that might result.

"Close study of the text of the Ambassador's note would convince anyone that it does not lend itself to interpretation as a threat or express any desire to interfere in American domestic affairs," the premier said.

Claims Crime Was "Keeping a Secret"

Ossining, New York, April 18.—Reuben Nortin was electrocuted in Sing Sing prison last night for assisting Abraham Becker in the murder of Becker's wife. Nortin acted as lookout while Becker knocked his wife unconscious and then helped him bury her in lime.

Becker was electrocuted last December. As the guards were about to strap him in the chair Nortin said, "My only crime is keeping a secret."

PROFESSOR E. L. HENDERSON ADDRESSES WOMAN'S CLUB HERE

The Woman's Club held its regular meeting in the Memorial Baptist society the life processes of American history. Washington, April 18.—Stories of oil company influence at the Chicago Republican convention in 1920 were further explained today by the Senate oil committee, with William C. Proctor, of Cincinnati, campaign manager for Leonard C. Wood.

Proctor denied that he had conferred with the late Senator Boise Penrose during the convention nor with Harry Sinclair at the convention, but that he had asked Sinclair before for a campaign contribution, but had been refused. Until the last day, the witness declared, he had known nothing of the plan to nominate Warren G. Harding.

The Carolina Motor Club was founded at a meeting of Carolina business men held September 15, 1922. The first membership began October 1st, 1922. It now has over 130 official emergency service stations all over the Carolinas.

In connection with the work of the club there will be an automobile license tax department. There will also be a complete road information service. This will give the condition of the roads and will be a valuable service to the traveler.

The Carolina Motor Club is making an attempt to turn the tide of tourists to the Carolinas and is busy compiling all the data necessary for the traveler.

The school boy of a generation ago found that when he had mastered "partial payments" he had gained much confidence in his own accuracy, his systematic method of work, his ability to stick to a problem until it was solved. It is so with business. Partial payment is the surest method of reaching the stage for the red line and the balancing.

### PROTECTION

Out in Nebraska the experience of a farmer who wanted to buy a disc harrow, recently, has found its way into print and is going the rounds of the metropolitan and rural press.

This farmer wanted a new harrow to prepare his land for oats. He asked the price of the machine and found that it would cost him the yield of a ten-acre field of oats. Then he began to seek an explanation of the disparity between the price of his products and the cost of the implements he needed in the cultivation and harvesting of his crops.

What that farmer discovered was that the harrow and most of his other machinery and tools are manufactured of steel and iron on which there is real, effective "protection"—the sort that can be collected in the selling price. He learned also—from the newspapers which told his story—that the United States Steel Corporation had just reported, through Judge Gary, chairman of its board of directors, that 1923 was for it a very prosperous year. This corporation had profits in 1923 sufficient to pay 7 per cent on its preferred stock and \$16.43 a share on its common stock—the latter originally practically all "water."

This little study of the tariff is typical of the inquiry the farmers are making elsewhere in the Northwest. What they learn is discrediting the Republican tariff and destroying the Republican chances in that region.

### ELEVEN MILLION ACRES BURNED

The area of forest land swept by fire each year is about twice the size of the area cut over annually by logging operations, state forestry officials. Records kept by the Forest Service show that an average of 36,000 forest fires occur each year, burning over 11,000,000 acres of land, and causing a loss of \$16,500,000, exclusive of the indirect damage to young growth, watershed protection, animal life, and recreation.

There are two primary reasons agency for holding opinion in America. In the first place, we are a nation of readers. It is true that large why the press is the outstanding

numbers of the people do not read the English language, but there are publications in every one of the important languages of the world in sufficient numbers to satisfy the peculiar literary tastes of all classes, creeds, and nationalities. Therefore we seldom find an American who does not read some kind of a current publi-

cation. It may be only an occasional paper or magazine, a semi-weekly farm paper, a religious quarterly—but the important thing is that practically all of us read something. And whether we read or not, we are all exposed to the influence of the press. If we do not read, our neighbors do, and we hear them discuss current happenings as reported through the press. Thus the influence of the press reaches all.

The second reason why the press is the outstanding agency for molding opinion is because but few of us have opinions of our own. When we make careful inquiry into the subject of opinion, we cannot help being astonished at the very few people who really form an opinion for themselves, and particularly are we surprised at the paucity of carefully formed opinions of any one individual. Most of us are either too busily engaged in our vocations or are not inclined to take the time and trouble to become sufficiently informed about a subject necessary to the formation of an intelligent opinion. We much prefer to adopt a ready-made opinion that is handed to us by some one else, and present it to our friends as glibly as if it were our own, than to do the work necessary to the formation of an original one. In other words, the average human being has an aversion for work and we are lazier in our mental processes than in anything else. As a result of this, but few of us hold the views that we do on any subject as a conclusion deduced from the careful weighing of facts might be had by sufficient effort, and in most cases, effort would be only nominal. The reason for this condition has been largely our system of education, which has demanded that most of our training consist of committing to memory those things handed to us by our elders without a question as to origin, appropriateness, or truthfulness. In other words, our education has been very largely one of indoctrination, and indoctrination is not conducive to the building of the thought processes necessary for the formation of intelligent opinion.

To give a few examples of what I mean, I refer you to the question of your party affiliation. How many of you vote the Democratic ticket as a

result of anything other than that you happen to reside south of the Mason and Dixon's Line, and that your grandfather, father, and brothers have voted that way, and you would be considered a kind of renegade to do otherwise? Again, I doubt if one-third of you belong to the church of your choice, except as a result of family affiliation or the influence of a friend. But few of you made careful study of those peculiar teachings that differentiate the church of your choice from other churches before you affiliated with it. Furthermore, I am persuaded that the most of the things we do are the result of following blindly the customs of the time or the persuasion of some apparently logically reached conclusion of some one else. In other words, tradition dictates to us, and custom hems us in. Our sphere of mental activity seems yet to be very closely circumscribed.

There has been no one else quite so quick to recognize this situation as the press agent. Consequently we find the press using every conceivable method of presenting its ideas to the people. The press agent knows that every paragraph, every cartoon, every joke, finds a sympathetic response some where. He knows also that if he can keep an idea before the people long enough it will be accepted by the great mass, unless it meets with a decidedly active opposition by some other part of the press. When such opposition does arise, however, that side usually wins that secures the most readers. For do you know that most of us will not read but one side of any question? We are usually so sure that we are right that we care not to take the time, or to be irritated by reading things that oppose our preconceived views. When once we have an opinion, it is a very sacred thing, regardless of how we came by it. In fact, we usually think so much of our opinions that we try to force them upon our neighbors. And the very thought of having to change them is severely painful.

There is a little poem by McCann that fits this situation very admirably and reads something like this:

"We clean our houses every day  
And throw the useless things away,  
But often let our minds for years  
Get filled with foolish thoughts and fears."

This situation would not be so serious if we were not living in a Democratic country where every person's opinion should be as good as any other's. The worst thing, however, is that every person's voice in the government is as great as any other's, and this is as it should be, provided, however, that each voice is the result of an intelligent opinion, reached through a careful study of the facts in the situation. Therefore that press which fails to present to the public both sides of a question at the same time may be a very dangerous influence, for it may be trying to over persuade in its conscious effort to mold opinion. A Democratic country cannot rise above the dignity of its press. Then we must demand of the press that it present all of its questions squarely; that it give the evidence in the case, and leave the decision of the question to the great jury of its readers.

The press of today is very largely partisan. It presents but one side of a question and usually that in a magnified form. If it should present both sides of a question, it usually takes particular pains to magnify one side or present only a portion of the facts on the other. The great business of the press today is to mold opinion in one way, and to that end a large part of it is willing to use any means. The various phases of the press are organized distinctly for propaganda. "Get it before the people through the press," is the slogan, and every one from the most intelligent is trying to get his opinions printed. Therefore we find the various publications, with a few exceptions, literally cluttered up with partially stated facts, misstated facts, fictitious facts, and deliberate misrepresentation of facts, all trying to attract attention and secure a following that some individual gain, social ambition, or political aspiration may gain impetus and ride upon a wave of popularity.

You who desire to form intelligent opinions, then, must be careful when you turn to the press for facts, or you will be the victims of half-stated, or over-stated situations and err in what seems to be well founded positions. One must cast aside all preconceived opinions as new situations in our Democratic life arise, and demand the facts before you take a stand on them. Remember that we are living under different conditions from that of any previous age and in most cases we do not have a reliable precedent to follow in deciding new questions. Therefore if we are to maintain the principles of Democratic equality, we must assume a different attitude toward the press and make new demands of it. We must substitute intelligent reasoning for our prejudices in the solution of

all our problems of economic, industrial, political, and social life that we may perpetuate a respectable society in which to live.

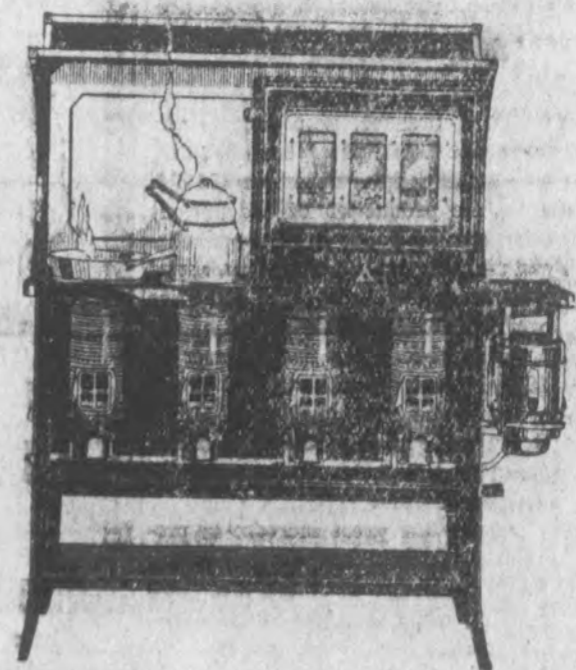

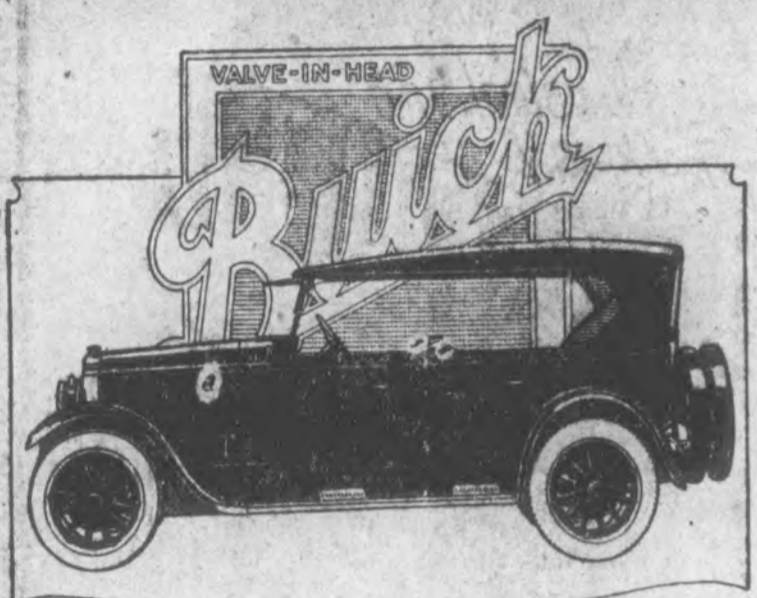

the Christian, it is to be classed as fanaticism. Men often place embellishments upon the faces and other parts of their bodies to make man think they are thereby serving a more powerful God, but the one real God does not recognize it as such. For God knows that the body of man which is to house the soul of the same being can and should be made a house of great dwelling and power.

The body out of Christ is a handiwork of the satanic powers combined with the full co-operation and support of the fallen man. Oscar Wilde the great artist of the English language, whose words have been proclaimed as masterpieces of the language itself, was an intellectual and physical giant but an immoral and degenerate wretch.
