OTHER CRIMES TRACED TO KIDNAPPERS

Advocates Ford Bid May Block Adjournment Congress

Former Chicago Murder May Be Laid To Prisoners

Bullet That Killed Former Student Fits Leopold's Pistol; Attacked Taxi-Driver Identifies Prisoners As His Assaultants

Chicago, June 3.—Declaration that the bullet which killed Freeman Louis Tracy's student, November 25, fits one of the pistols found in the room of Nathan Leopold, Jr., who with Richard Loeb, both sons of millionaires, confessed the kidnaping and slaying of Robert Franks, was made by Dr. Joseph Springer, coroner's physician today.

The two youths spent last night in jail, while prosecuting attorneys and detectives sought to connect them with at least one other murder and another attack furthering elaborations of the theory of their Dr. Jeckly and Mr. Hyde existence.

The slayers still maintained that their only motive for killing the Franks boy was an experimental adventure in the hope of obtaining the \$10,000 ransom.

Norman Ream, young taxi driver taken to the jail by newspaper men seeking to explain the attack and mutilation upon him last fall, screamed identification of Leopold and Loeb and fell to the floor in a faint.

WASHINGTON LAD IS KILLED BY AUTO

Washington, N. C., June 3.—Walter Guy Jarvis, 12, son of Mr. and Mrs. Walter Jarvis of this city was fatally injured yesterday when run over by an automobile driven by Mr. James Roberson, who resides a few miles from here. Suffering a broken arm, crushed skull and both legs broken the boy was rushed to a local hospital where he died within a few minutes.

The accident occurred when the boy, riding a wheel, dashed out in front of the automobile at the intersection of two streets.

Receives Injuries When Gas Tank Explodes

Raleigh, June 3.—R. R. Summers, automobile mechanic of this city, was in the hospital today as the result of injuries received when the gasoline tank of the car on which he was working, exploded. At the hospital it could not be determined the extent of Summers' injuries until complete X-ray pictures had been made. However it was stated that his shoulders were badly cut and that there was a possibility that his head was hurt.

The mechanic stated that the explosion was caused by the hot air from the exhaust pipe igniting the fumes from the gas tank.

The report was signed by Senators Ladd, Republican, North Dakota; Smith, South Carolina; Carroway, Arkansas; Harrison, Mississippi and Heflin, Alabama, Democrats.

CLAIMS M'ADOO TREATED UNFAIR

Ladd Declares There Is Nation-Wide Conspiracy to Suppress McAdoo News

Los Angeles, June 3.—A nationwide newspaper conspiracy against William G. McAdoo's candidacy for Democratic presidential nomination, is charged in a statement signed by David Ladd Rockwell, chairman of the national McAdoo for President committee and made public here today at McAdoo headquarters.

"Almost the entire of the partisan Republican press and of the reactionary Democratic press" says the statement, "have combined to suppress all news favorable to McAdoo's candidacy. At the same time all news unfavorable to his candidacy has been given conspicuous space upon front pages."

Child Labor Amendment Now Before States For Approval

Washington, June 3.—The Child Labor amendment to the Constitution was before the states today for final action.

The proposal which empowers the federal government to limit, regulate or prohibit the labor of children under the ages of 18 years, already passed by the House and approved by the Senate last night by a vote of 61 to 23, now awaits ratification by three-fourths of the states to become a part of the nation's fundamental law.

Although President Coolidge has expressed himself favorable to the amendment, his approval of the resolution is not required.

Stedman Appointed Member S. Mountain Memorial Committee

Raleigh, June 3.—Major J. M. Stedman of Greensboro, Congressman from the First Congressional District, has been appointed by Governor Morrison as a member of the North Carolina committee of the Stone Mountain Confederate Memorial Foundation. He will succeed the late General Julian S. Carr of Durham.

Major Stedman served in the Confederate Army and is now the only Confederate Veteran sitting in the National House of Representatives.

Endowment Fund for Methodists \$875,133

Raleigh, June 3.—Amounts requested for the superannuated endowment fund from North Carolina and Western North Carolina Conference of the Methodist Episcopal Church, South total \$875,133, to be paid in five yearly installments, it was announced here by leaders in the fund work. Conference claimants of the two conferences number 142 the statement says, towards whose support the sum of \$41,752 was contributed last year.

Of the 280 presiding elders in the Southern Methodist connection the names of 204 appear on the honor roll, indicating that every church in 204 districts of the conferences of the Methodist Episcopal church south, has pledged its full quota and more towards the \$10,000,000 fund that is being raised for the superannuated Methodist preachers, it is reported by Dr. Luther E. Todd of St. Louis, executive secretary of the Board of Finance, which is sponsoring the movement. Latest reports from superannuated headquarters indicate that out of 6,500 Southern Methodist churches, there remain only 150 that not pledged to the superannuated endowment fund the full amount requested of them by the Board of Finance.

New Swedish Air Service.

London, June 3.—A new air service is to be opened between London and Stockholm during the coming summer. It is proposed to operate three airships capable of carrying 25 passengers each. The ships will leave both capitals daily.

Des Moines, June 3.—Returns from 1,519 precincts out of the 2,412 in Iowa for Republican nomination to the Senate have Brookhart 132,628 and Sweet 123,134 or a lead for Brookhart of 9,494.

Advocates Declare That With Aid of Senators Favoring Farm Relief They Will Block Adjournment of Congress Until Vote On Muscle Shoals Question

Washington, June 3.—The Muscle Shoals issue loomed today as one of the most prominent obstacles to the proposed adjournment by Congress next Saturday night.

Advocates of the Henry Ford offer today reiterated that they would oppose any proposal for adjournment before a vote on the Ford bid was obtained. They asserted that with the support of Senators who favored enactment of farm relief legislation at this session of Congress that they controlled sufficient votes to become a determining factor.

COOLIDGE SIGNS TAX REDUCTION BILL YESTERDAY

Washington, June 3.—A new federal tax law is on the statute books today but it will have to weather a determined fight by the administration to obtain a law more to its liking at the next session of Congress to remain there.

President Coolidge served notice in a statement issued coincident with his signature to the tax reduction bill yesterday that he would bend all his energies to obtain passage, by the next session of Congress, of a bill "less political and more economical."

The bill which the president declared represented merely "tax reduction, not tax reform," cut the federal revenue an amount estimated at \$361,000,000 for the next fiscal year decreasing the tax rates to the lowest level since 1917. Almost every federal tax payer shares in the tax relief afforded. This reduction, however, will not result in any deficit, according to Treasury experts.

Individual income tax-payers are given the greater relief, although most of the remaining special war excise taxes either are wiped off the statutes or reduced. At the same time the law creates two new taxes—on gifts and Mah Jongg sets—and increases the rate of taxes on estates and playing cards.

Likewise, the administrative provisions are revised to plug gaps in the old law for tax evasions and considerable additional revenue is expected as a result.

The net reduction which it is estimated the bill will make in government revenue for the next fiscal year, beginning July 1, is \$361,000,000, but the full effect of the tax relief afforded will not be shown in government receipts until the following year, when it is estimated the reduction will amount to more than \$400,000,000.

Changes ordered in the excise rates go into effect after thirty days. Of course, the provision for a 25 per cent reduction on income taxes payable this year is effective immediately, while the cuts made in the individual income taxes are effective as of January 1 this year on taxes which are payable next year.

The following changes are ordered in the income taxes:

A 25 per cent reduction on taxes payable this year.

General revision of both the normal and surtax rates, amounting to a 50 per cent cut on taxes levied against incomes of \$8,000 and under.

An additional reduction of 25 per cent which may be made on earned incomes. For purposes of this reduction all incomes of \$5,000 and under are defined as earned. The cut may be made only on incomes up to \$1,000.

Exemption for heads of families with incomes of \$5,000 and over is increased from \$2,000 to \$2,500, the same as now allowed heads of families with incomes of \$5,000 and under. No change is made in the present law allowing an exemption of \$1,000 for single persons.

MICKEY WALKER KEEPS WELTHER WEIGHT TITLE

Philadelphia, June 3.—Mickey Walker of Elizabeth, N. J., world's welterweight champion, successfully defended his title against Lew Tendler, Philadelphia Southpaw, in a furious ten round bout in the National league ball park here last night. The challenger put up a strong fight against the youthful champion but was outpunched in the infighting.

In the first ten round bout Johnny Mealy, Philadelphia light weight, won a judge's verdict over Pedro Campo, of the Philippine Islands. The verdict was unpopular.

Tom Tiplitz, sensational Philadelphia 138 pounder, won a decision over Dan Gartin, also of Philadelphia, in a ten round bout. Tiplitz won all the way despite the game showing of Gartin.

The main go was sent on ahead of the final preliminary bout due to the threatening weather. Tendler was the first to enter the ring. He came in at 10:03 o'clock. The southpaw was given a tremendous ovation although the consensus of opinion favored Walker.

A small army of photographers followed the challenger in. Tendler sat calmly in his corner while the crowd waited for the champion. The crowd rose to its feet when Walker came down the aisle and paid a glowing tribute to the welterweight king. The champion parted the ropes at 10:08 o'clock attired in a loud purple sweater bunched high around his neck.

It was announced that Slim Brennan of Wilkesbarre, Pa., would referee the bout. Despite Tendler's popularity in Philadelphia the champion apparently had just as many friends at the ring side as his challenger.

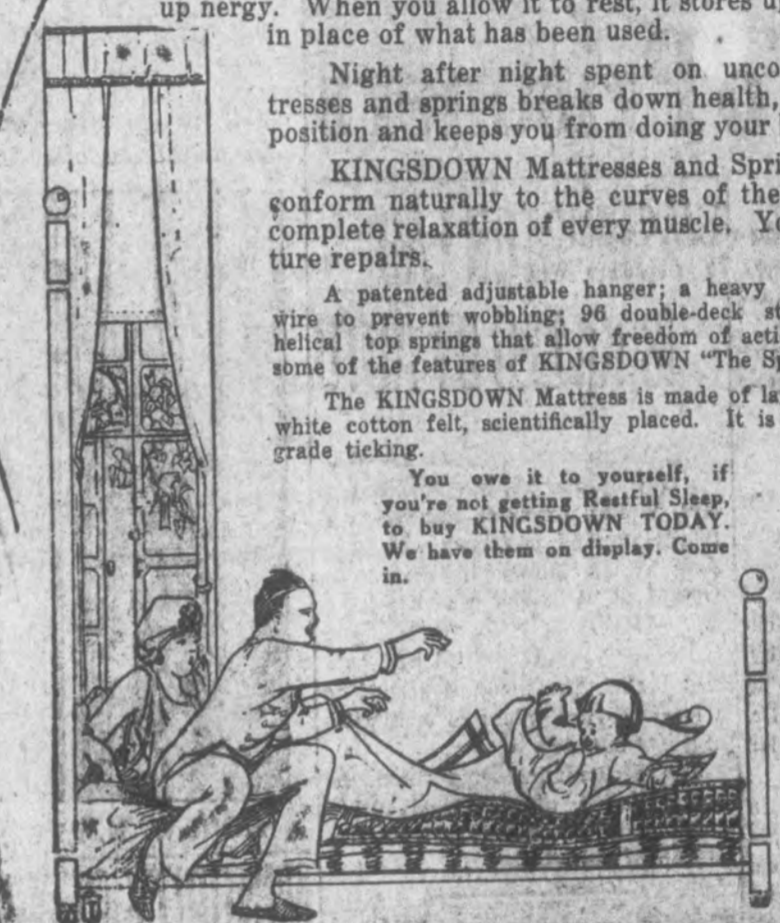

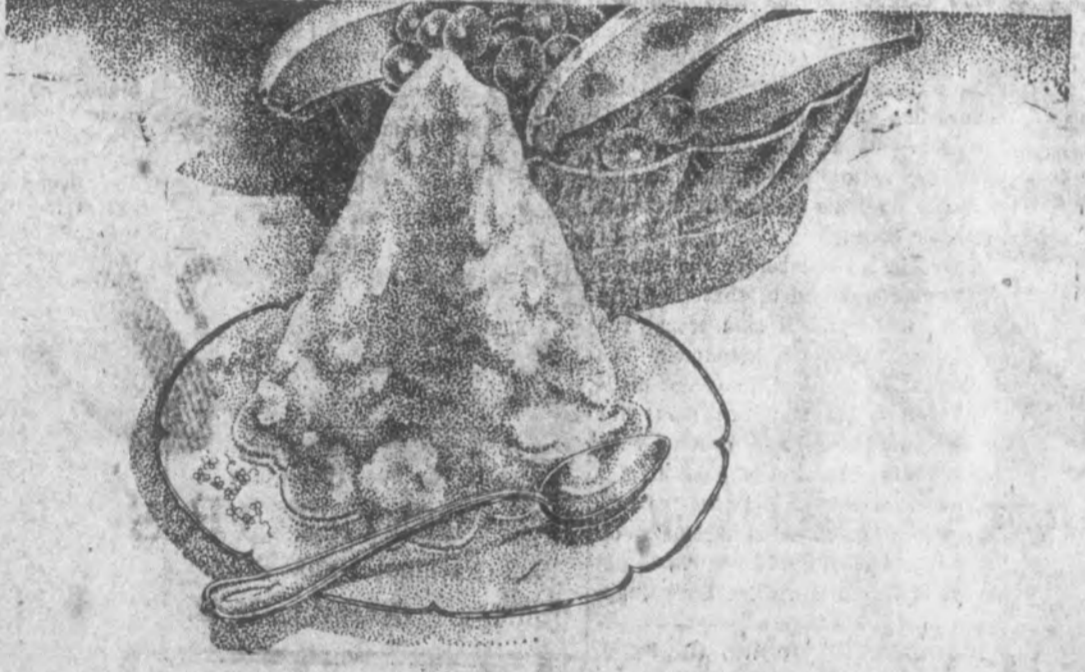

COOLIDGE OR CONGRESS

What will the Republican platform adopted at Cleveland have to say of the Republican Congress?
 Will this reference to the legislative performances of Congress be laudatory or condemnatory?
 These are questions that are provoked by the recent and present divergence between what President Coolidge wants of Congress and what Congress gives him.

Except for the annual appropriations Congress has enacted few bills of major significance. The bills which have attracted most attention are those which the President has urged Congress to defeat; namely, the pension bill, the bonus bill, and the immigration bill. The first two he vetoed. The third included provisions to which he and Secretary Hughes objected and sought to have eliminated.

The tax bill as it was passed was not a Republican but a Democratic measure in its essentials. This also had Mr. Coolidge's vigorous opposition. He favored and tried to force the enactment of the Mellon plan, but he could never command enough votes among Republican leaders of the House to get it even a serious consideration.

Agricultural legislation now pending either lacks Mr. Coolidge's indorsement or has been repudiated by him. There is no present likelihood that any of the bills Congress will adopt will receive his sanction.

That is the situation with which the writers of the Republican platform will have to deal. If they praise Congress for what it has done it will be at the expense of President Coolidge, who, as the titular leader of his party and the head of the Administration, has found fault with all its principal accomplishments and endeavors.

The attempt to make President Coolidge better than his party and his Congress, if it forsook, will be accompanied by some difficulties and political dangers for him. If the Congress which the propaganda in his behalf has been denouncing is condemned by utterance of silence, its Republican members will doubtless show resentment and seek revenge. If this Congress is commended for its work, this commendation will be a rebuke to the President's propagandists.

The writer of the platform, therefore, have a job cut out for them.

CAMPAIGN CHESTS

Being in the business of making laws, congress can not be expected to come to a realization of a possible situation wherein too many laws exist. To the contrary, the nation's legislative body has shown evidence of not abating its lawmaking rush at one enactment for each purpose.

The senate has passed a "rider" provision which would require wide publicity of contributions to the 1924 presidential campaign. The act would stand in high favor but for the fact we already have compulsory publicity for political contributions. If there has been falsification of campaign expenses it has not been because of the lack of legislation and

two laws will afford no relief where one may have failed.

Undoubtedly the senate was actuated by recent disclosures of duplicate contributions from the same sources to both major parties during the Harding-Cox campaign and also of suspiciously generous contributions from big business. Such practices are to be depreciated and if possible abolished but if publicity can accomplish that the condition would not exist since the nation's newspapers have long given much publicity to large political contributions whether national, state or local.

Nation-wide political campaigns involve immense sums of money. There have been few candidates for the presidency in recent years with private fortunes adequate to meet the financial requirements of a presidential campaign. It would take countless small contributions to finance a campaign if the average voter could be persuaded to give his money as well as his vote to his party, but in this the best of campaign managers have always failed. Big business and rich men have financed presidential candidates for government favor or government appointments.

This system has been found obnoxious because government should not discriminate and the public offices should be filled on a basis of qualifications for service rather than of riches. It is evident that the present system must endure until the high cost of campaigning is lowered or the white house shall become attractive to our multi-millionaires.

HE HADN'T TIME

The funeral procession that held you up as you were driving along the street was in honor of a man who hadn't time. He was only 54, yet in that brief span of years had built a fine, substantial business. He couldn't be enticed away from his desk. One meeting followed another. One conference crowded up another. His daily correspondence was a veritable mound. He hadn't time for anything but business—until they called the undertaker.

Most of us have the promise of a good three score years and ten. Twenty-five of these years we spend in growing up and getting prepared to make good. Then we work madly for another twenty-five years or so, promising ourselves to sit down and enjoy the last ten or twenty years, with a big roll in the bank. But the life insurance statistics suggests that that promise is not always performed.

So, why make that promise? Why delay the fun of living until the golden moment of your dreams when you are going to take it easy? Why wait?

Life is only so long. Nobody can crowd all the good things it offers into a decade. Even though you live, age will creep on to take away the bloom from the things you planned to do. You can't motor across the Continental Divide at 60 and get the same punch out of it you could have gotten at 40. At 60 you cannot hike in the woods and brave the dangers of the outdoors as you did when young.

What does it profit a man to gain the whole world and then shuffle off? What is the sense of making a great pile of money and lose the power to enjoy it?

Horace Greeley, who died untimely at 61, promised a friend shortly before his end, that he expected to quit the game soon and go fishing. But he never did. He hadn't time. HAVE YOU?

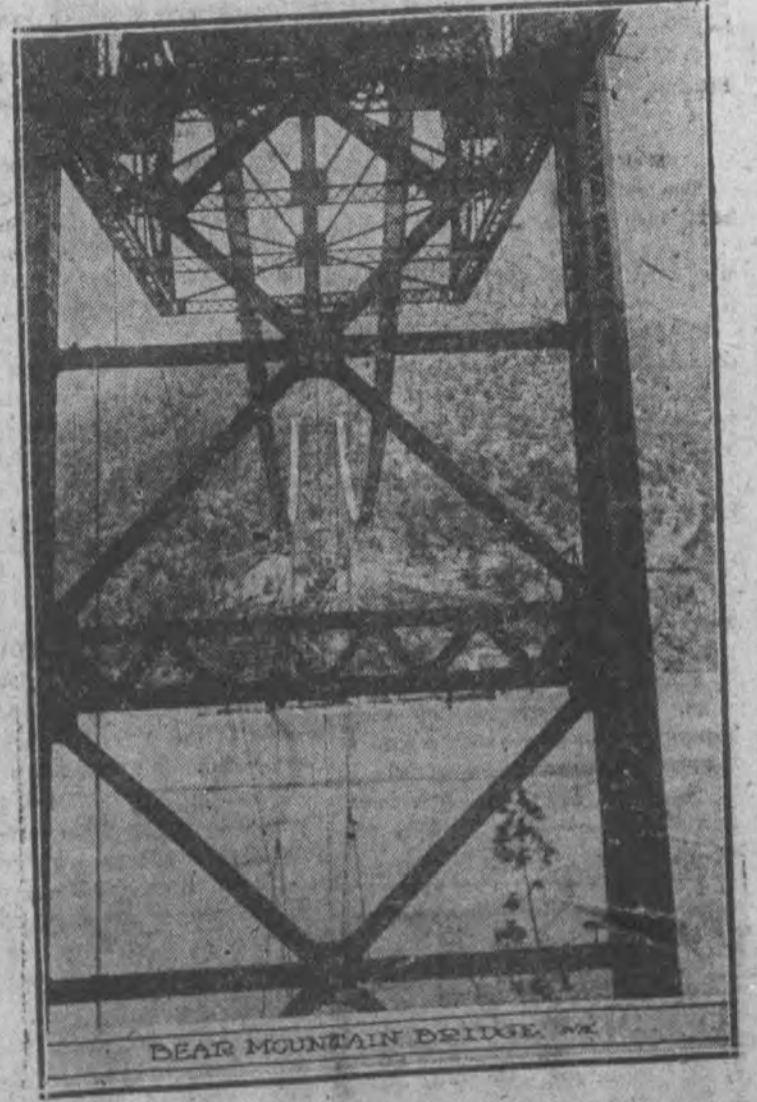

Wright presented the diplomas and
Bibles and conferred the degree of
A. B. on Miss Annie Howard Fekon.

President Wright announced sev-

The speaker was introduced in
glowing terms by President Wright
and was given a distinct ovation by
the audience.

In introducing Hon. W. N. Everett
to make the commencement address,
President Wright expressed profound
gratitude for his recovery and ad-
miration for what he has stood for
in the life of the State. He pre-
sented the speaker as a truly great
North Carolinian.

Mr. Everett showed few marks
of his recent illness and was in re-
markably fine form. For exactly
45 minutes he held the undivided at-
tention of the large audience. He
began by referring to his first visit
to Greenville when he came on a
boat, in the days when a bale of cot-
ton could be sent from Greenville to
Norfolk for one dollar, a reference
not without significance now that in-
testes in water transportation is be-
ing re-awakened. He referred in
feeling terms to the late Governor
Jarvis and his wife, other public
leaders coming out of his county, and
to the fine work done by this insti-
tution and his own personal pride
and interest in it and its President
with whom he had come in contact
in matters of finance and appropri-
ations.

In his speech, Mr. Everett played
a pleasant little joke on the news-
papers, since he abandoned the
speech which he had intended to de-
liver, and branched out on an en-
tirely different theme. He took the
story of a newspaper correspondent
who happened to see a little child in
Europe leave his home and his moth-
er's side to go to the palace to be
crowned king. He did not want to
be king. He had not chosen it.
There was a wistful, appealing look
on his face as he left his mother with
her kiss fresh upon his lips and
marched straight and resolute down
the avenue between lines of soldiers

amid the clamor and the hurrahs of
the multitude. The king business
seemed to be up to him and he would
shoulder it as best he could.

Graphically, even dramatically,
the speaker described an analogous
scene when there came a morning in
September when this same newspa-
per man, on his own front porch,
saw his six year old boy led out by
his mother's hand. There was no
troop of cavalry, no shouting multi-
tudes, only two older boys waiting
to accompany the lad to school. This
boy too looked back and waved, with
something of wistfulness and hope
on his face. He looked serious and
determined. He had not looked for
this, but here it was. Whether he
wanted to or not he had to be a citi-
zen.

With this setting, the discussion
went on to what the school should
do for the youth, and what the duties
of the parents are. The child is the
unknown quantity, and we are too
prone to leave the solution entirely
to the teachers. What is this school
business all about? Is the system
efficient? Does it build character as
well as give facts? Are the teachers
broad-minded, sincere, well-pre-
pared? The truly great teachers are
those who leave a permanent impress
in the molding of character. Facts
can be taught, but the rarer quality
of wisdom is another matter. What
are we doing to teach a fine con-
sideration for others, a passion for
service, a sane patriotism, and a love
for beauty? To leave this entirely
to the teacher is to be a slacker with
reference to our own flesh and blood.

The business of training youth is
a partnership between parent and
teacher. The parents must help to
show the relation of facts to life,
should show a real interest in the
school and become friends with the
folks who are teaching their chil-
dren. The teacher's job and the par-
ent's job both begin on the day
when a lad starts to school.

Mr. Everett said that he had no
advice to give to the graduates.
They had shown their capacity for
self-leadership and could therefore
lead others, and be of real service to
the state. His feeling for them, was
one of admiration and envy.

We boast, he said, of our progress,
of our system of highways which is
making us all neighbors. We are
proud of our work in the conserva-
tion of health and the prolongation
of human life. We point with pride
to what we are doing for our schools
and colleges. But this is but a pro-
mise of what we are to give. We
are living in the advent of the real
glory and greatness of North Caro-
lina. As she moves out and for-
ward, she catches the attention and
the admiration of men. Men can
lose their hearts to a state that is
this year spending \$25,000,000.00
on the education of this youth. This
is translating the philosophy of the
Nazarene into equality and oppor-
tunities.

The Class Day exercises of the
Senior Normal class were held yes-
terday at Teachers College at 6:00
o'clock. The program was somewhat
different from those of previous
years. In fact it is the aim of each
class to make its program different.
The traditional class history, prop-
hecy, etc., were omitted. Miss
Grace Atwater read a class poem
which was exceedingly clever.

The first year normal class and the
freshmen and sophomore classes
were brought into the program and
made delightful contributions of
song and folk dances.
One very delightful surprise con-

nected with the class day exercises
was the presentation to the college
by the Senior Normal Class of an
oil portrait of President Robert H.
Wright. The secret had been well
kept by the members and few peo-
ple outside knew what was to be
done. It has been the custom for
each departing class to leave a gift
with the college and the 1924 class
decided to have a portrait of the
man who had guided the destinies of
the institution for fifteen years.

The portrait is a remarkably good
piece of work done by a noted New
York portrait painter, Griffith Coale.
He has made portraits of some of
the most eminent people in America,
and while still a young man has
made quite a reputation for himself.
In the portrait of President Wright
he has succeeded in transferring to
canvas something of the expression
of vision and forward looking that
has characterized his subject. Those
who have known Mr. Wright intima-
tely pronounce it a remarkably
good piece of work. It will be hung
in the main corridor of the Admin-
istration Building.

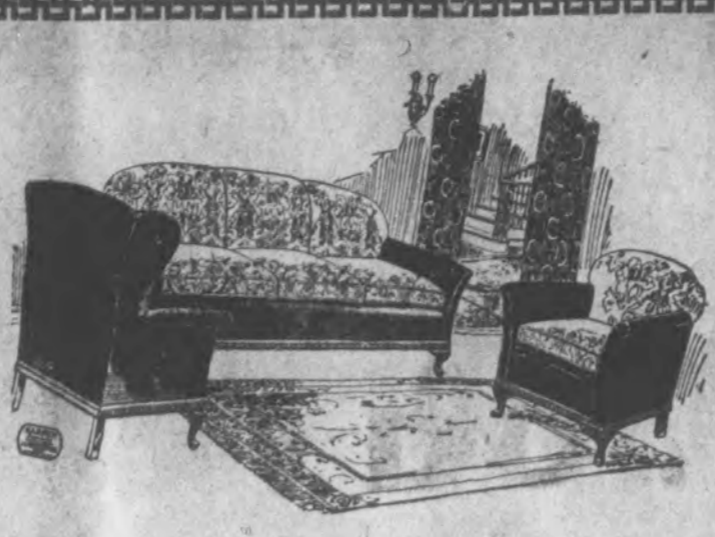
The presentation speech was made
